FIG. 3 is a top view of the bin of FIG. 1;

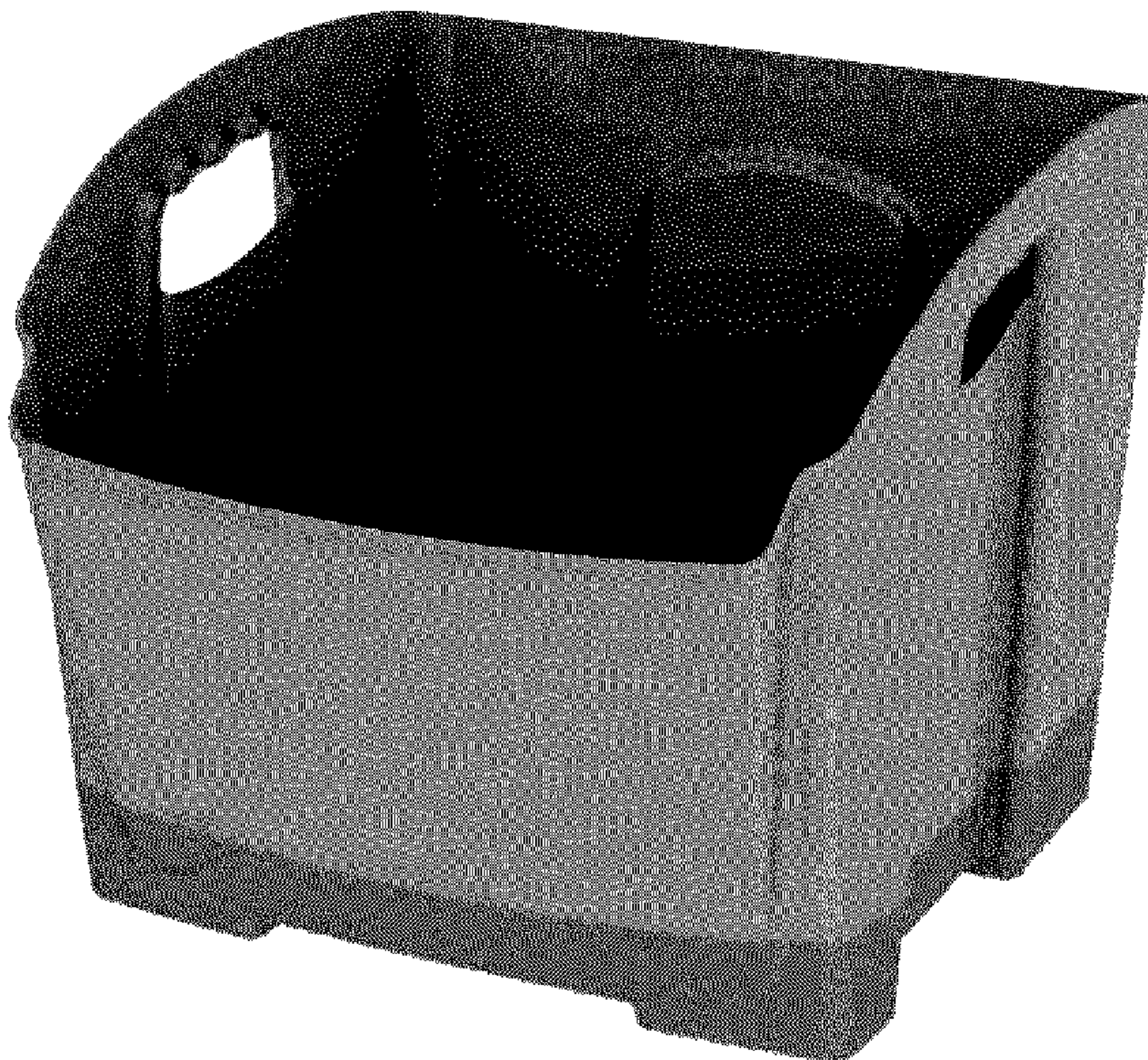
FIG. 4 is a right side view of the bin of FIG. 1, the left side view being a mirror image thereof;

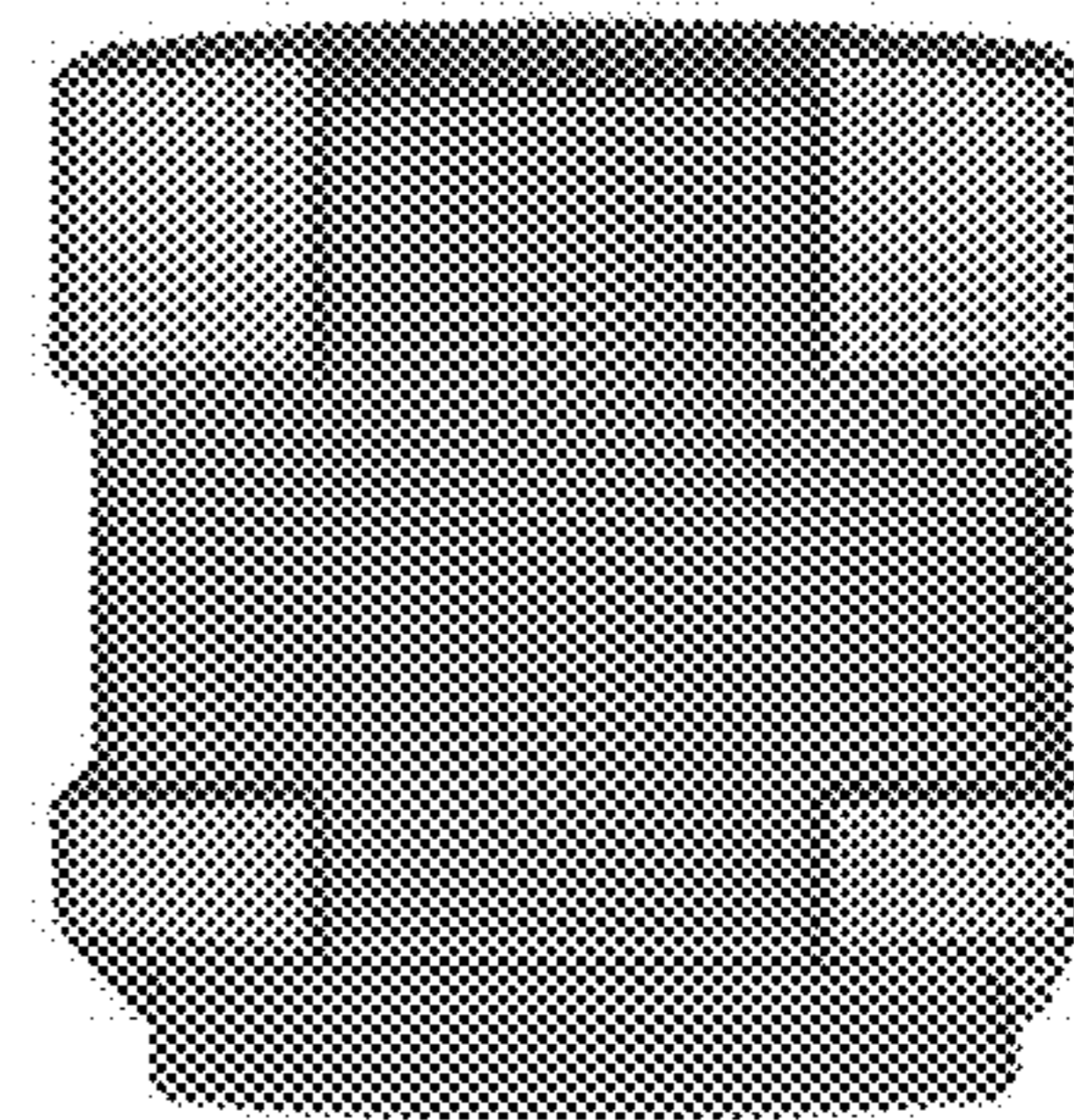

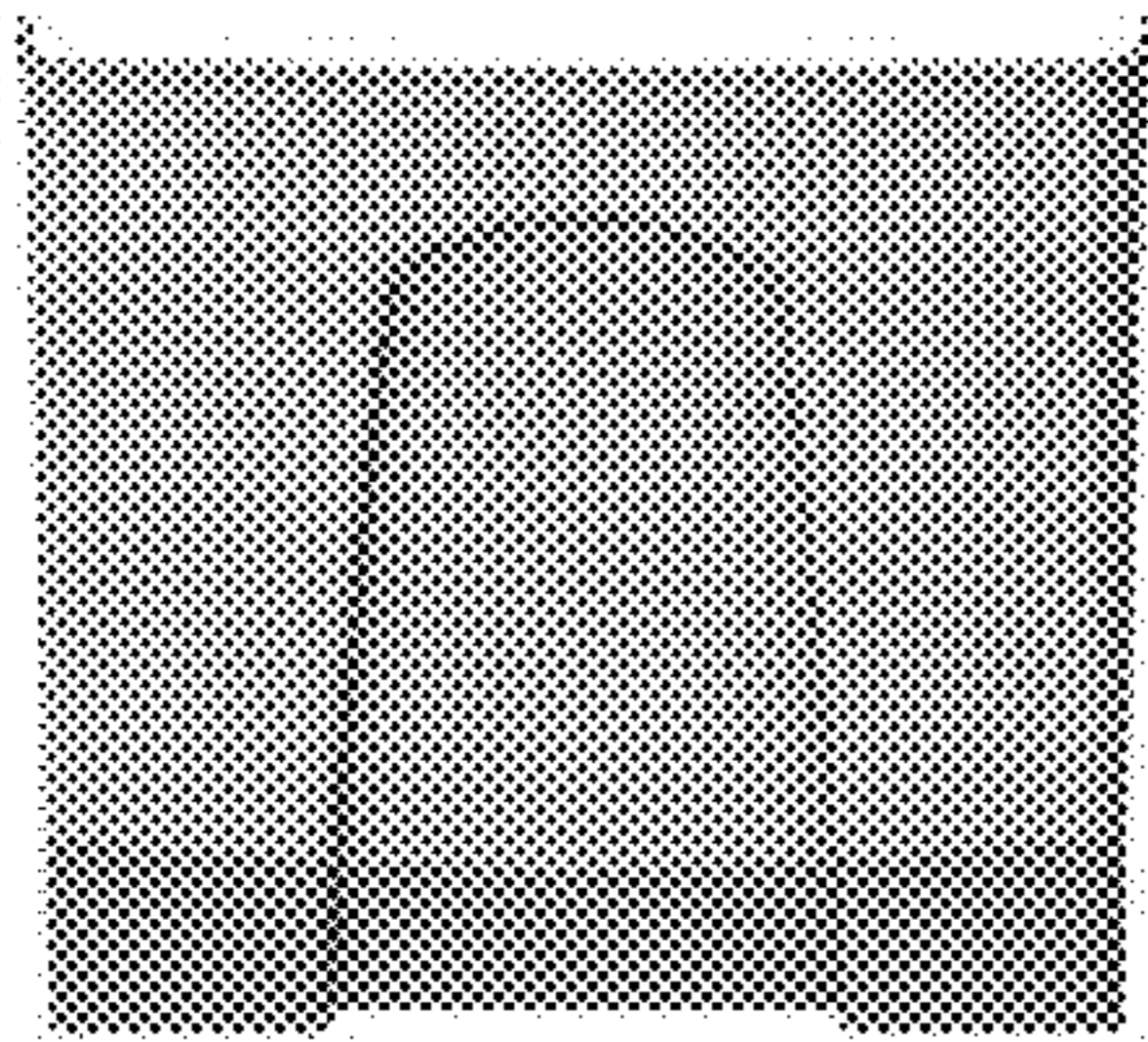




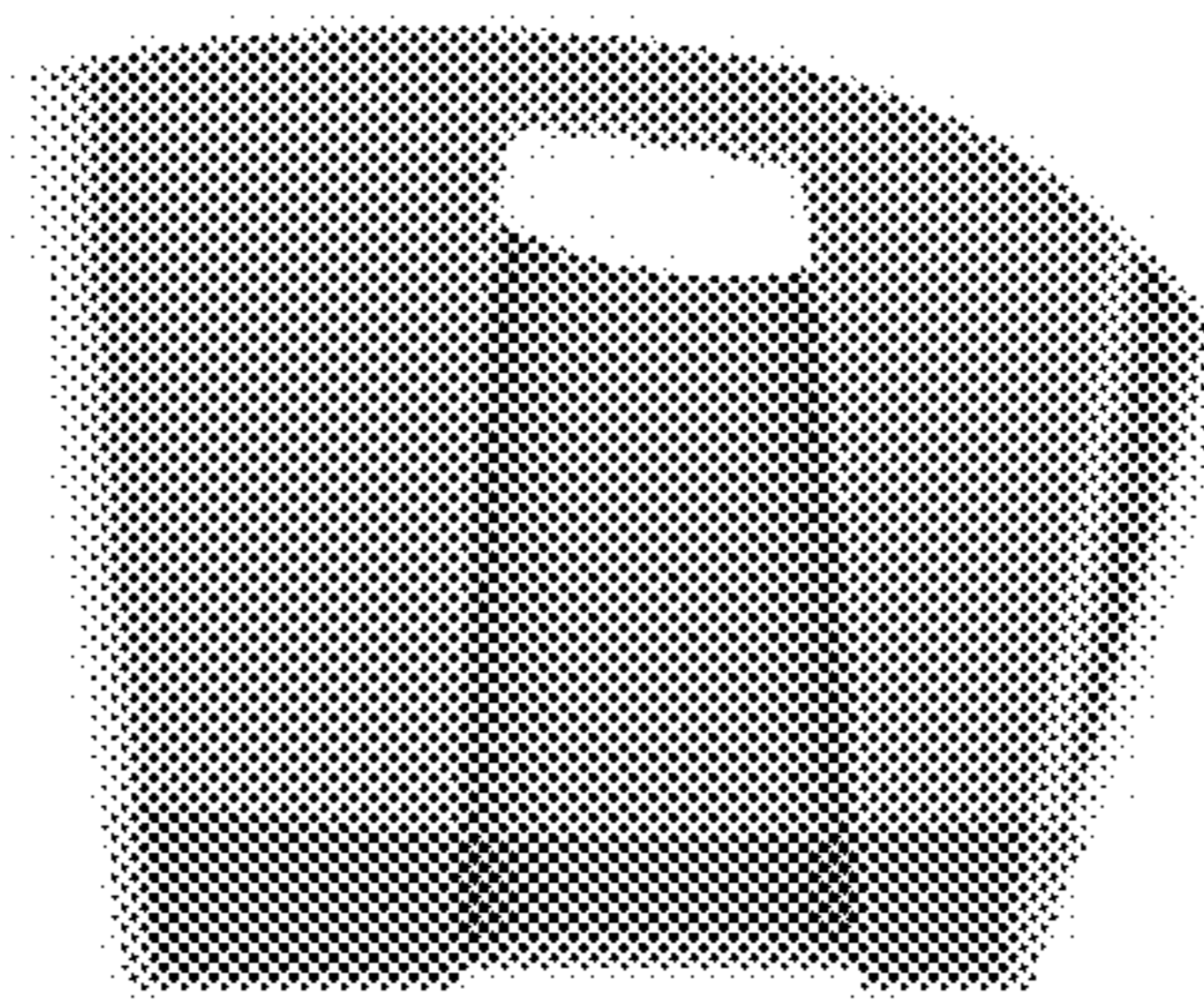

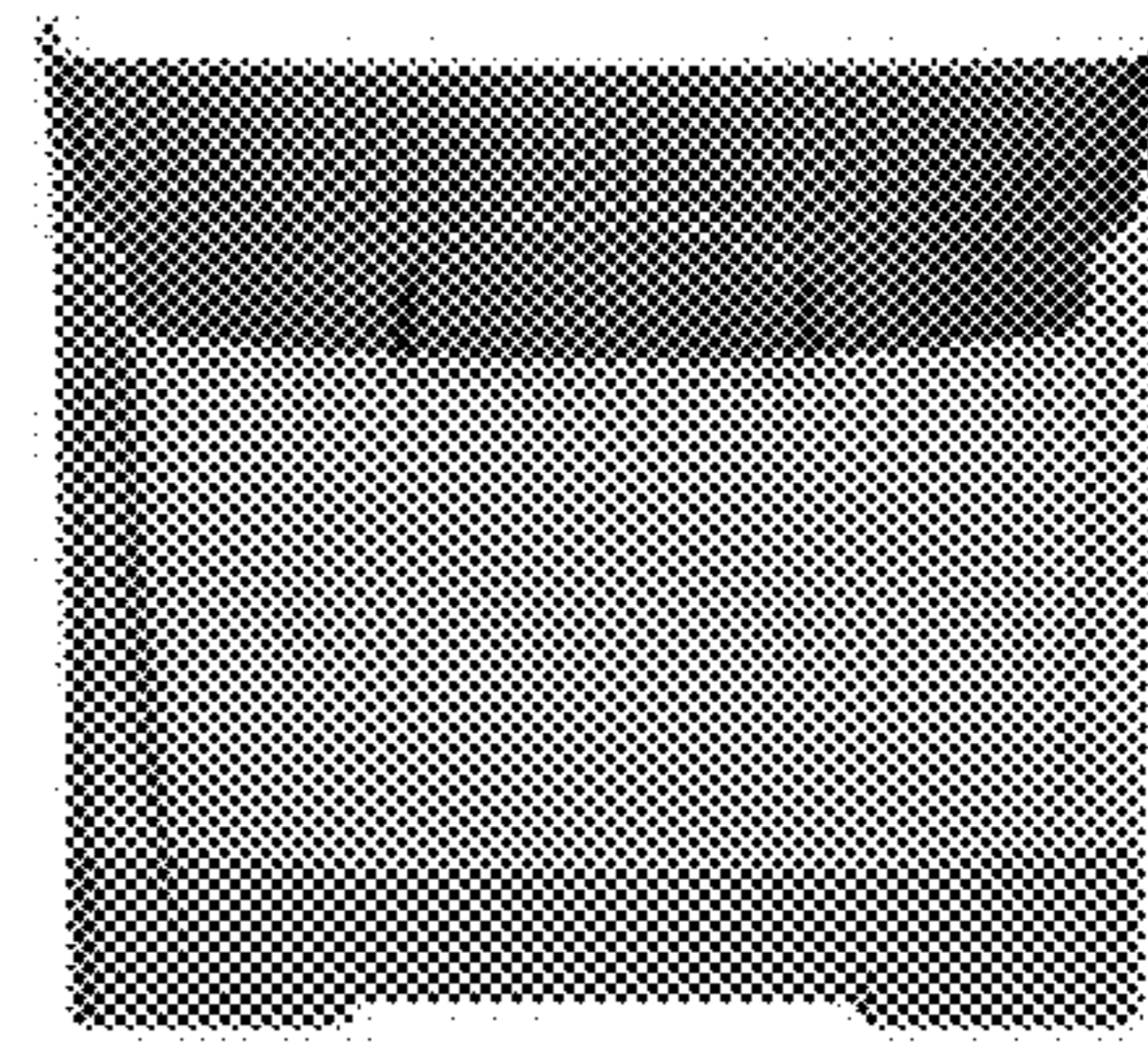

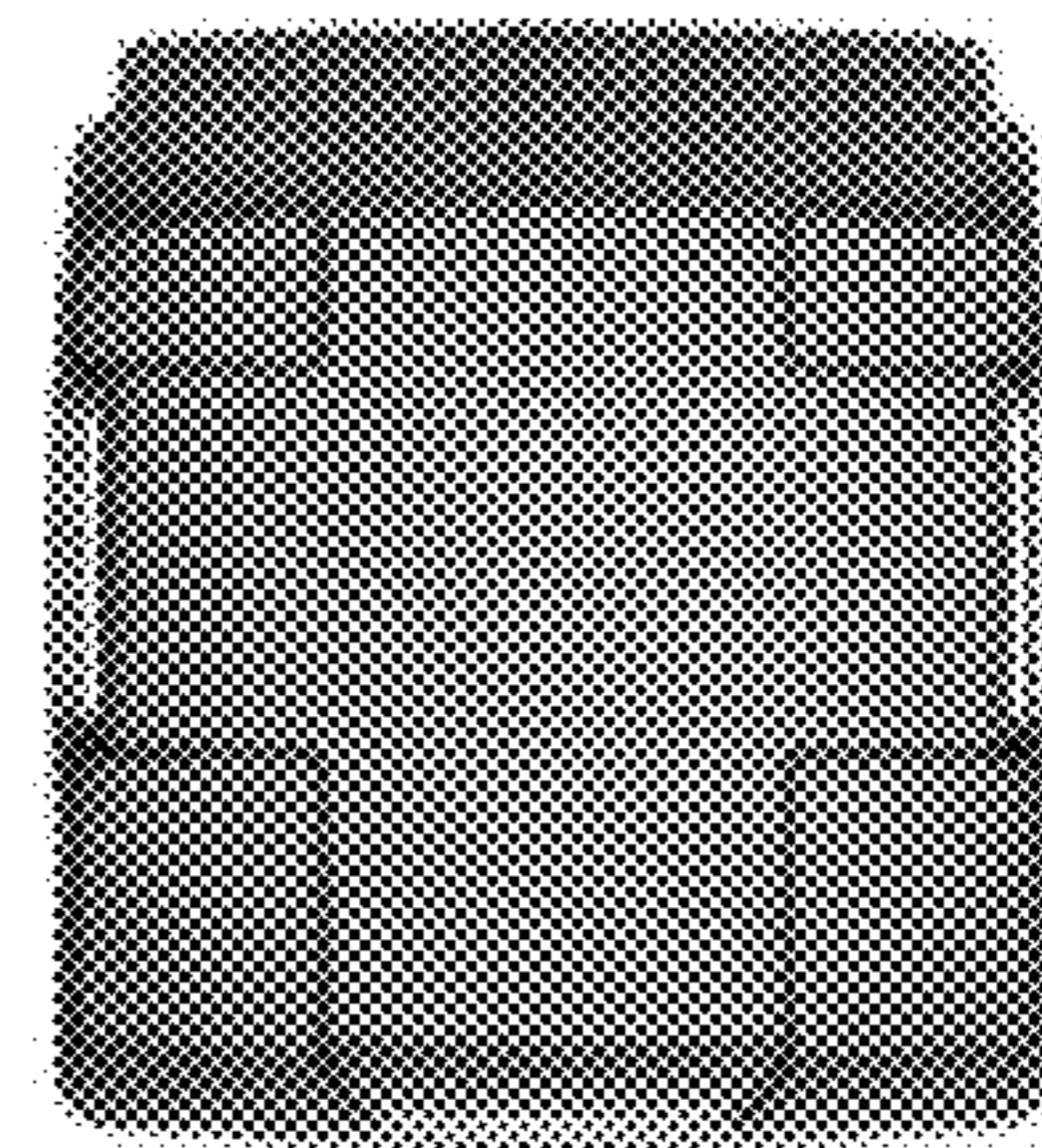
