We claim the ornamental design for an LCD monitor, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an LCD monitor showing our new design:

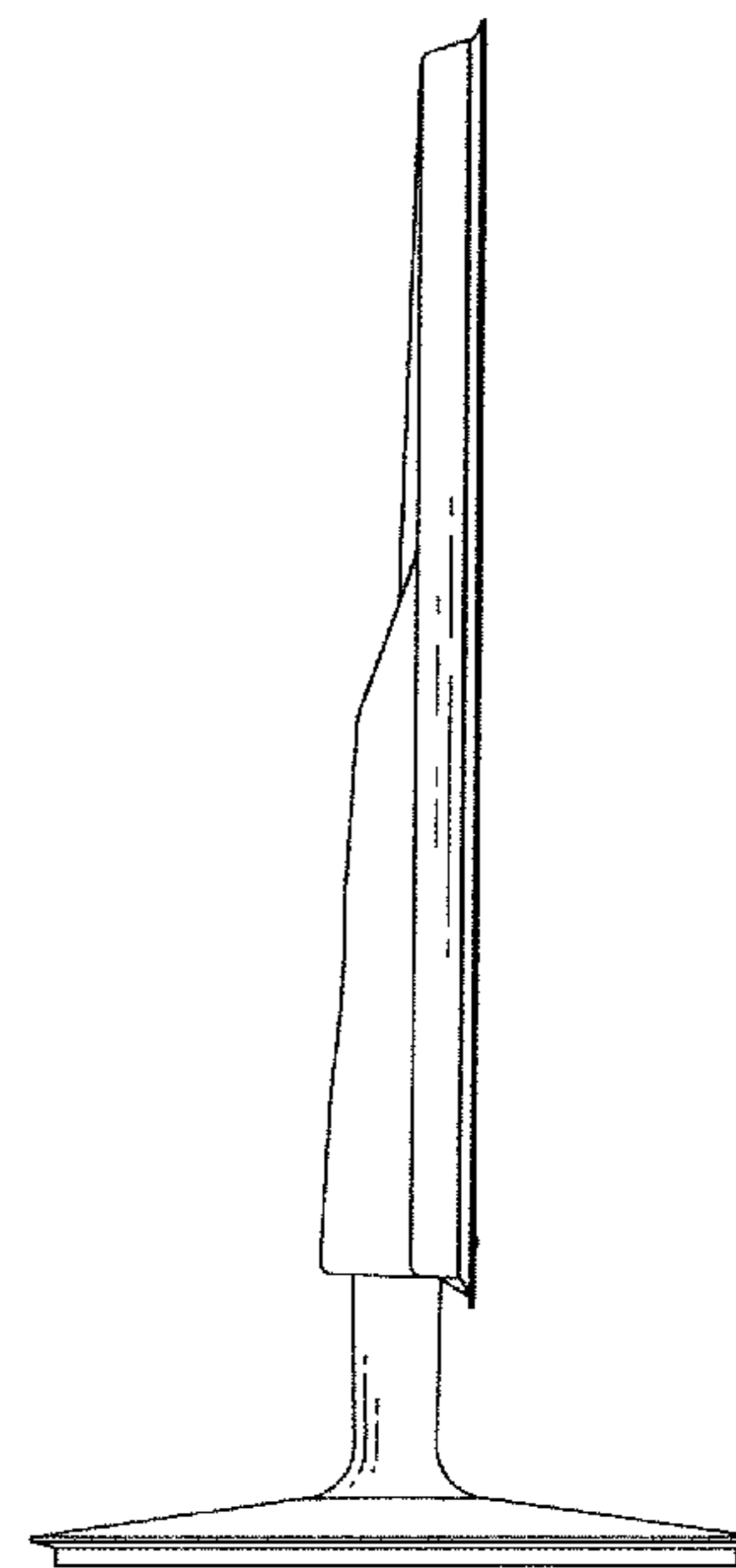
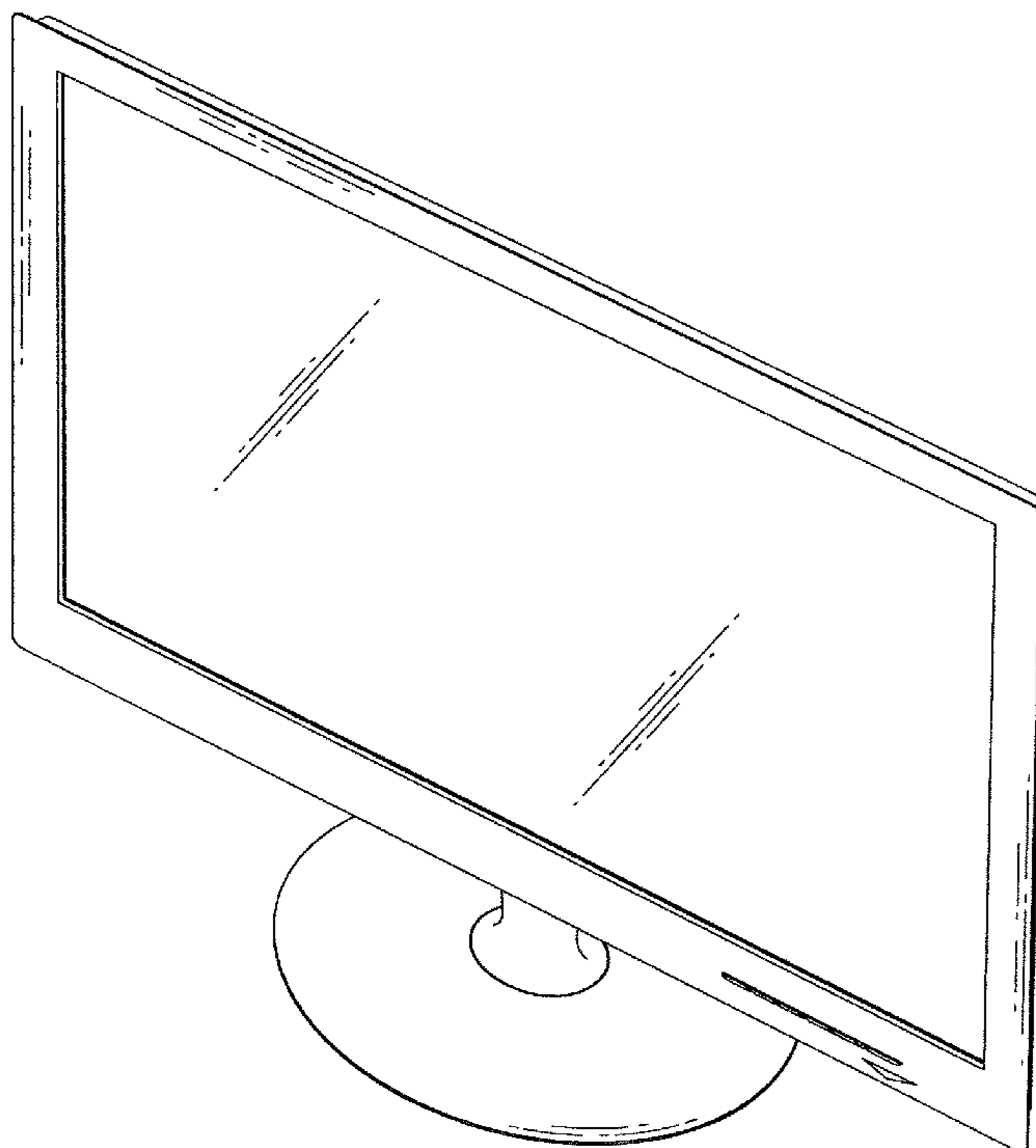

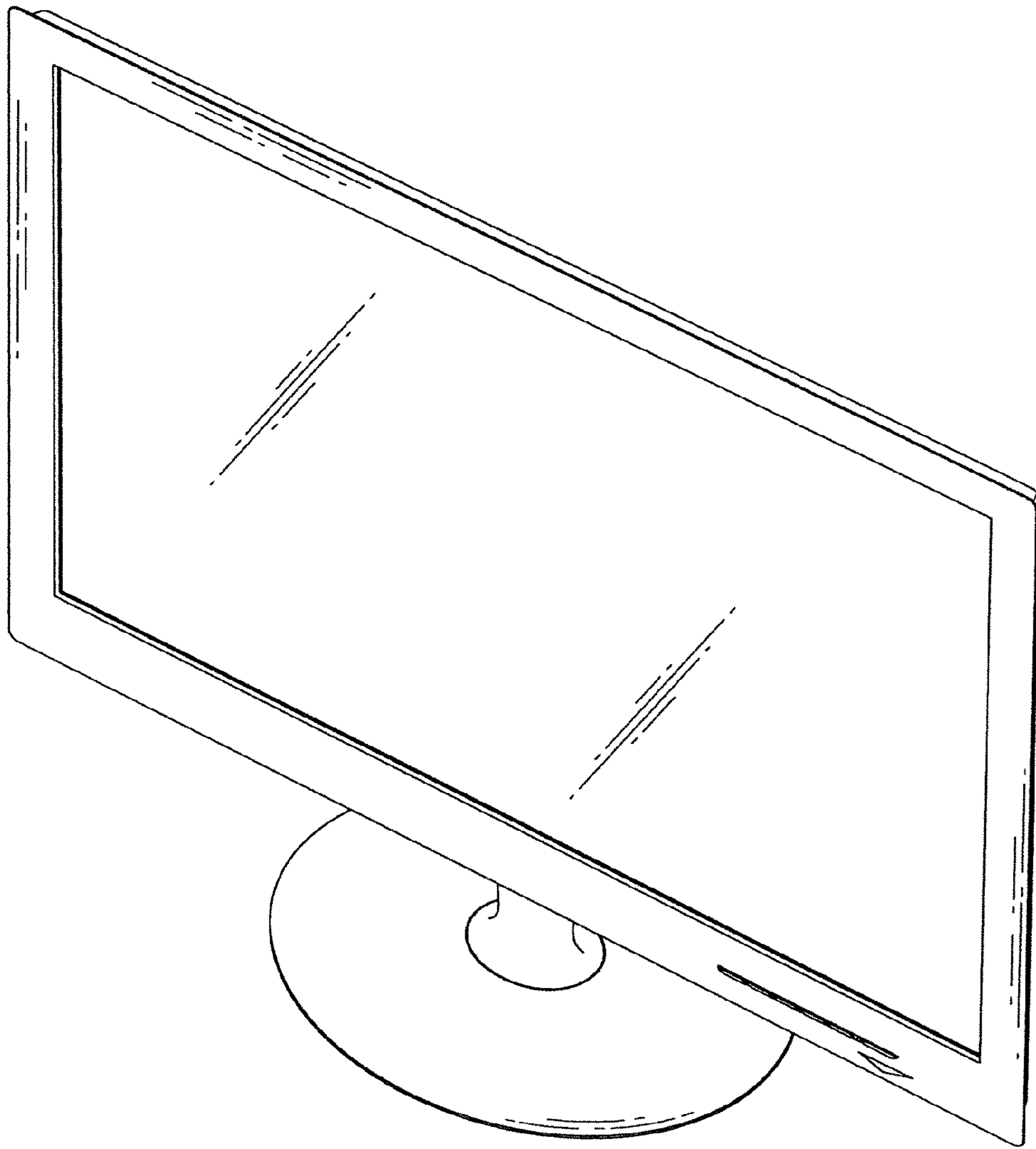

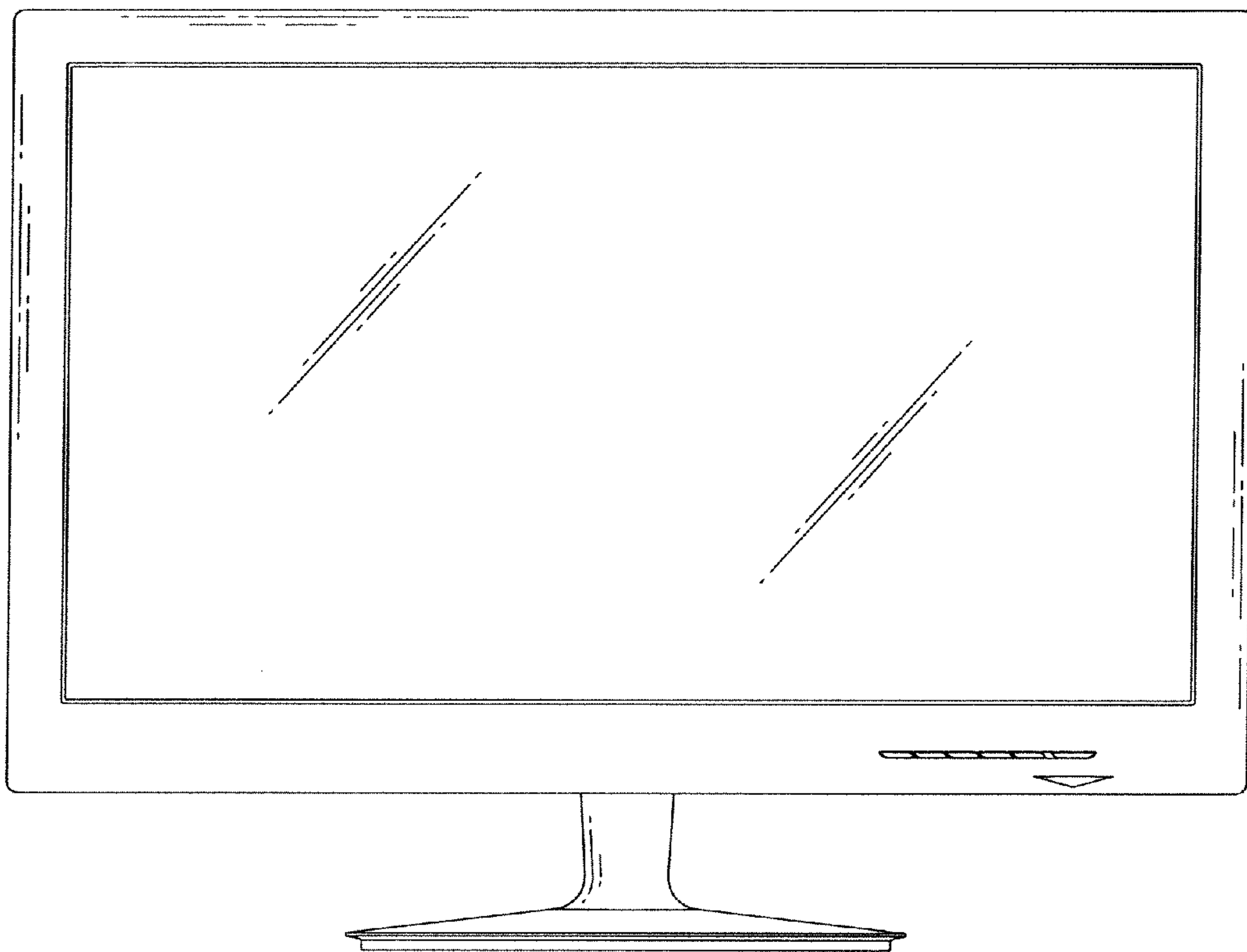

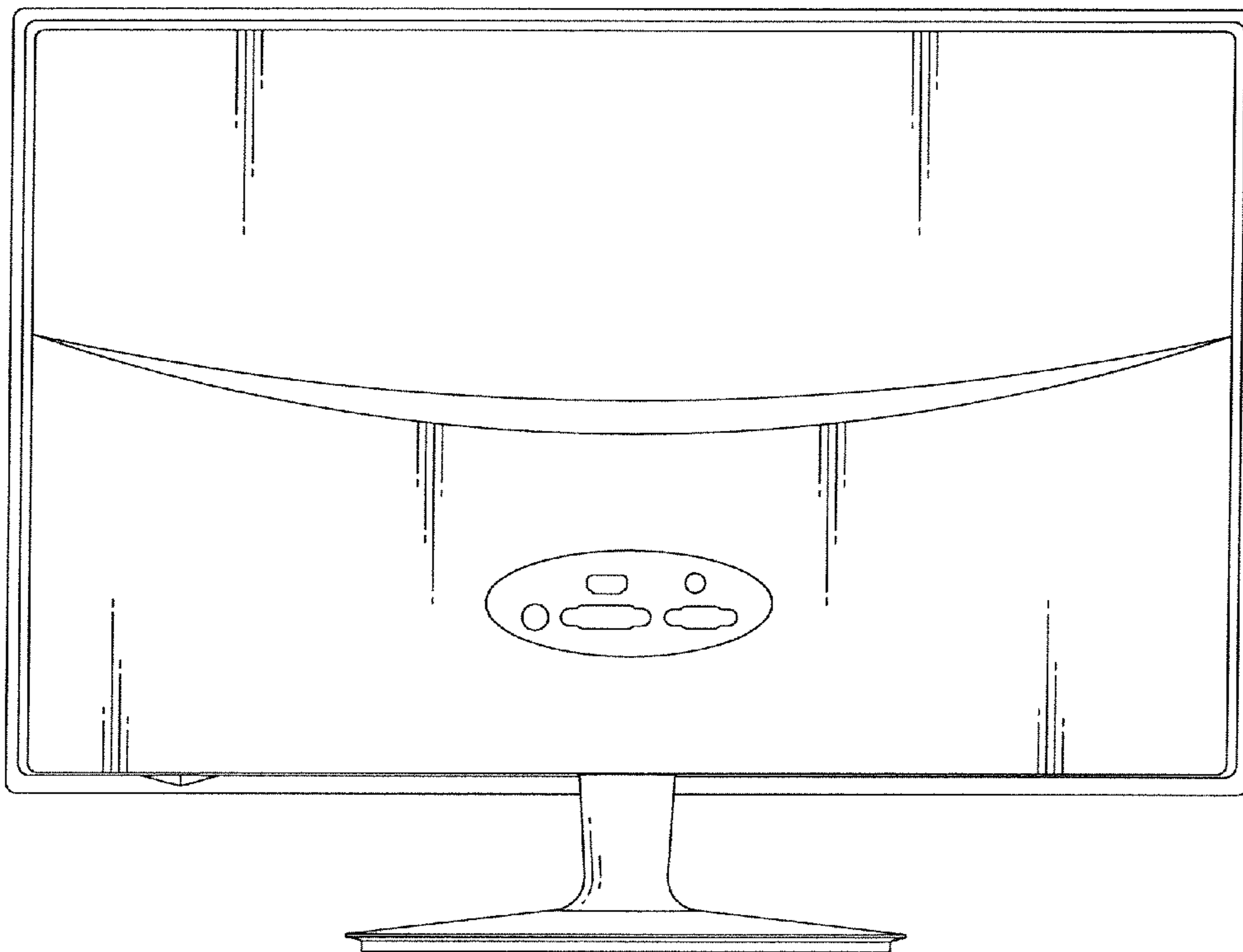

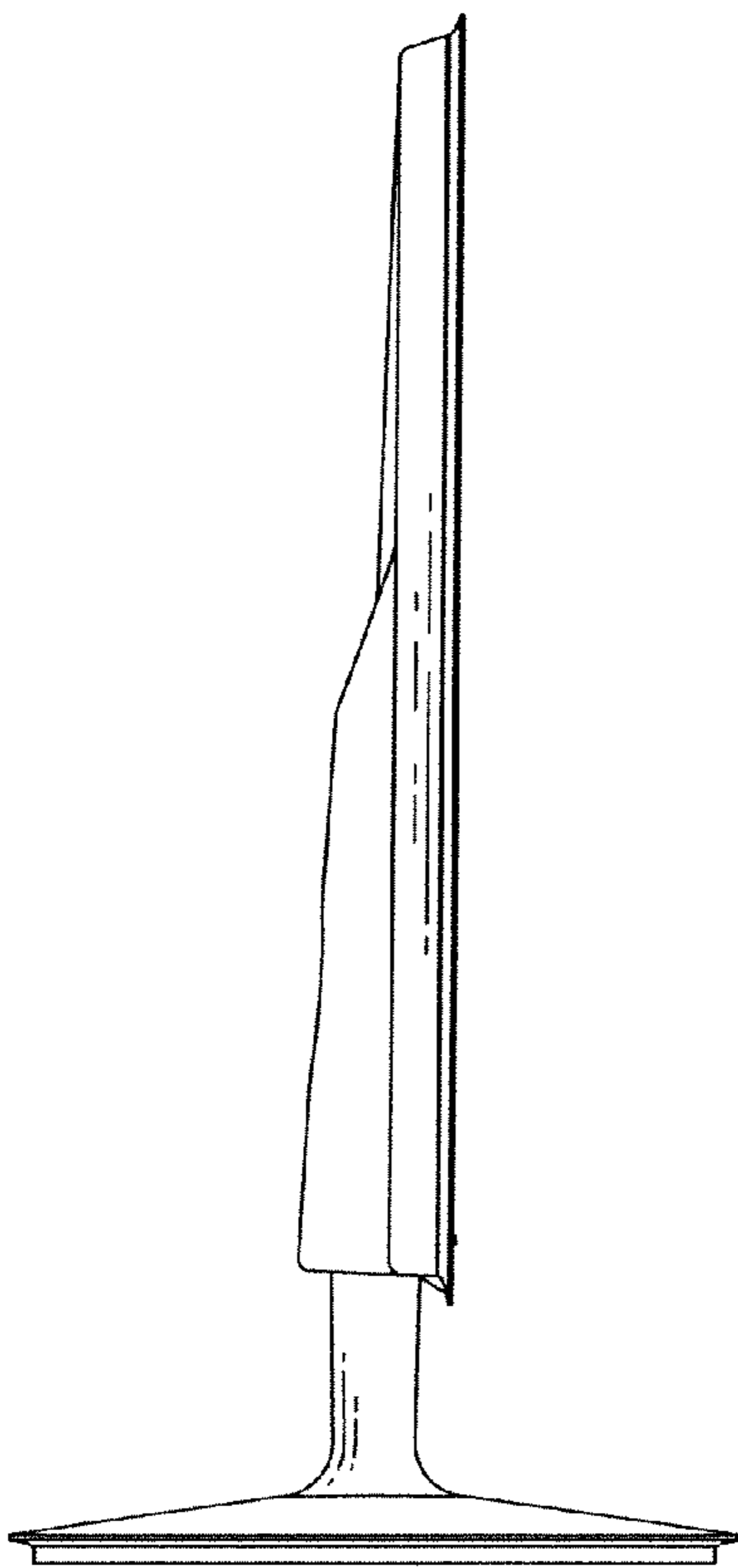

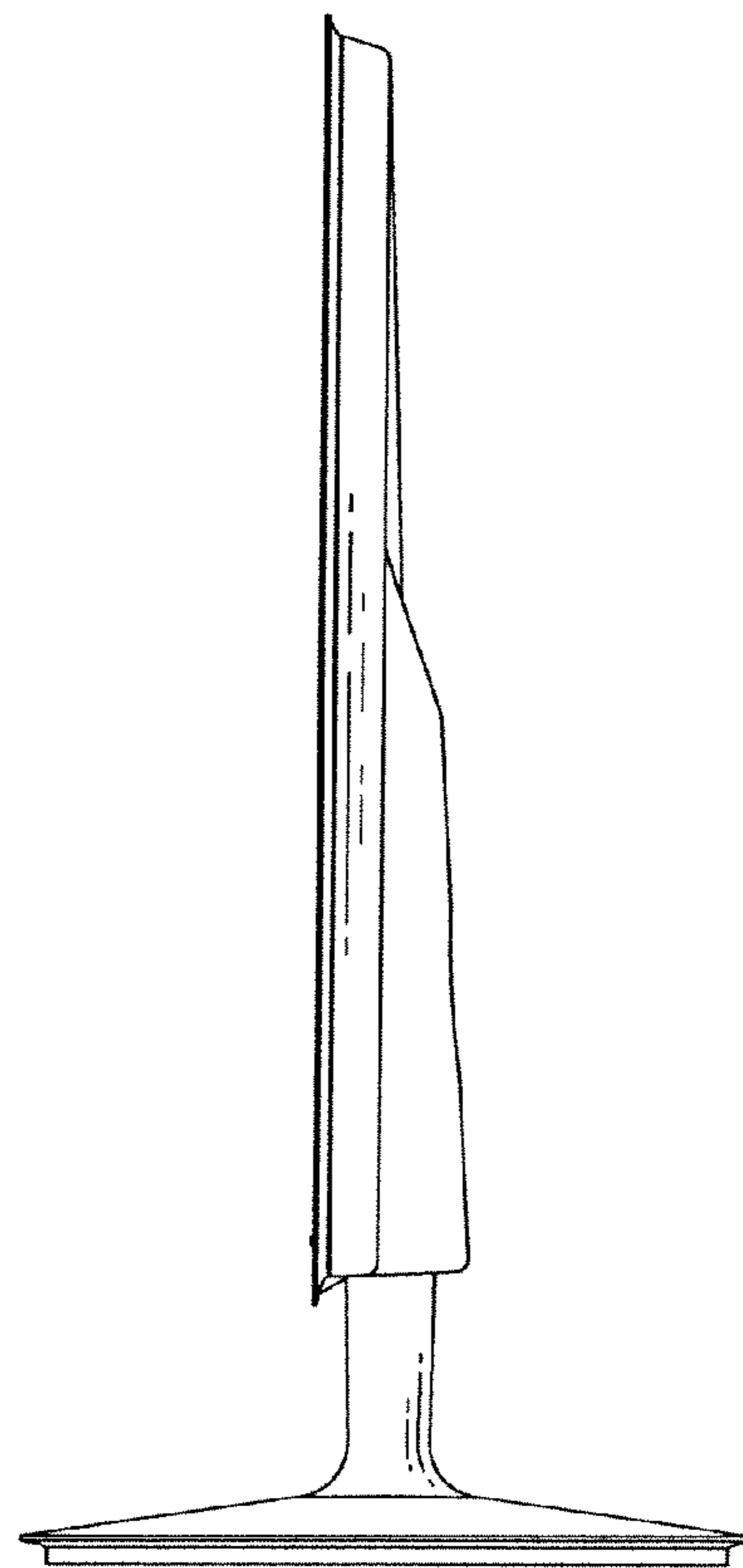

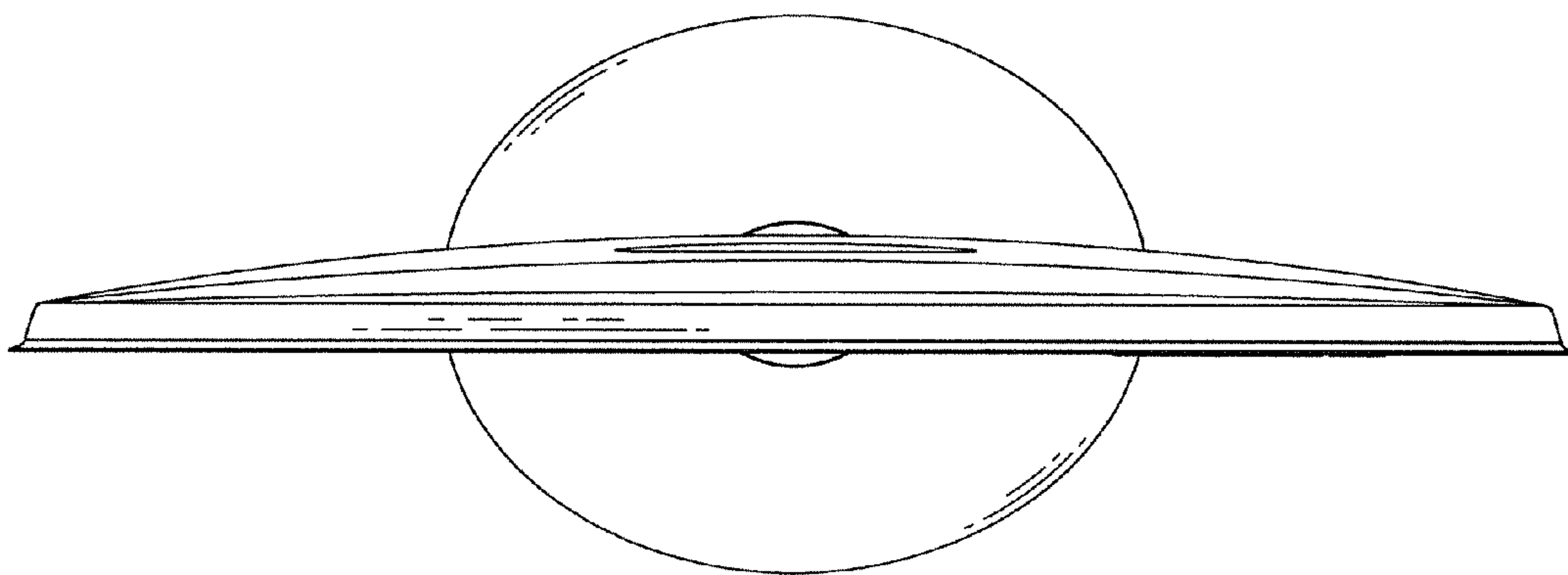
