(57) **CLAIM**

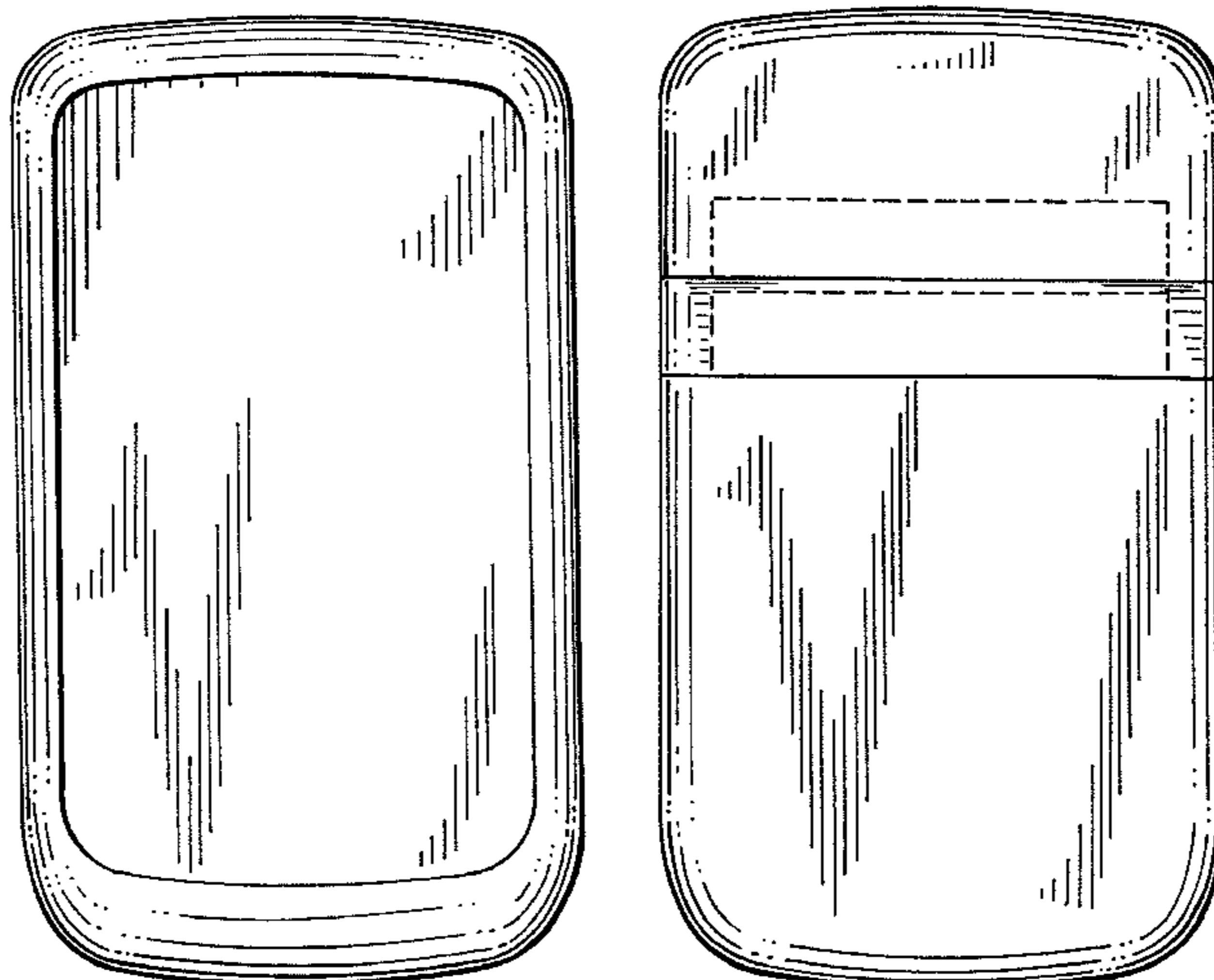
The ornamental design for a phone cover with integral card holder, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a phone cover with integral card holder according to our new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a top plan view thereof; FIG. 4 is a left side elevational view thereof; FIG. 5 is a right side elevational view thereof; FIG. 6 is a rear elevational view thereof; and, FIG. 7 is a bottom plan view thereof.

In FIG. 1, the broken lines and the unshaded region on the front of the case depict an unclaimed cell phone. In FIG. 6, the broken lines and the unshaded regions that are bounded by broken lines depict unclaimed cards.

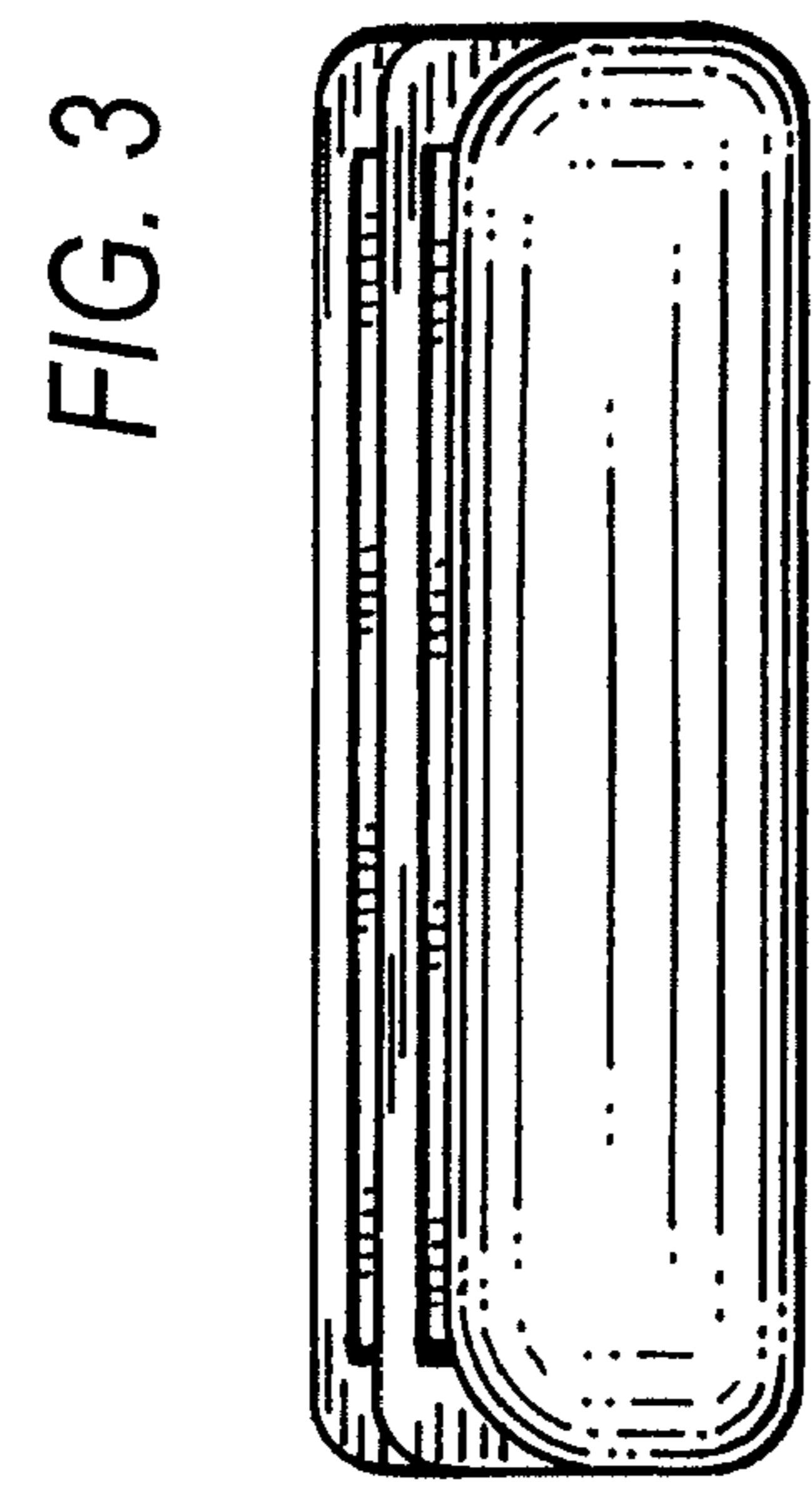

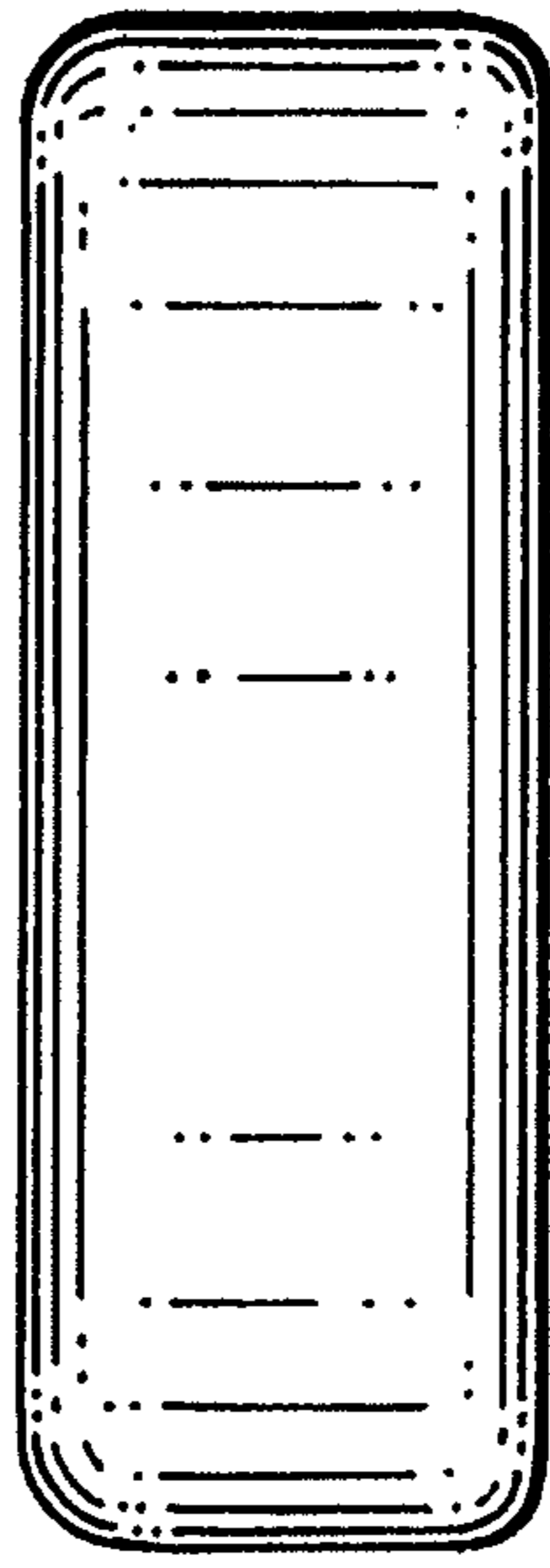

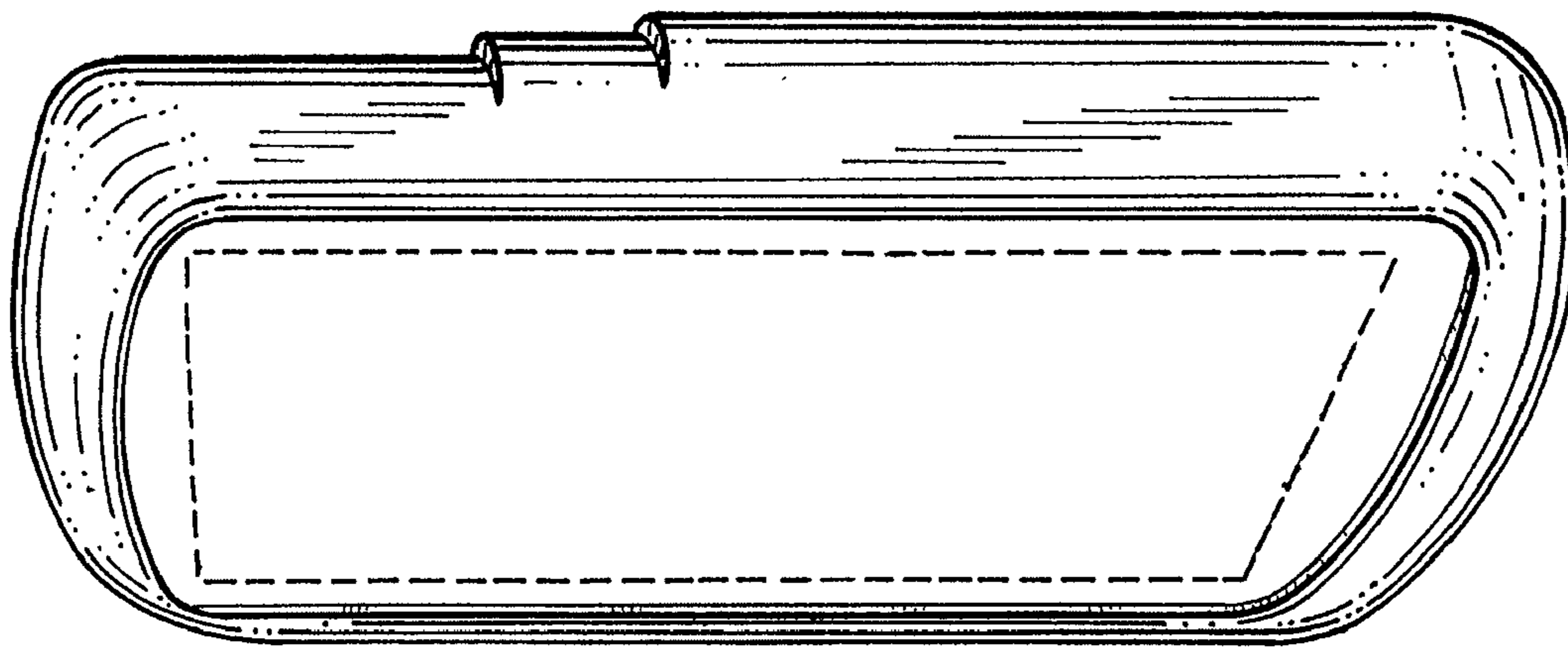

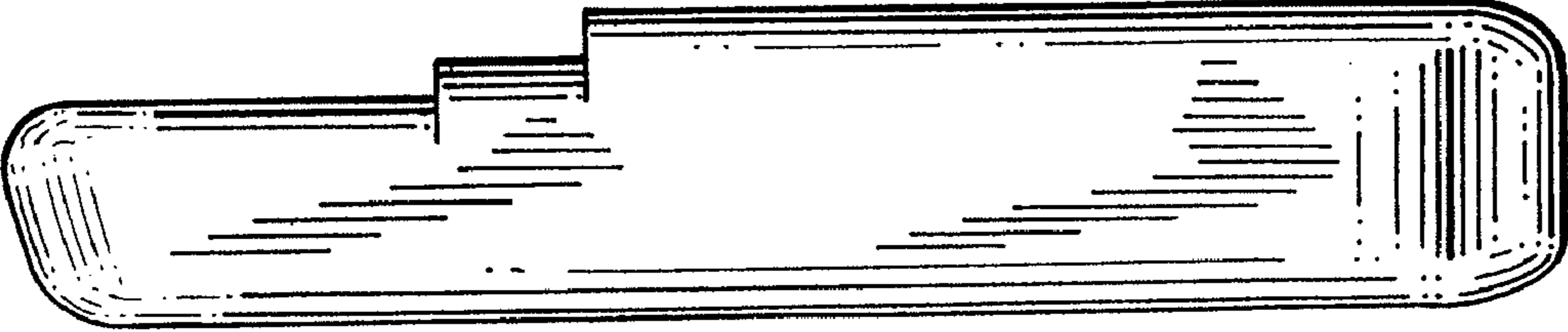

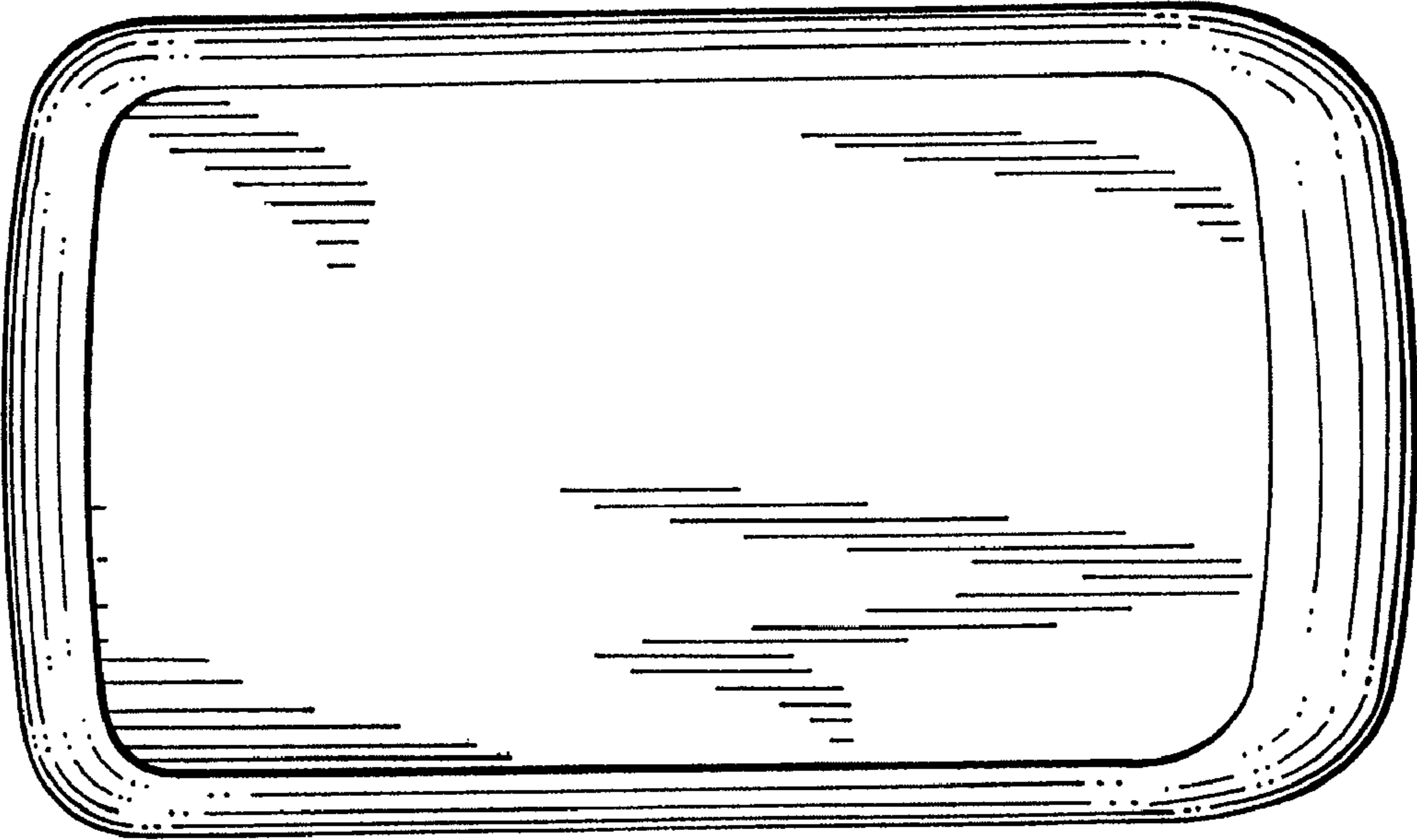

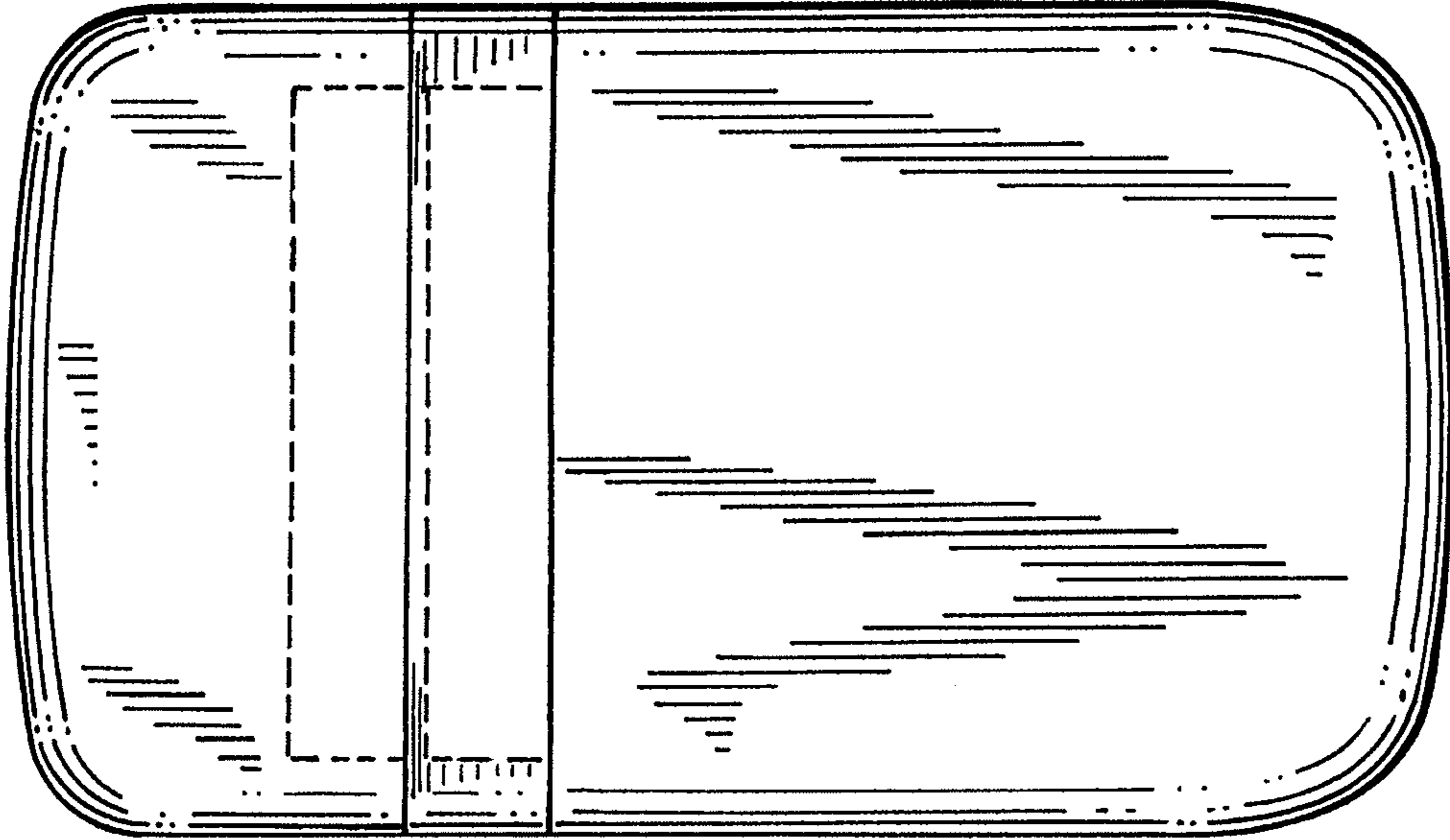
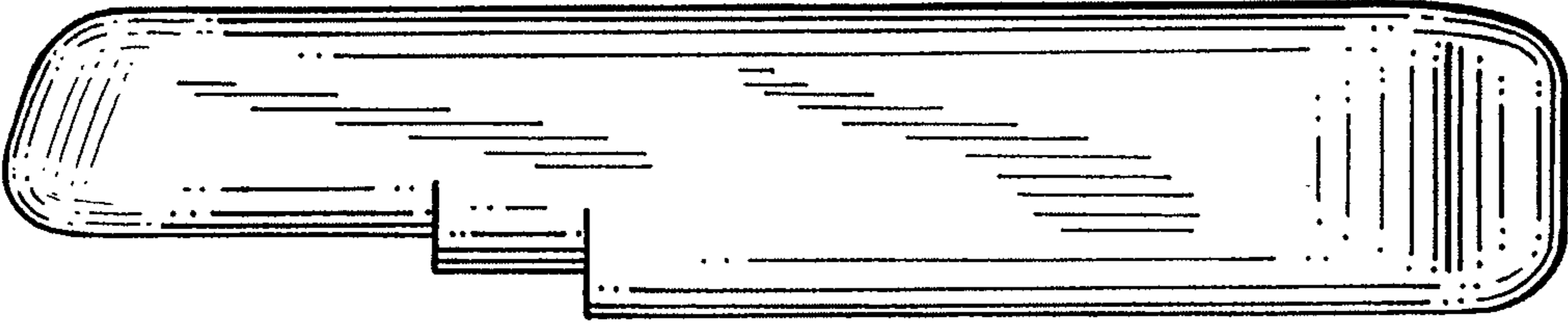
