(57) **CLAIM**

We claim the ornamental design for an engine coil cover, as shown and described.

**DESCRIPTION**

FIG. 7 is a bottom plan view of the engine coil cover of FIG. 1.

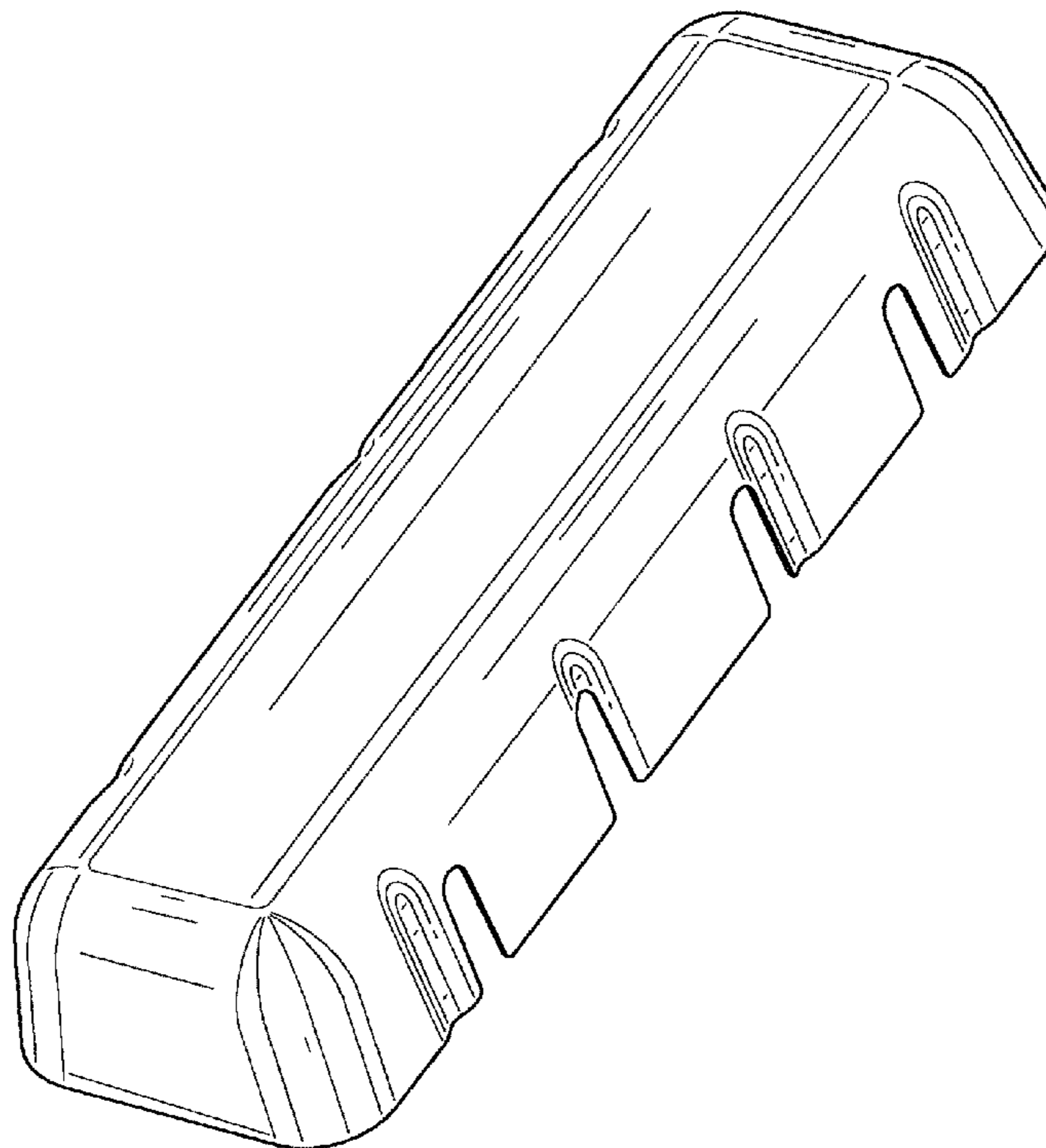

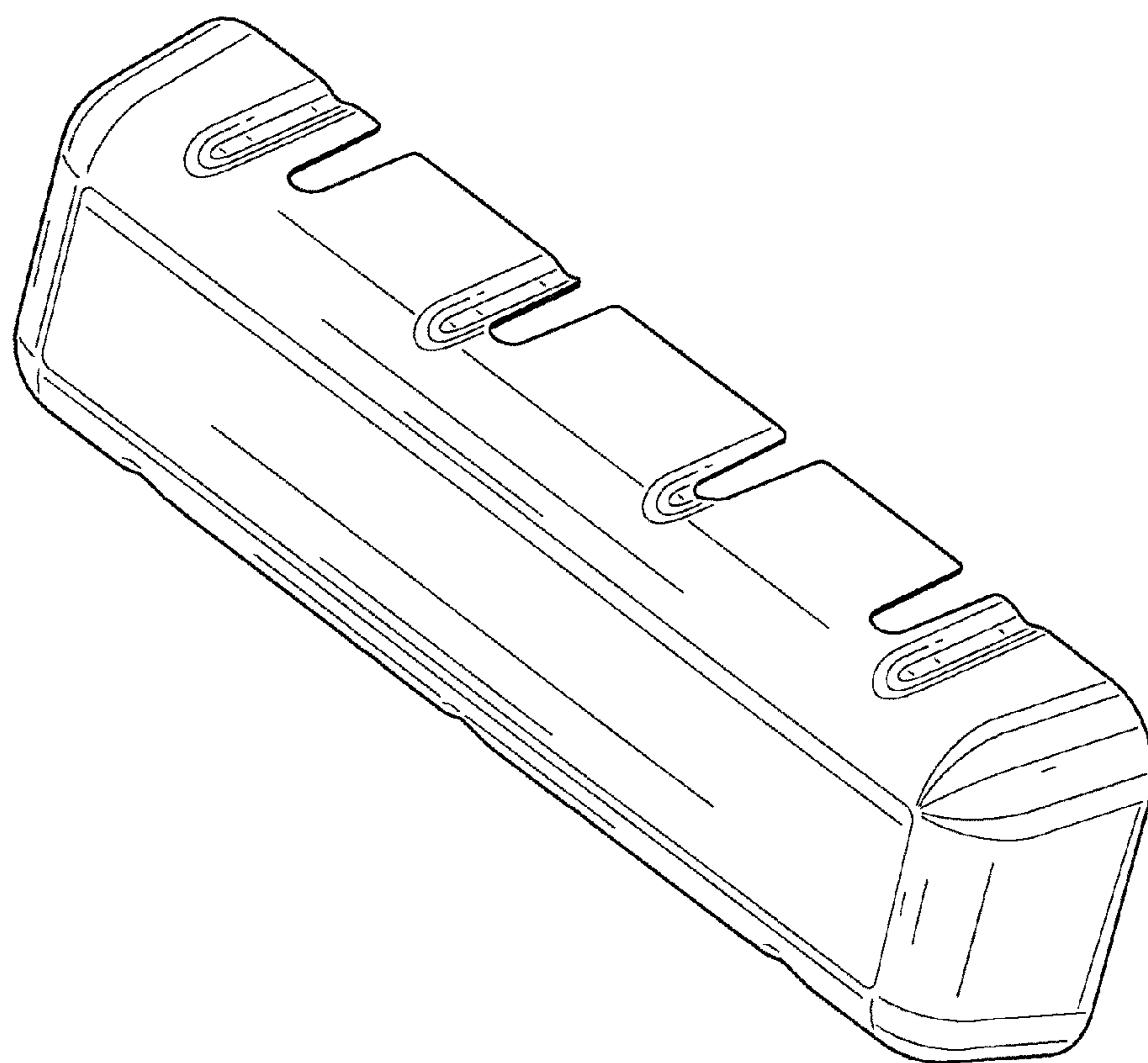

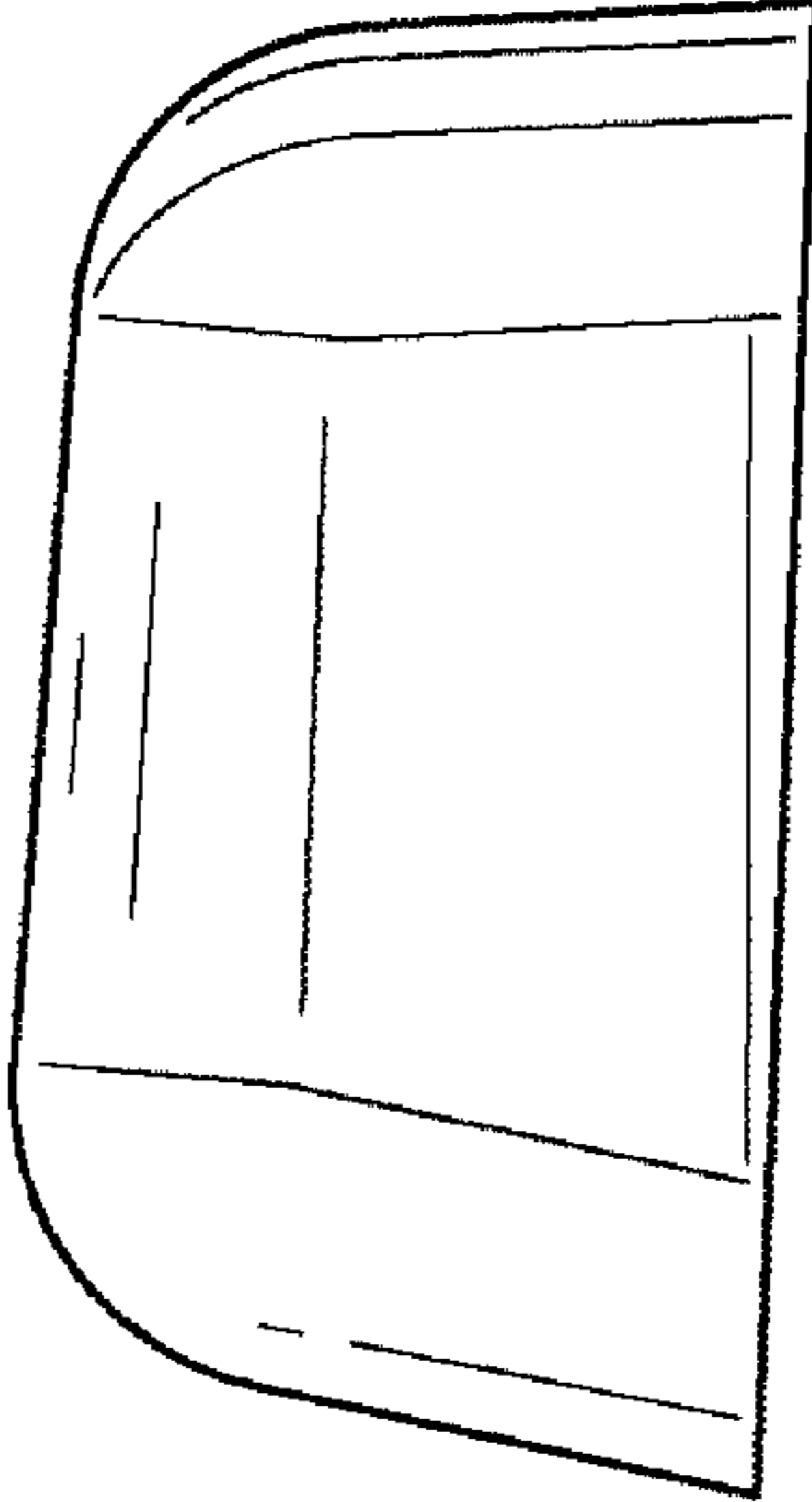

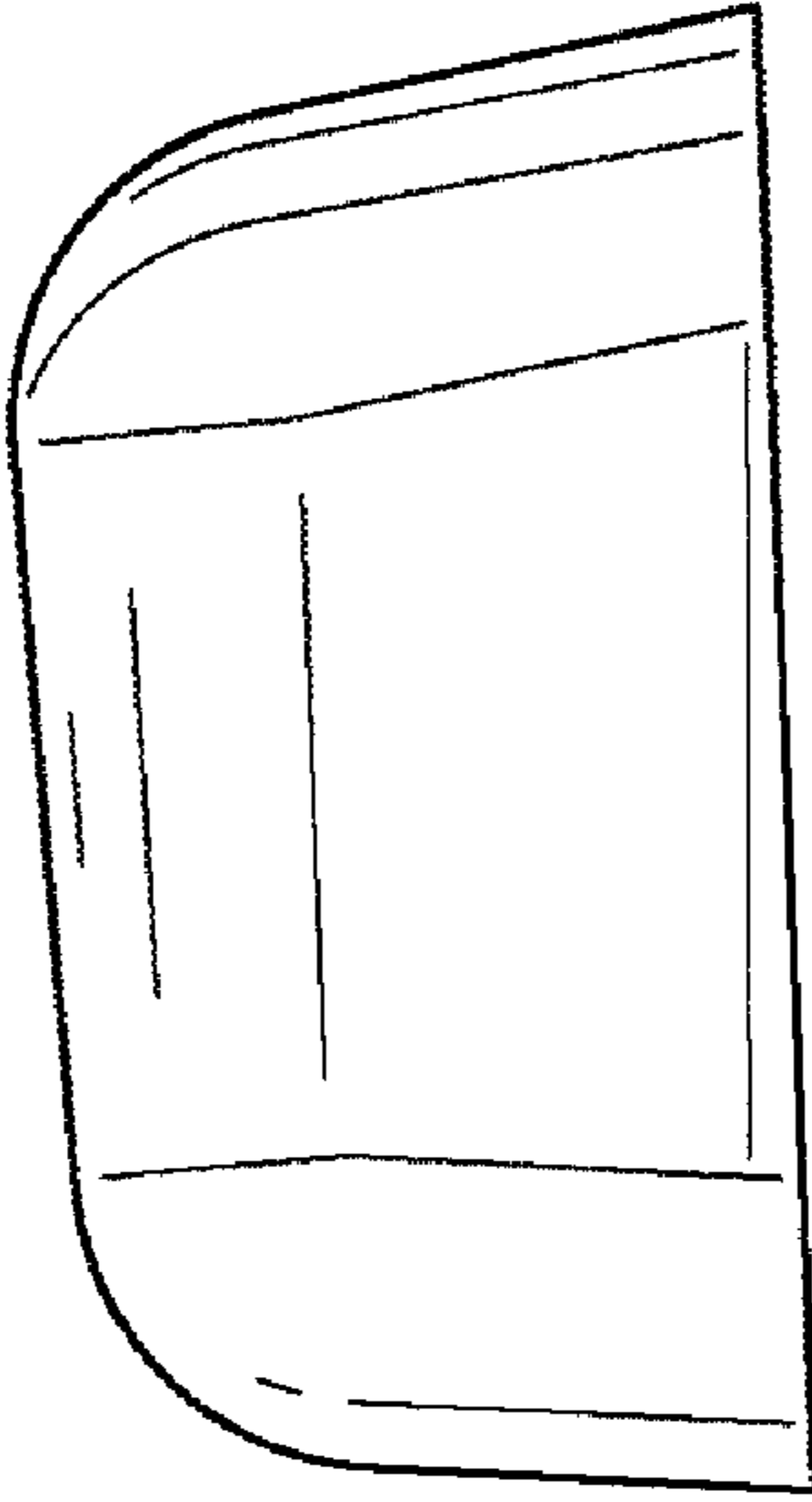

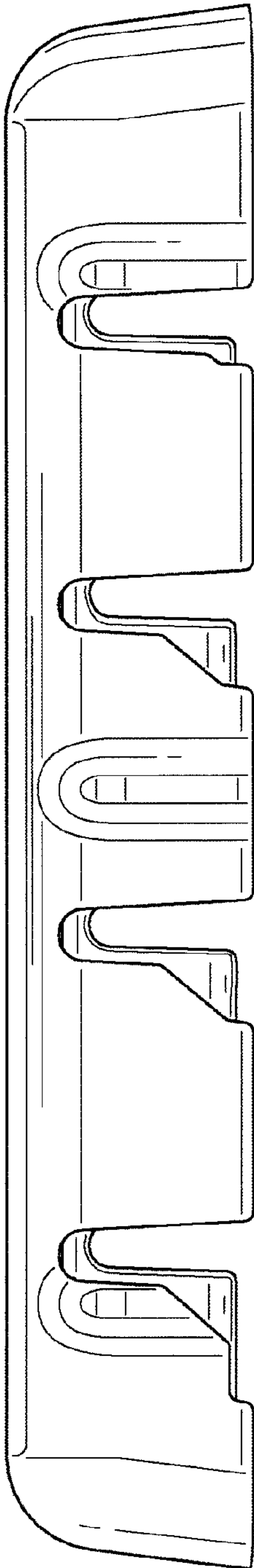

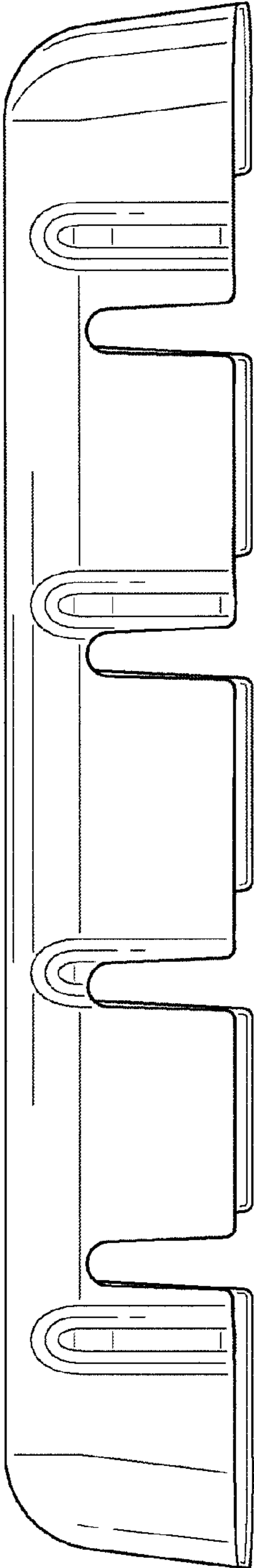

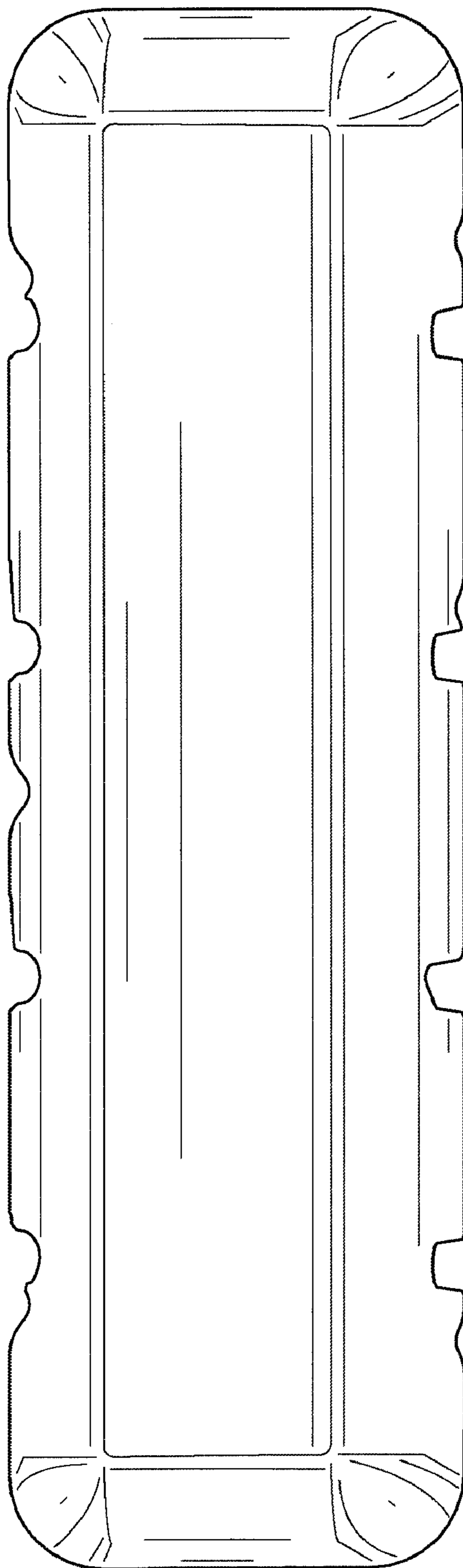

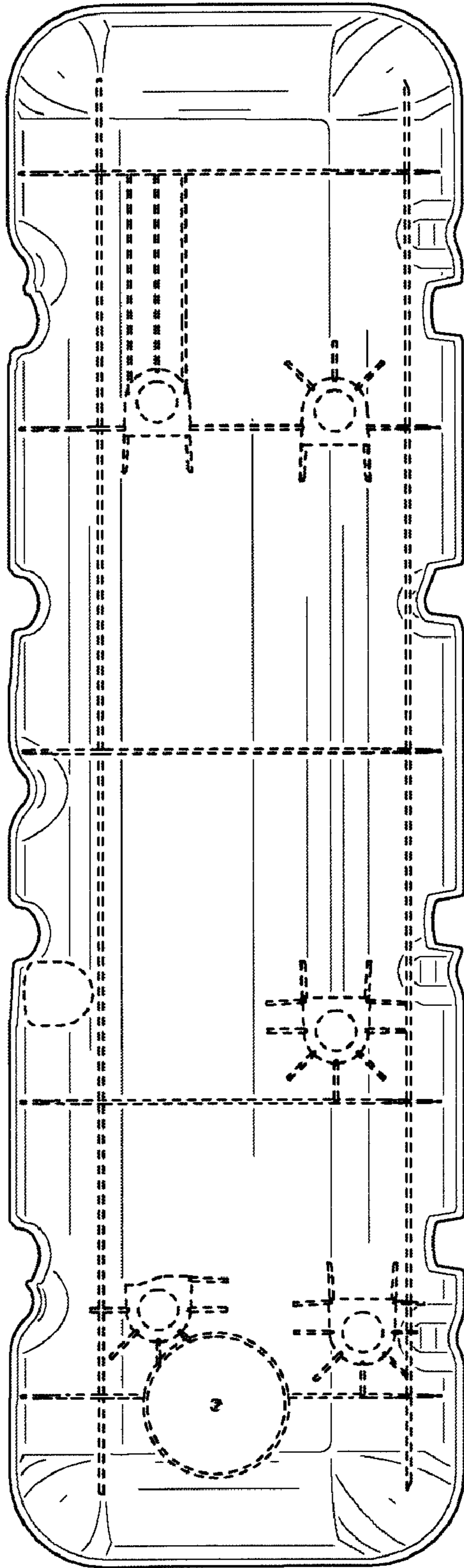
