(57) **CLAIM**

The ornamental design for a heart-shaped sleeve for a massage apparatus, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the heart-shaped sleeve for a massage apparatus, showing my design with the massage apparatus shown in phantom-line forming no part of the design;

FIG. 2 is a front view of the heart-shaped sleeve for a massage apparatus;

FIG. 3 is an opposing rear side view of the heart-shaped sleeve for a massage apparatus;

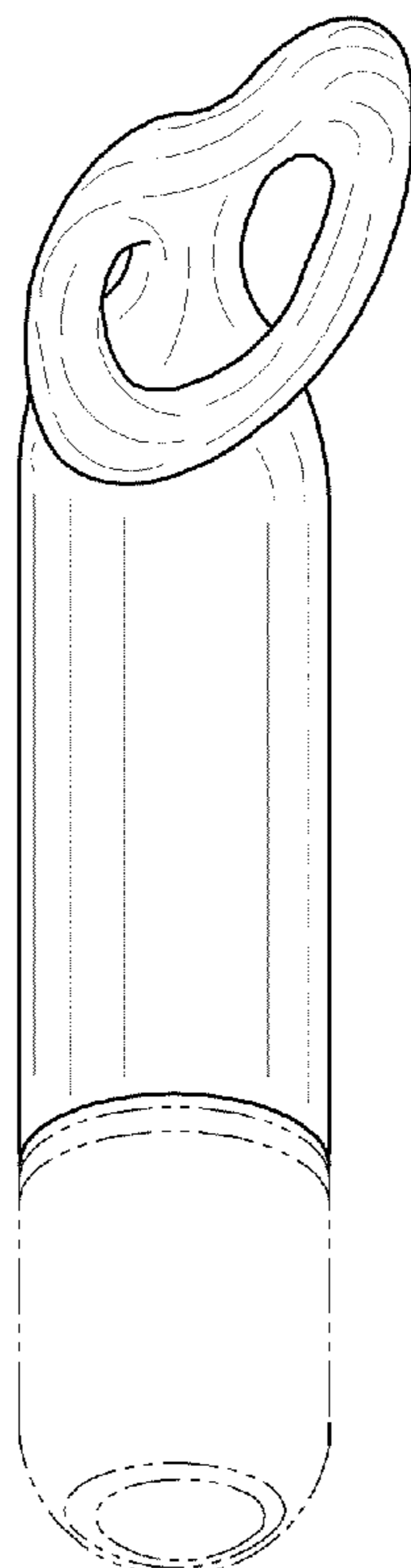
FIG. 4 is a left side view of the heart-shaped sleeve for a massage apparatus;

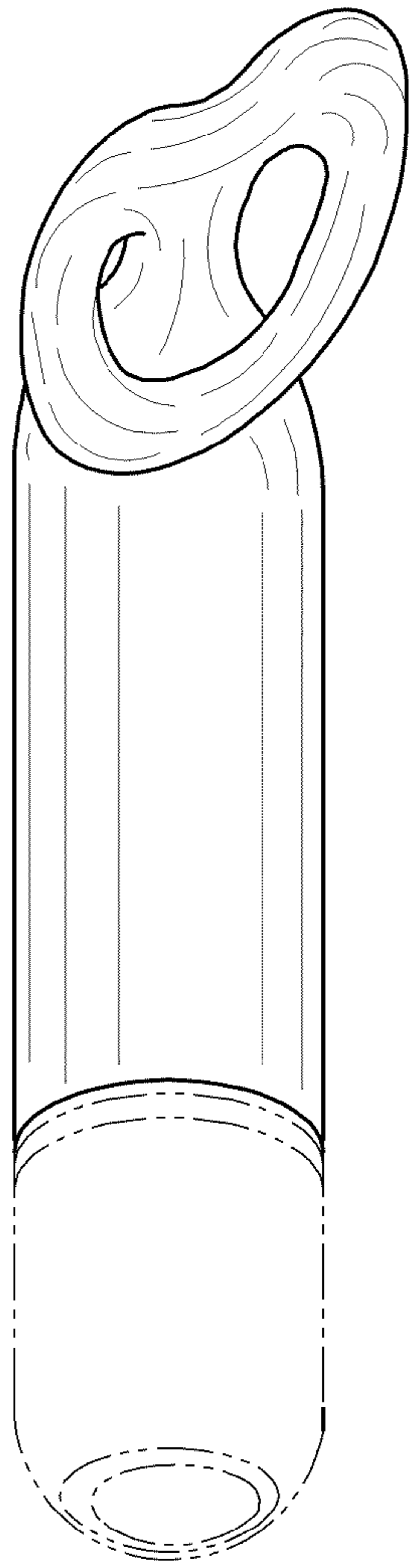

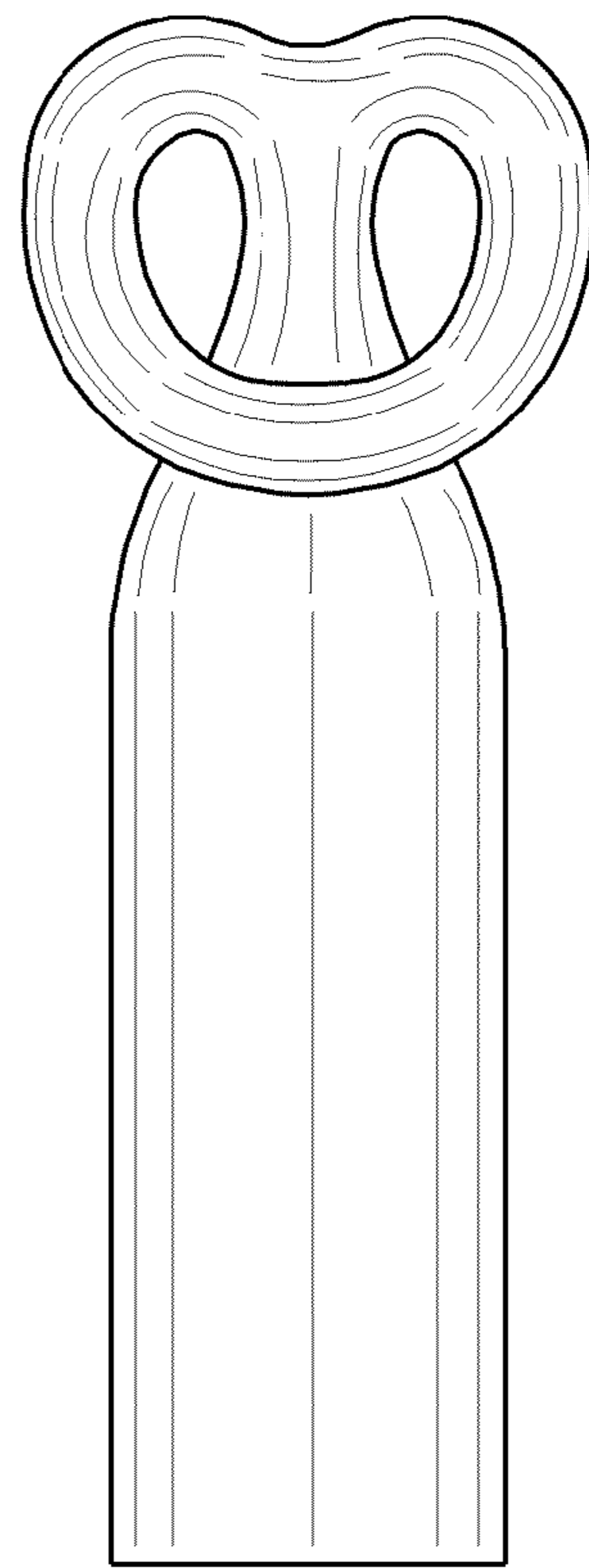

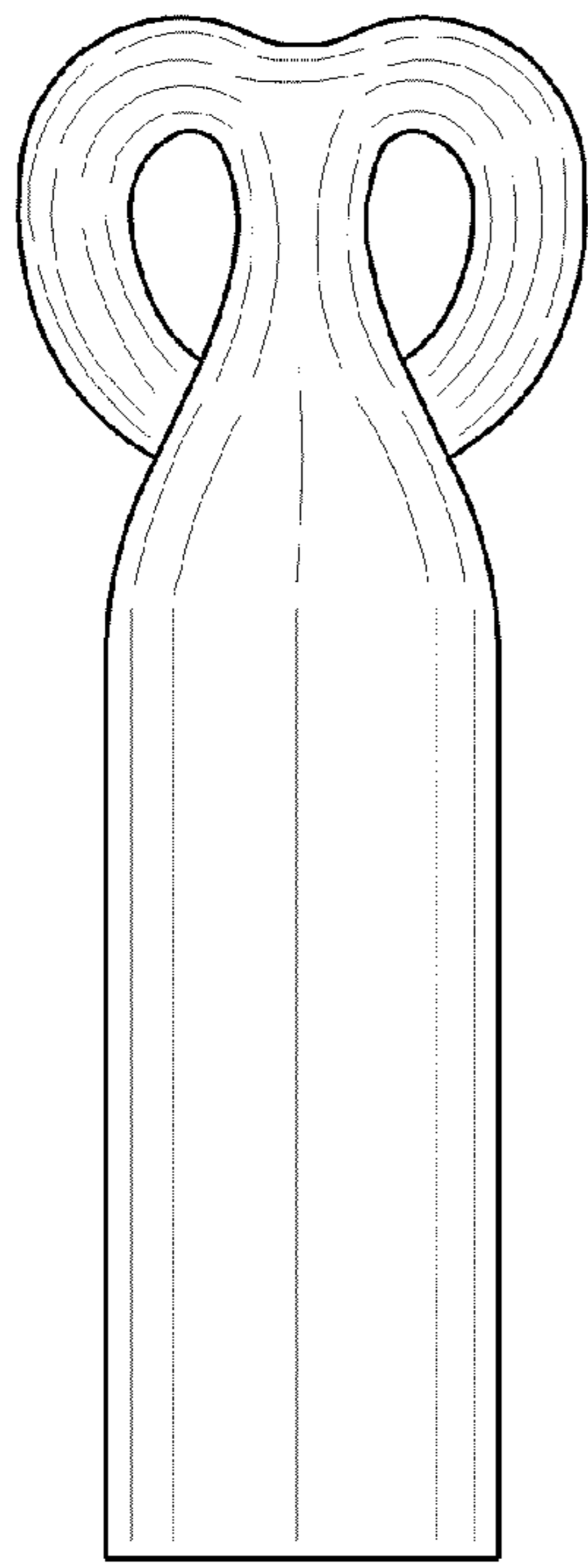

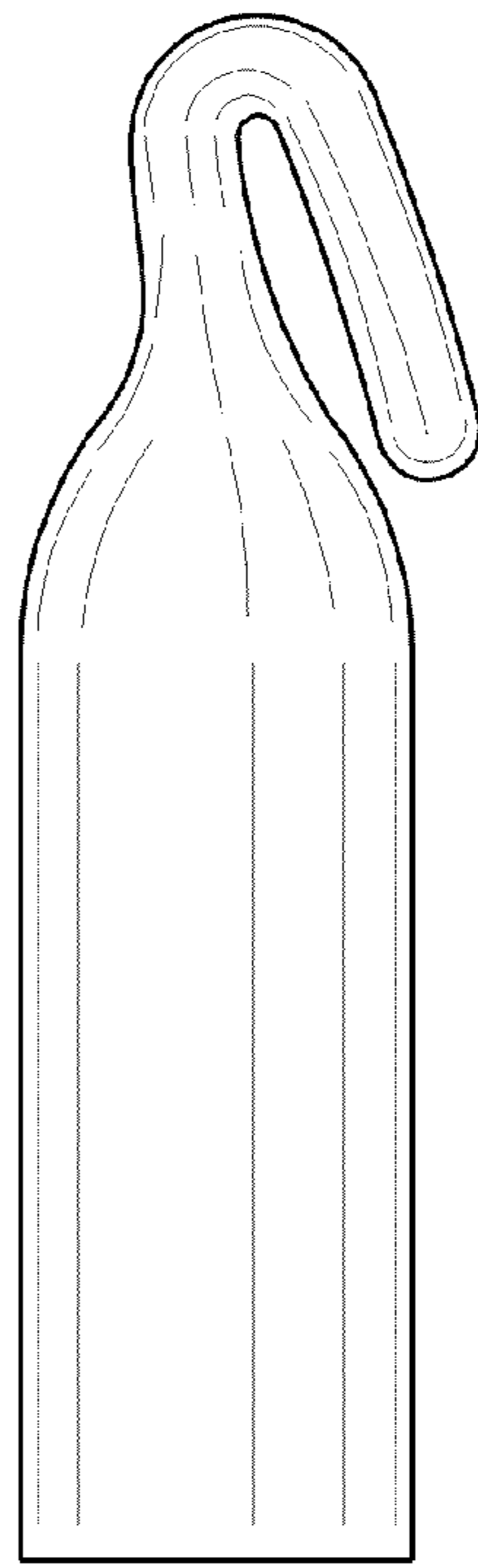

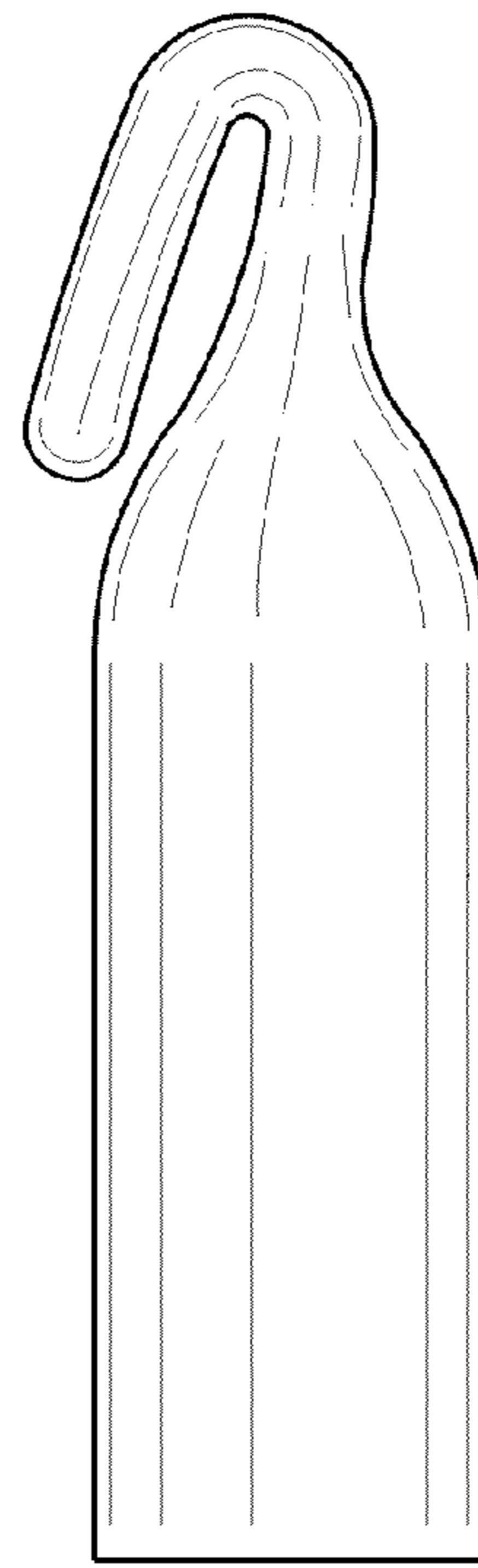

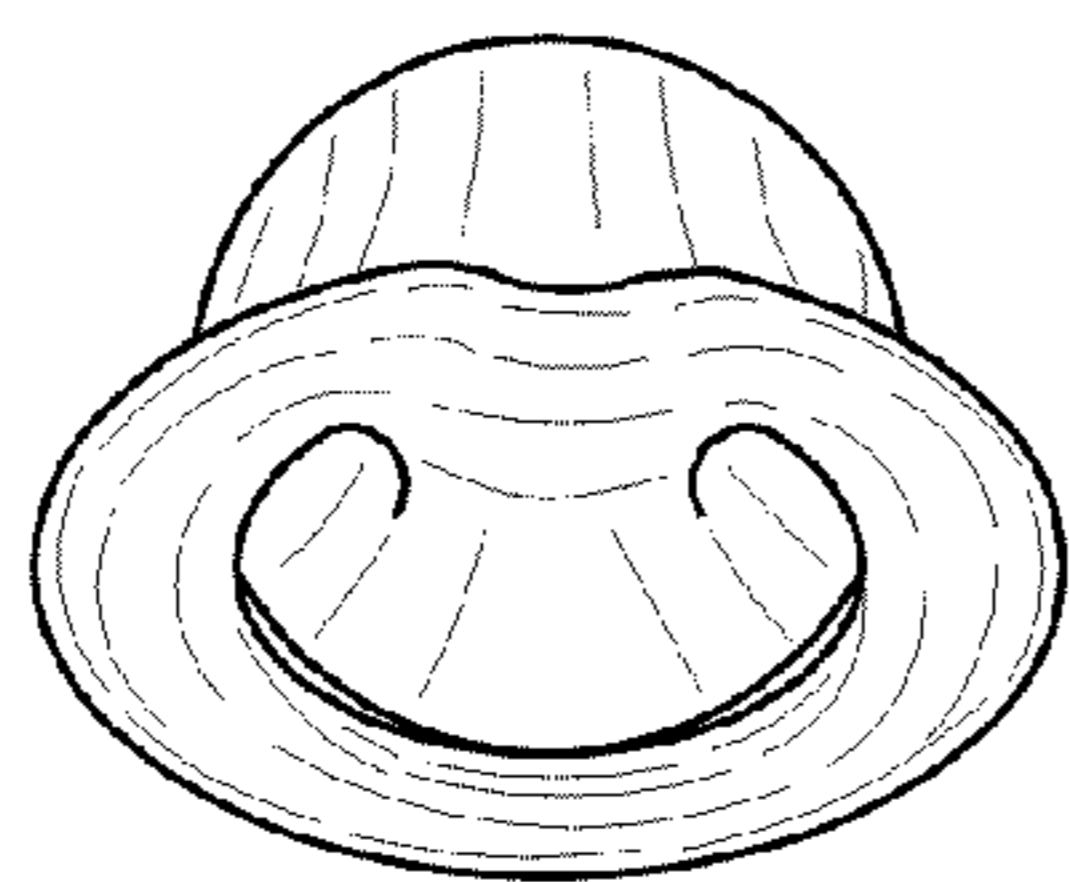

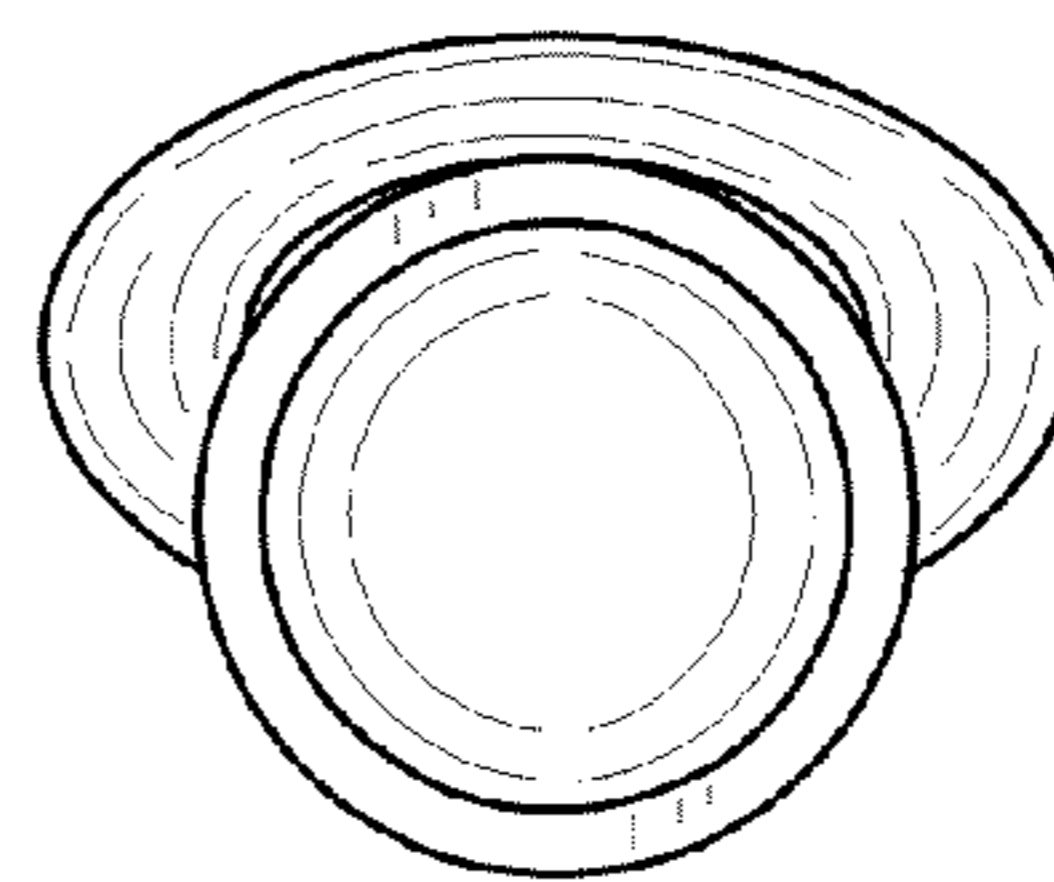
