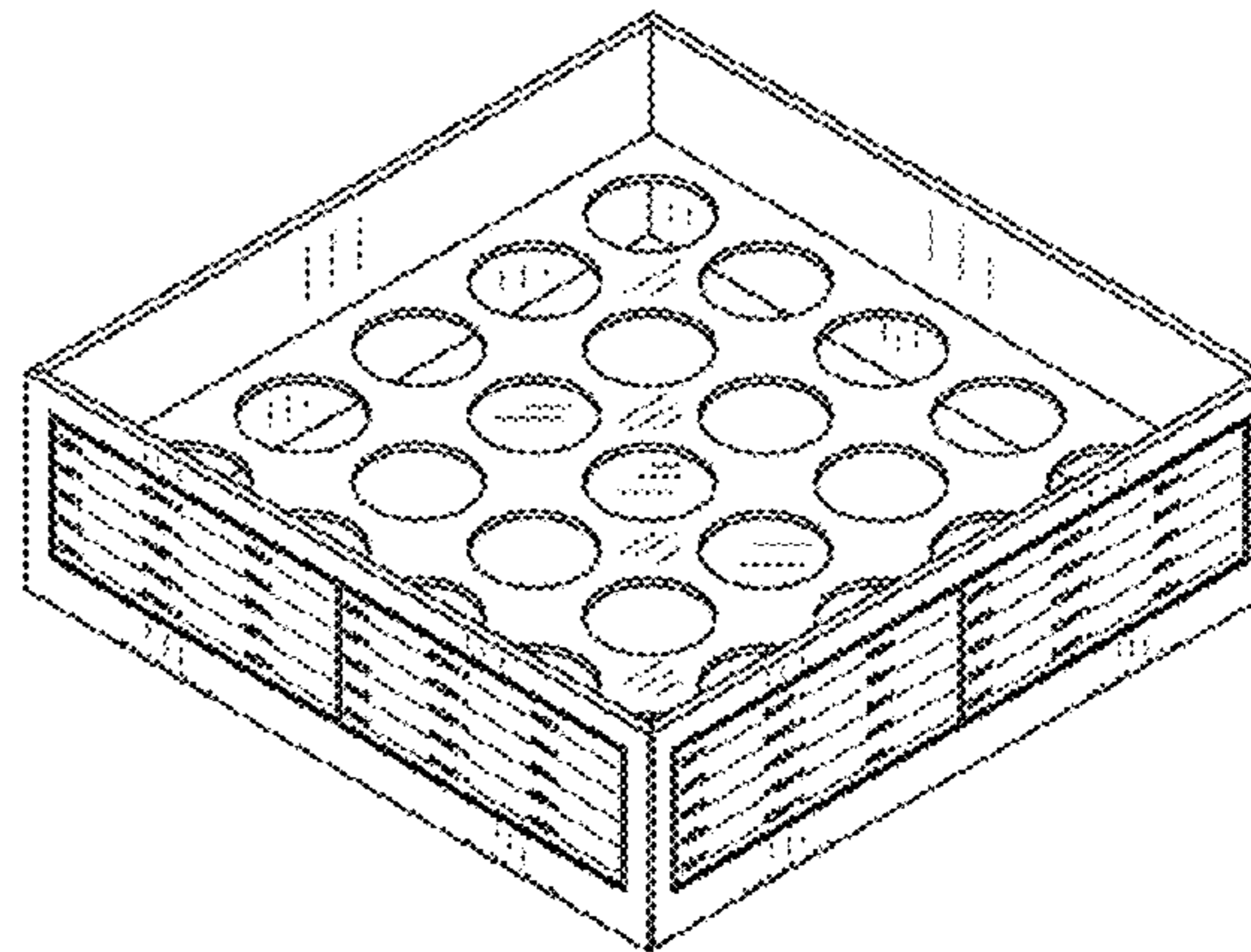
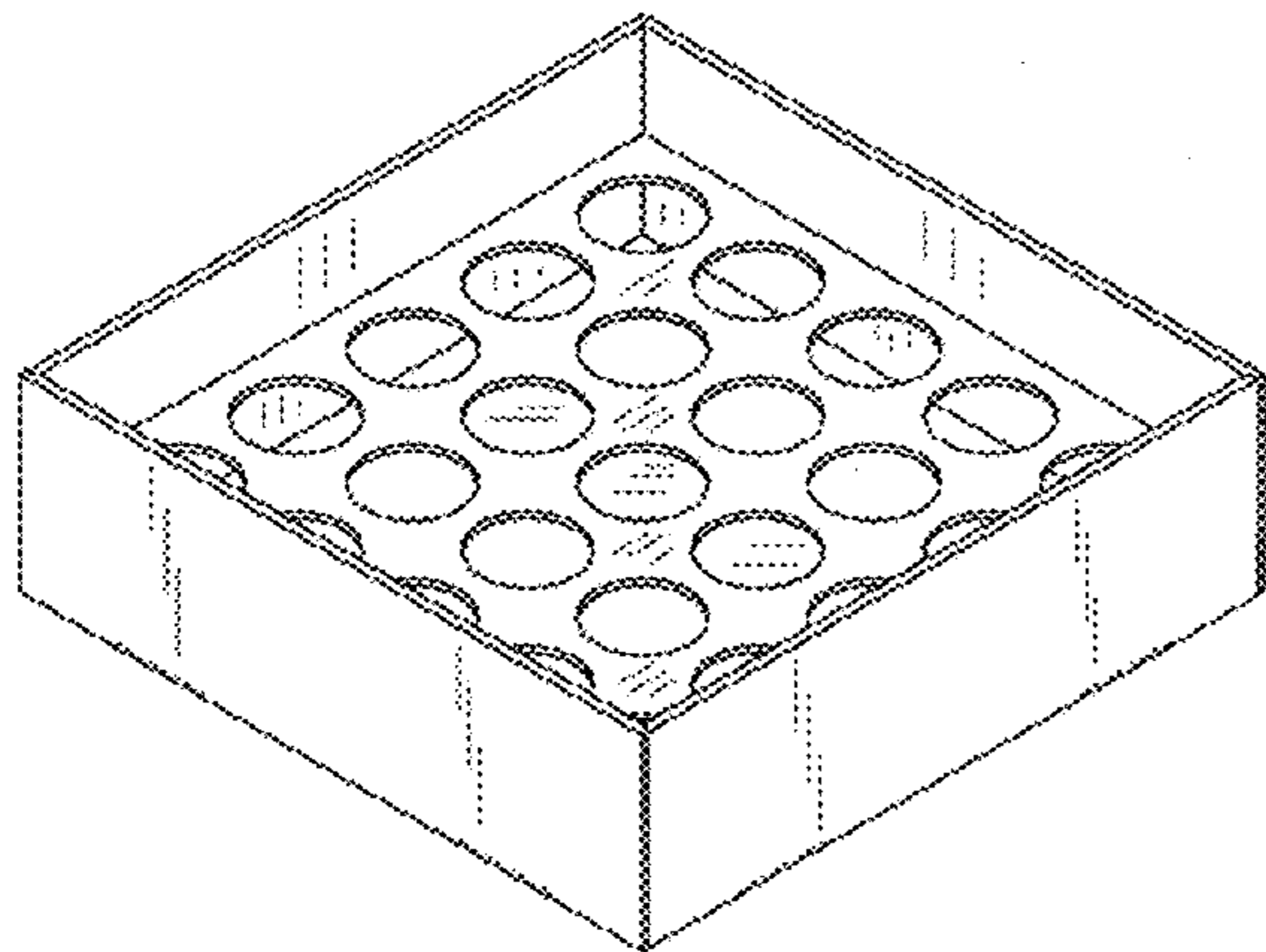
(57) **CLAIM**

The ornamental design for a vial container, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a vial container;
 FIG. 2 is a front elevational view thereof wherein the rear elevational view is a mirror image;
 FIG. 3 is side elevational view thereof wherein the other side is a mirror image;
 FIG. 4 is a top view thereof;
 FIG. 5 is a bottom view thereof;
 FIG. 6 is front perspective view of a second embodiment of a vial container;
 FIG. 7 is a front elevational view thereof wherein the rear elevational view is a mirror image;
 FIG. 8 side elevational view thereof wherein the other side is a mirror image; and,
 FIG. 9 is an enlarged view of the front or side view of the second embodiment to illustrate indicia.
 The top view and bottom view of the second embodiment are mirror images of the first embodiment.
 All broken lines are for illustrative purposes only, and form no part of the claimed design.

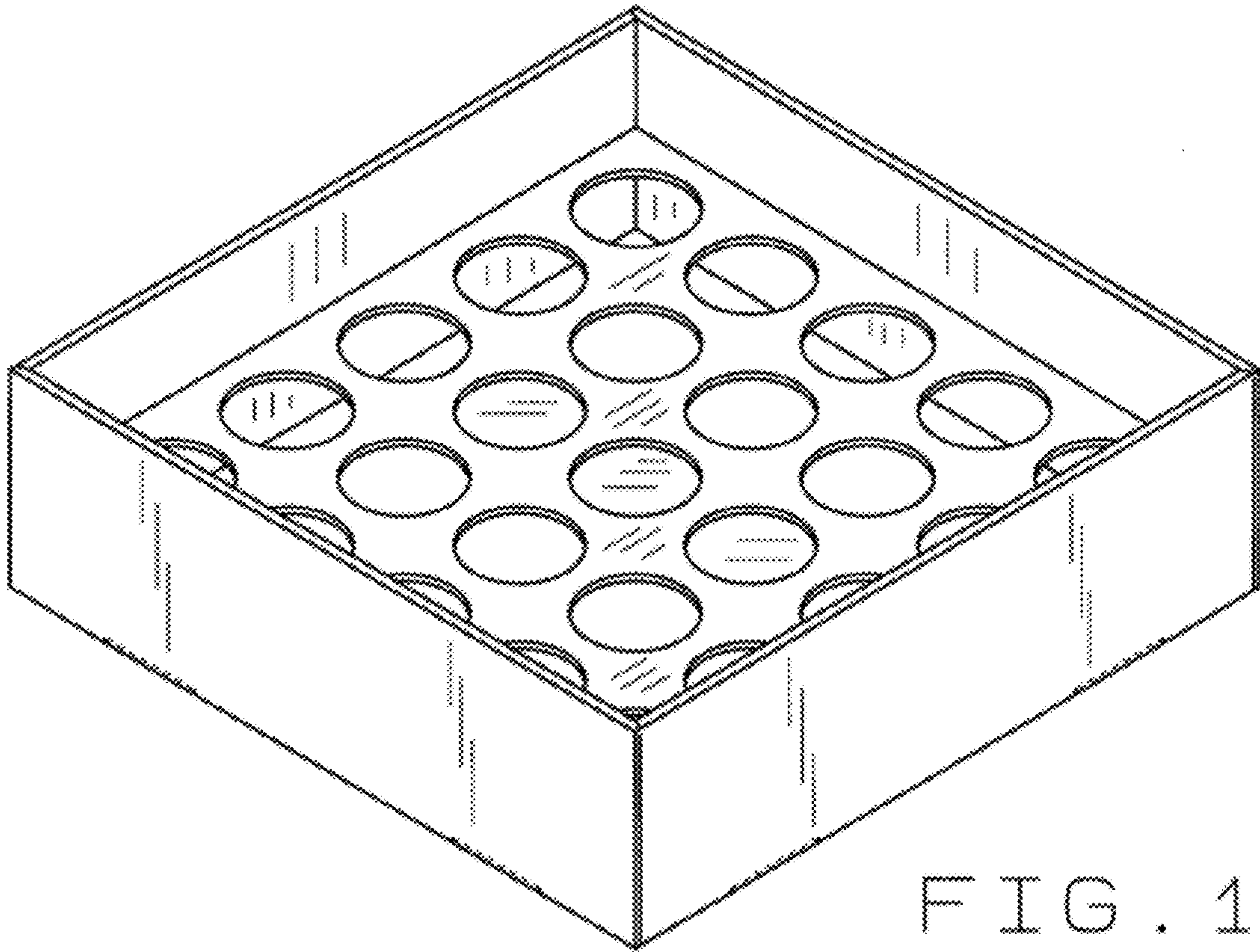

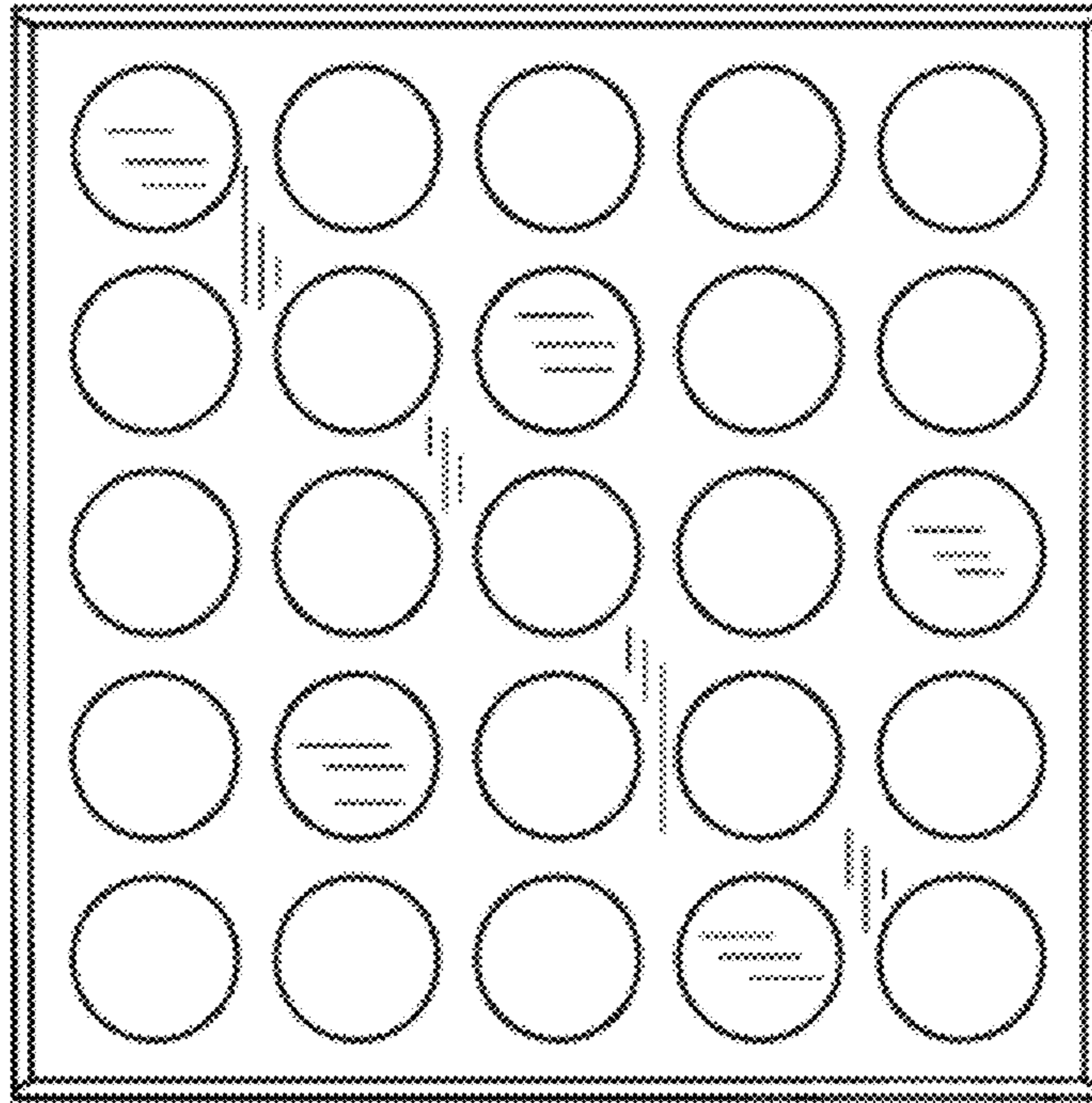

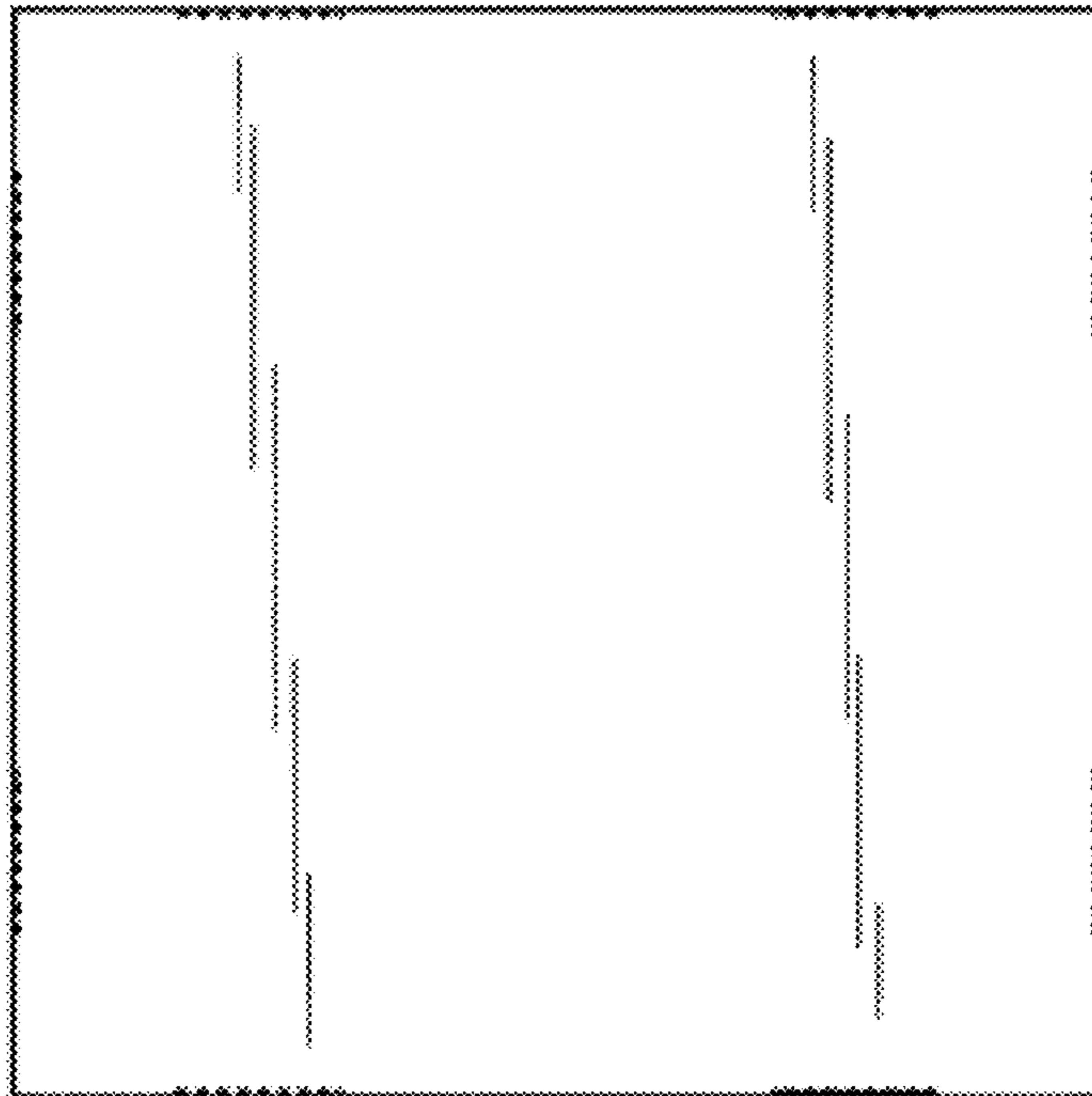

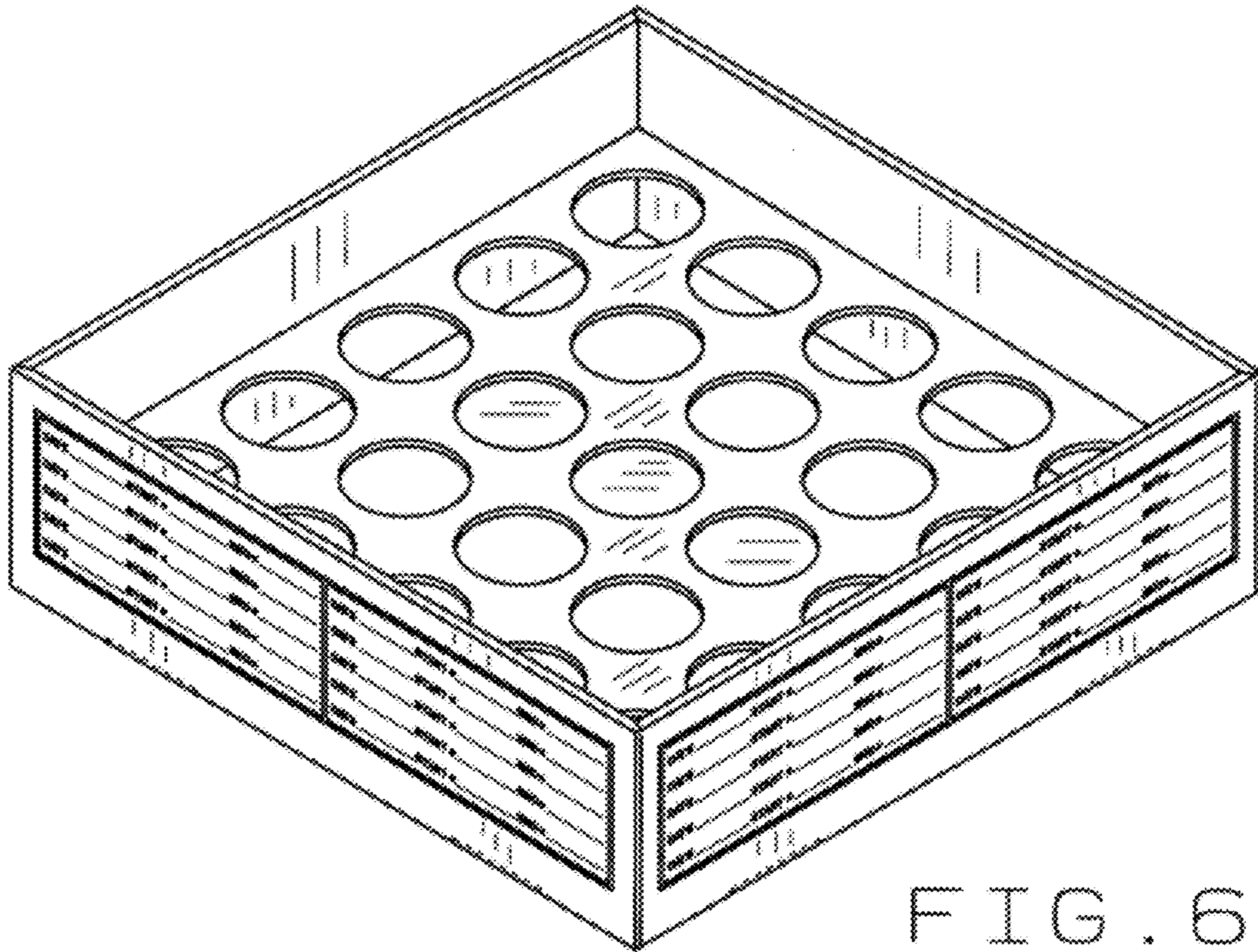

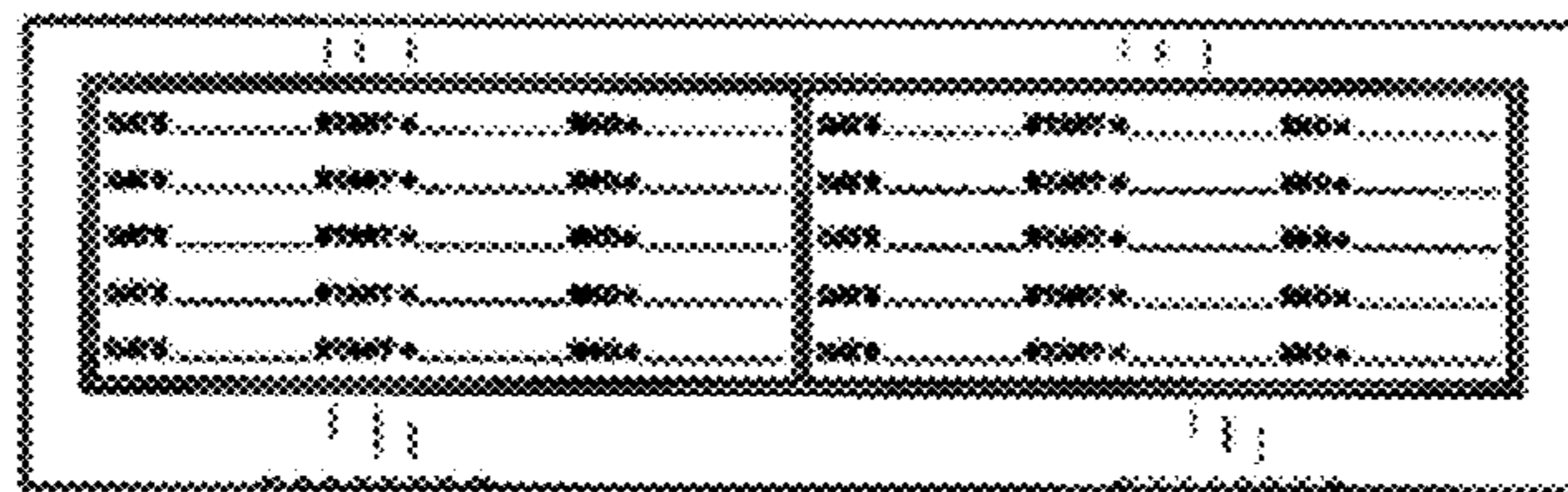

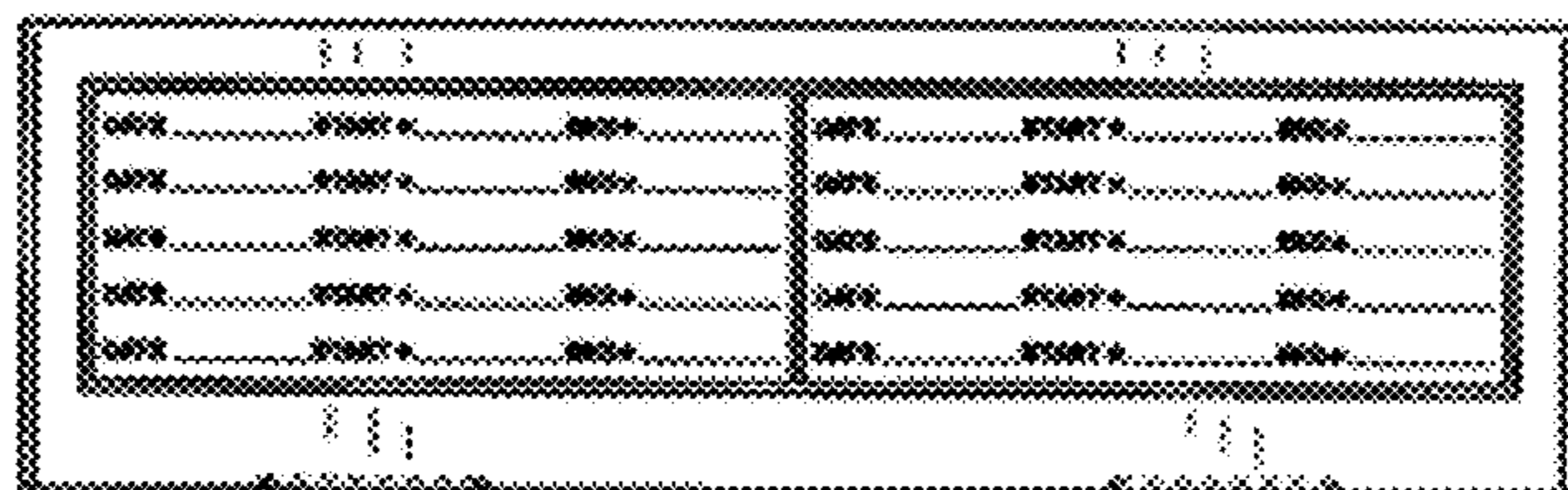
