FIG. 2 is a bottom perspective view of a surface mounted light fixture therefor;

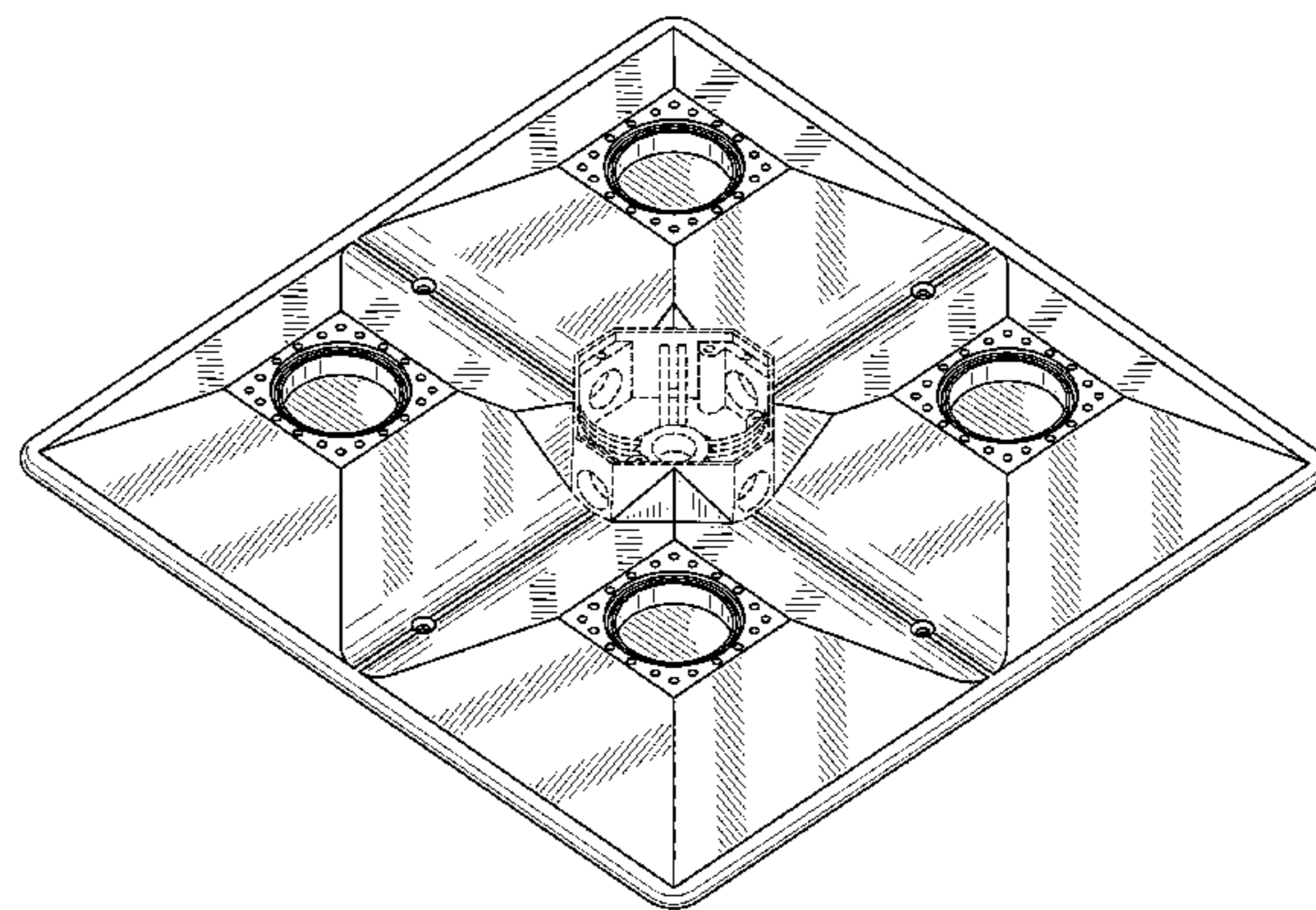
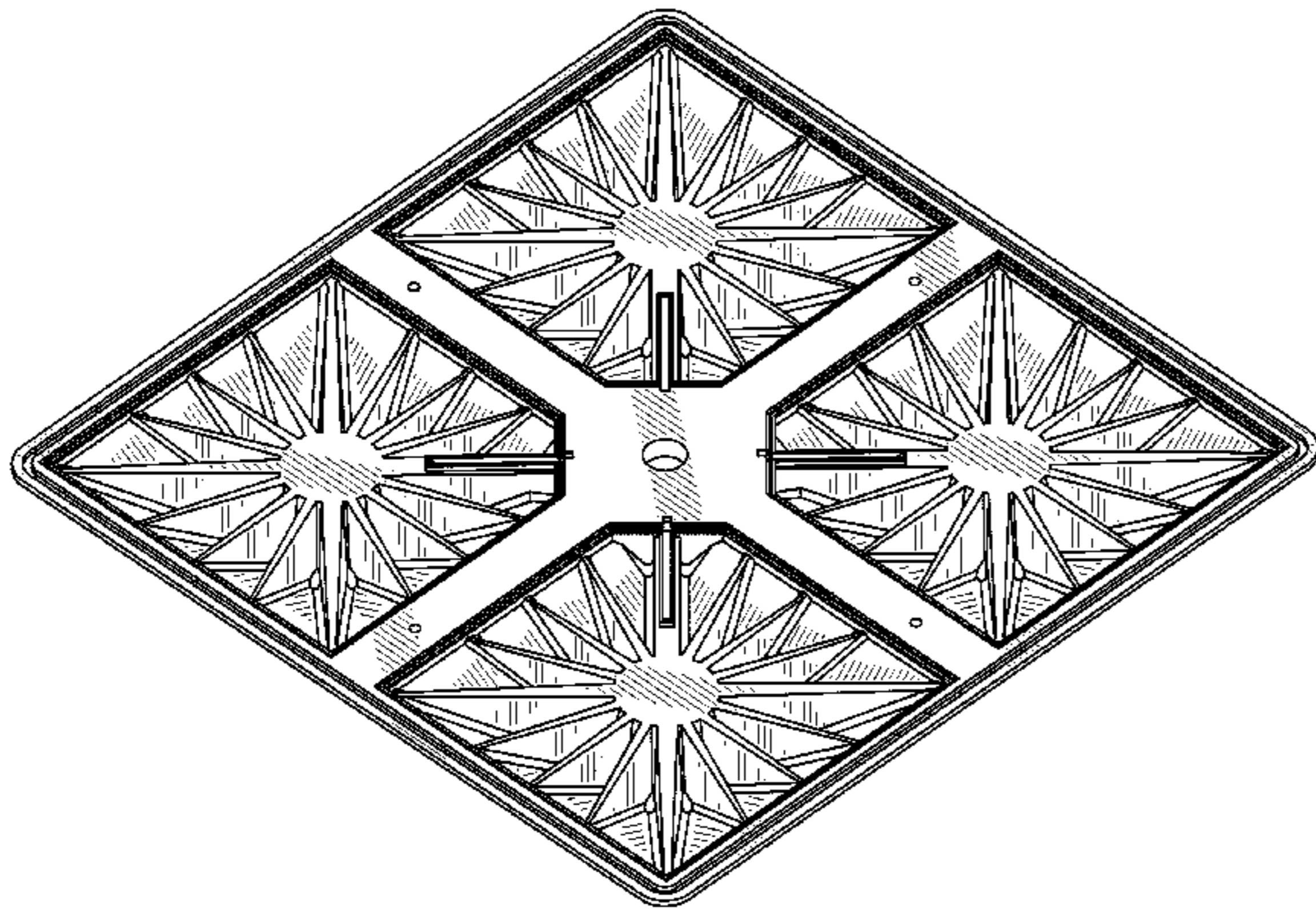
FIG. 3 is a top view therefor;

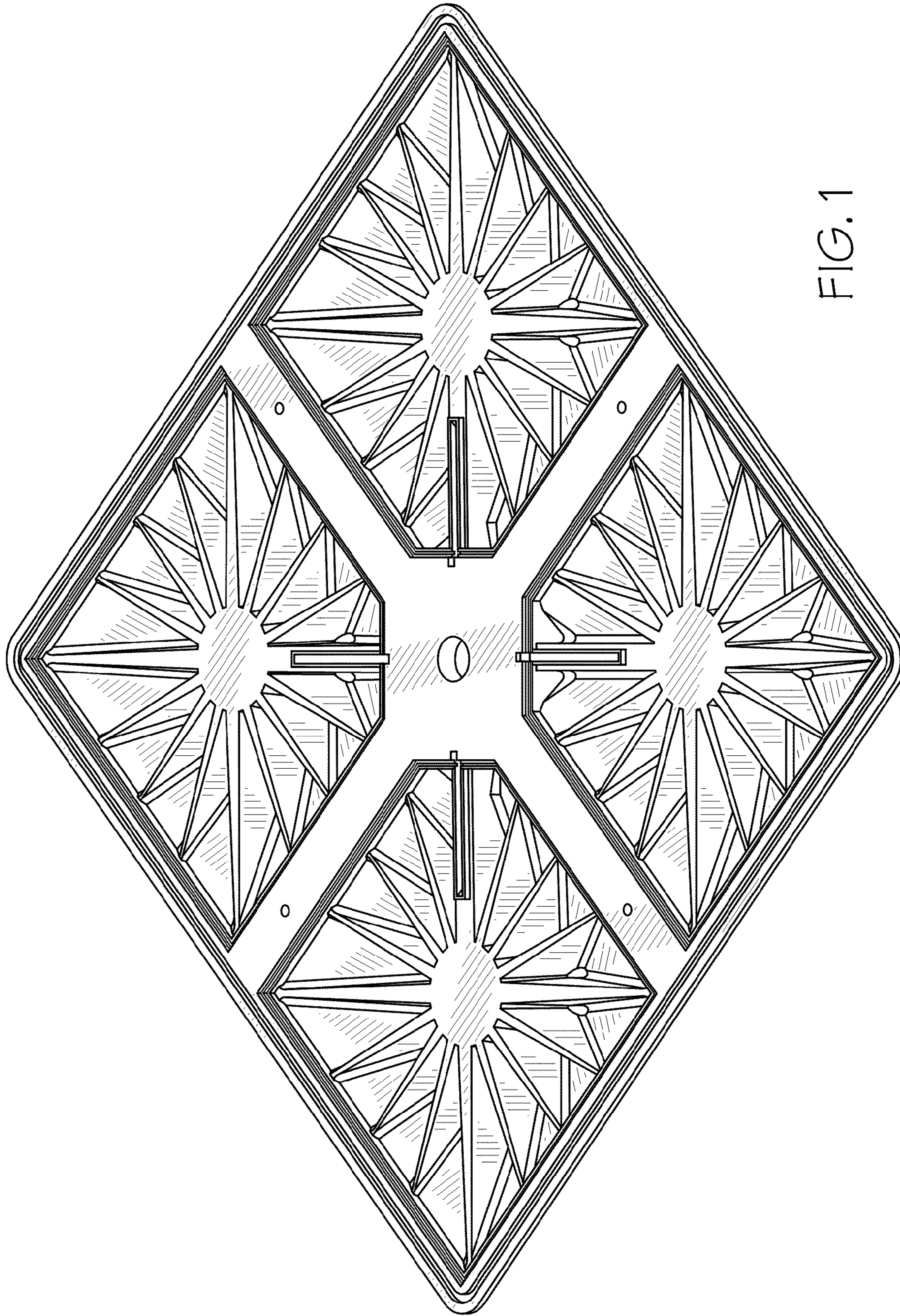

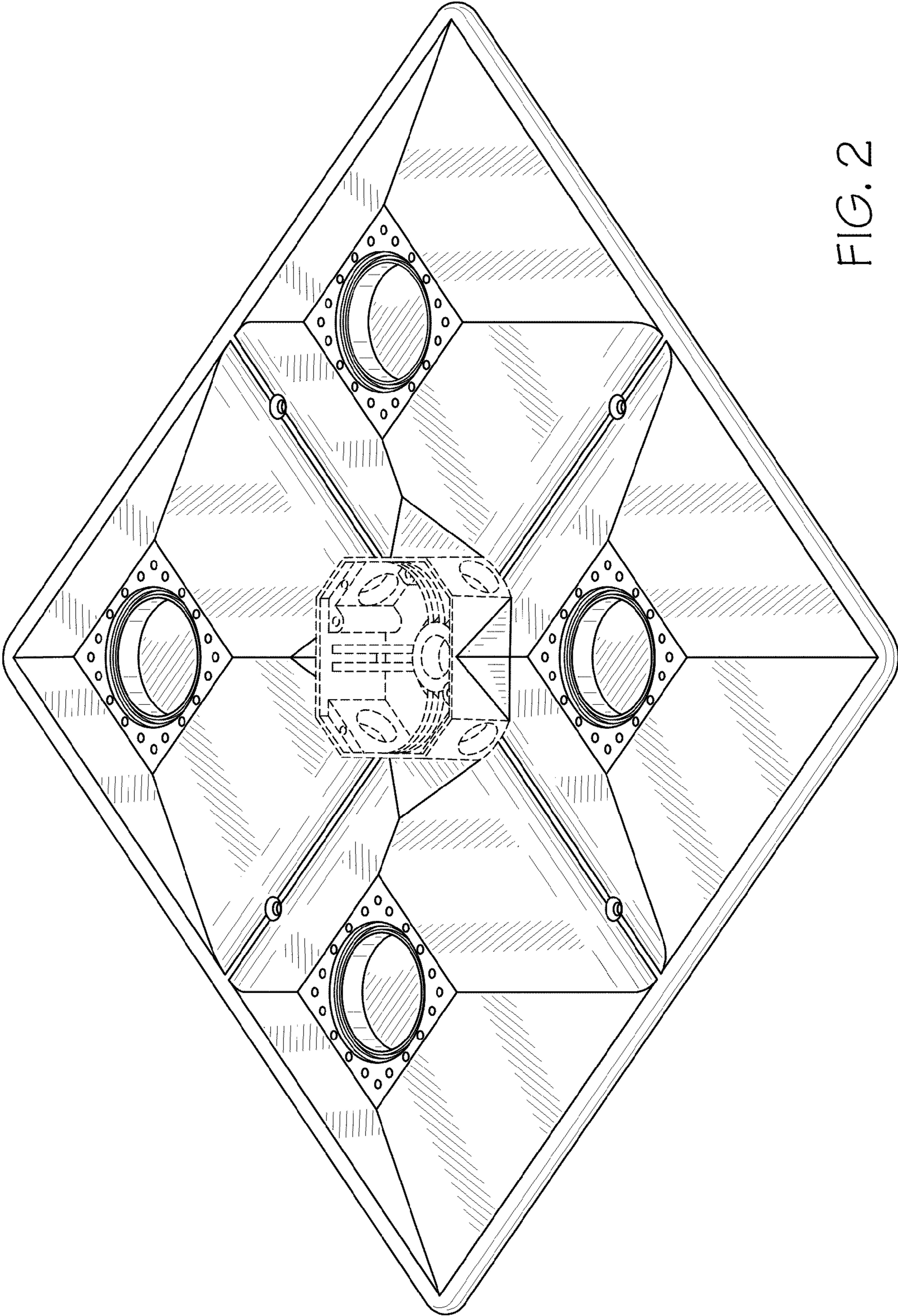

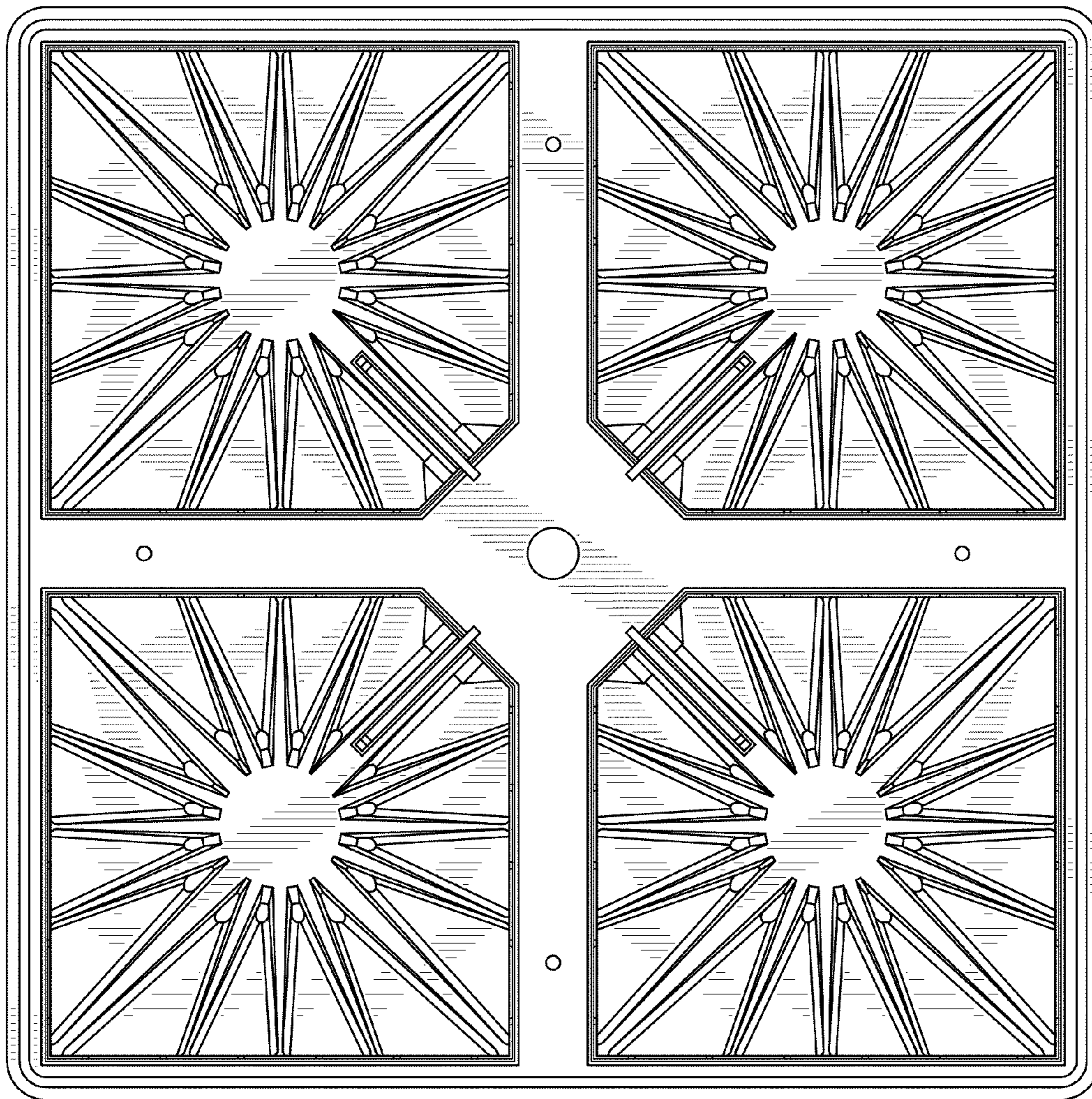

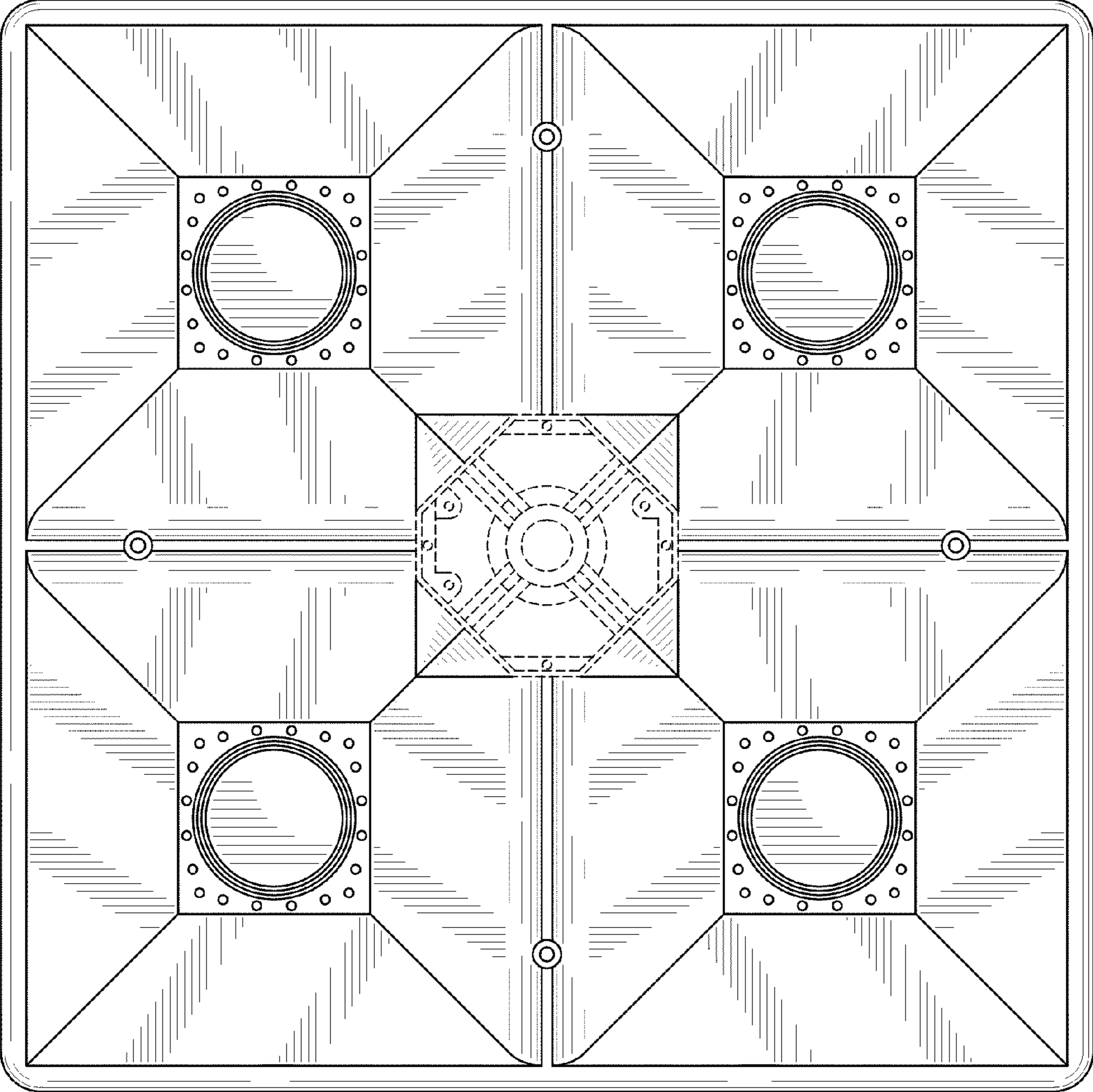

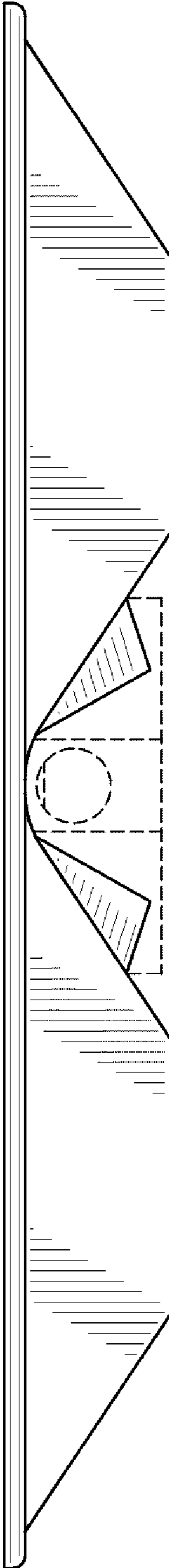
