(57) **CLAIM**

We claim the ornamental design for a sweatshirt, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of a sweatshirt, showing our new design with a right arm thereof in a raised position;

FIG. 2 is a front elevational view thereof, illustrated with the right arm in a lowered position;

FIG. 3 is a rear elevational view of FIG. 2;

FIG. 4 is a left-side elevational view of FIG. 2;

FIG. 5 is a right-side elevational view of FIG. 2;

FIG. 6 is a top plan view of FIG. 2;

FIG. 7 is a bottom plan view of FIG. 2;

FIG. 8 is a perspective view of a second embodiment of the design, showing the right arm thereof in the raised position;

FIG. 9 is a front elevational view of FIG. 8, illustrated with the right arm in a lowered position;

FIG. 10 is a rear elevational view of FIG. 9;

FIG. 11 is a left-side elevational view of FIG. 9;

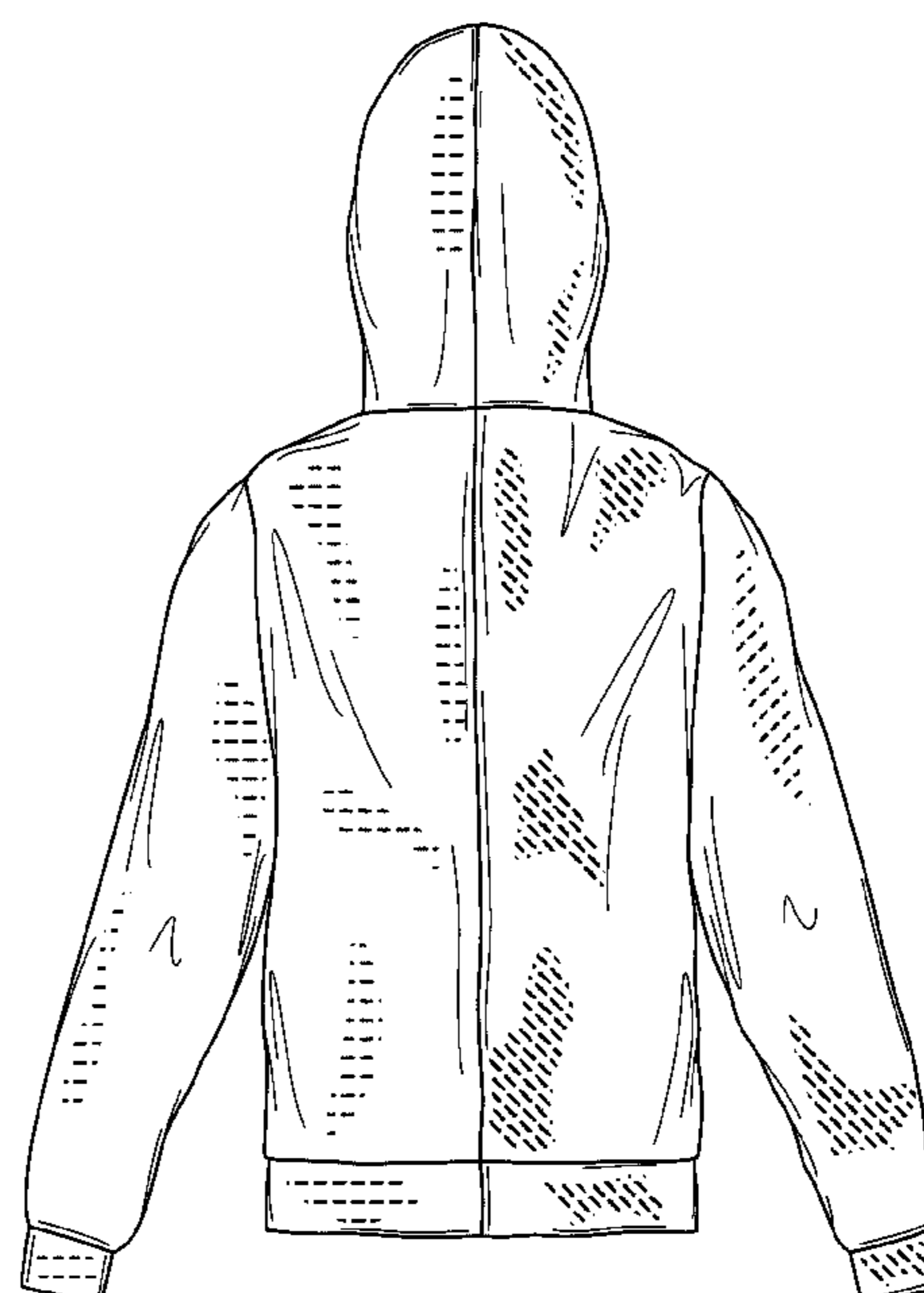
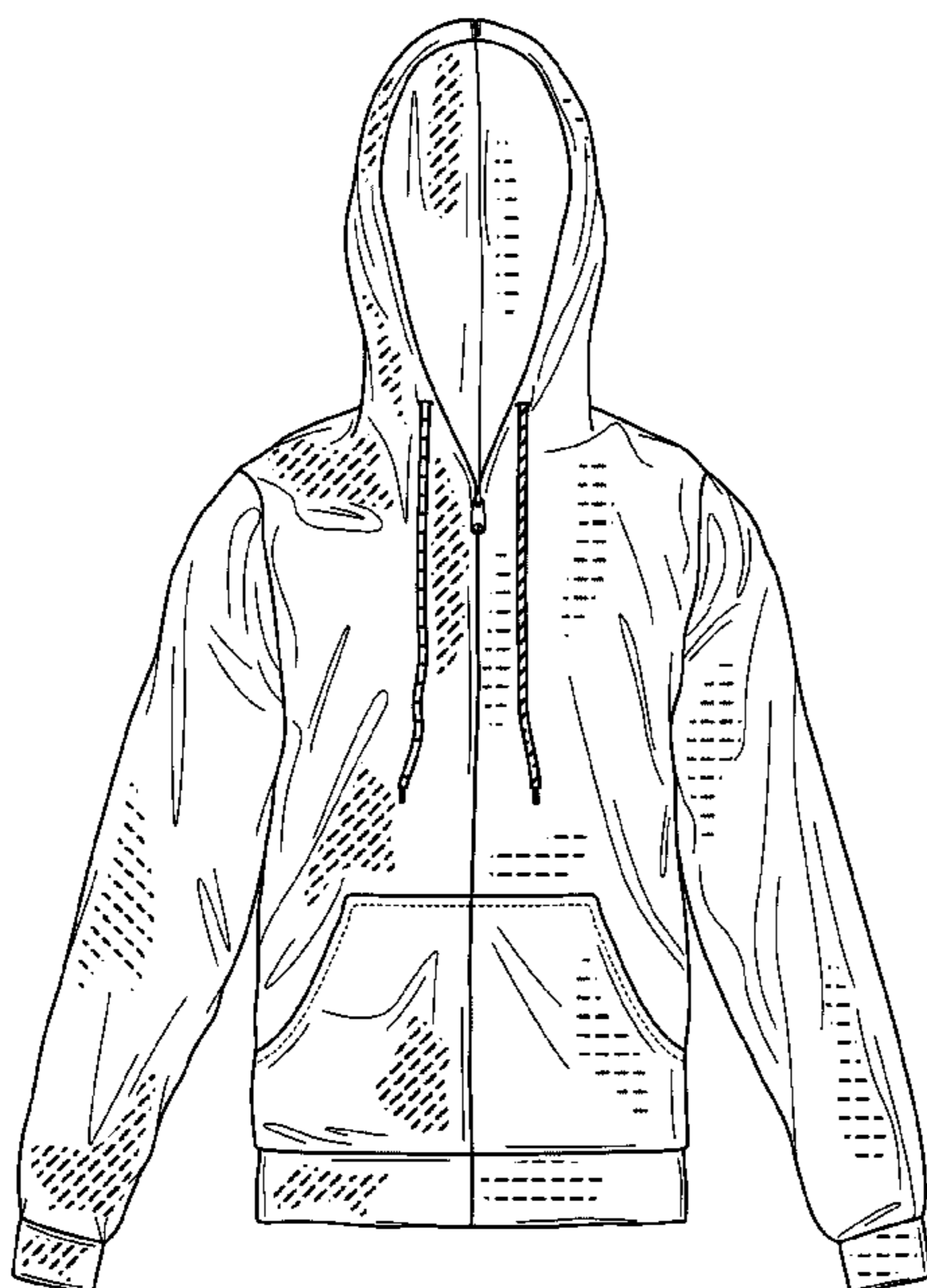
FIG. 12 is a right-side elevational view of FIG. 9;

FIG. 13 is a top plan view of FIG. 9; and,

FIG. 14 is a bottom plan view of FIG. 9.

The broken lines showing a person in FIGS. 1 and 8 depict environmental matter and form no part of the claimed design. The different shading patterns on either side of the design denotes contrasting colors evenly applied to each side; further, it is intended that the right-side draw string visible in FIGS. 1, 2, 8 and 9 is of the same color as the left-side of the design, and the left-side draw string is of the same color as the right-side of the design. The broken lines on the surface of the sweatshirt's front pockets represent stitching.

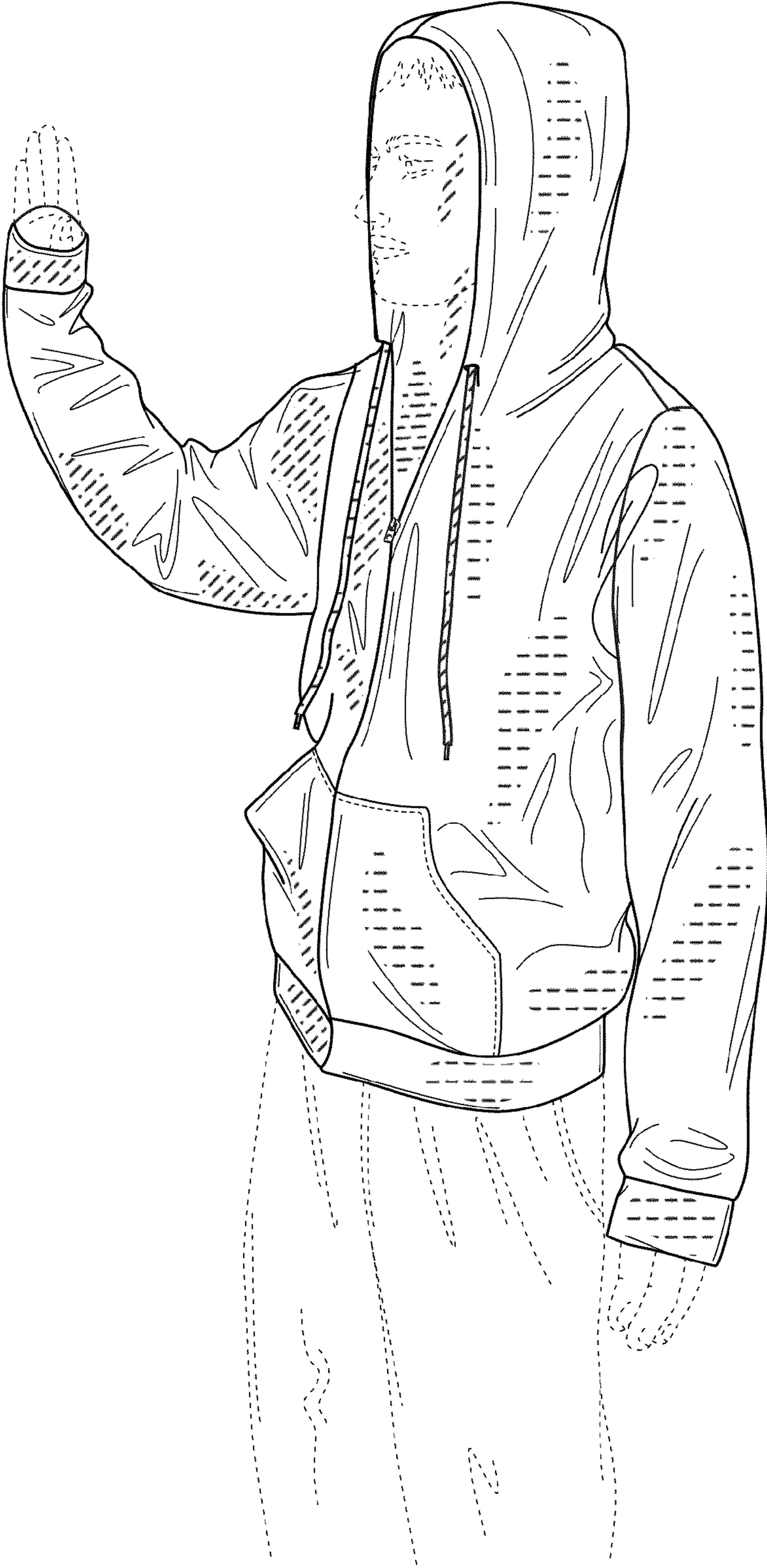

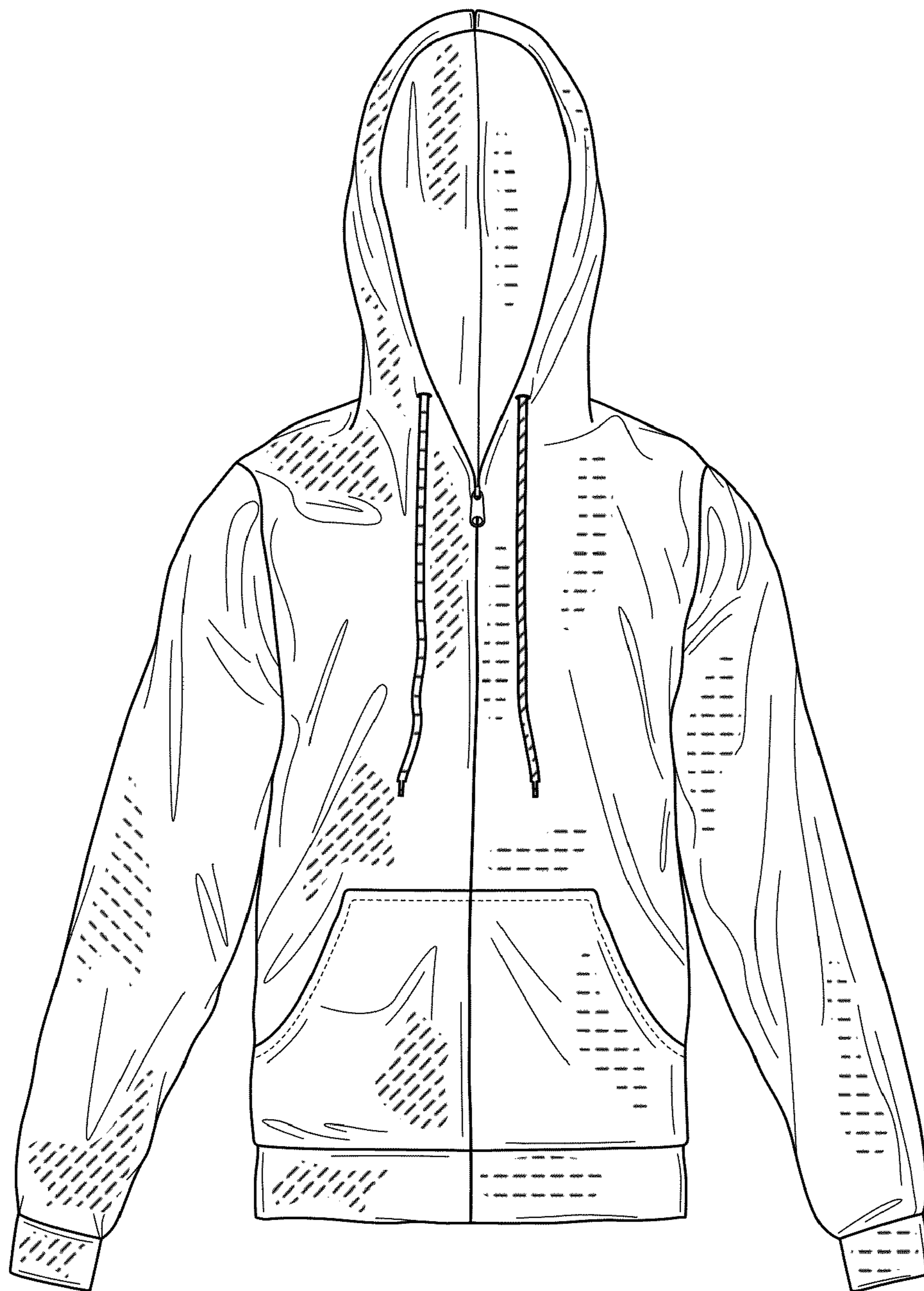

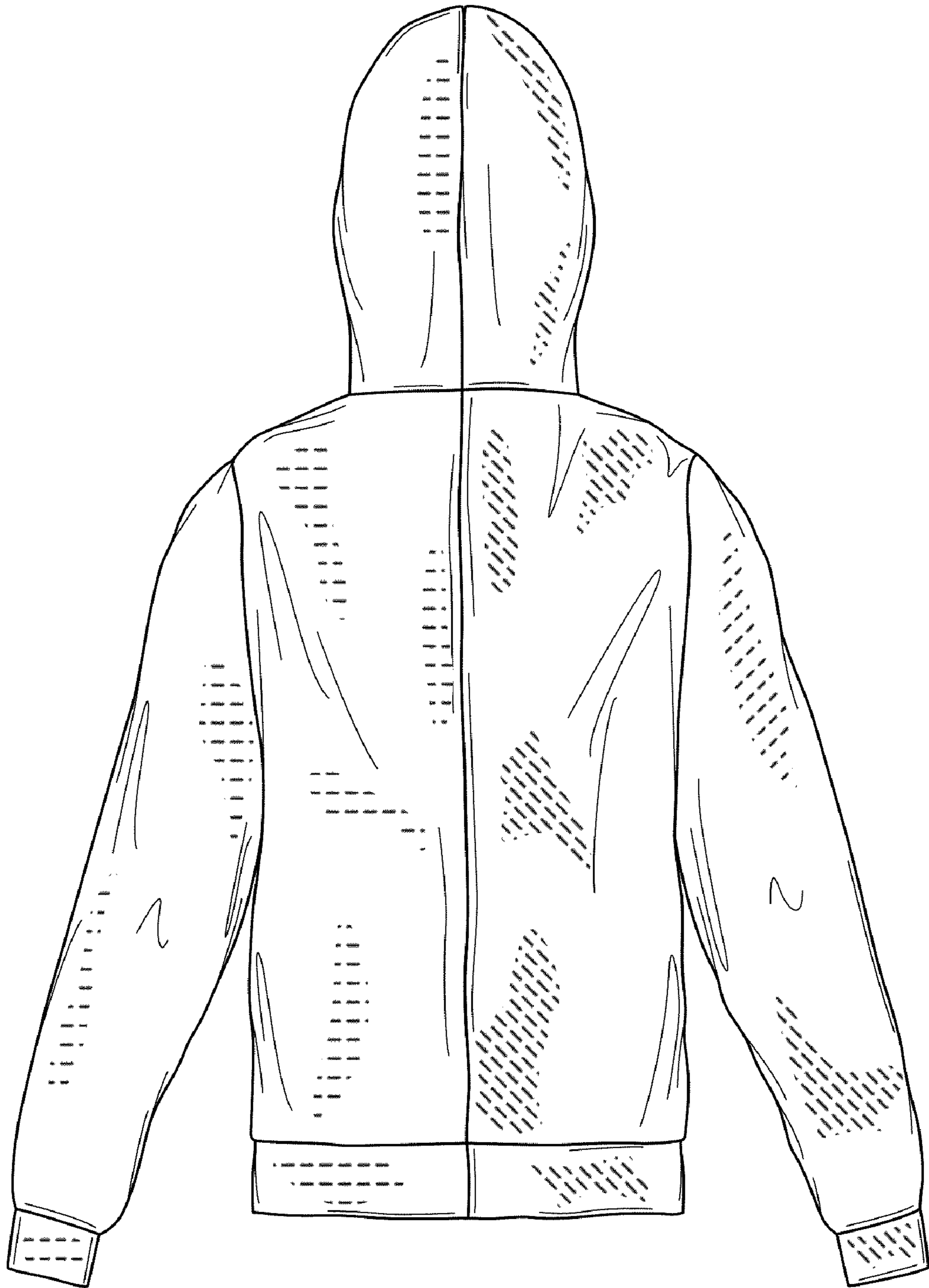

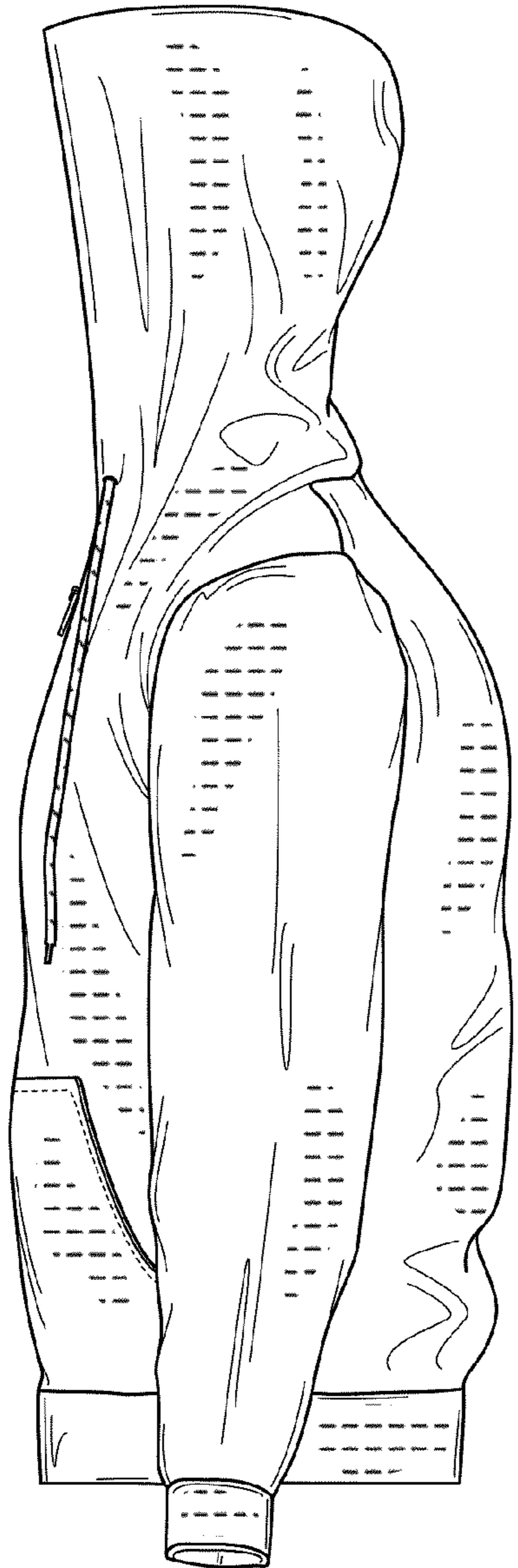

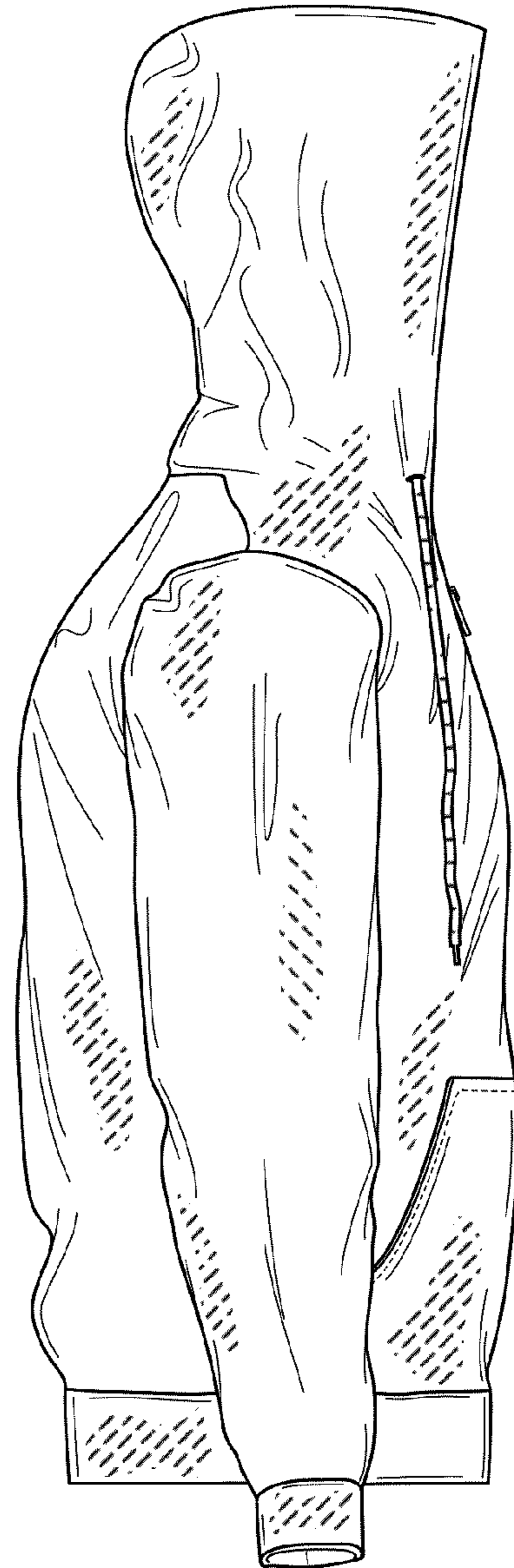

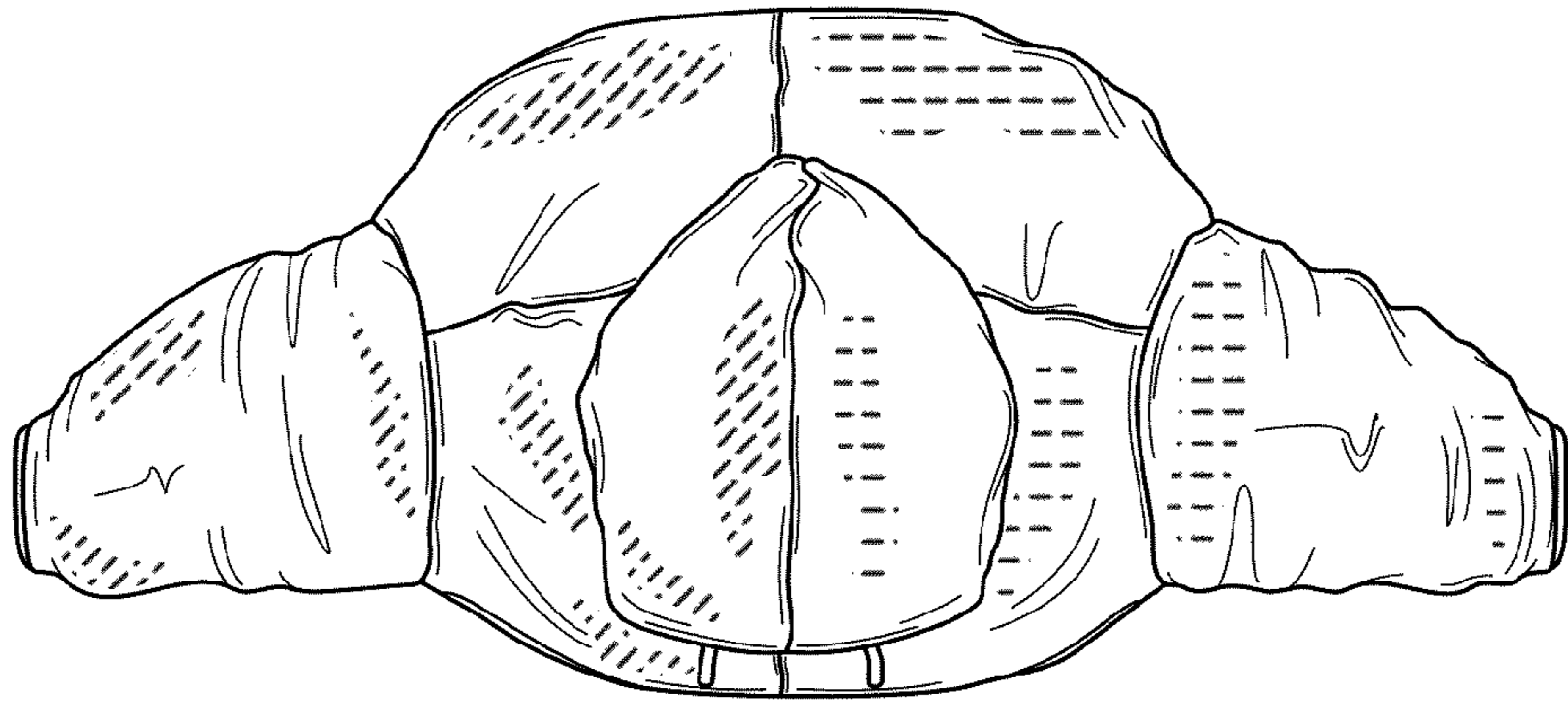

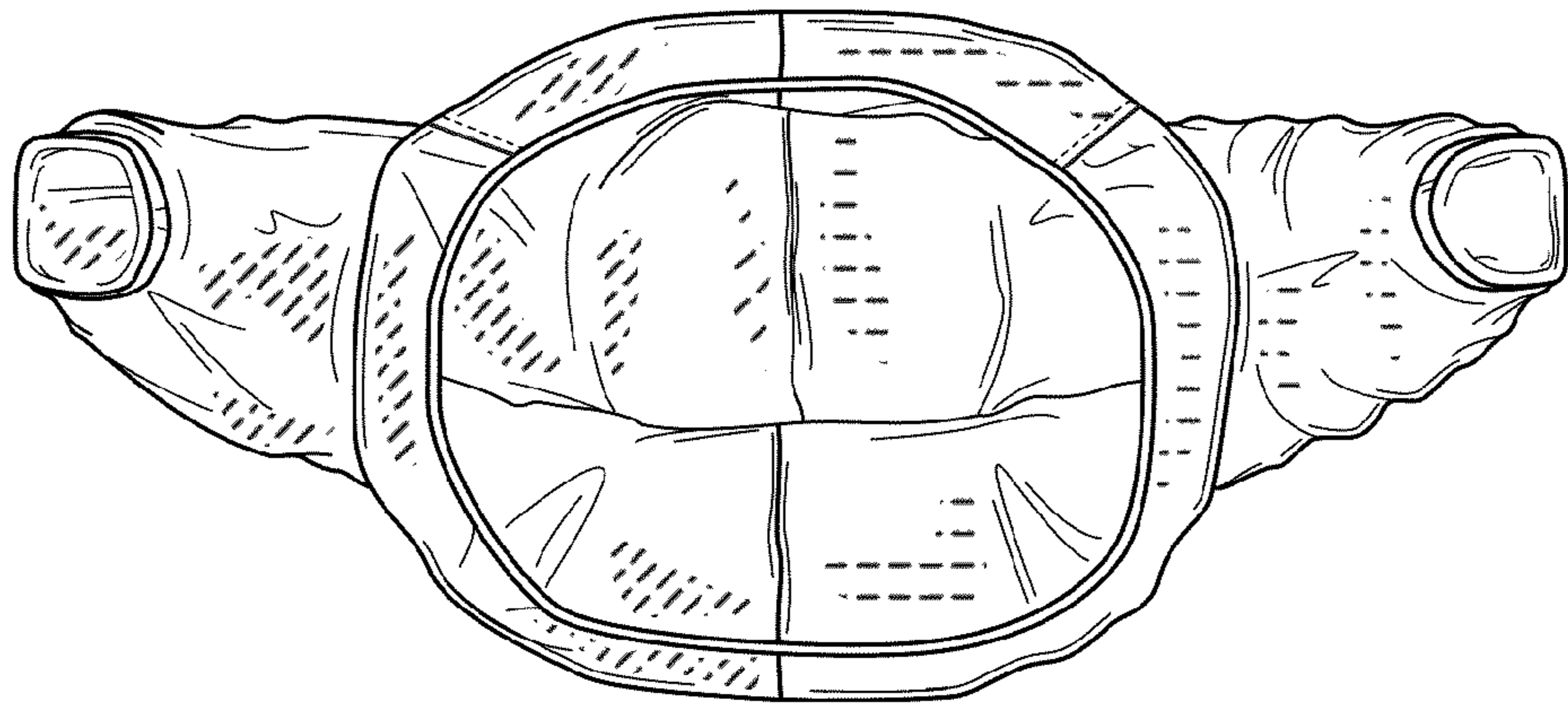

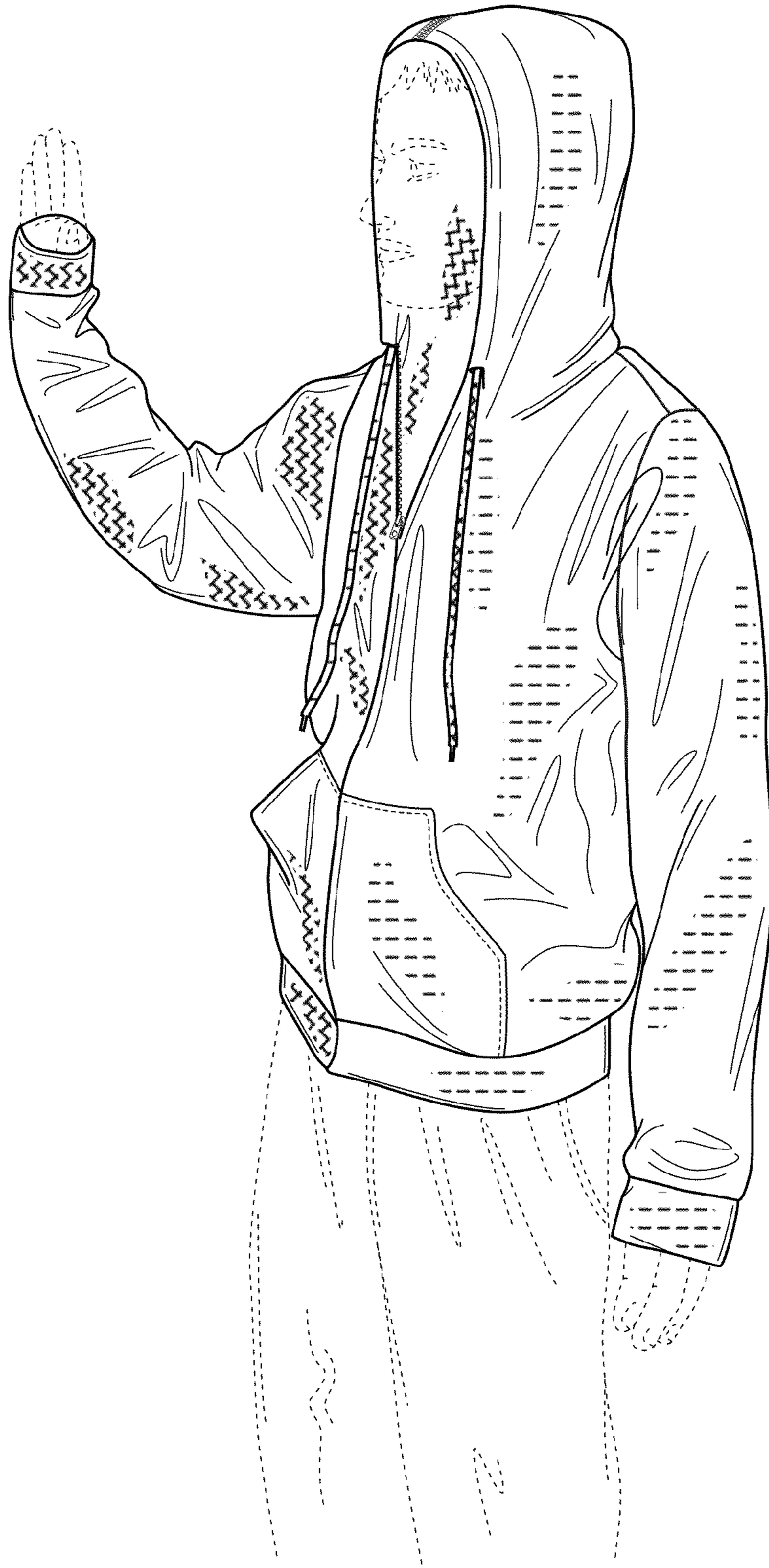

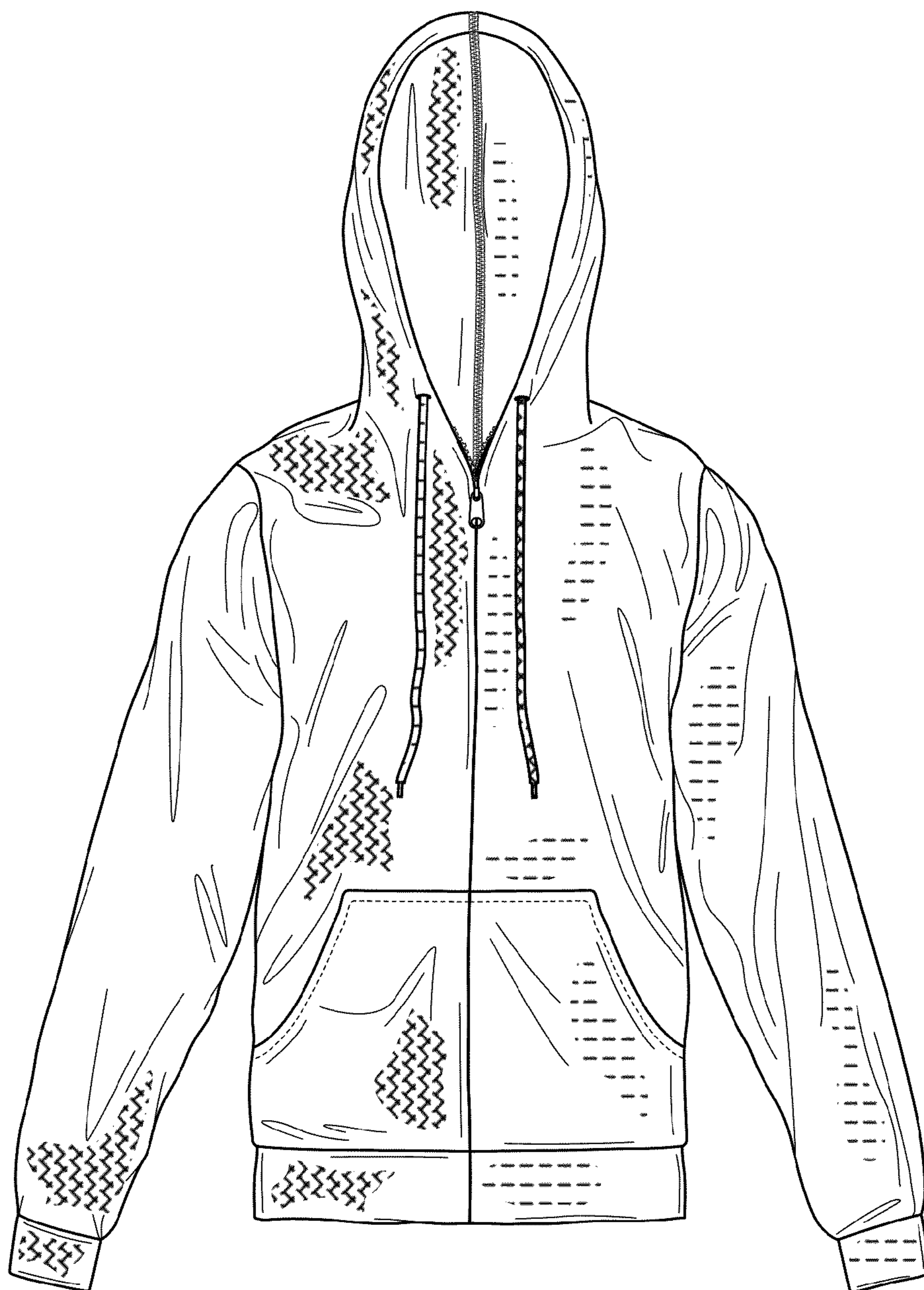

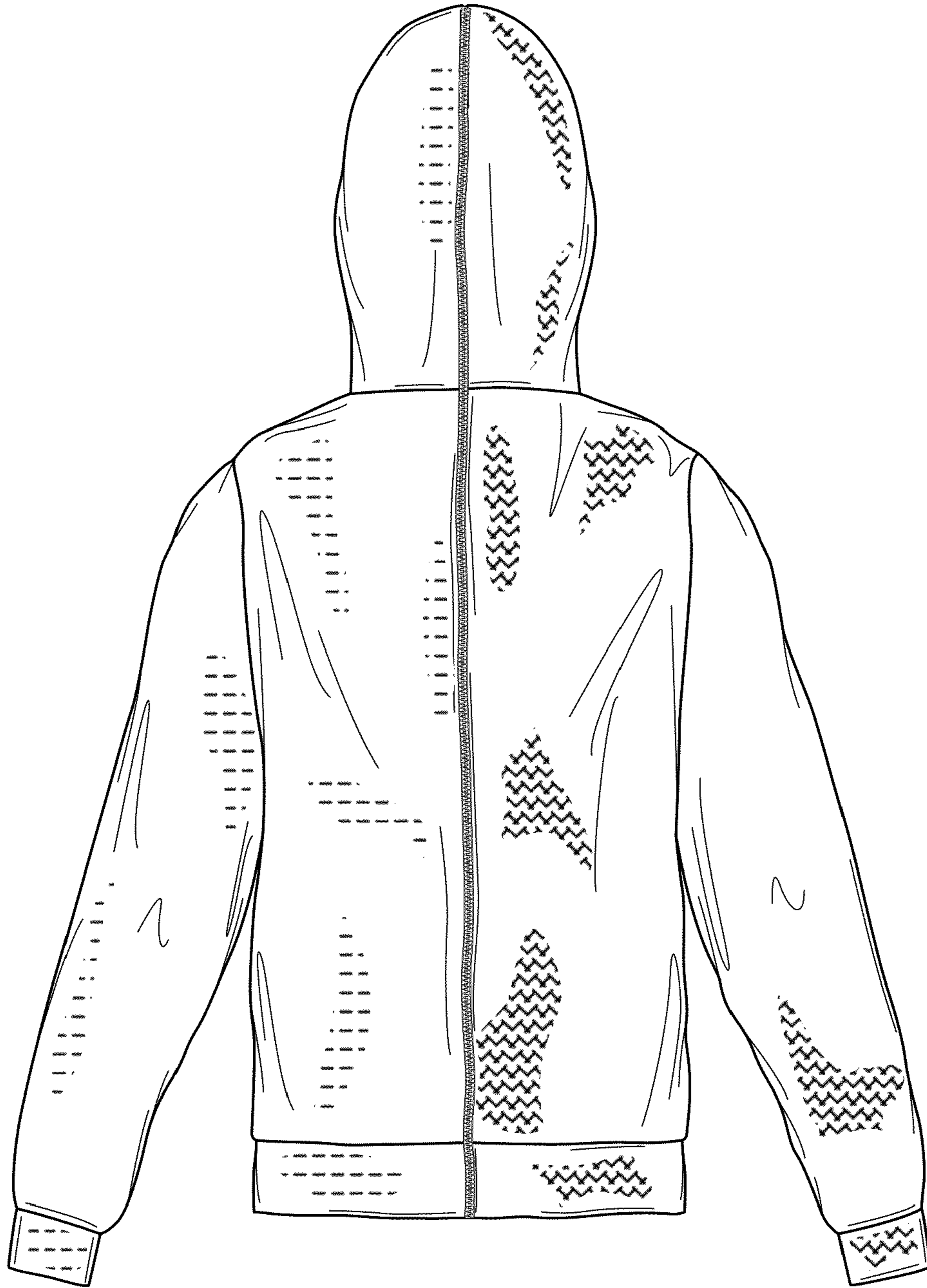

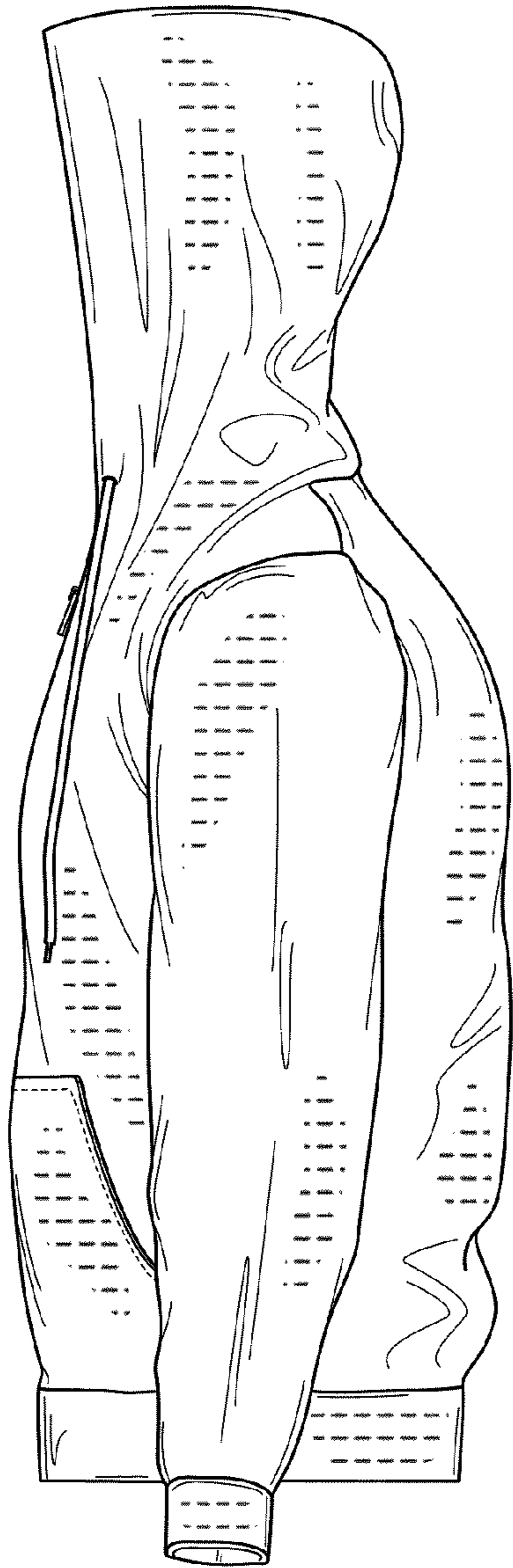

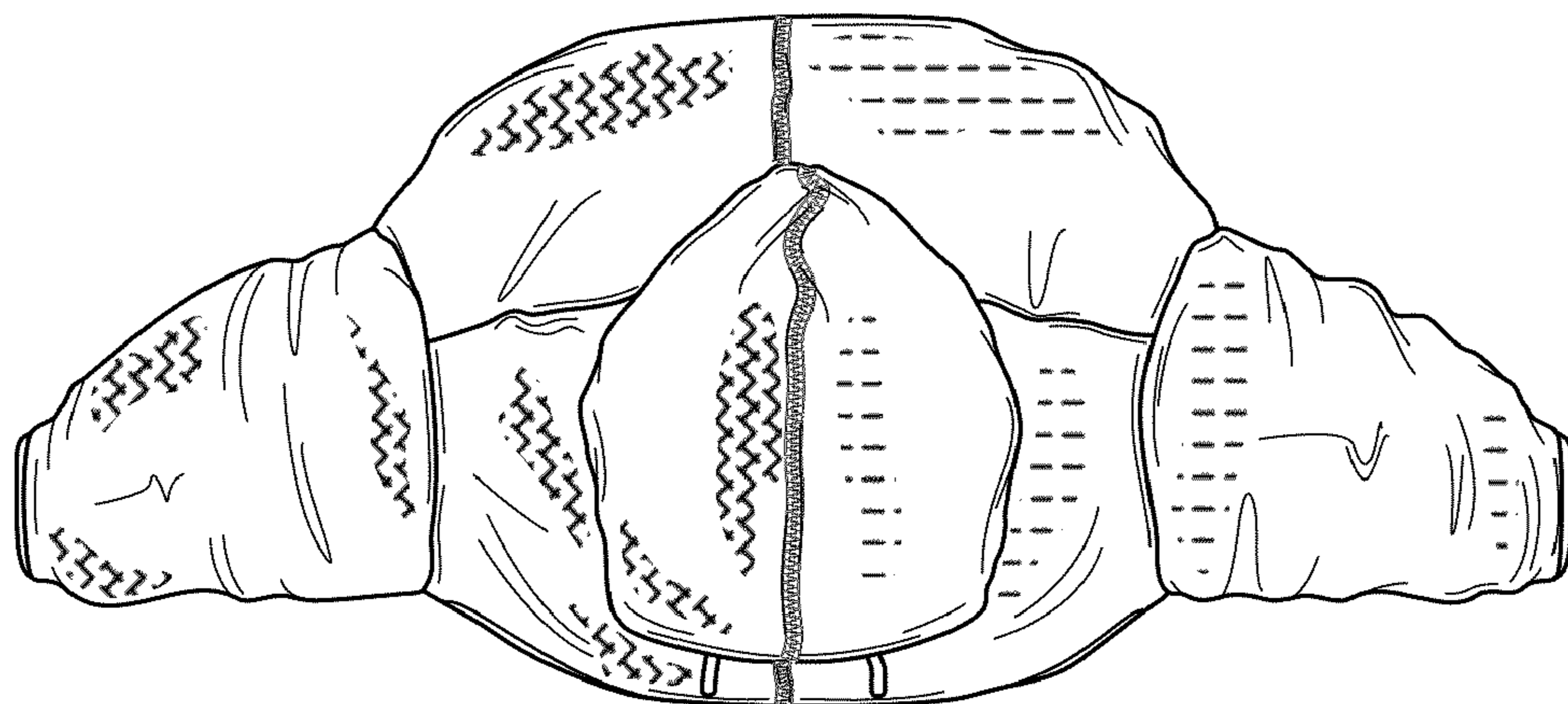

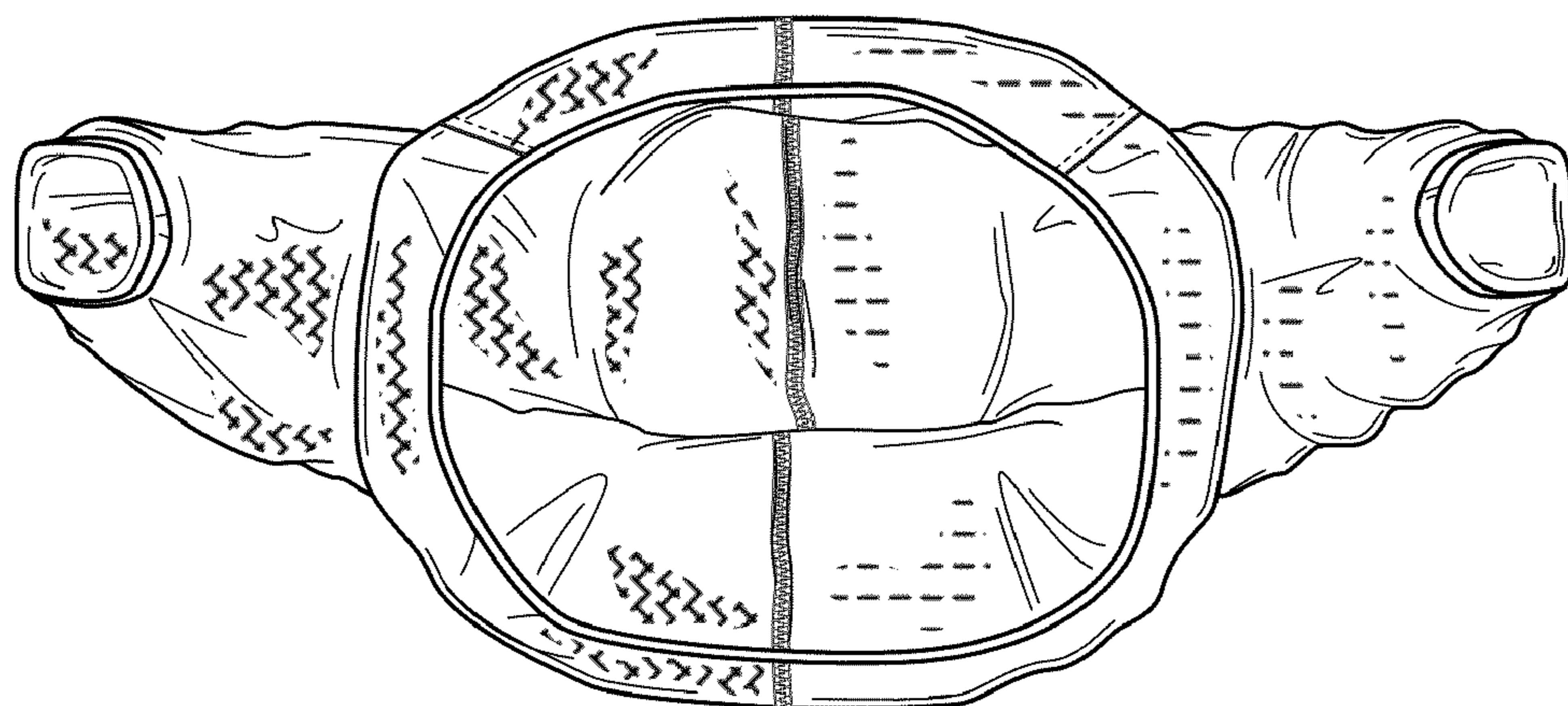
