(57) **CLAIM**

The ornamental design for a handbag, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a handbag showing my new design;

FIG. 2 is a front view of the handbag shown in FIG. 1;

FIG. 3 is a rear view of the handbag shown in FIG. 1;

FIG. 4 is a left side view of the handbag shown in FIG. 1;

FIG. 5 is a right side view of the handbag shown in FIG. 1;

FIG. 6 is a top view of the handbag shown in FIG. 1;

FIG. 7 is a bottom view of the handbag shown in FIG. 1;

FIG. 8 is a front perspective view of an alternative embodiment of the handbag shown in FIG. 1;

FIG. 9 is a front view of the alternative embodiment of the handbag shown in FIG. 8;

FIG. 10 is a rear view of the alternative embodiment of the handbag shown in FIG. 8;

FIG. 11 is a left side view of the alternative embodiment of the handbag shown in FIG. 8;

FIG. 12 is a right side view of the alternative embodiment of the handbag shown in FIG. 8;

FIG. 13 is a top view of the alternative embodiment of the handbag shown in FIG. 8; and,

FIG. 14 is a bottom view of the alternative embodiment of the handbag shown in FIG. 8.

The broken lines showing the zipper, zipper pull, metal rings, bottom buttons, stitching, closure flap and portions of the bottom of the bag are for the purposes of illustrating environment and forms no part of the claimed design.

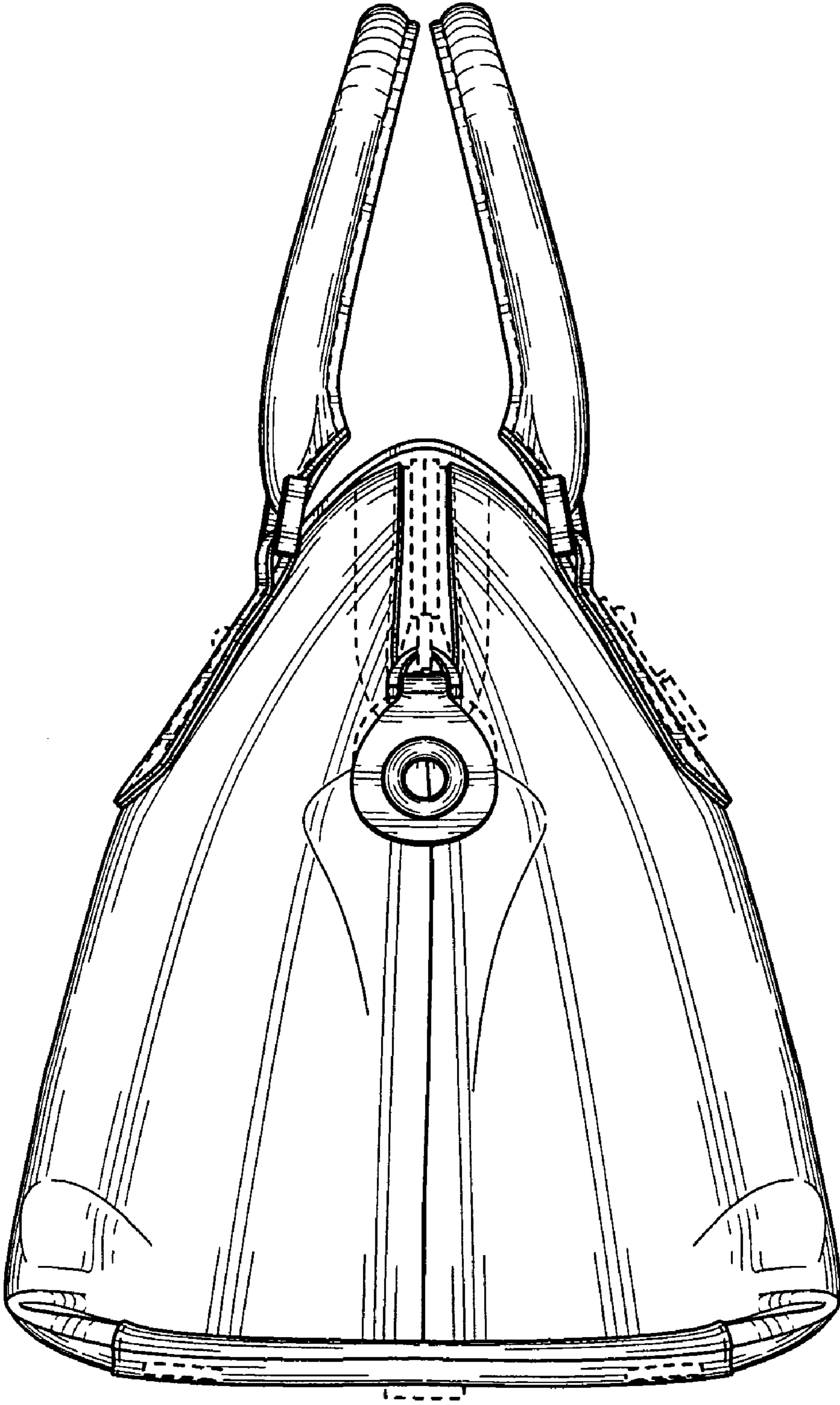

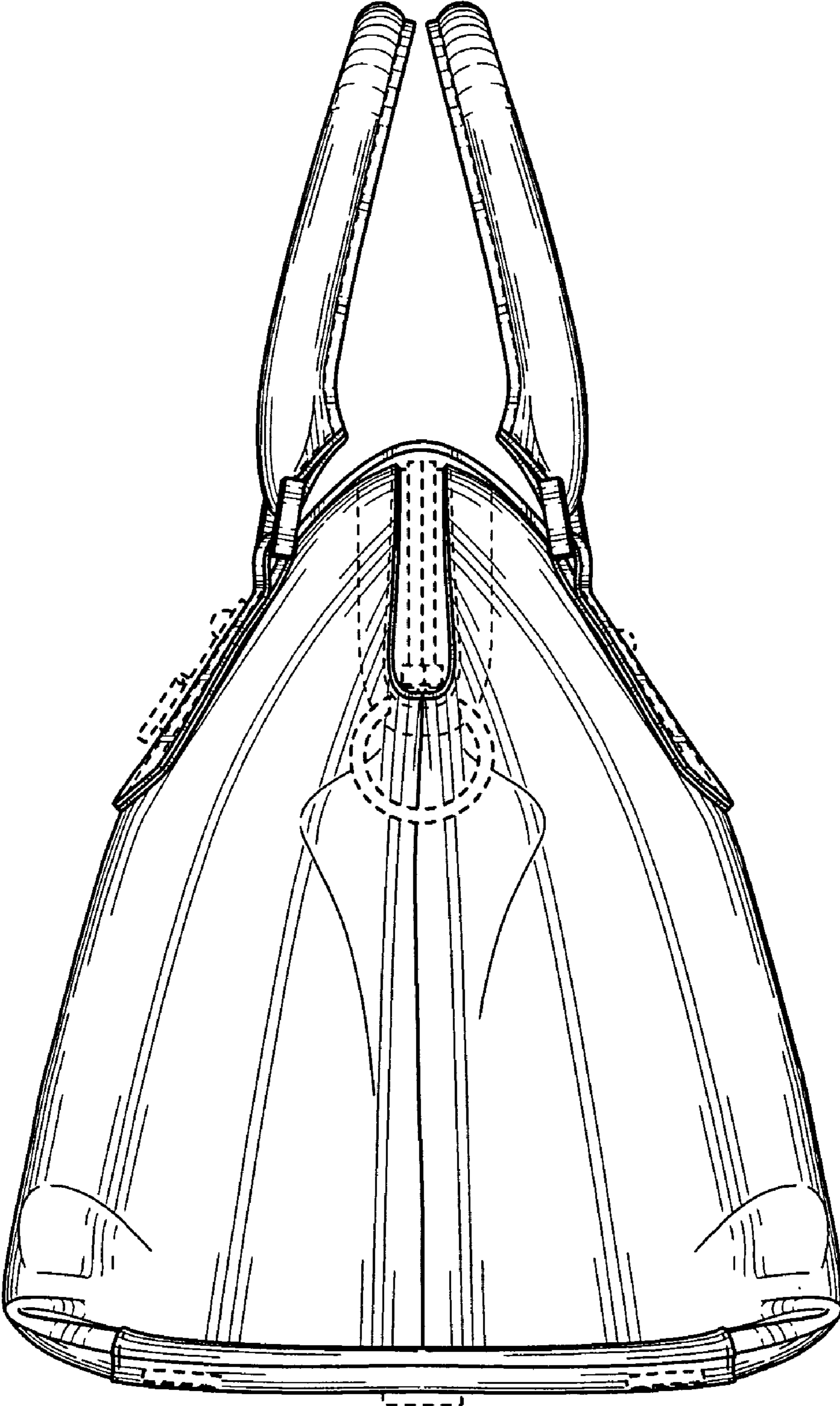

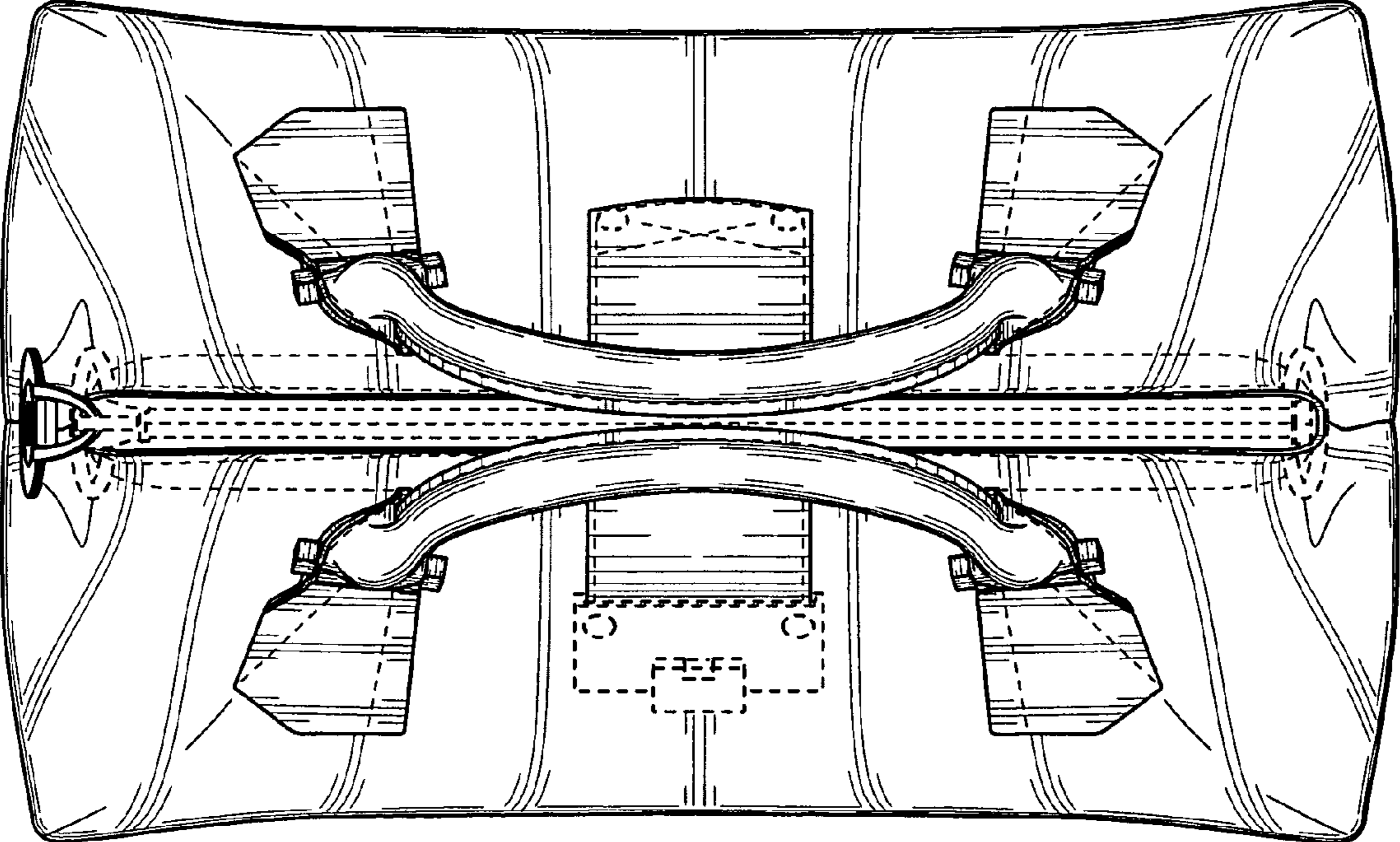

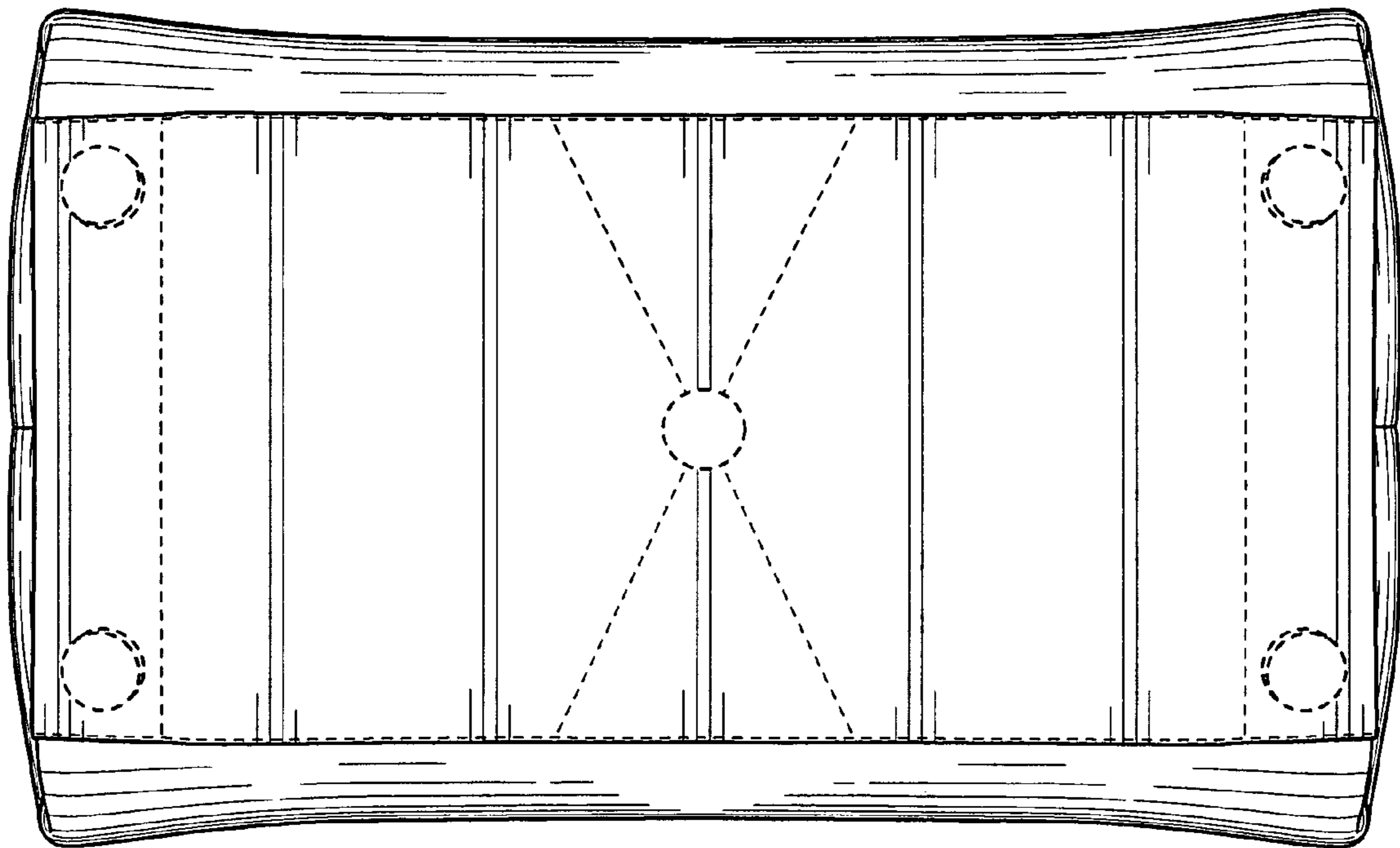

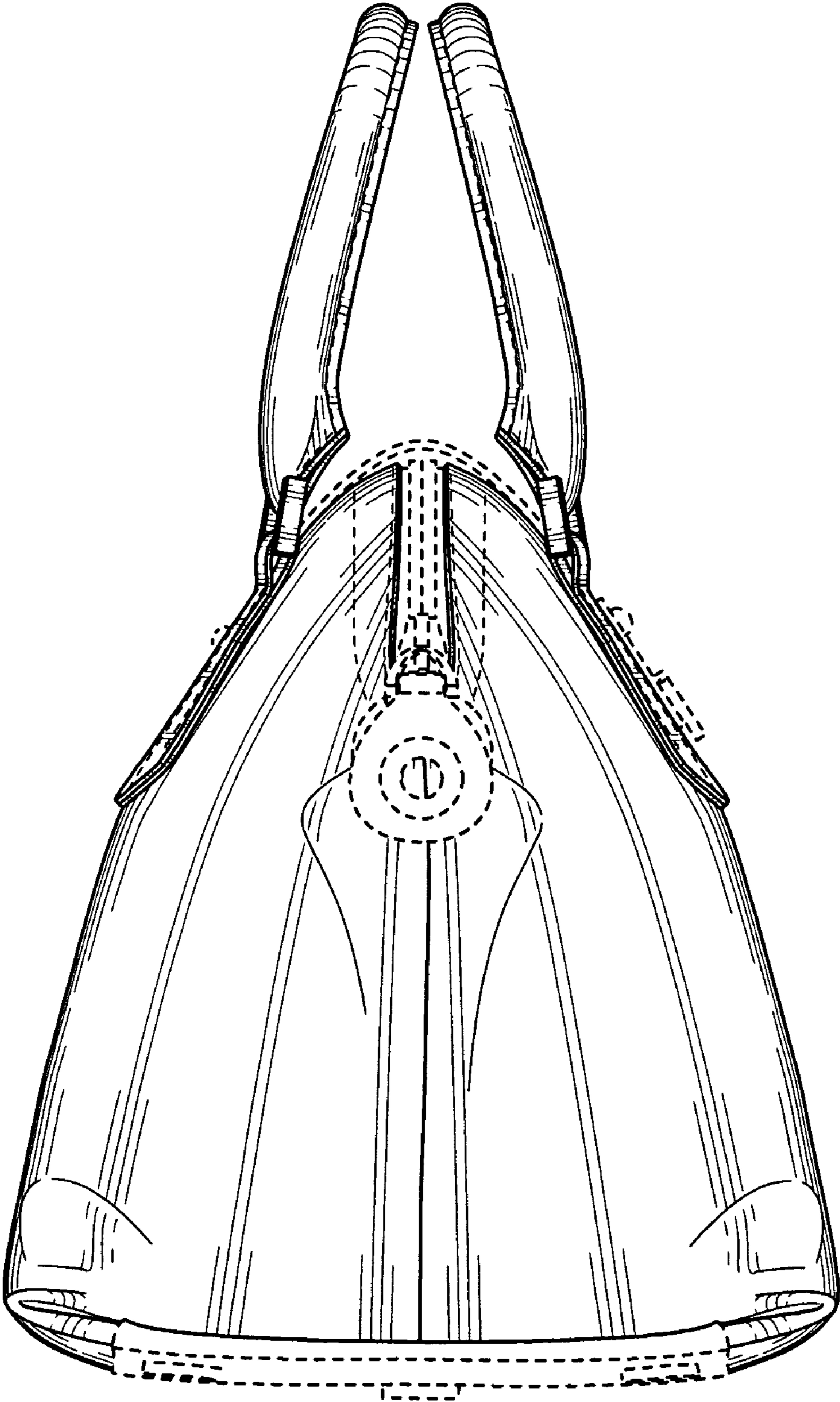

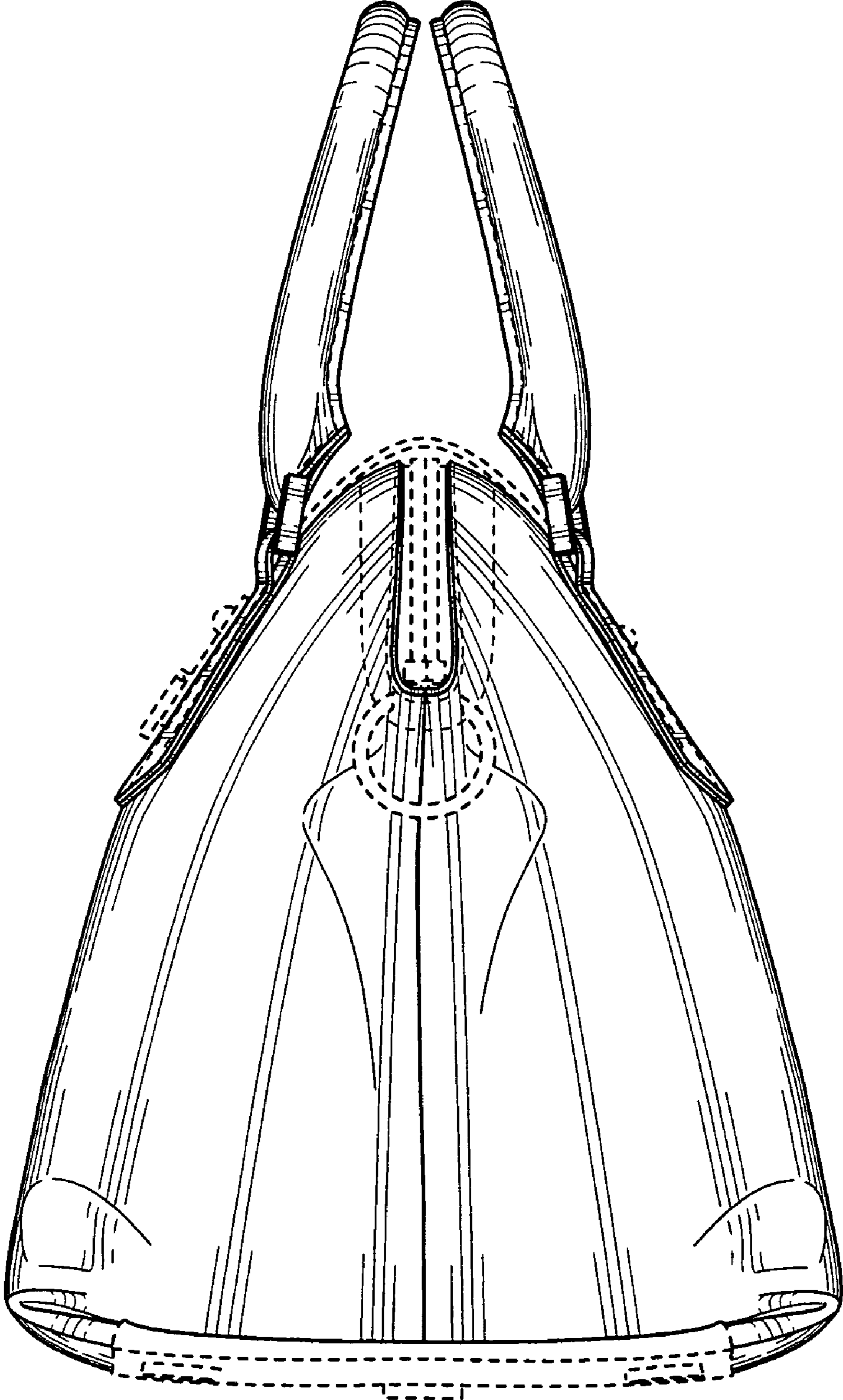

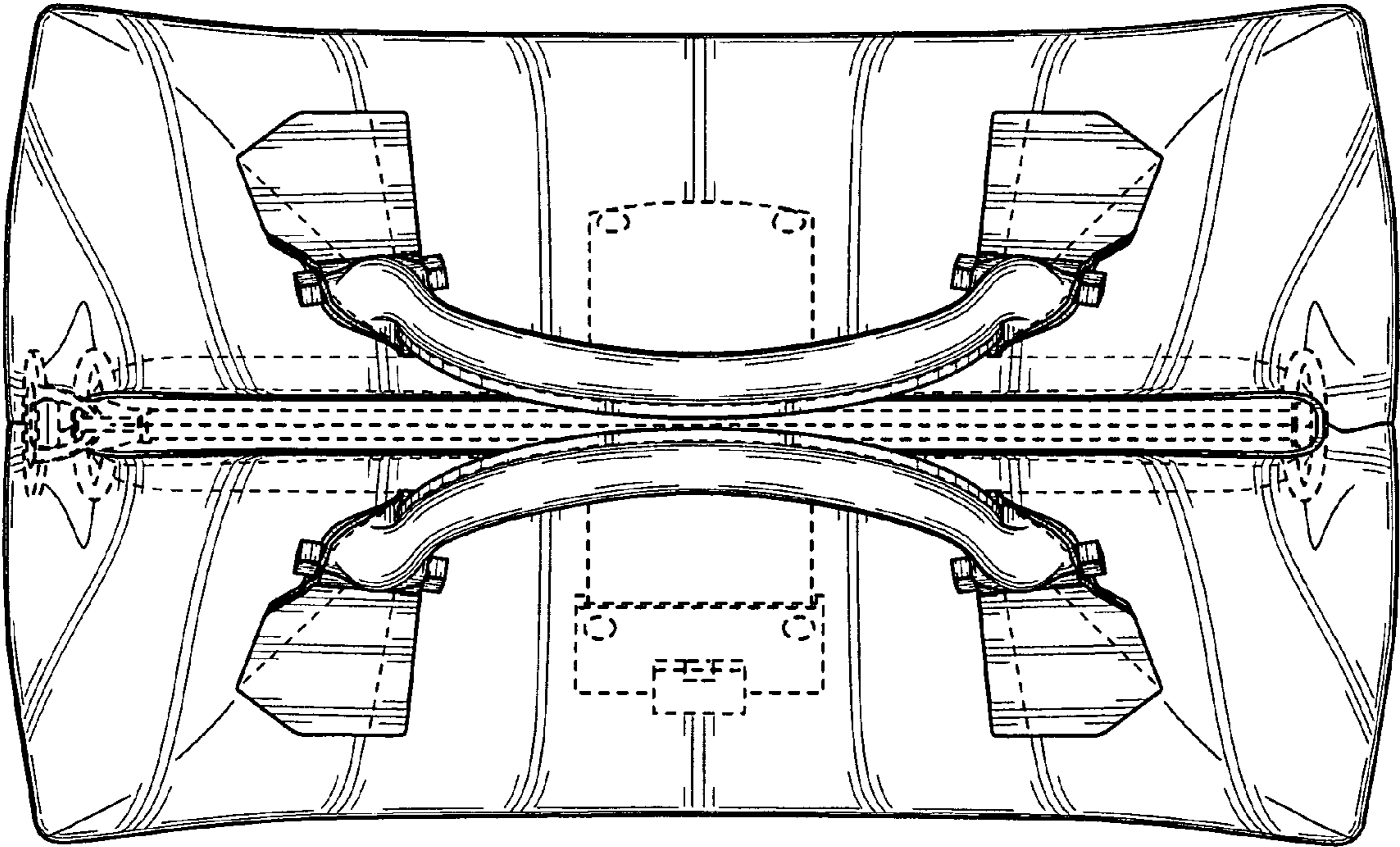

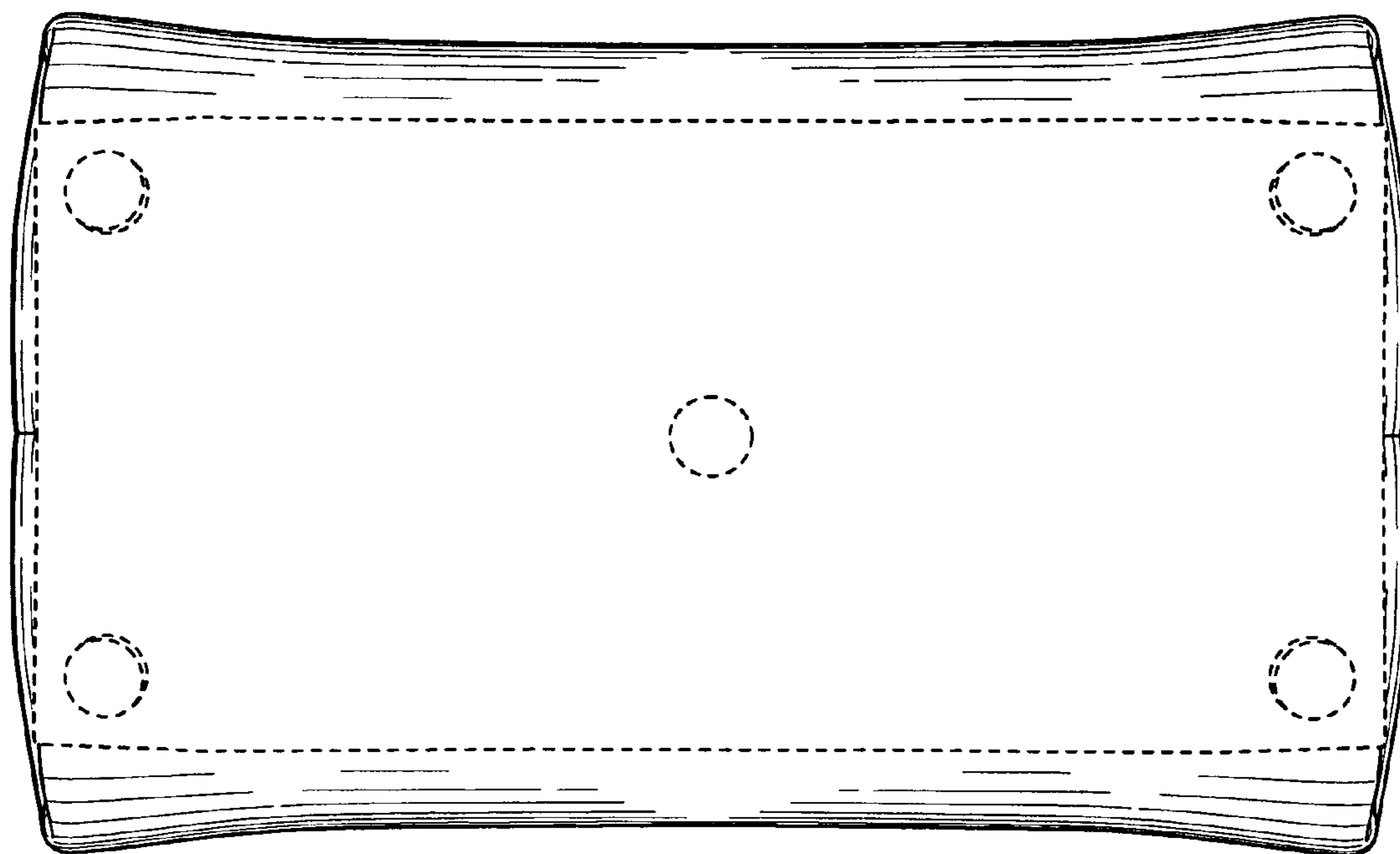
