(57) **CLAIM**

We claim the ornamental design for a racquet equipment bag, as shown and described.

DESCRIPTION

FIG. 1 is a top, side perspective view of a racquet equipment bag;

FIG. 2 is a top, second end perspective view of the racquet equipment bag of FIG. 1;

FIG. 3 is a first side view of the racquet equipment bag of FIG. 1;

FIG. 4 is a second side view of the racquet equipment bag of FIG. 1;

FIG. 5 is a first end view of the racquet equipment bag of FIG. 1;

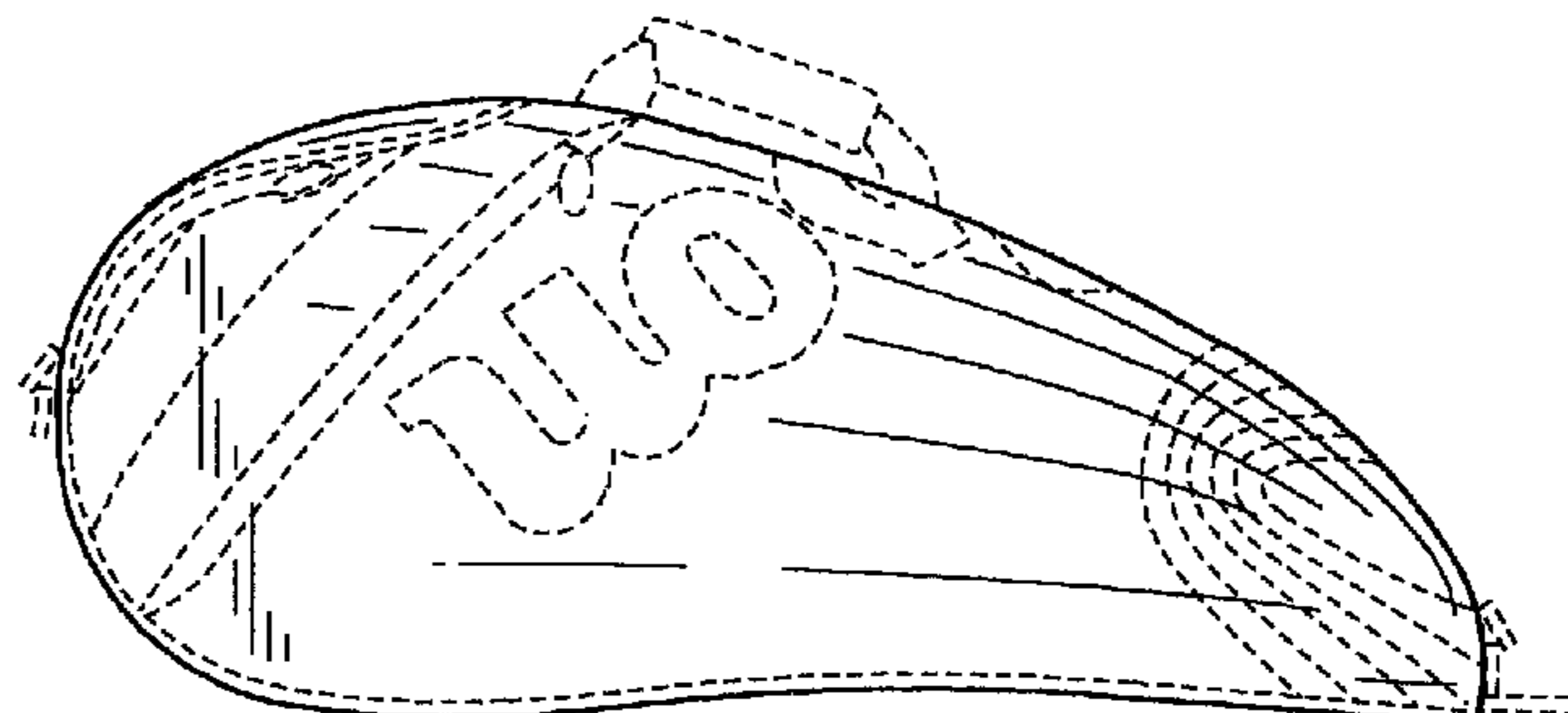
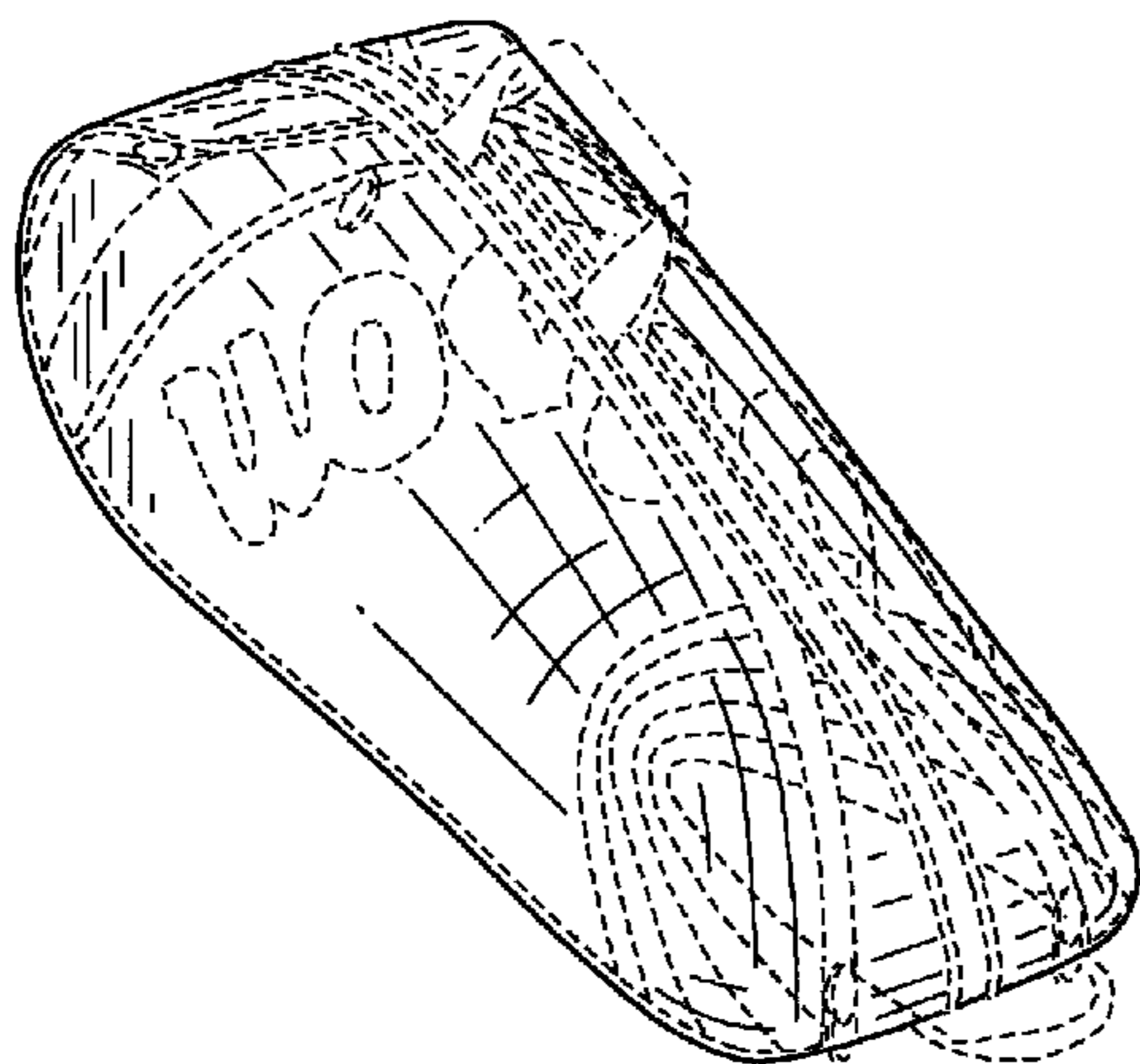
FIG. 6 is a second end view of the racquet equipment bag of FIG. 1;

FIG. 7 is a top view of the racquet equipment bag of FIG. 1; and,

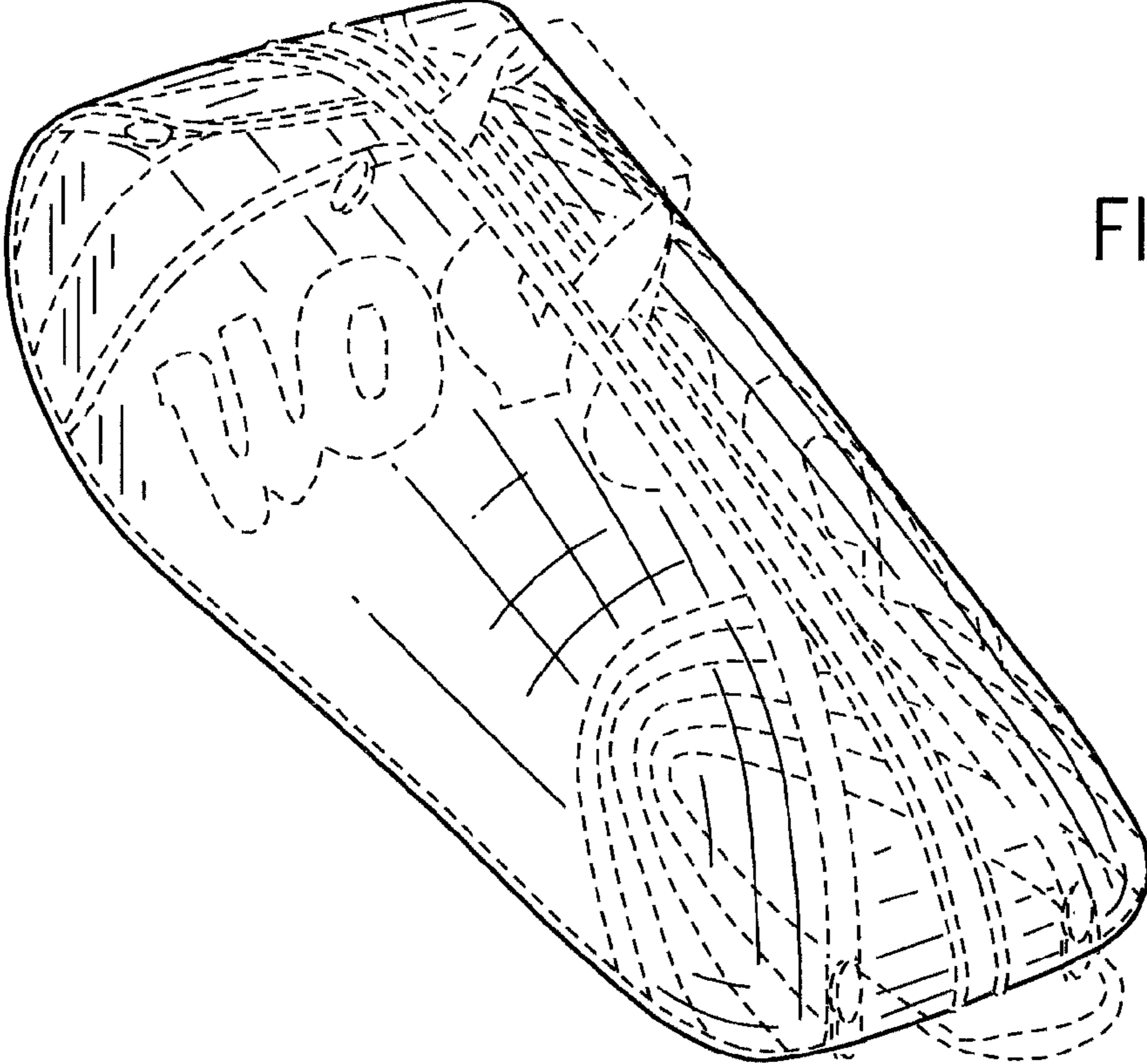

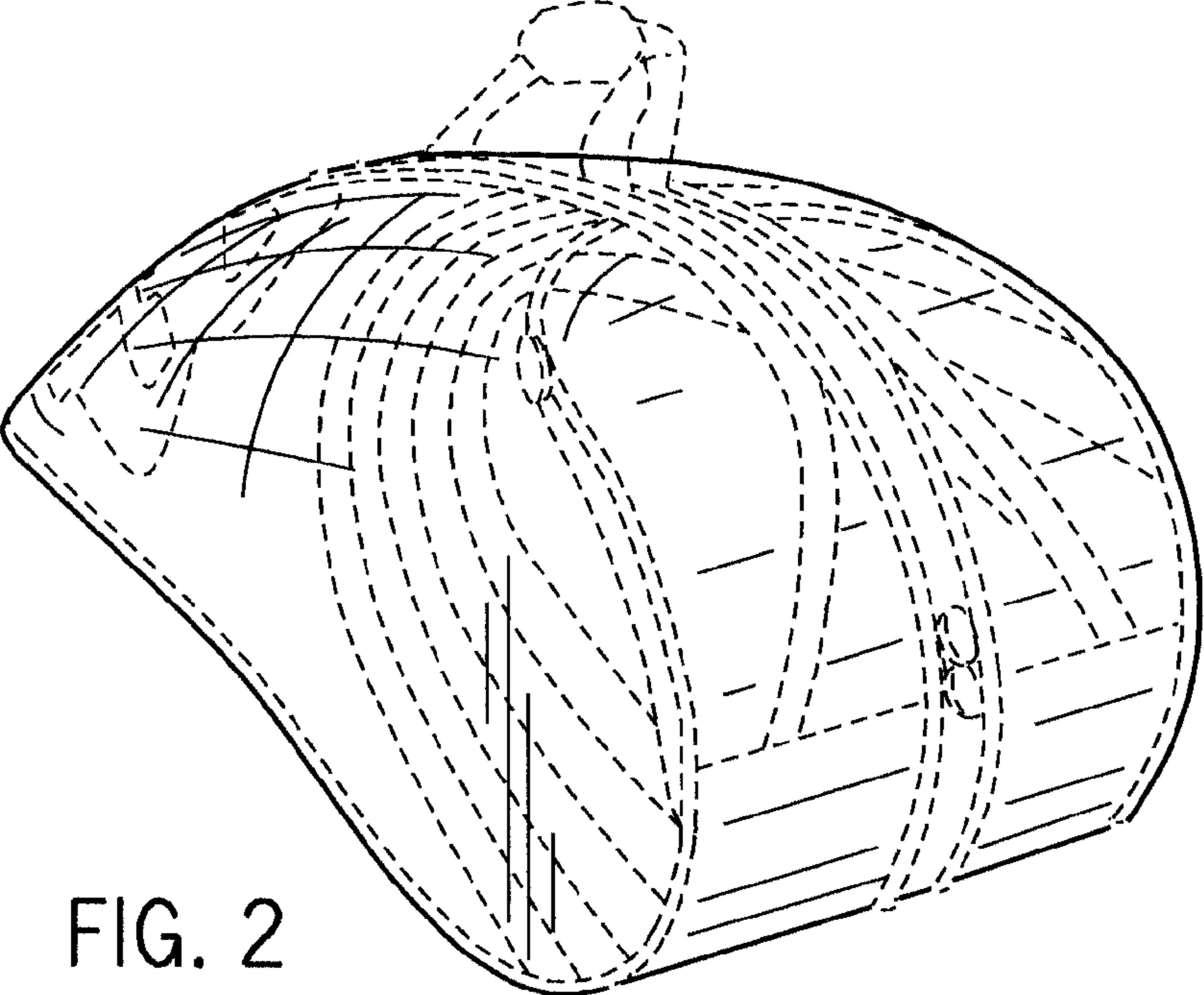

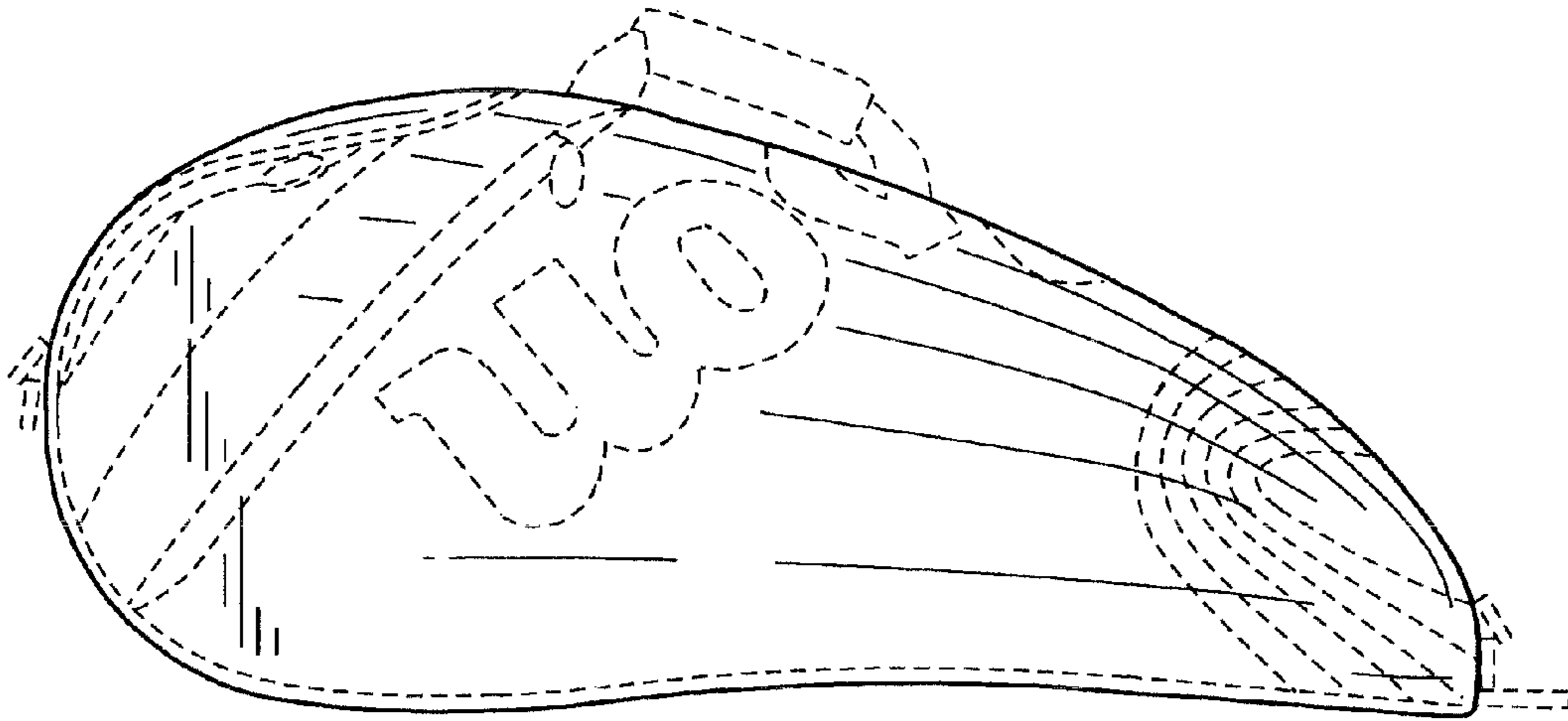

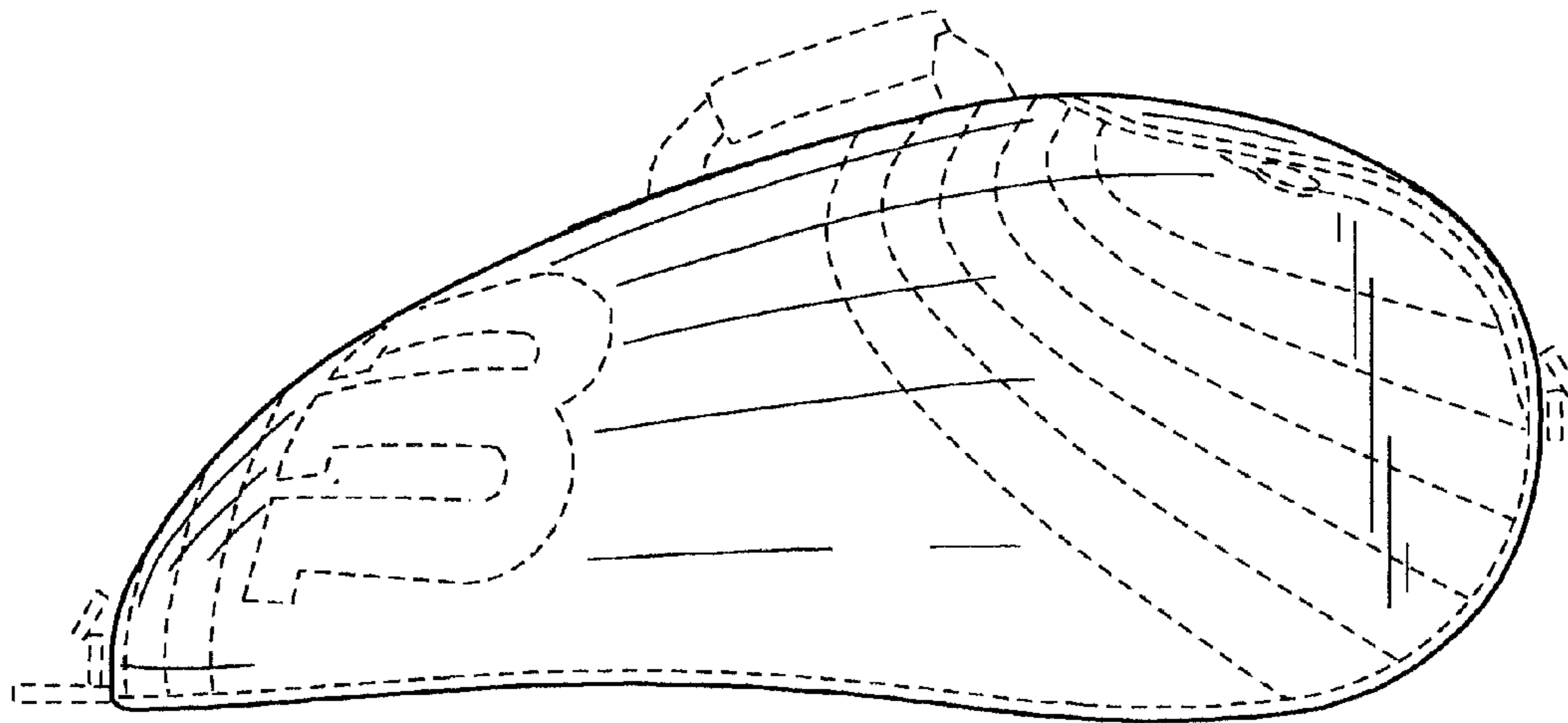

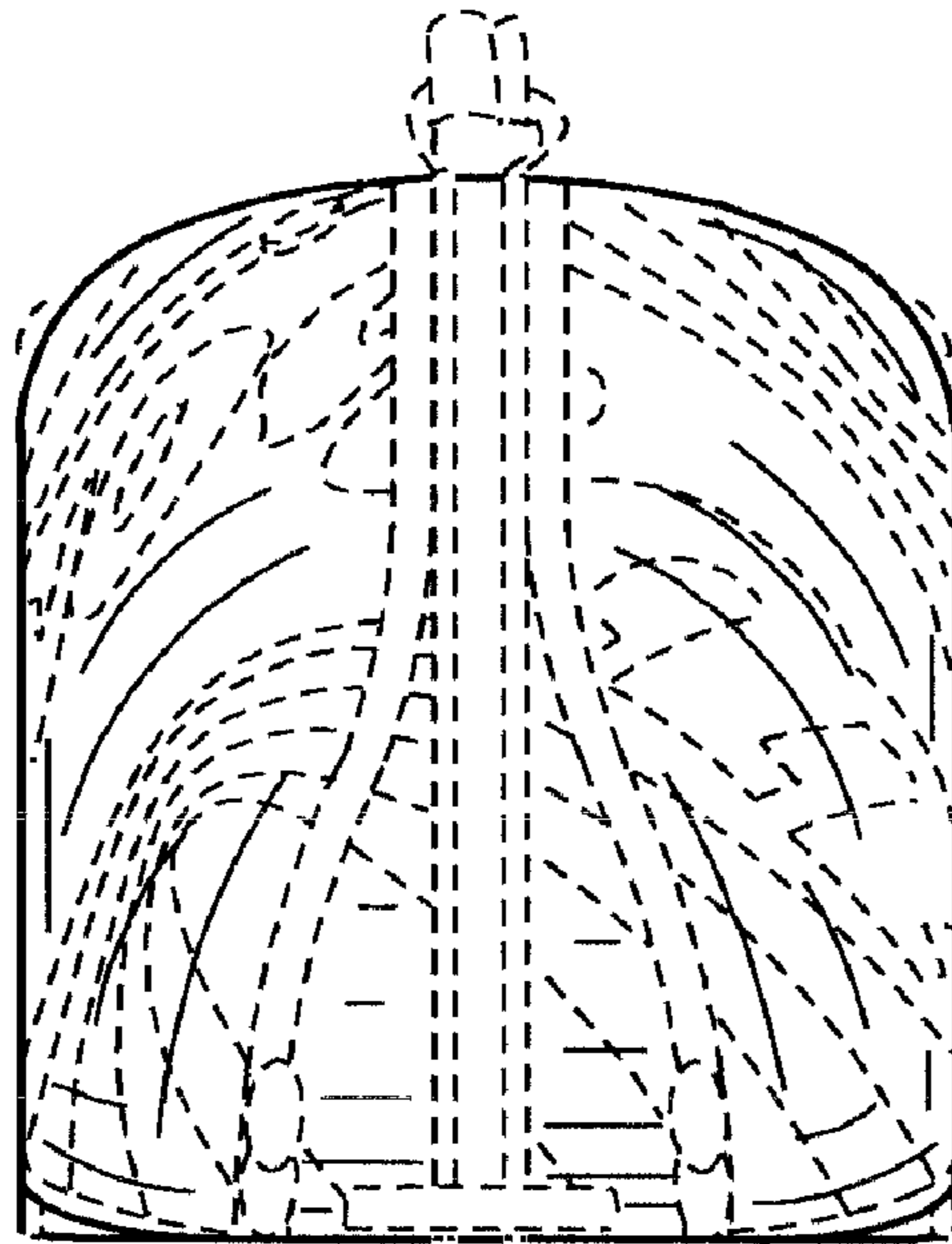

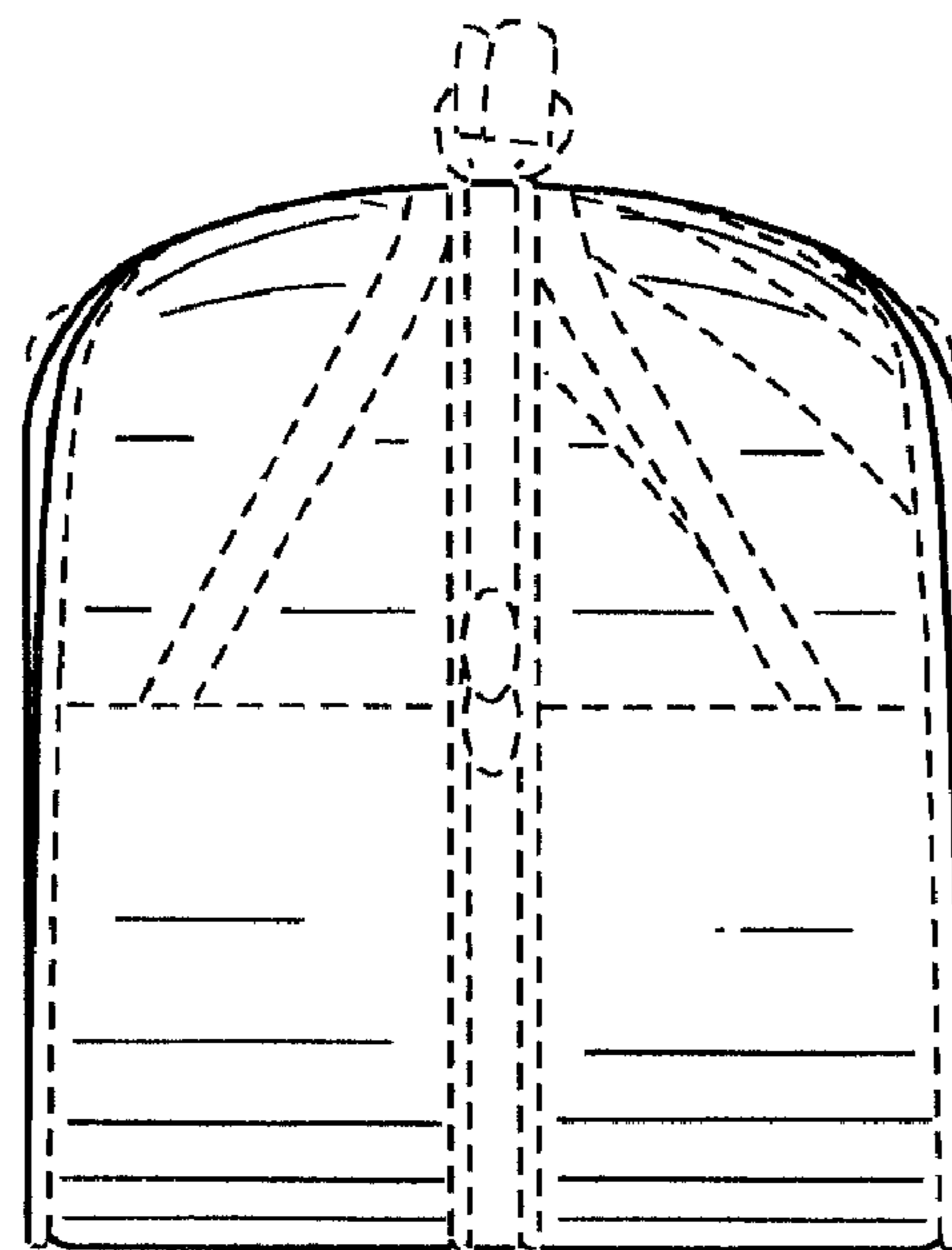

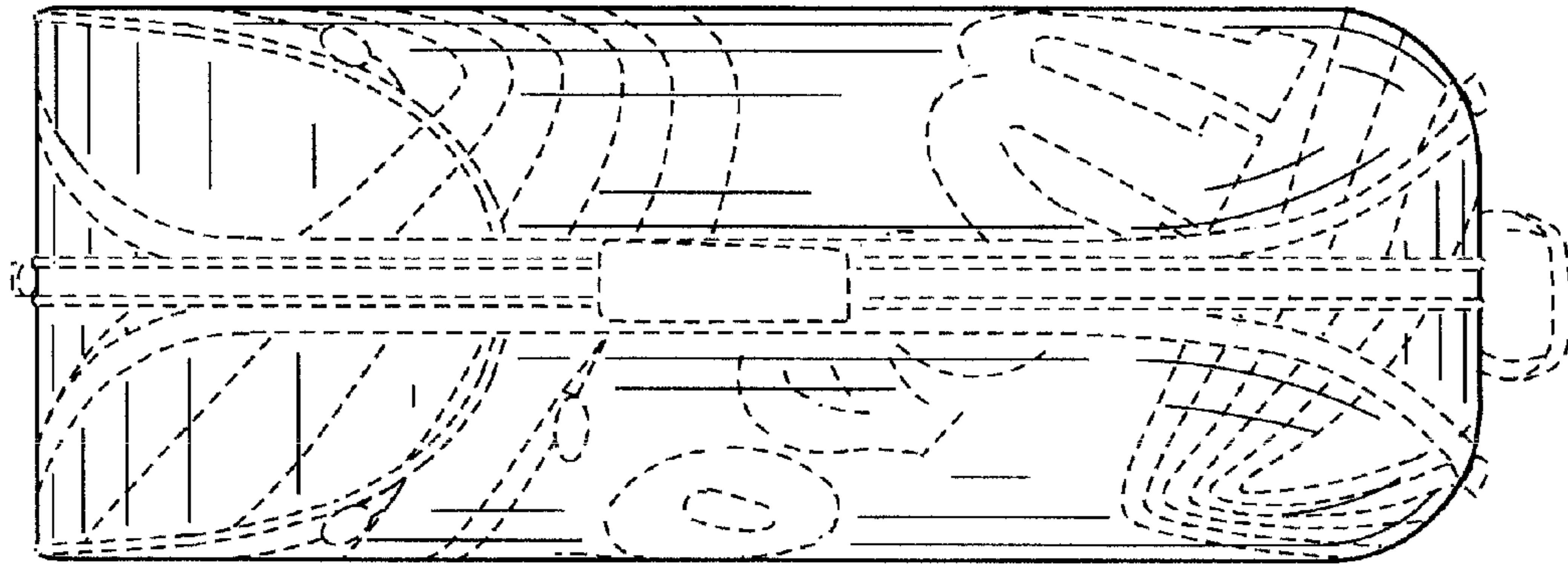

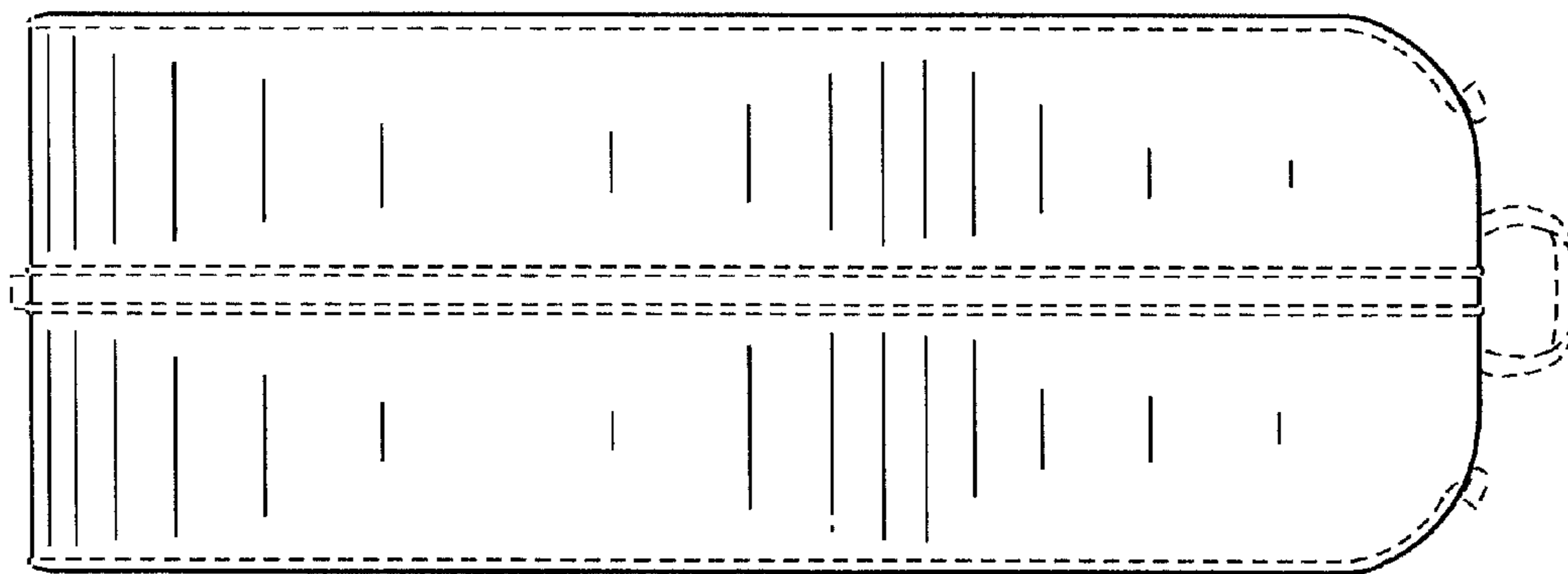
