FIG. 1 is a front elevation view of a garment hanger with notch showing our new design, the rear elevation view being a mirror image thereof;

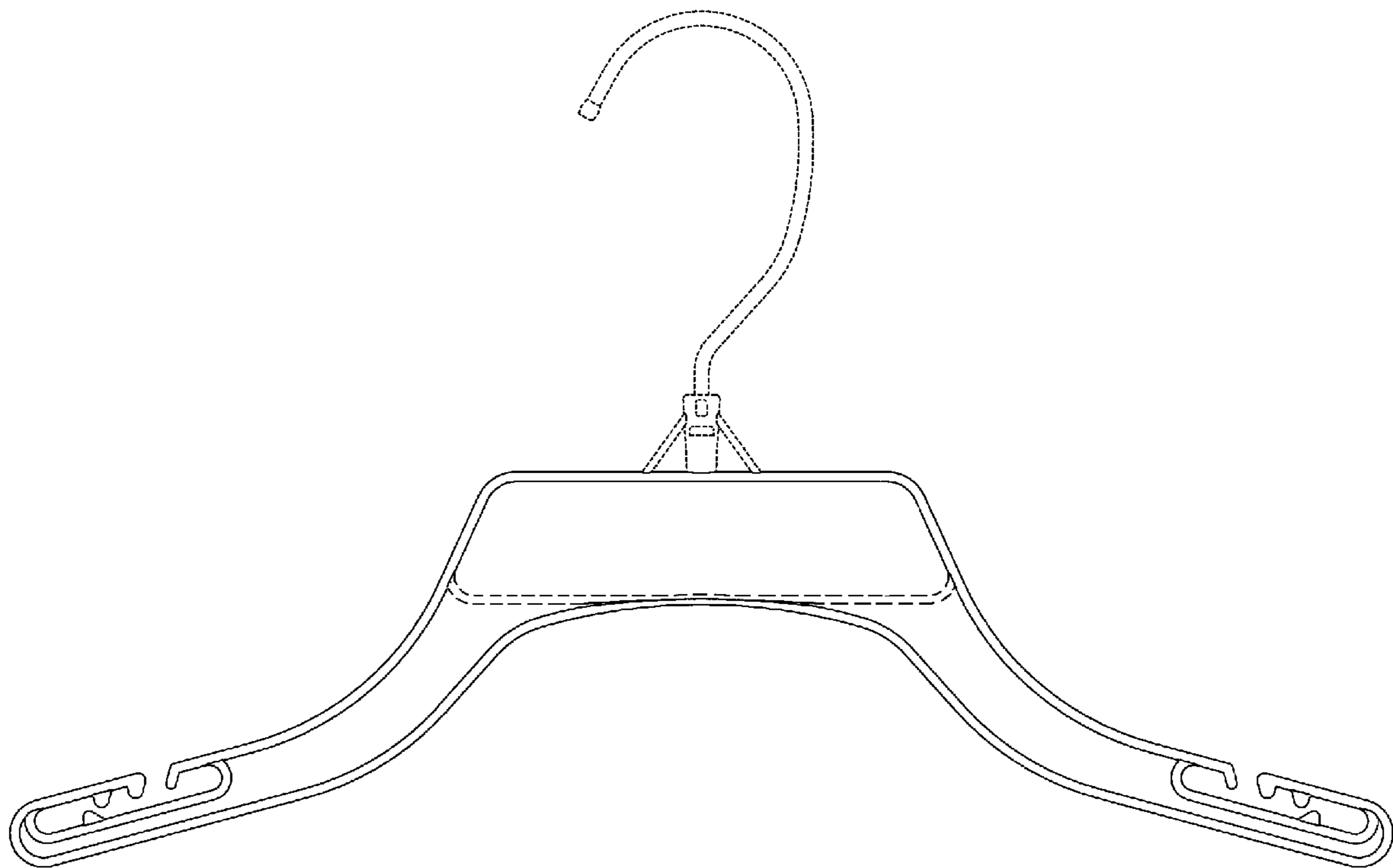
FIG. 2 is a left side elevation view thereof, the right side elevation view being a mirror image thereof;

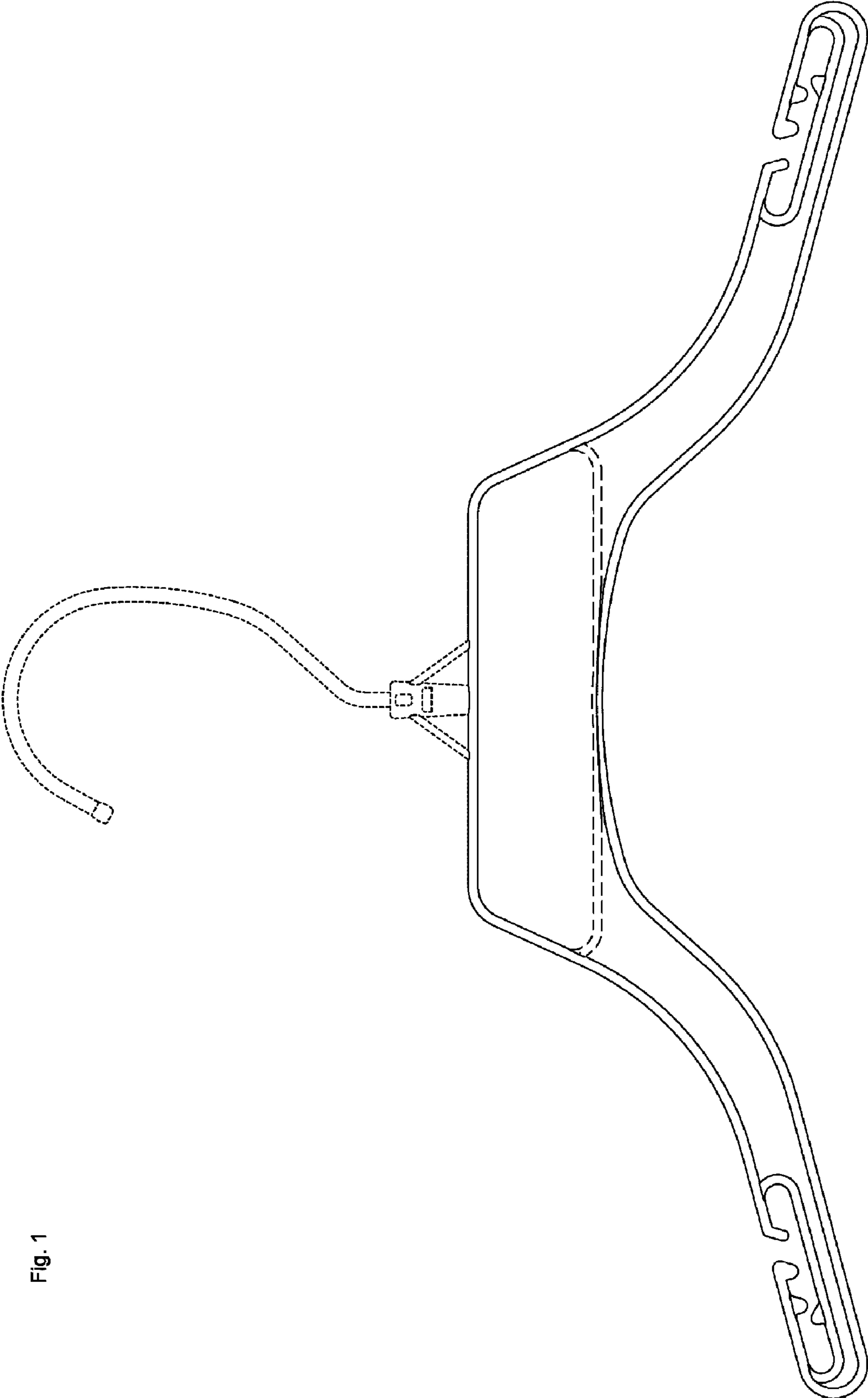

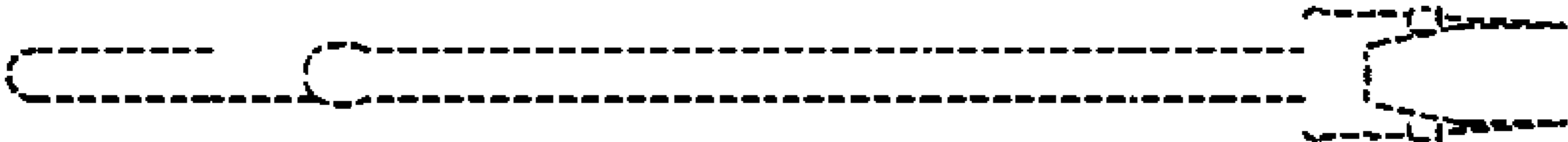
