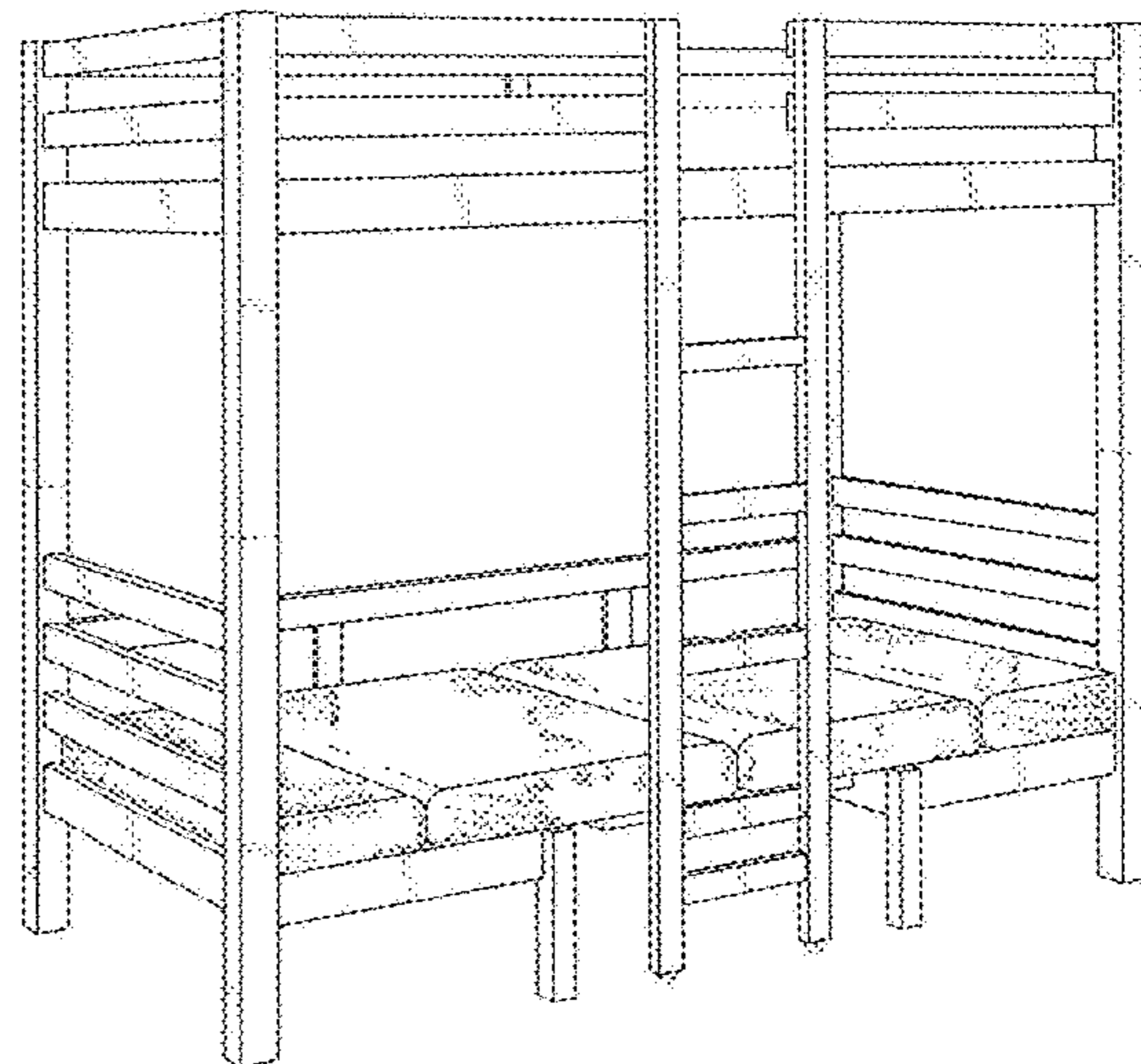
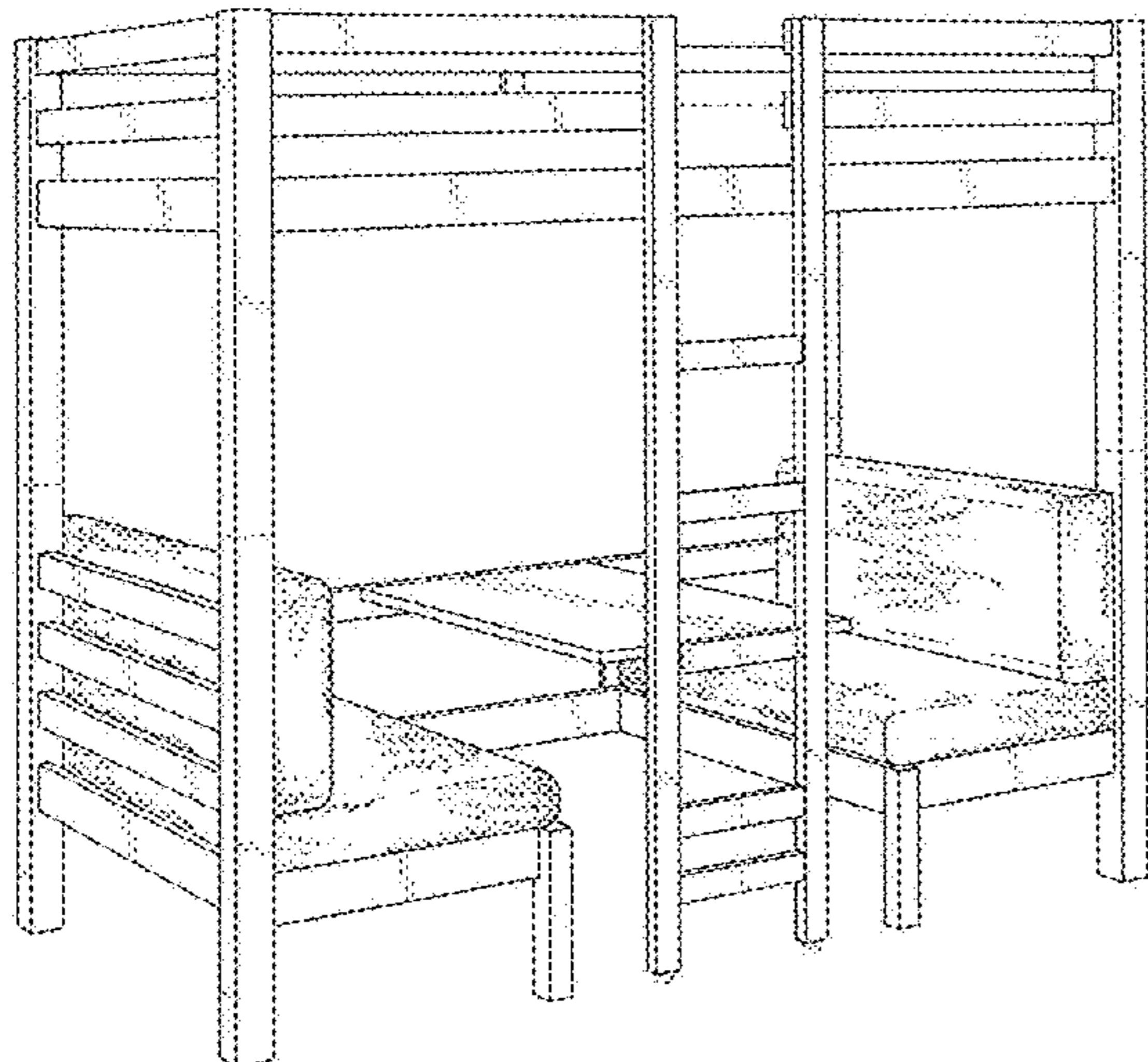

**DESCRIPTION**

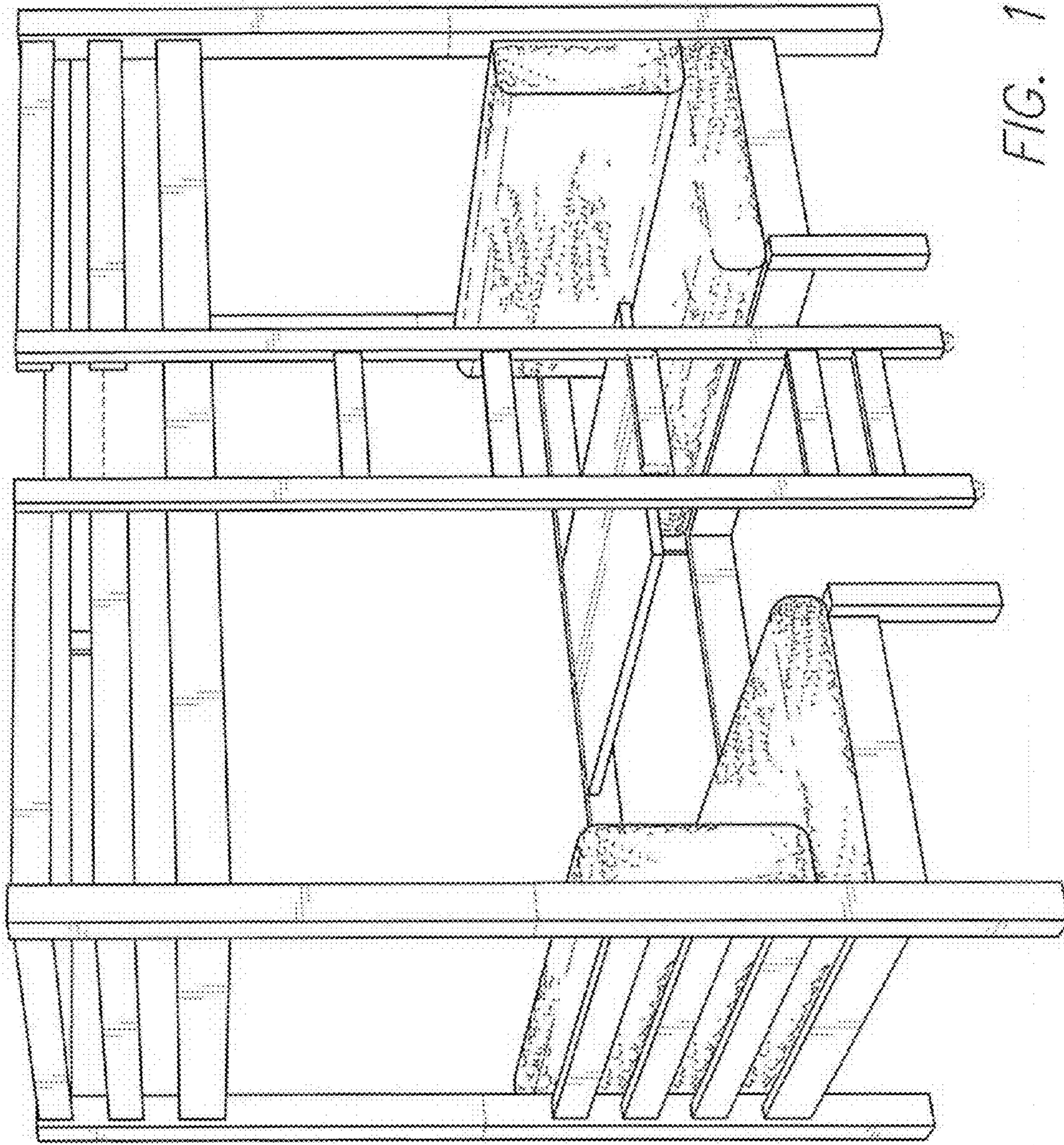

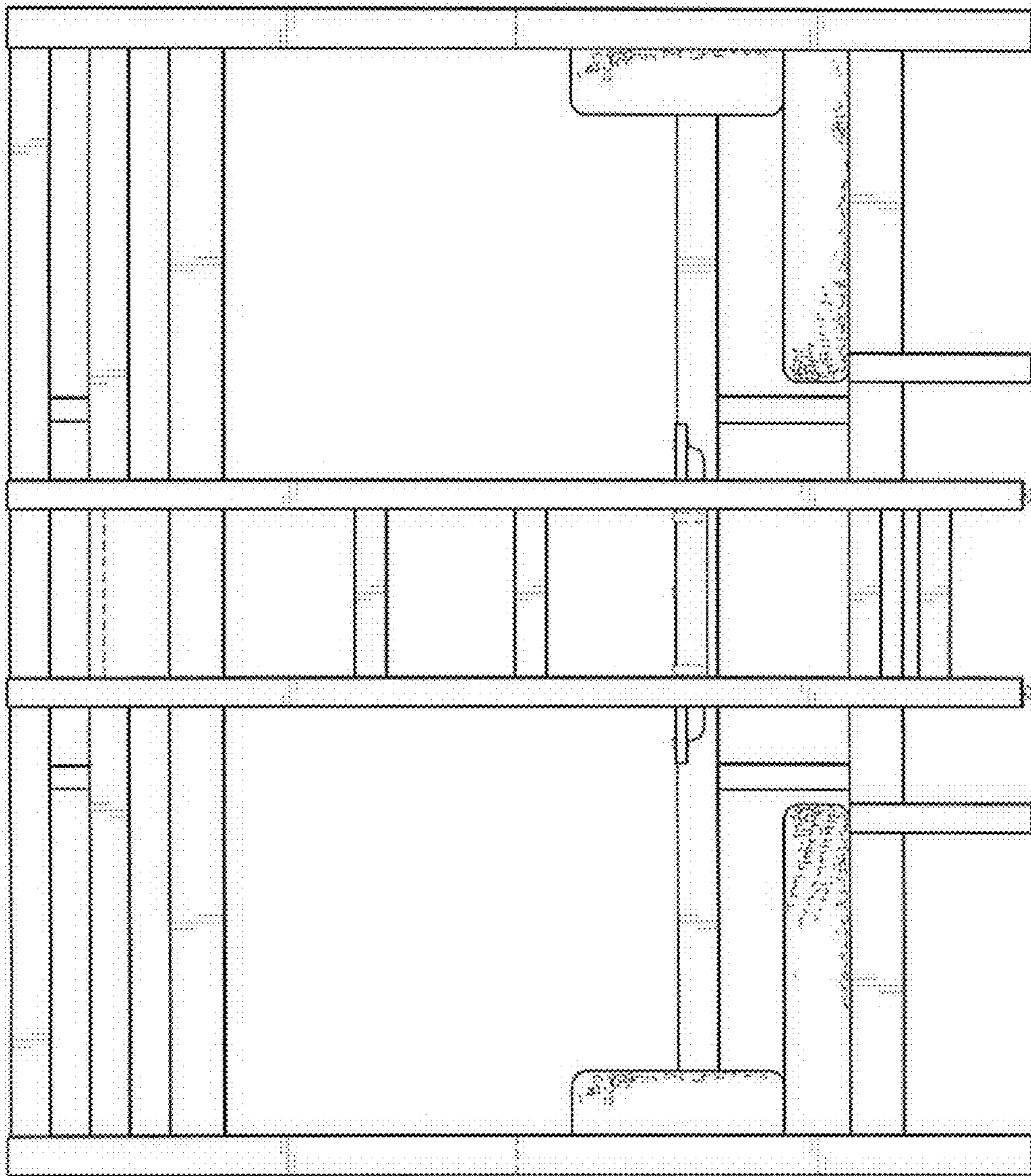

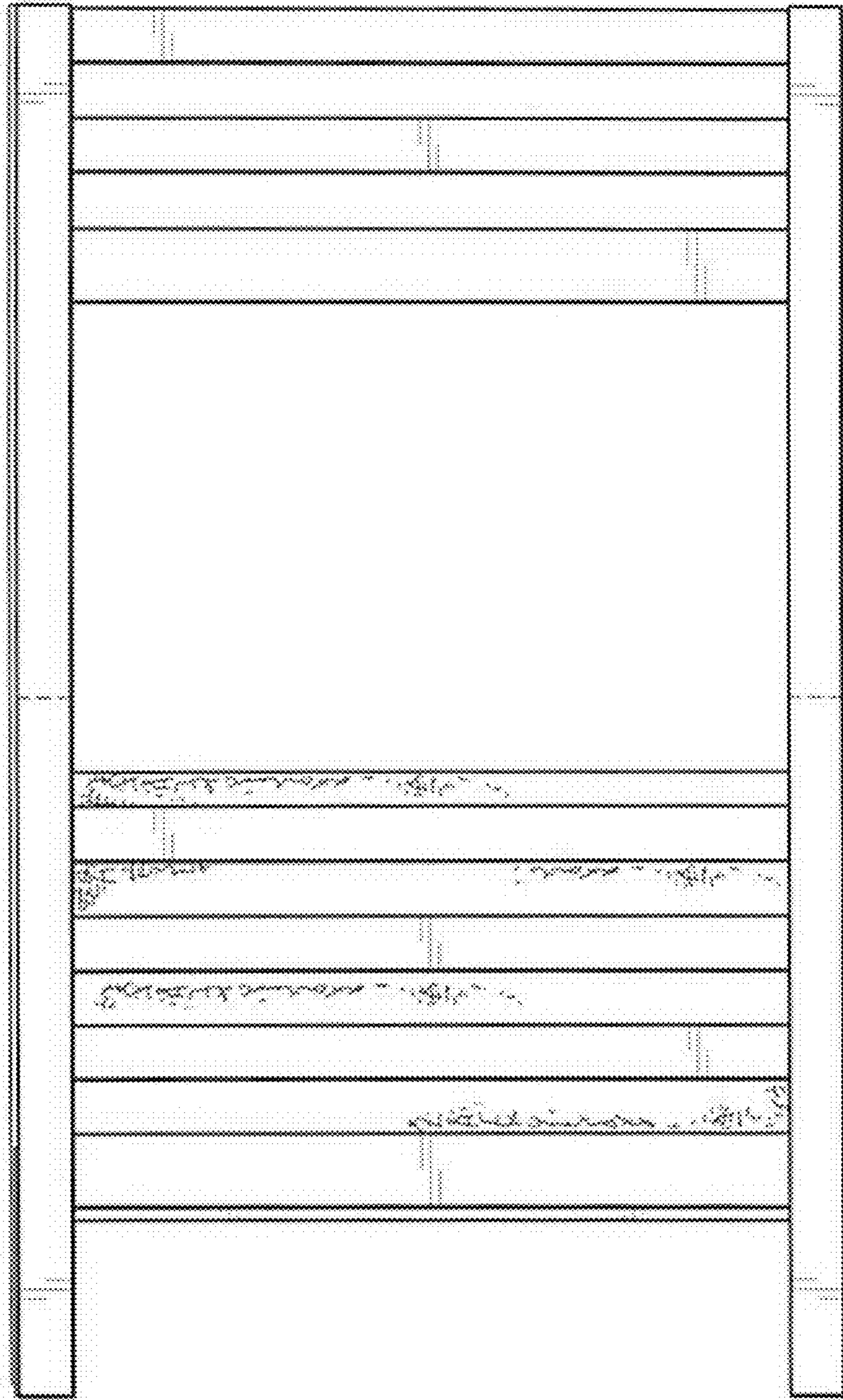

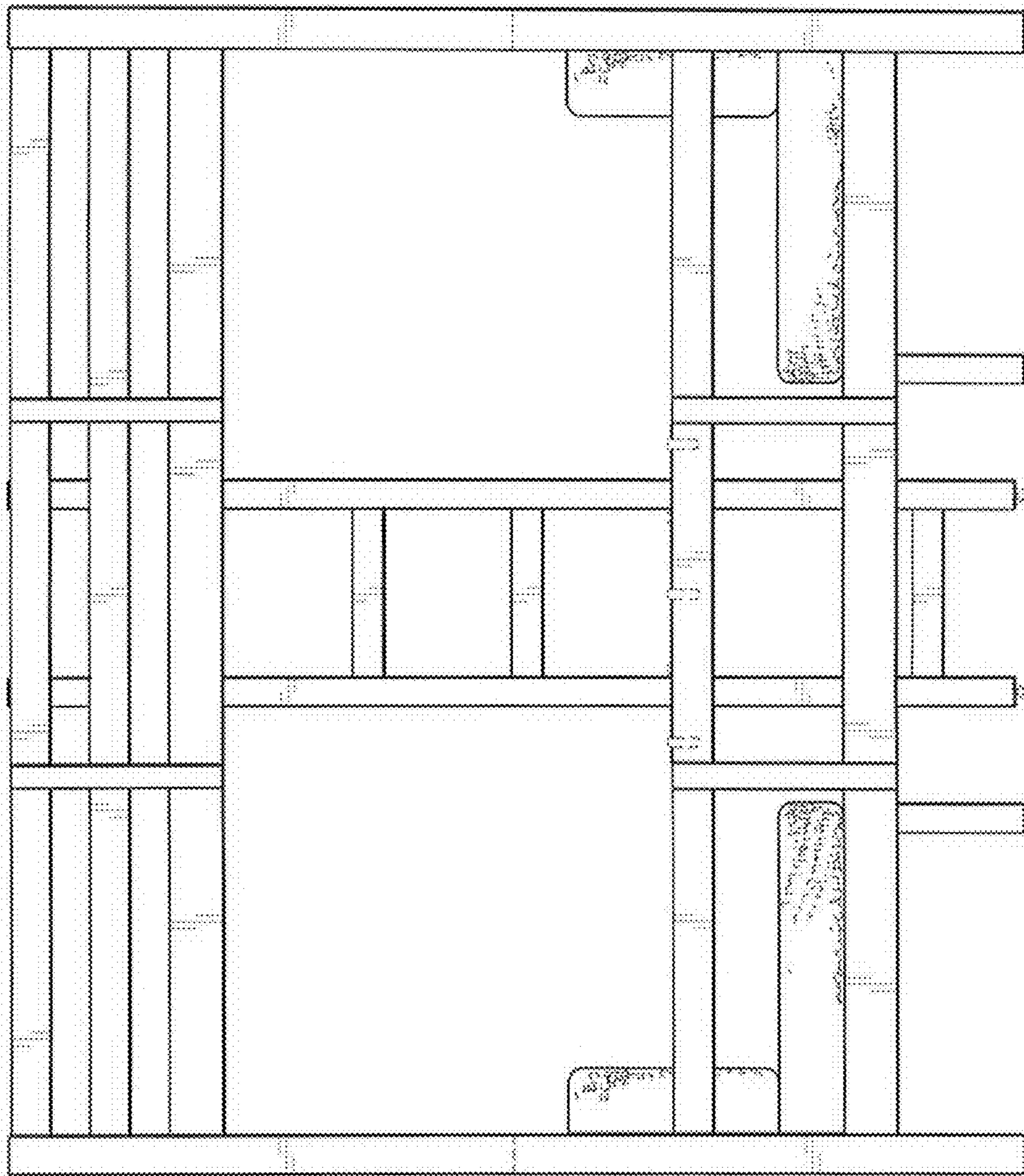

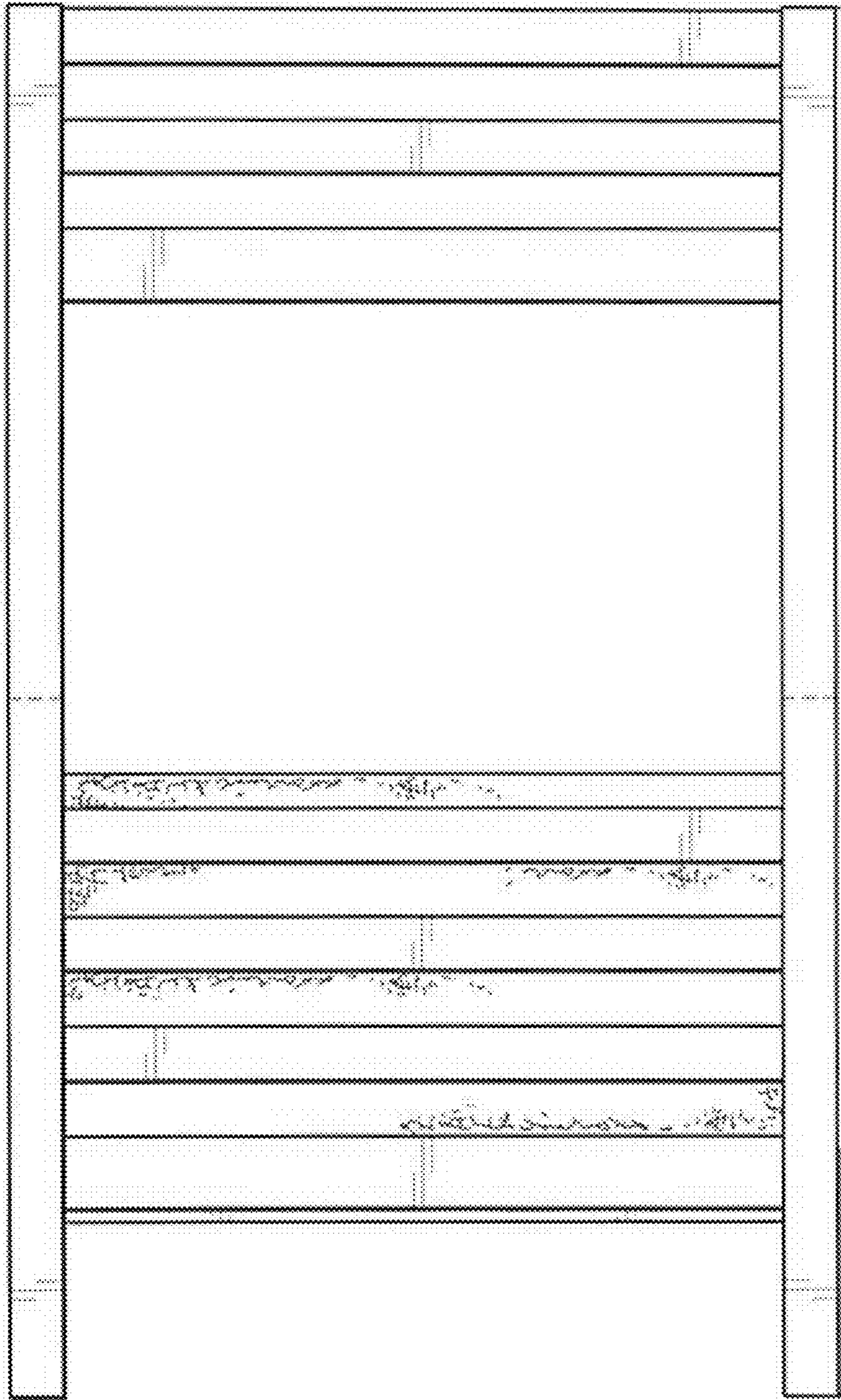

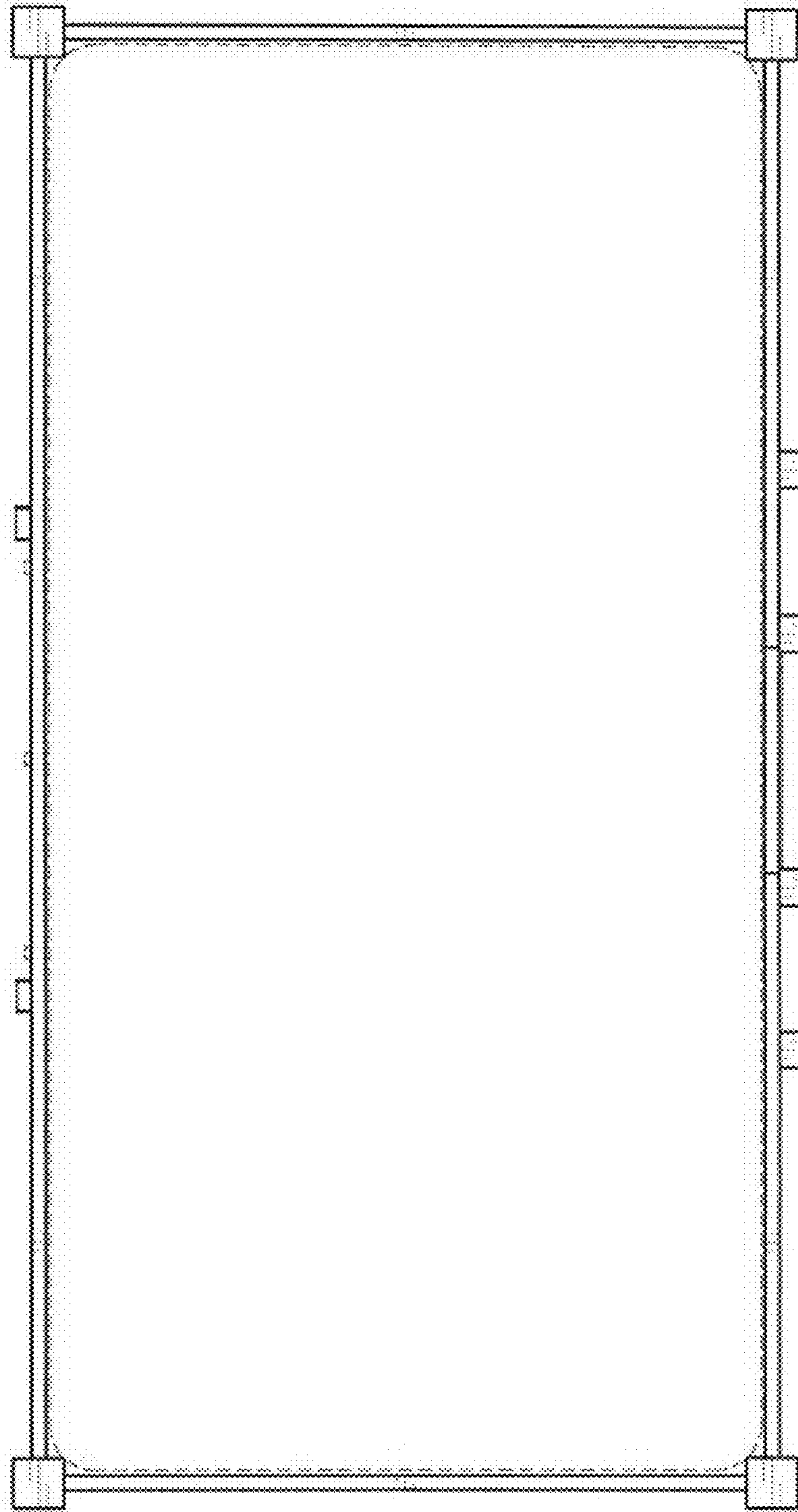

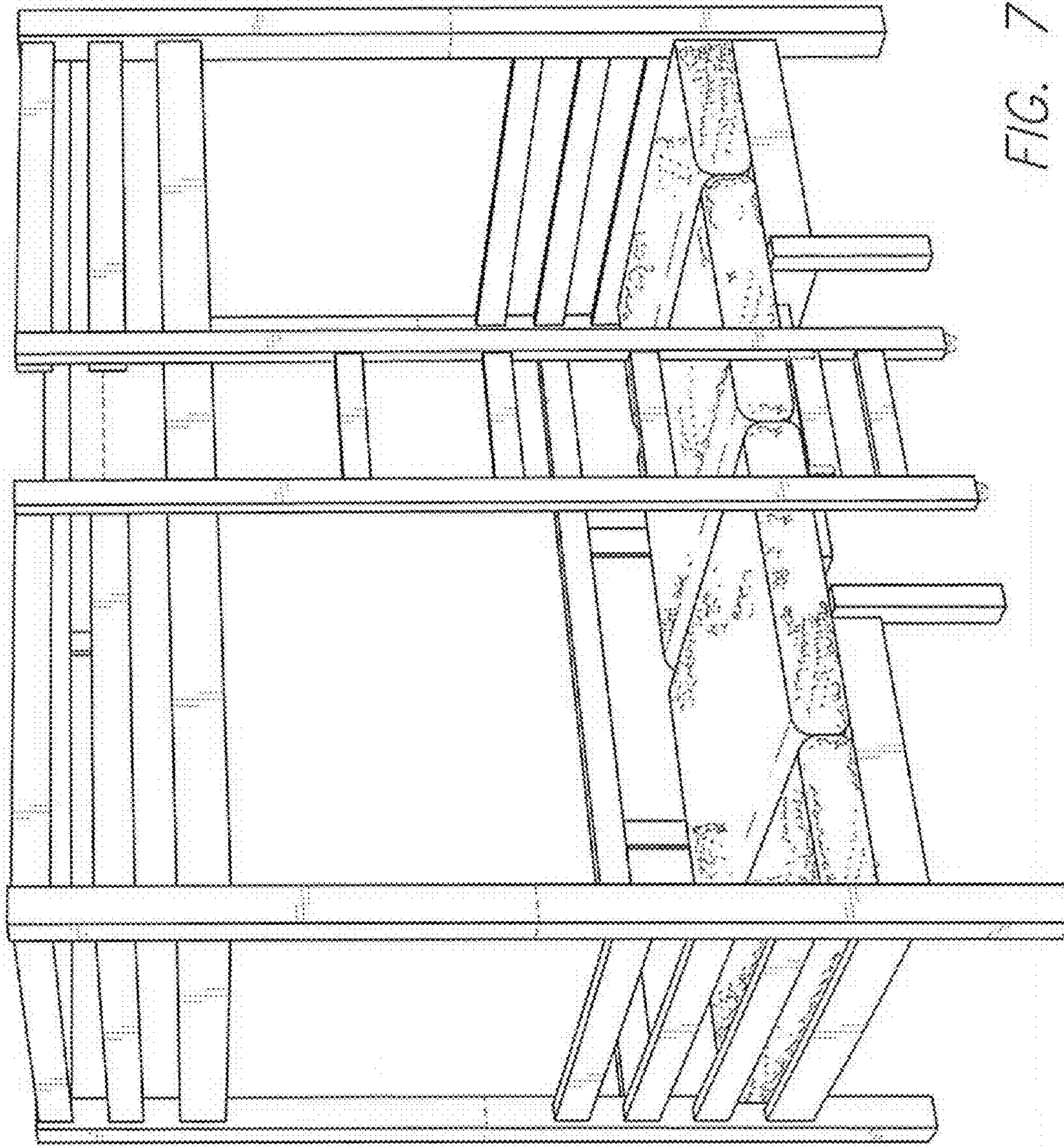

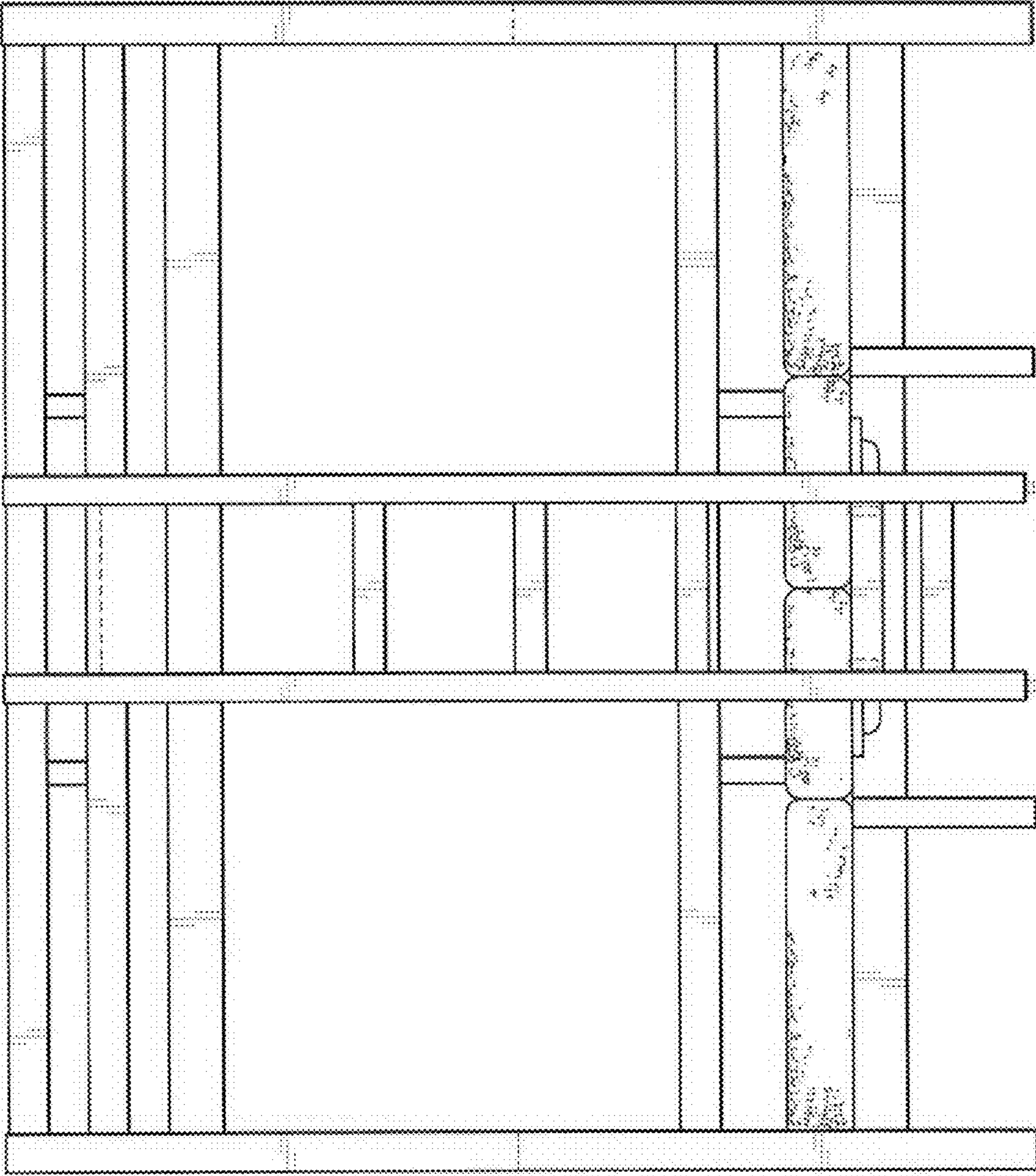

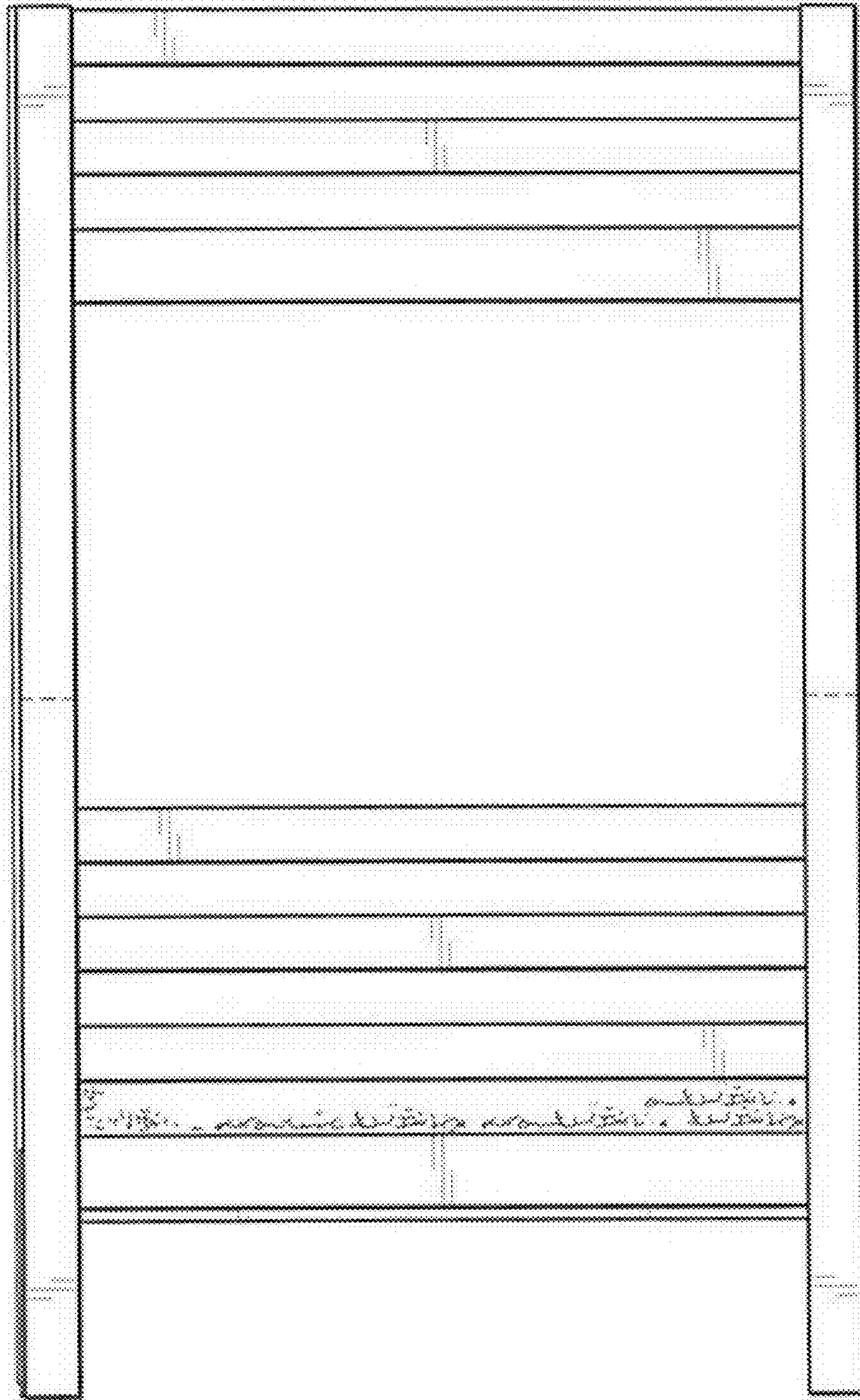

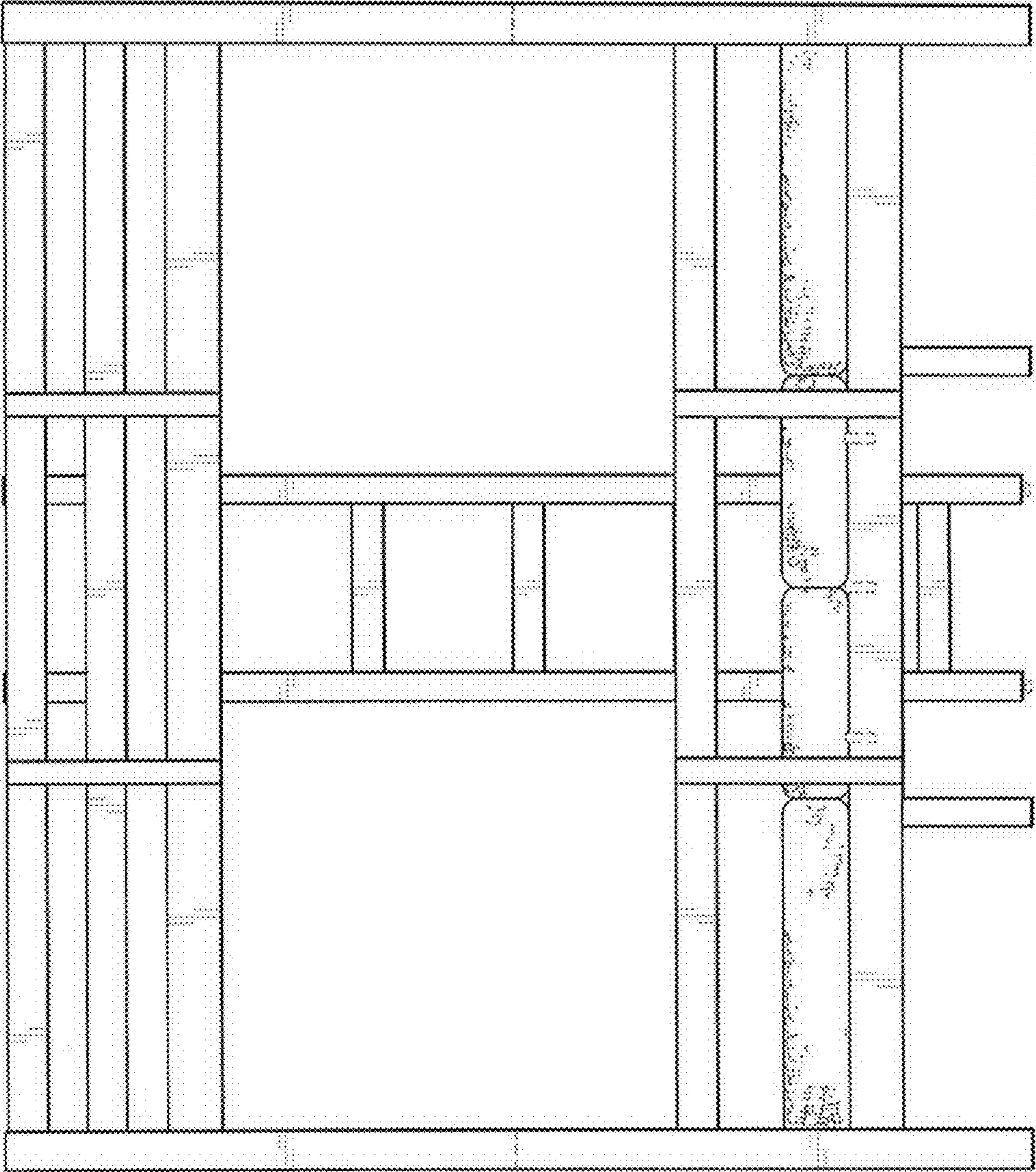

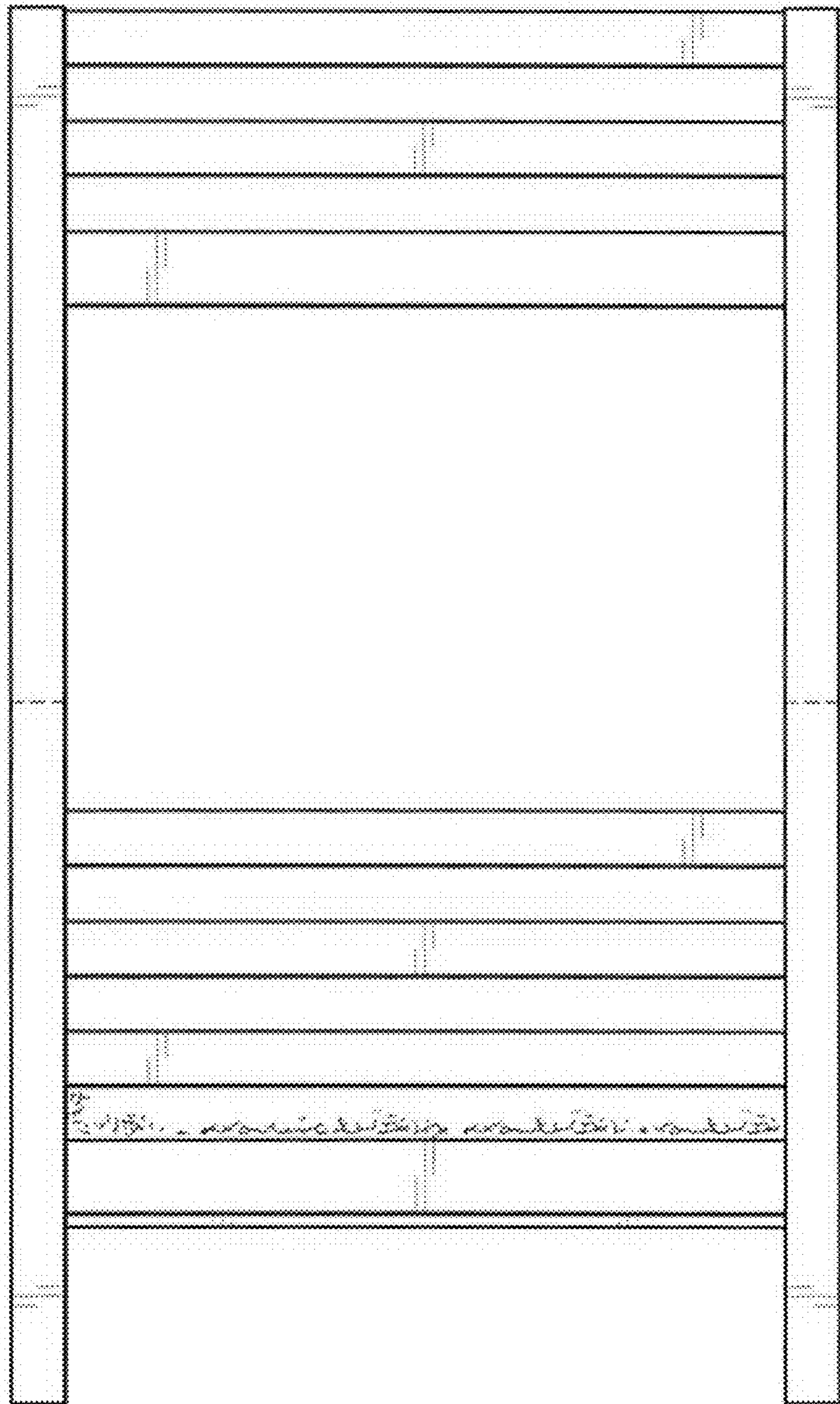

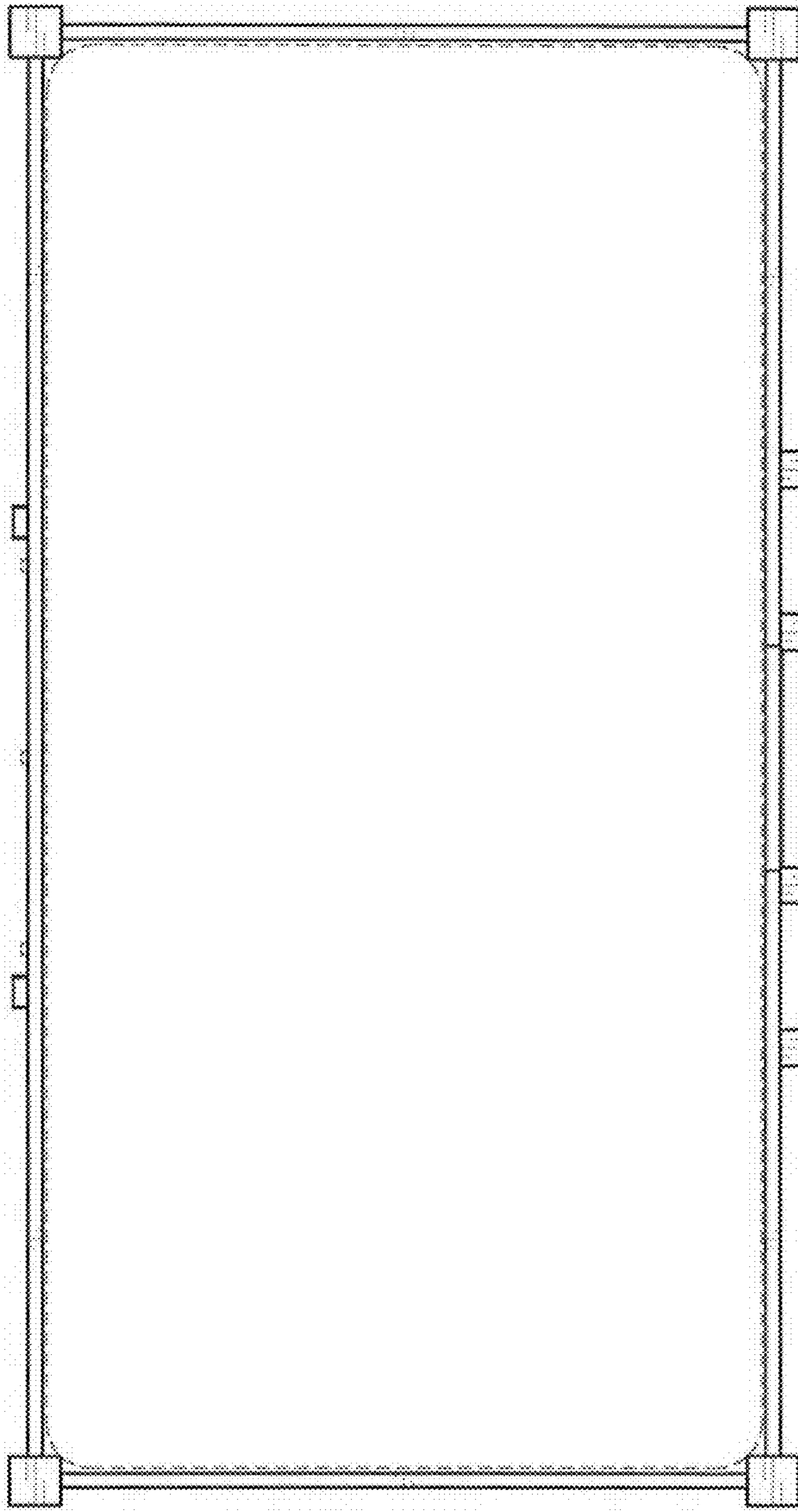
