(57) **CLAIM**

The ornamental design for a fabric toilet paper storage unit, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, left side, and top perspective view of a fabric toilet paper storage unit showing my new design; FIG. 2 is a front, left side, and top perspective view of a fabric toilet paper storage unit with the right front partially open, the left front being a mirror image of the right front. FIG. 3 is a front elevational view thereof; FIG. 4 is a left side elevational view thereof, the right side being a mirror image; FIG. 5 is a rear elevational view thereof; and, FIG. 6 is a bottom view thereof.

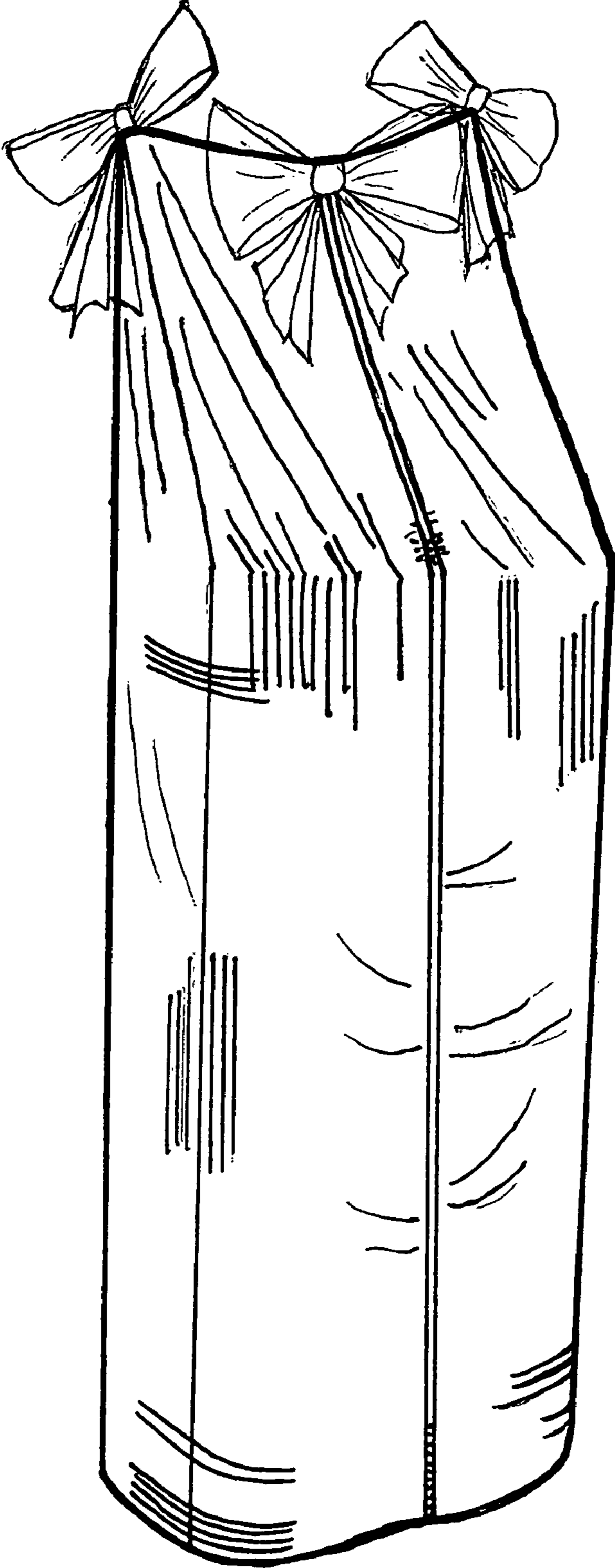

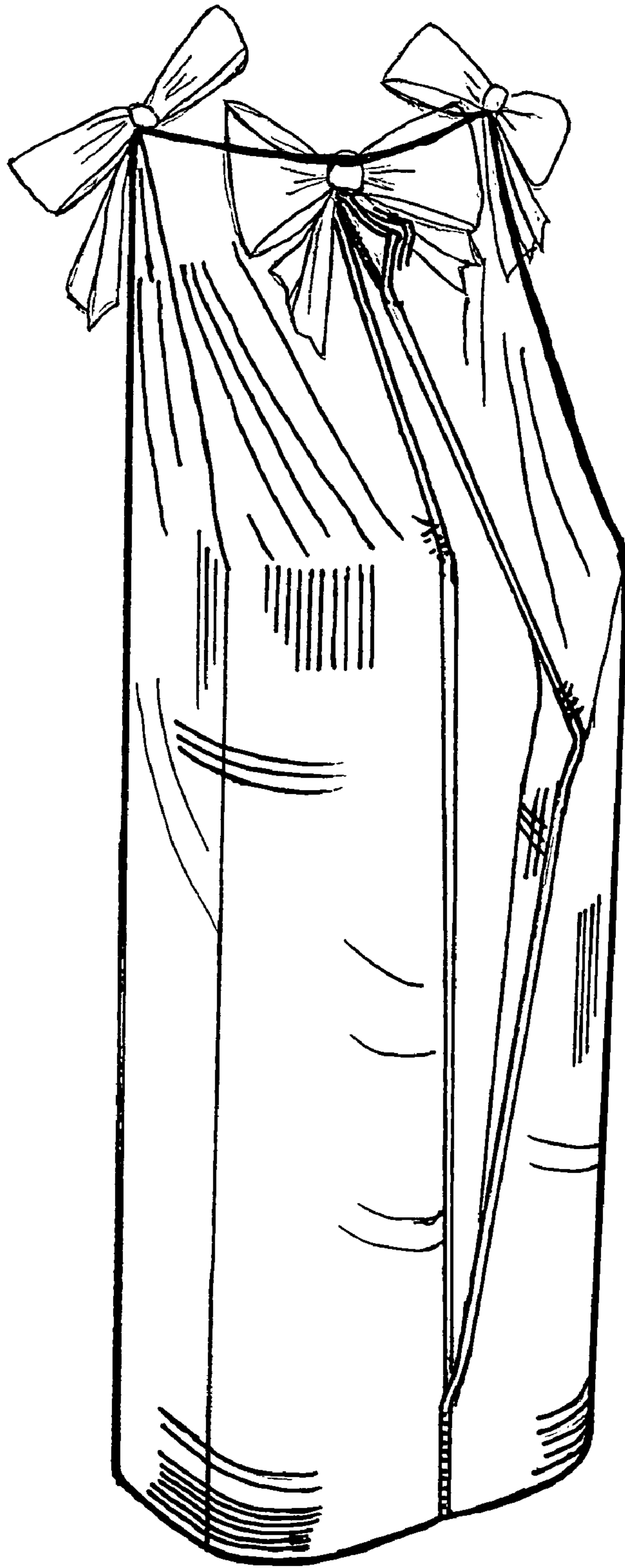

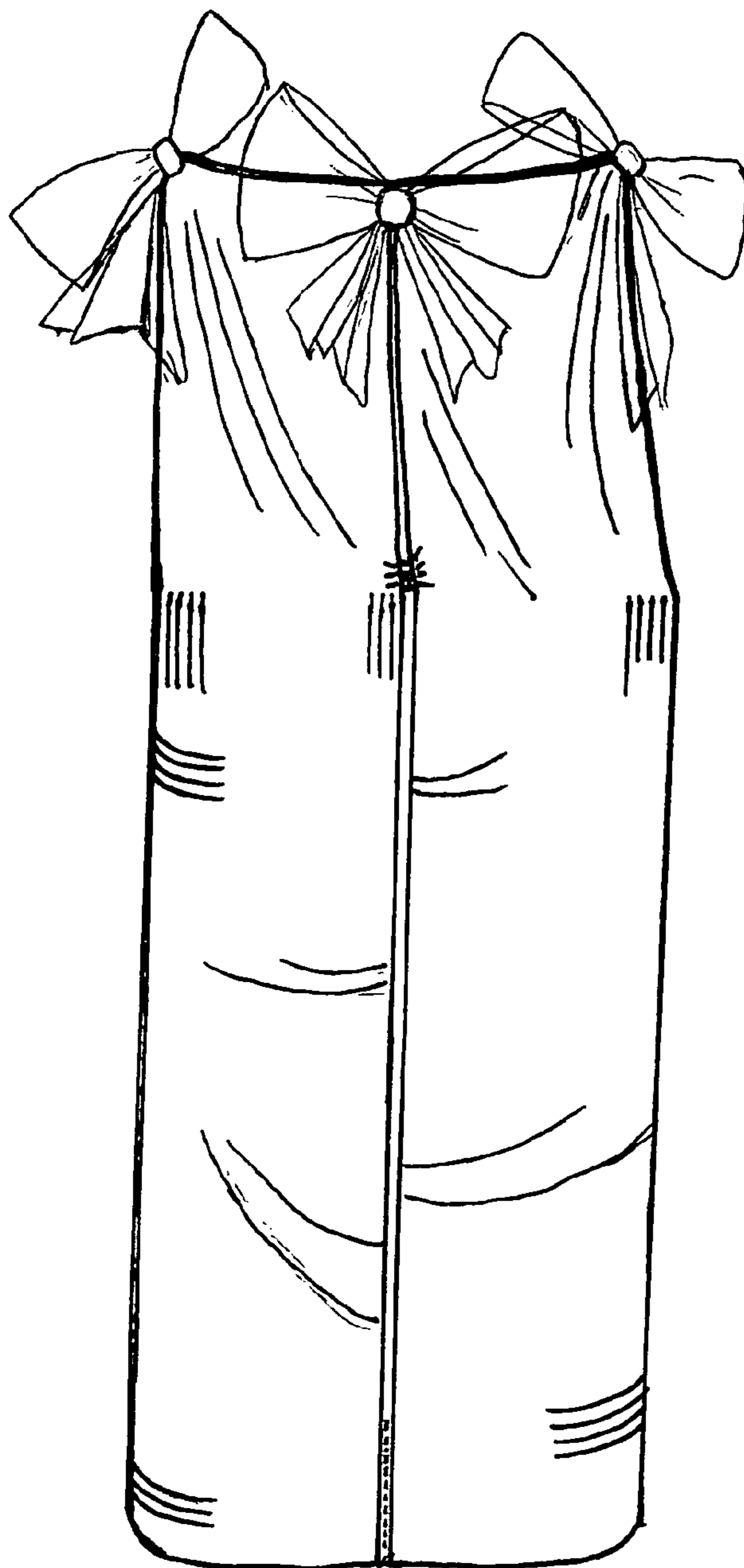

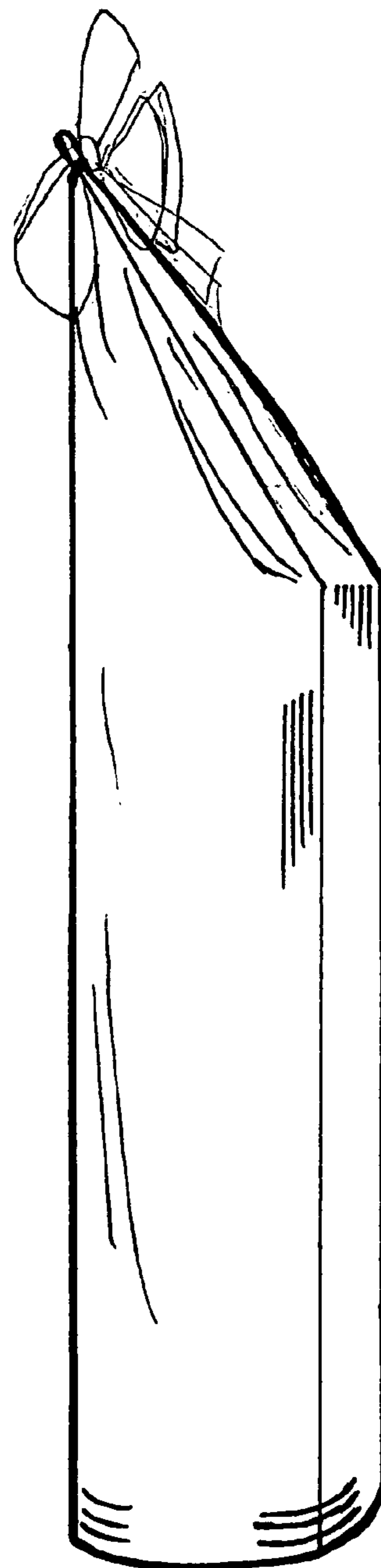

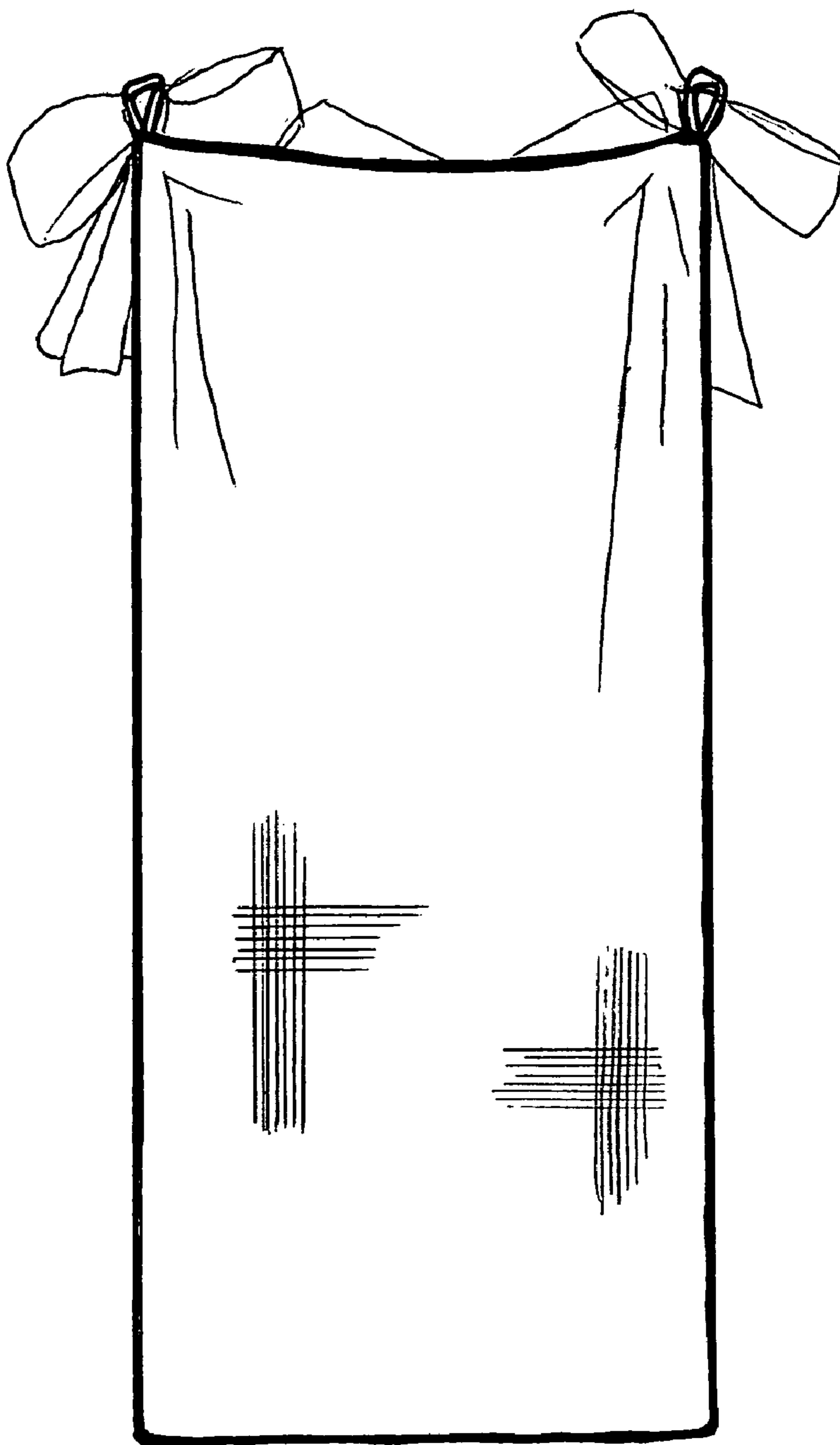
