DESCRIPTION

FIG. 1 is a top, front, left side perspective view of a vase showing the new design;

FIG. 2 is a front elevation view thereof;

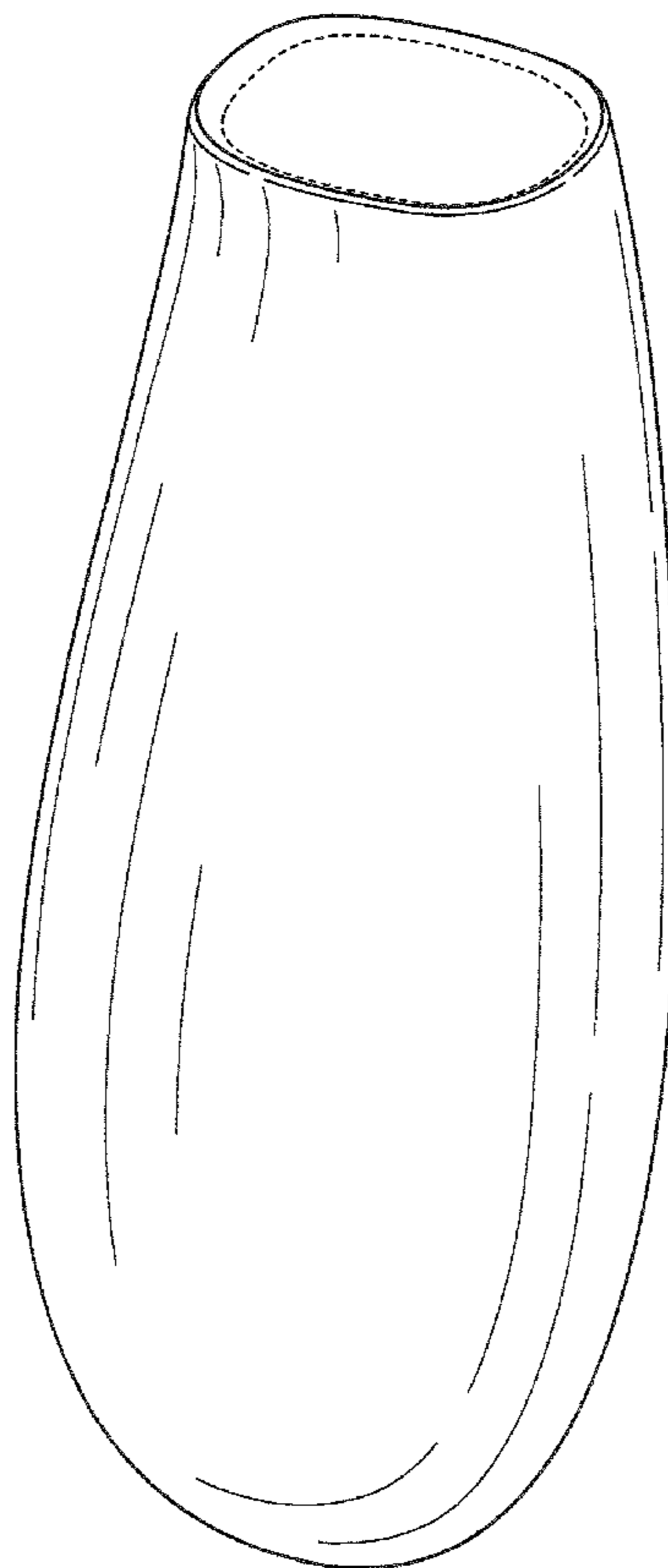

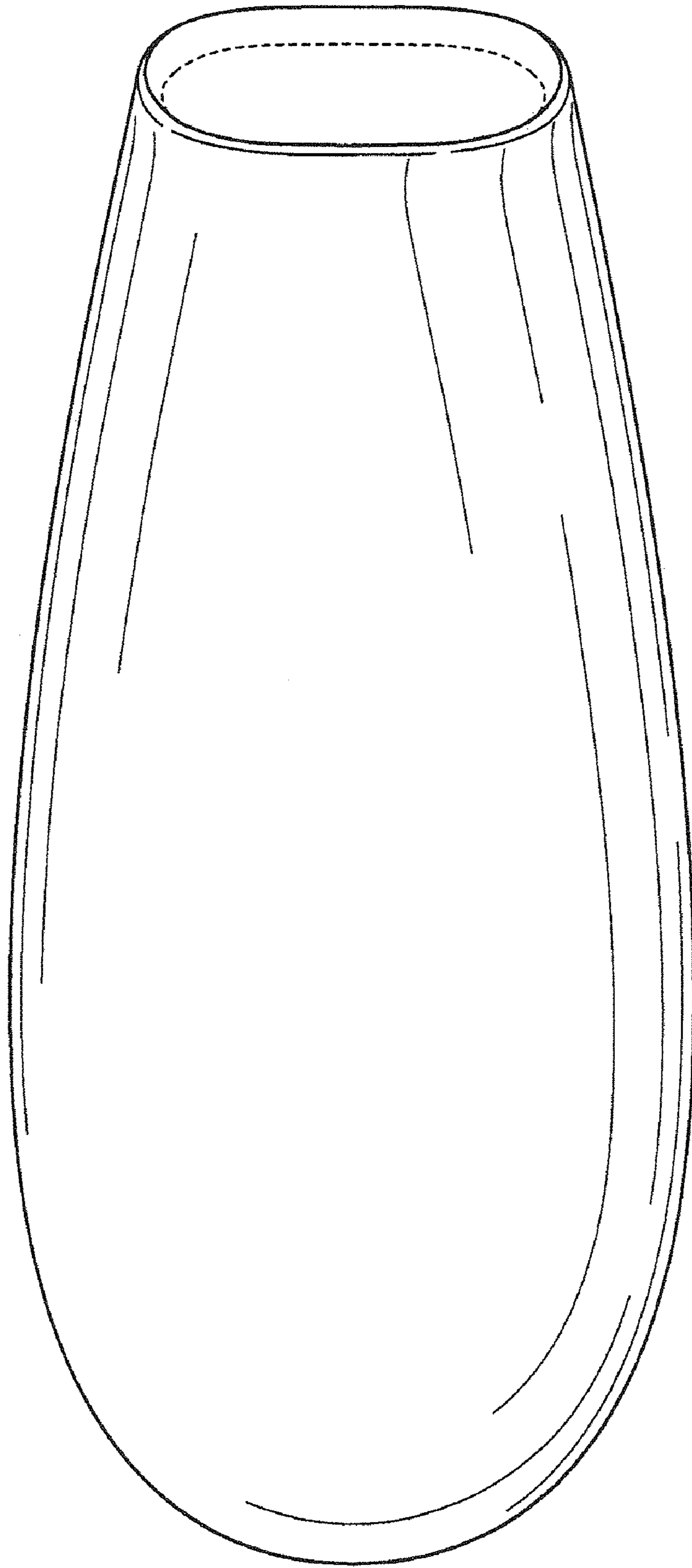

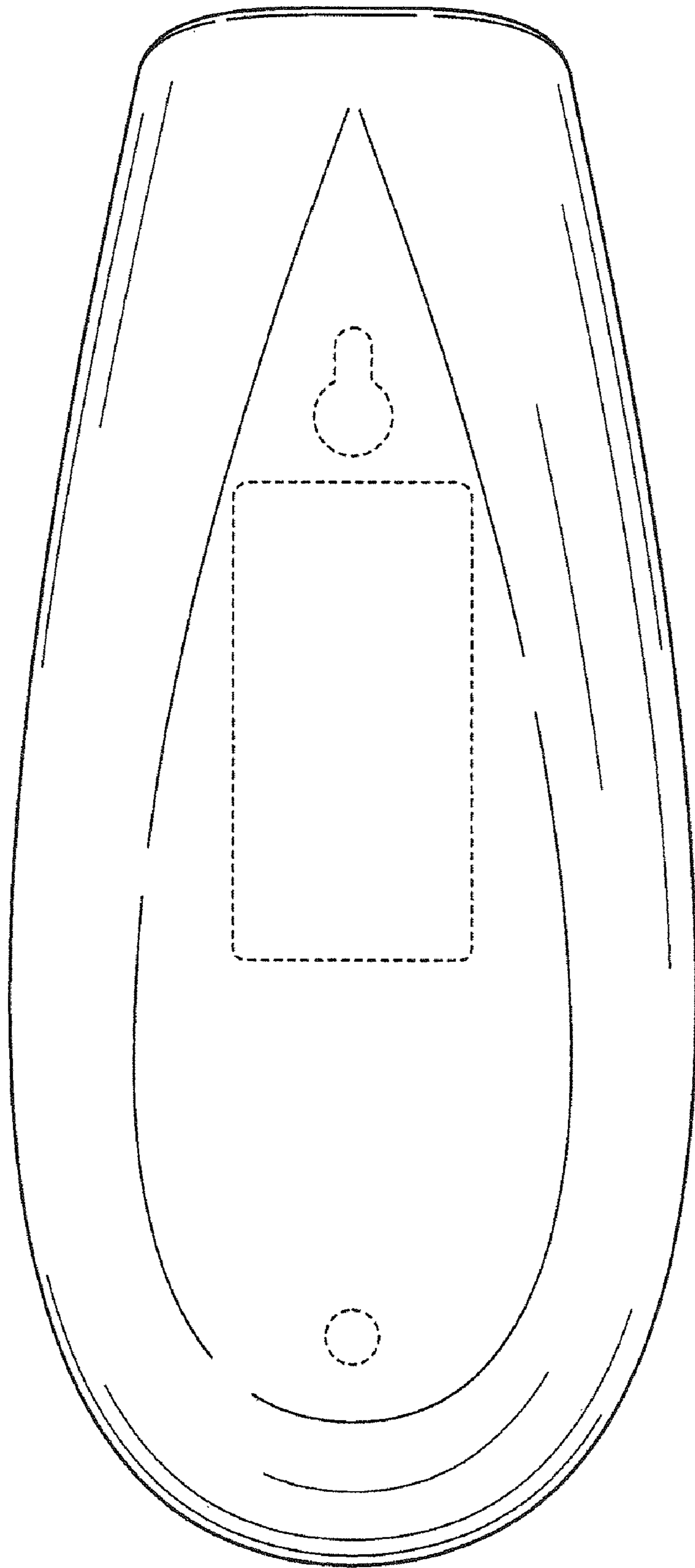

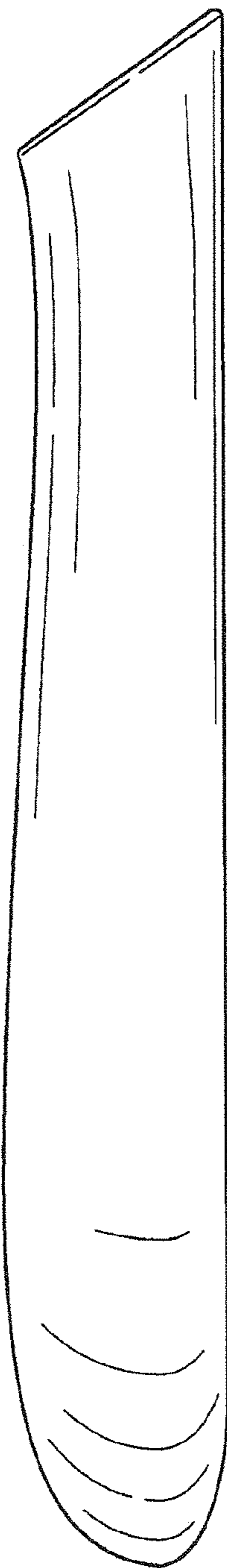

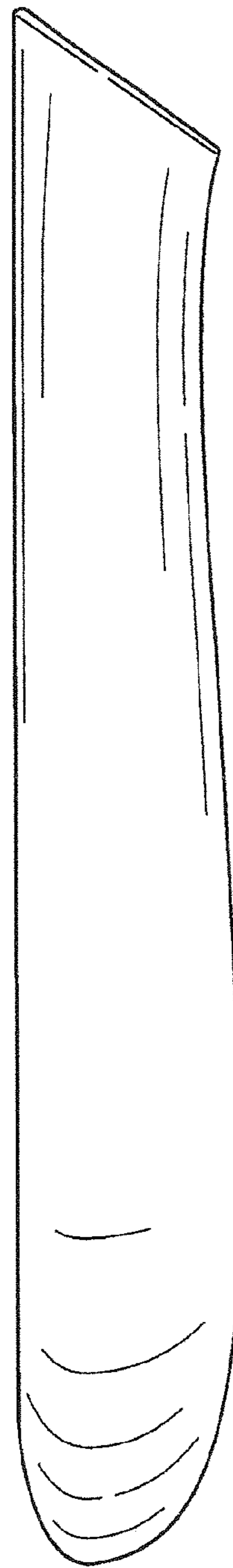

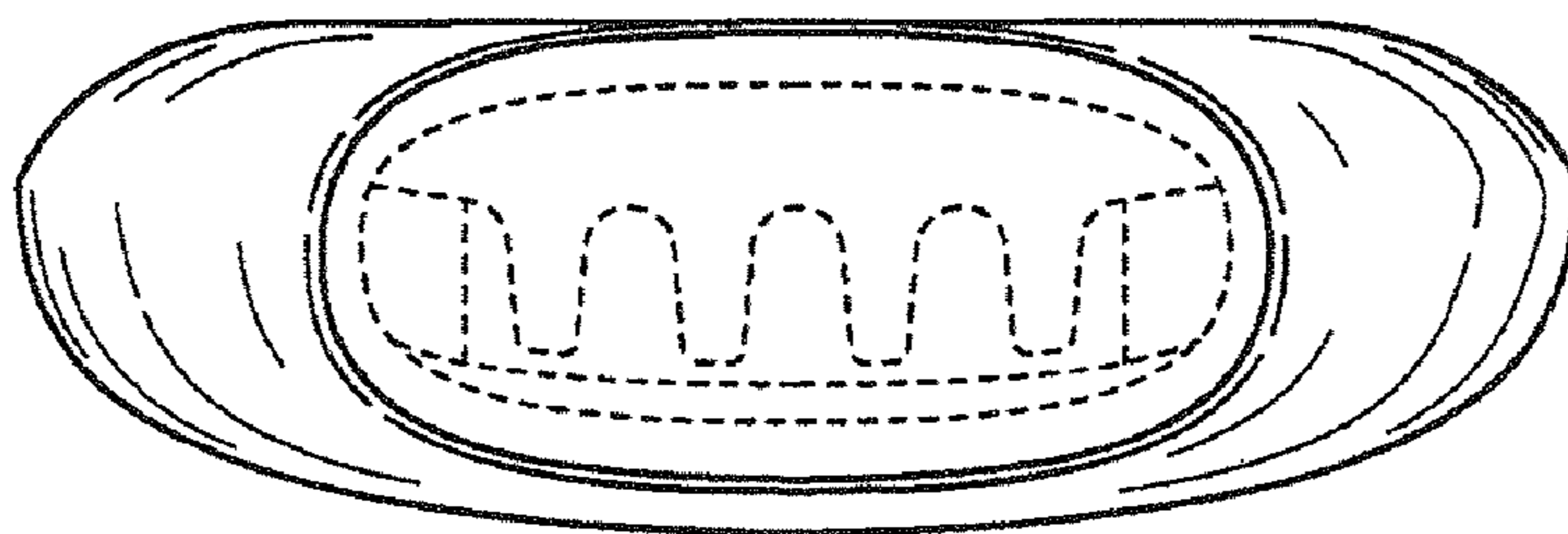

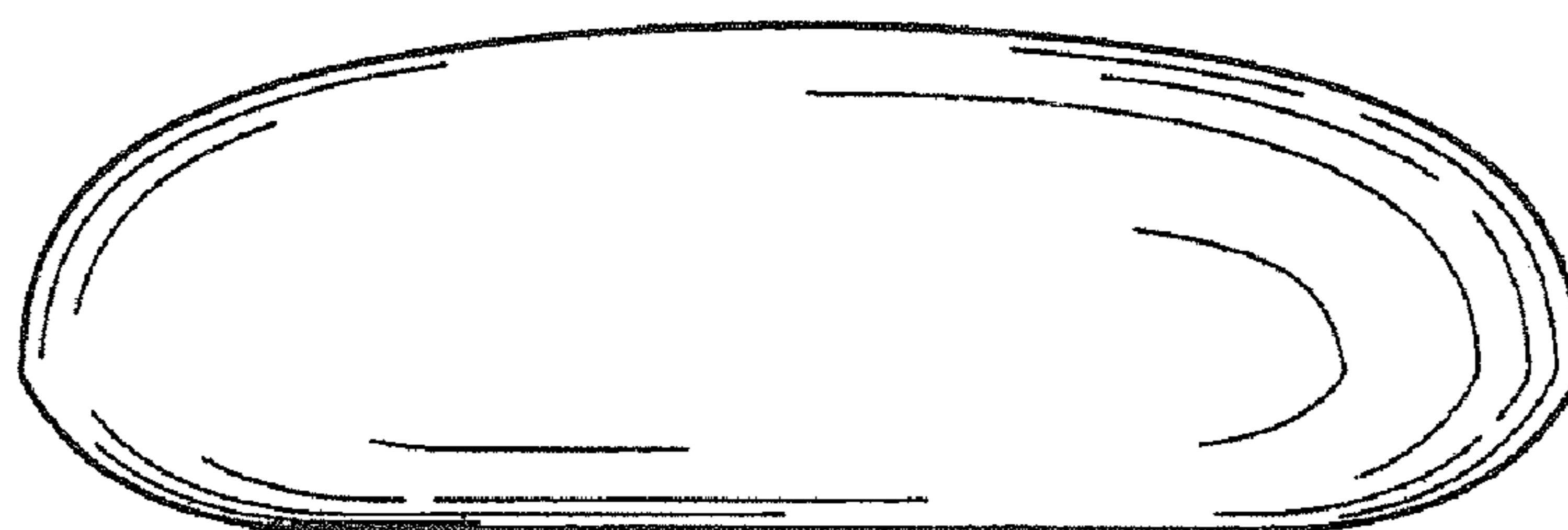
