(57) **CLAIM**

I claim the ornamental design for a body support, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a body support constructed in accordance with the present invention.

FIG. 2 is a front view of the body support shown in FIG. 1.

FIG. 3 is a rear view of the body support shown in FIGS. 1 and 2.

FIG. 4 is a left side view of the body support shown in FIGS. 1-3.

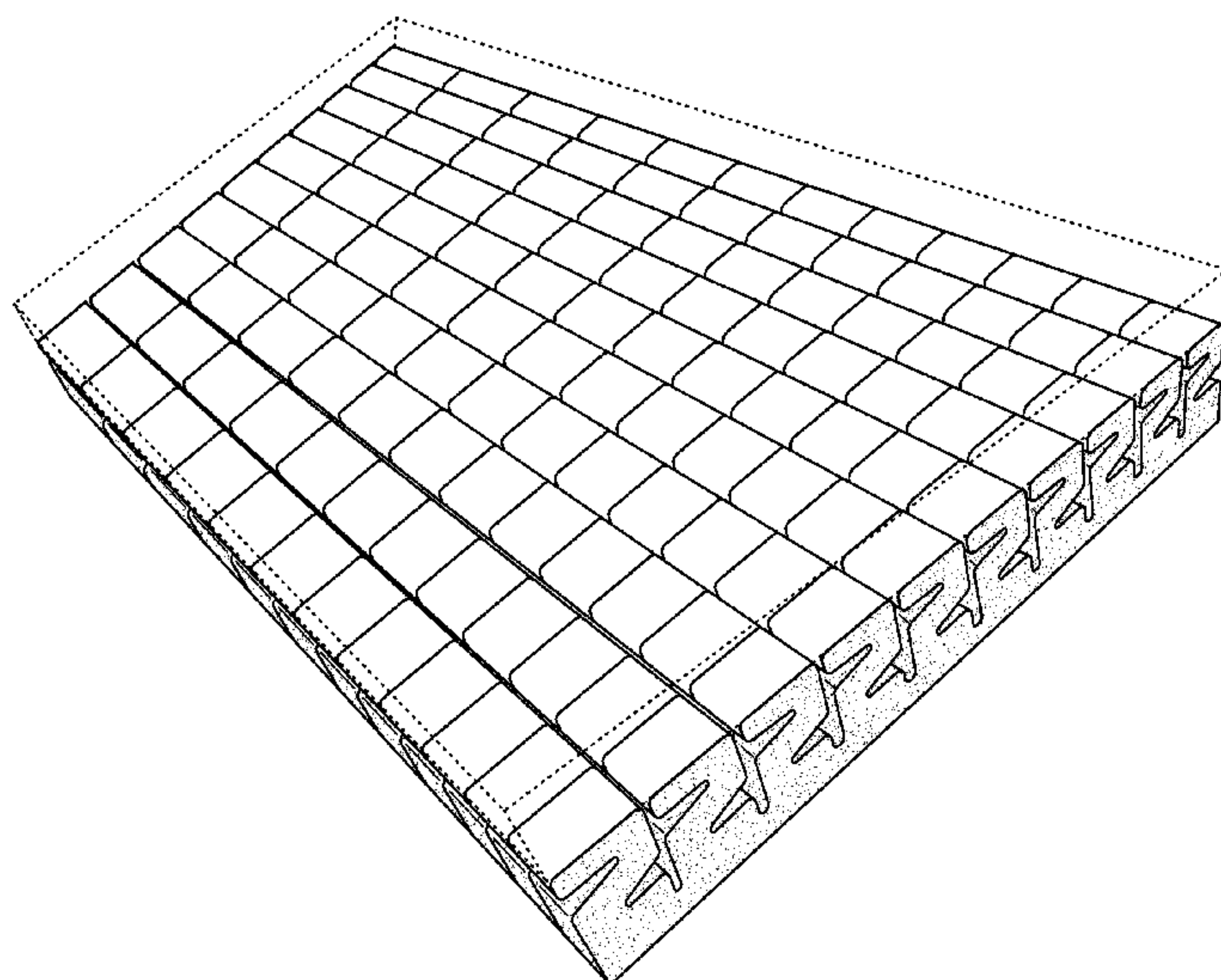
FIG. 5 is a right side view of the body support shown in FIGS. 1-4.

FIG. 6 is a planar view of the body support shown in FIGS. 1-5; and,

FIG. 7 is another planar view of the opposite side of the body support shown in FIGS. 1-6.

The broken line disclosure is understood to represent portions of the article in which the claimed design is embodied, but which form no part of the claimed design. Where surface shading meets a broken line, that broken line is understood to represent an unclaimed boundary between claimed and unclaimed surfaces.

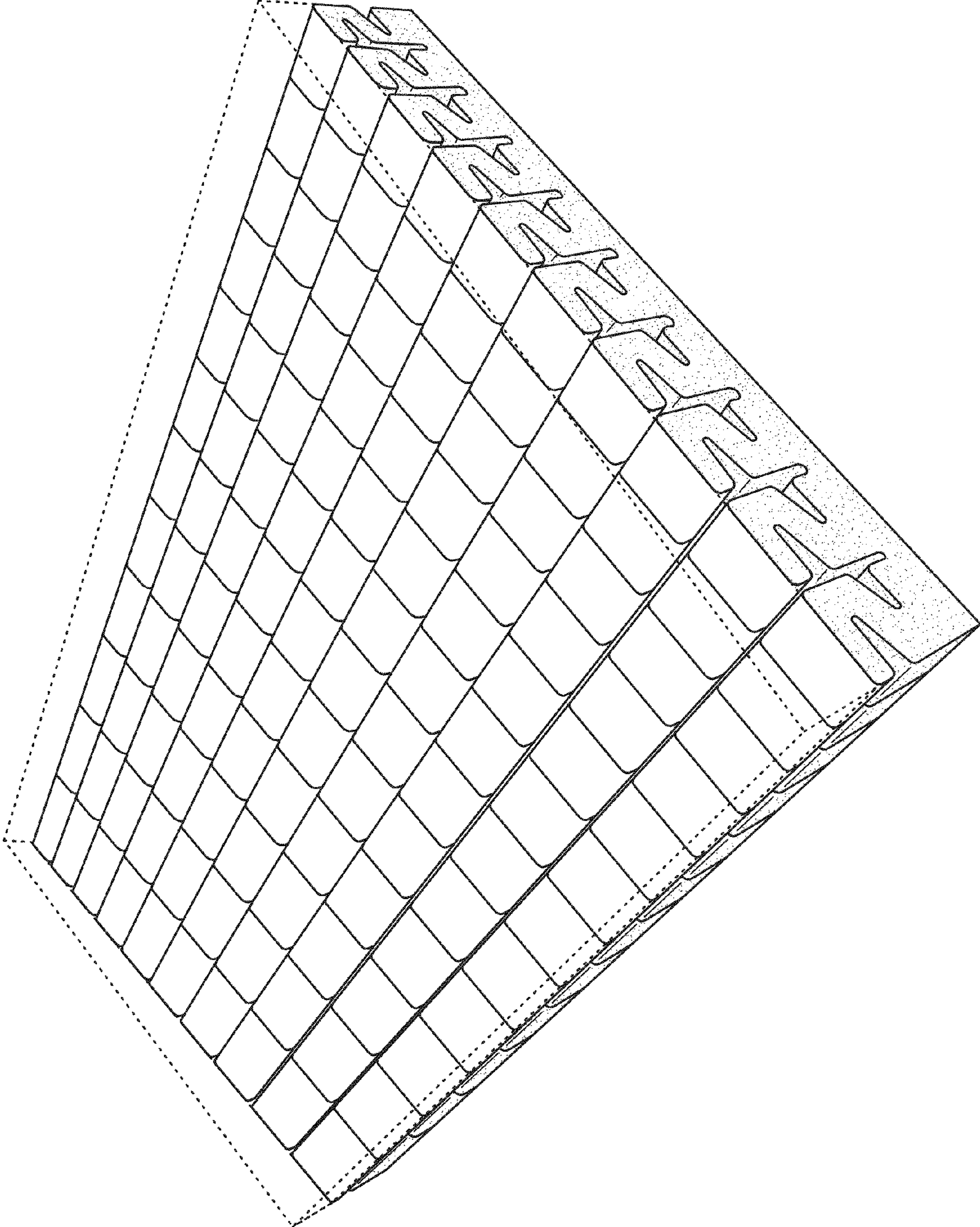

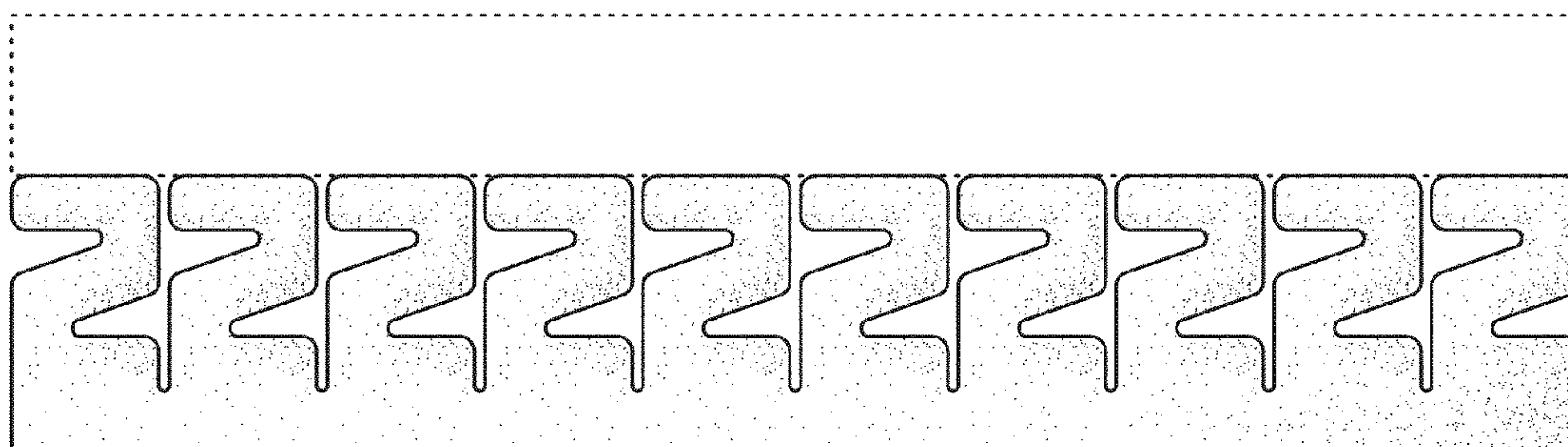

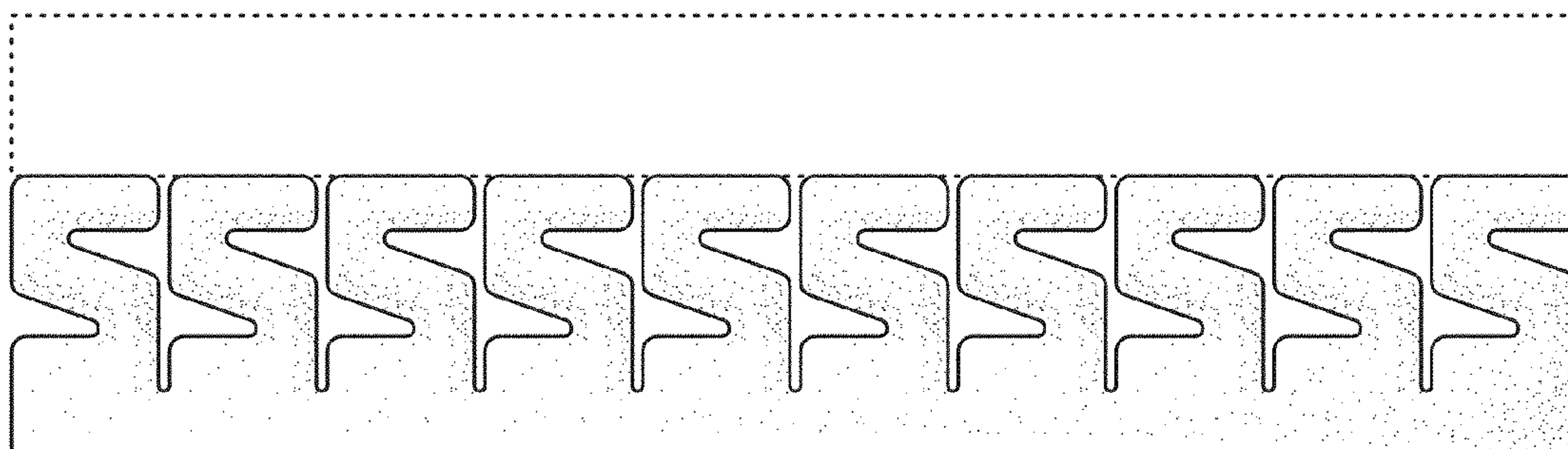

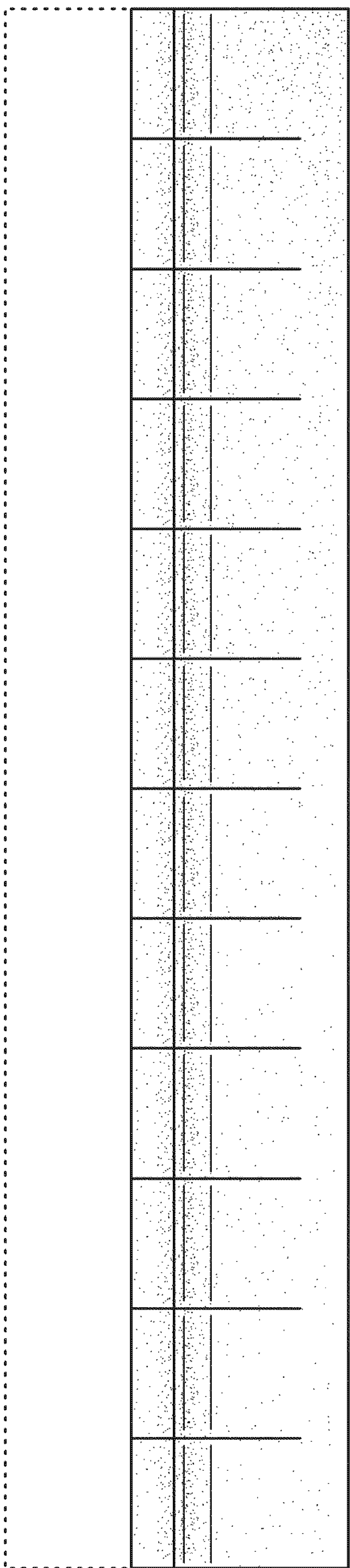

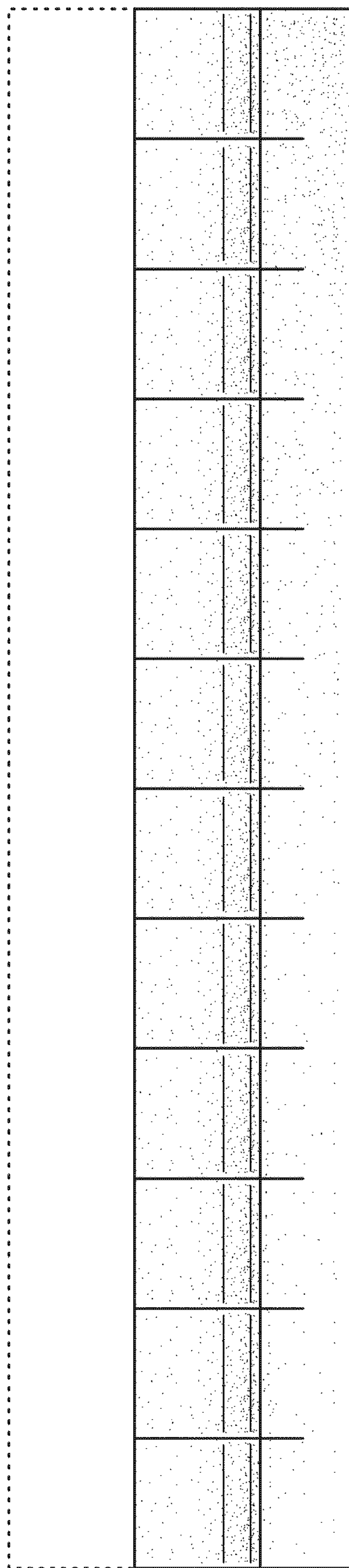

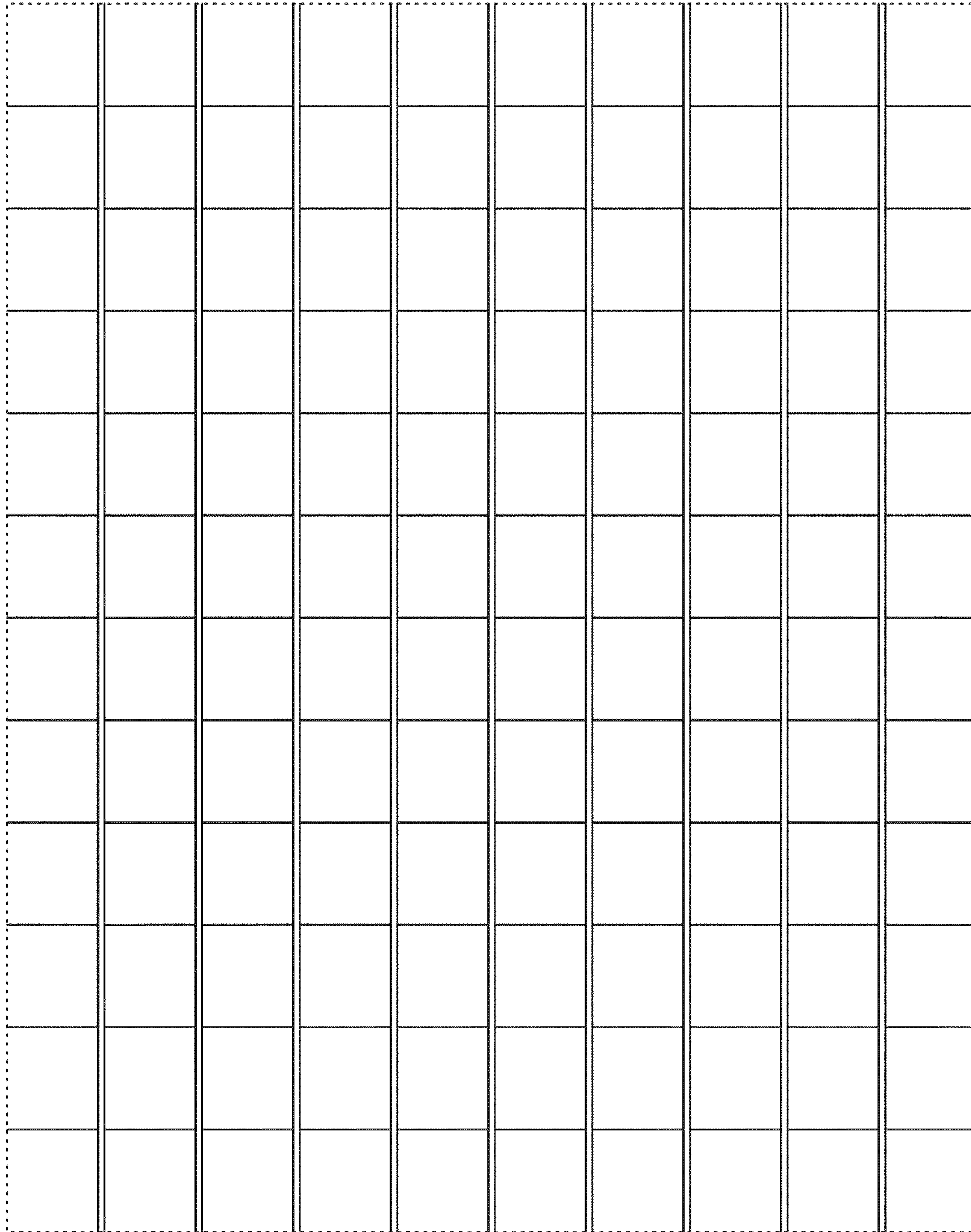

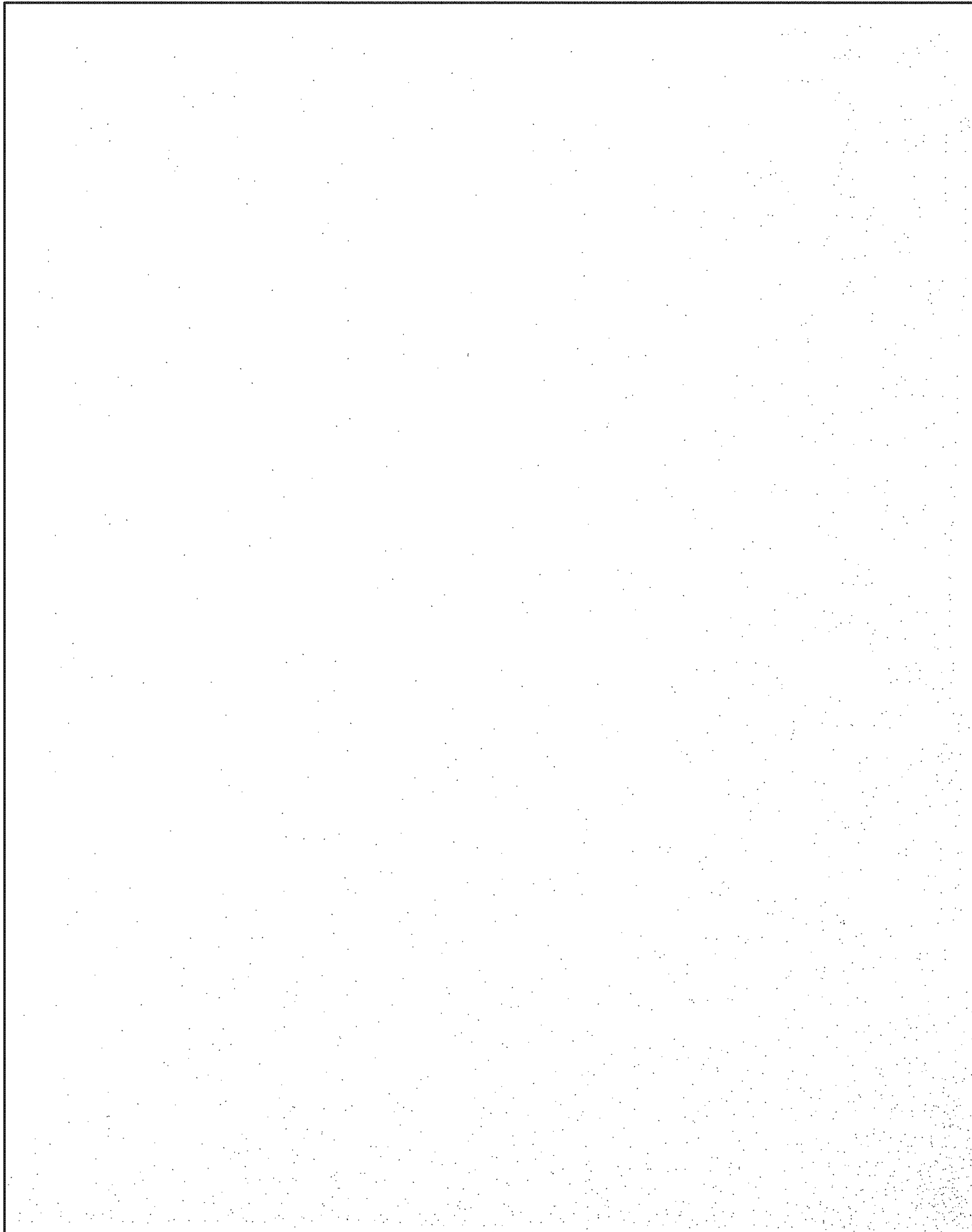
