(57) **CLAIM**

The ornamental design for a pair of handles for a microwave container cover, as shown and described.

DESCRIPTION

FIG. 1 is a top, side and front perspective view of a pair of handles for a microwave container cover showing my new design;

FIG. 2 is a bottom, side and rear perspective view thereof;

FIG. 3 is a front elevation view thereof;

FIG. 4 is a rear elevation view thereof;

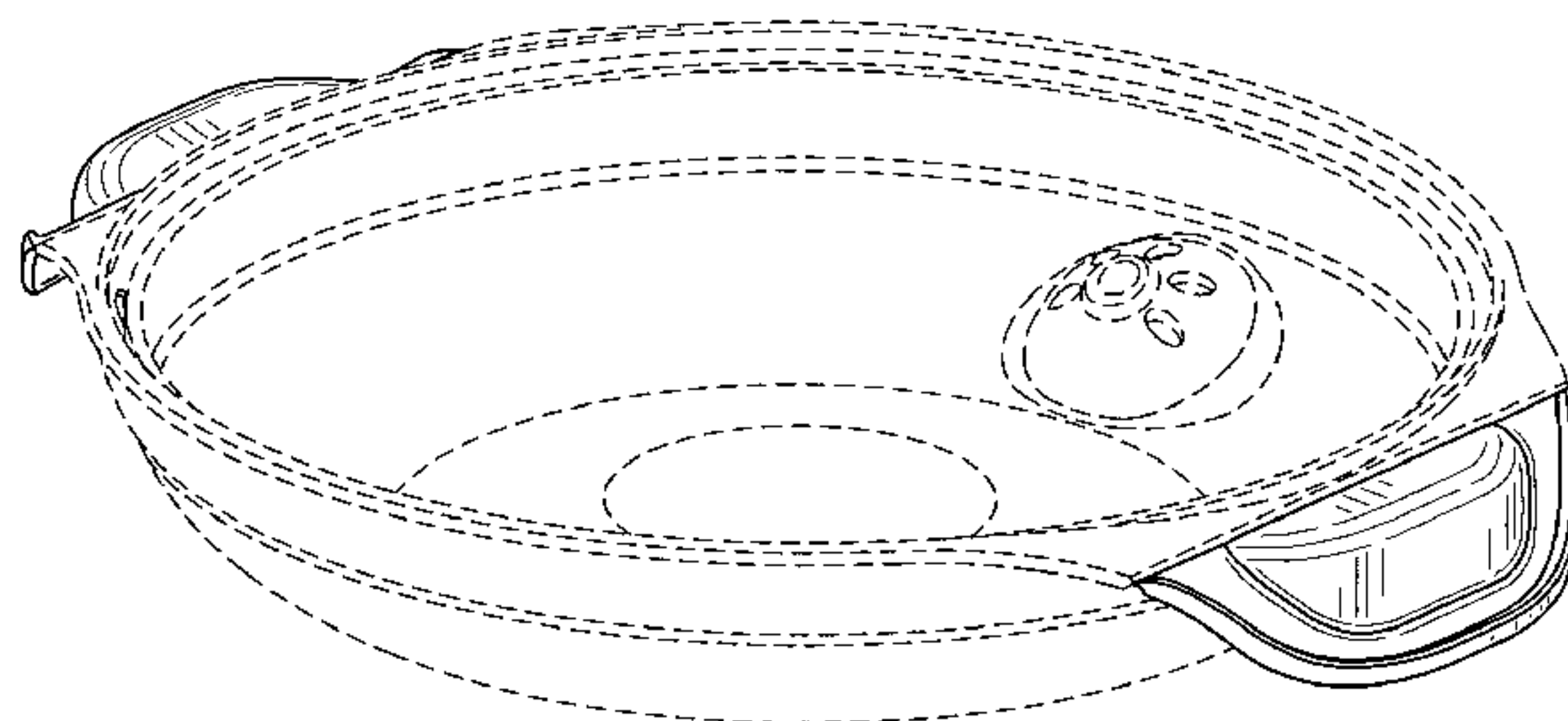
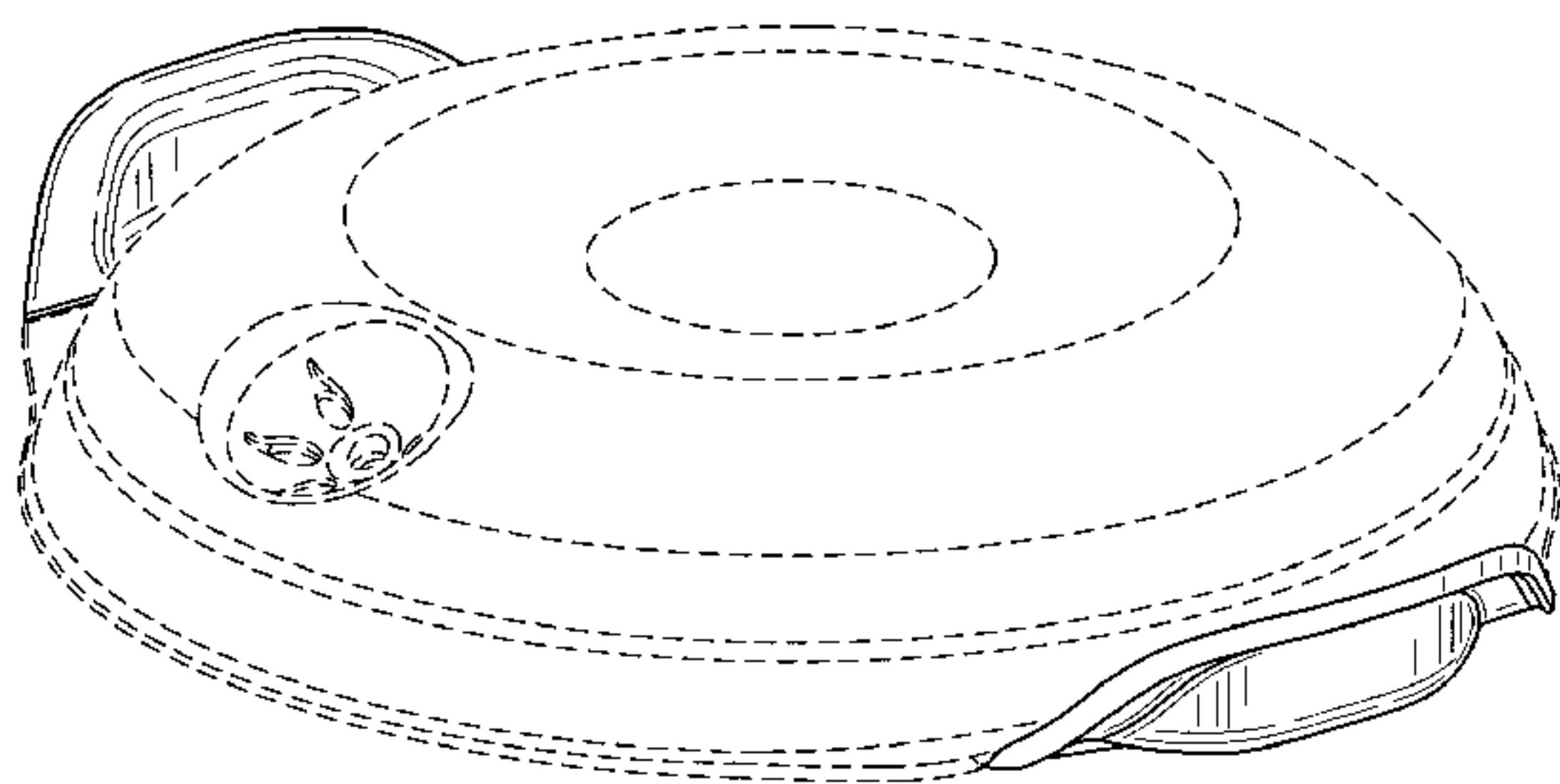
FIG. 5 is a right side elevation view, the left side elevation being identical thereto;

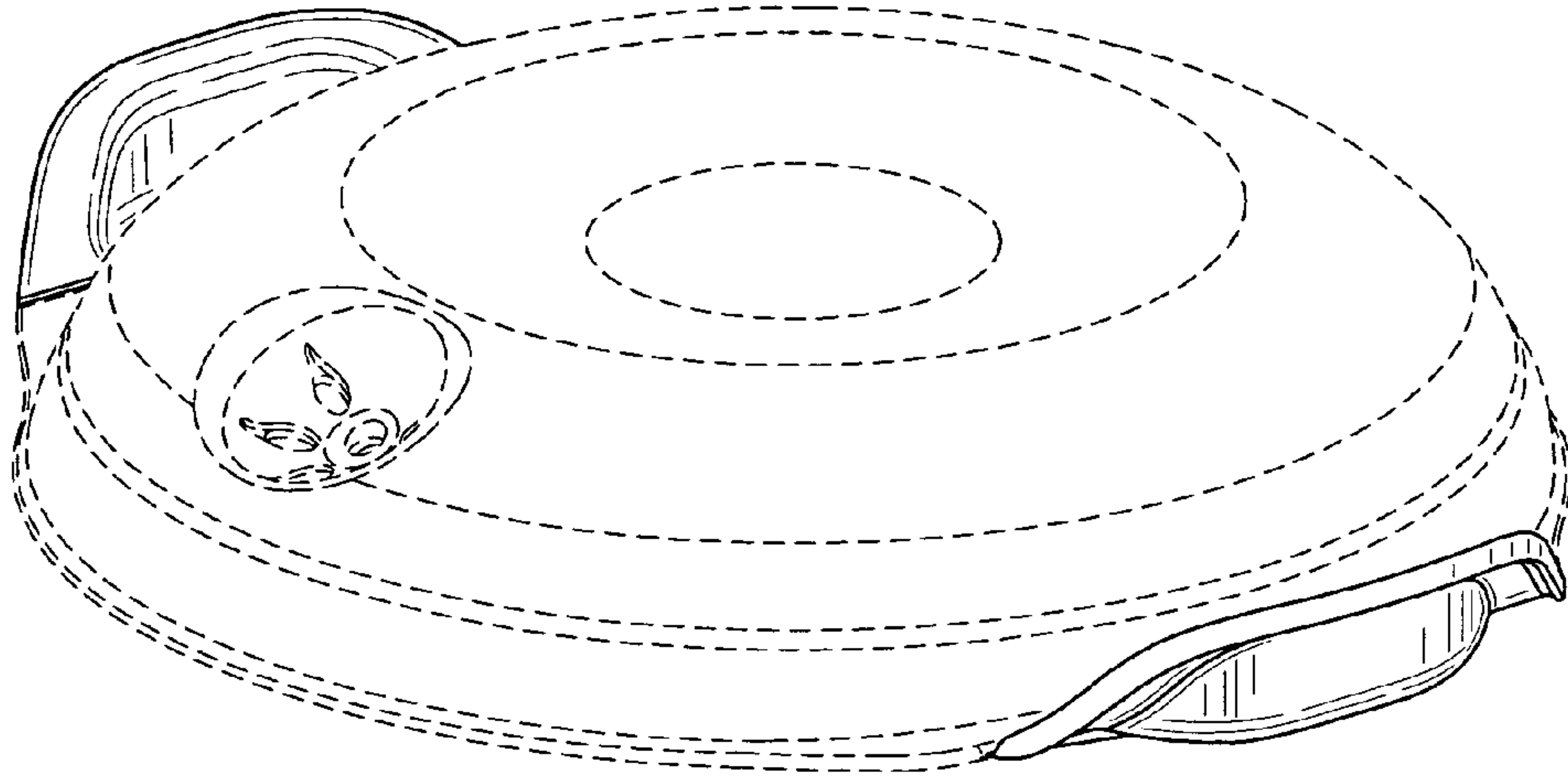

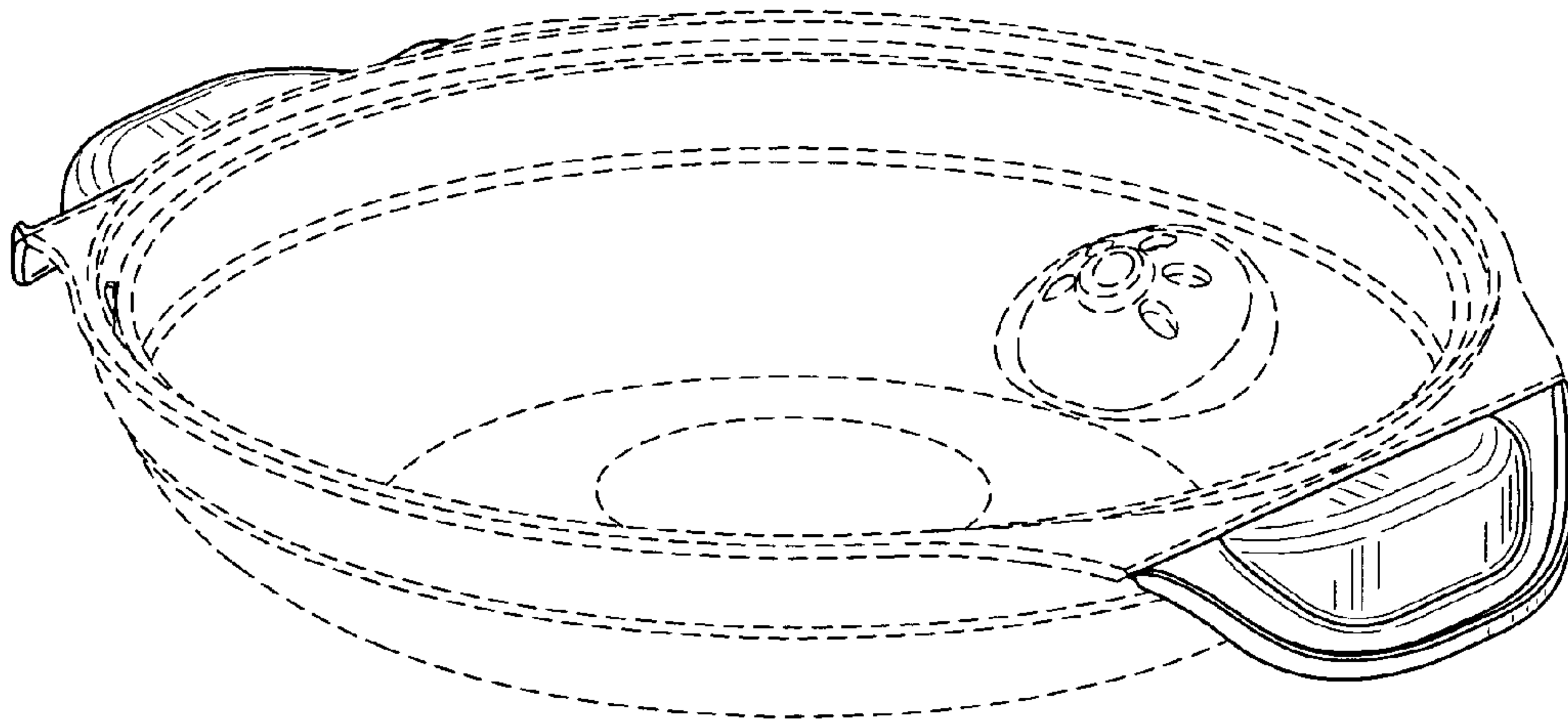

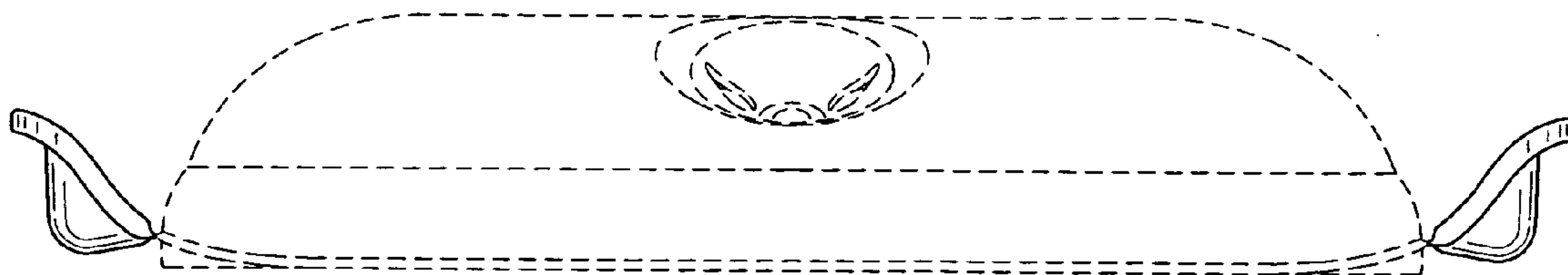

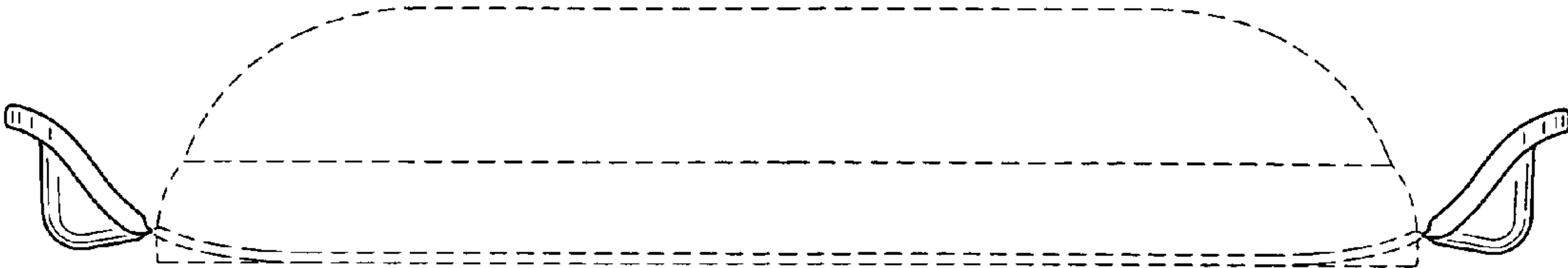

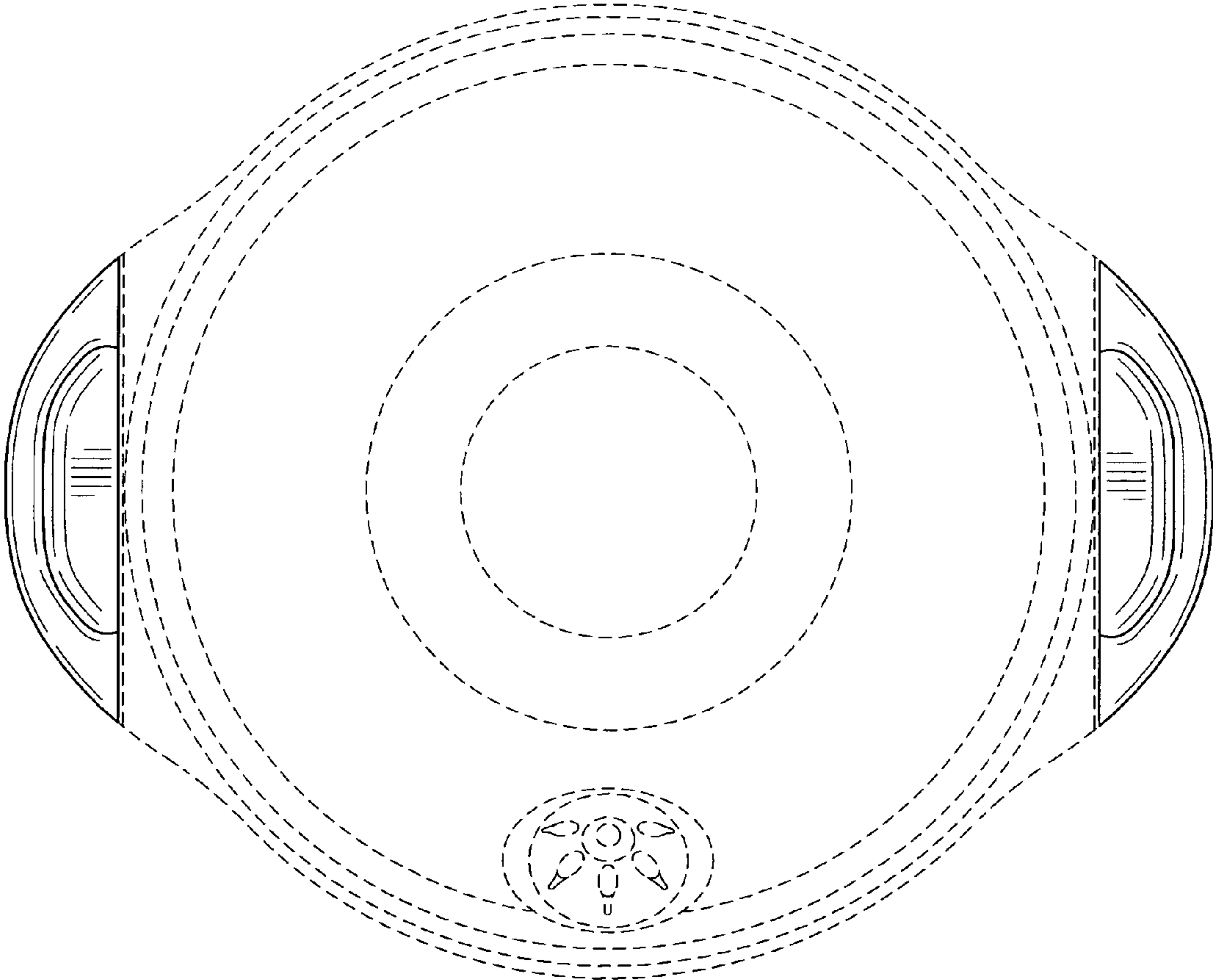

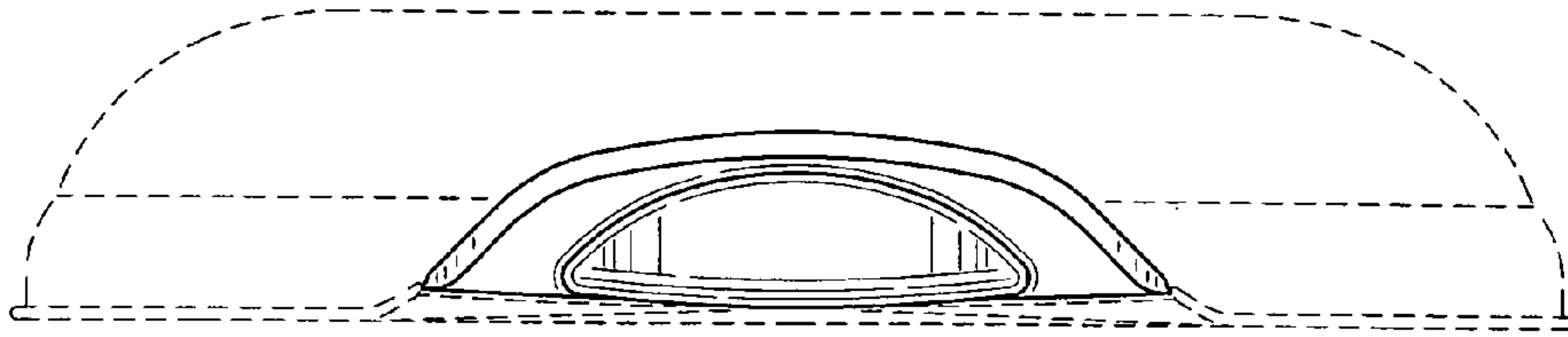

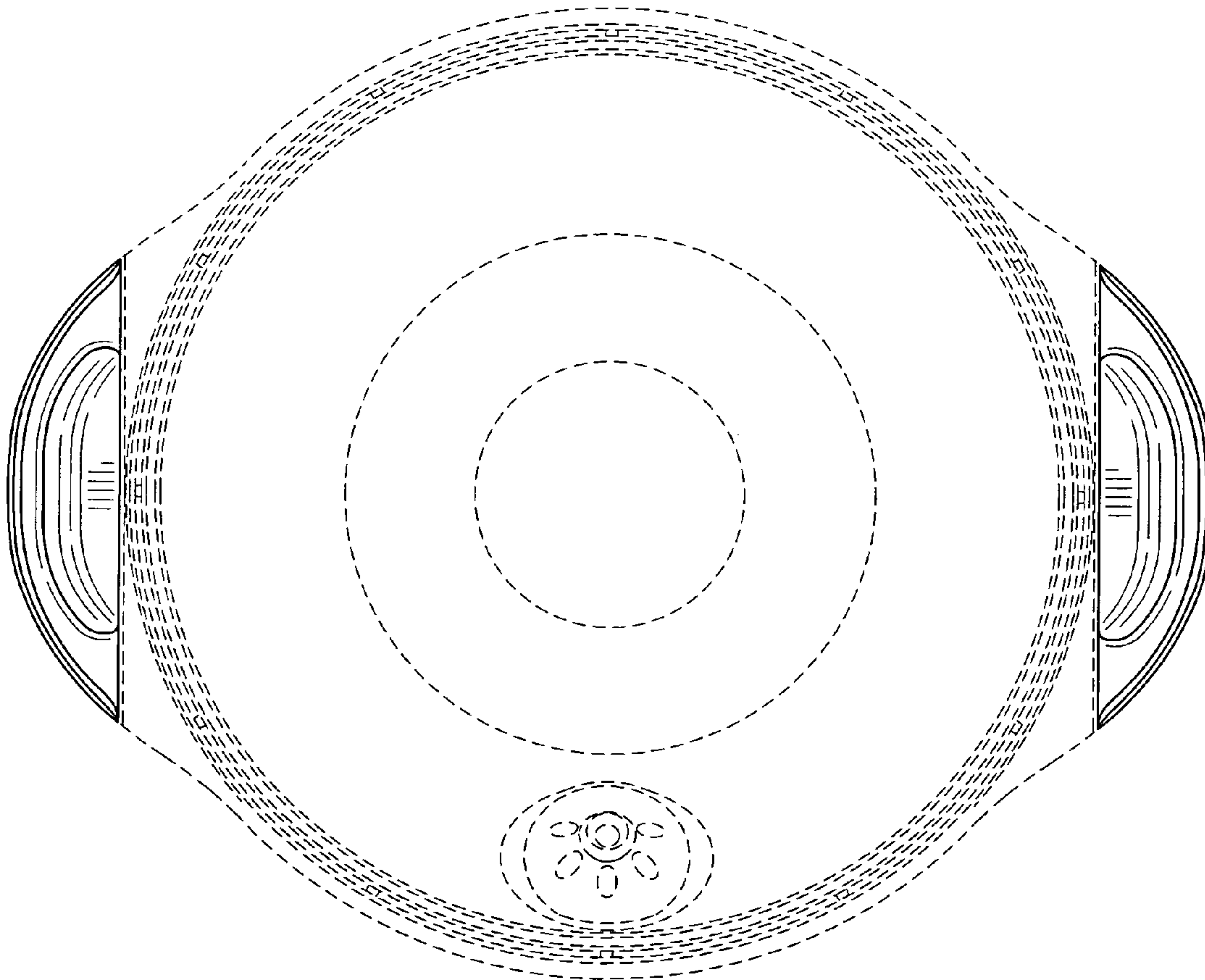
