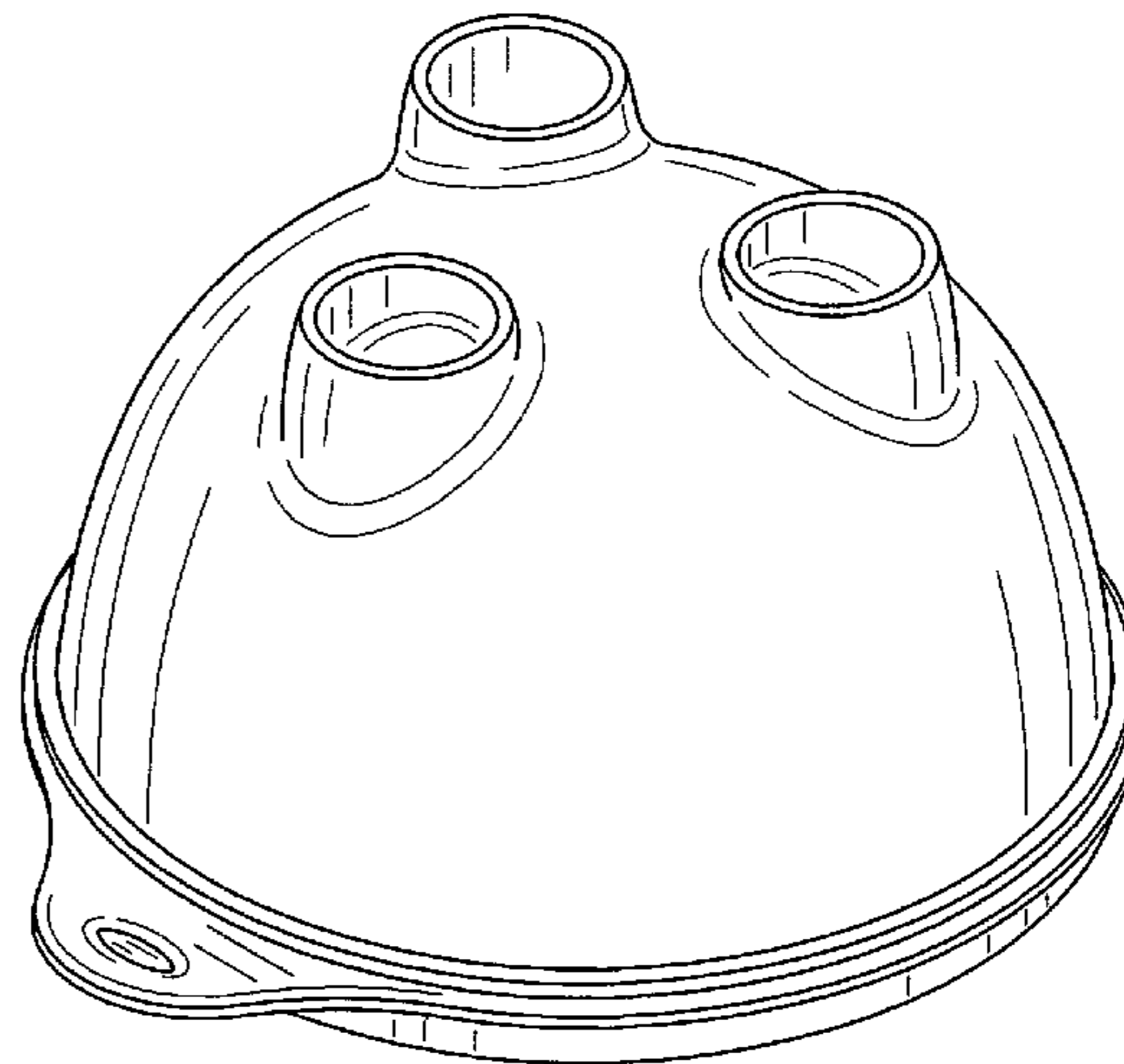
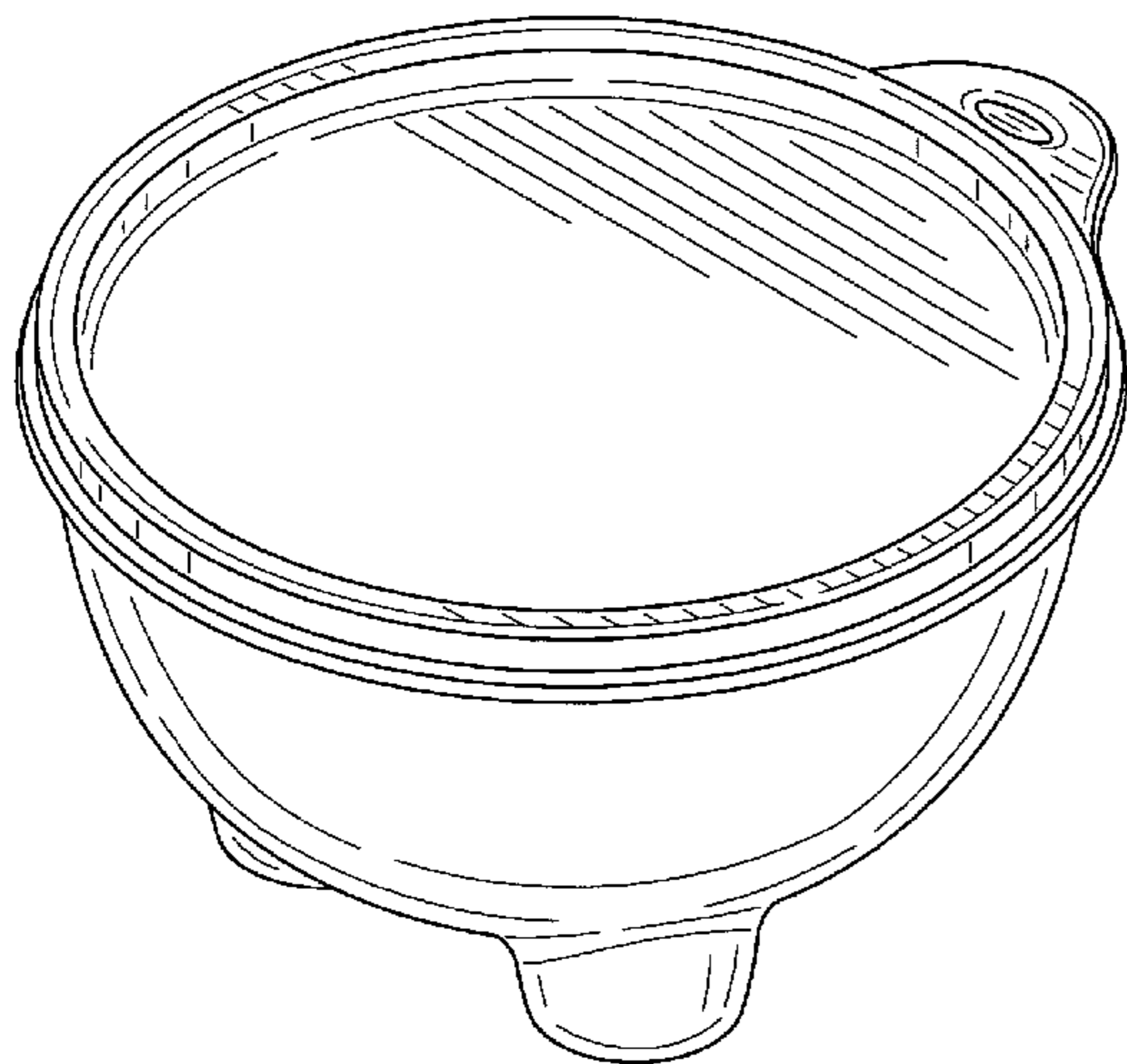
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top, side and front perspective view of a covered container showing my new design;
FIG. 2 is a bottom, side and rear perspective view thereof;
FIG. 3 is a top plan view thereof;
FIG. 4 is a bottom plan view thereof;
FIG. 5 is a front elevation view thereof;
FIG. 6 is a rear elevation view thereof; and,
FIG. 7 is right side elevation view, the left side elevation being a mirror image thereof.

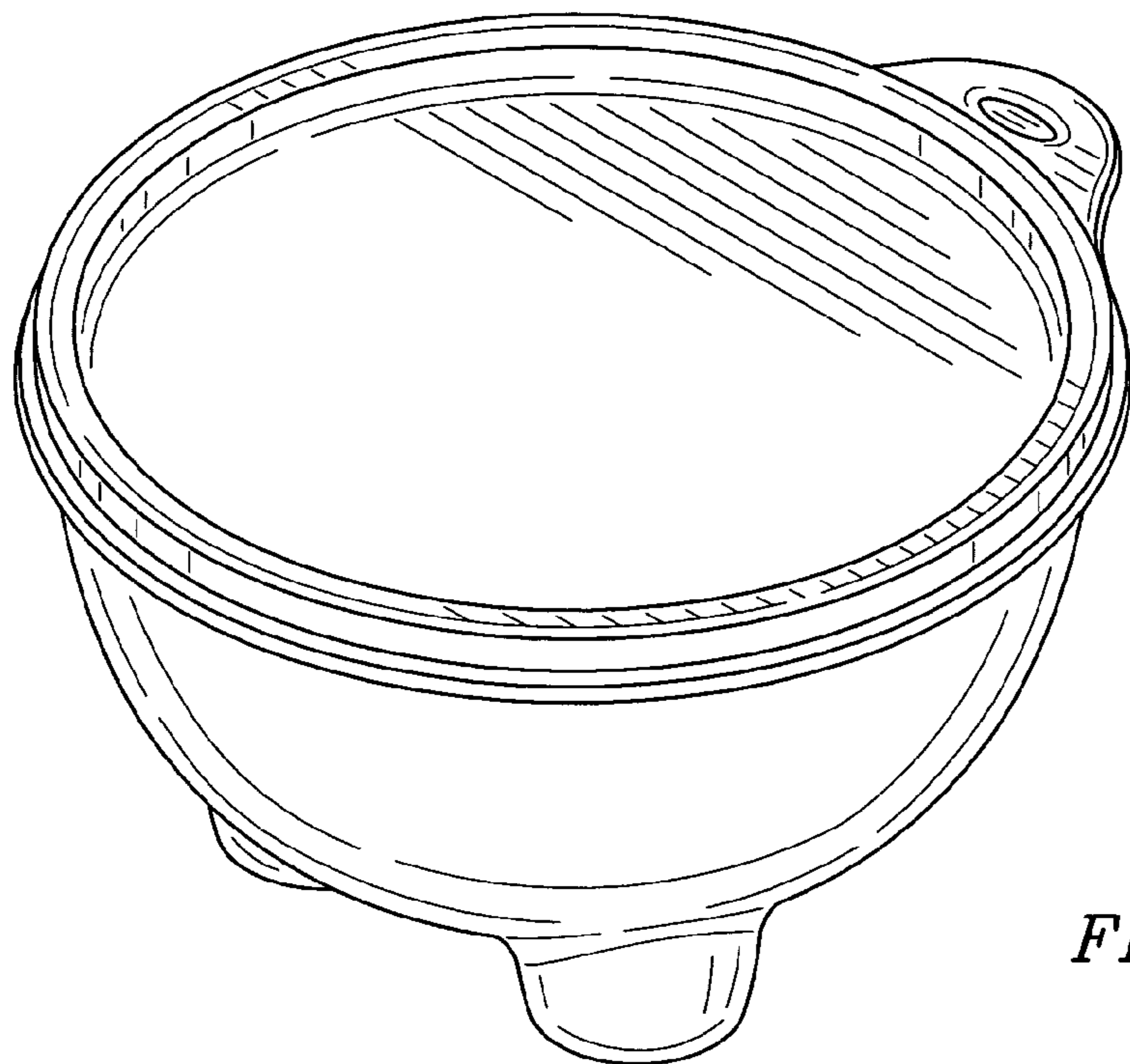

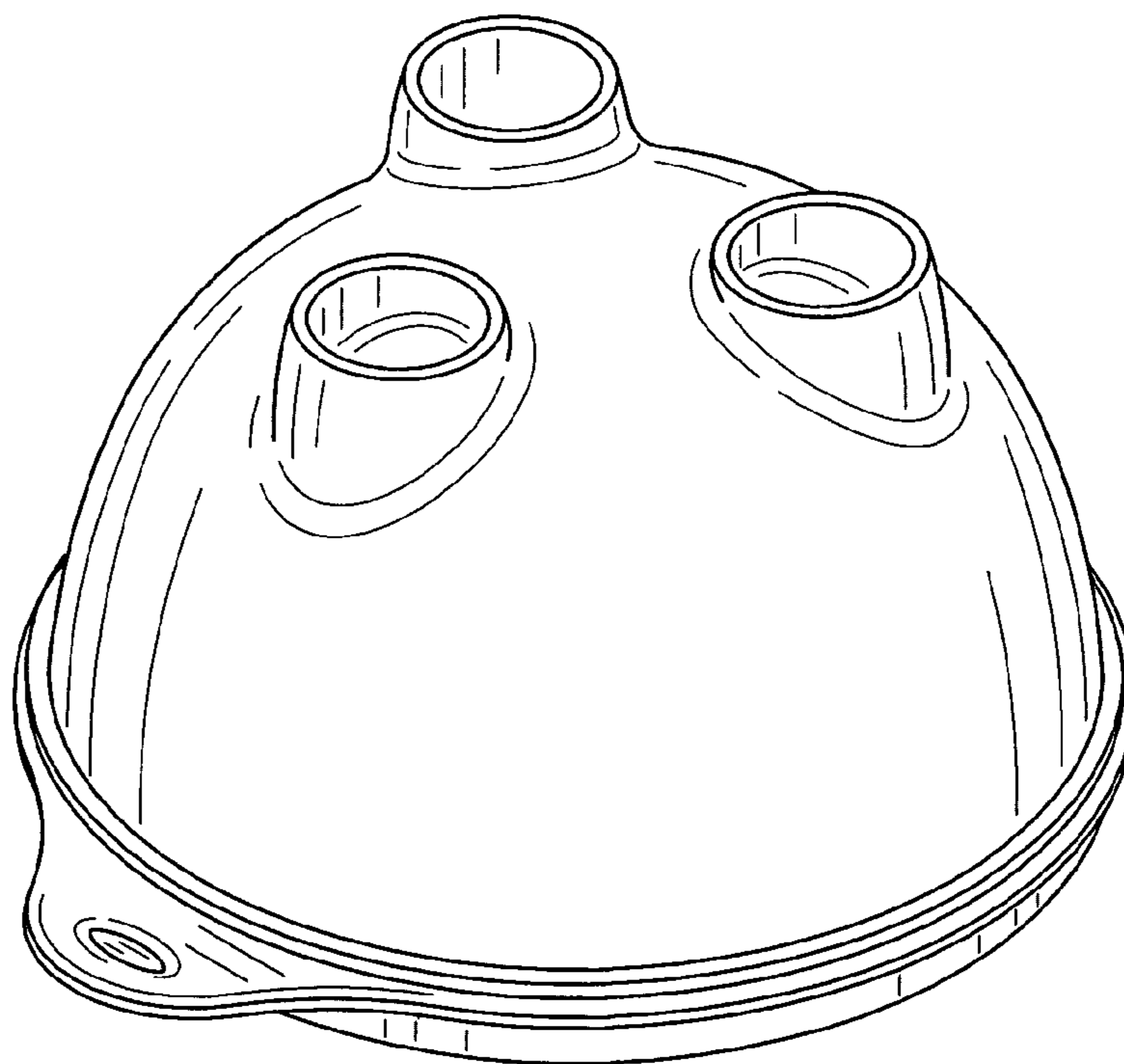

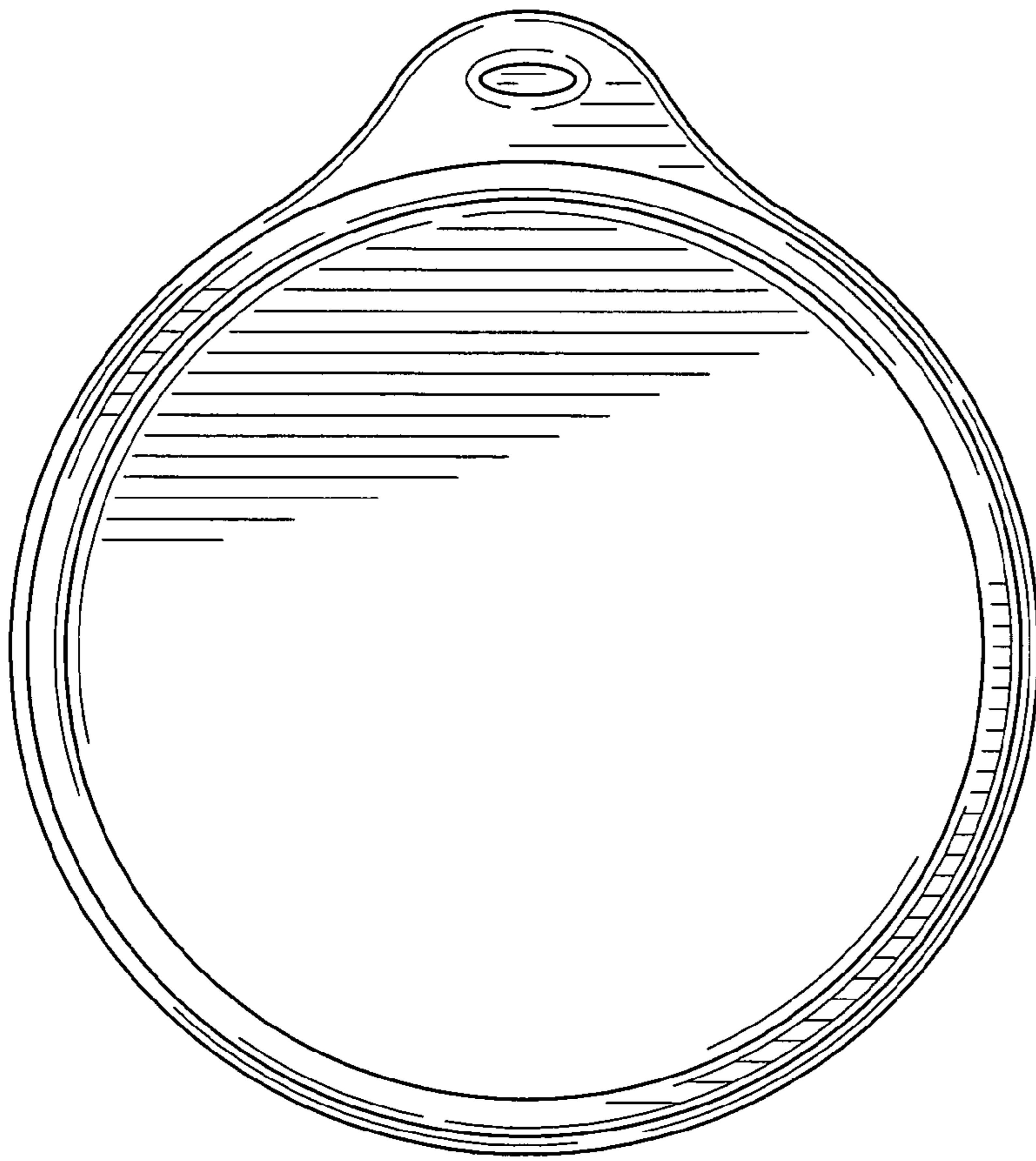

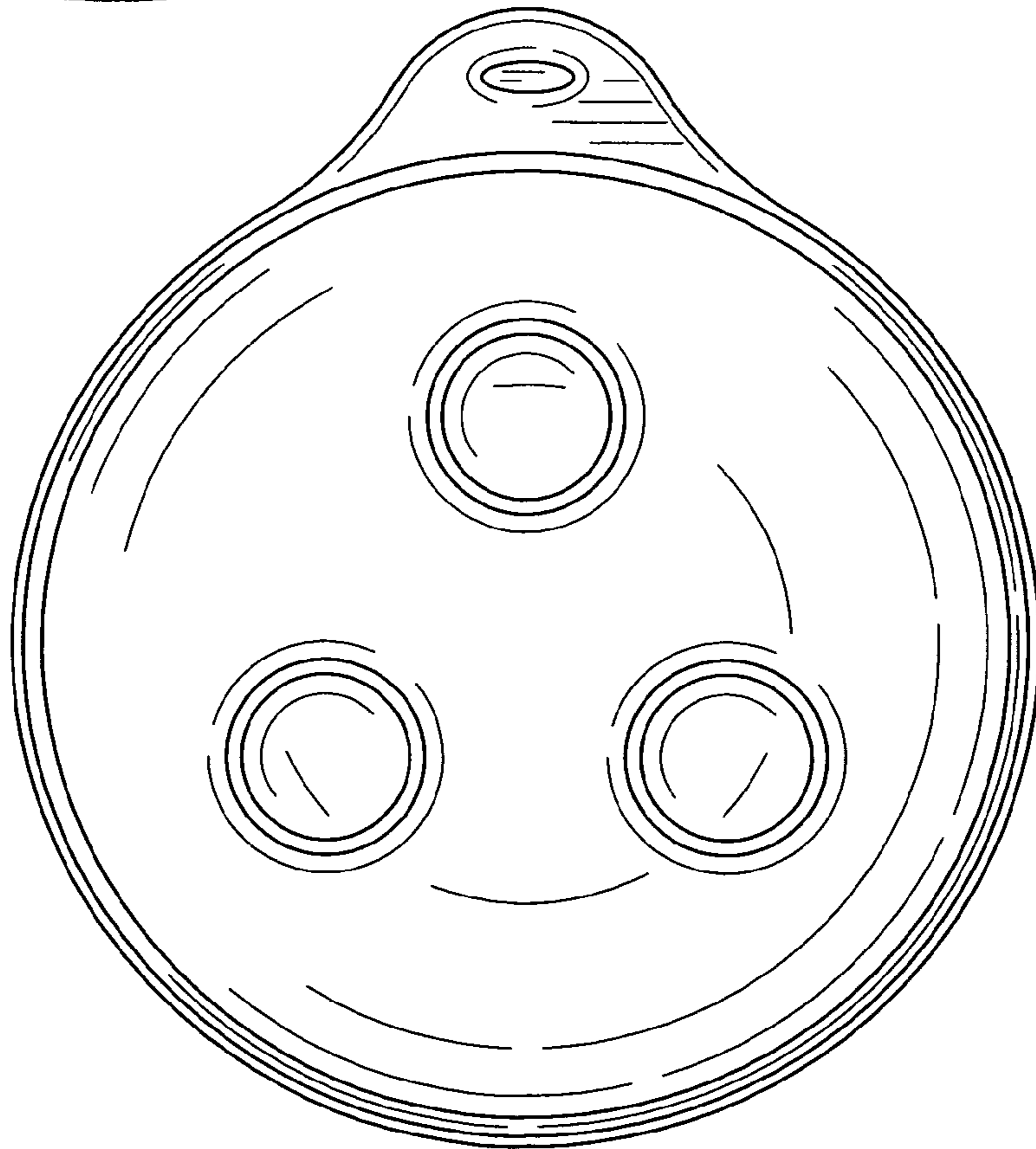

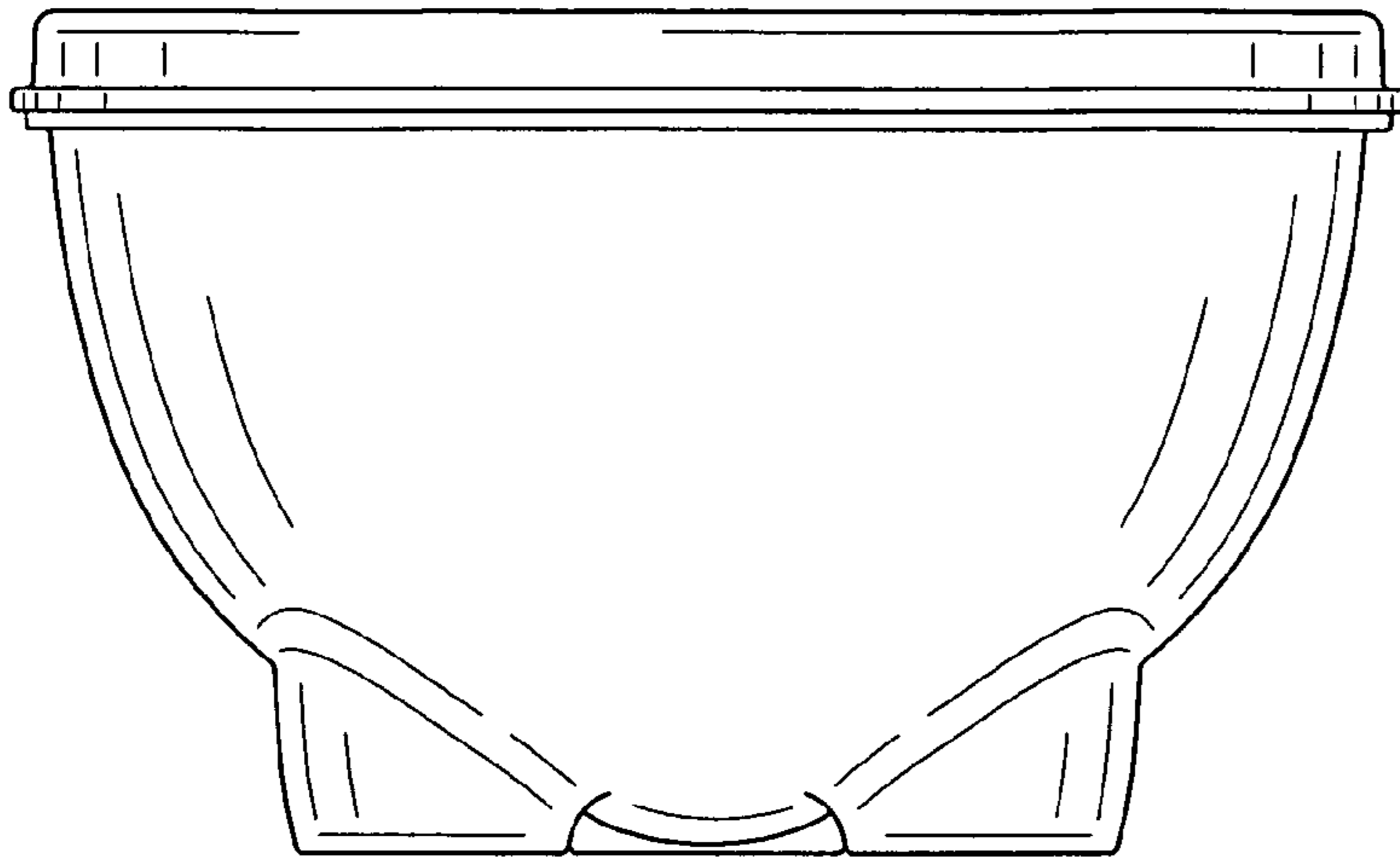

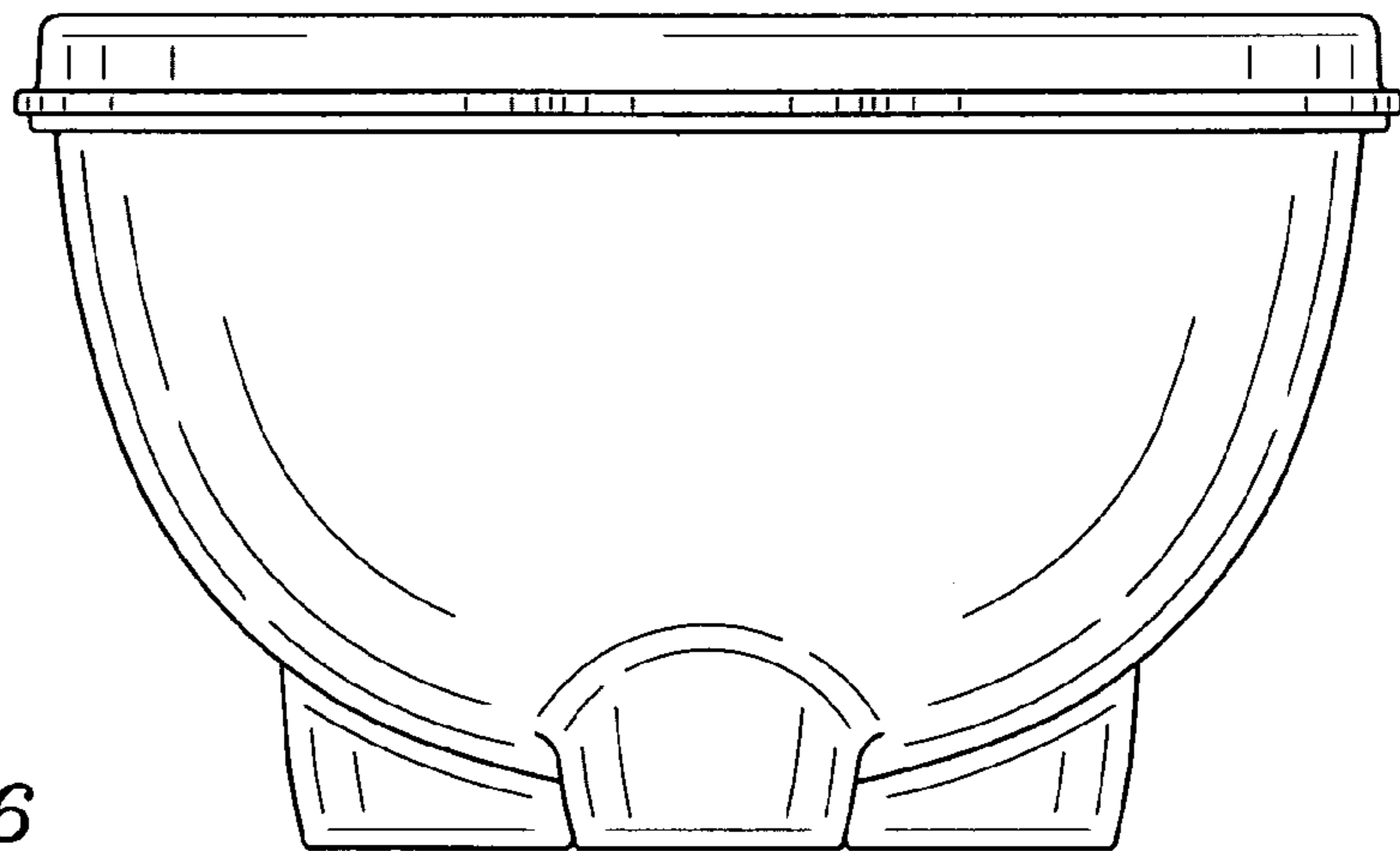

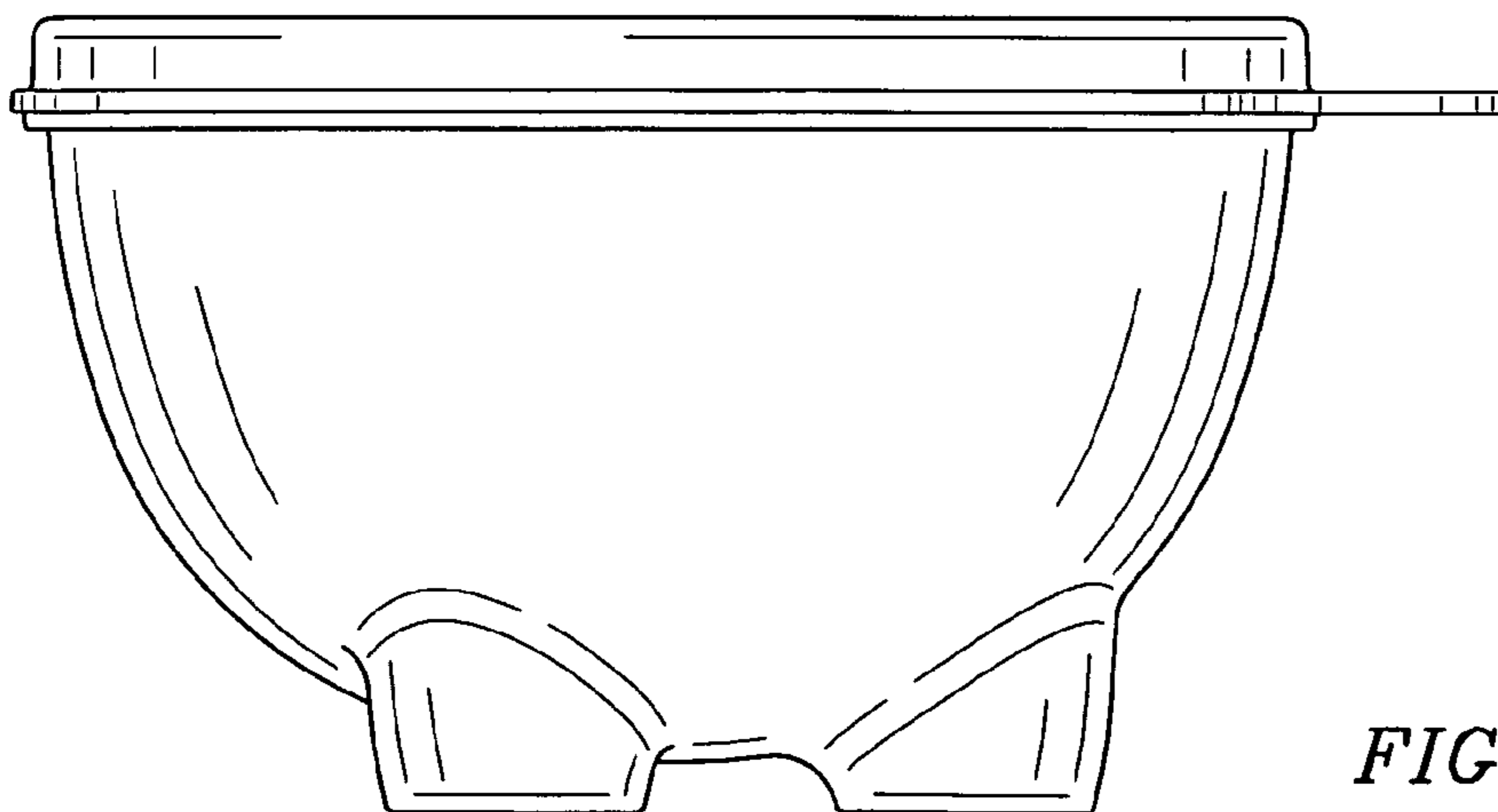
