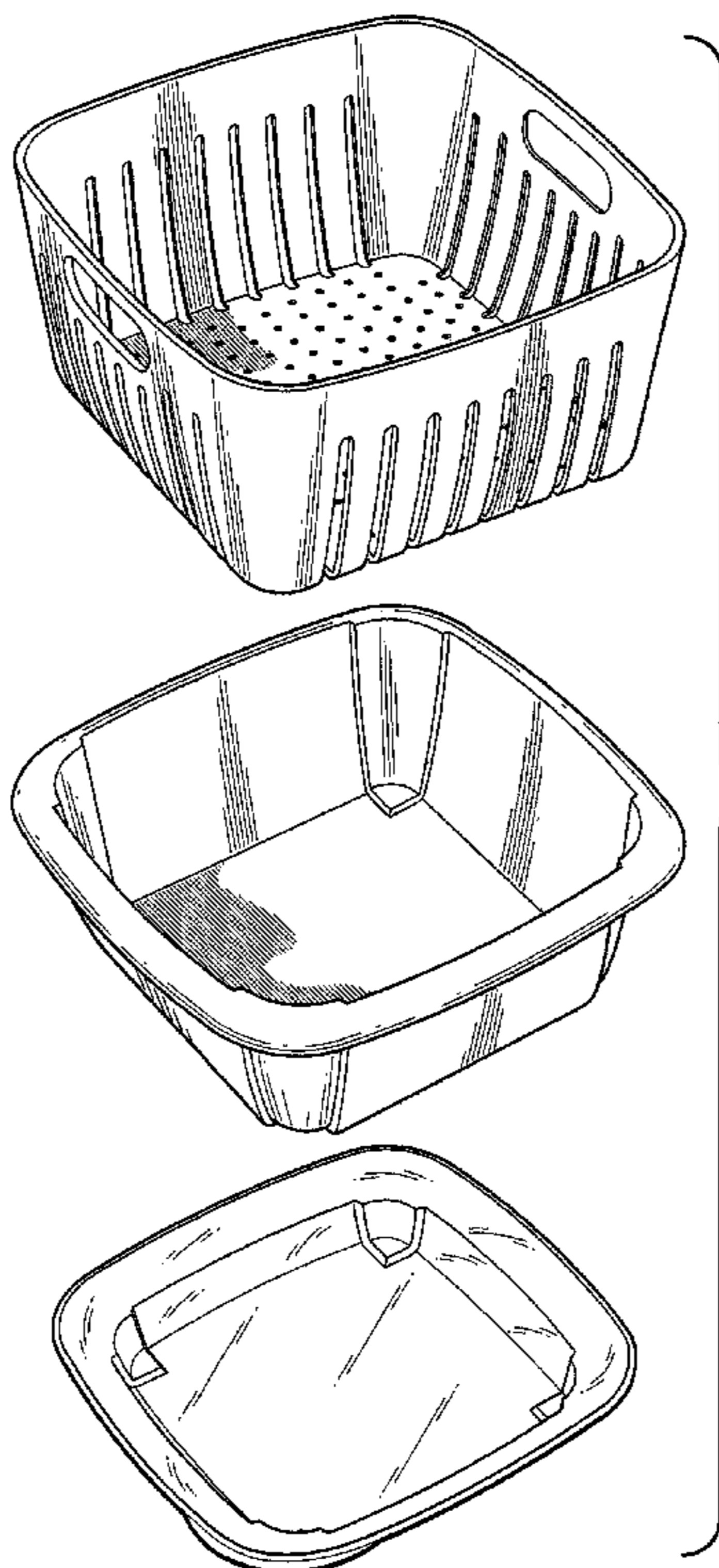
FIG. 15 is a top perspective view of the bowl in an assembled form.

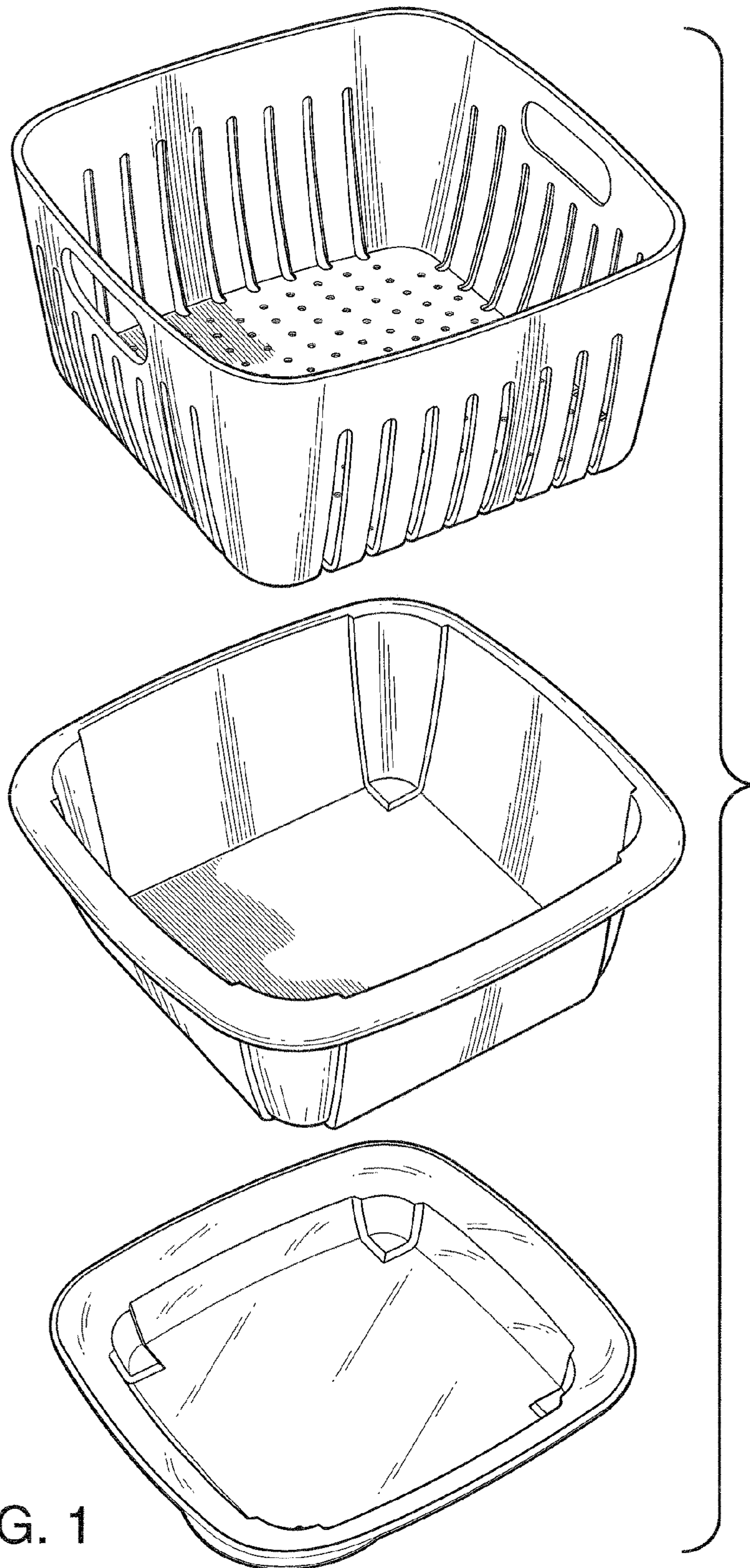

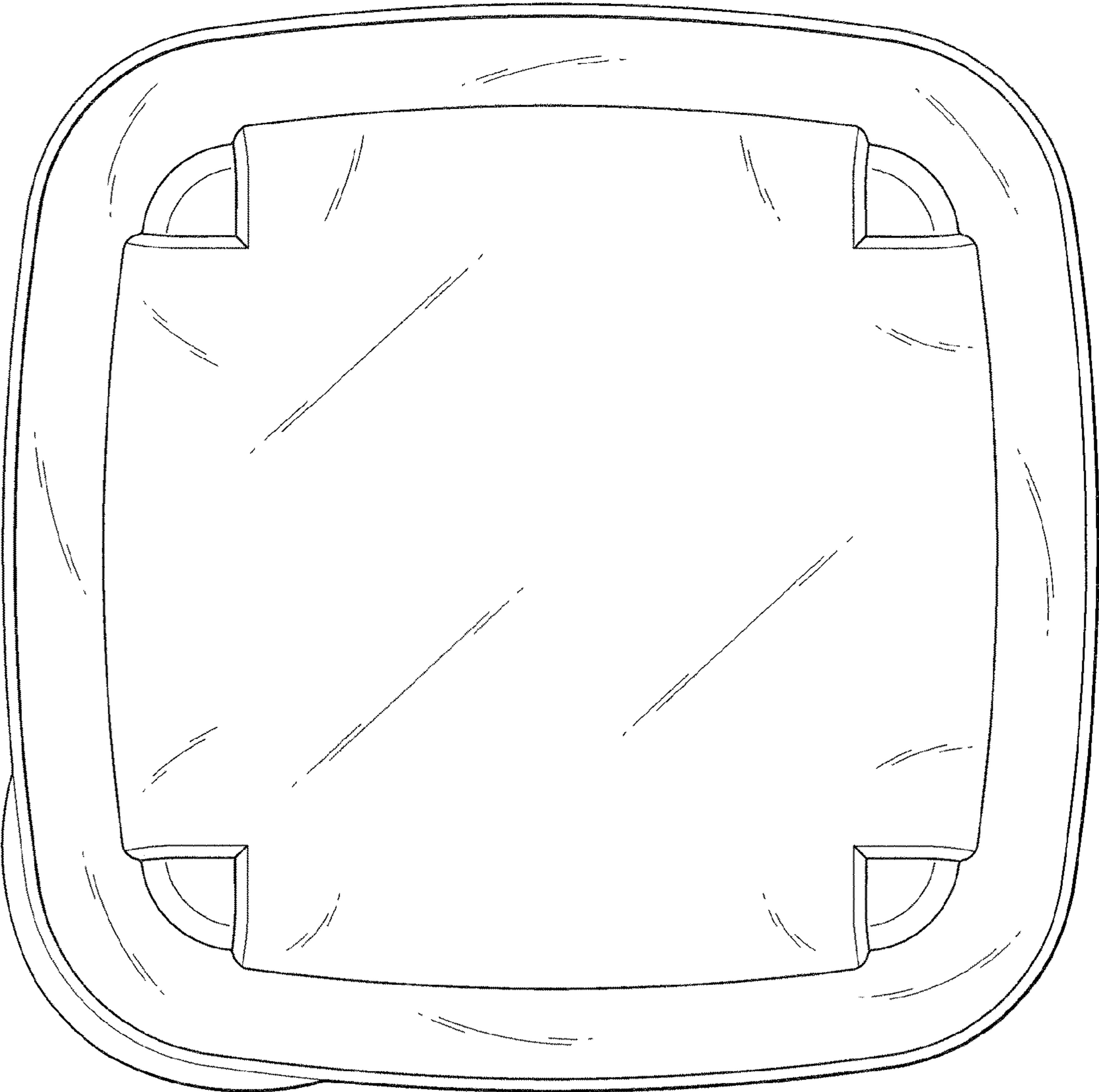

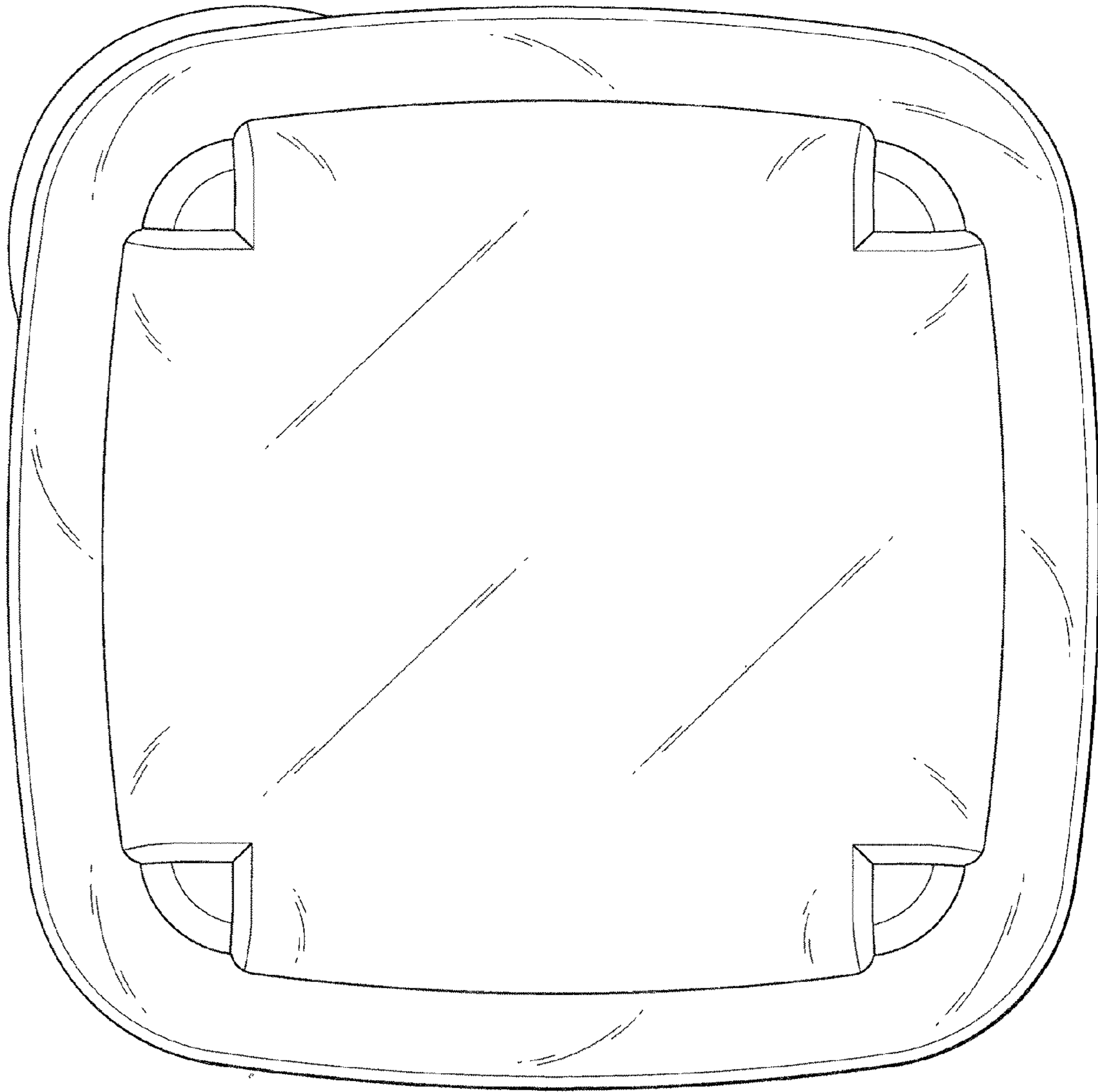

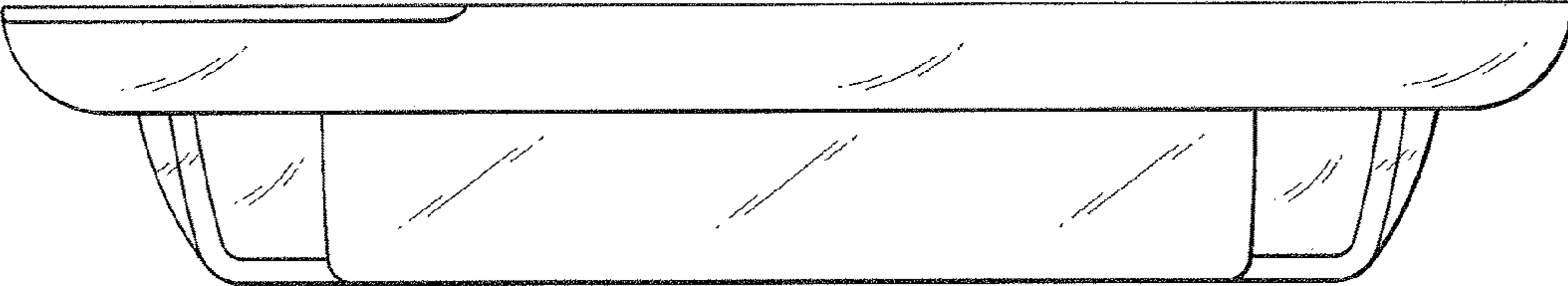

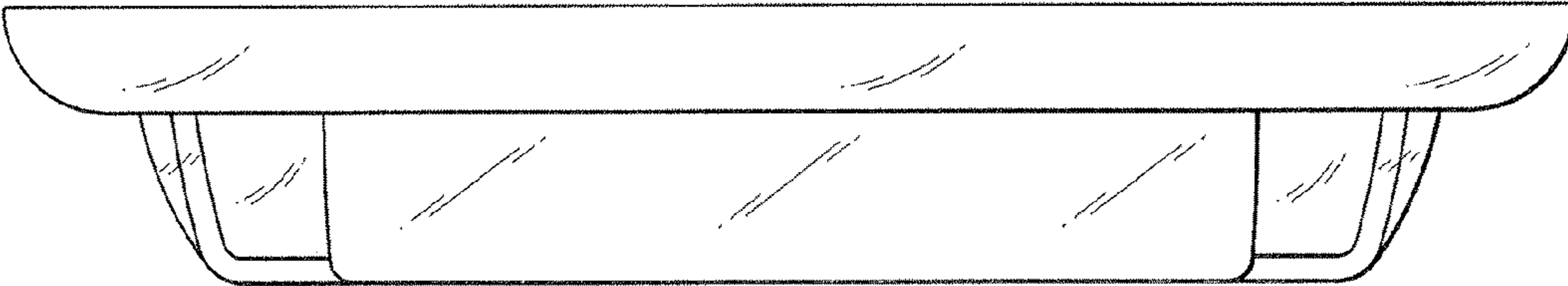

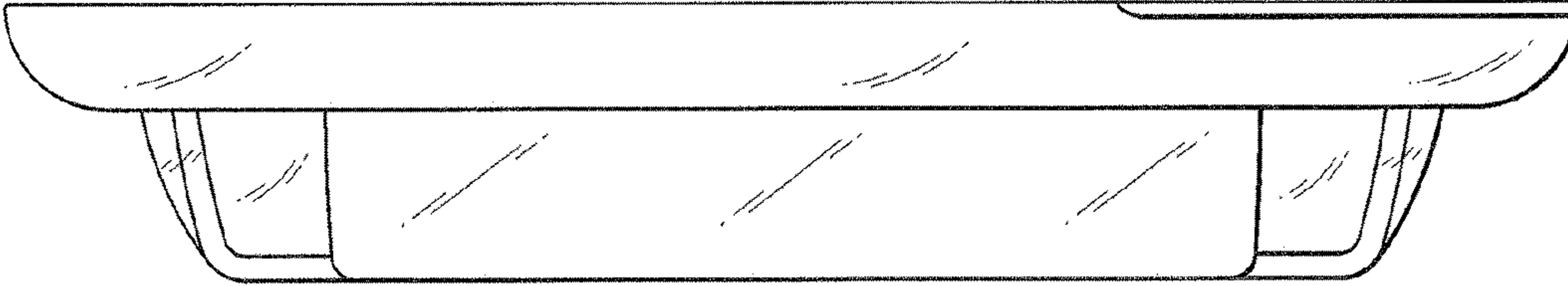

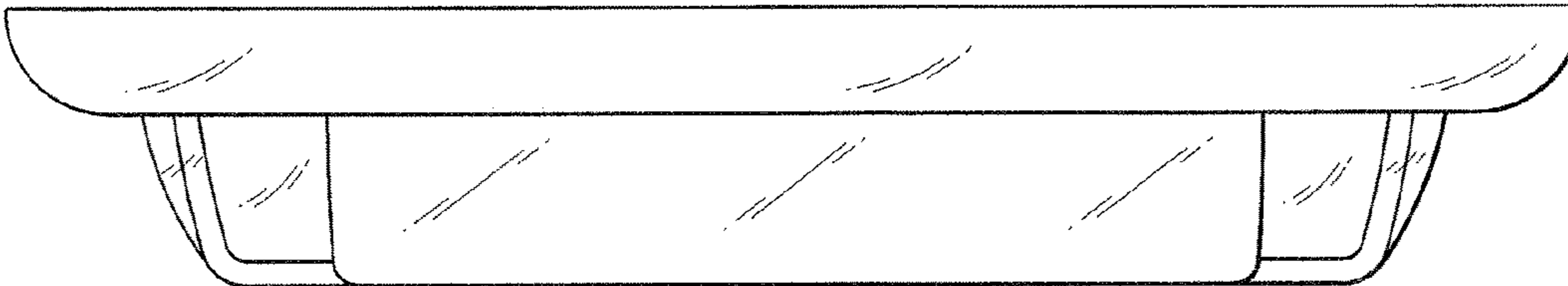

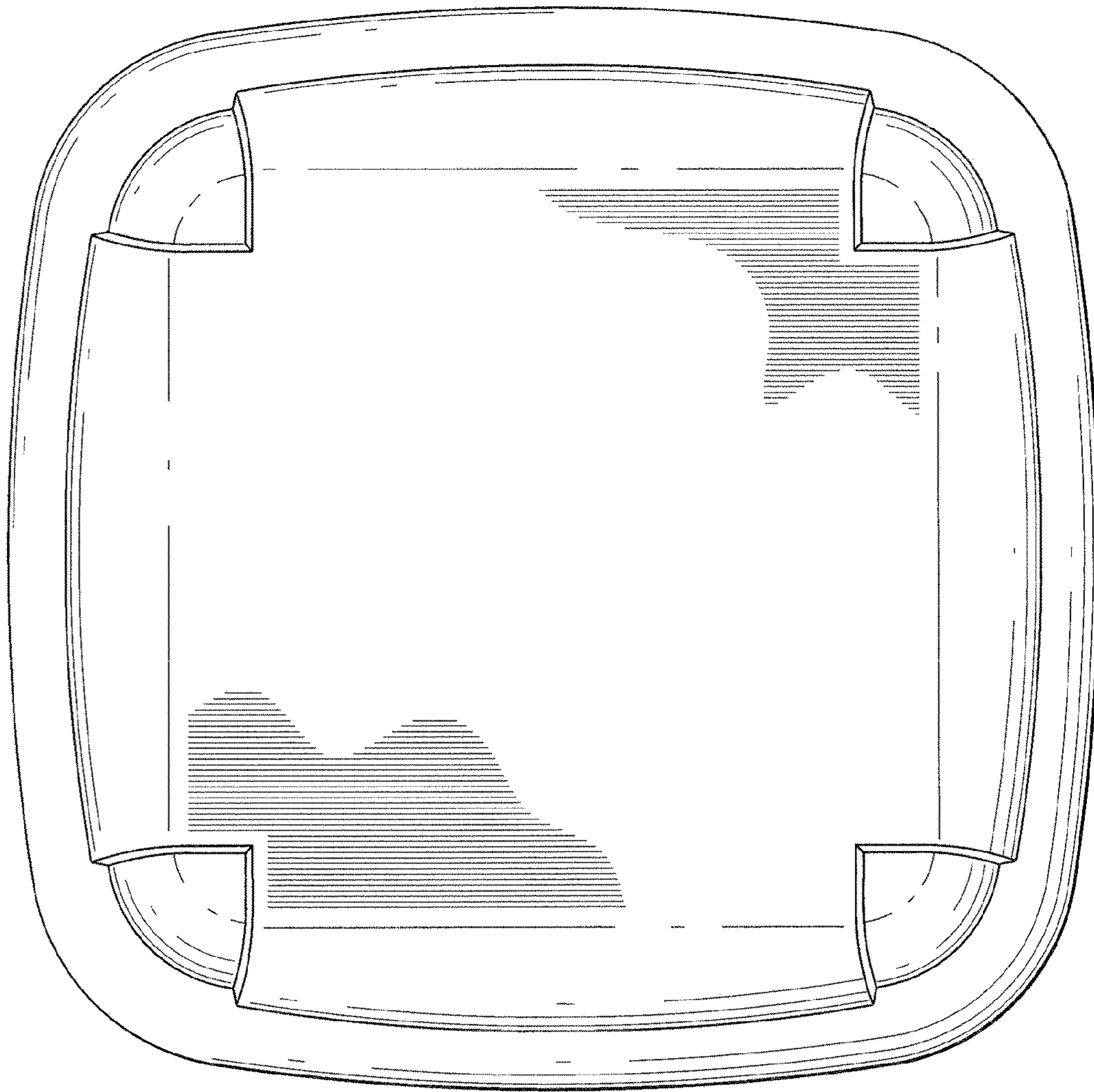

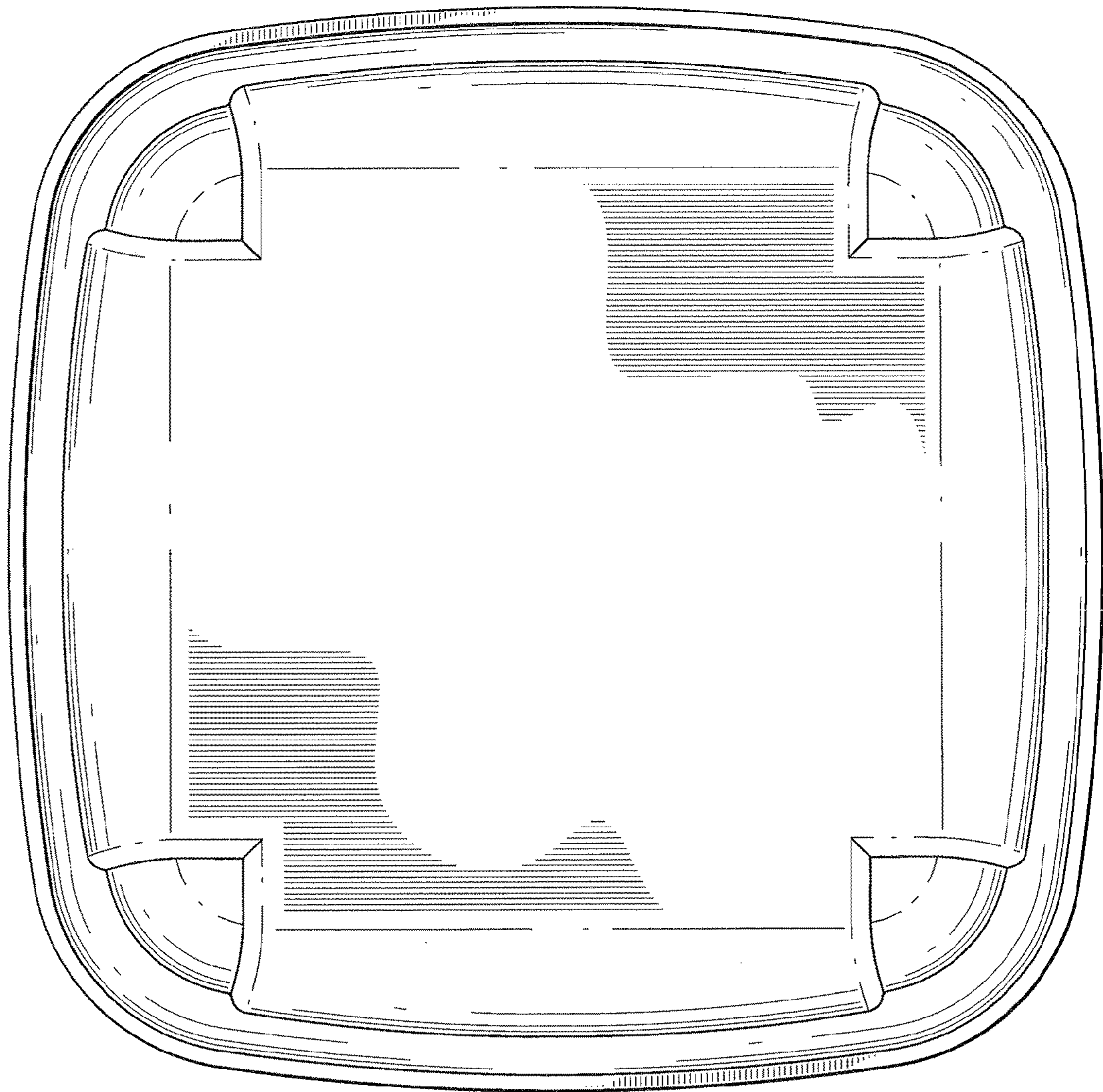

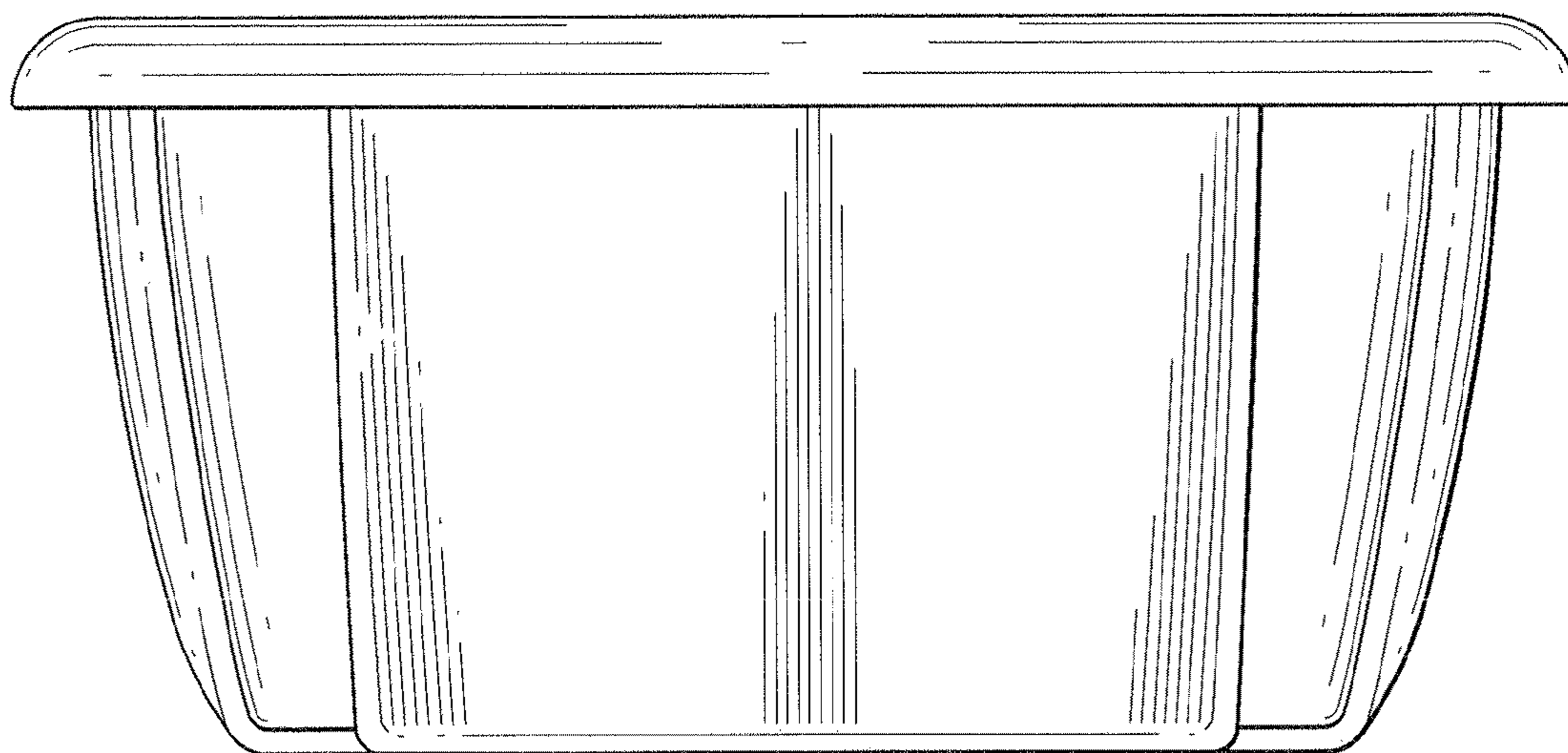

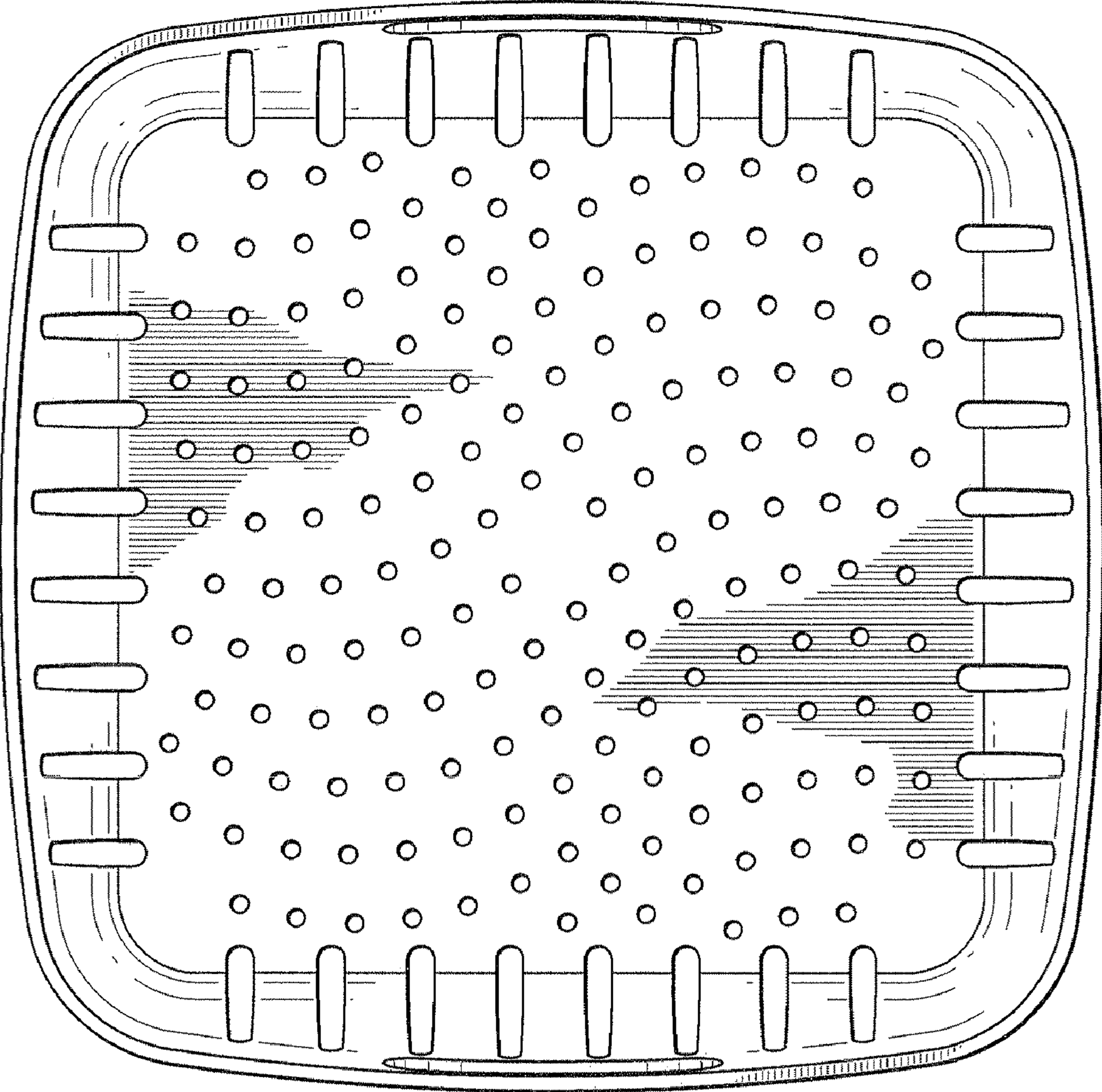

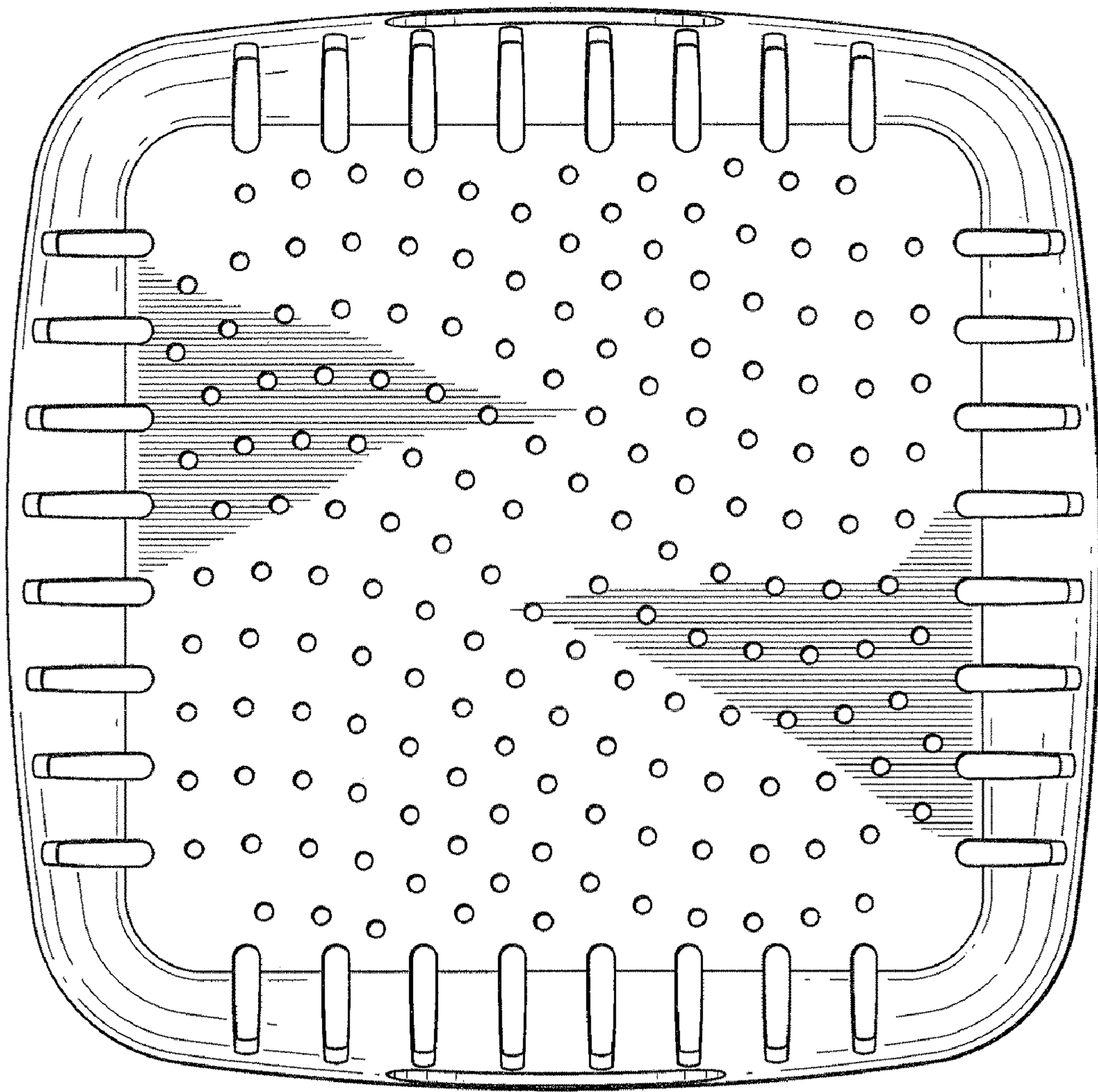

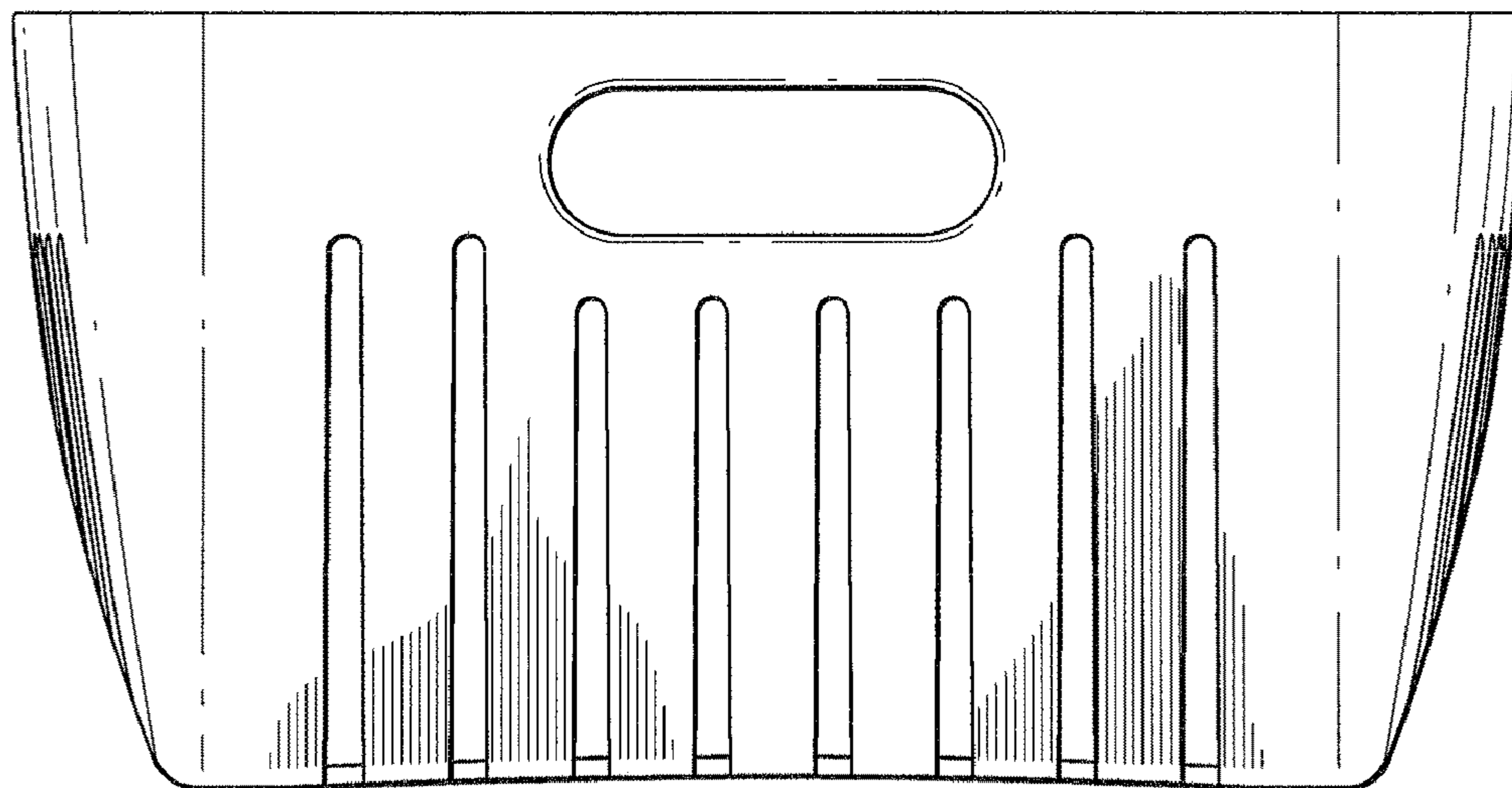

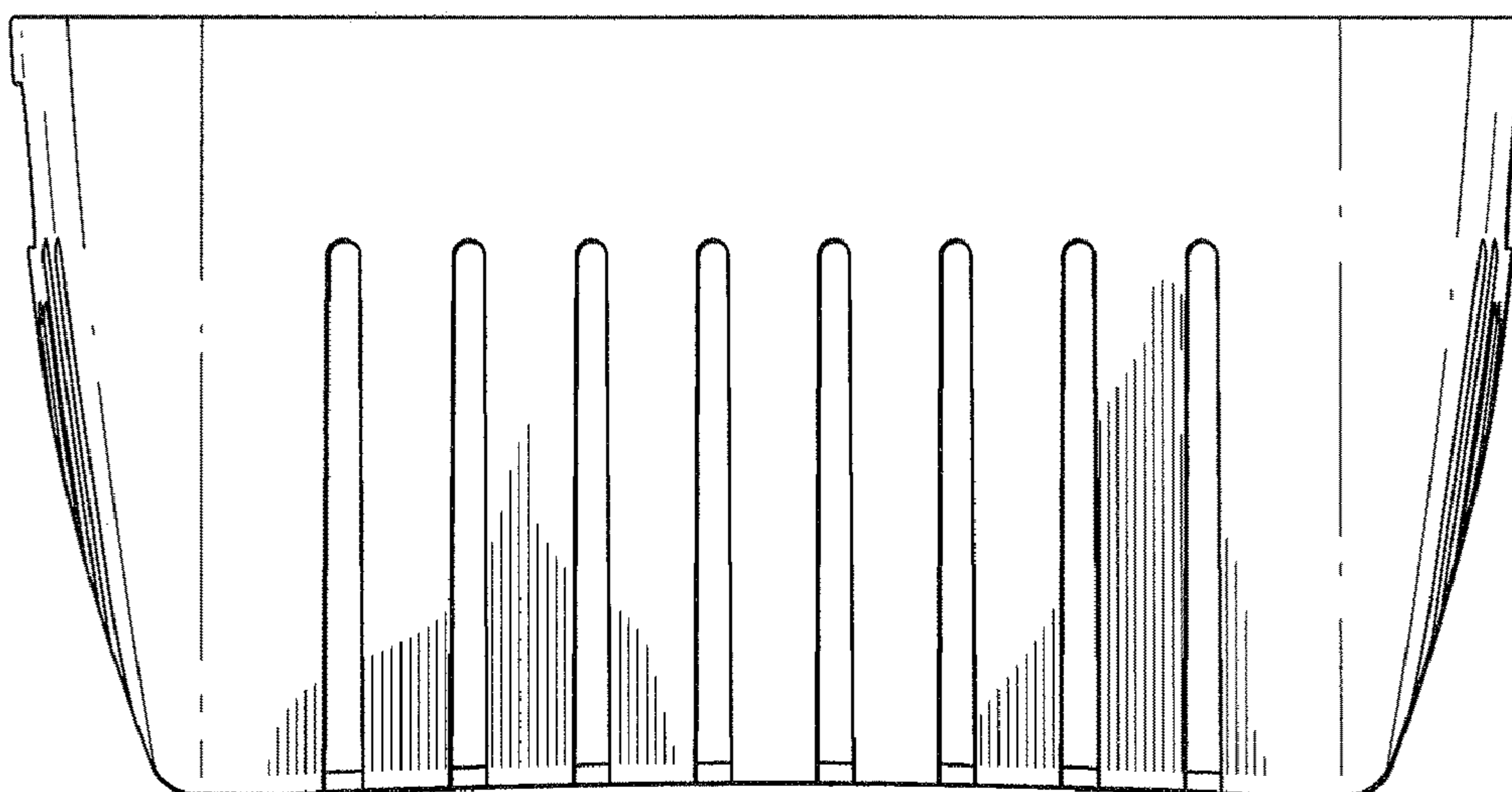

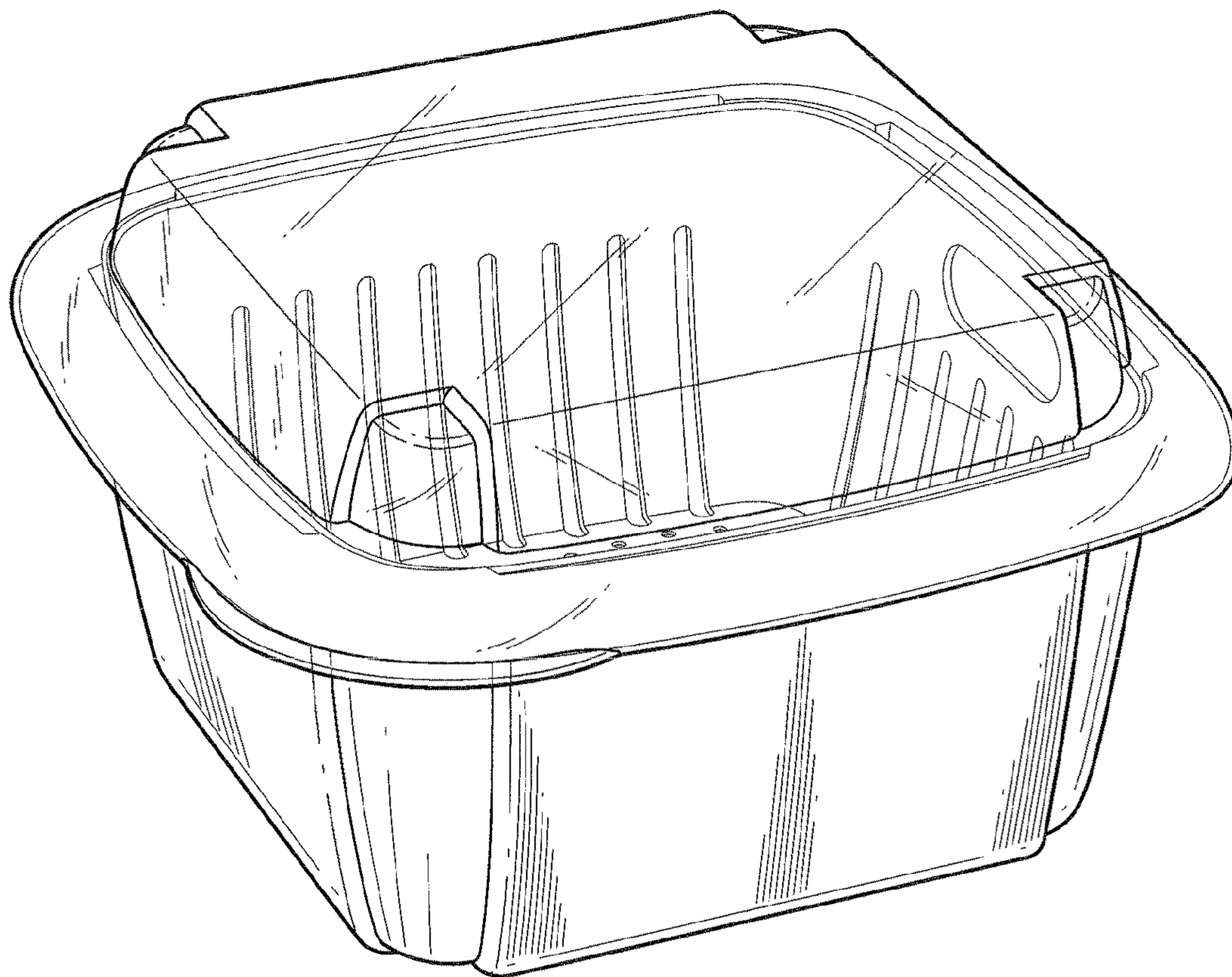
