The ornamental design for an end panel for cans, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an end panel for cans showing our new design;
FIG. 2 is another perspective view thereof;
FIG. 3 is a front view thereof;
FIG. 4 is a plan view thereof;
FIG. 5 is a bottom view thereof;
FIG. 6 is a right side view thereof; a left side view being identical to the right side view; and,
FIG. 7 is an enlarged cross-sectional view thereof taken along line 7-7 in FIG. 4.

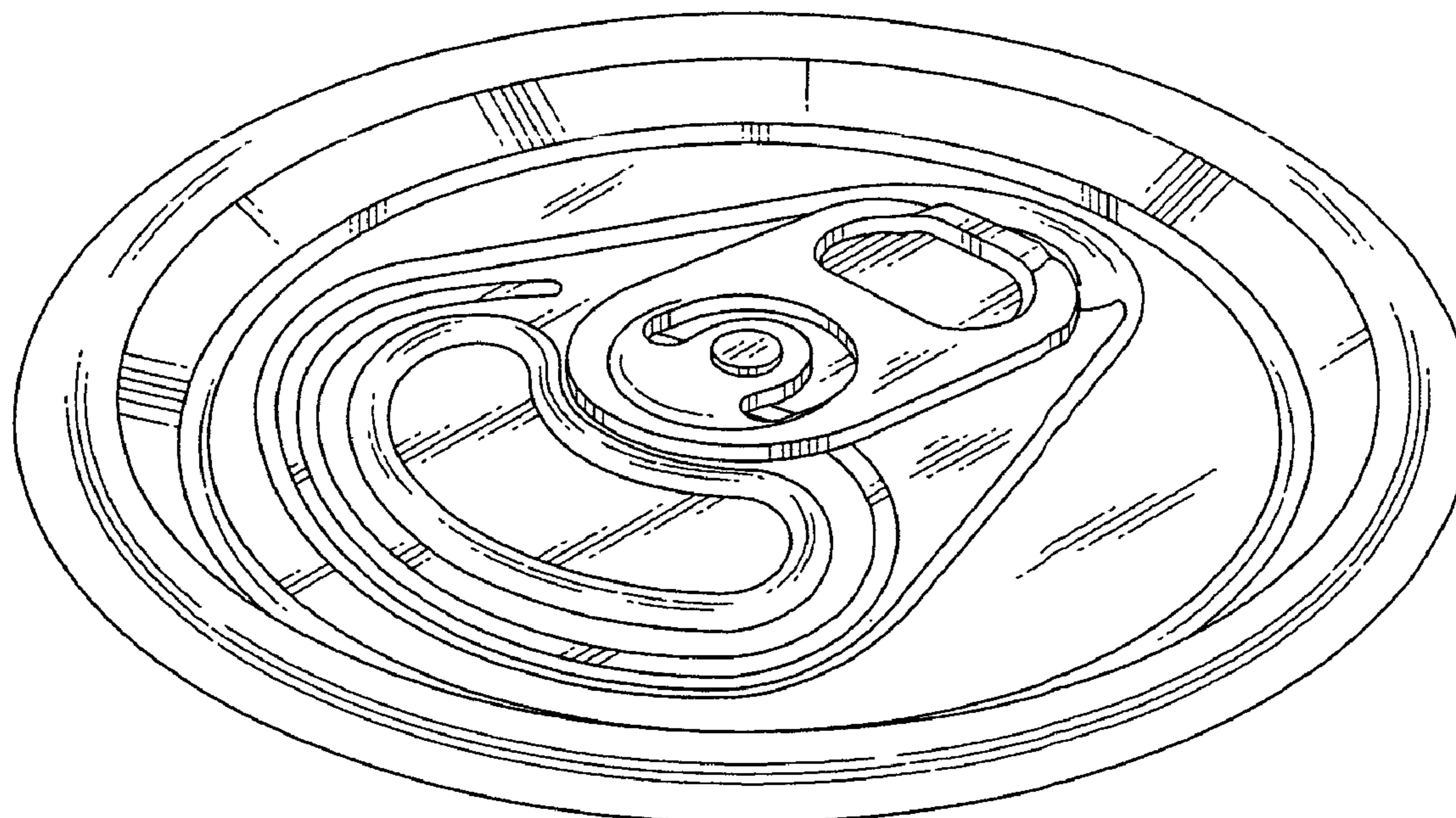

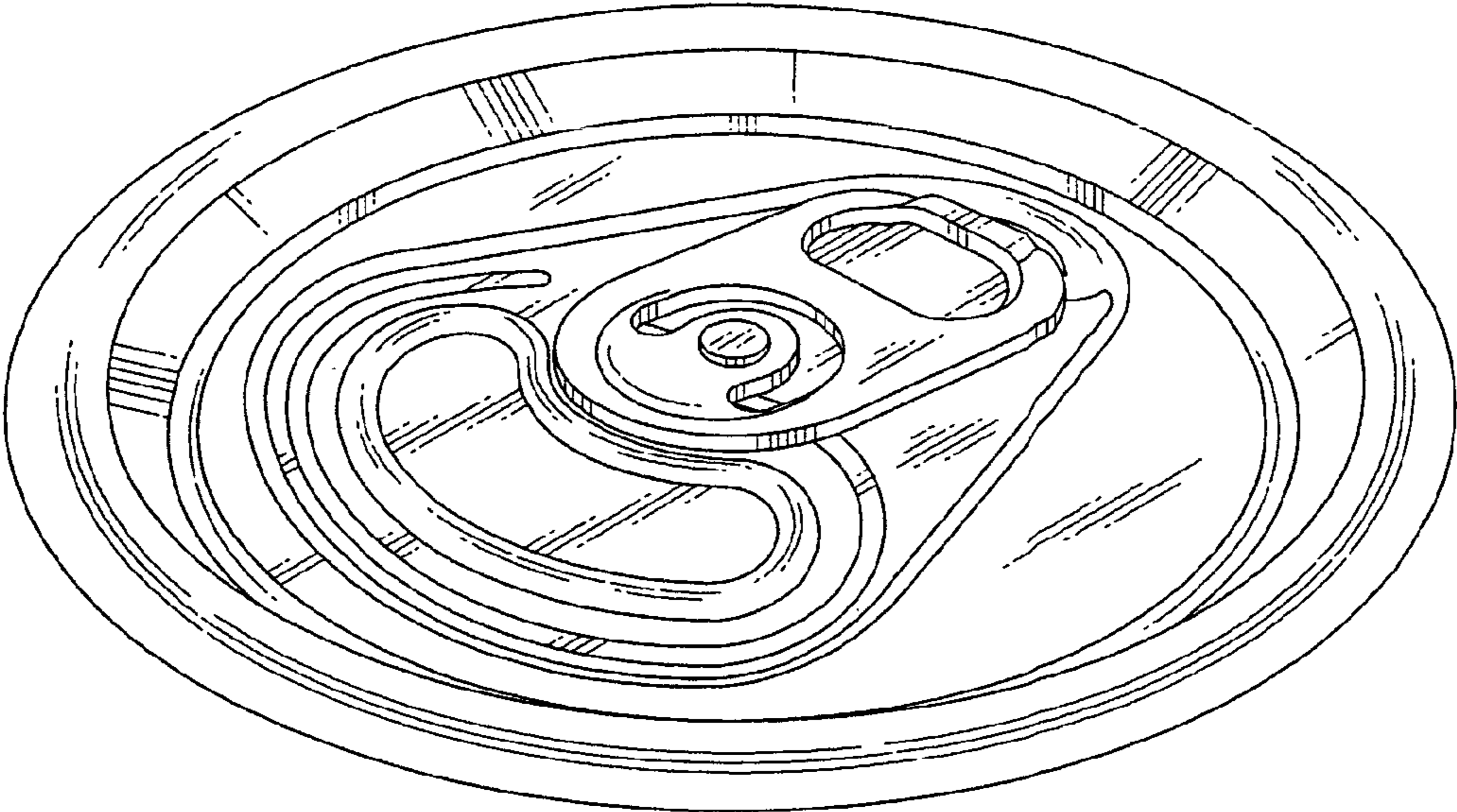

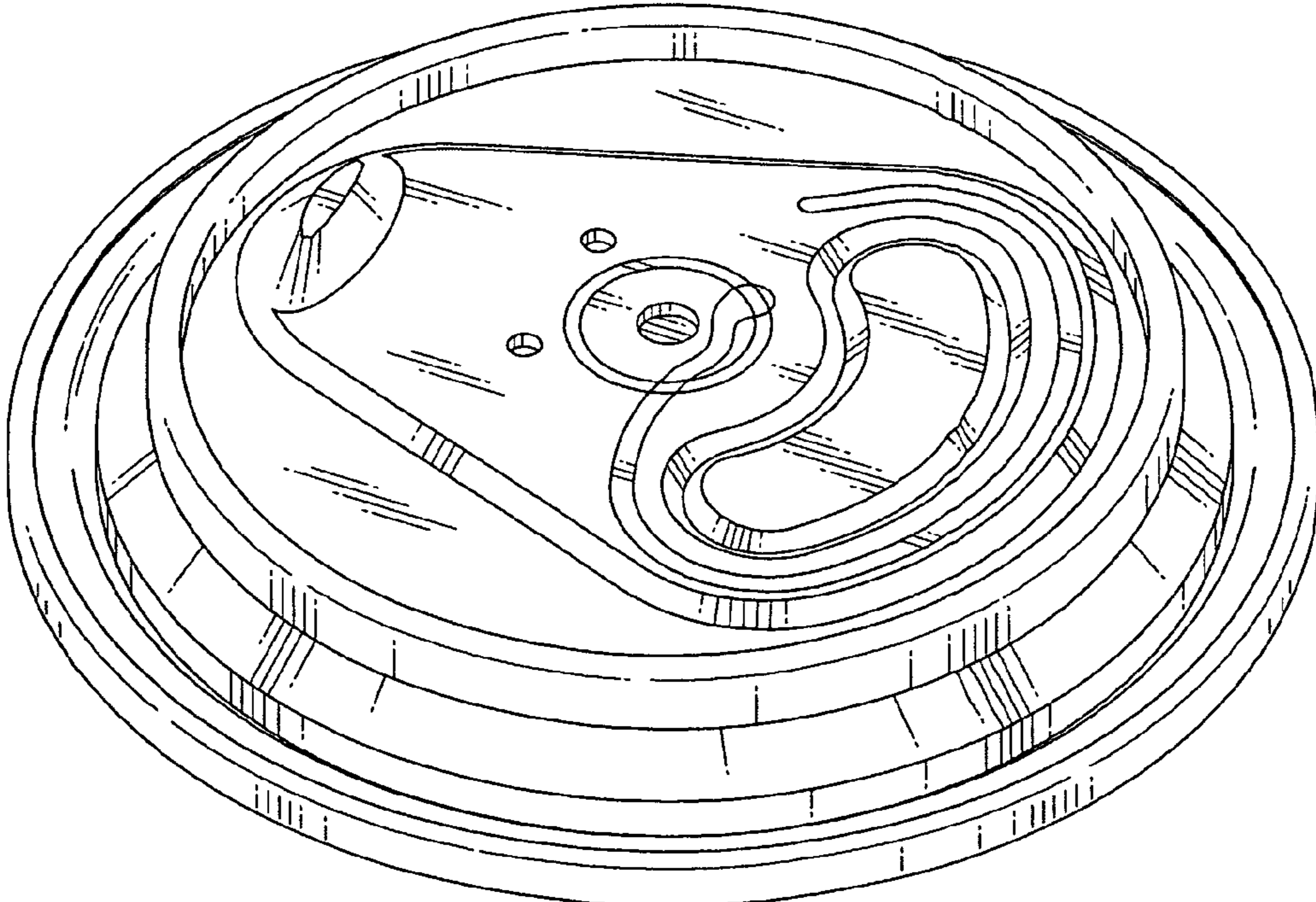

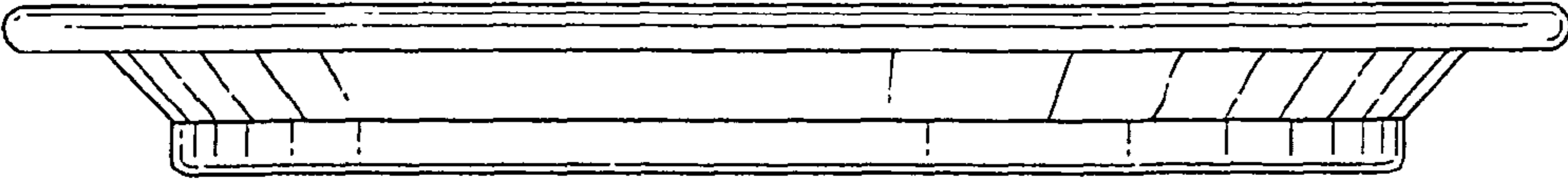
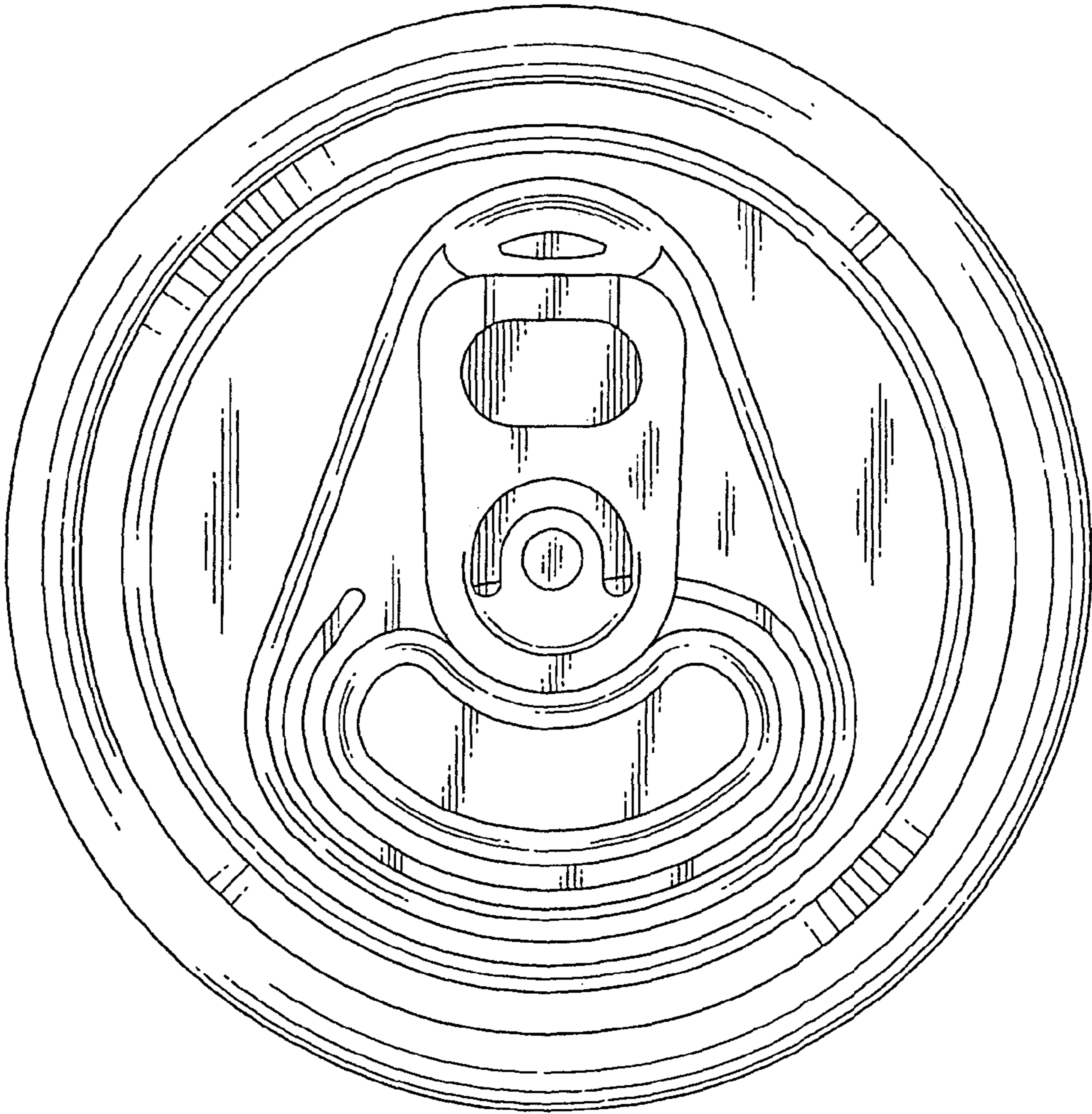

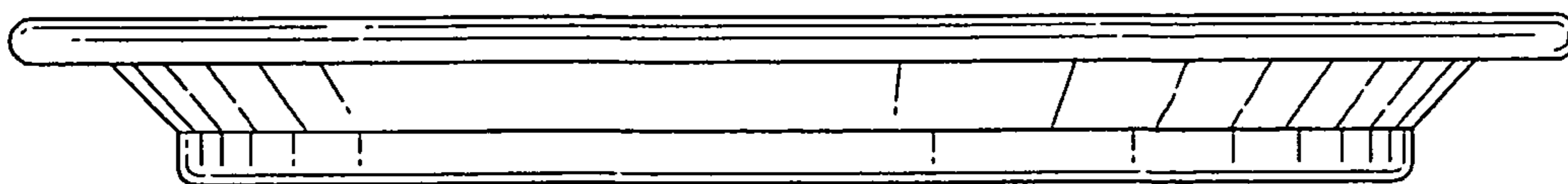
