**DESCRIPTION**

FIG. 2 is a right side view thereof, and the left side view is a mirror image of FIG. 2.

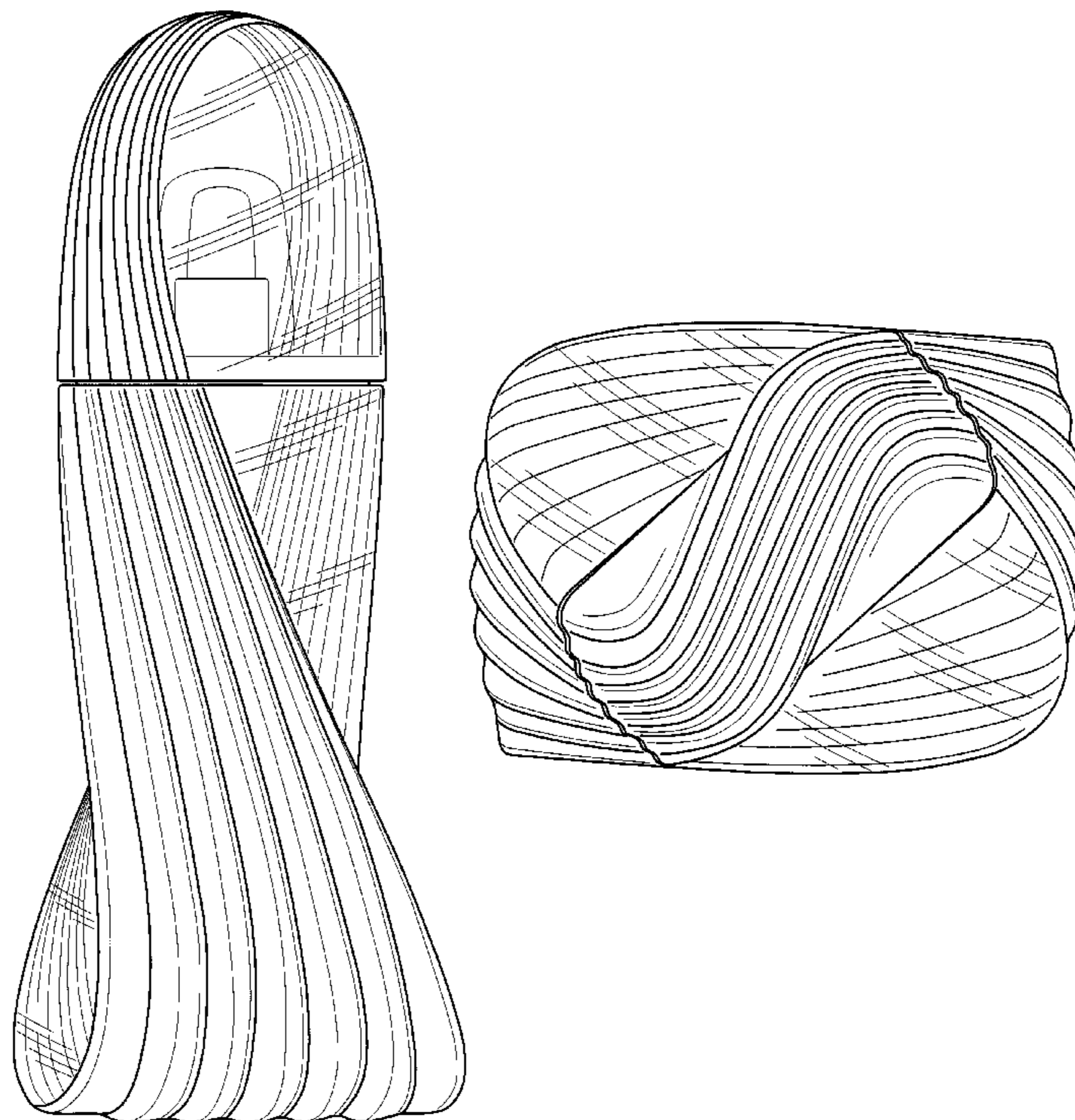
FIG. 3 is front view thereof.

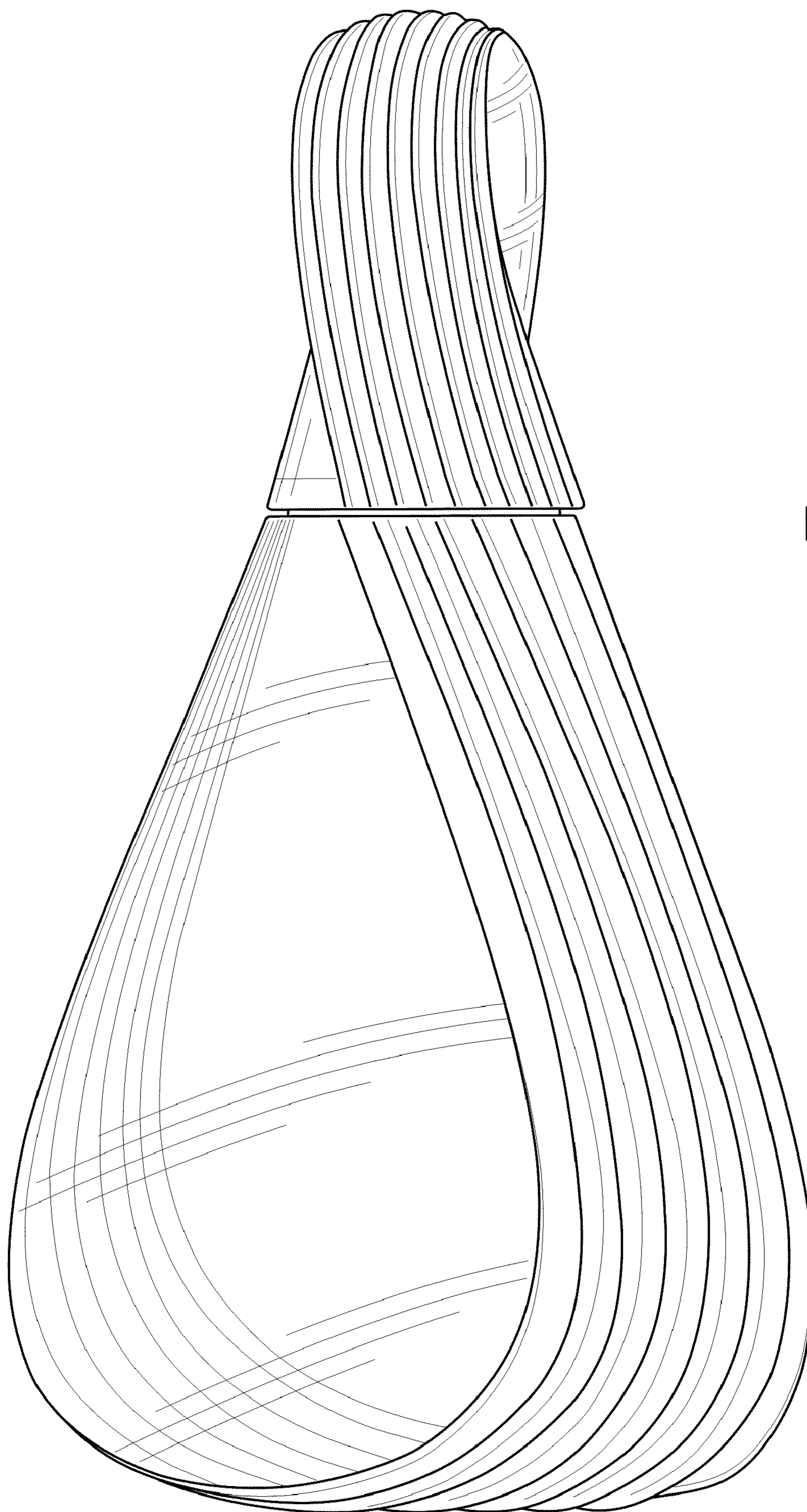

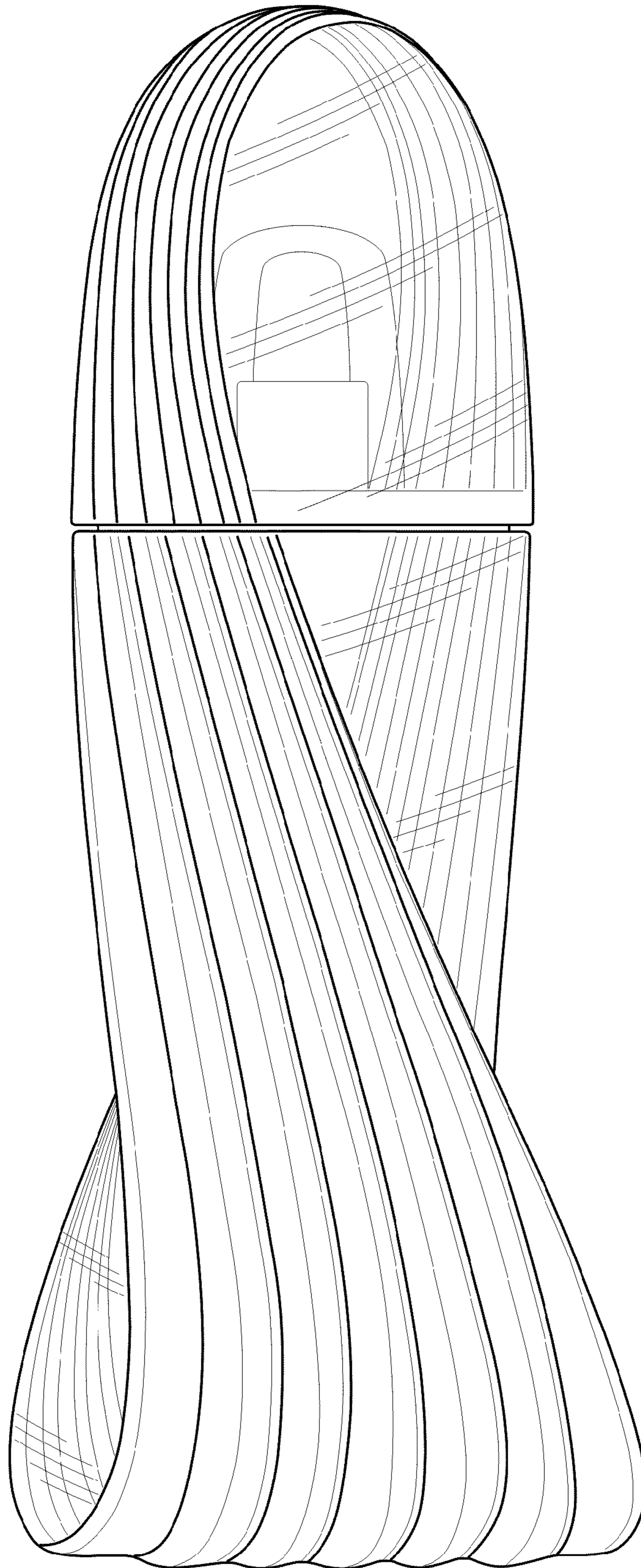

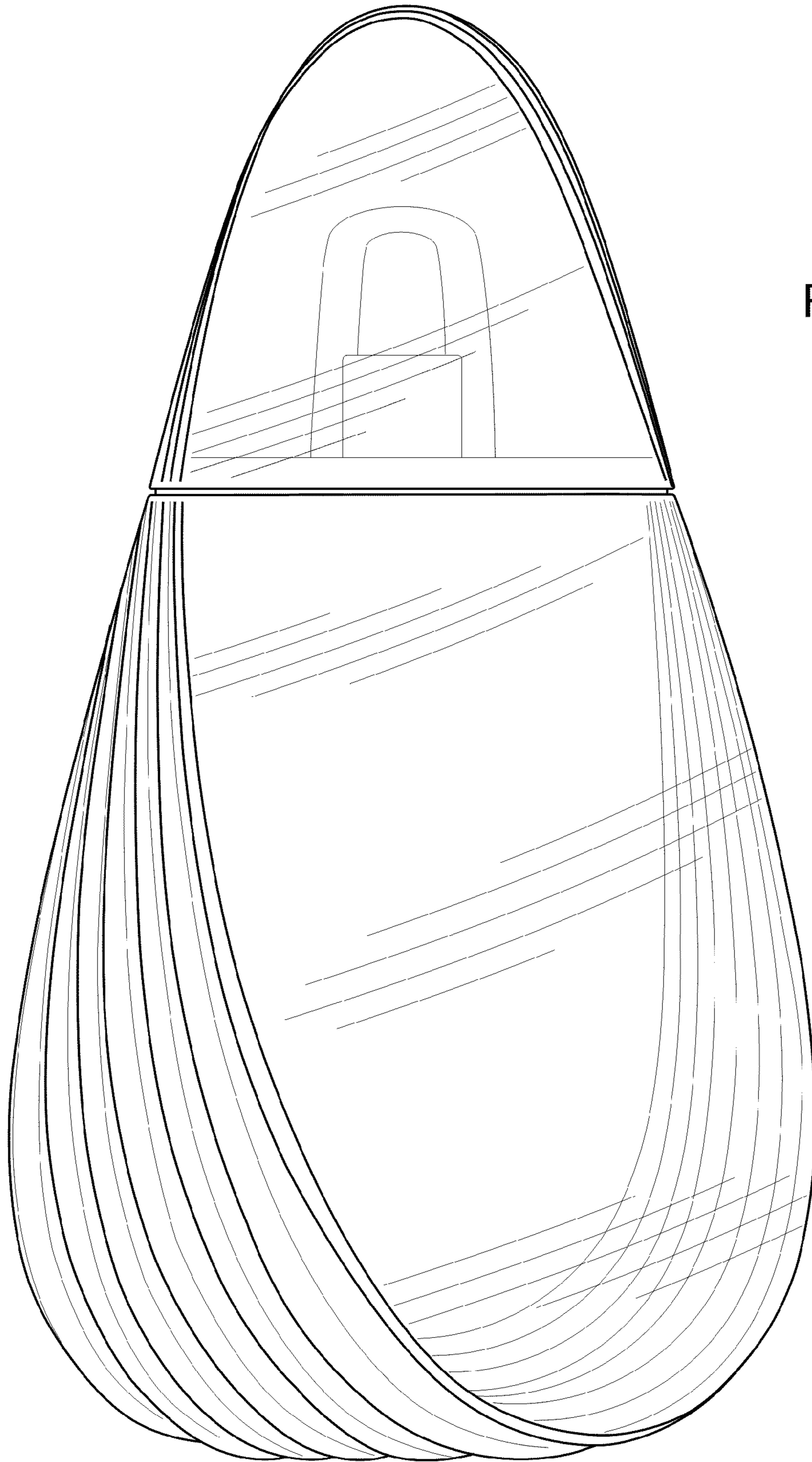

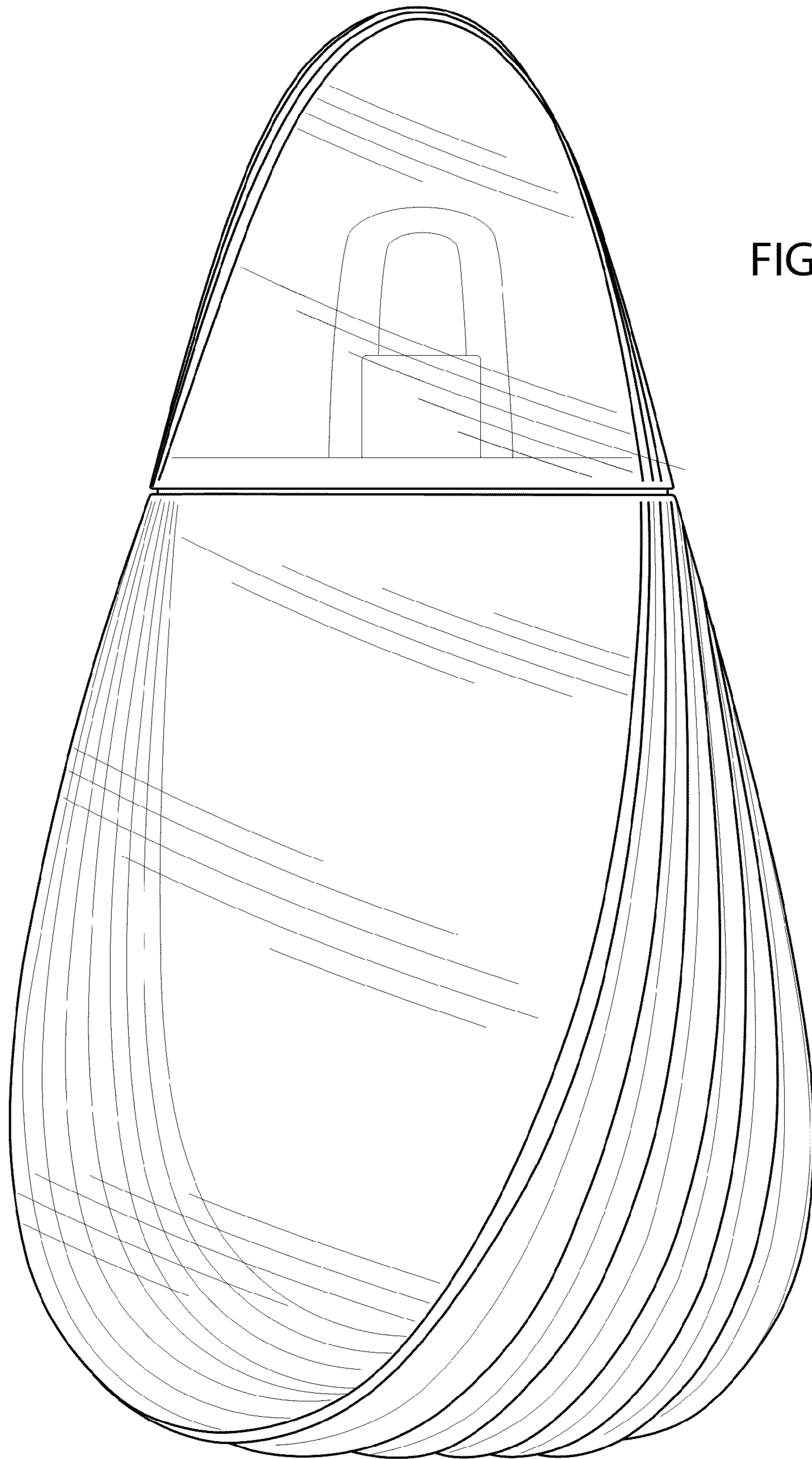

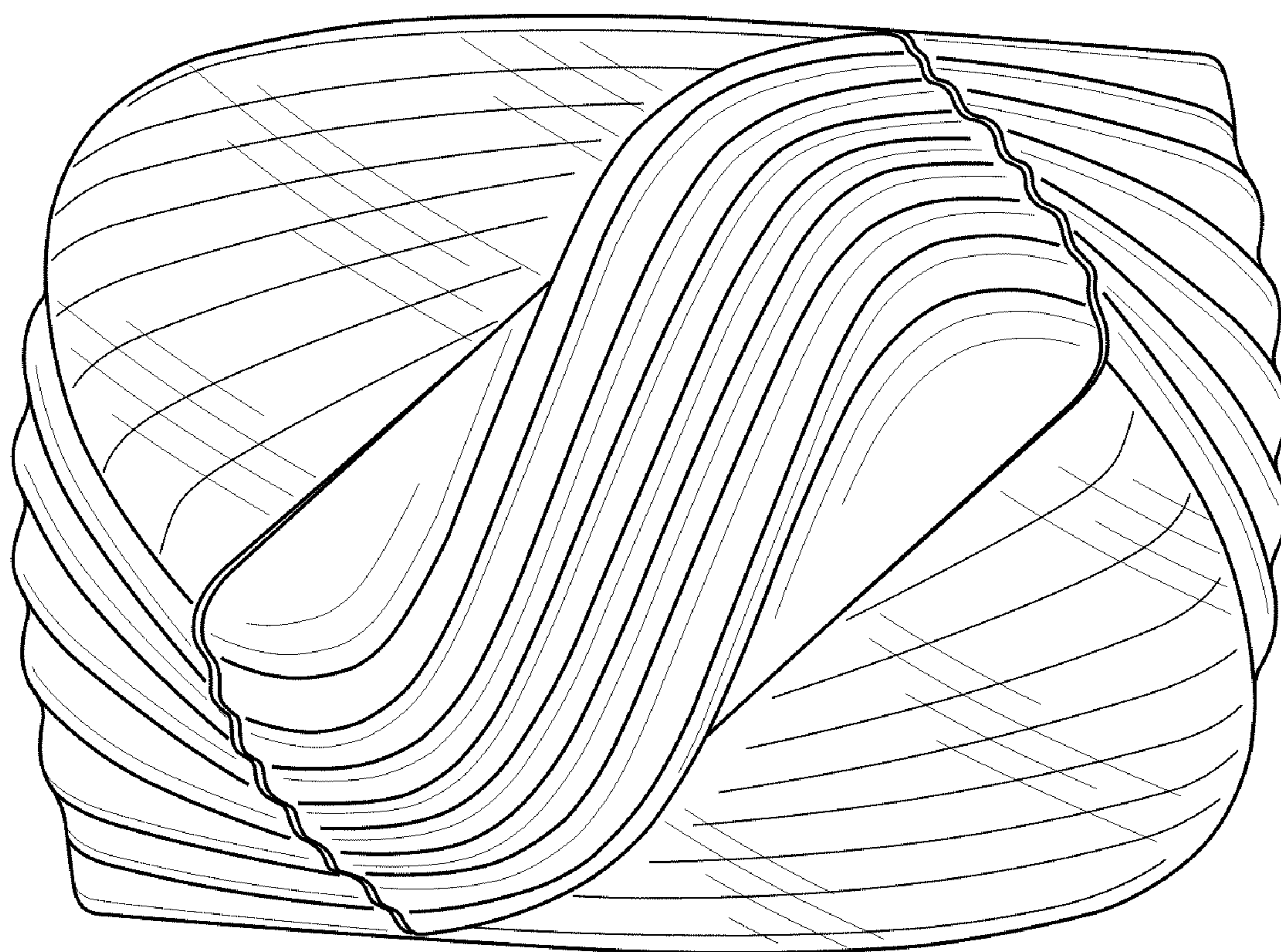

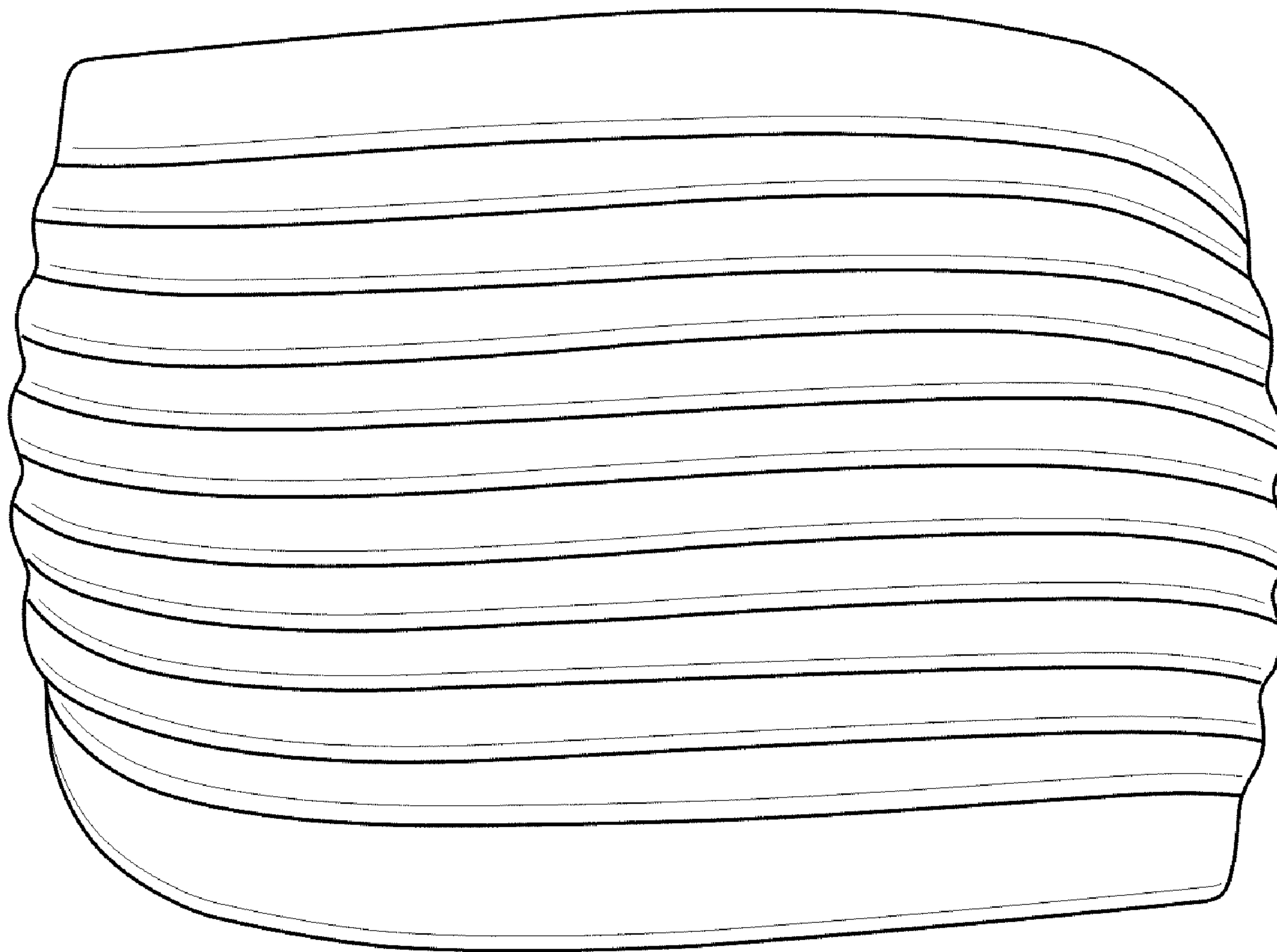
