FIG. 1 is a front perspective view of a container, embodying my our design;

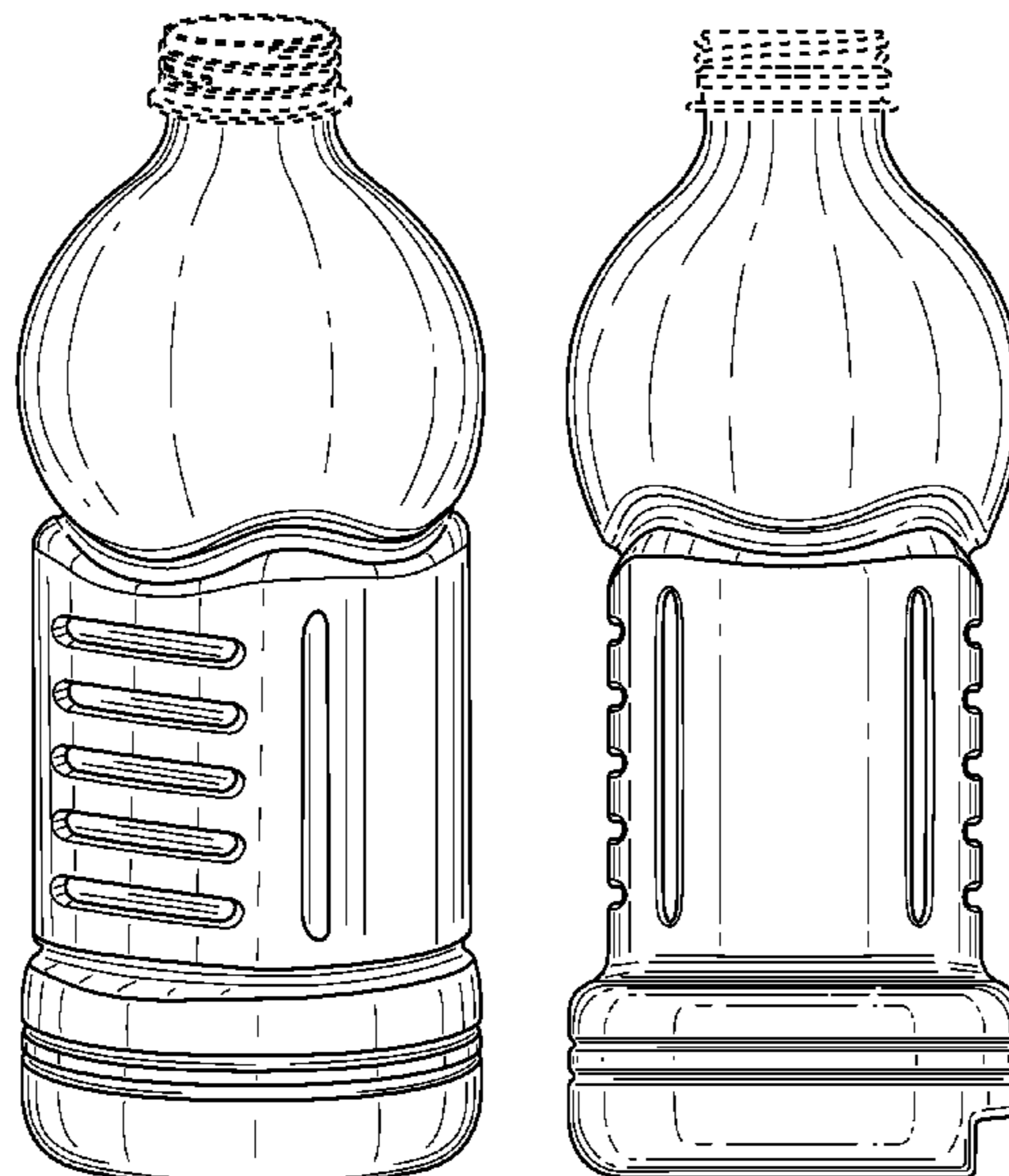
FIG. 2 is a side elevation view thereof, the opposite side being a mirror image thereto;

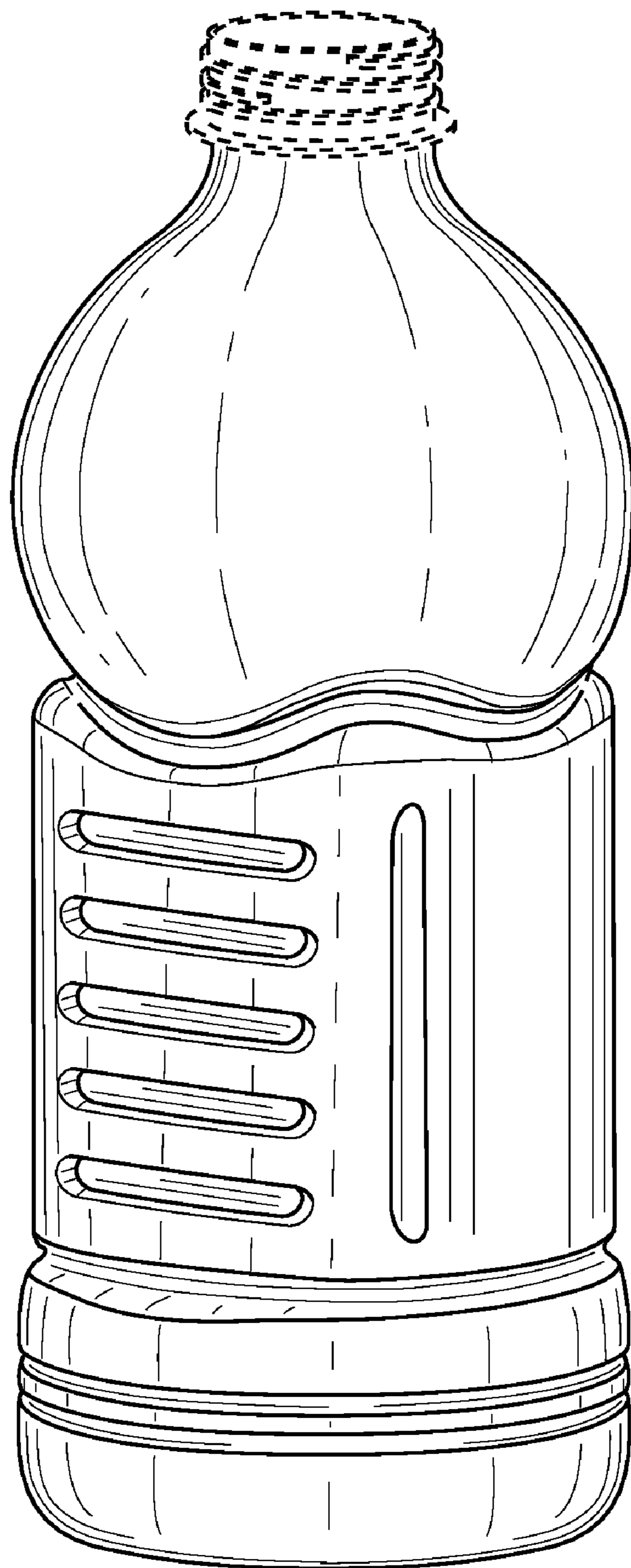

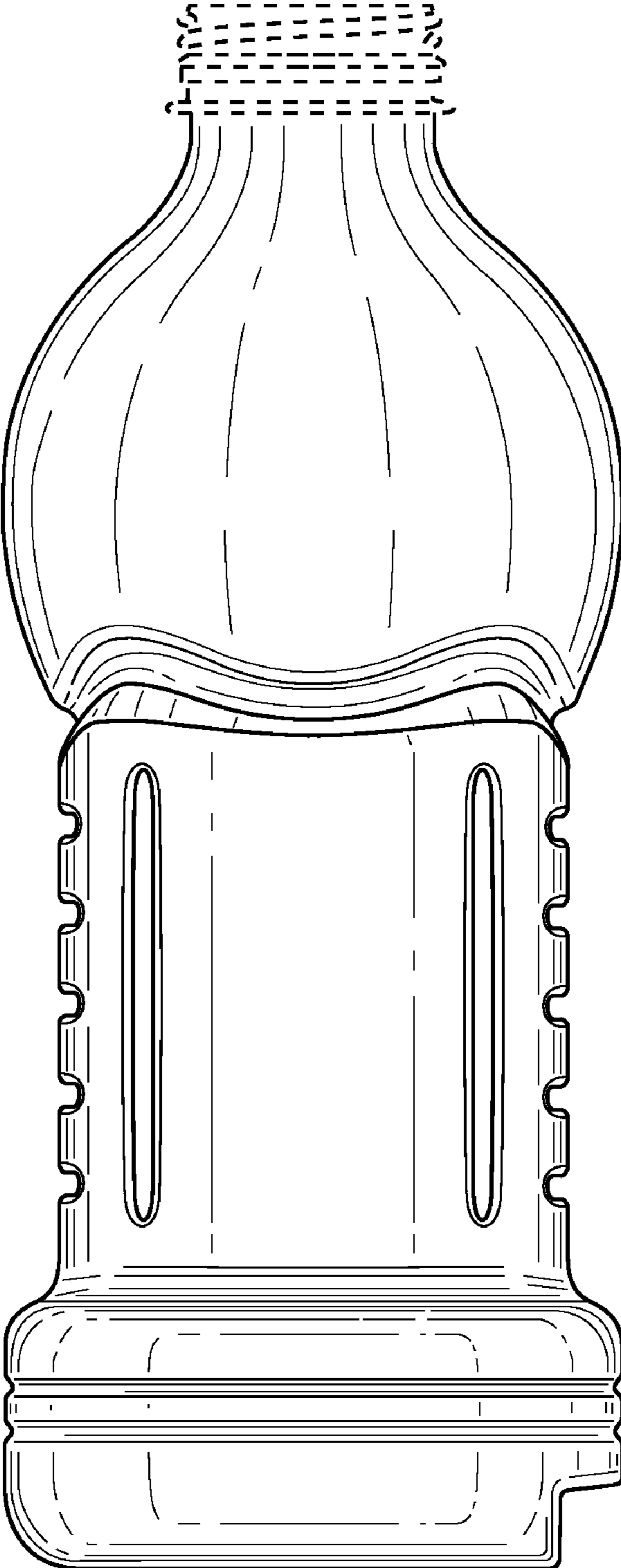

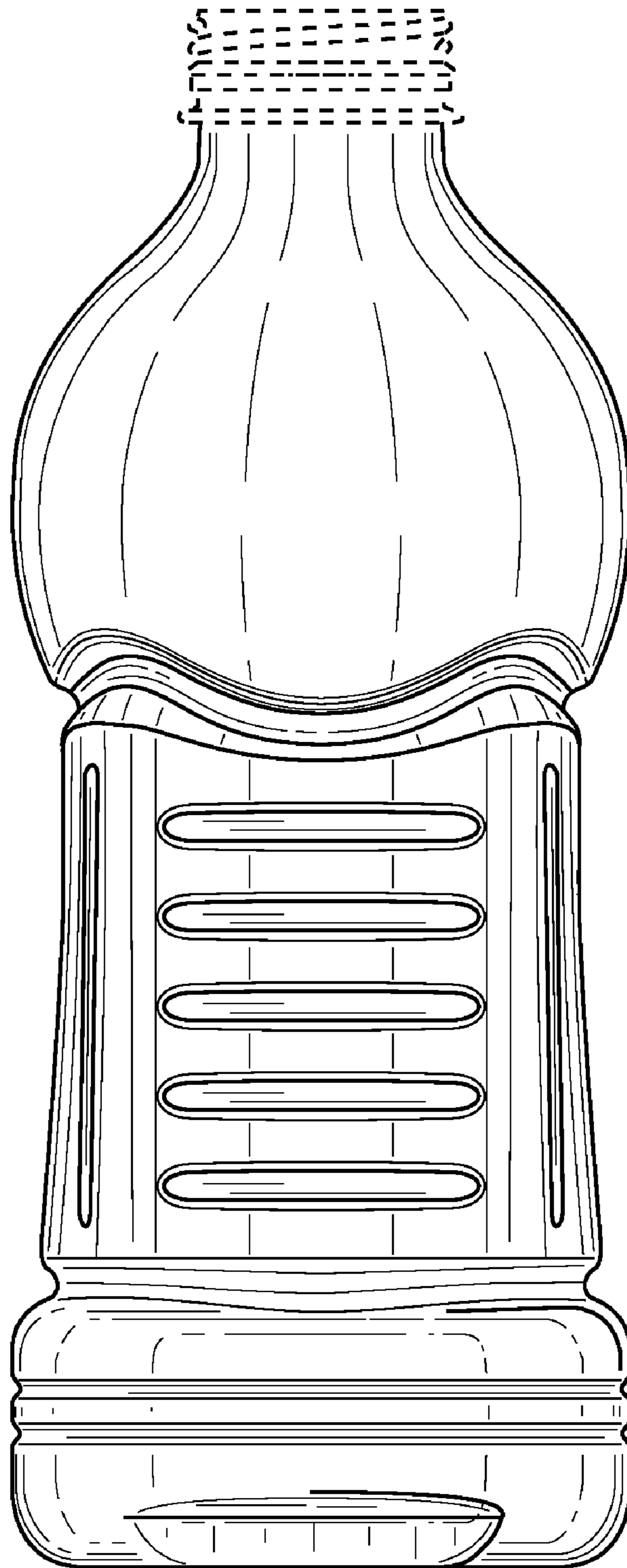

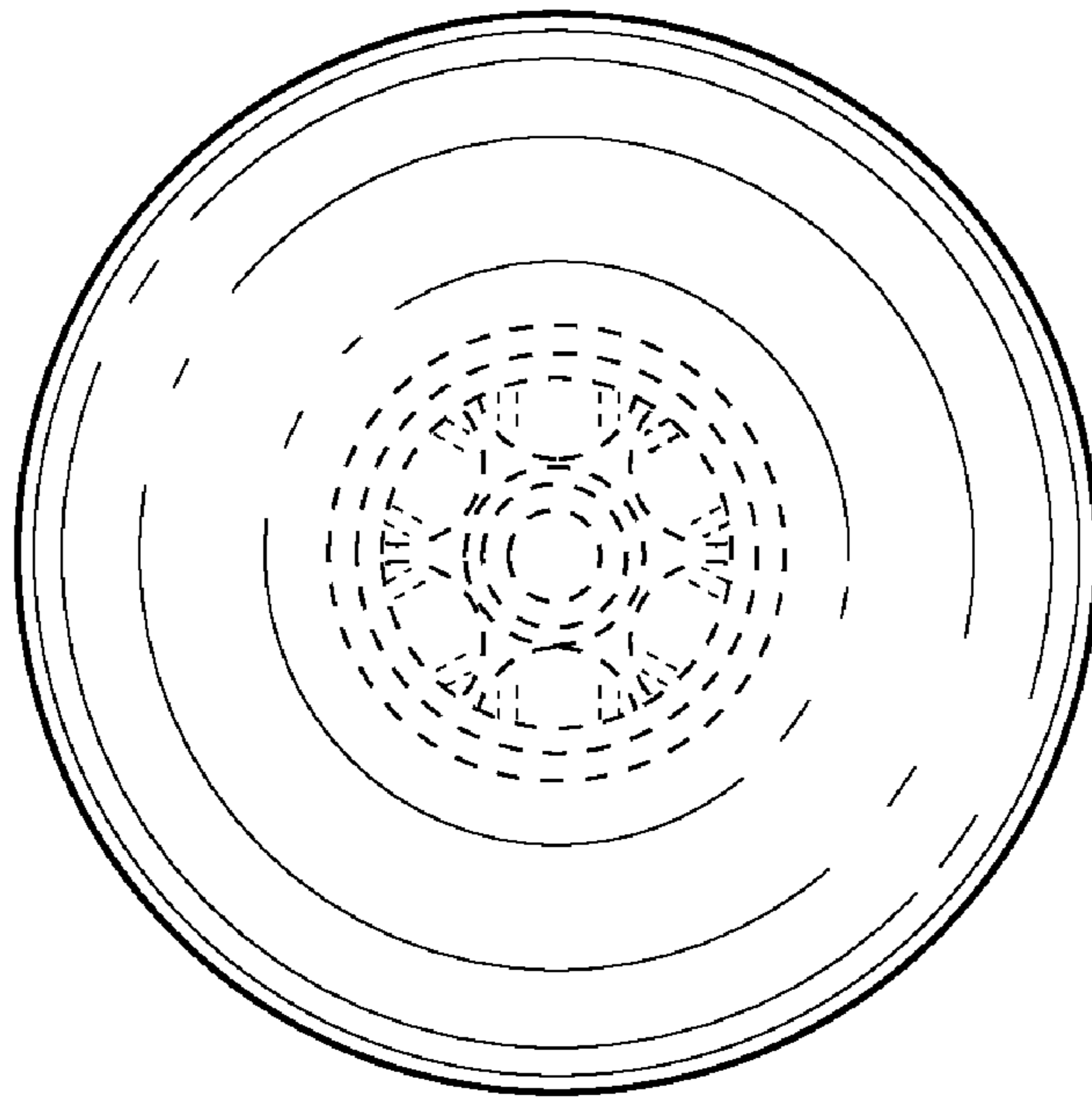
