DESCRIPTION

FIG. 1 is a top, front perspective view of a vase showing the new design;

FIG. 2 is a front elevation view thereof, the rear elevation view being a mirror image thereof;

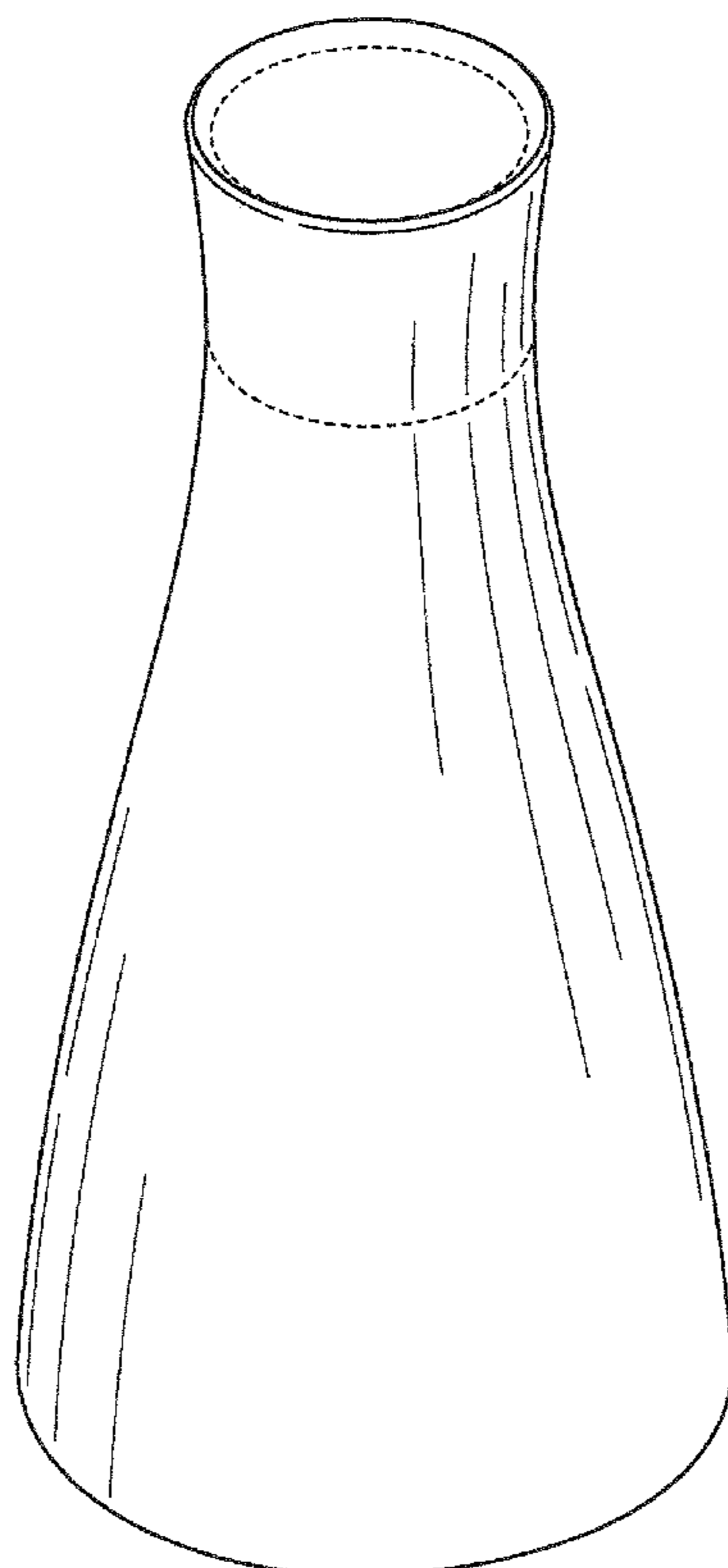
FIG. 3 is a left side elevation view thereof, the right side elevation view being a mirror image thereof;

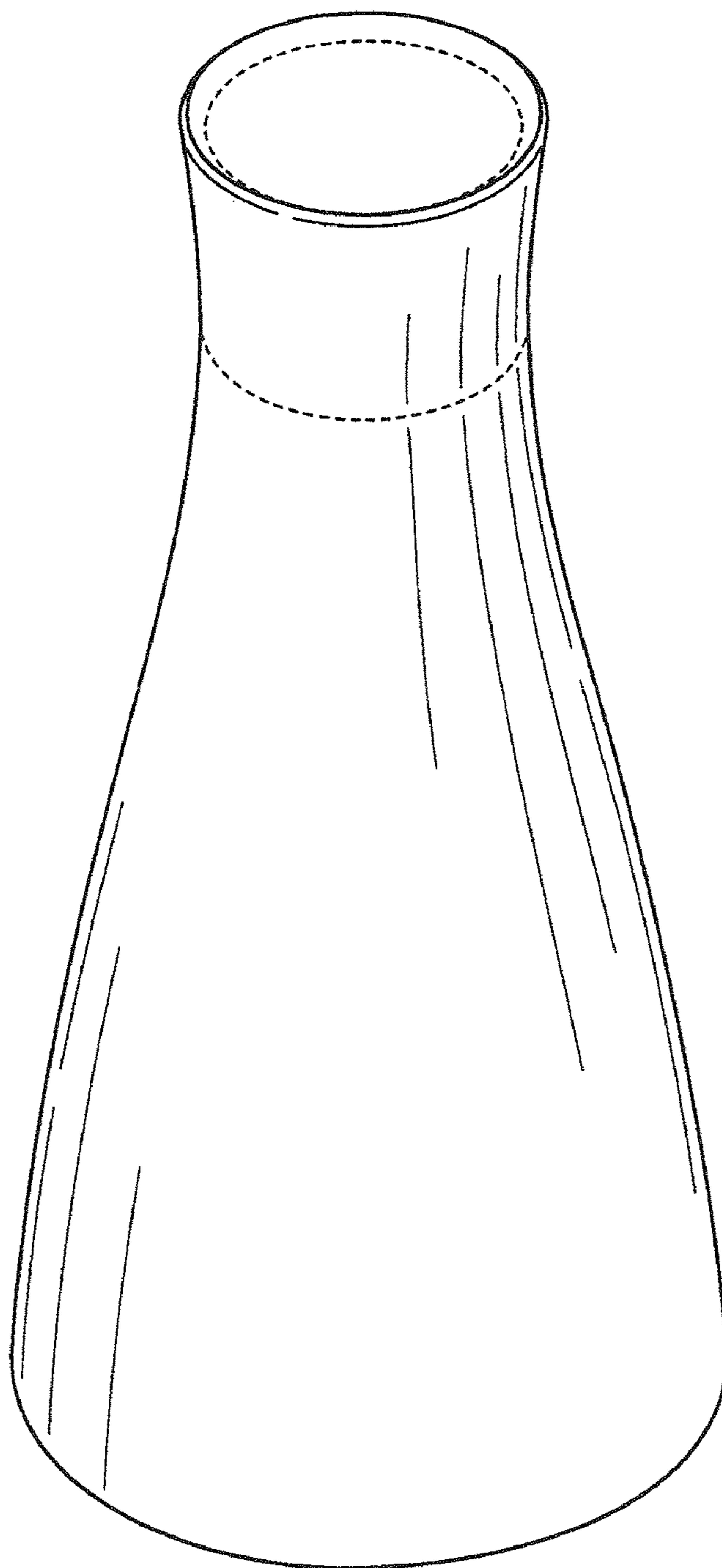

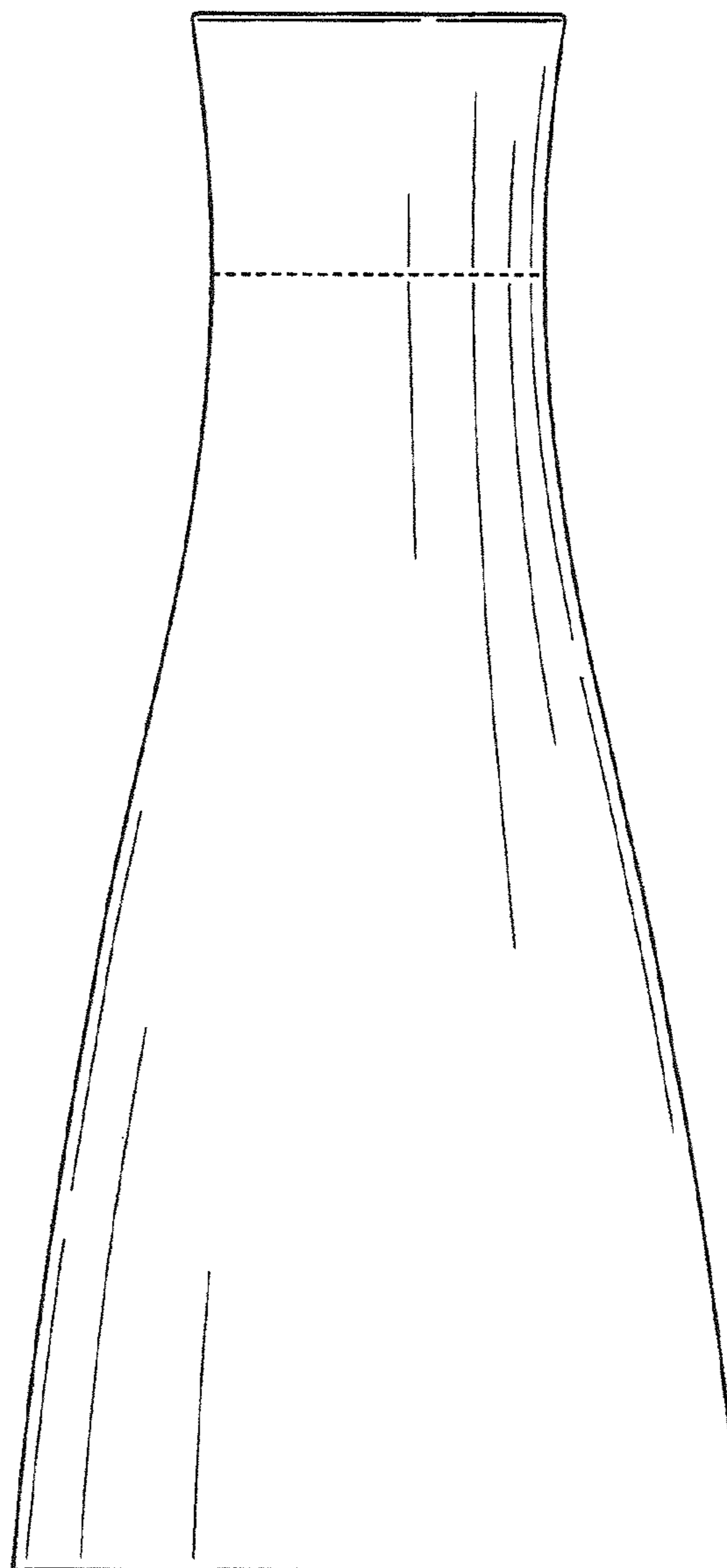

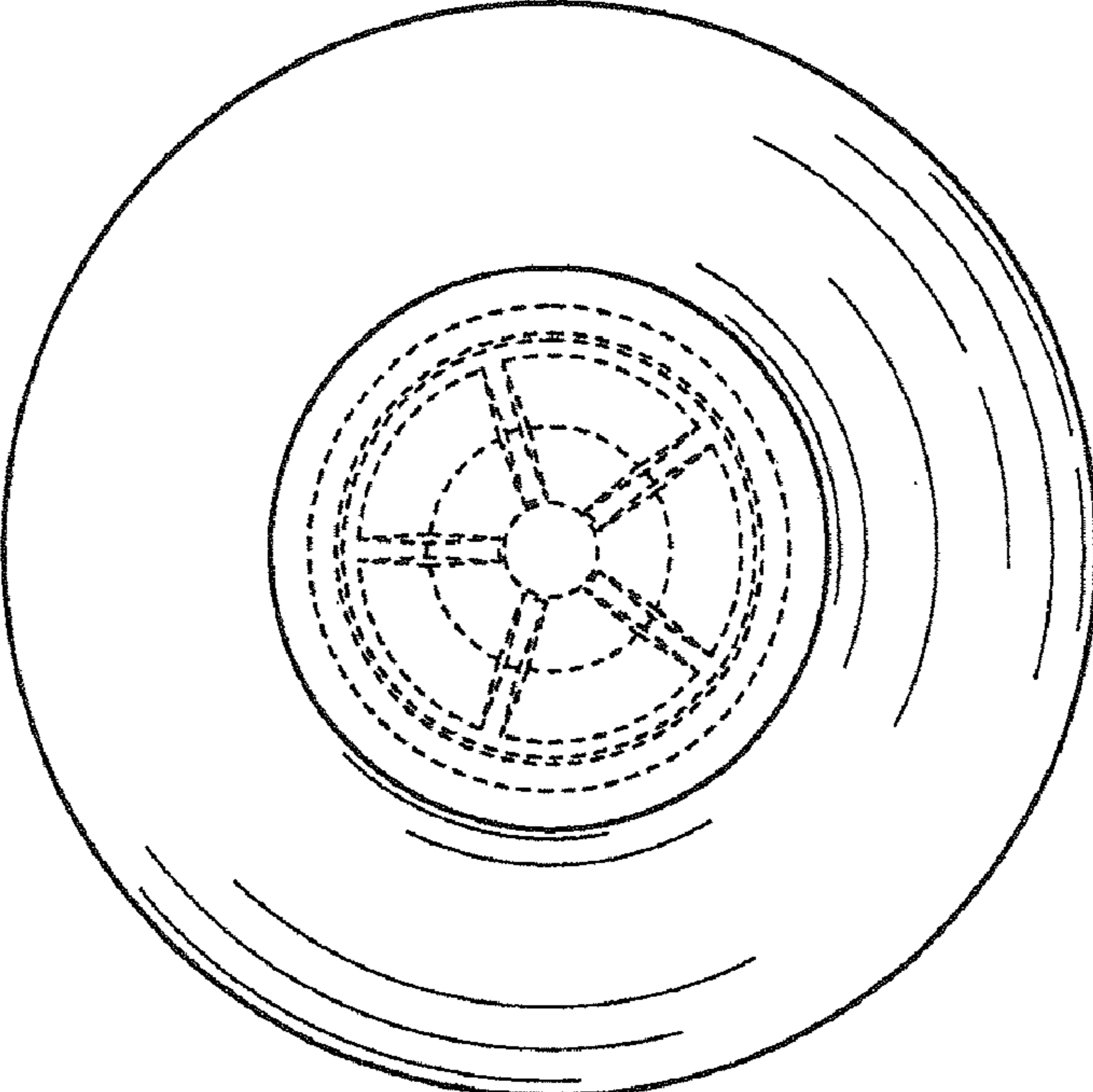

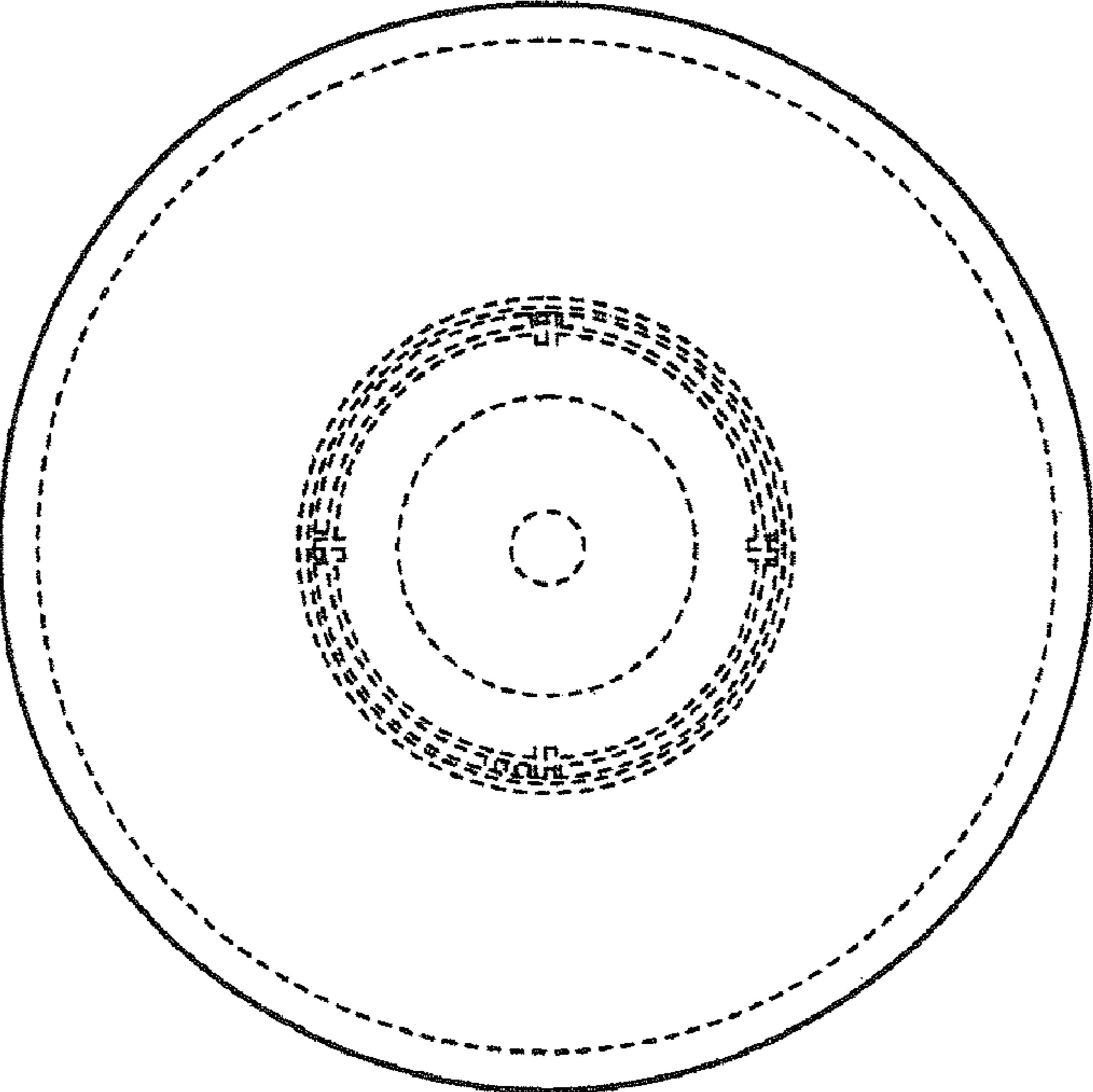
