The ornamental design for a truck cab body, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a truck cab body of the present invention.

FIG. 2 is a rear view of the truck cab body of FIG. 1.

FIG. 3 is a top plan view of the truck cab body of FIG. 1.

FIG. 4 is a bottom view of the truck cab body of FIG. 1.

FIG. 5 is a right side view of the truck cab body of FIG. 1.

FIG. 7 is a front perspective view of the truck cab body of FIG. 1.

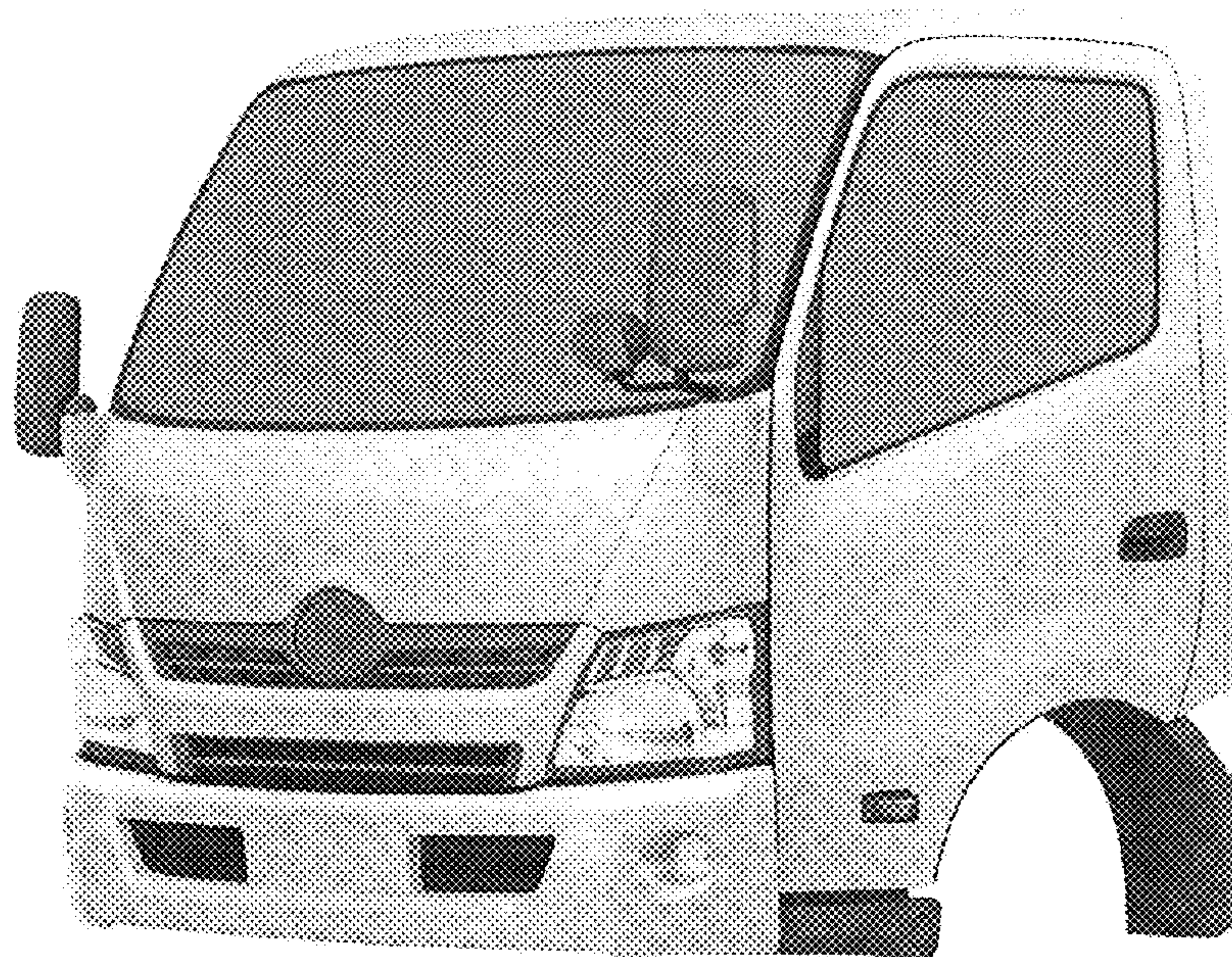
FIG. 8 is a rear perspective view of the truck cab body of FIG. 1.

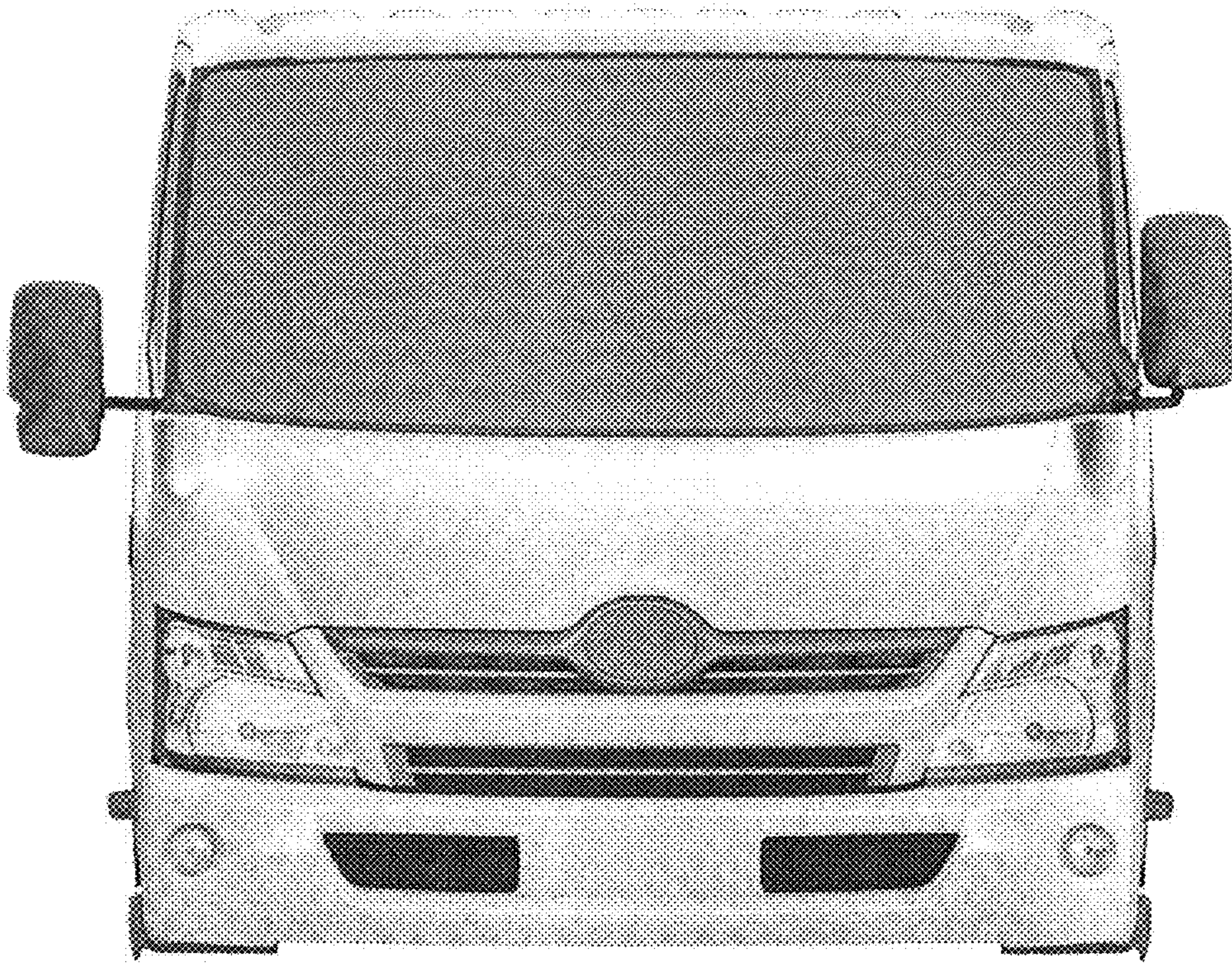

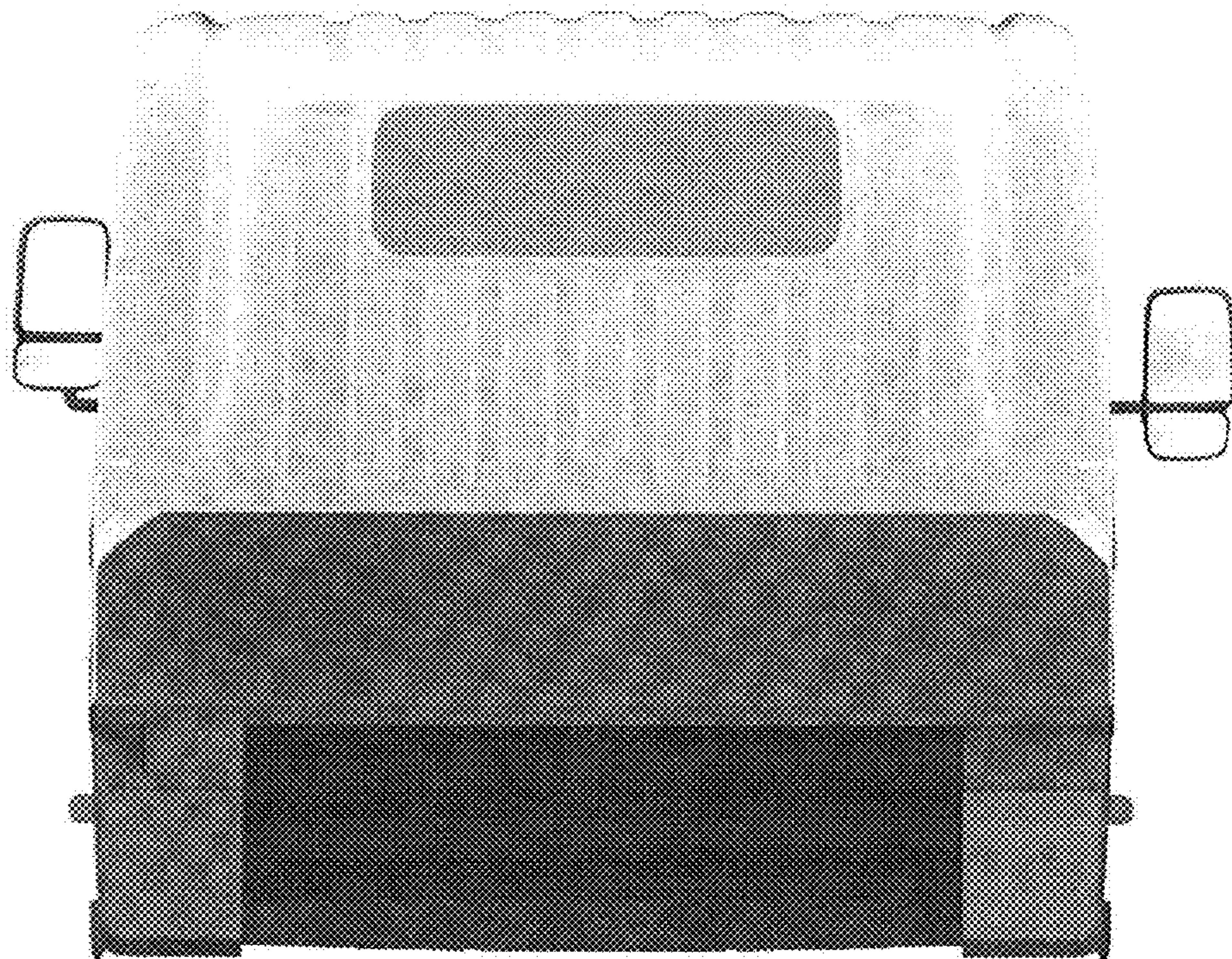

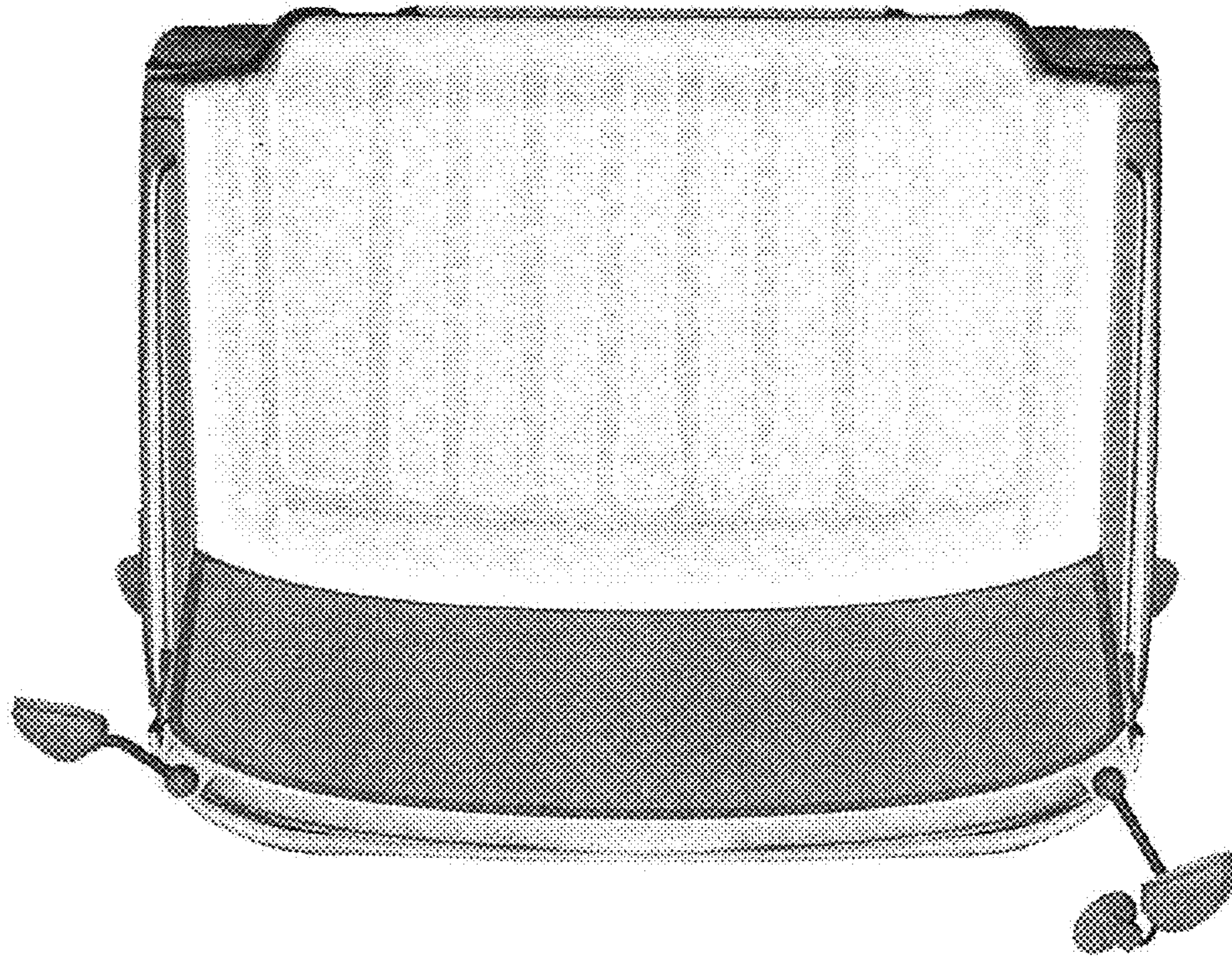

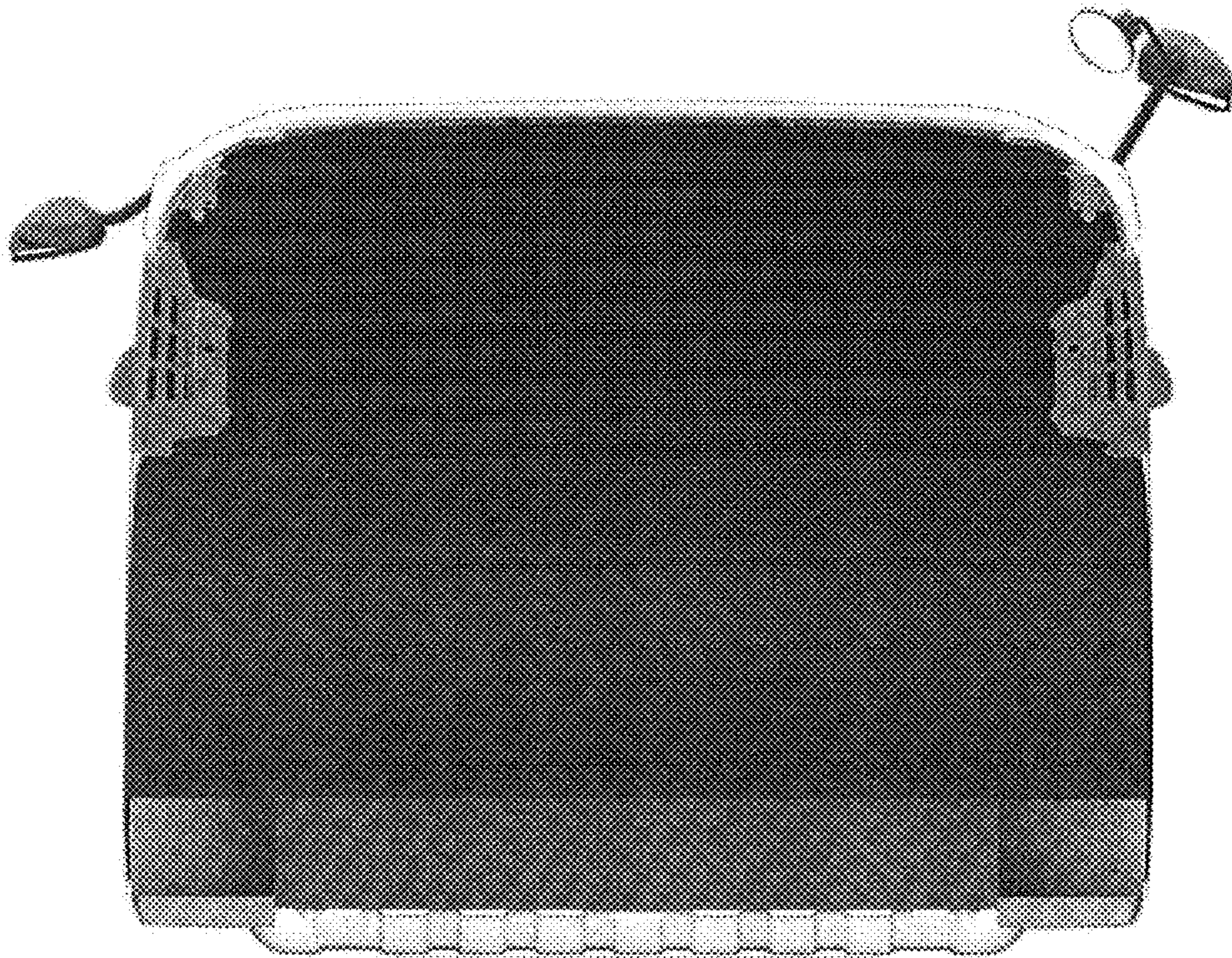

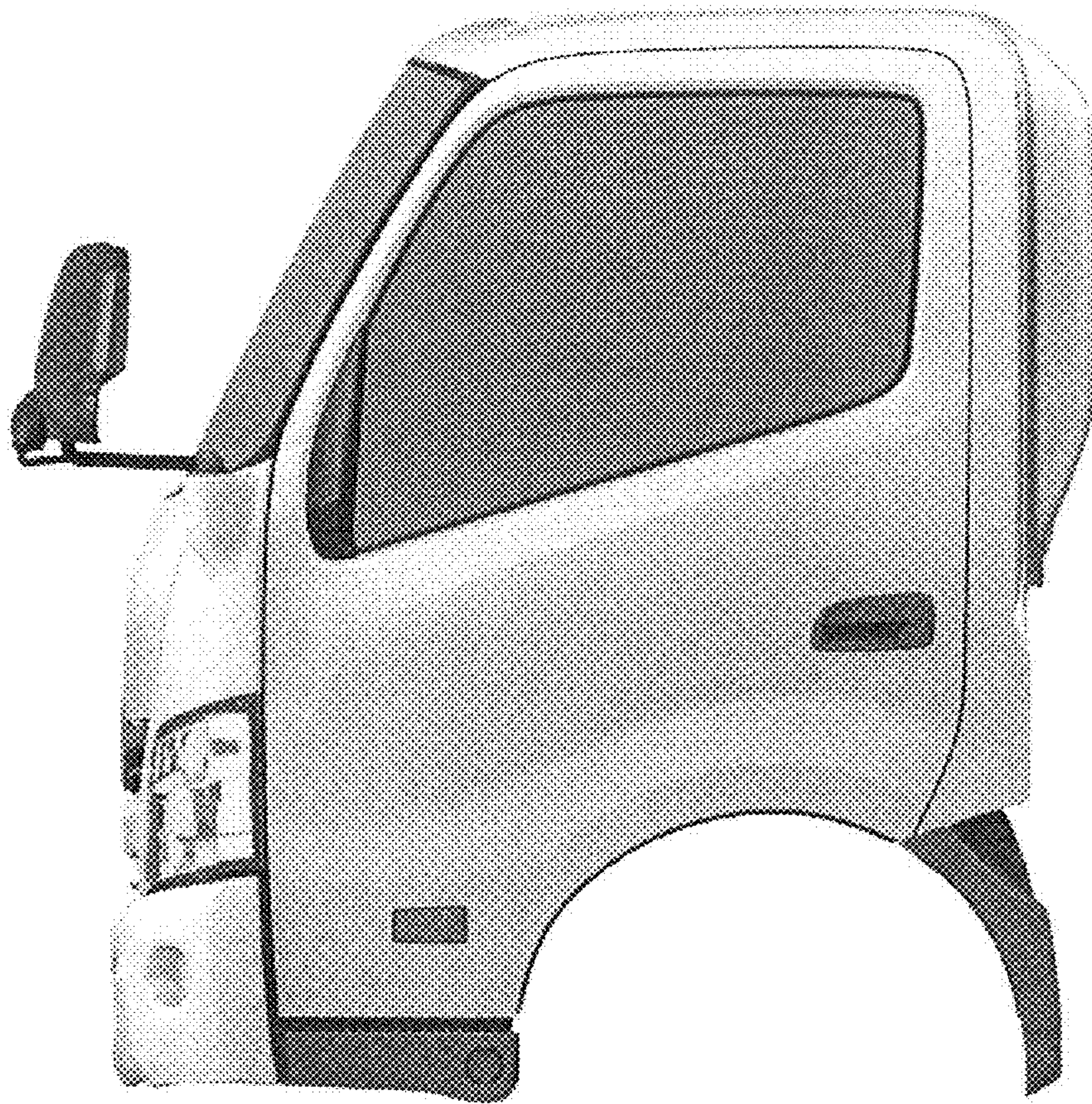

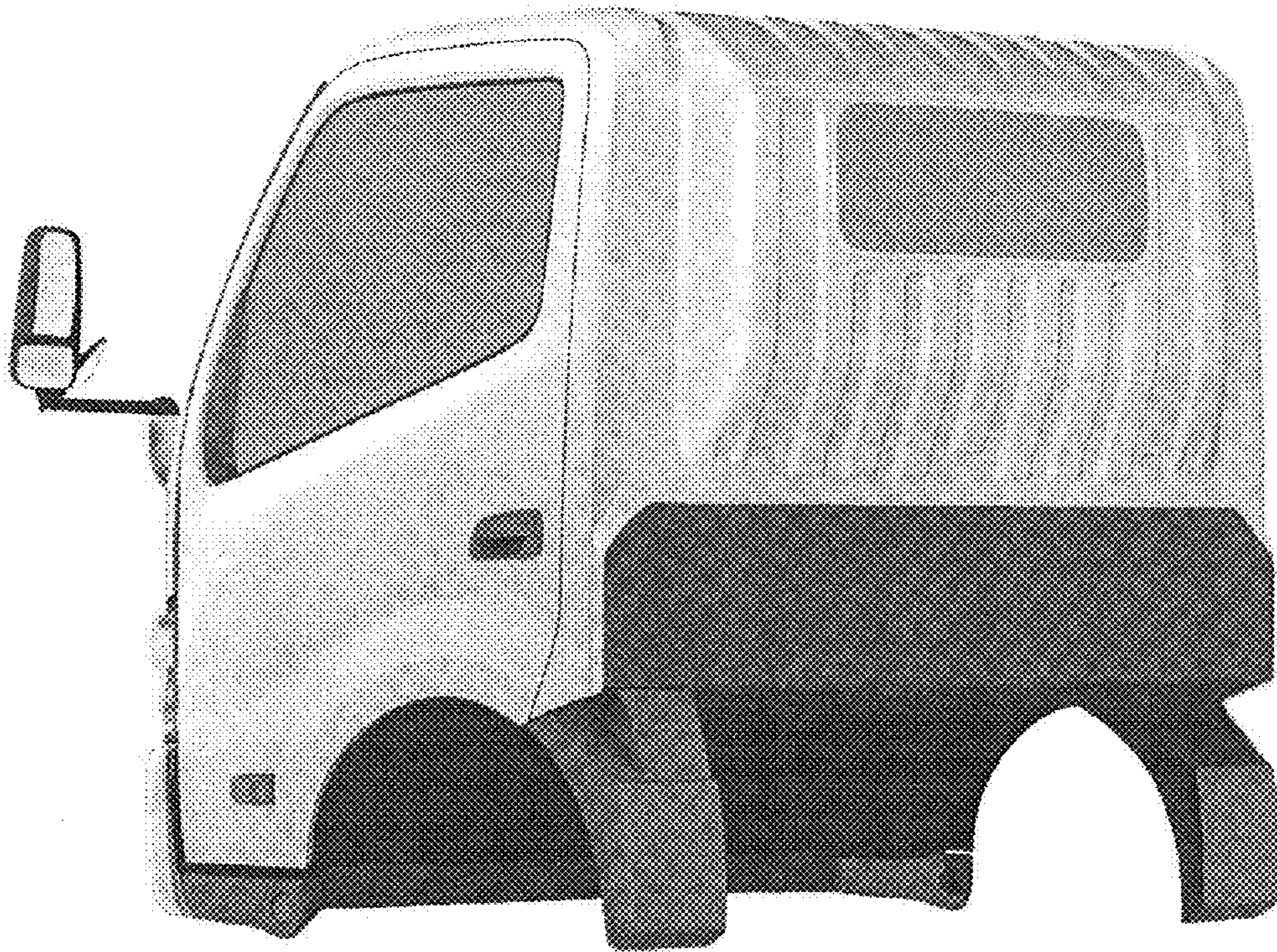

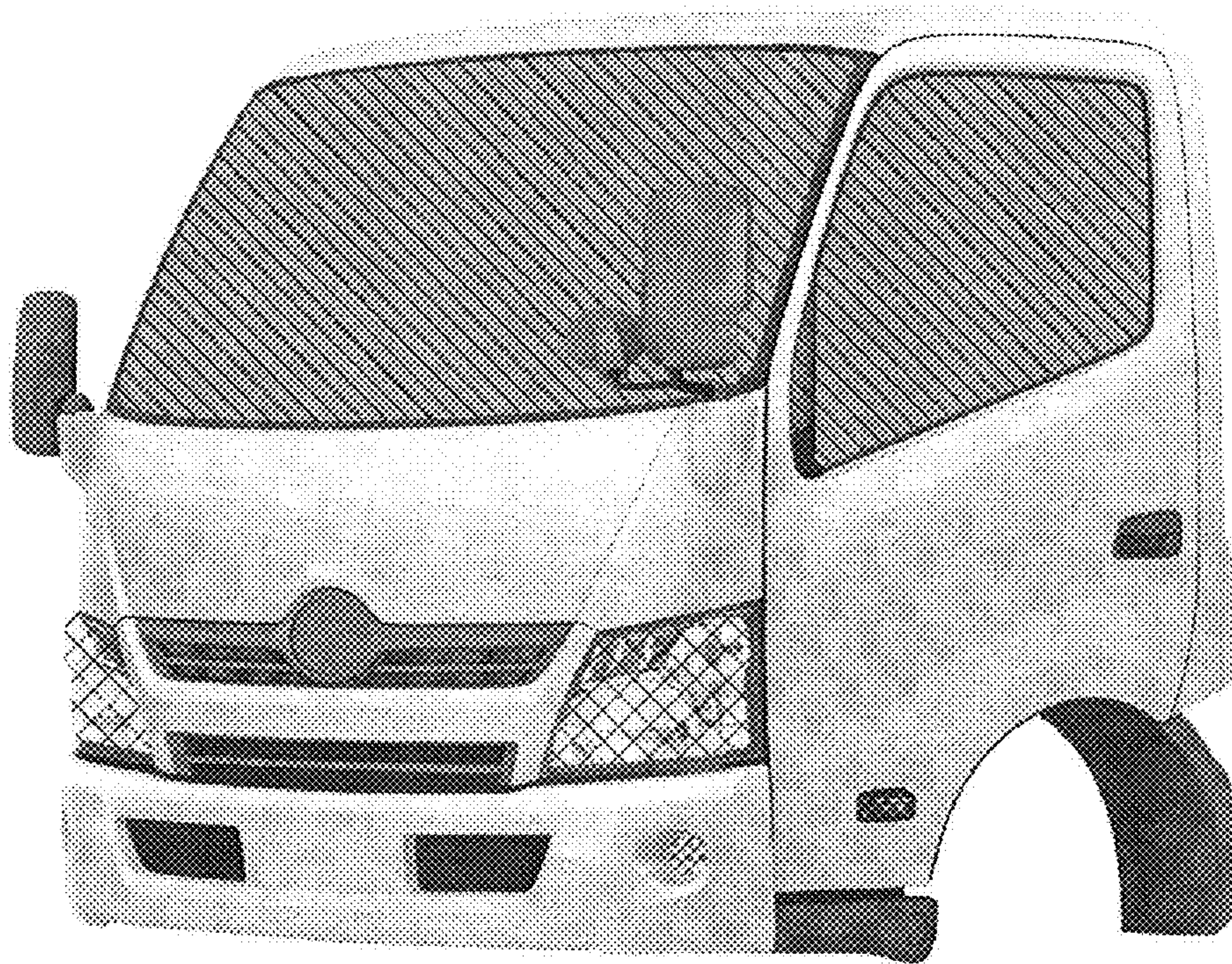

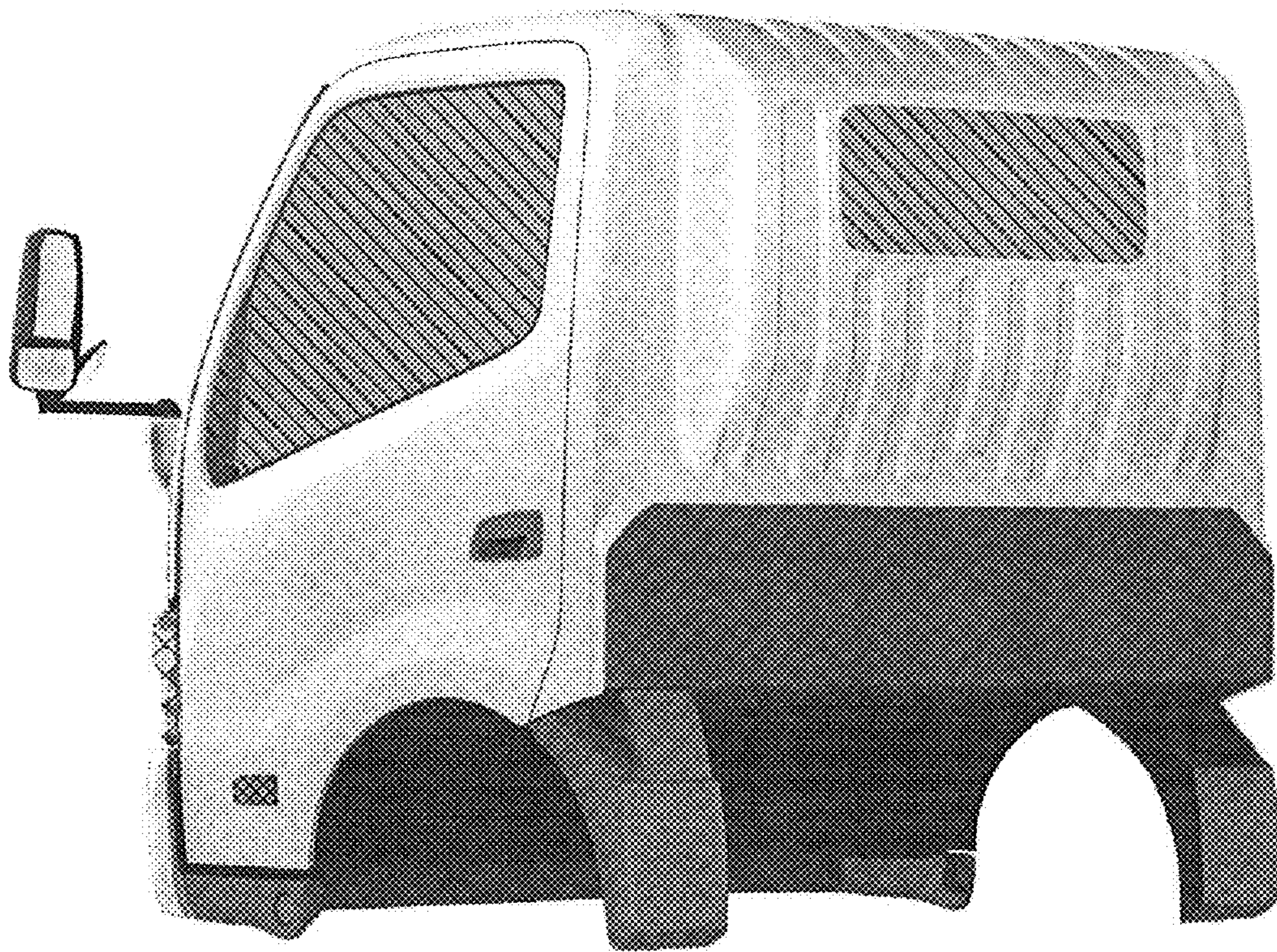

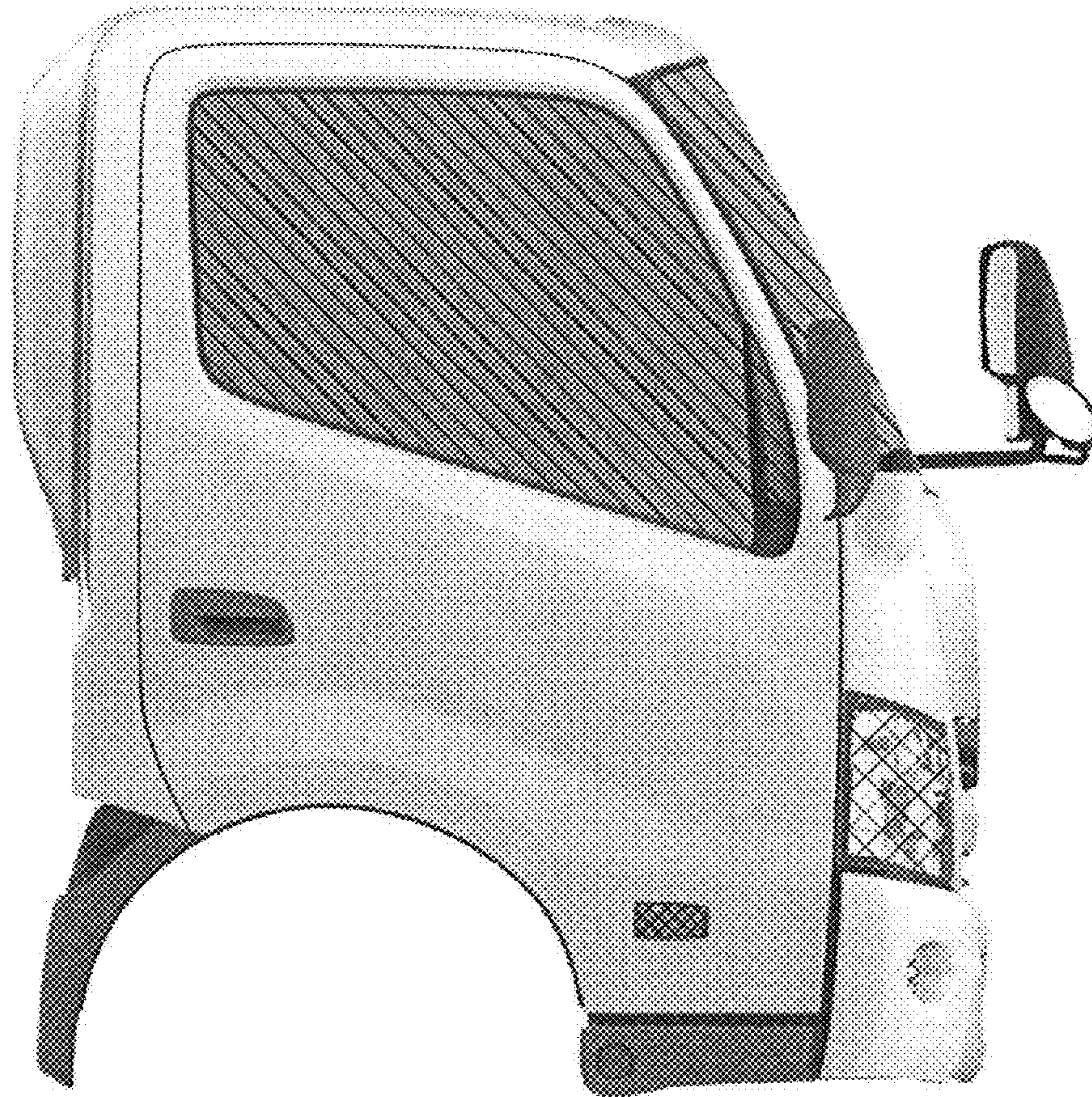
