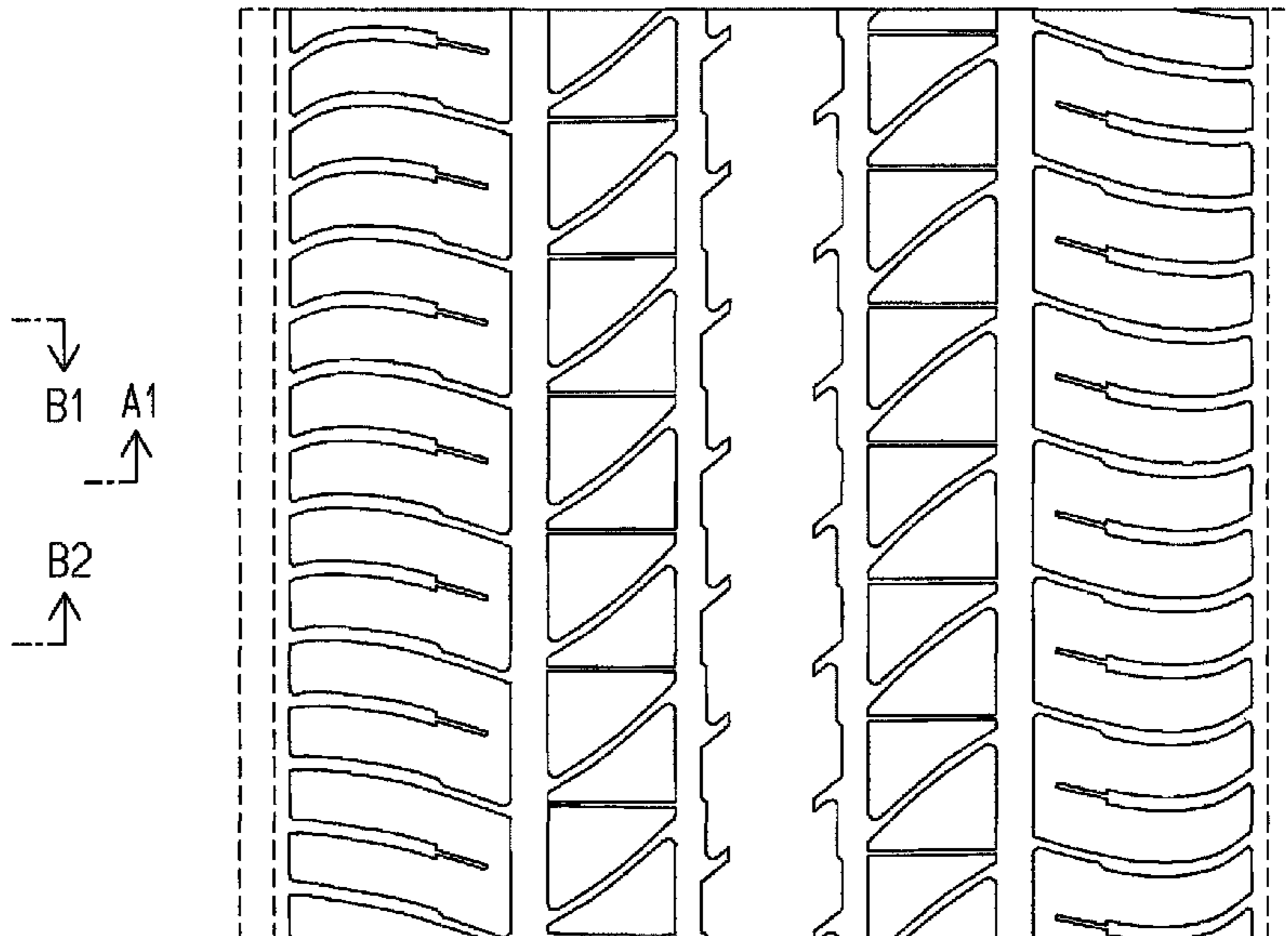
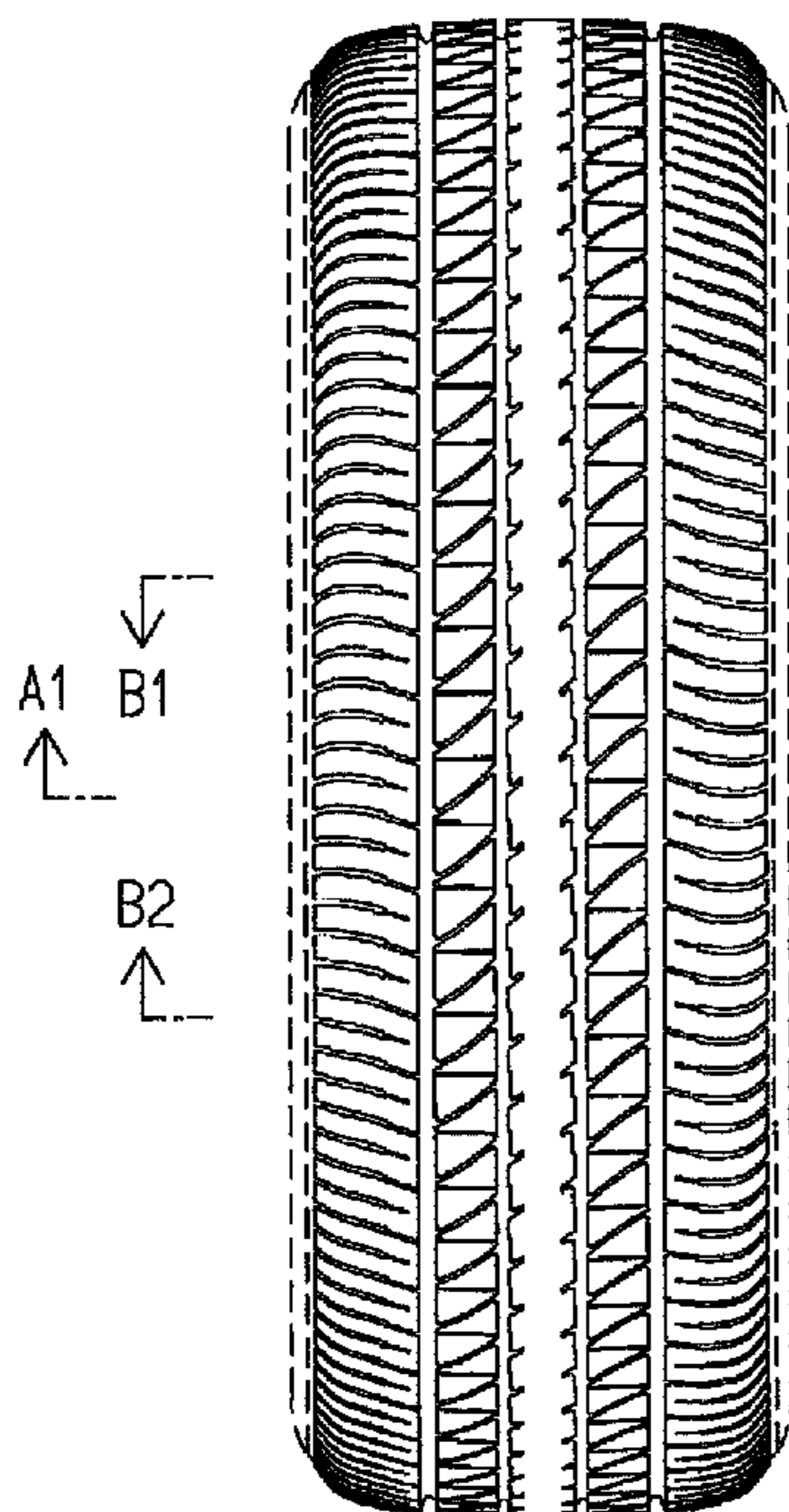
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front view showing our new design;
FIG. 2 is a right-side view thereof;
FIG. 3 is a top view thereof;
FIG. 4 is a perspective view thereof;
FIG. 5 is an enlarged cross-section view taken along the line A1-A1 of FIG. 1, in the part C-C of FIG. 2; and,
FIG. 6 is an enlarged view of the part B1-B2 in FIG. 1.

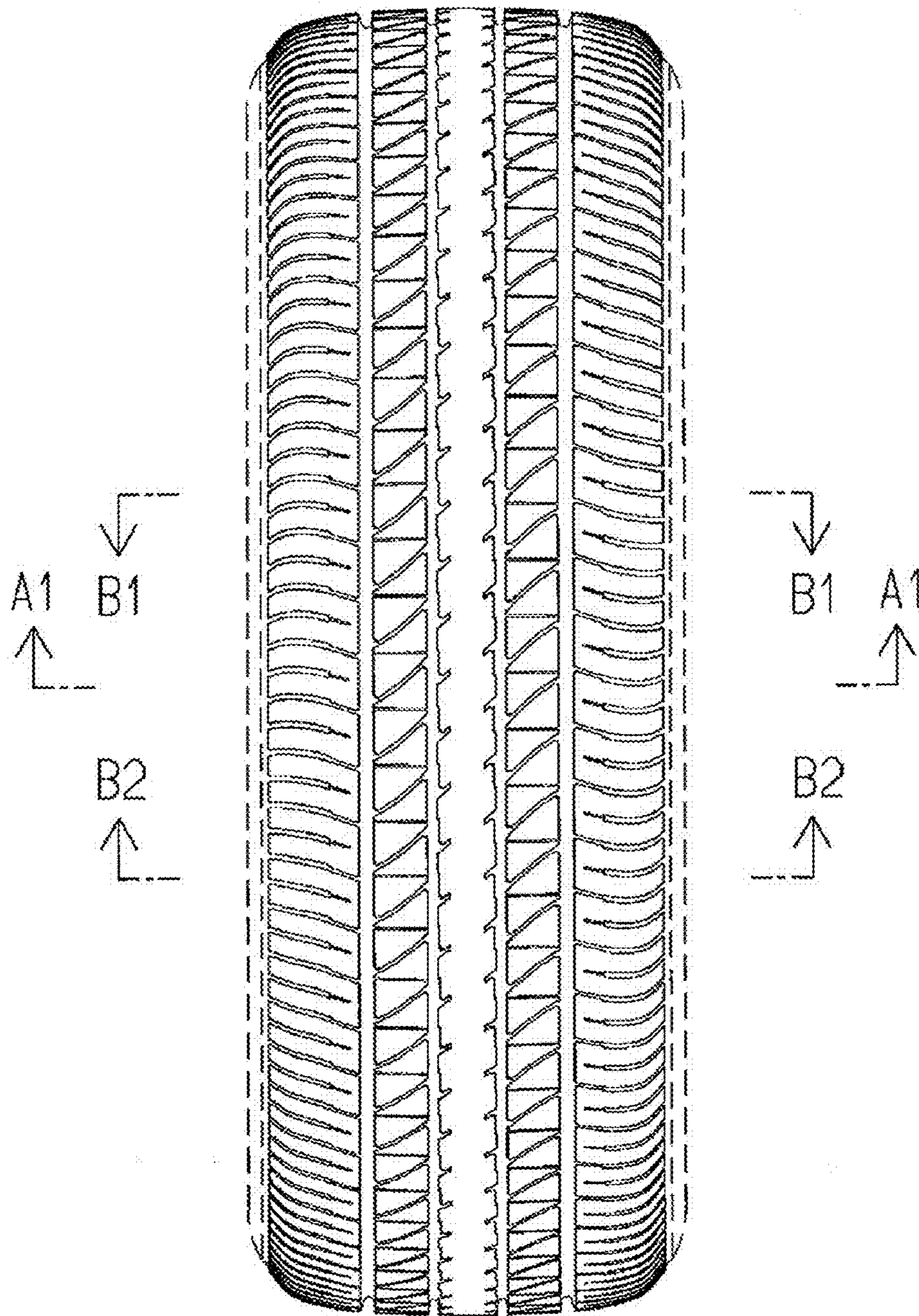

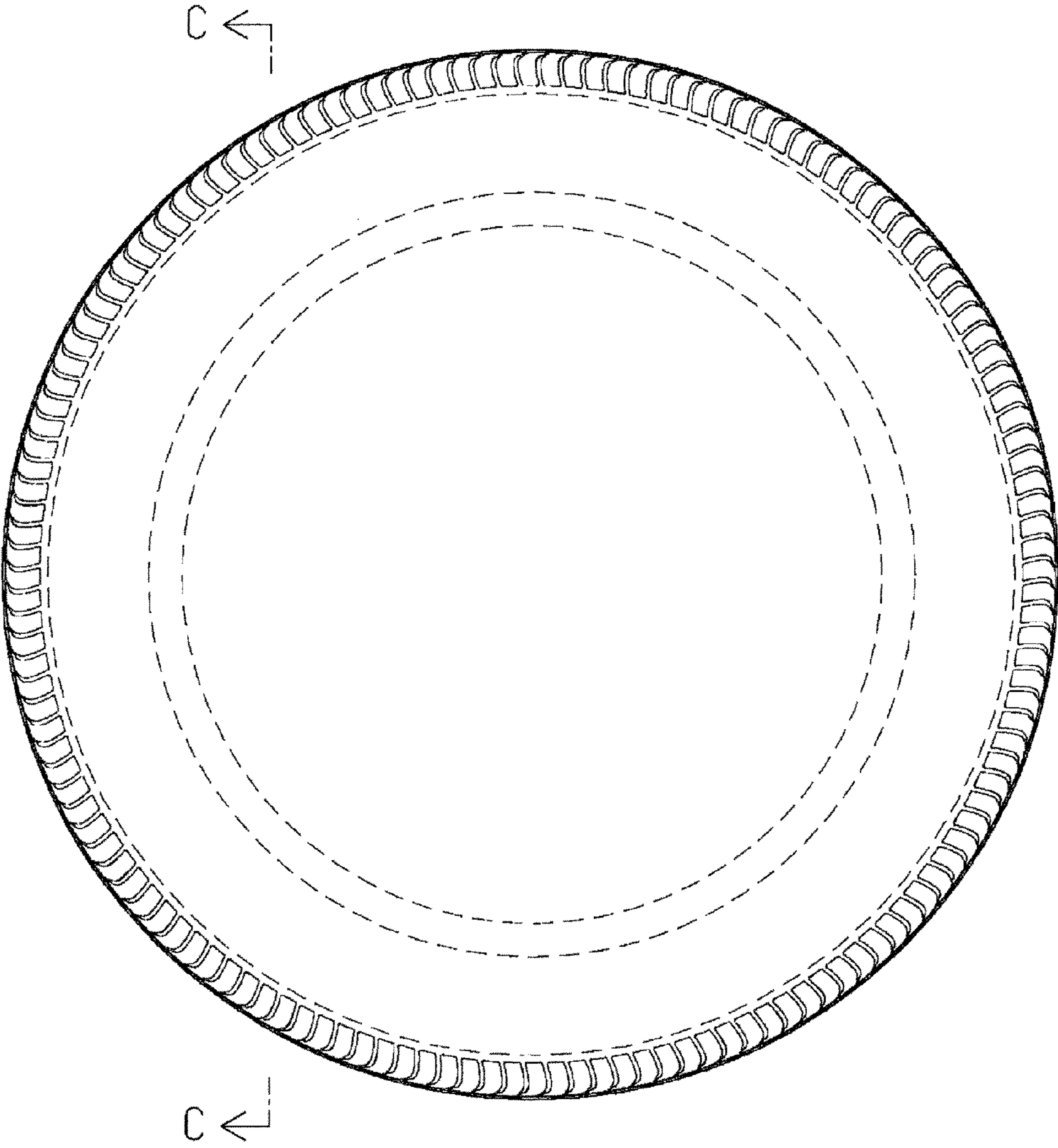

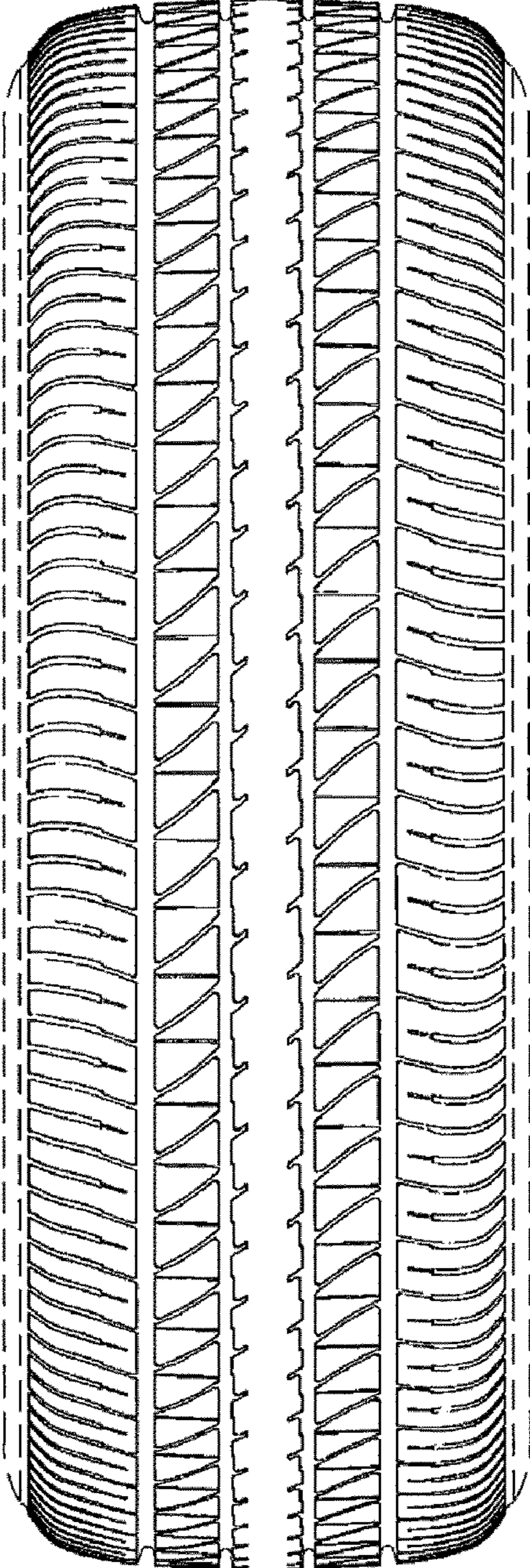

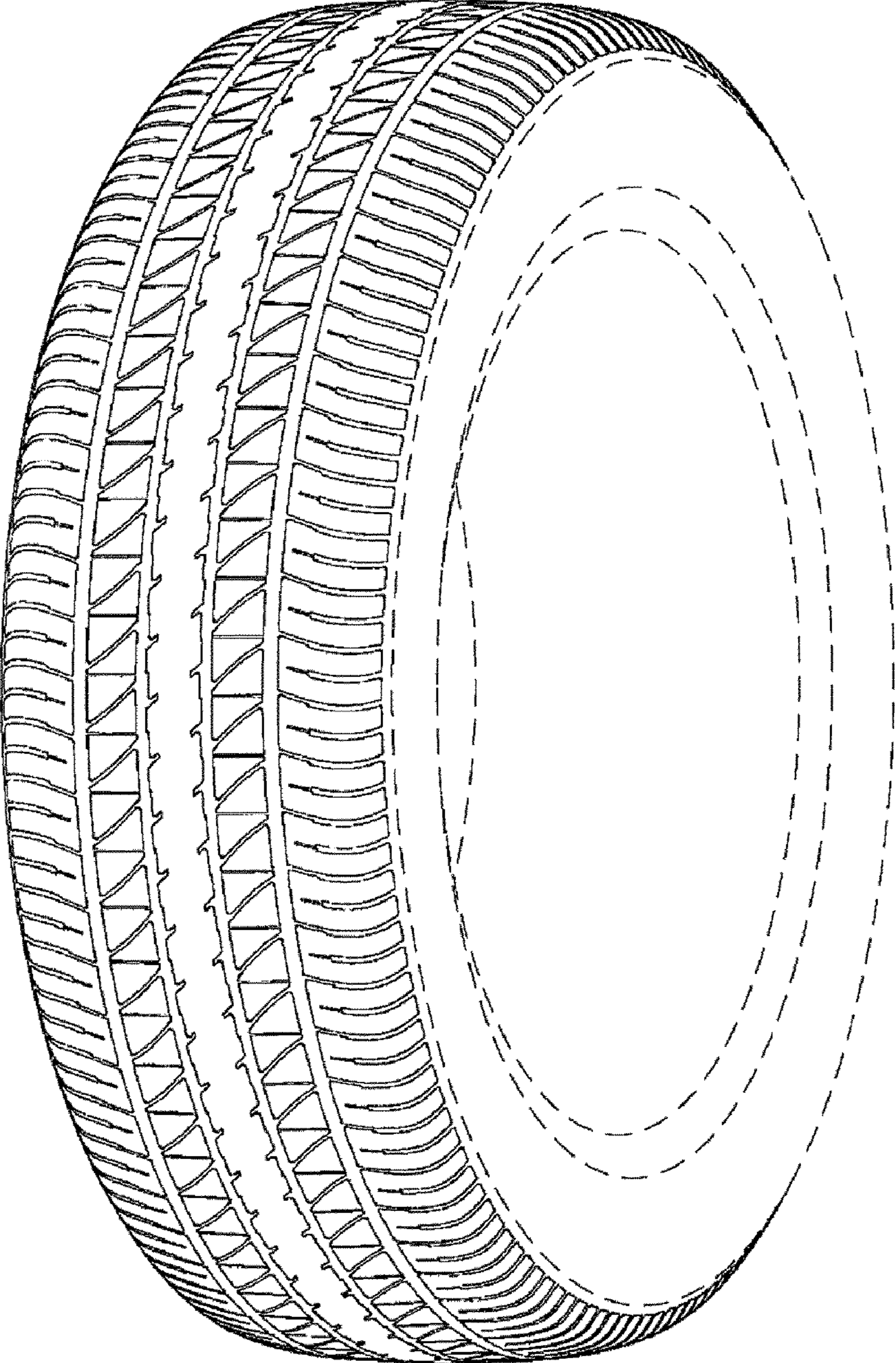

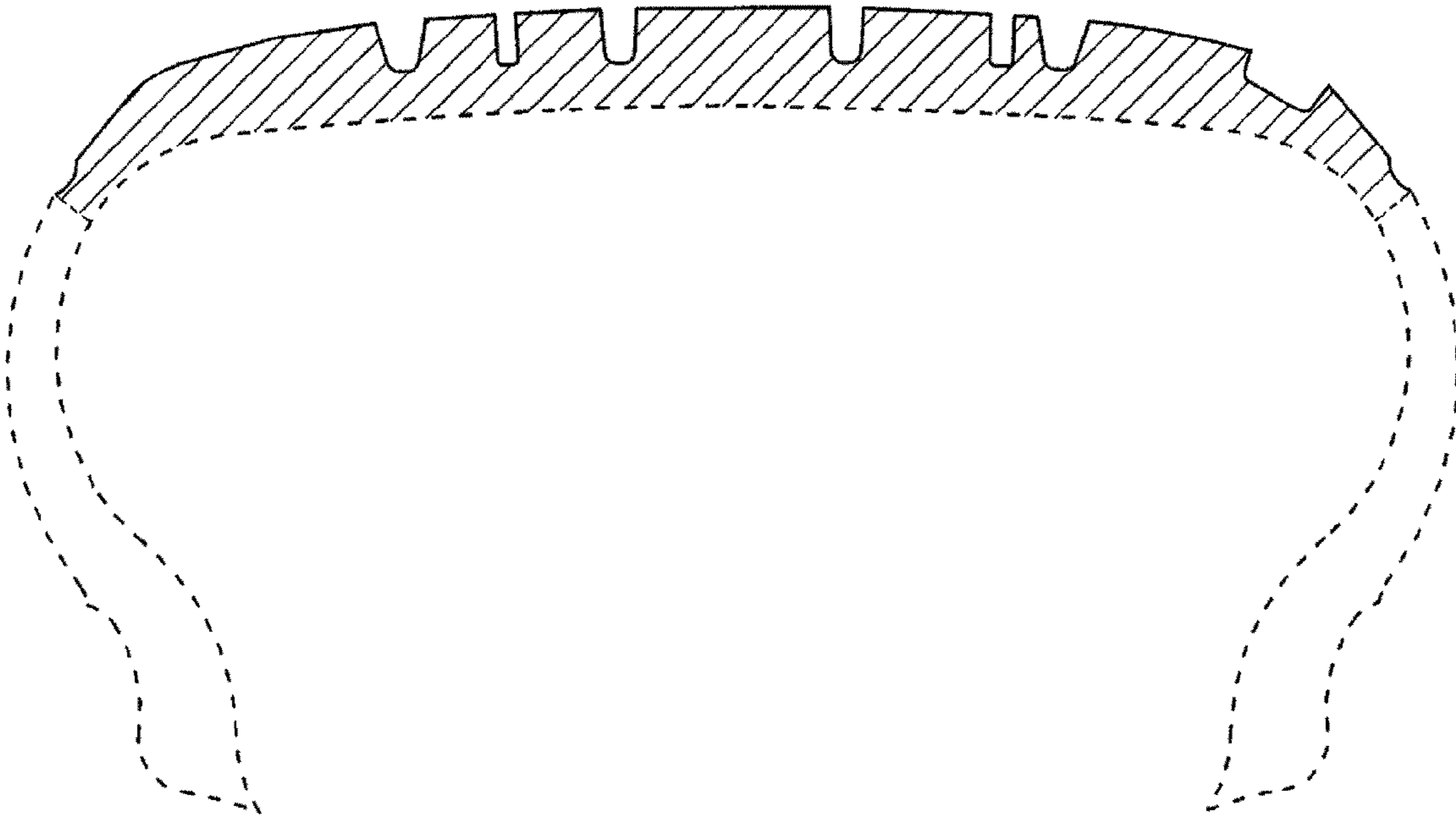

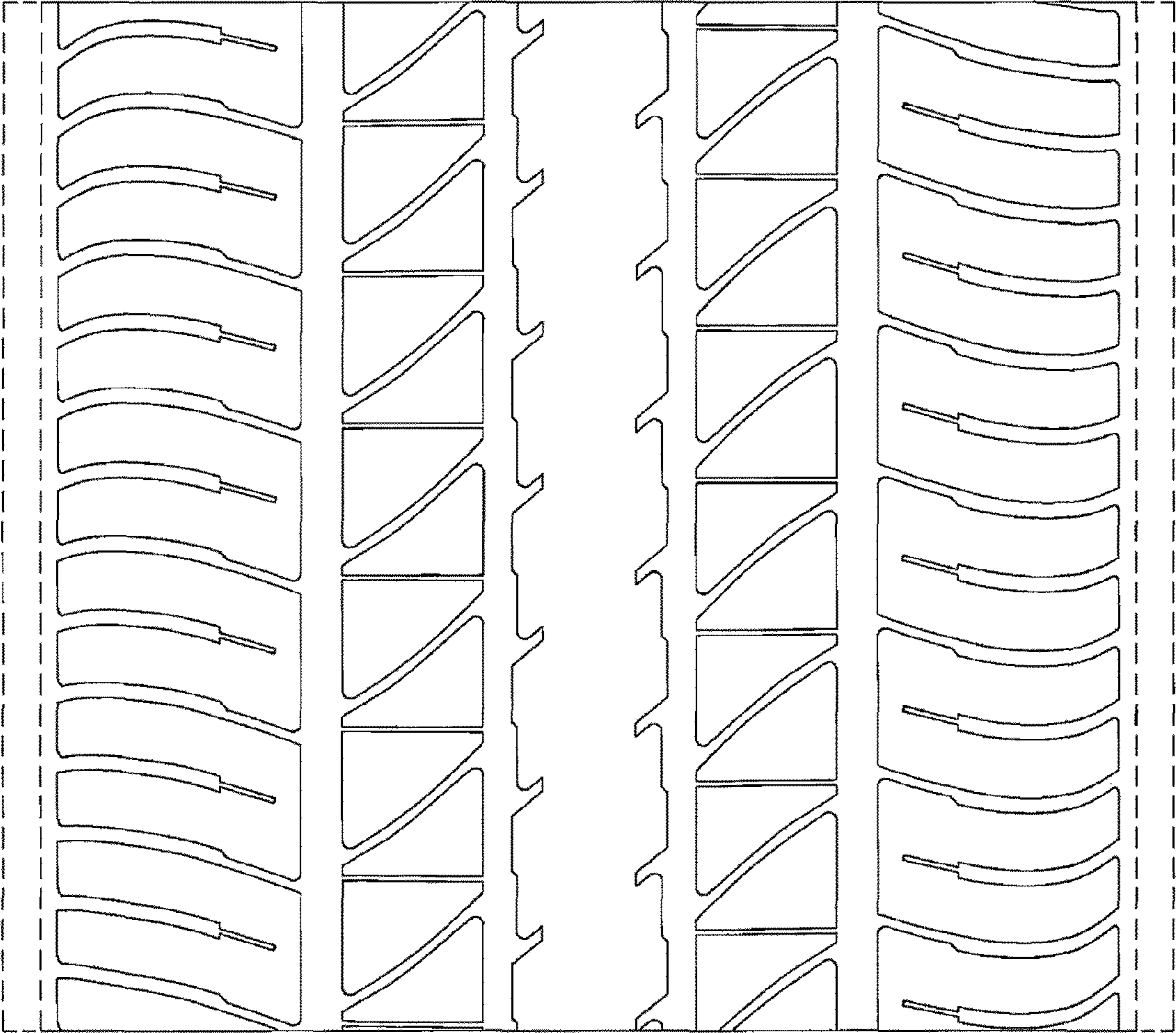
