(57) **CLAIM**

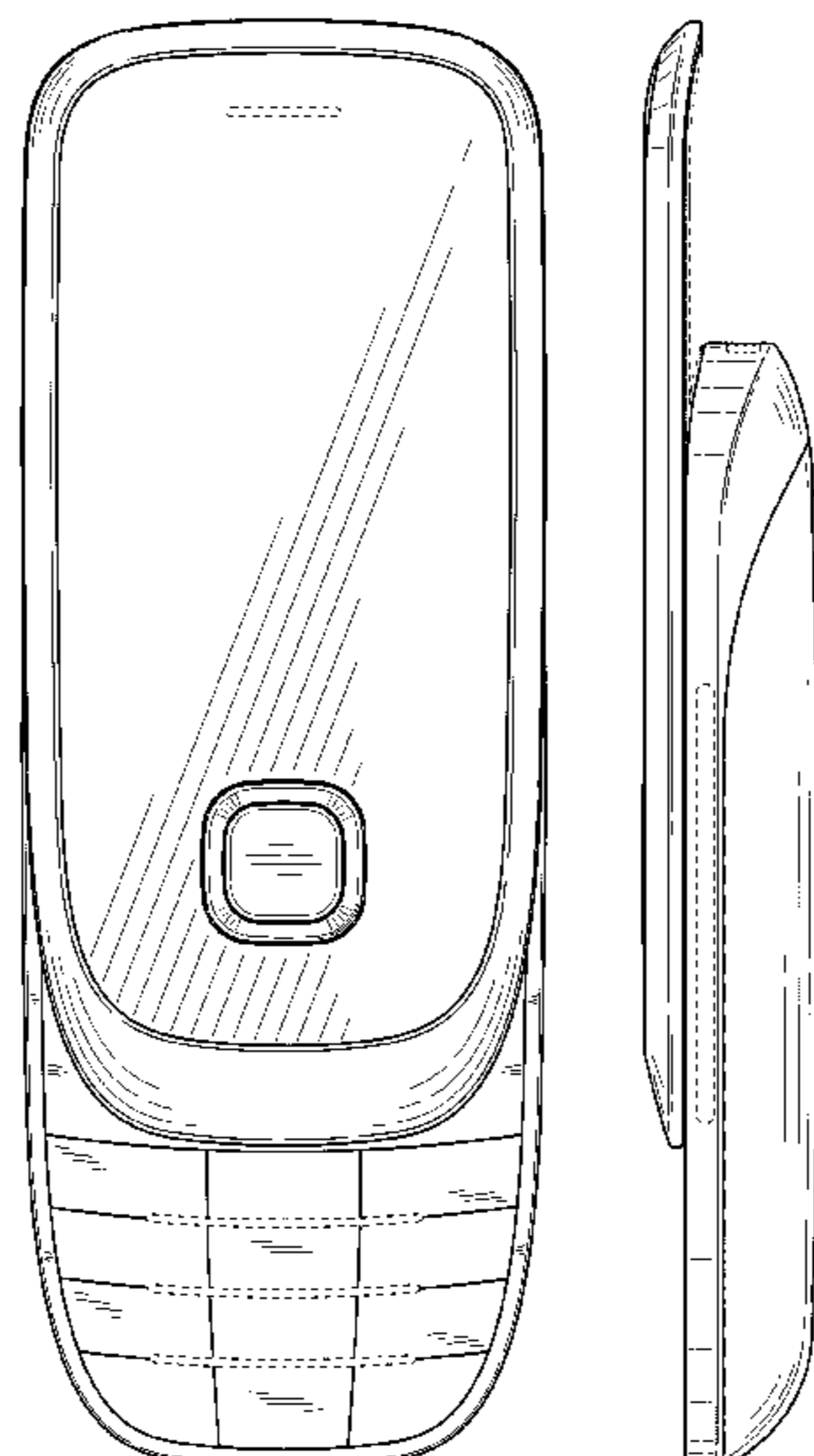
The ornamental design for a handset, as shown and described.

DESCRIPTION

FIG. 1 is a perspective front view of a first embodiment of a handset showing my new design;
FIG. 2 is a front view thereof;

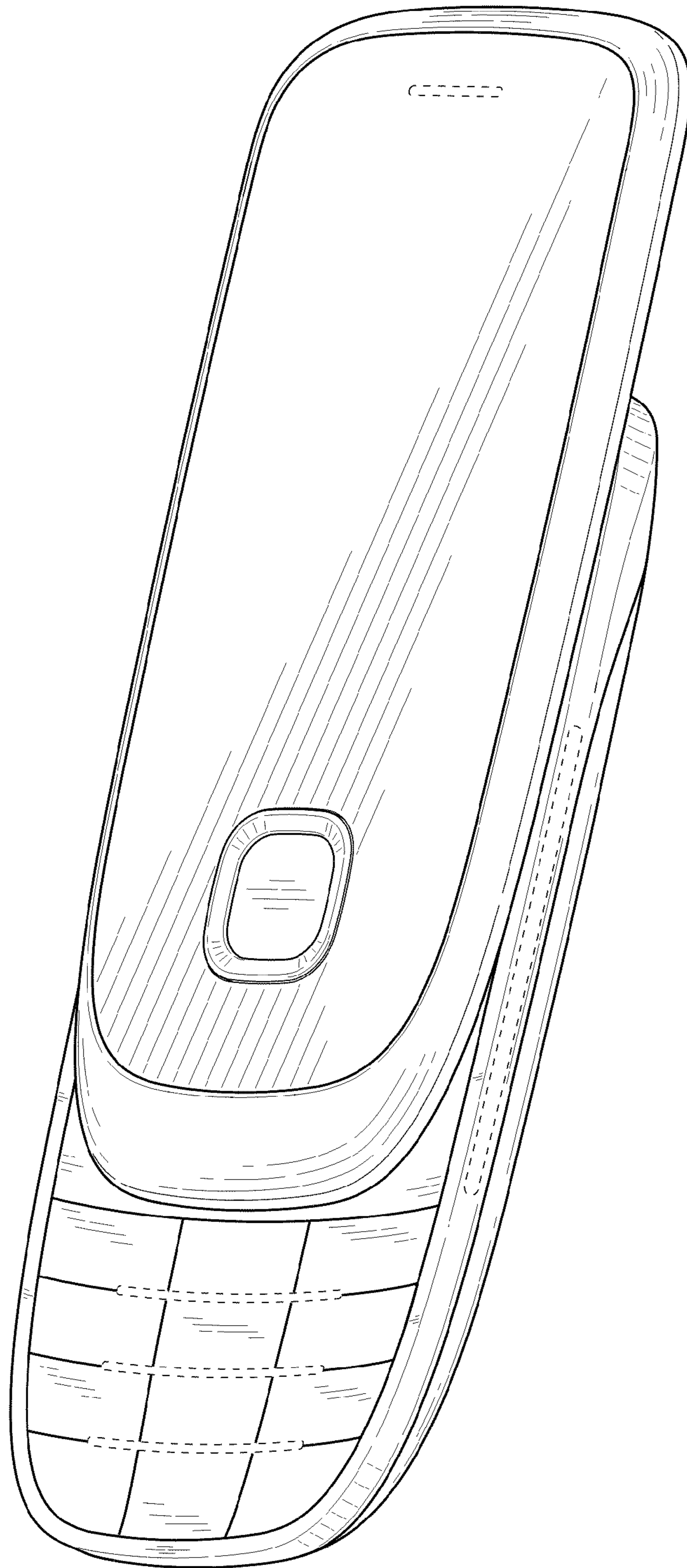

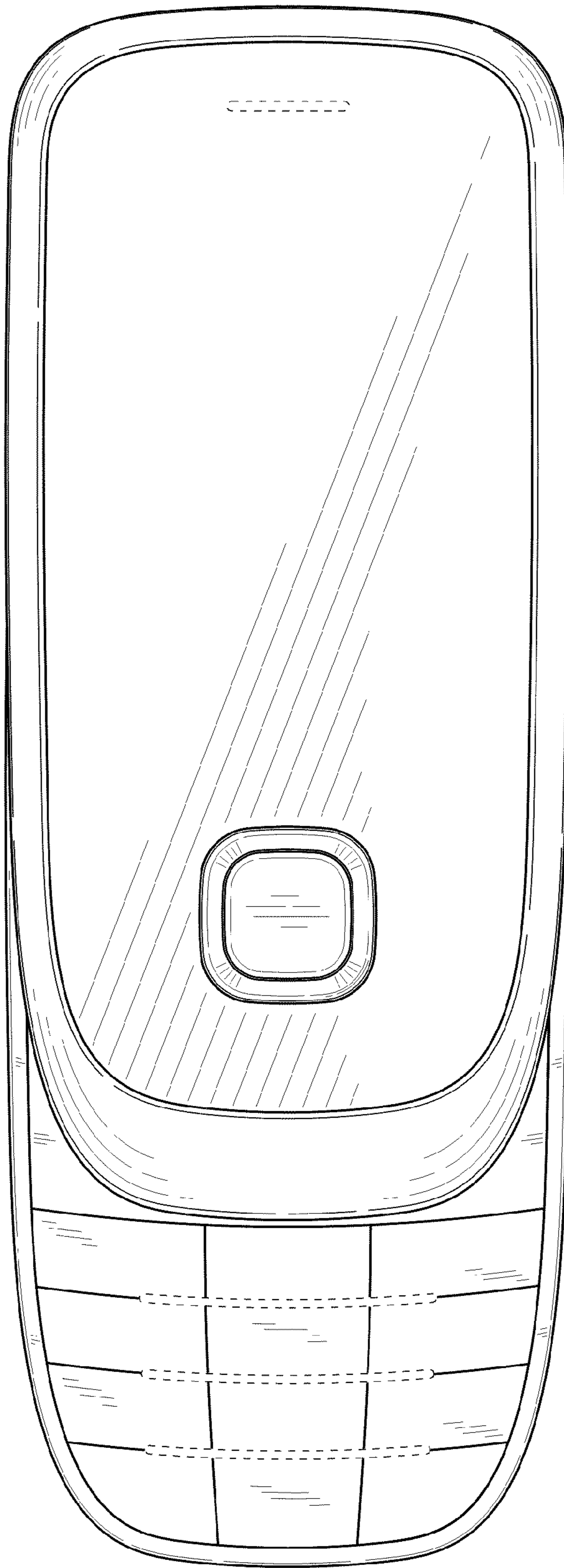

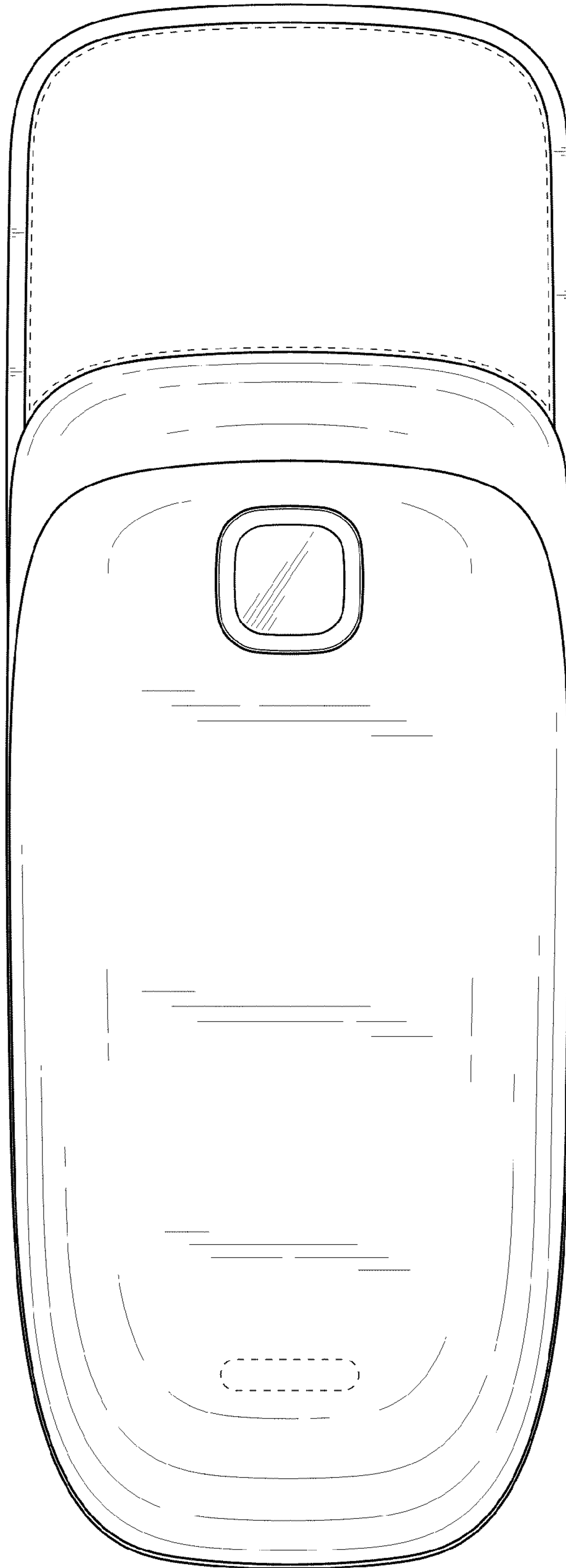

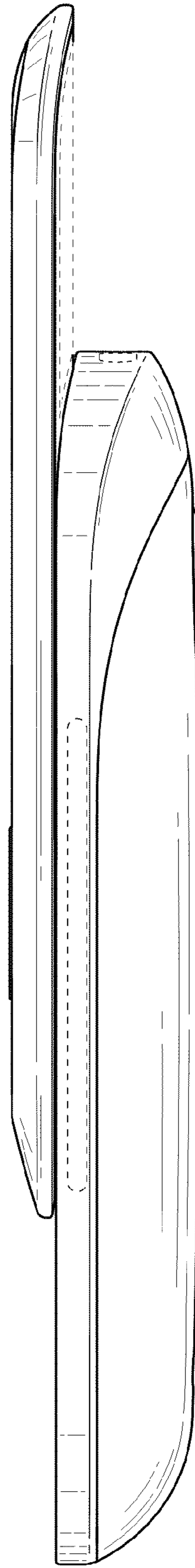

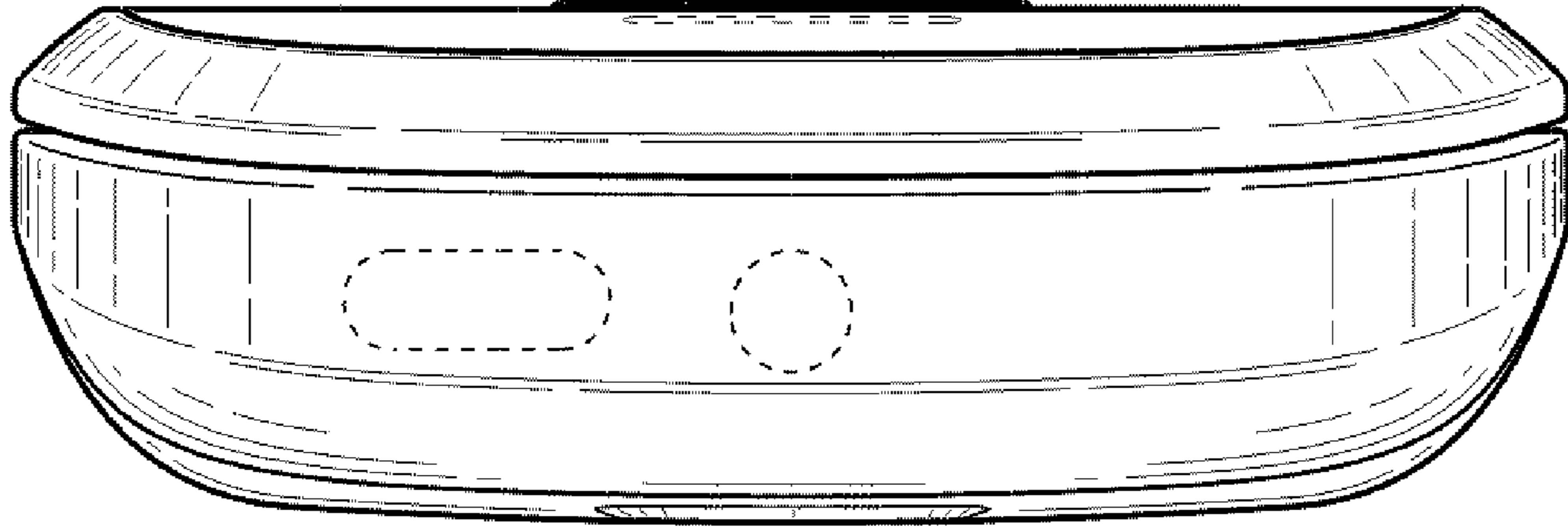

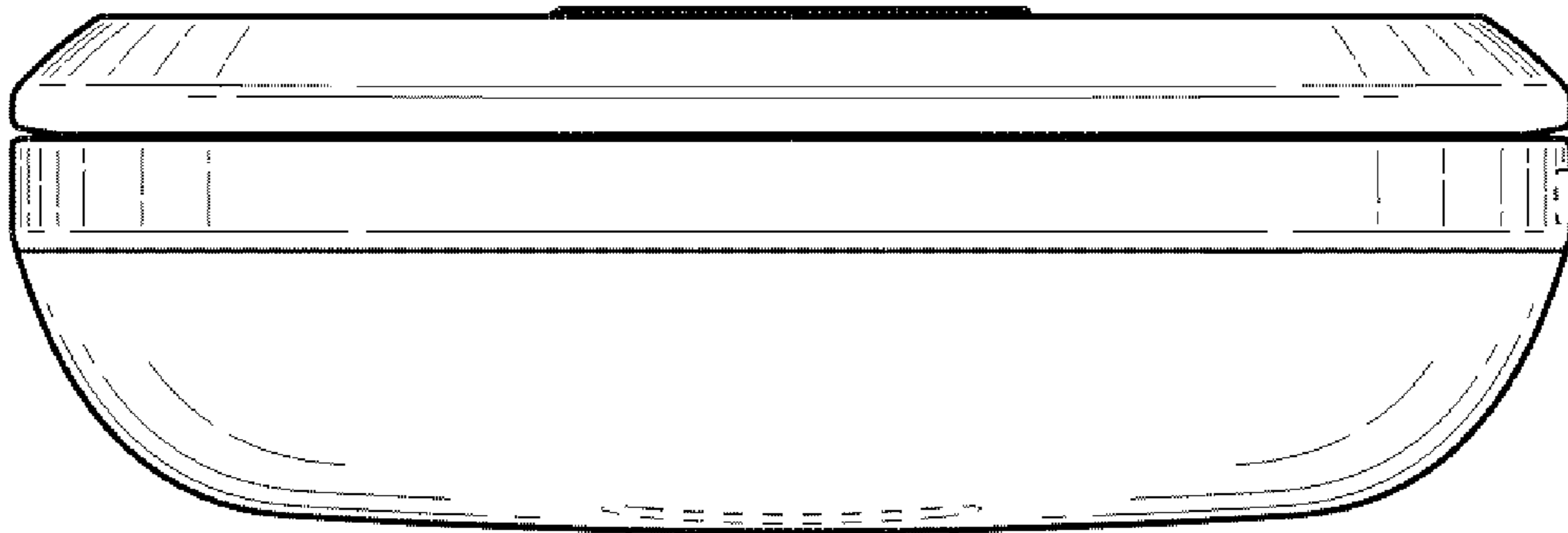
