FIG. 11 is a right side elevational view of the new design and in the second configuration;

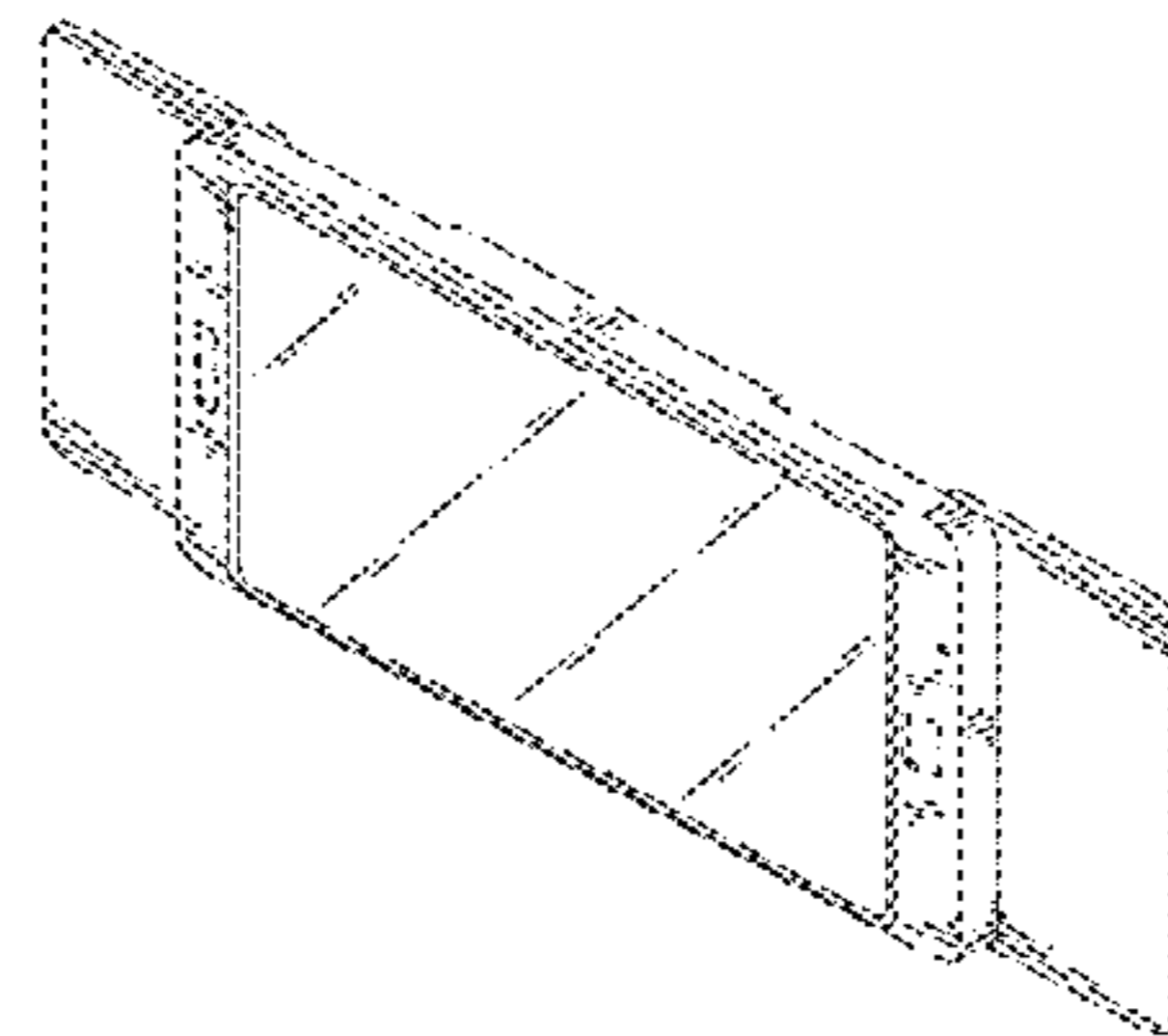
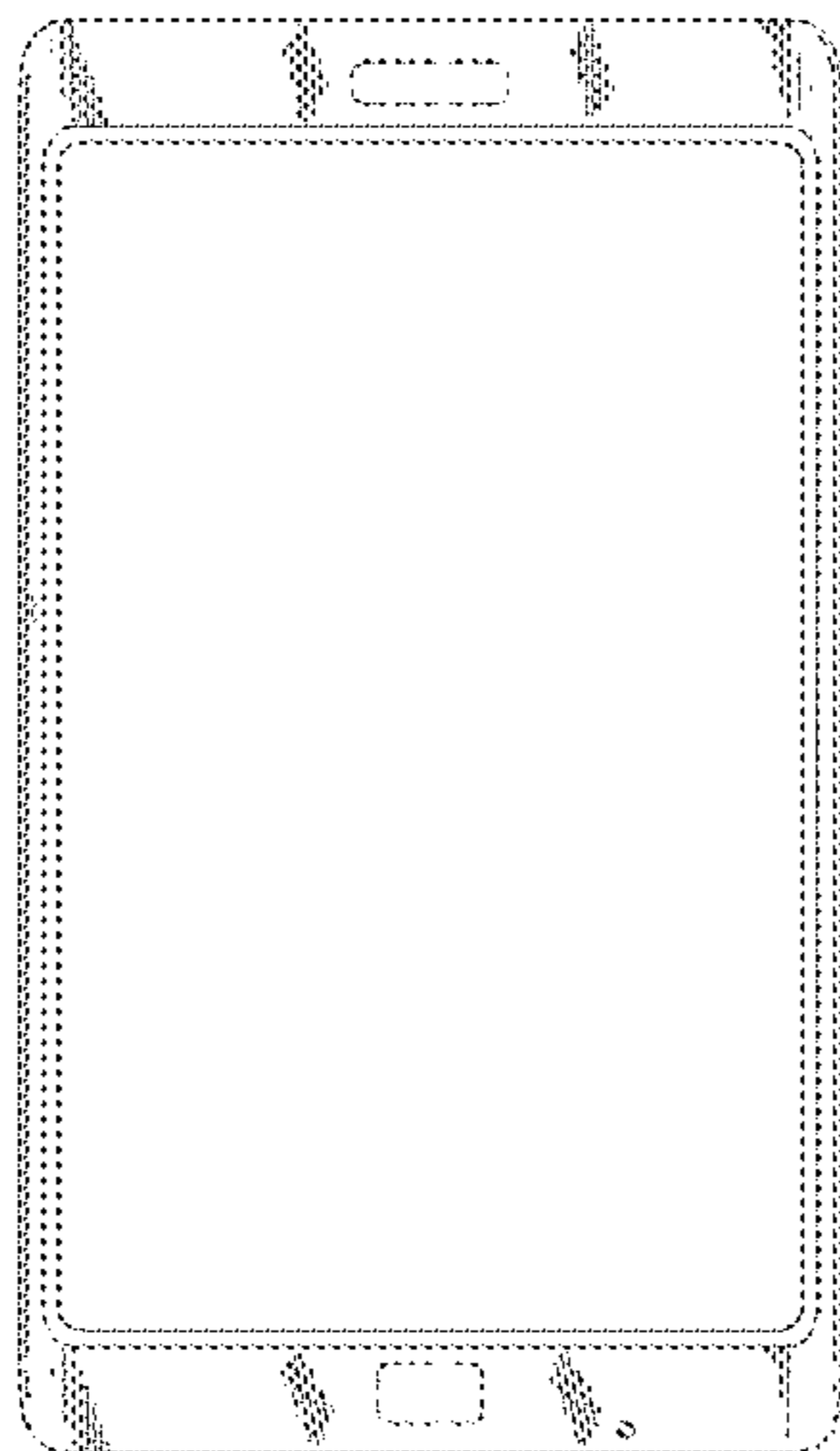
FIG. 12 is a left side elevational view of the new design and in the second configuration;

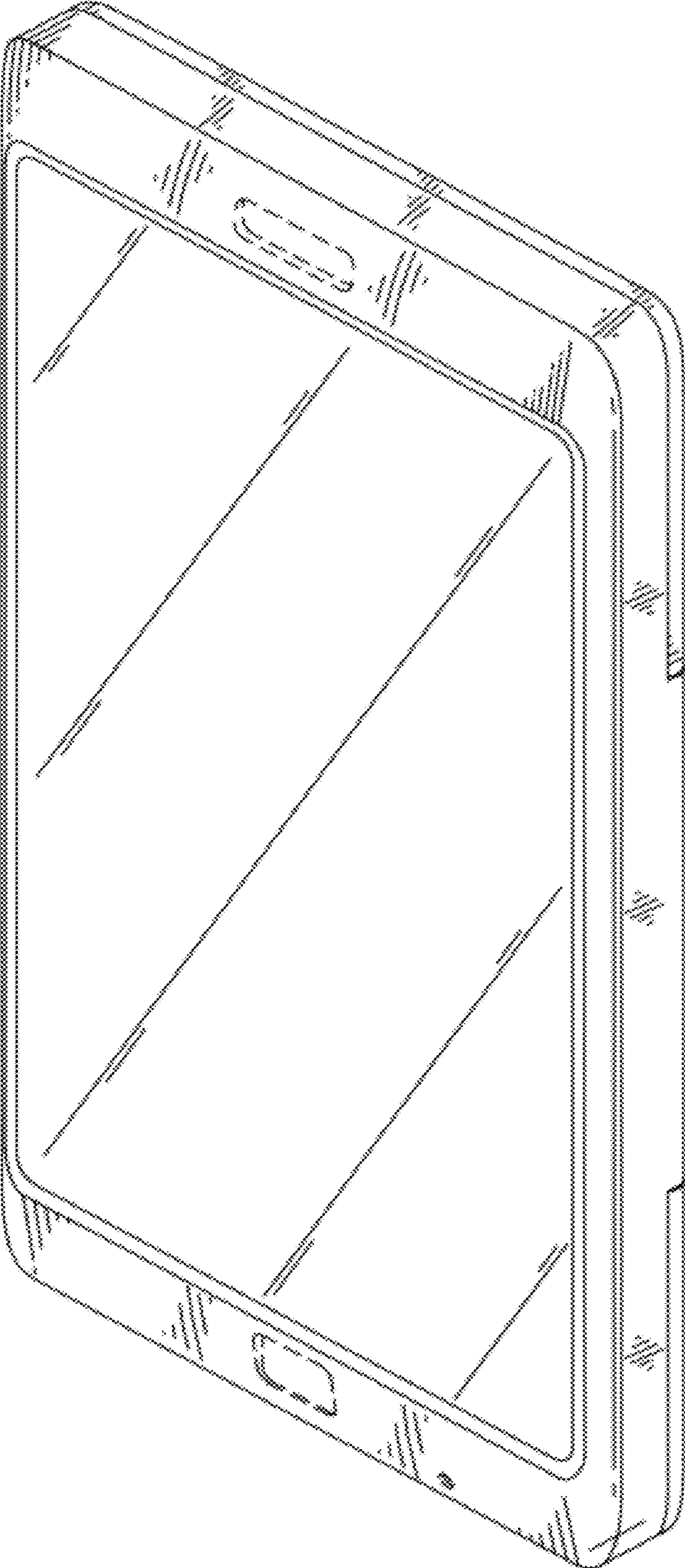

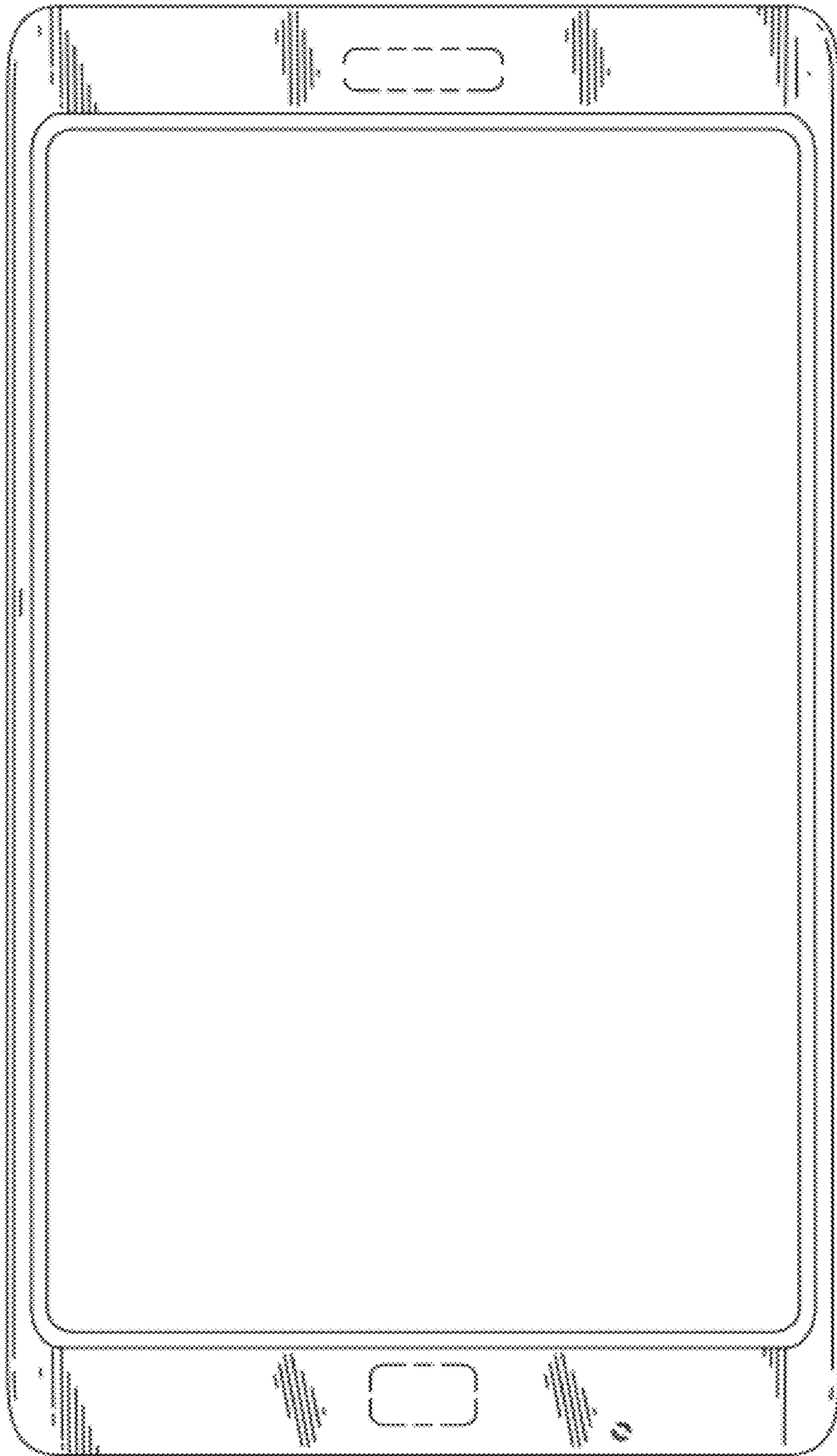

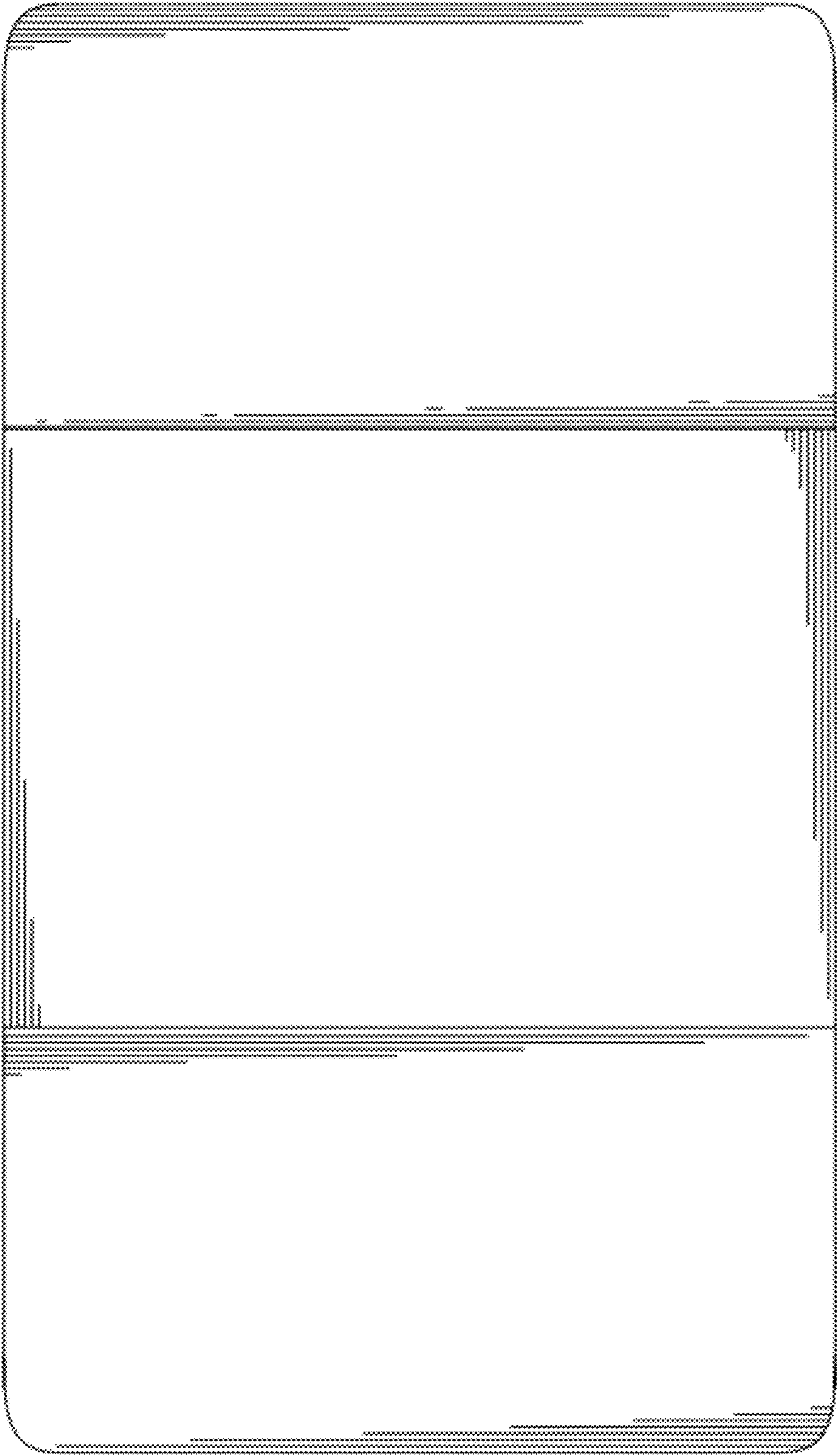

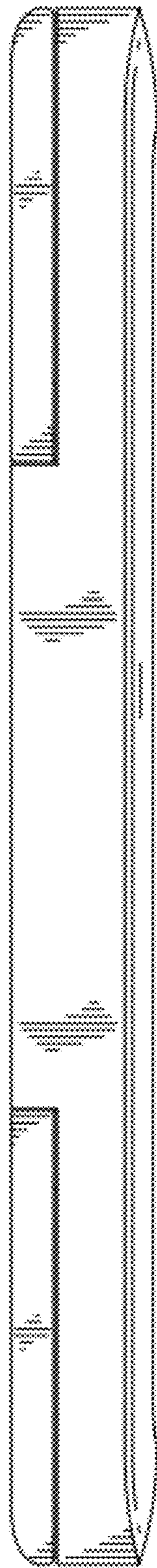

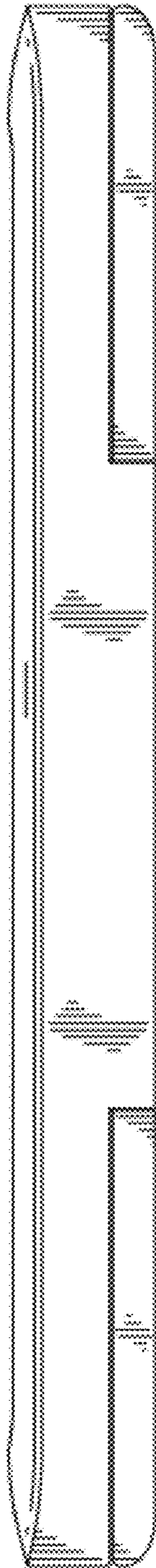

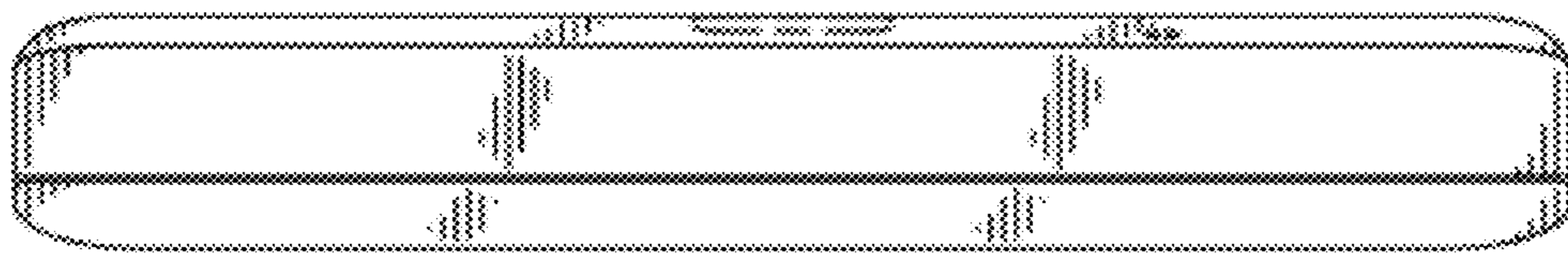

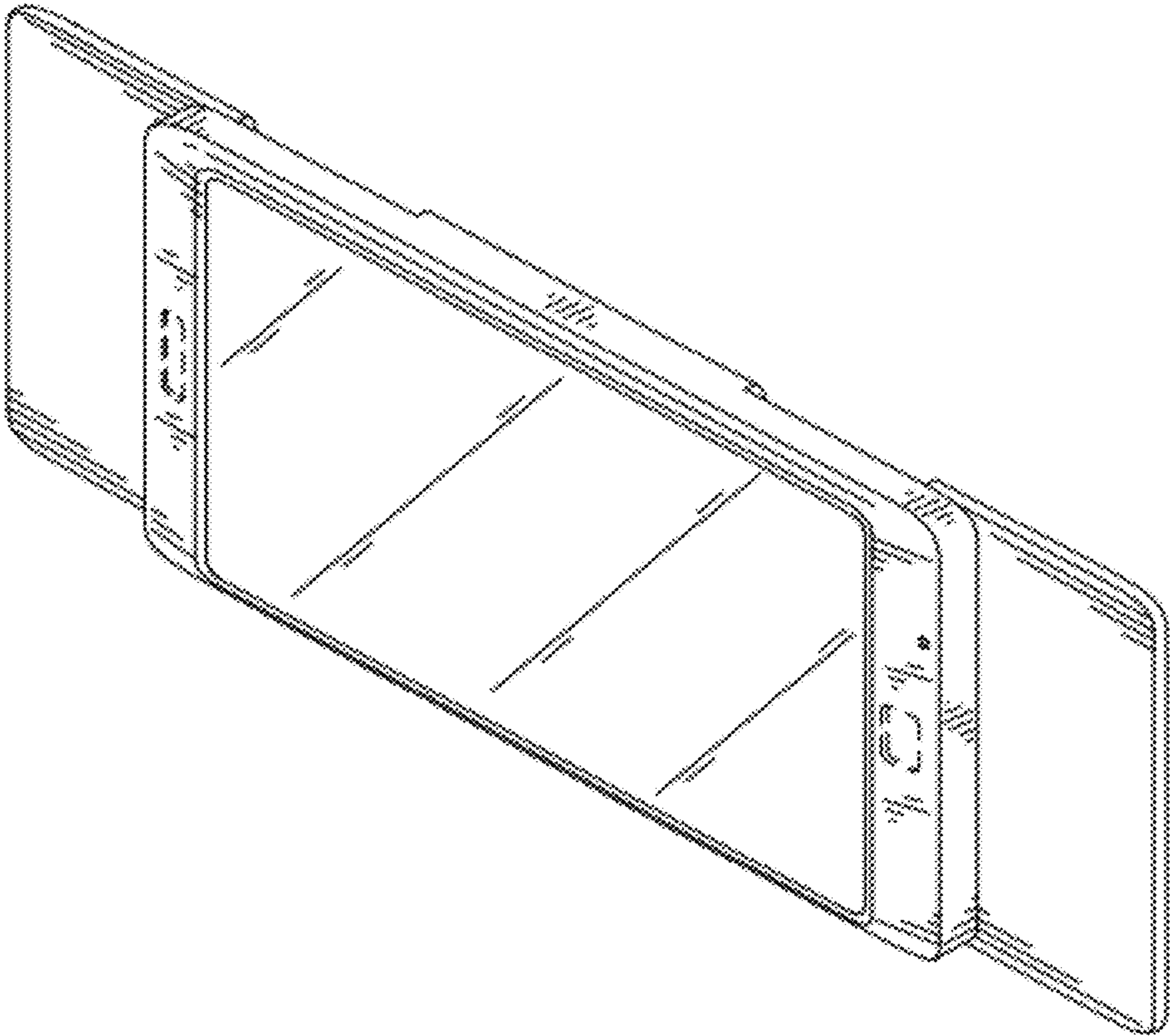

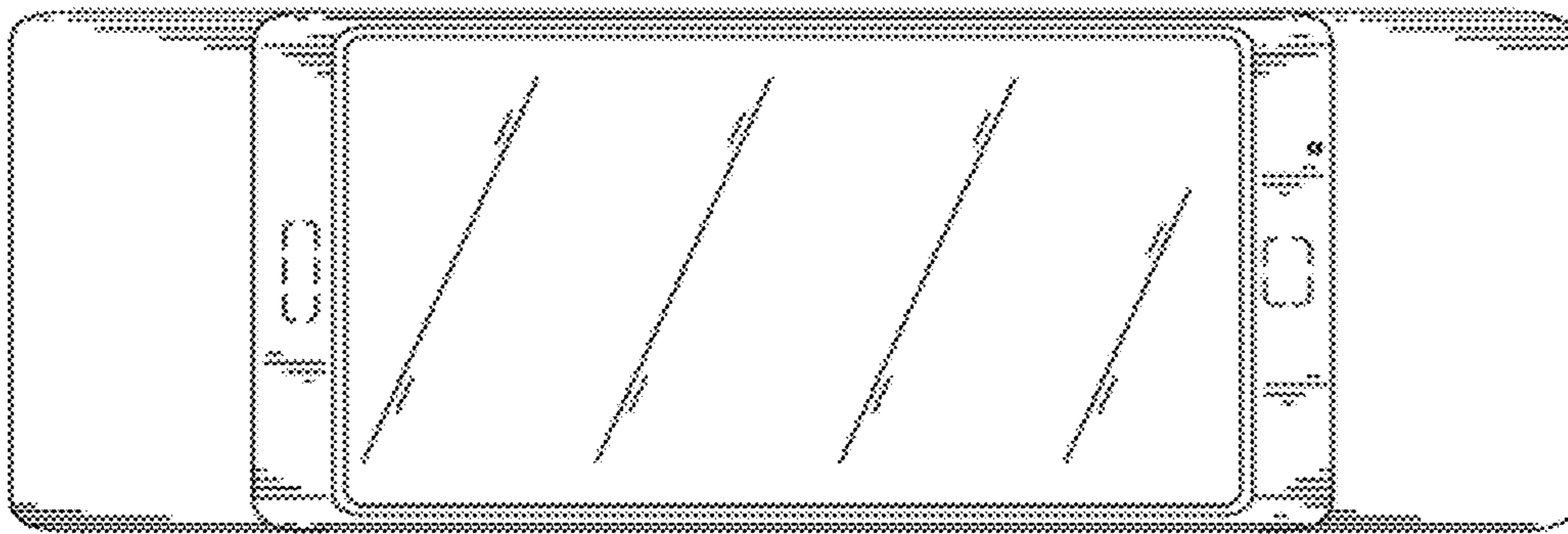

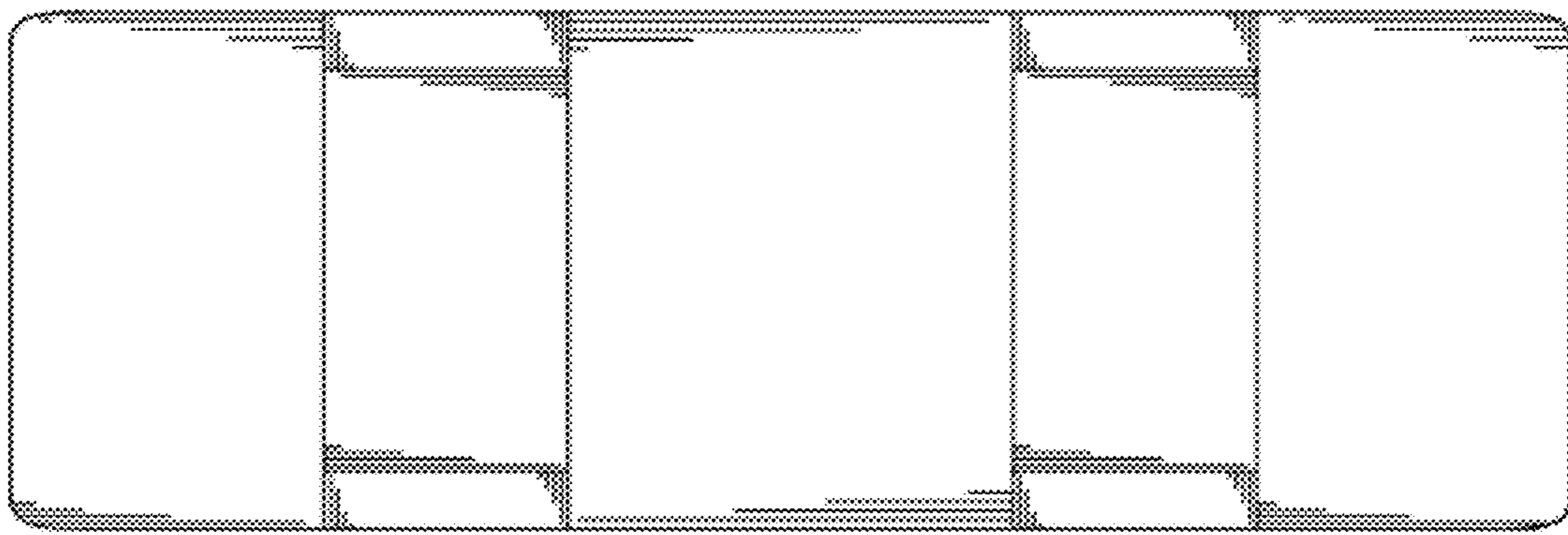

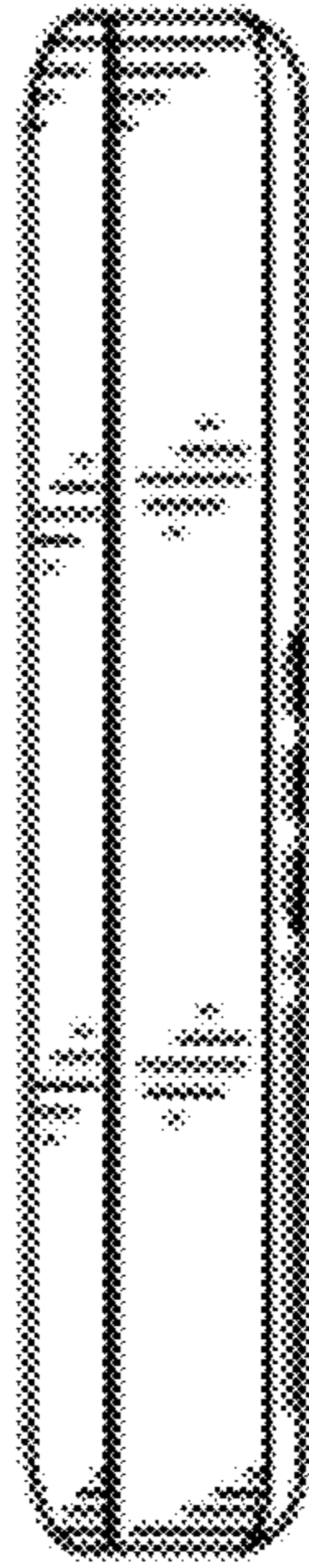

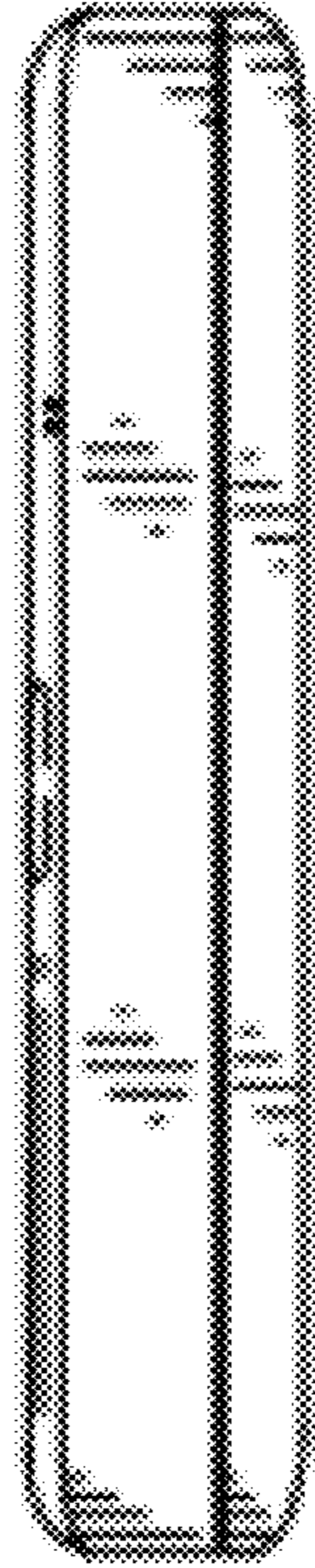

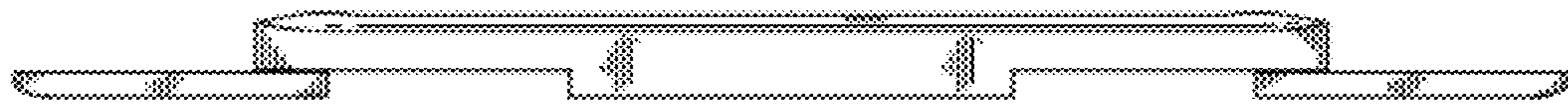
