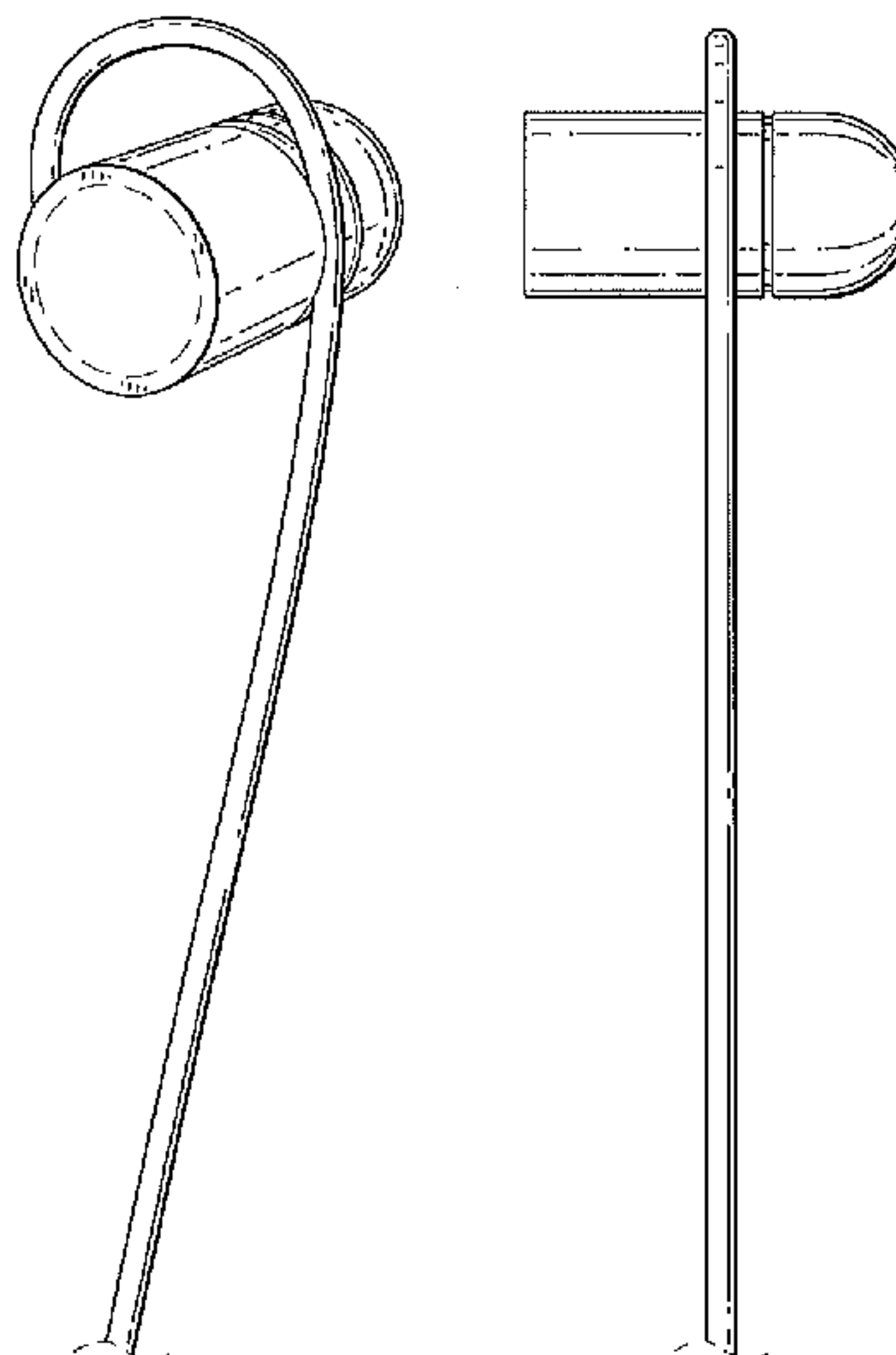
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of an earphone showing our new design, the earphone tip is not part of the claimed design; FIG. 2 is a front elevational view thereof. 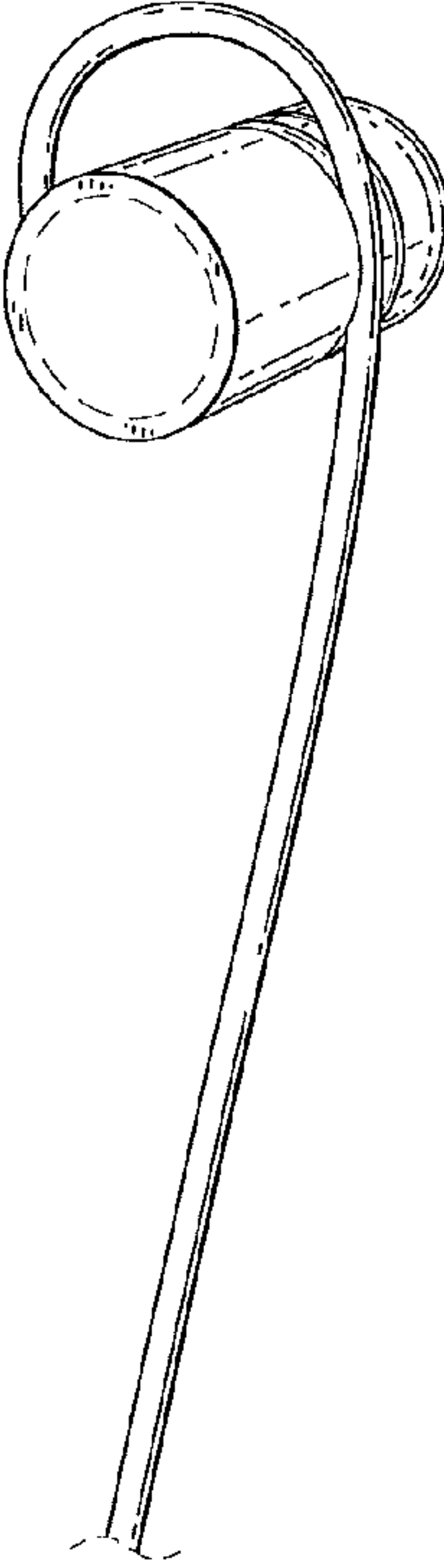

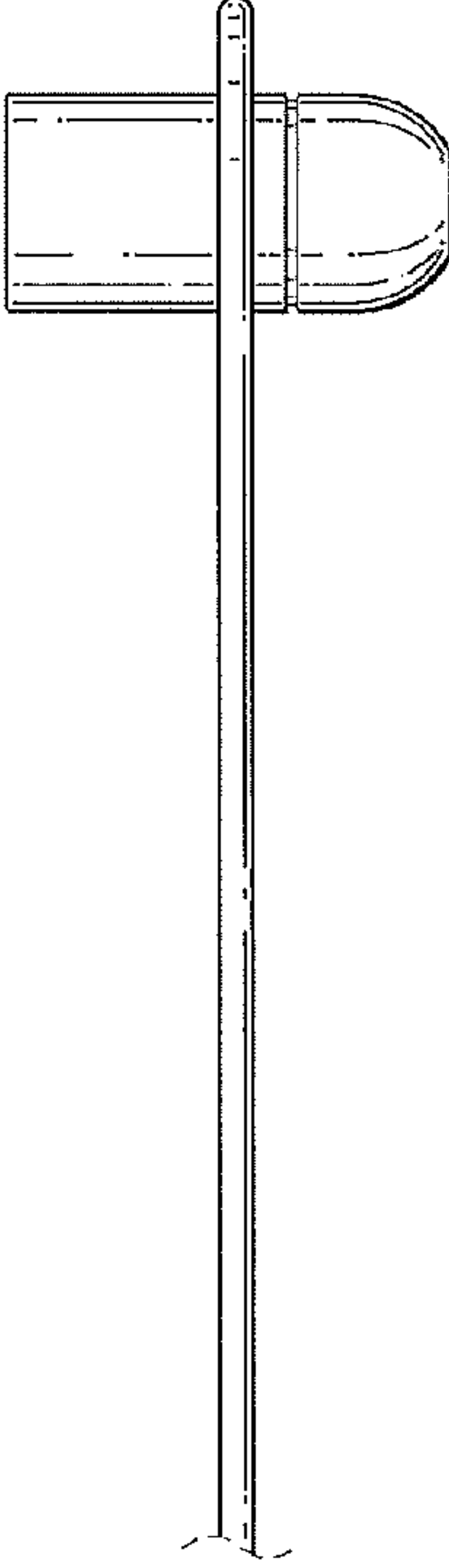

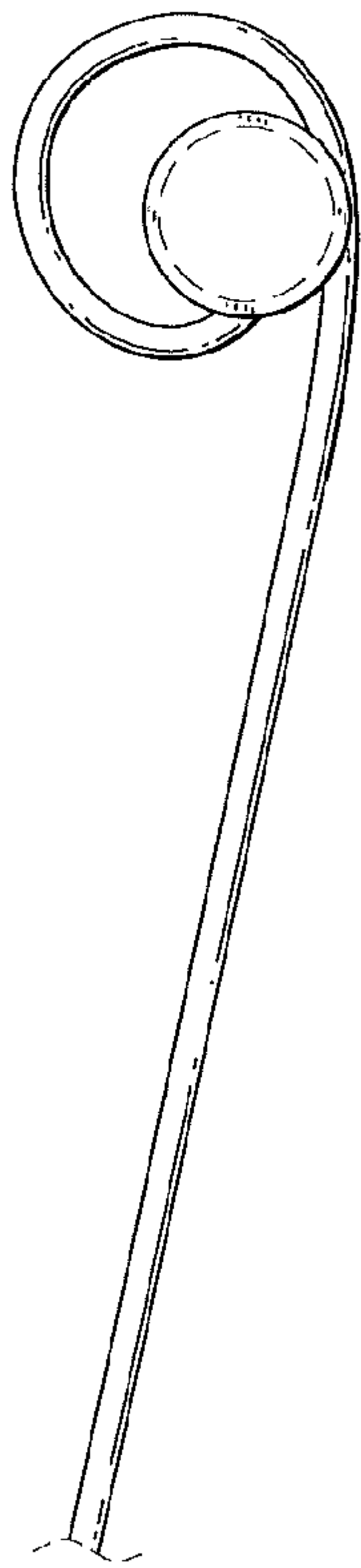

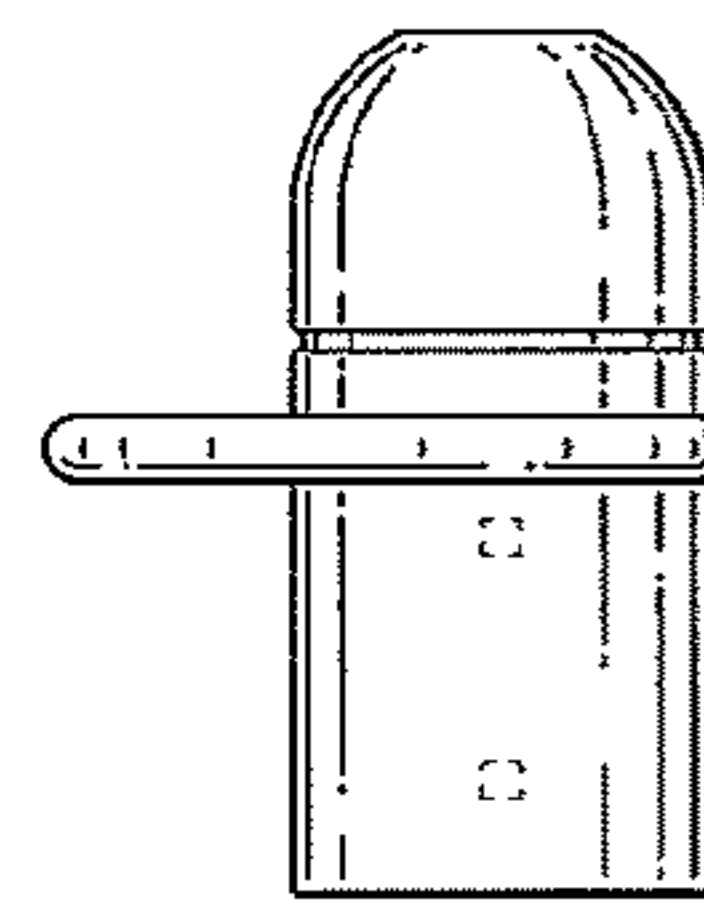
