 FIG. 8 is an enlarged cross-sectional view taken along line 8-8 in FIG. 2.

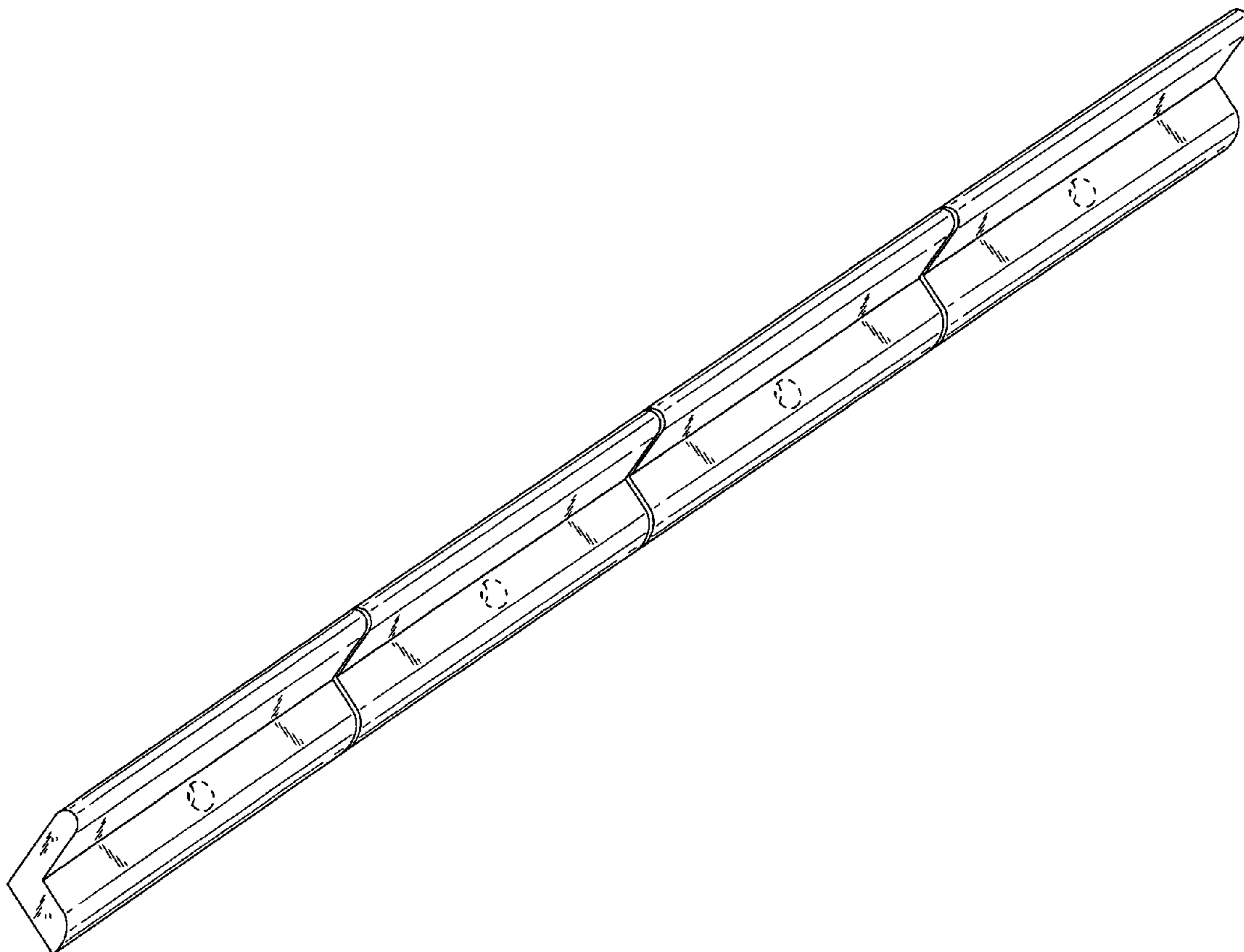
The broken line showing of the flexible landscape edging is for the purpose of illustrating a hole and forms no part of the claimed design.

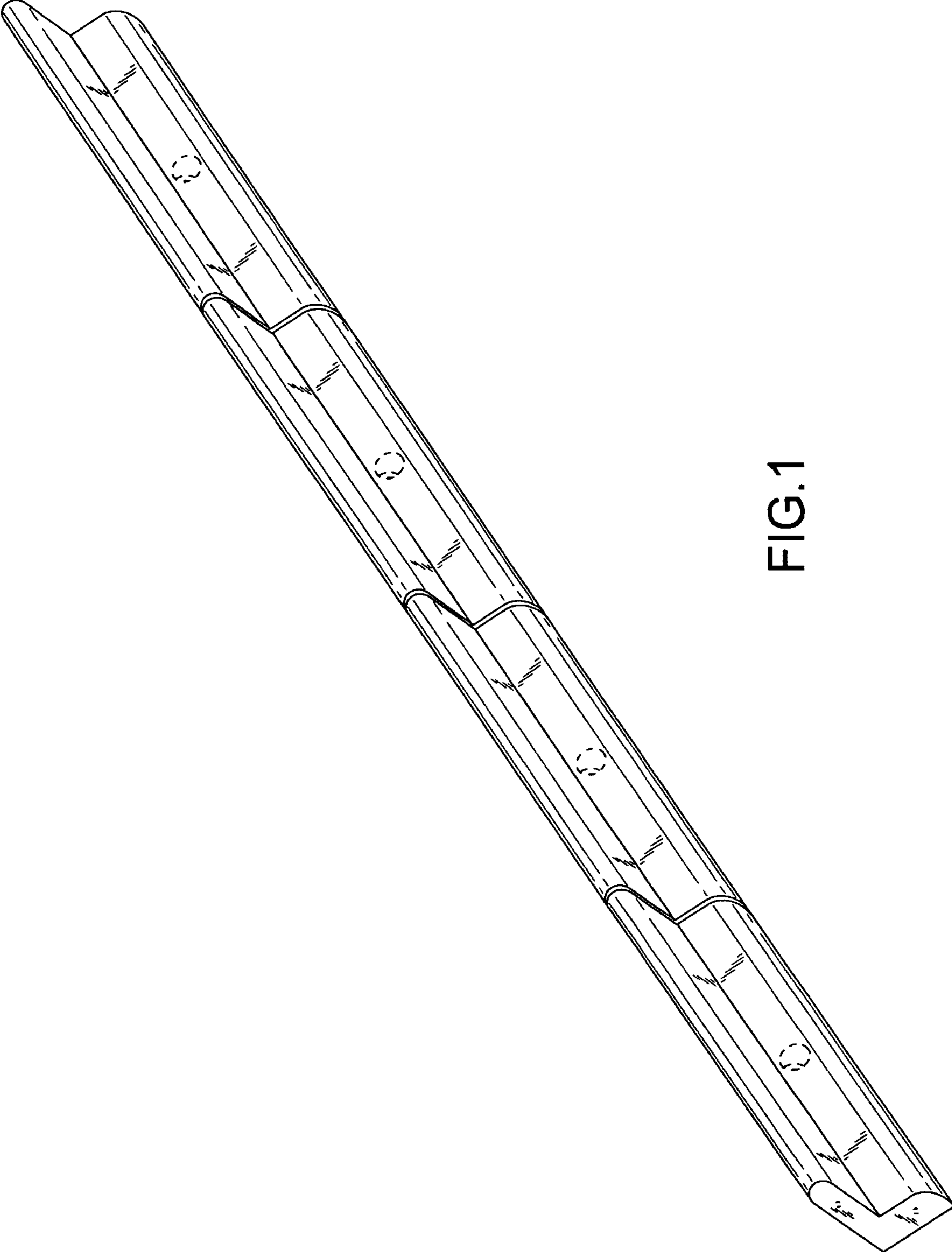

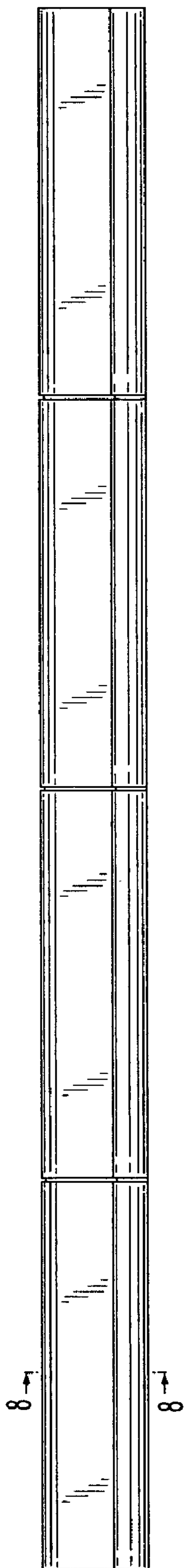

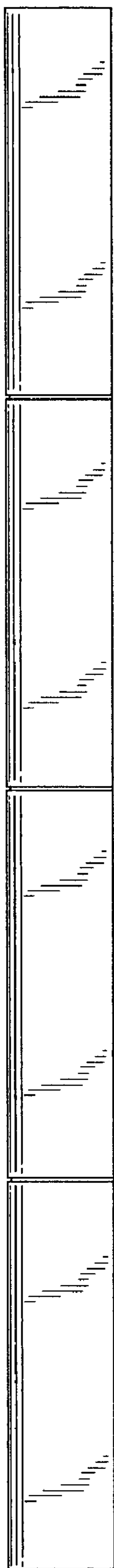

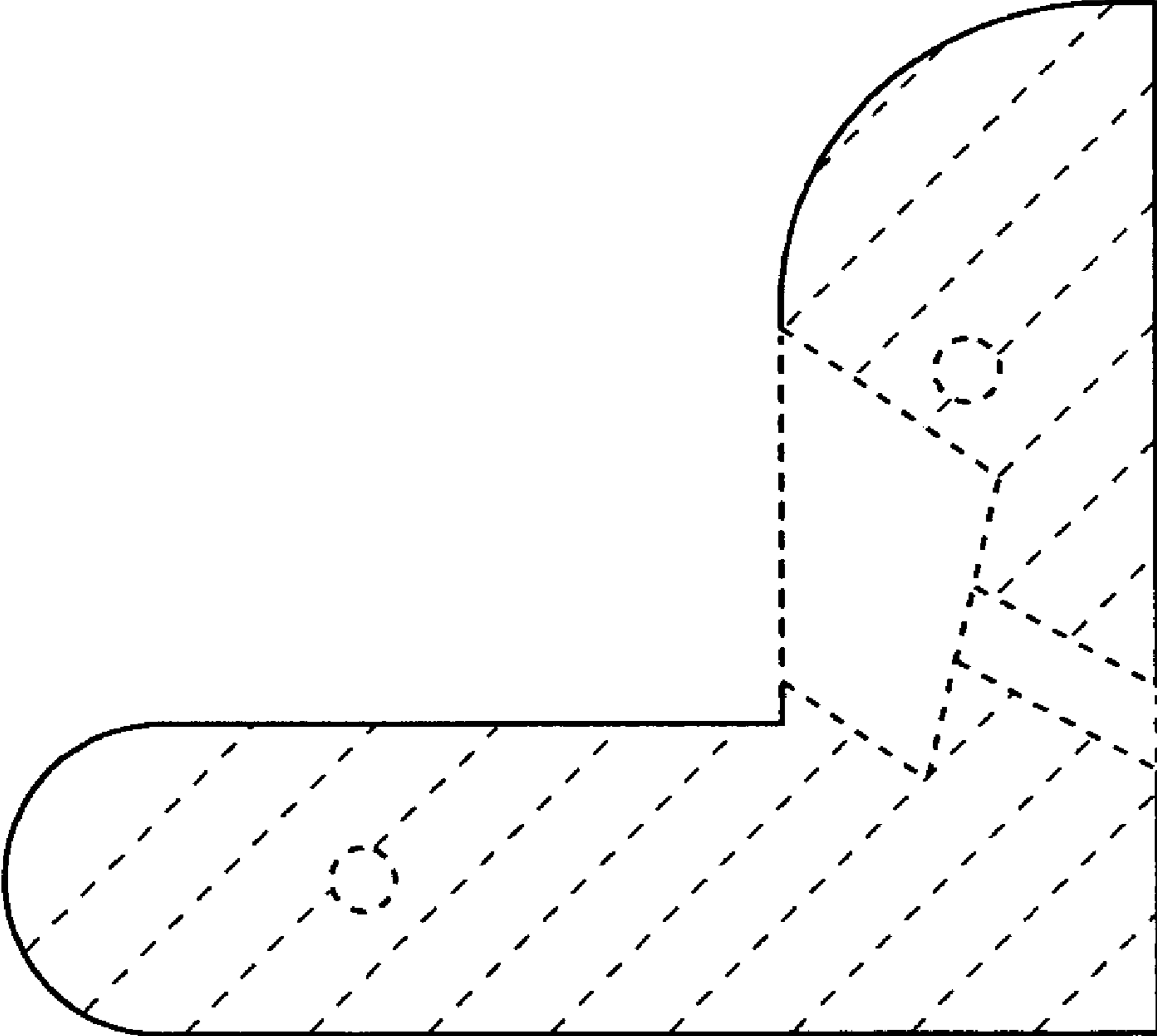
