(57) **CLAIM**

The ornamental design for a fabric care device, substantially as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a fabric care device from a first end of the fabric care device;

FIG. 2 is a top perspective view from the second end of the fabric care device;

FIG. 3 is a bottom perspective view of the fabric care device;

FIG. 4 is a first end view of the fabric care device;

FIG. 5 is a second end view of the fabric care device;

FIG. 6 is a side view of the fabric care device;

FIG. 7 is another side view of the fabric care device;

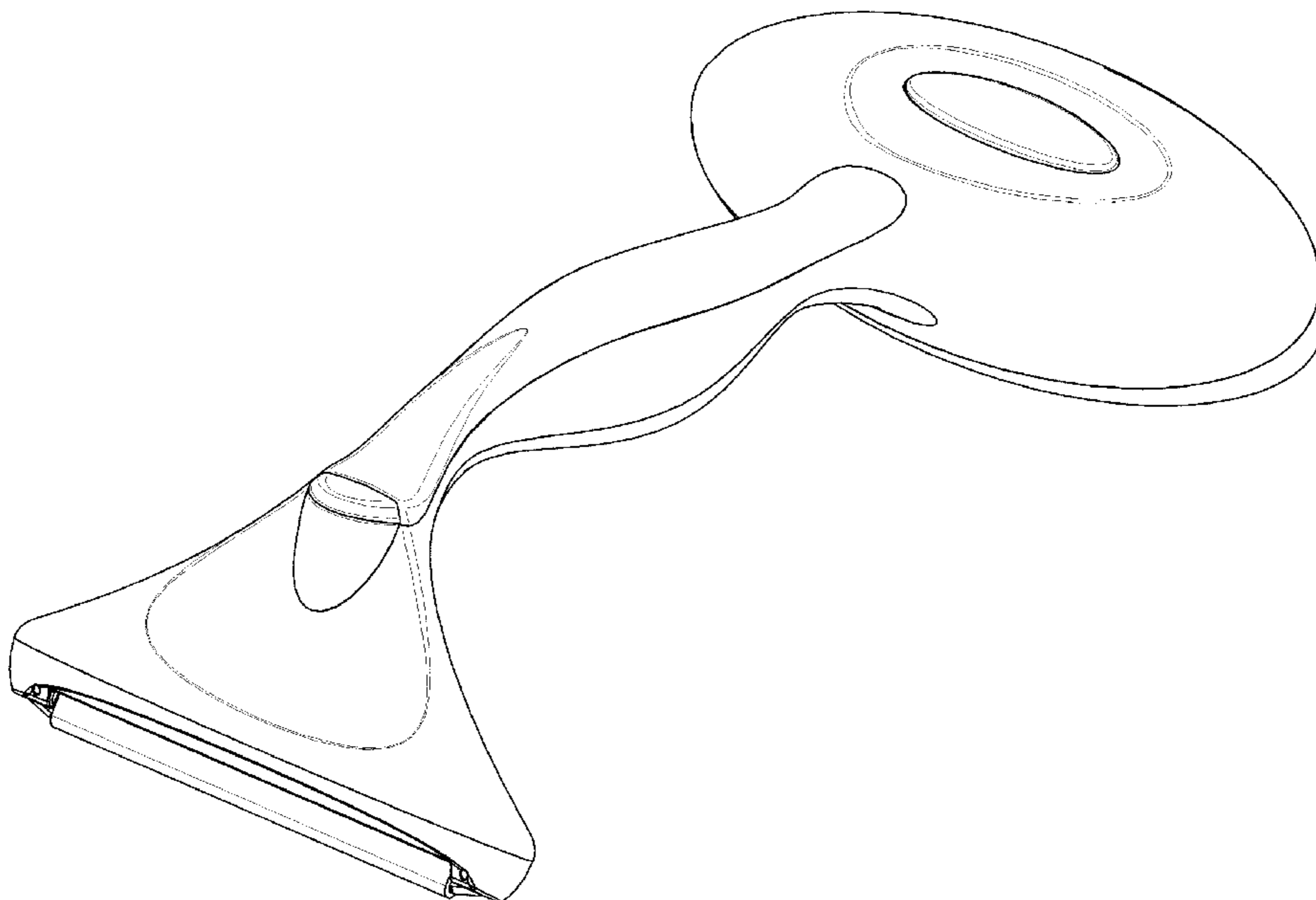
FIG. 8 is a top plan view of the fabric care device;

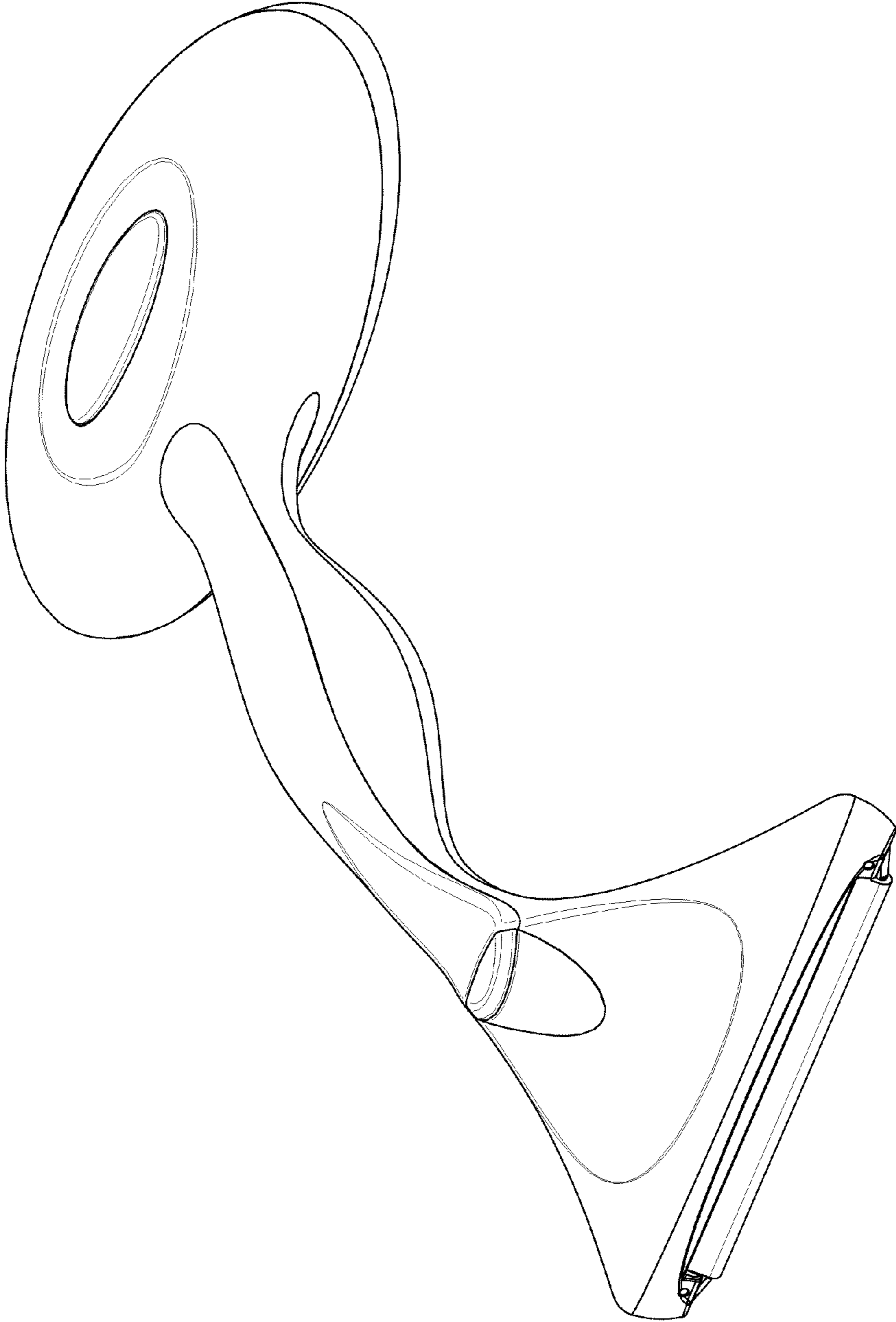

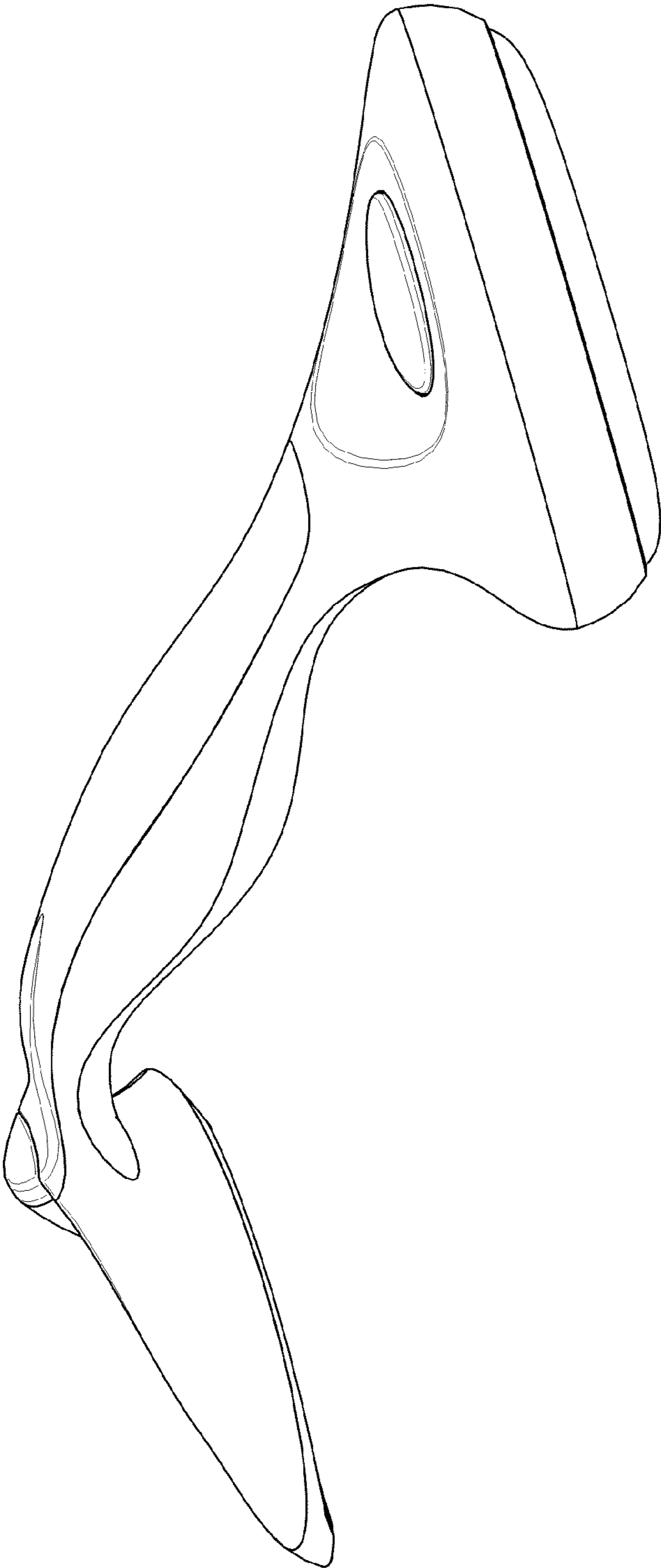

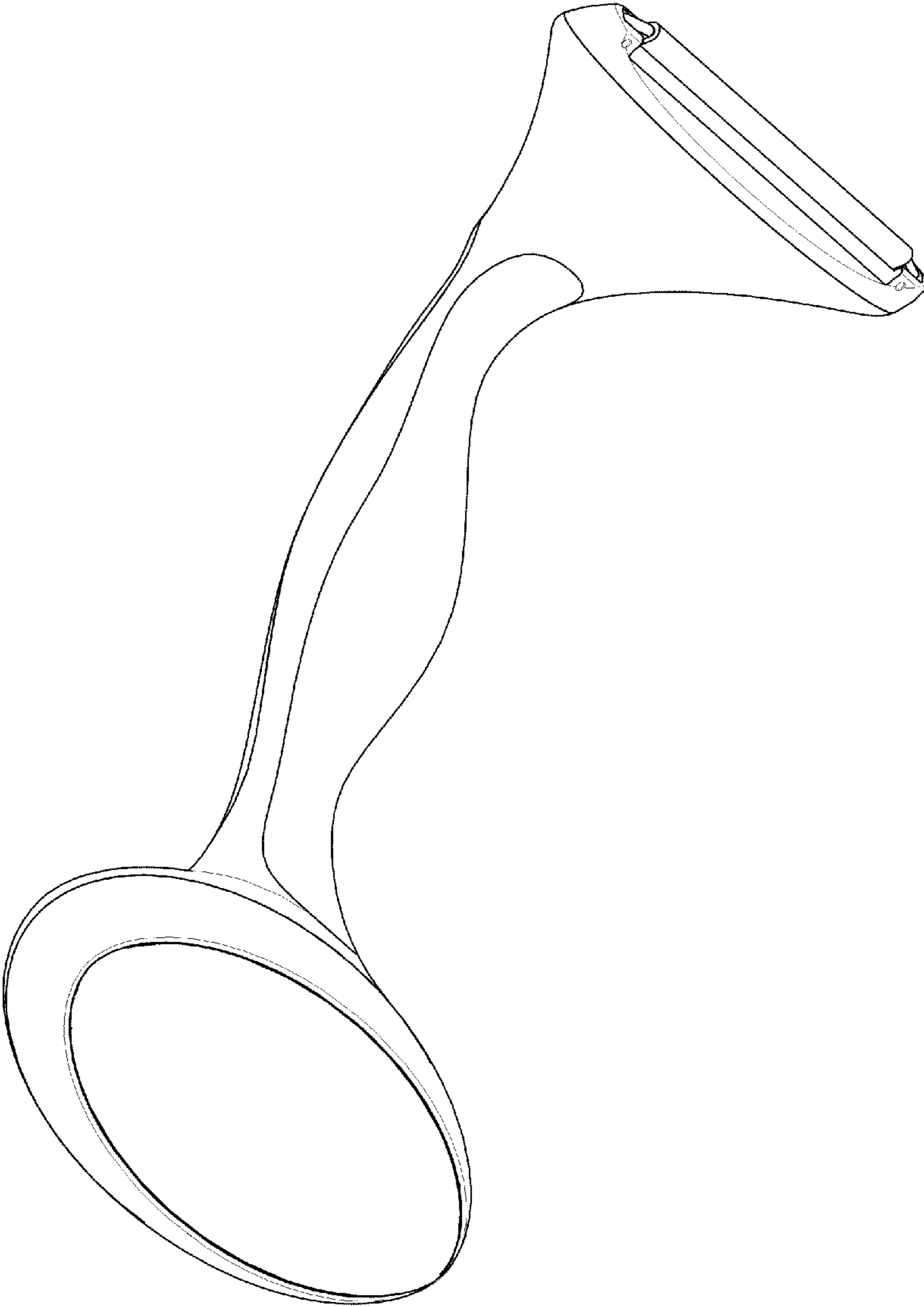

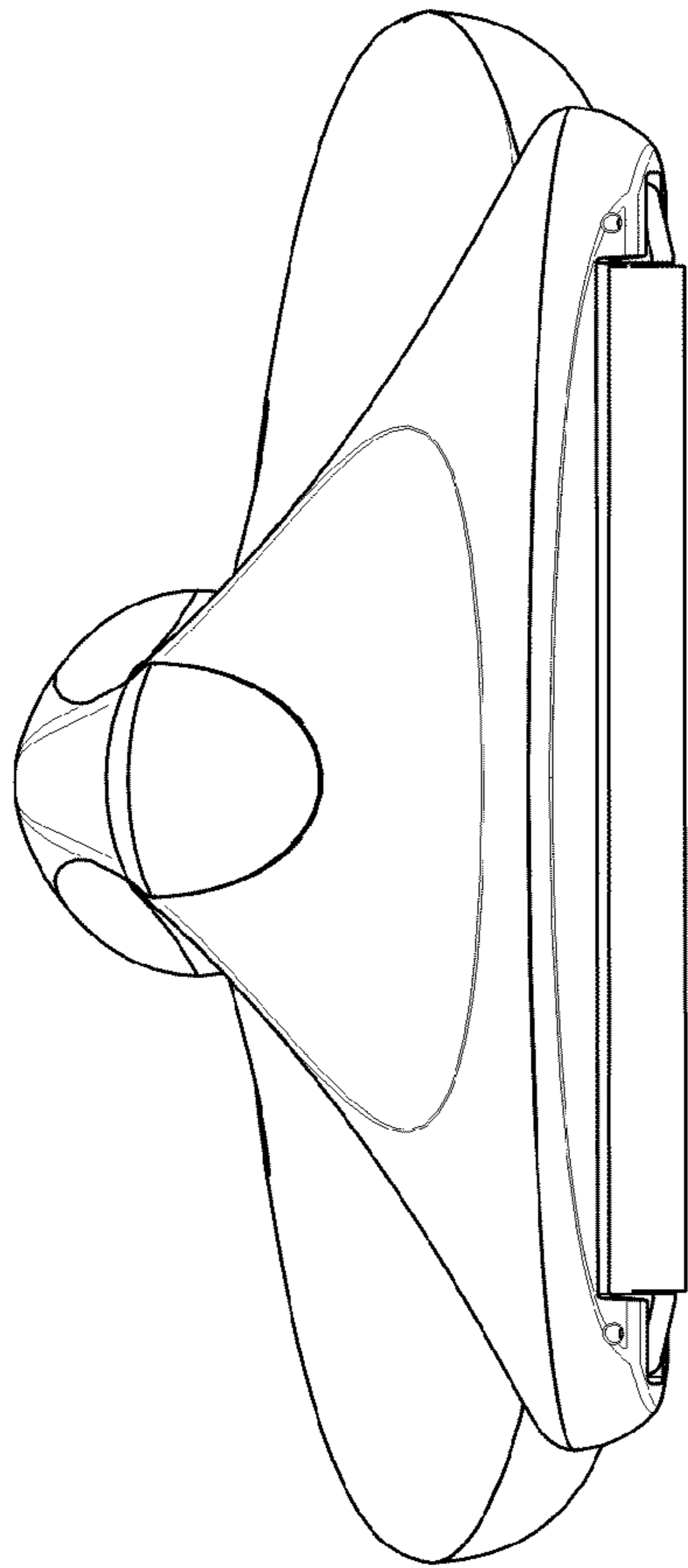

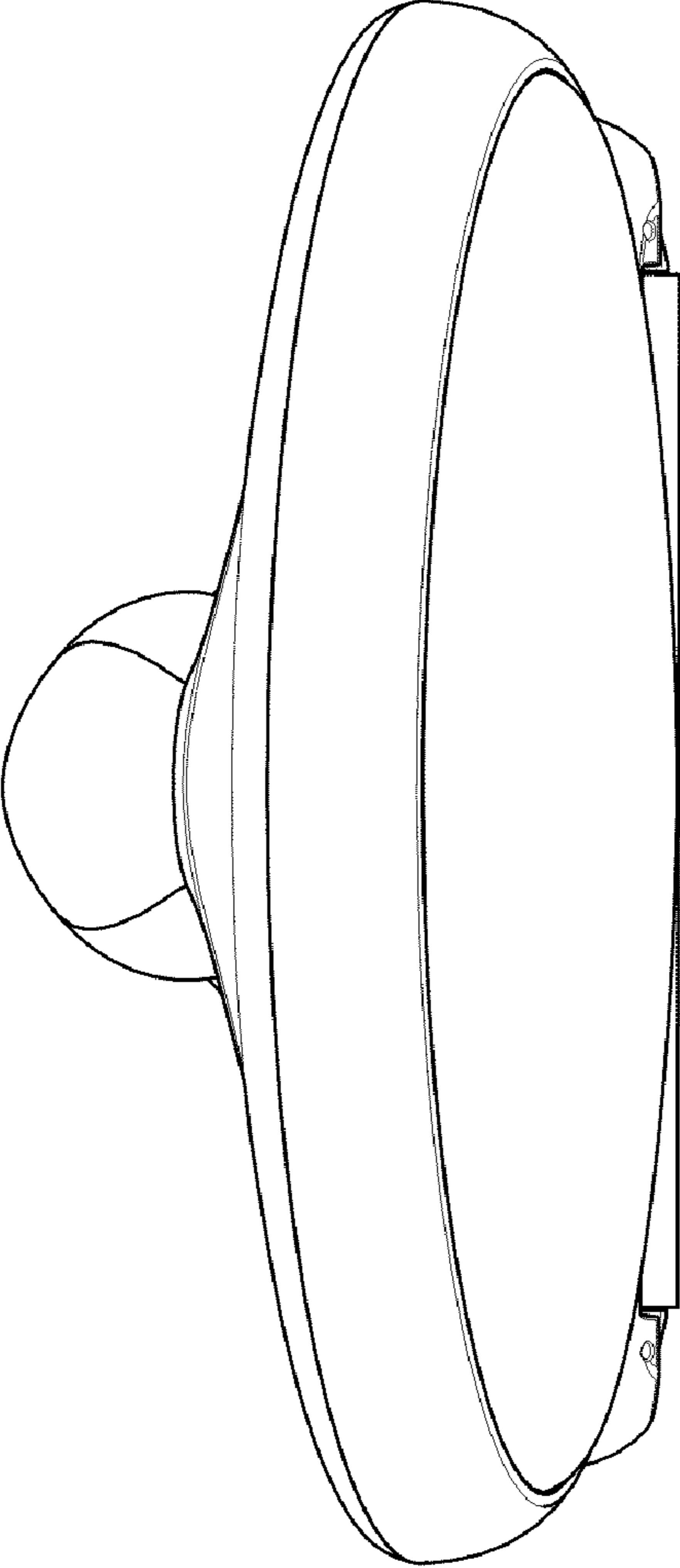

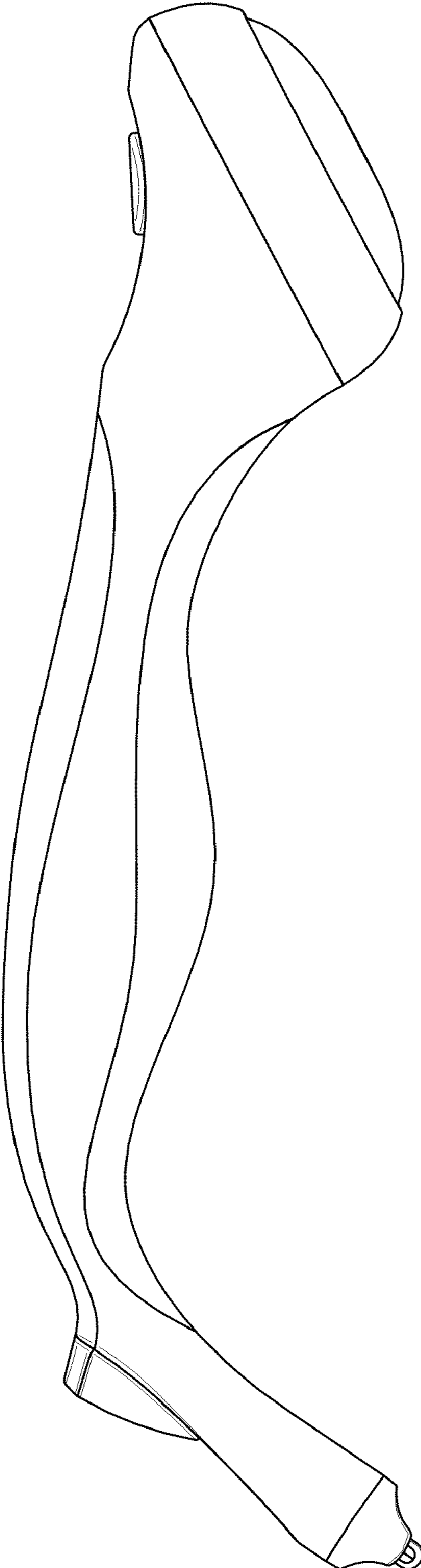

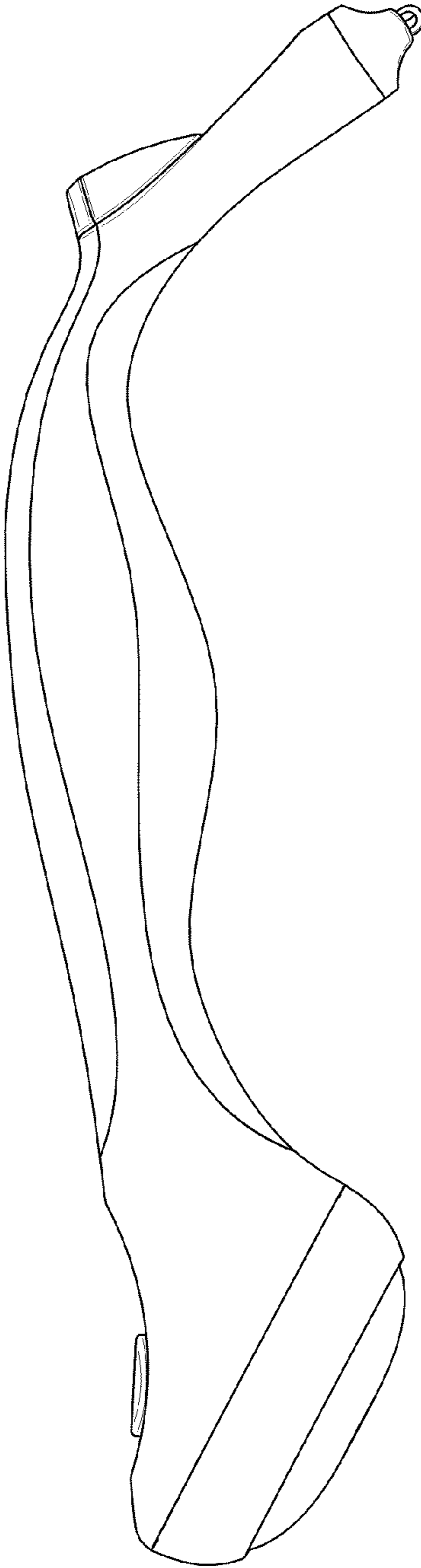

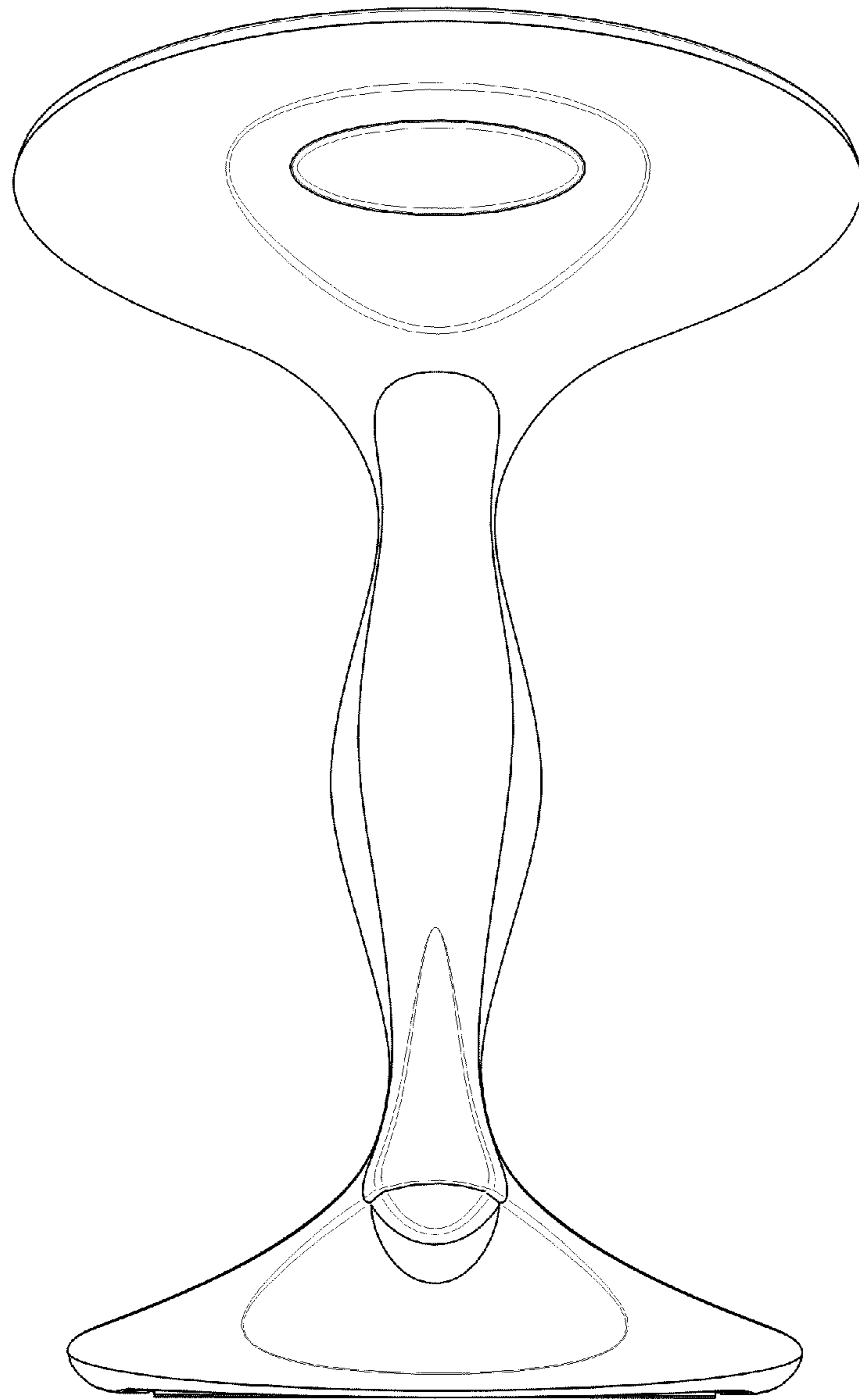

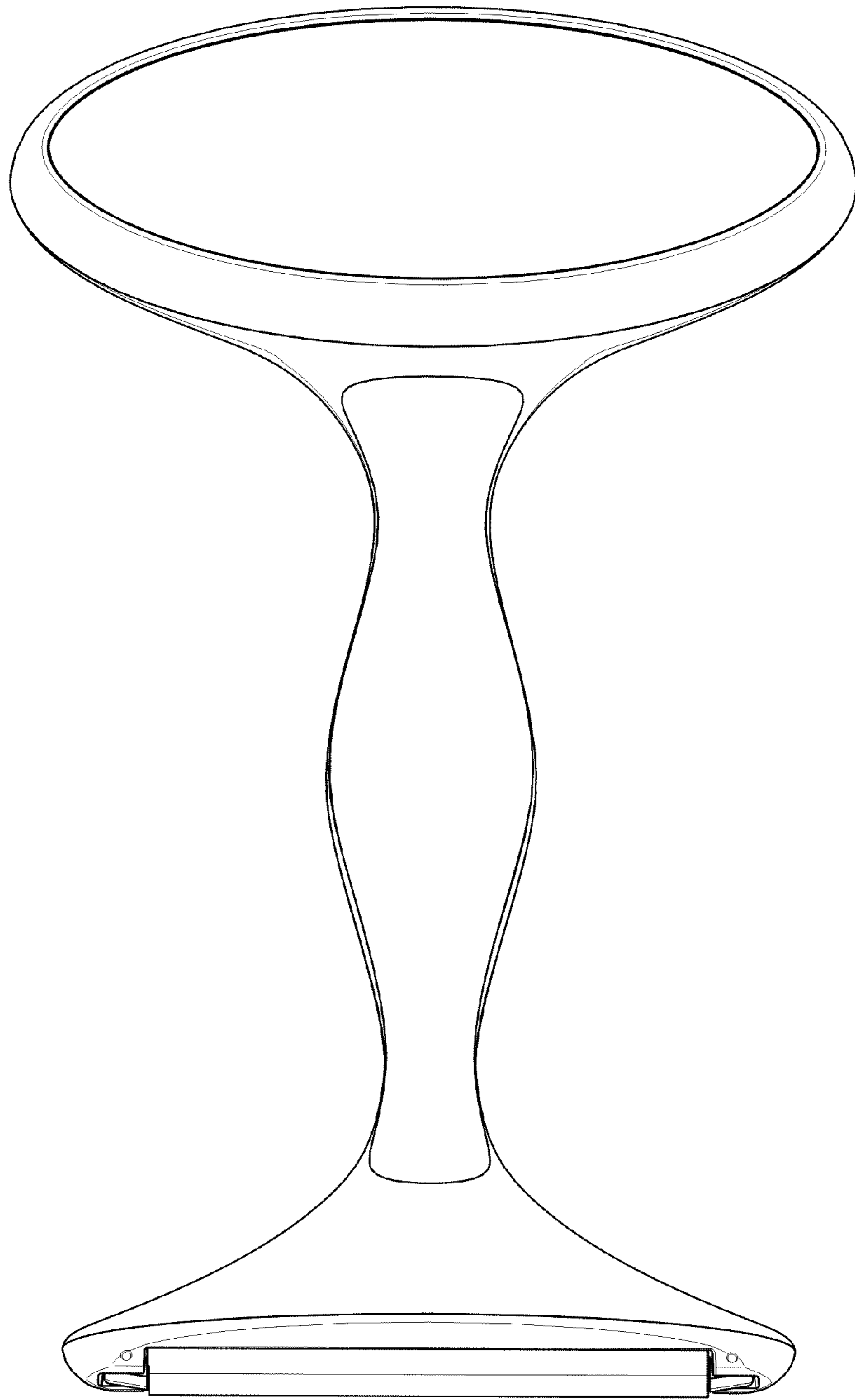
