FIG. 3 is a top view of the multi-sport vest;

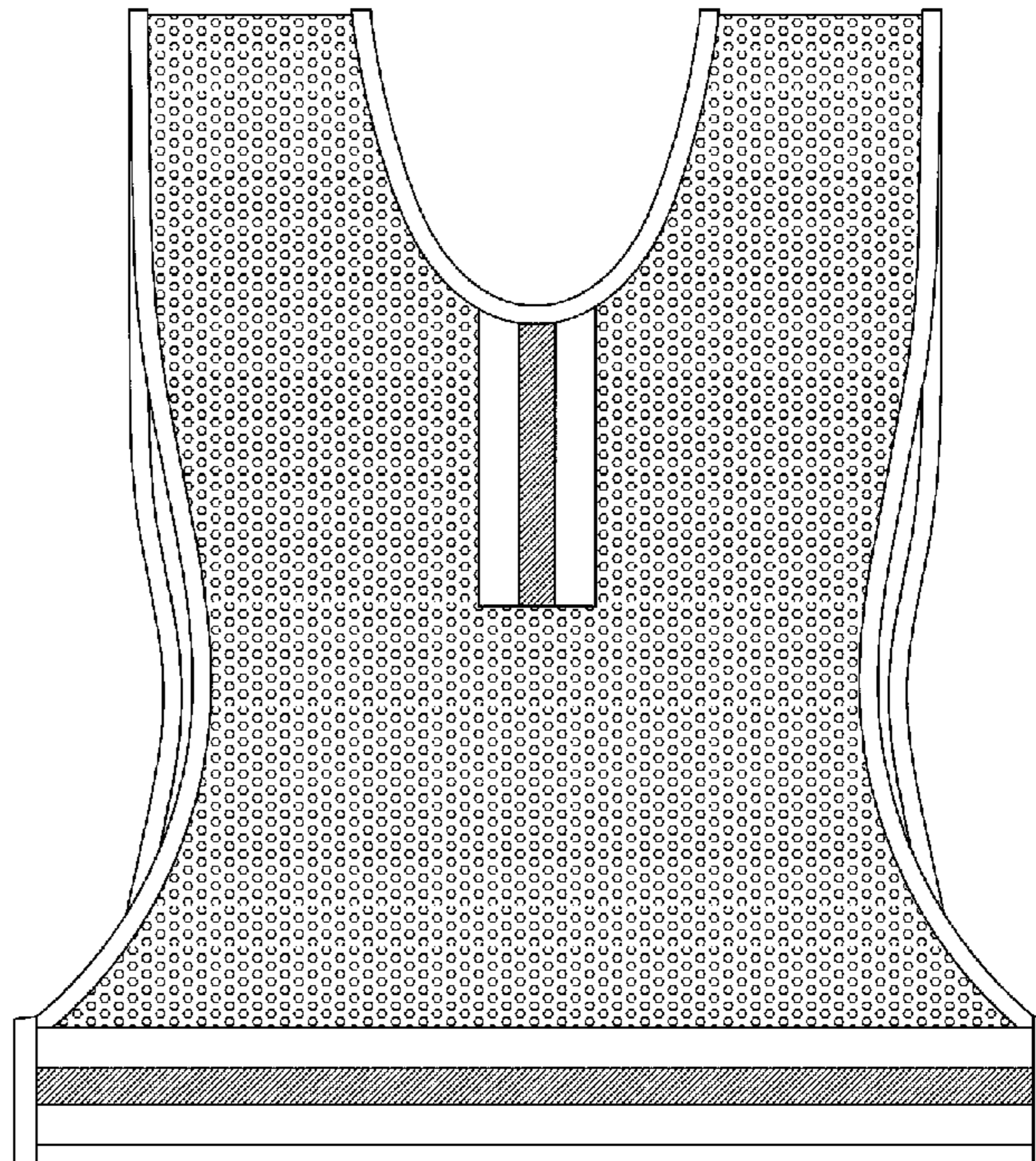
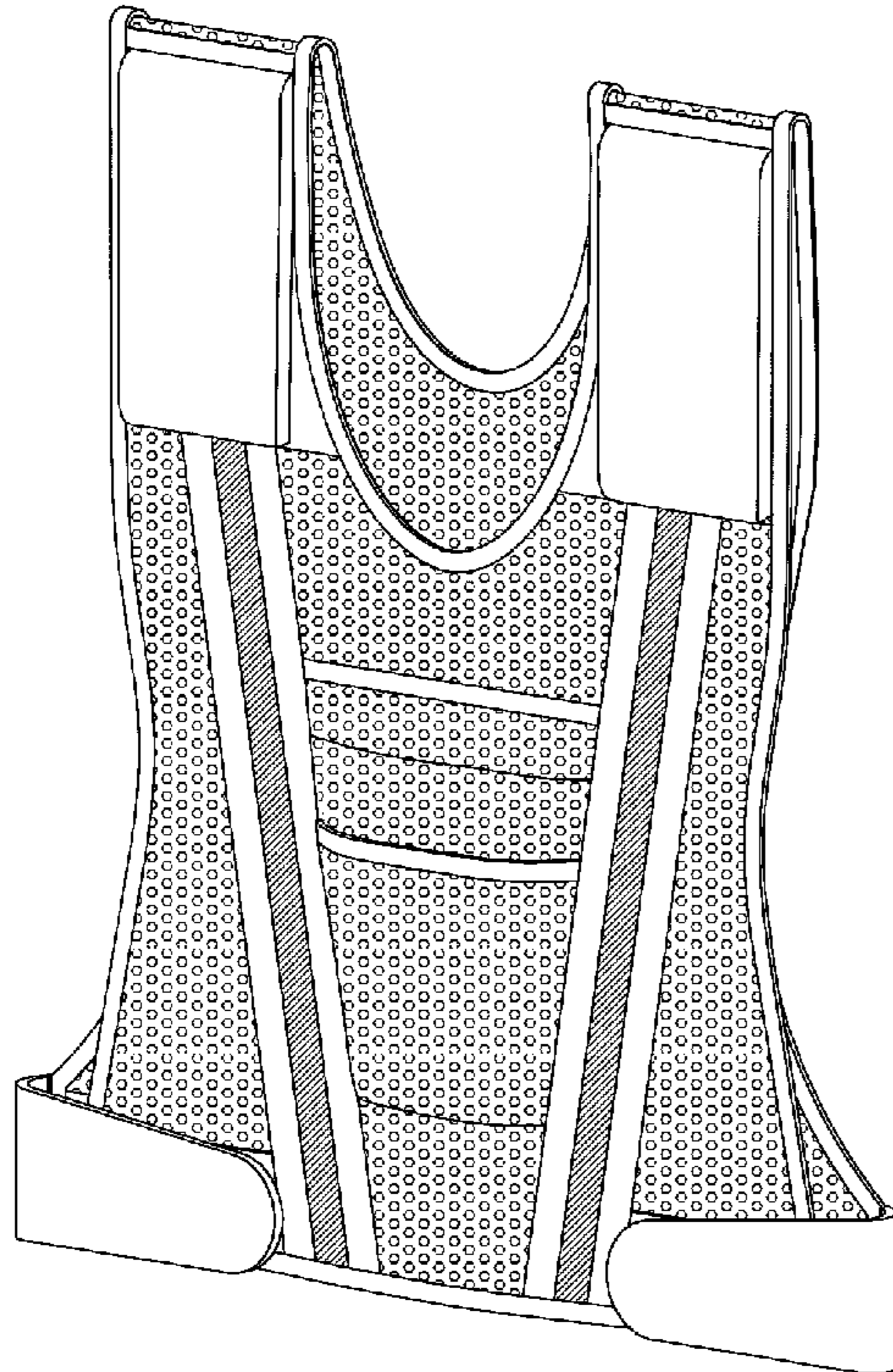
FIG. 4 is a bottom view of the multi-sport vest;

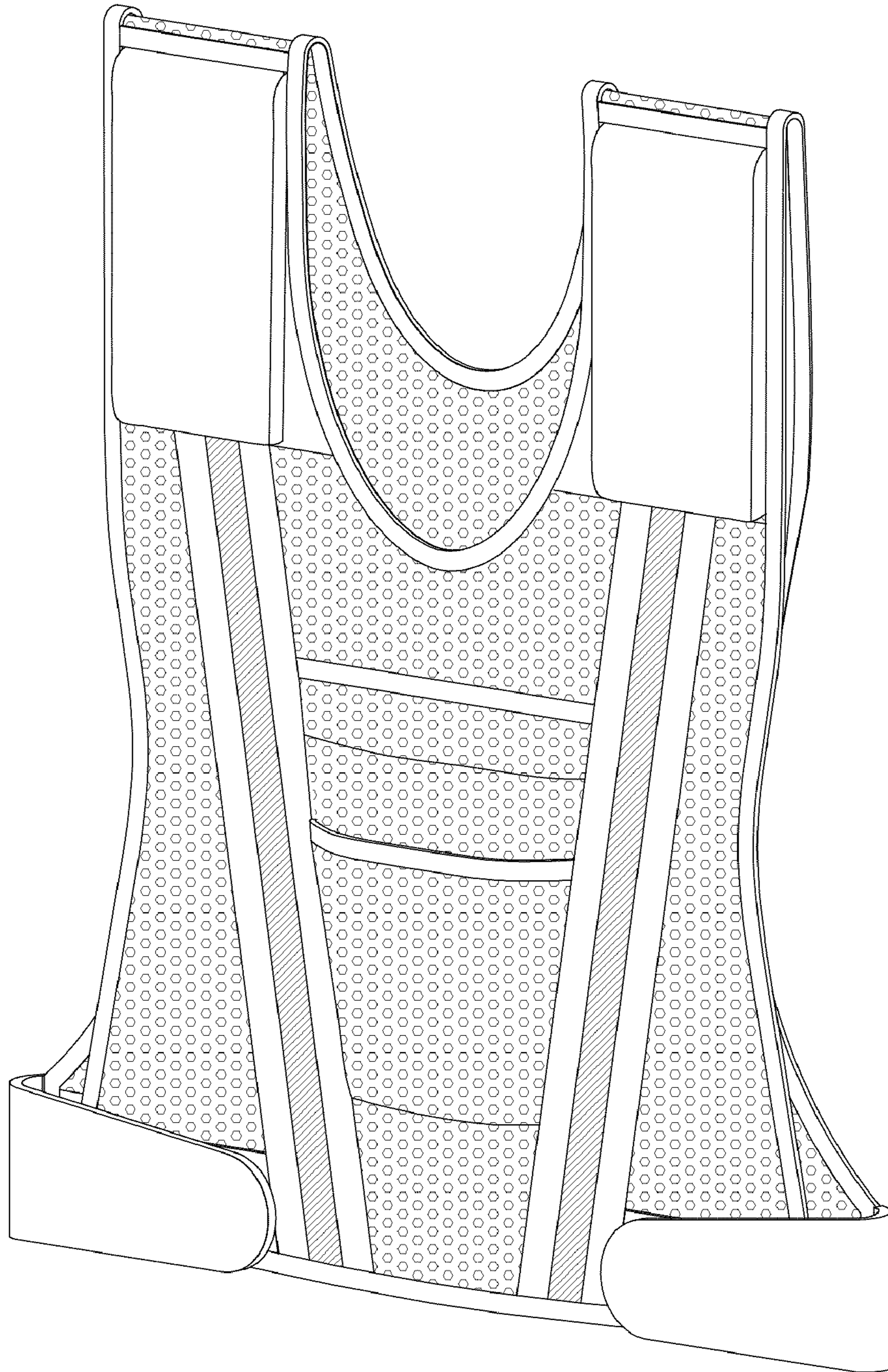

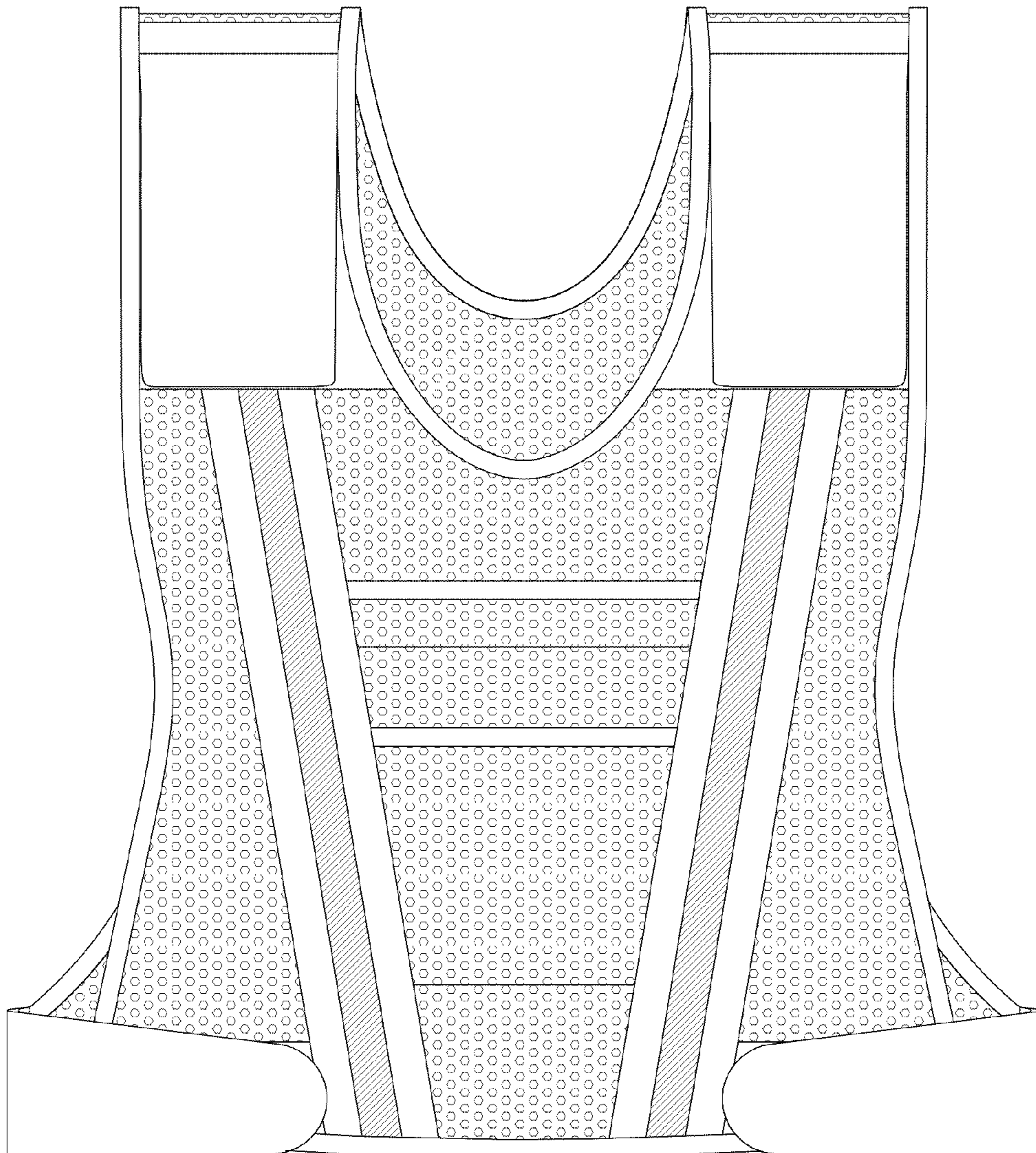

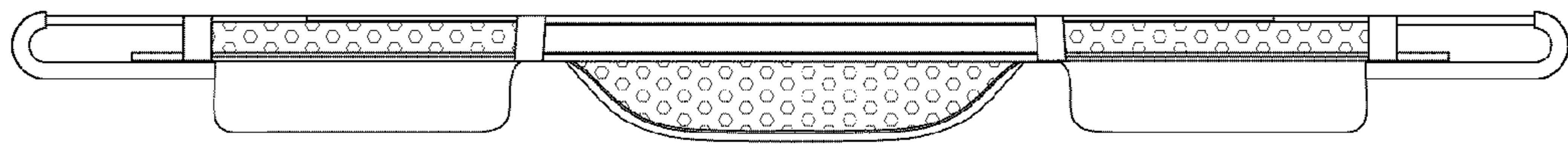

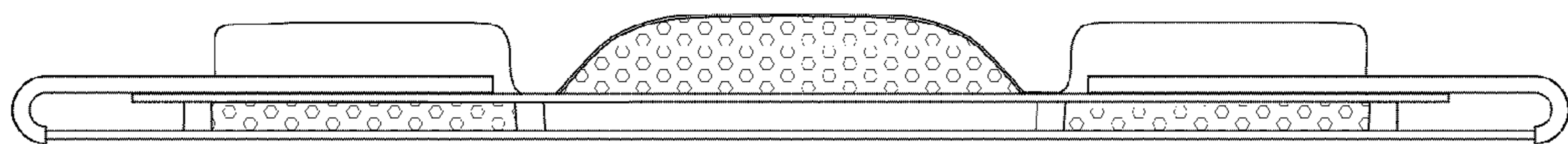

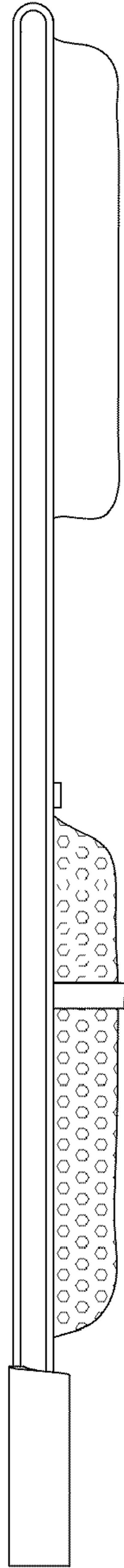

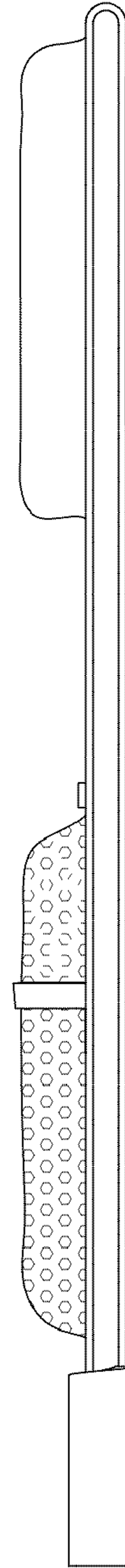

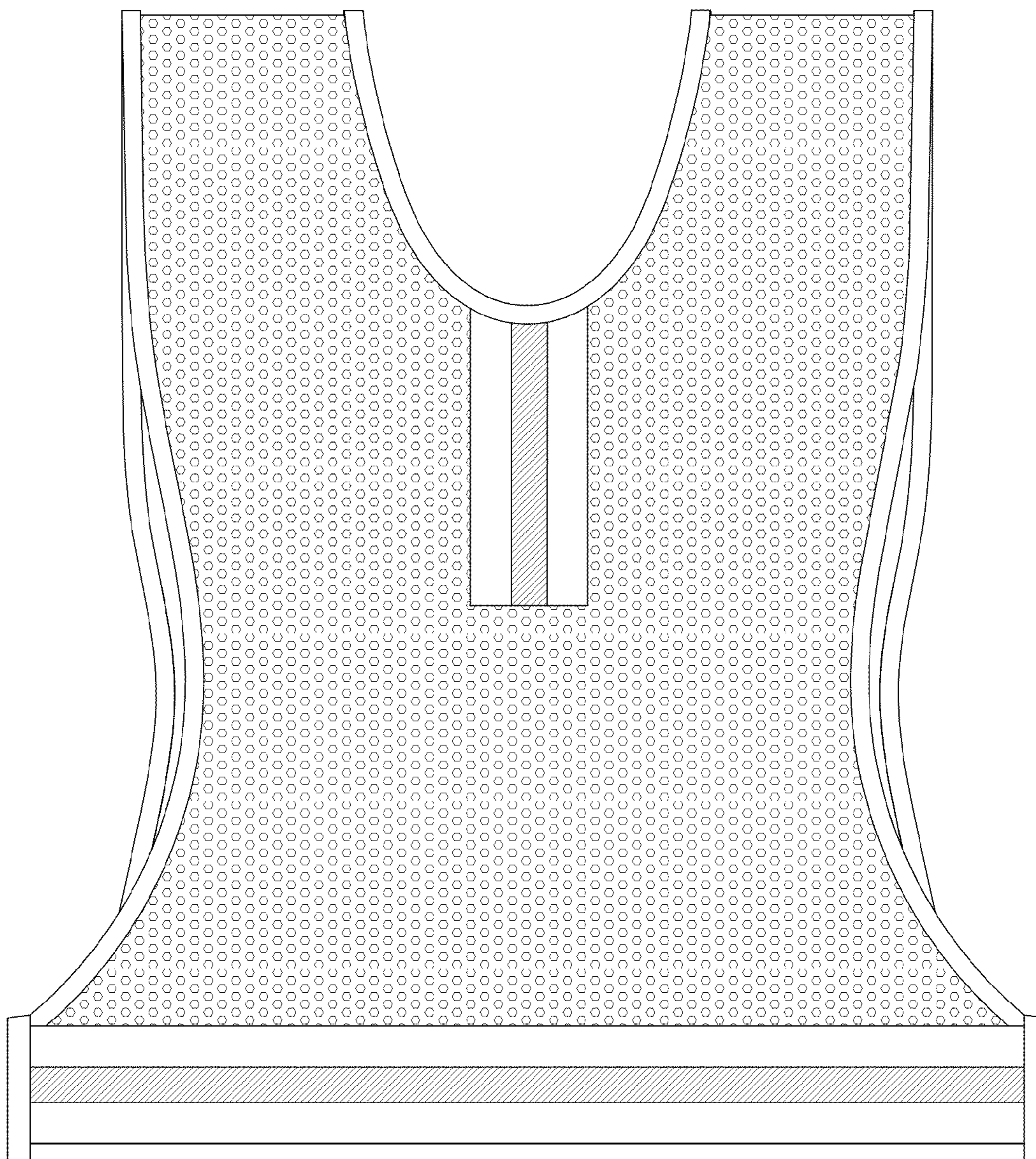
