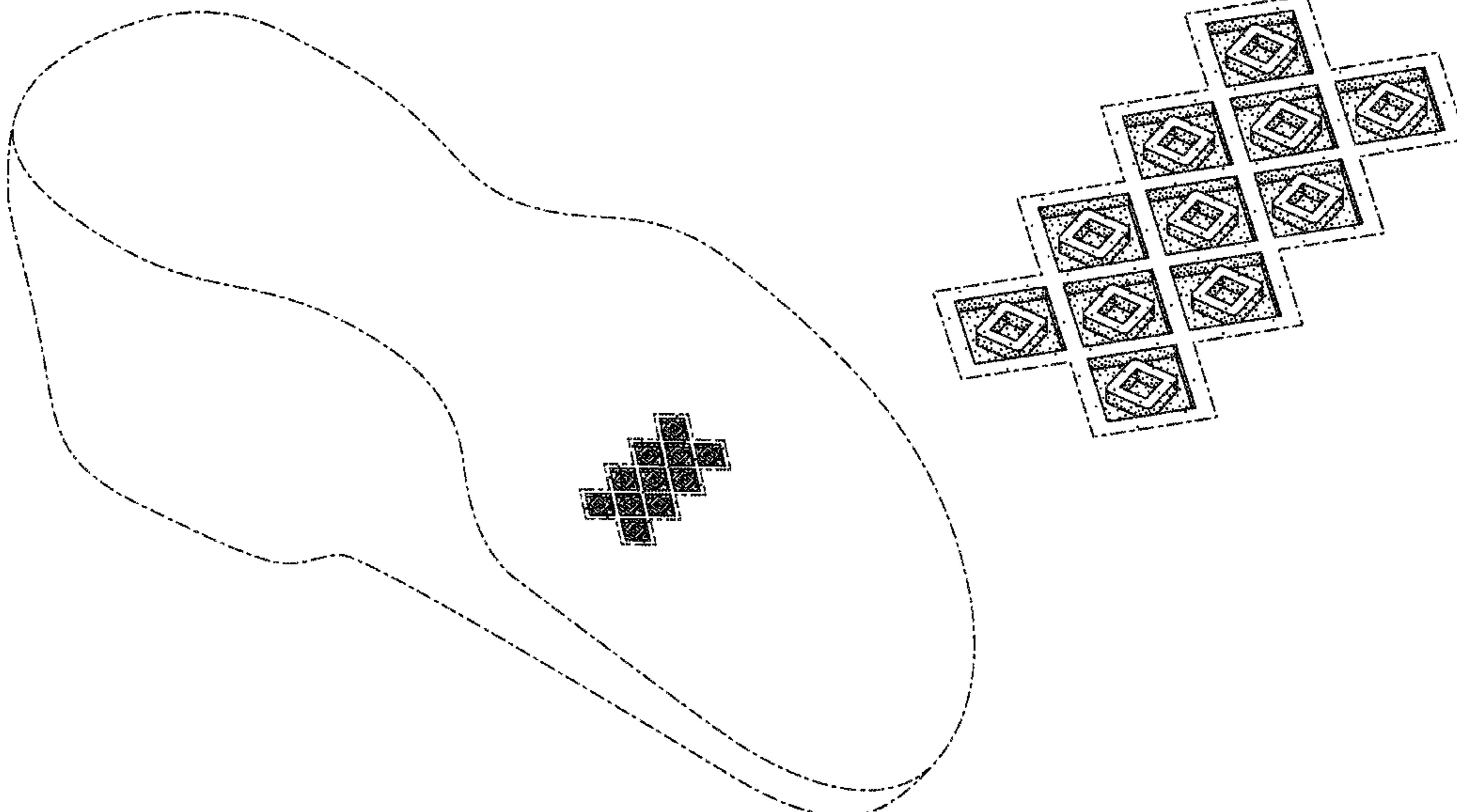
(57) **CLAIM**

The ornamental design for a shoe outsole, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a shoe outsole showing my new design;
FIG. 2 is a plan view thereof;
FIG. 3 is a rear perspective view thereof;
FIG. 4 is a greatly enlarged view of the claimed design as seen in FIG. 1, but with the surrounding environment removed;
FIG. 5 is a greatly enlarged view of the claimed design as seen in FIG. 2, but with the surrounding environment removed; and,
FIG. 6 is a greatly enlarged view of the claimed design as seen in FIG. 3, but with the surrounding environment removed.
The broken lines immediately adjacent to the shaded area represent unclaimed boundaries of the design. The broken lines showing the remainder of the shoe are for environmental purposes only and form no part of the claimed design.

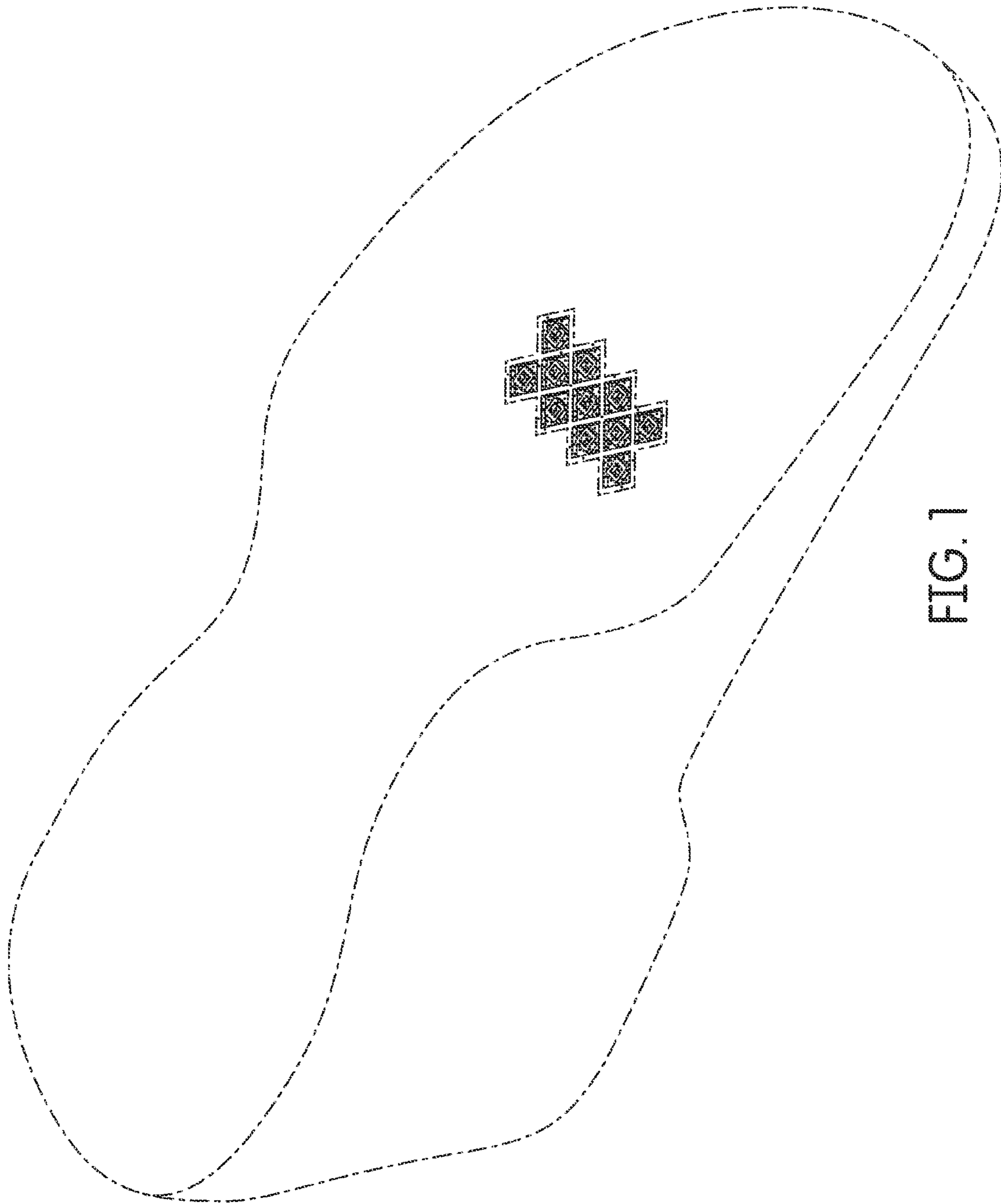

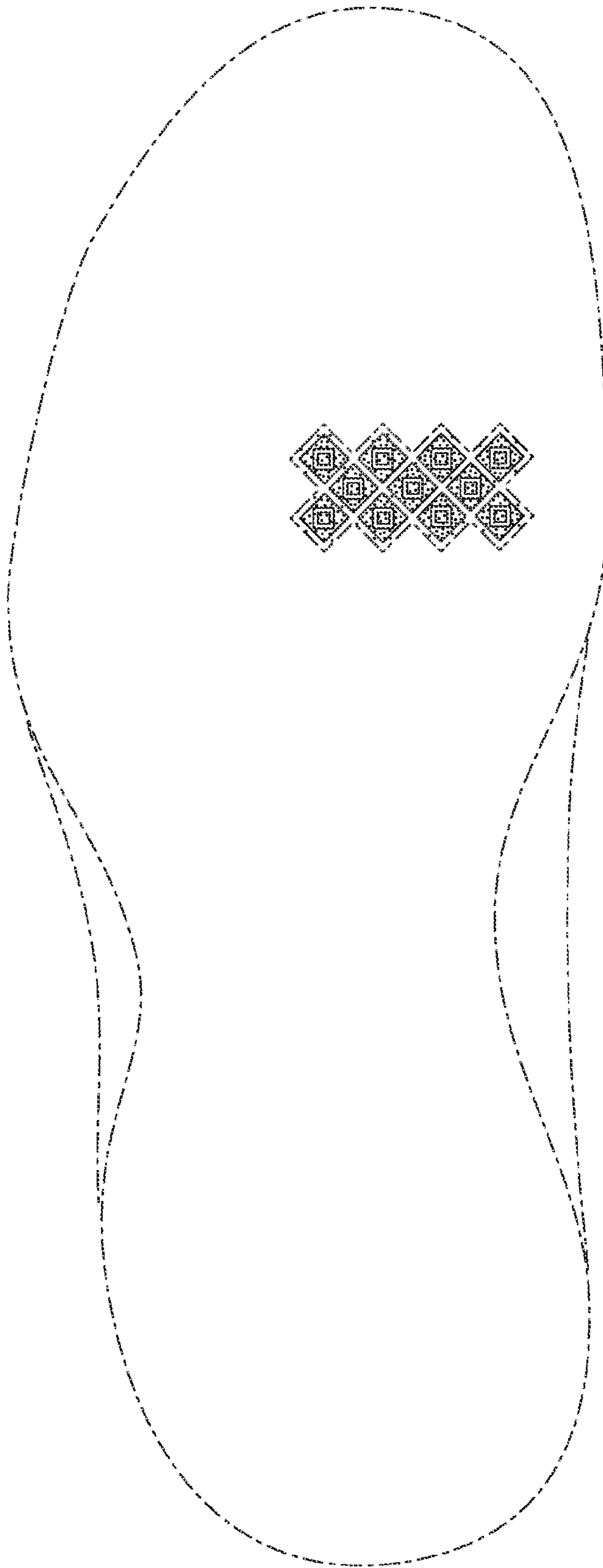

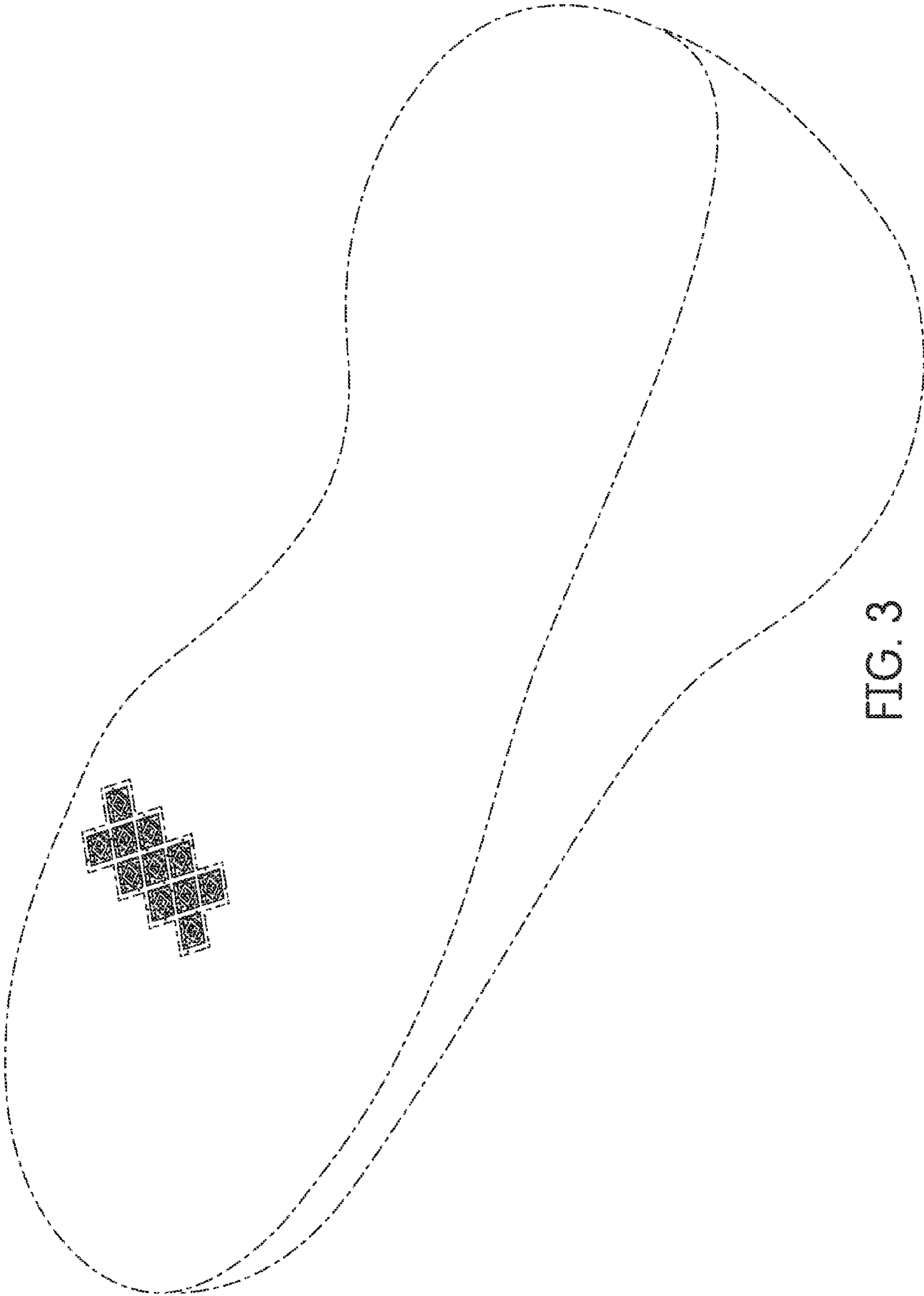

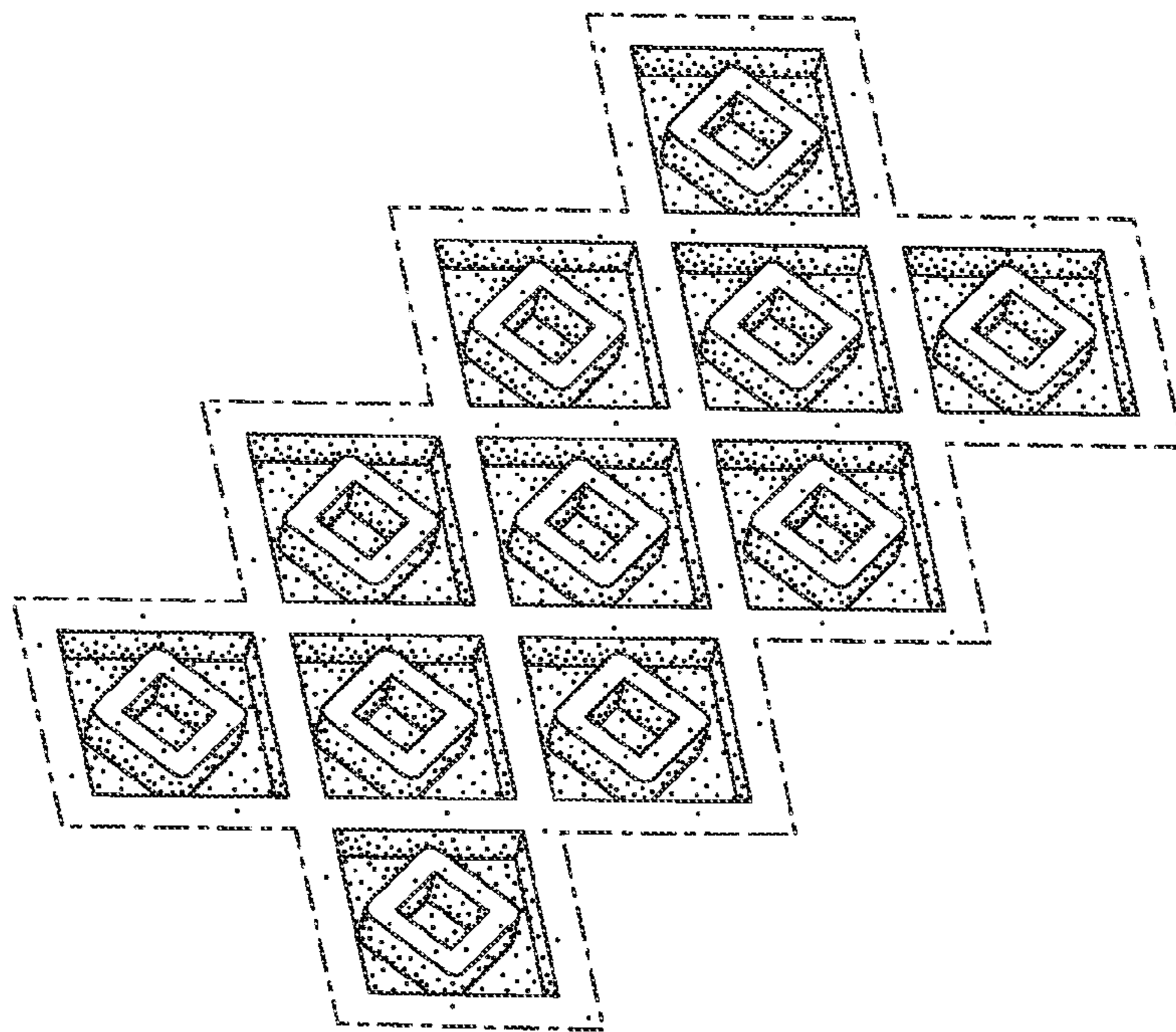

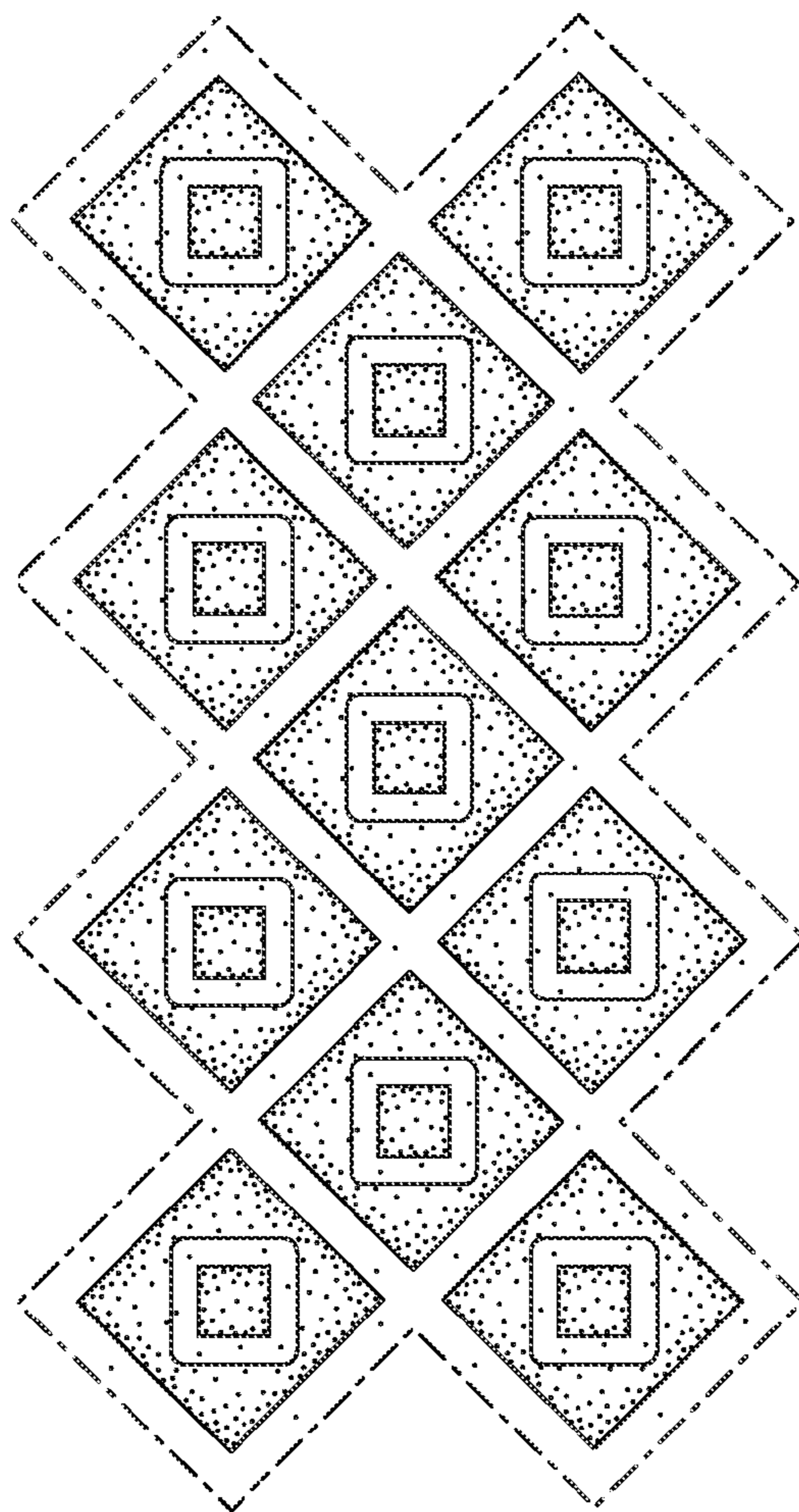

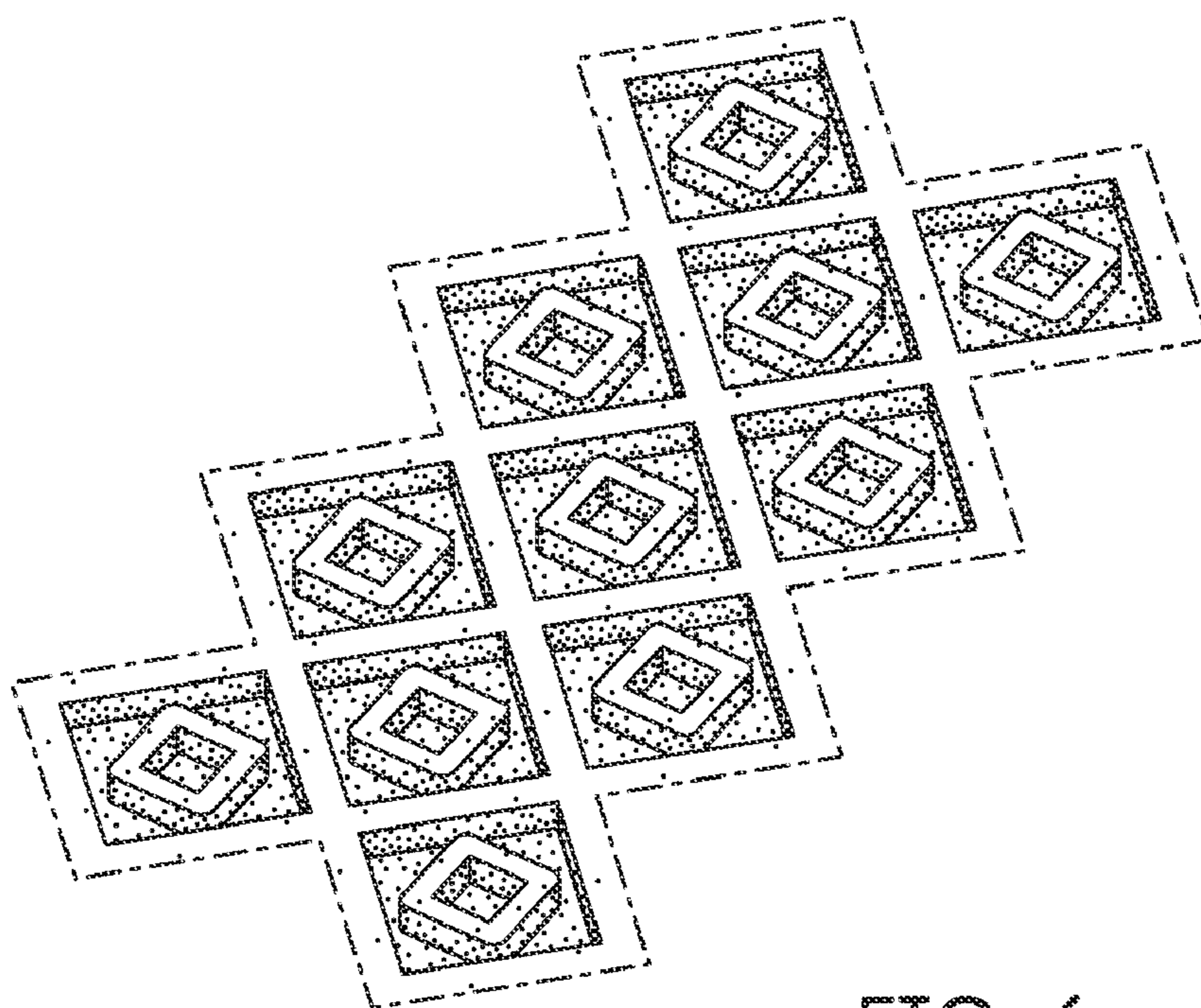
