DESCRIPTION

FIG. 1 is a front elevation view of the inflatable, portable crib, the opposite side being substantially identical to the side shown;

FIG. 2 is a top plan view of the inflatable, portable crib;

FIG. 3 is a right side view of the inflatable, portable crib, the opposite side being substantially identical to the side shown; and,

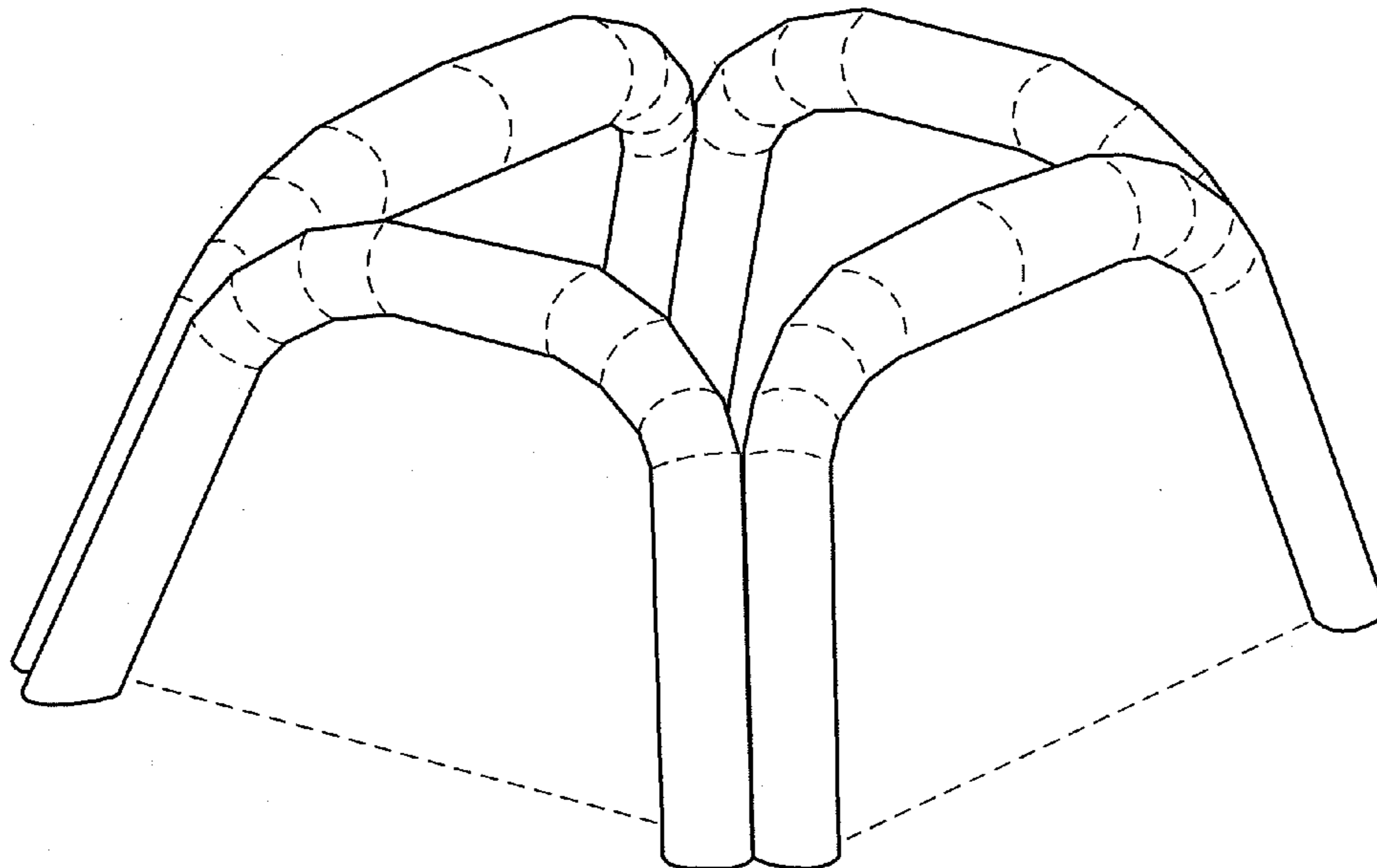
FIG. 4 is a perspective view of the inflatable, portable crib. The broken lines are for environmental purposes only and form no part of the claimed design.

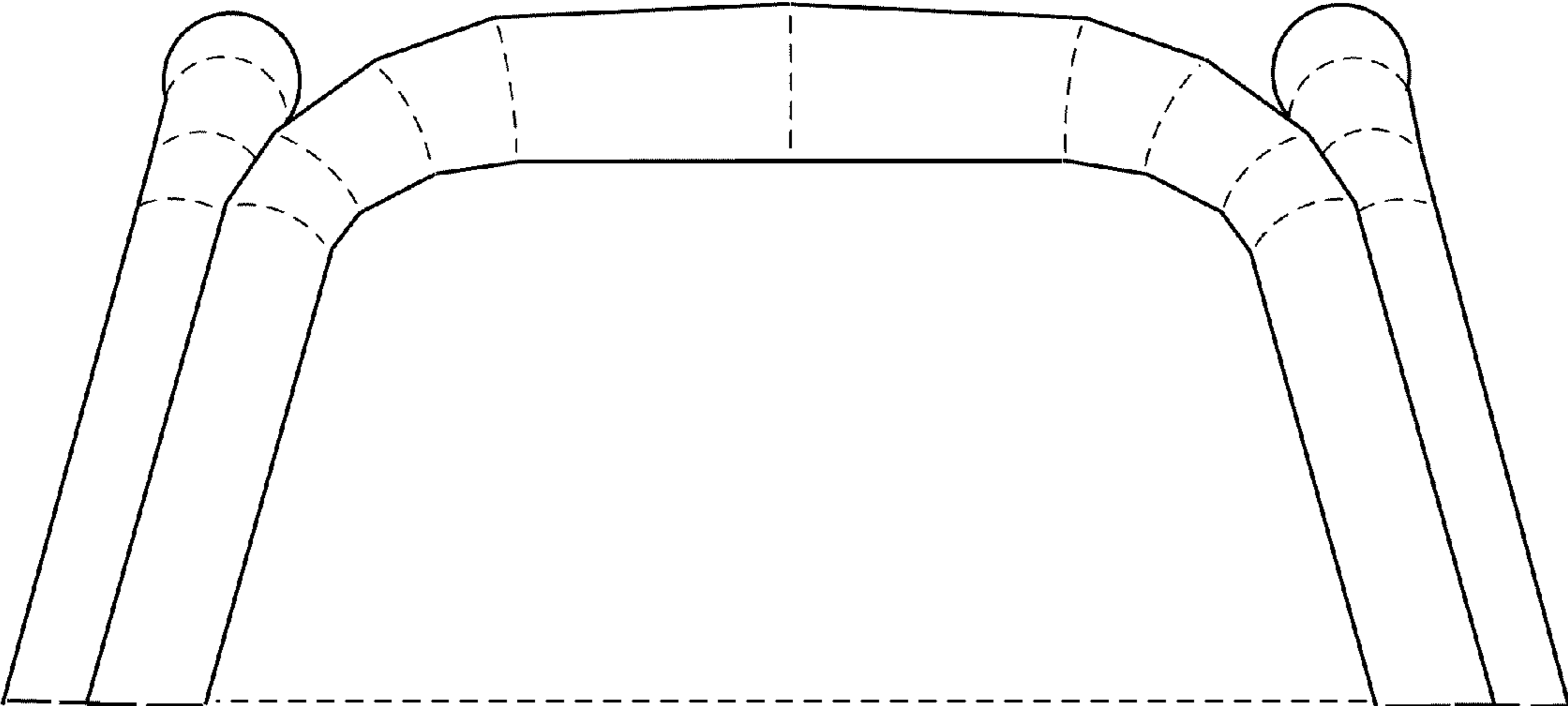

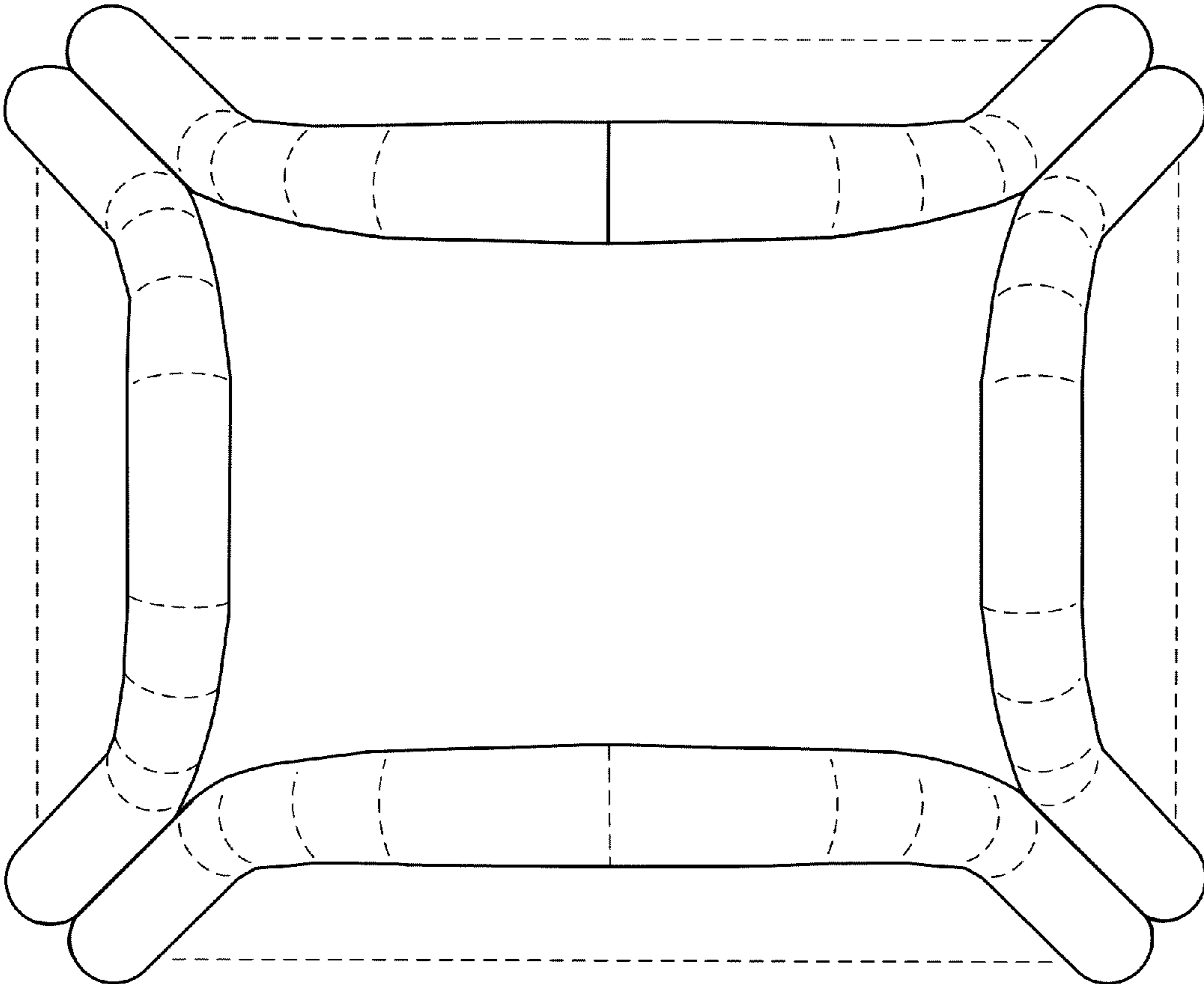

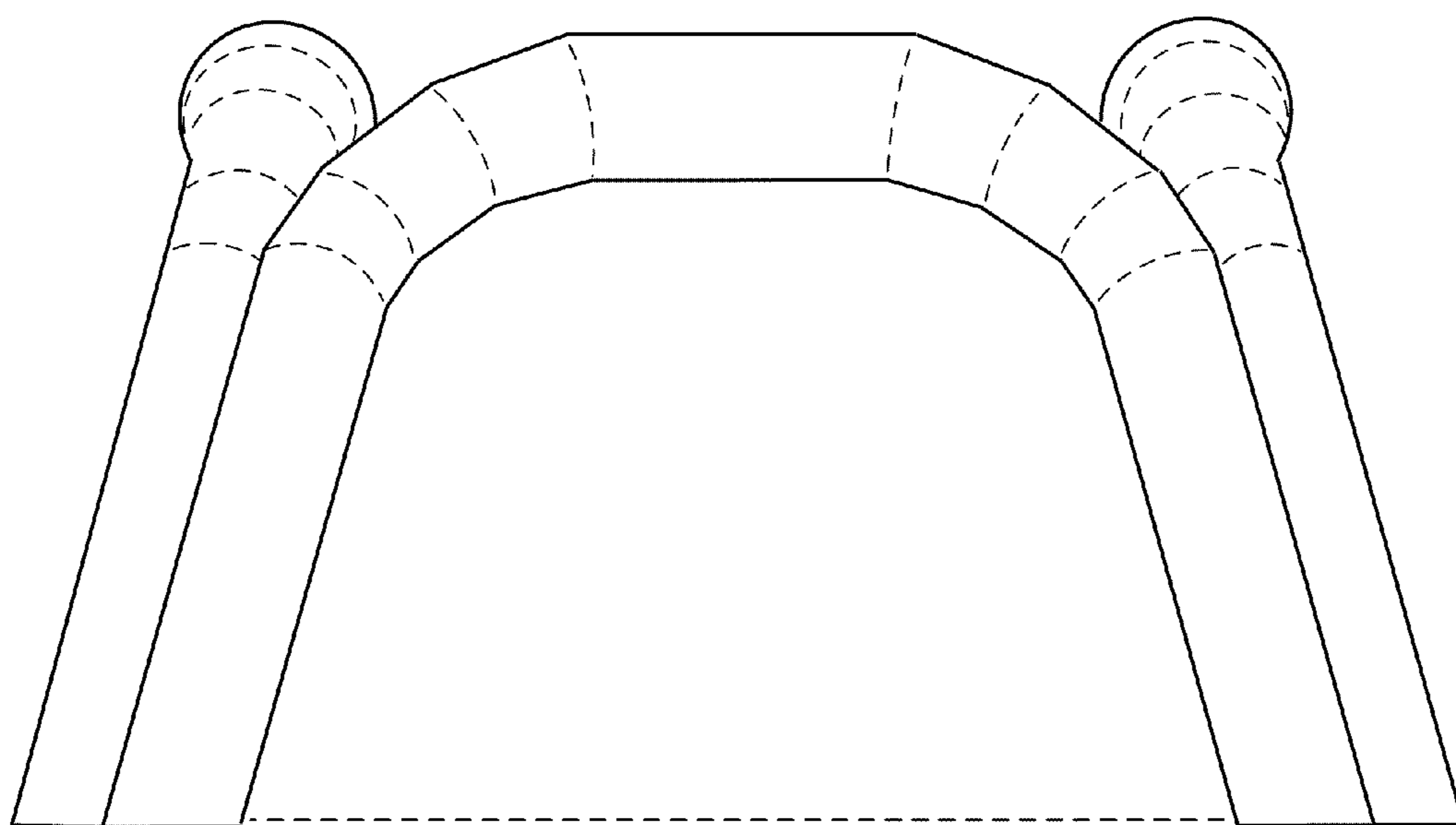

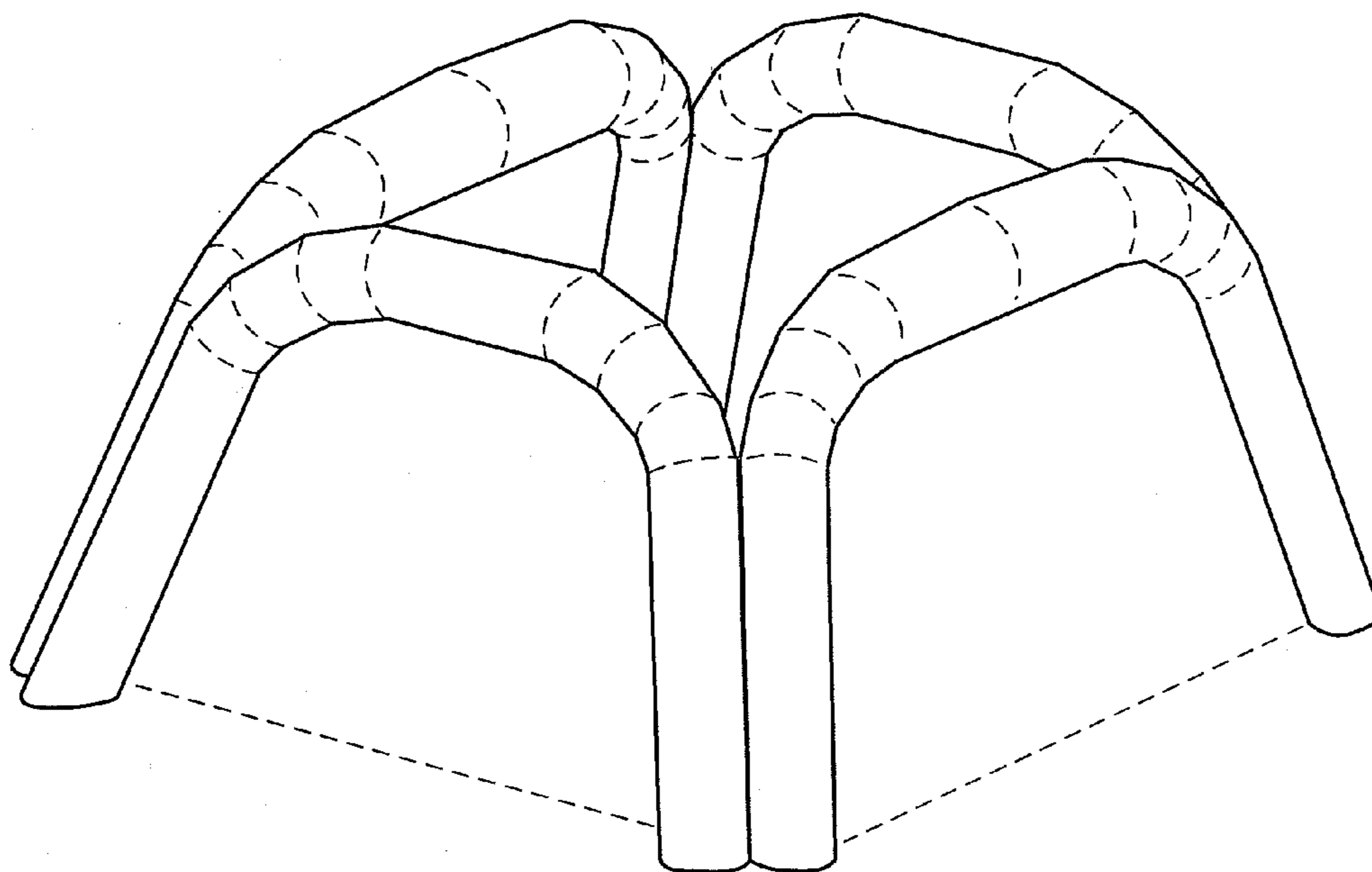
