(57) **CLAIM**

The ornamental design for a sprayer bottle, as shown and described.

DESCRIPTION

FIG. 1 is perspective view of the sprayer bottle showing our new design;
FIG. 2 is a front view thereof;
FIG. 3 is rear view thereof;
FIG. 4 is a left side view thereof;
FIG. 5 is a right side view thereof;
FIG. 6 is a top view thereof; and,
FIG. 7 is a bottom view thereof.

The dashed lines are included for the purpose of illustrating portions of the sprayer bottle that form no part of the claimed design.

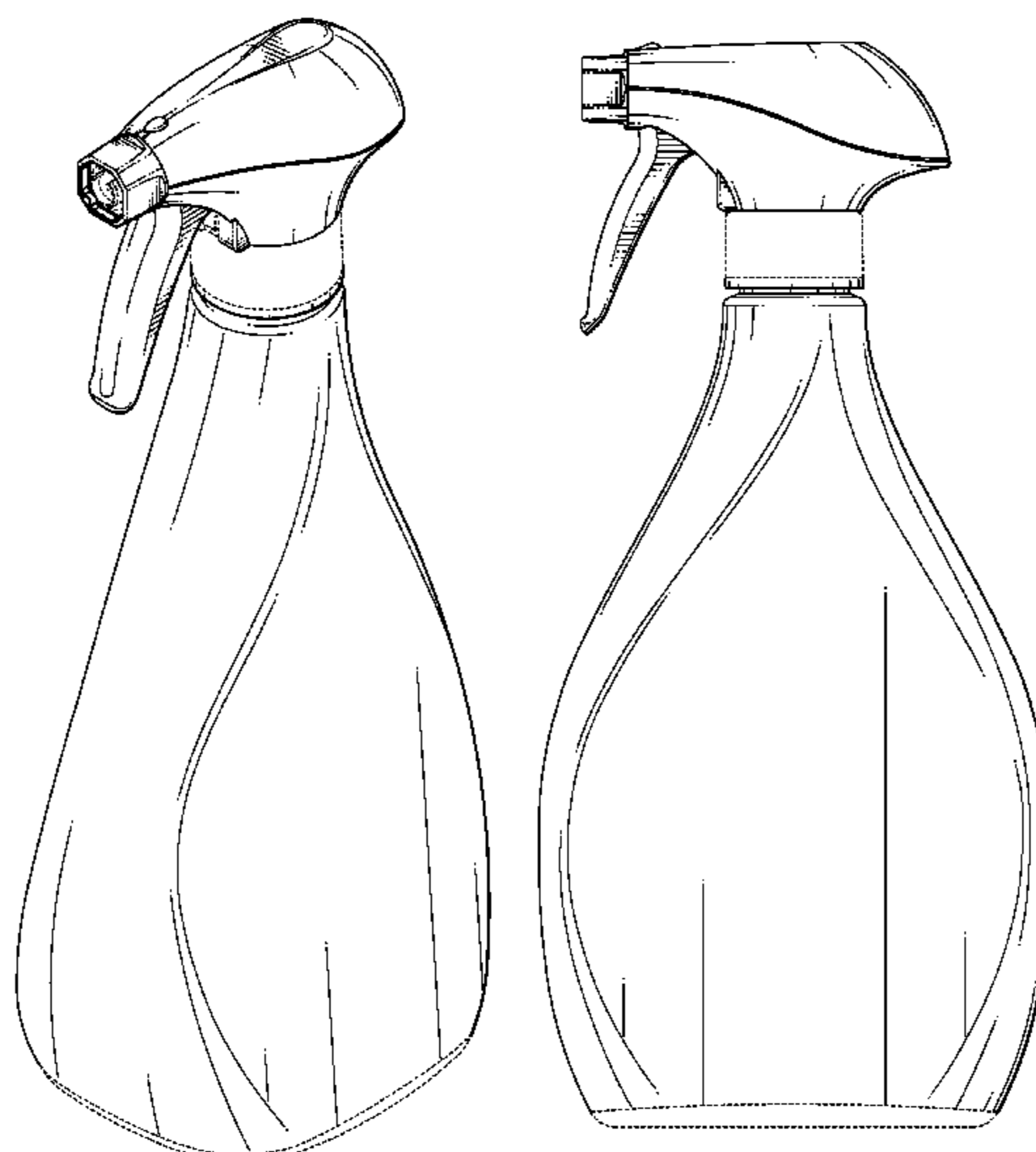

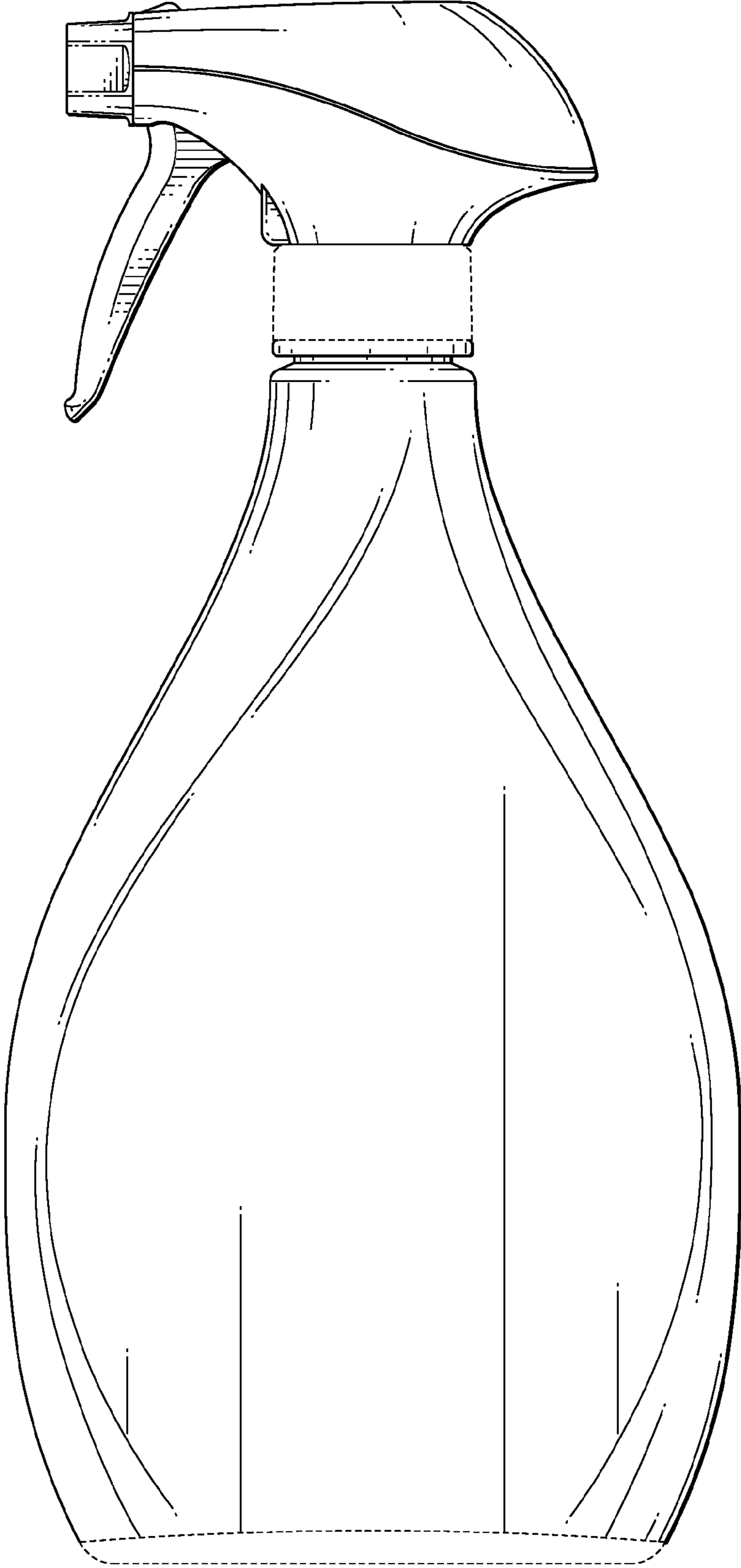

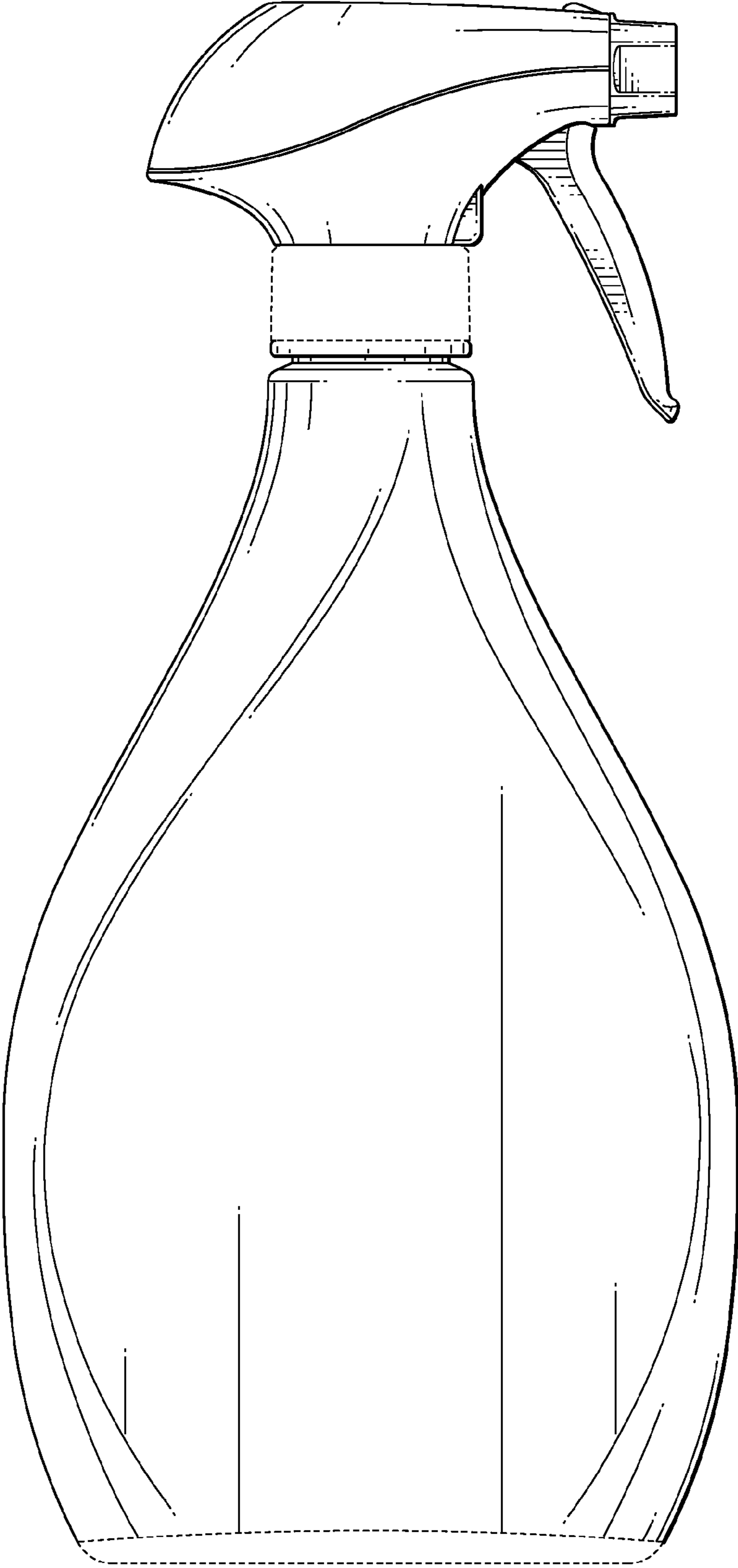

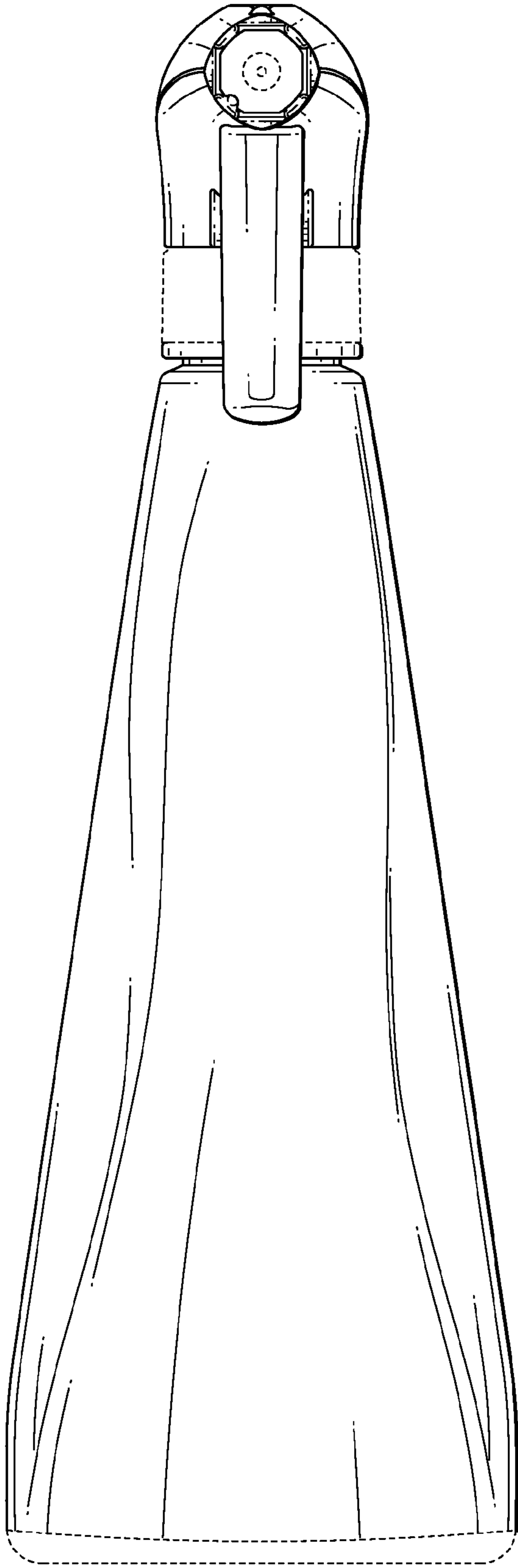

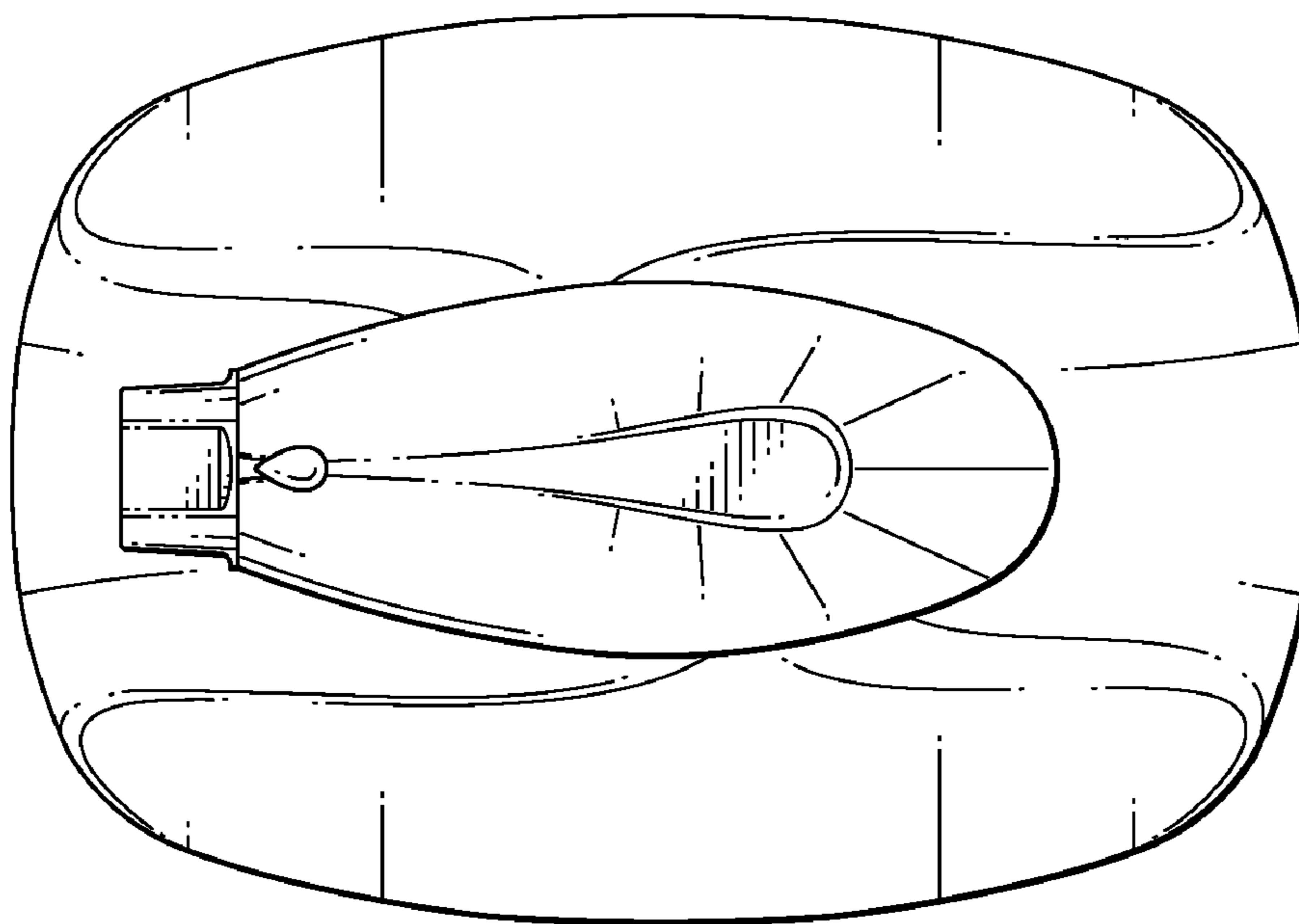

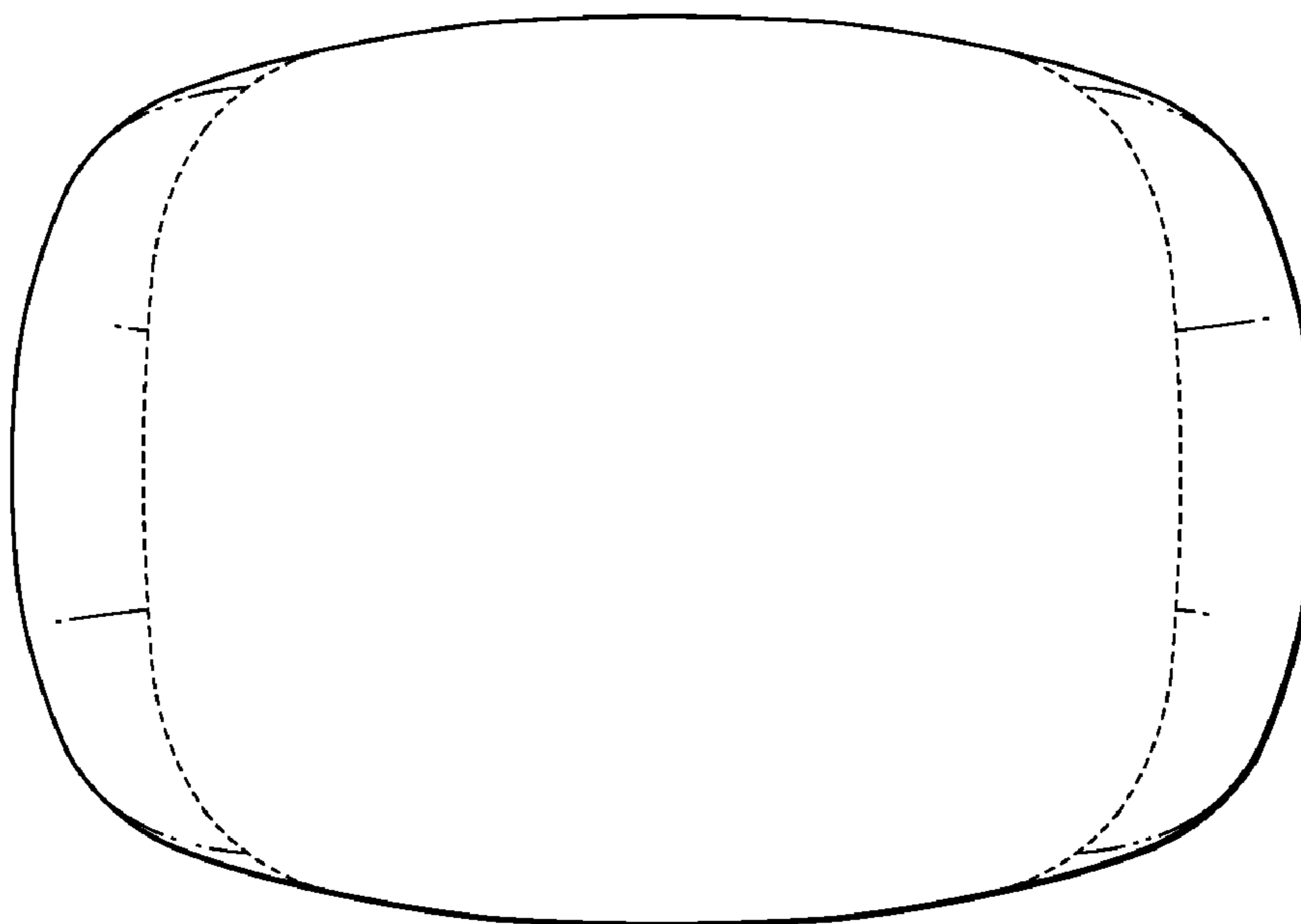
