The ornamental design for an alarm clock capable of playing a plurality of pre-recorded audio tracks, as shown and described.

DESCRIPTION

FIG. 1 is a frontal perspective view of an alarm clock capable of playing a plurality of pre-recorded audio tracks.

FIG. 3 is a front elevation view thereof.

FIG. 5 is a right side elevation view thereof.

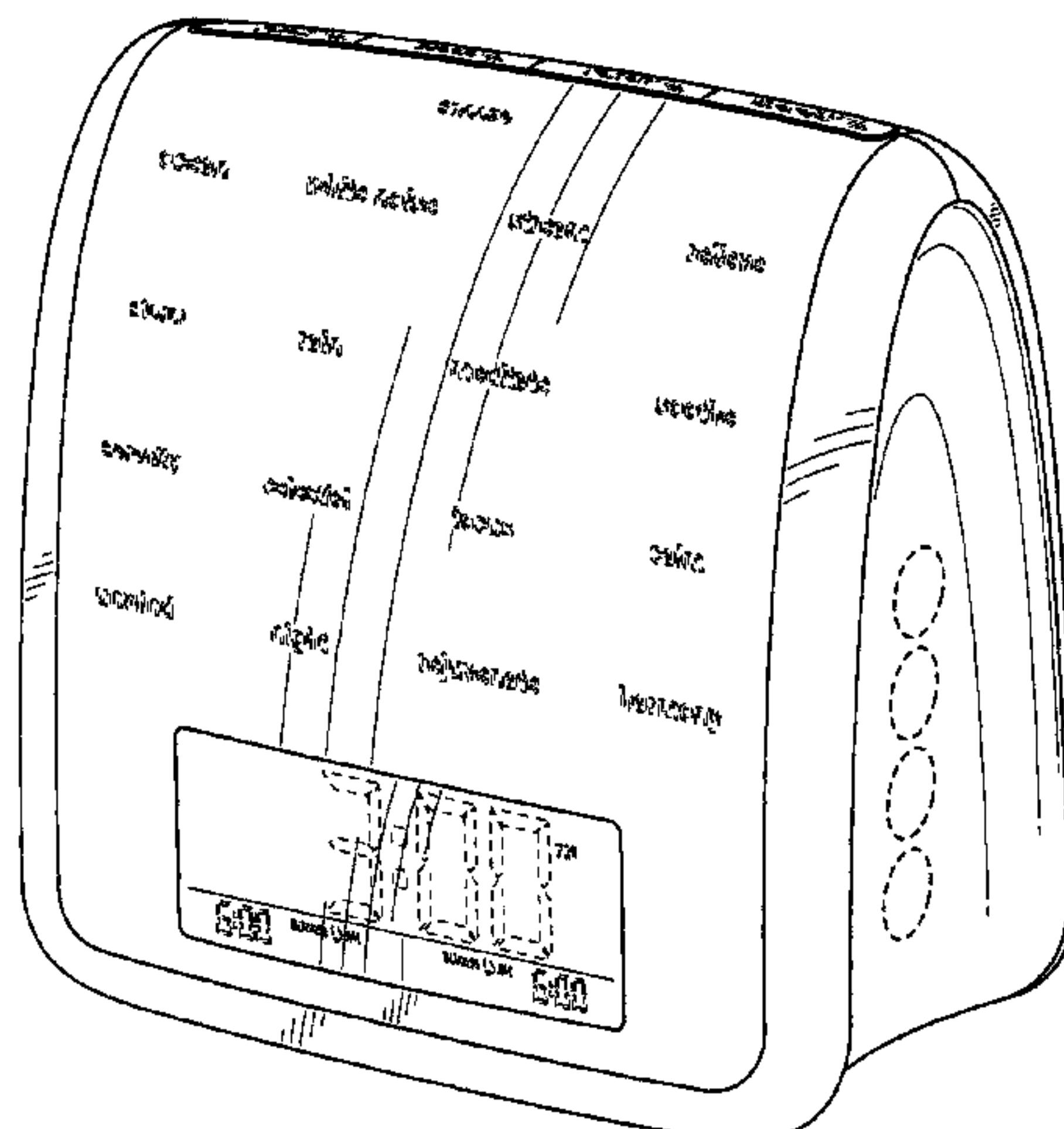
FIG. 6 is a left side elevation view thereof.

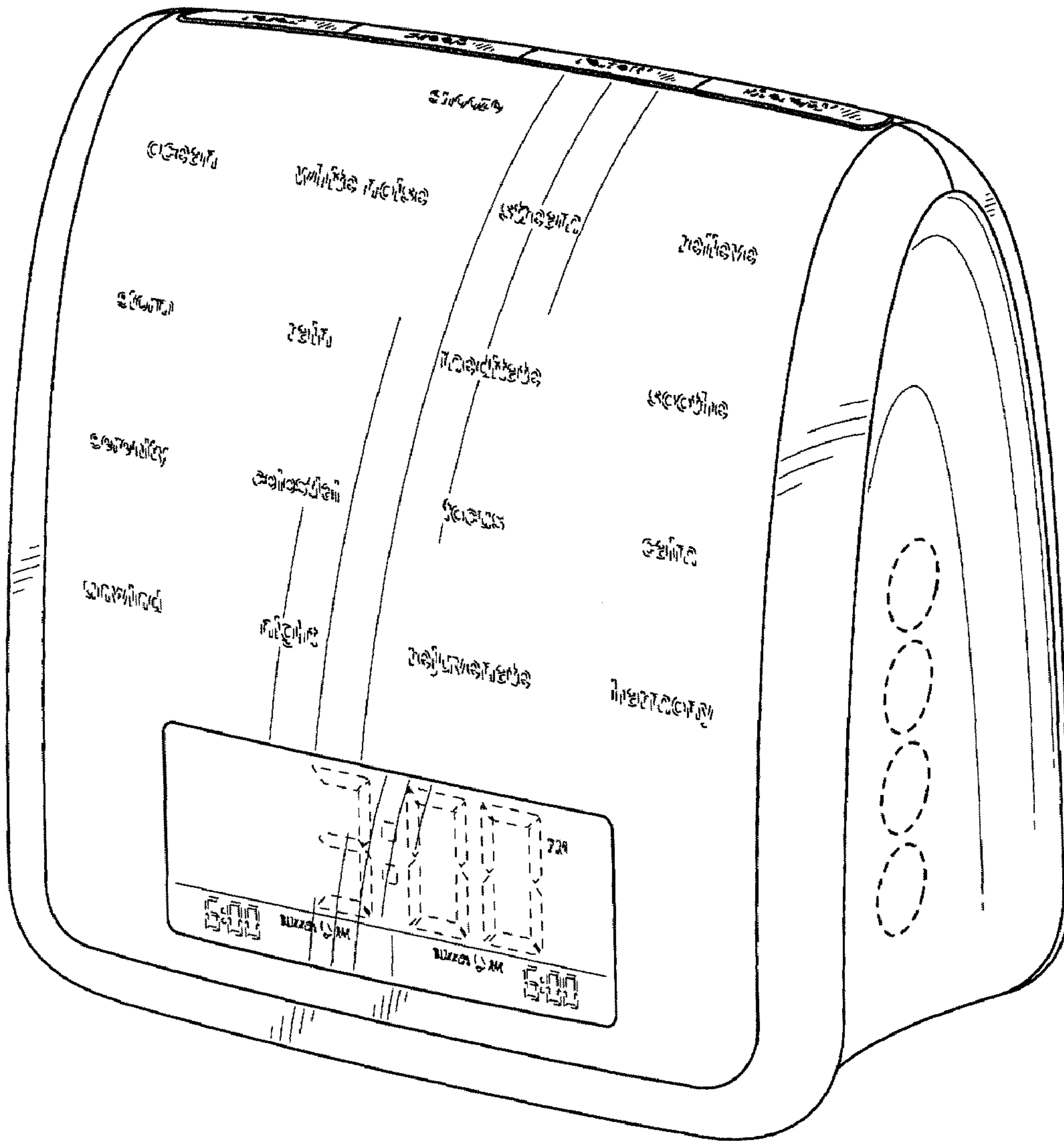

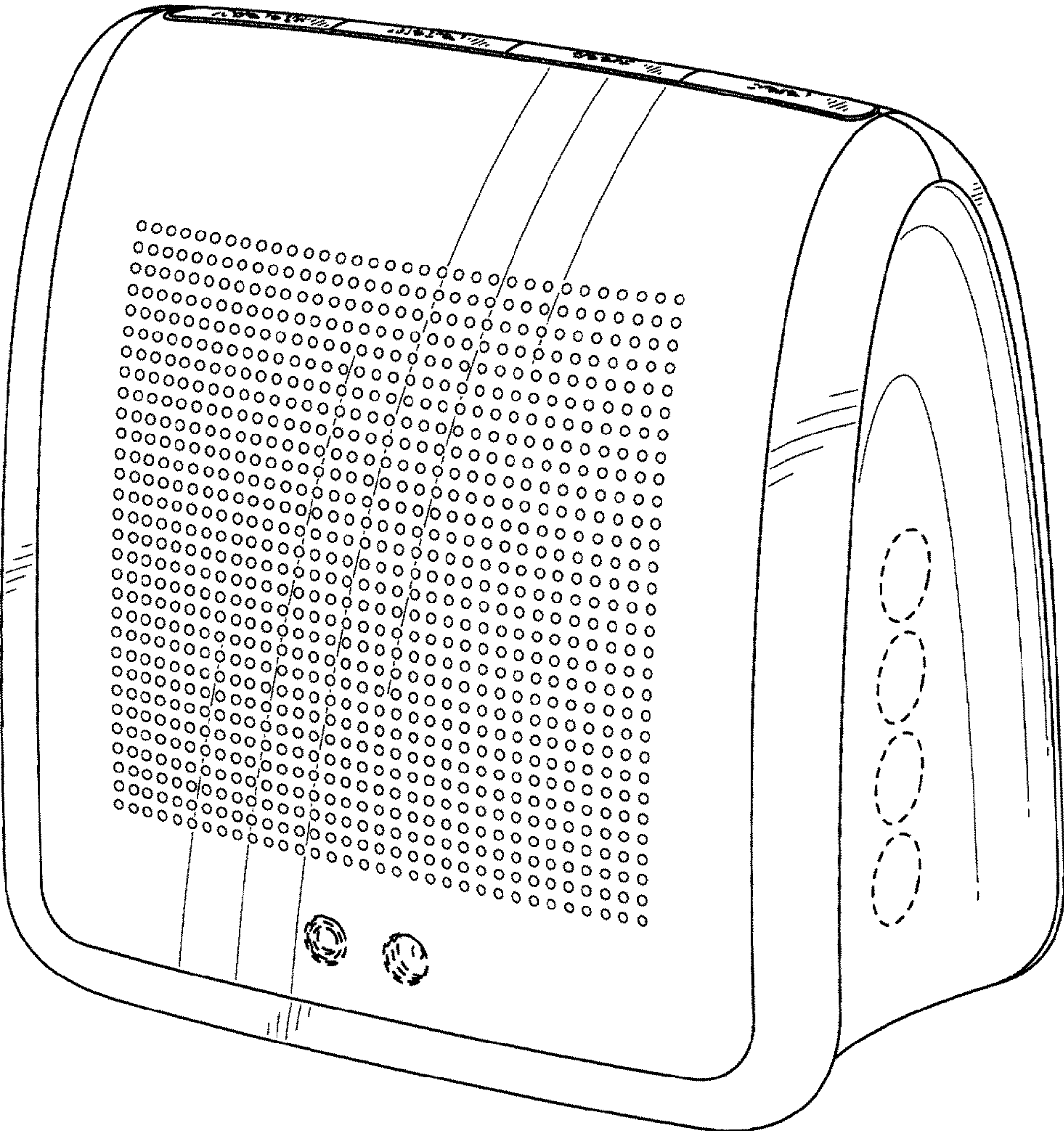

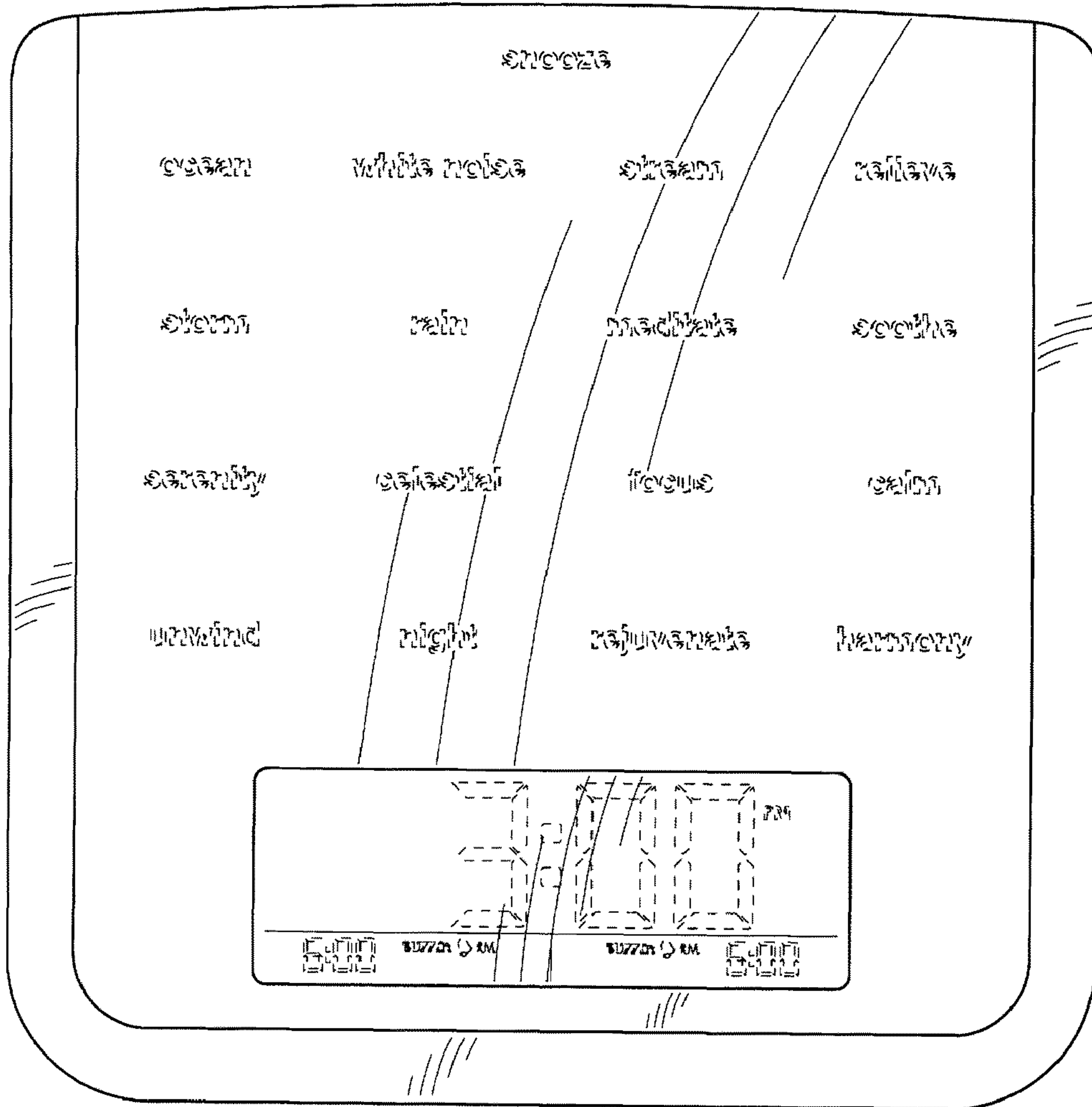

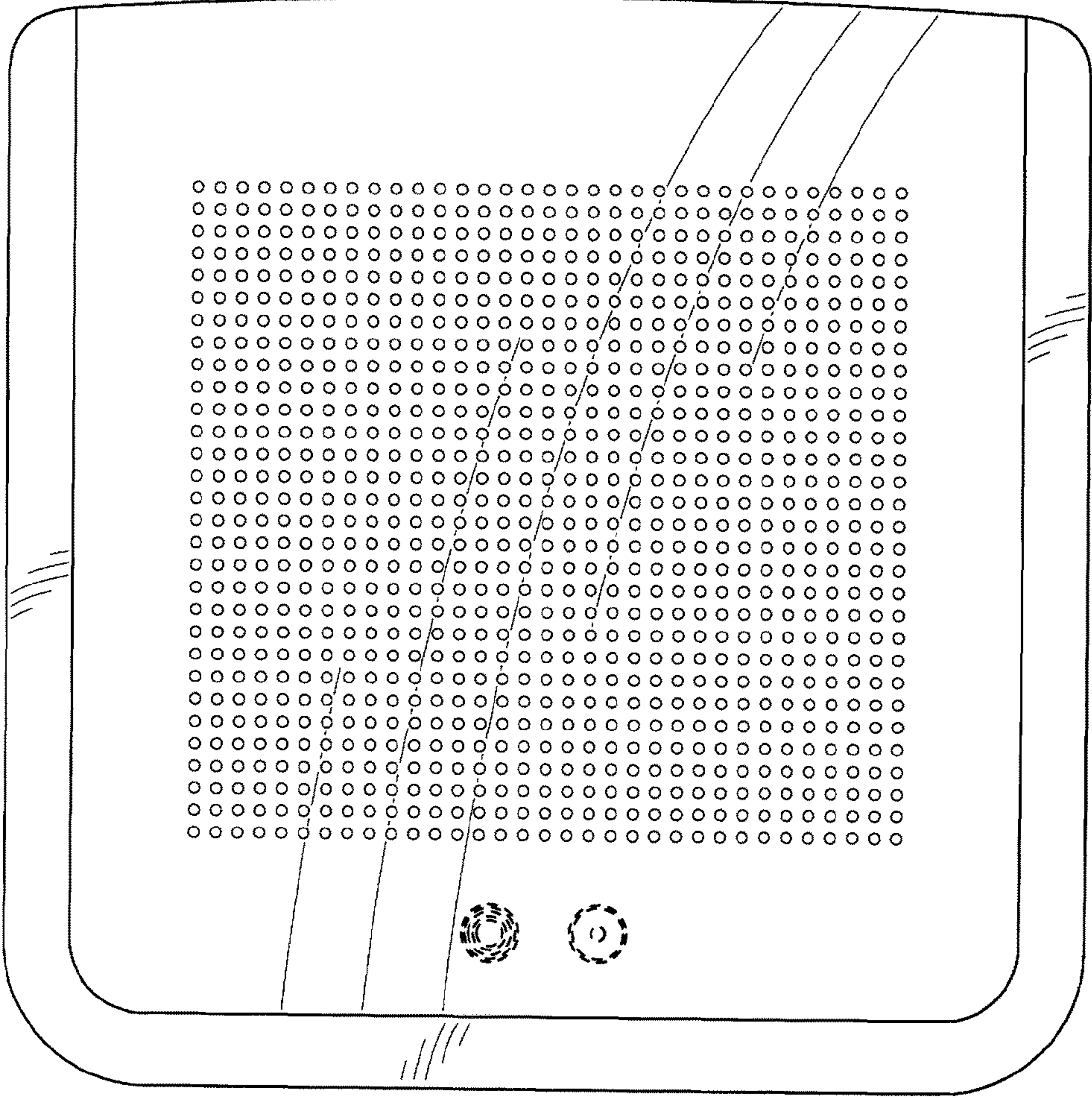

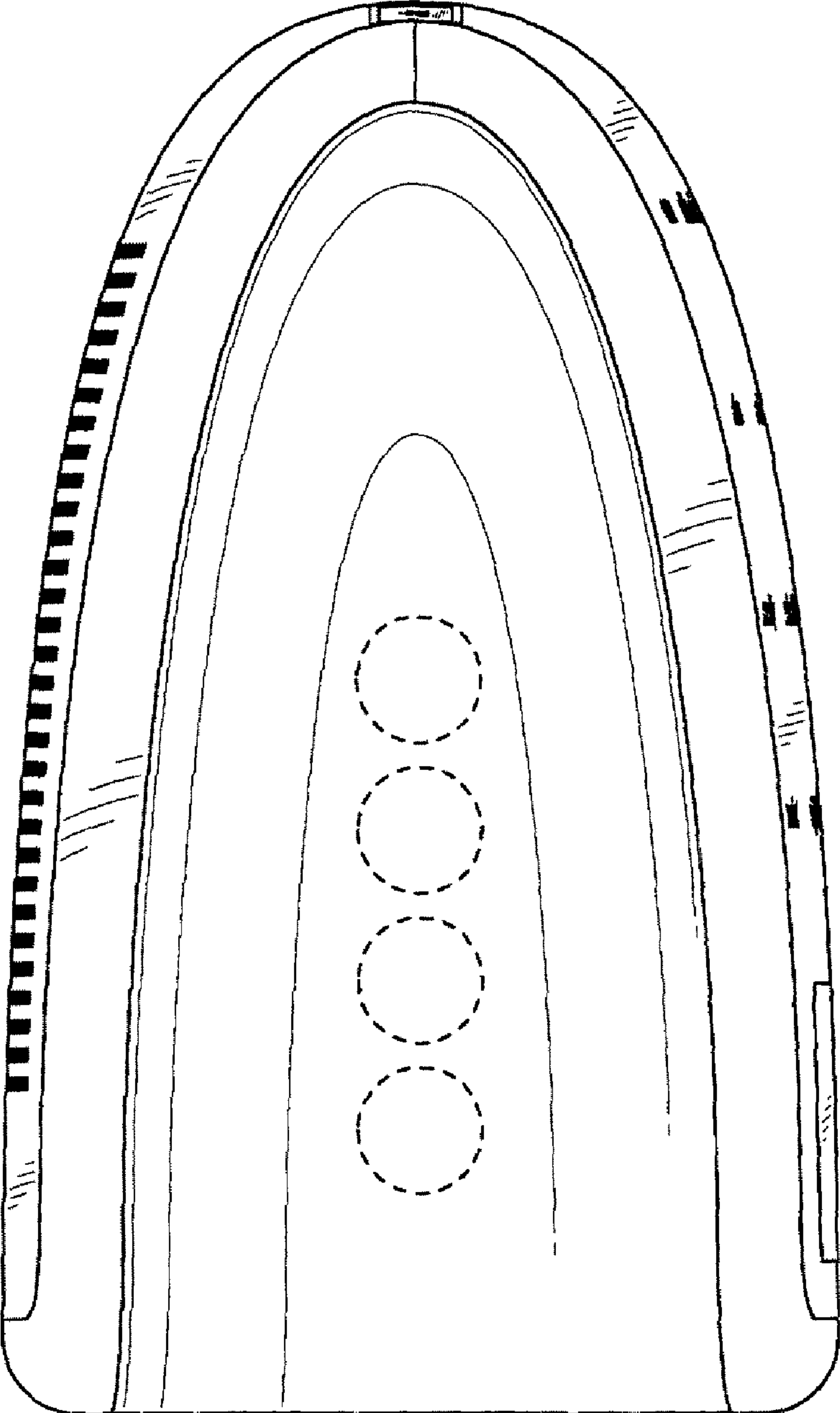

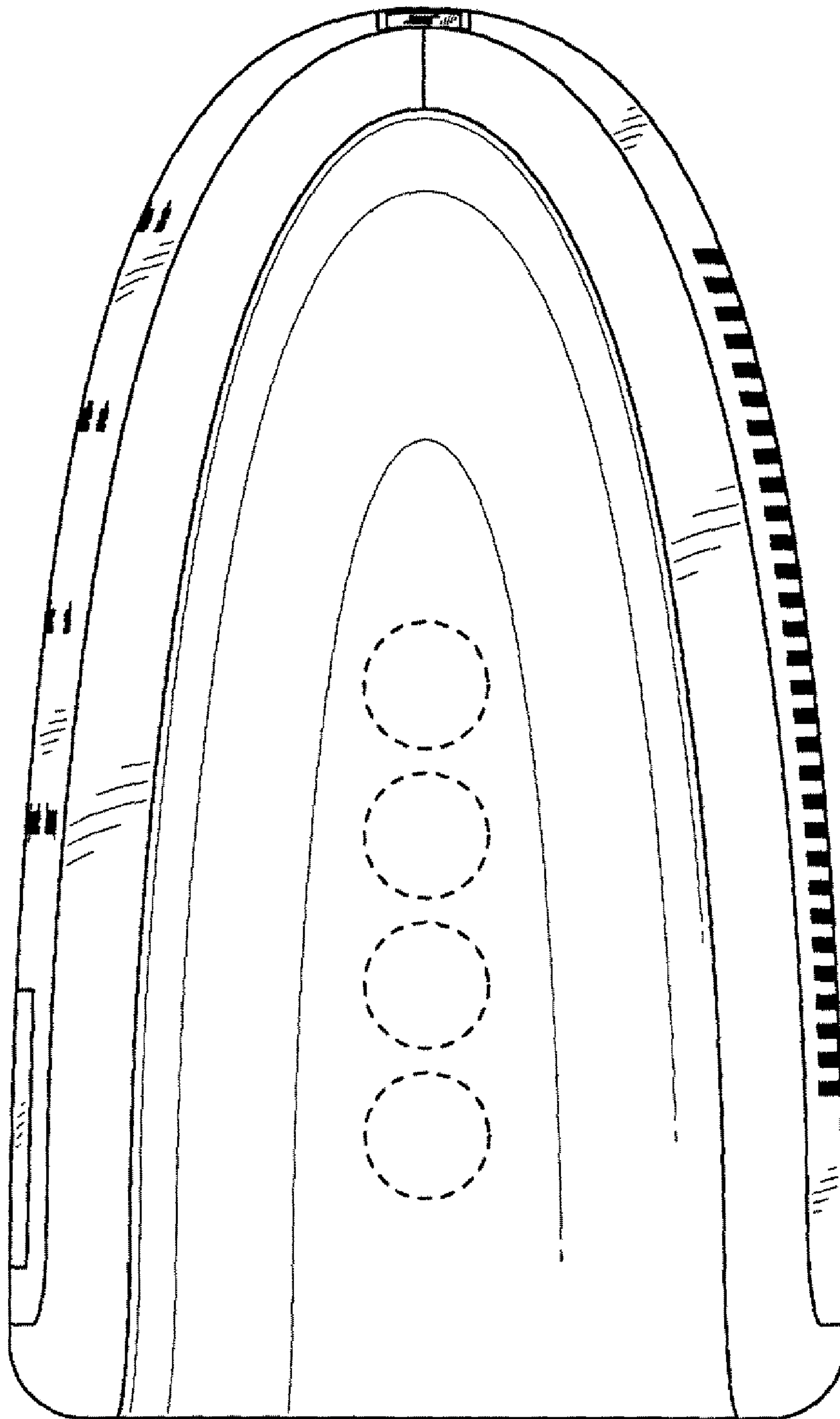

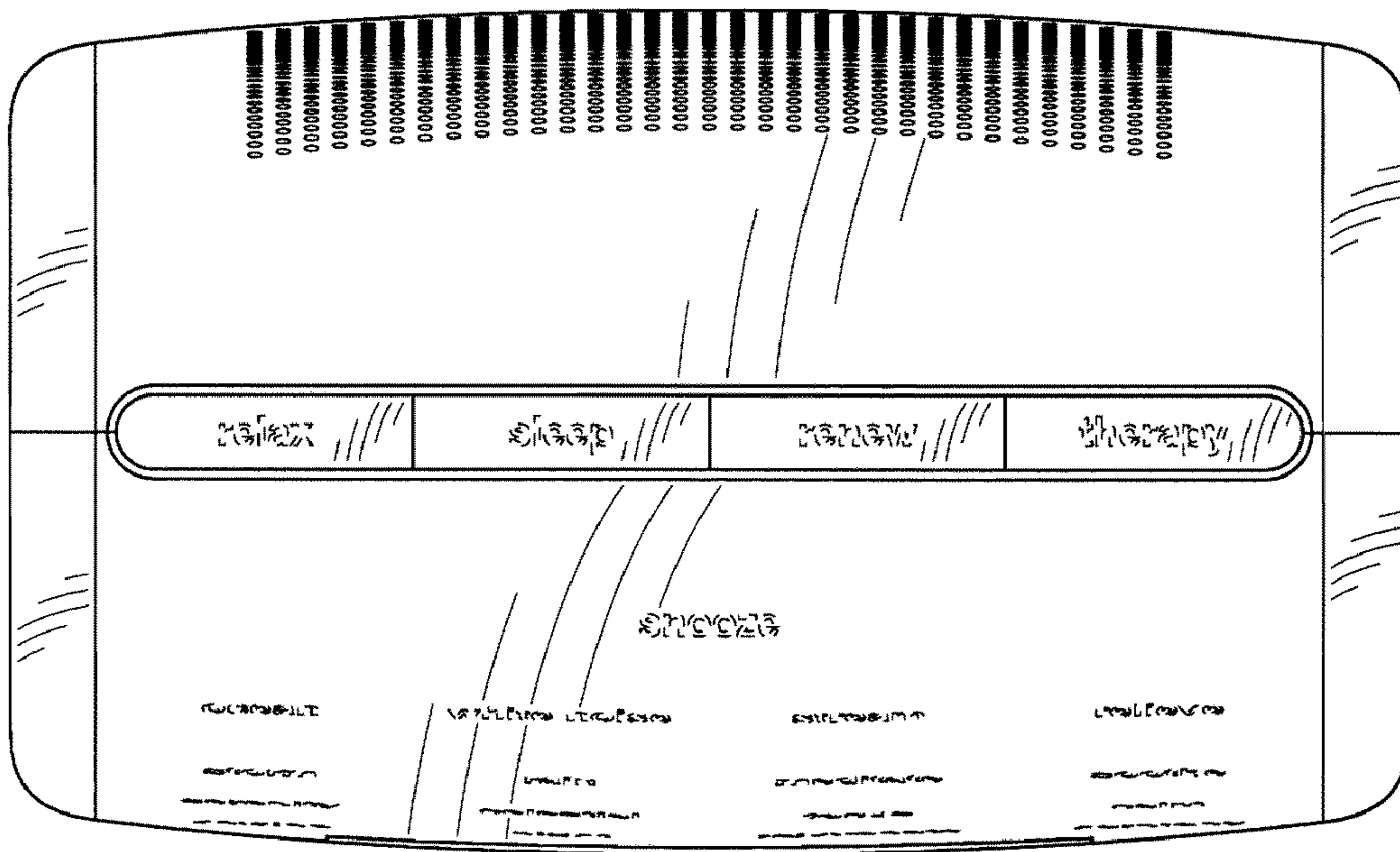

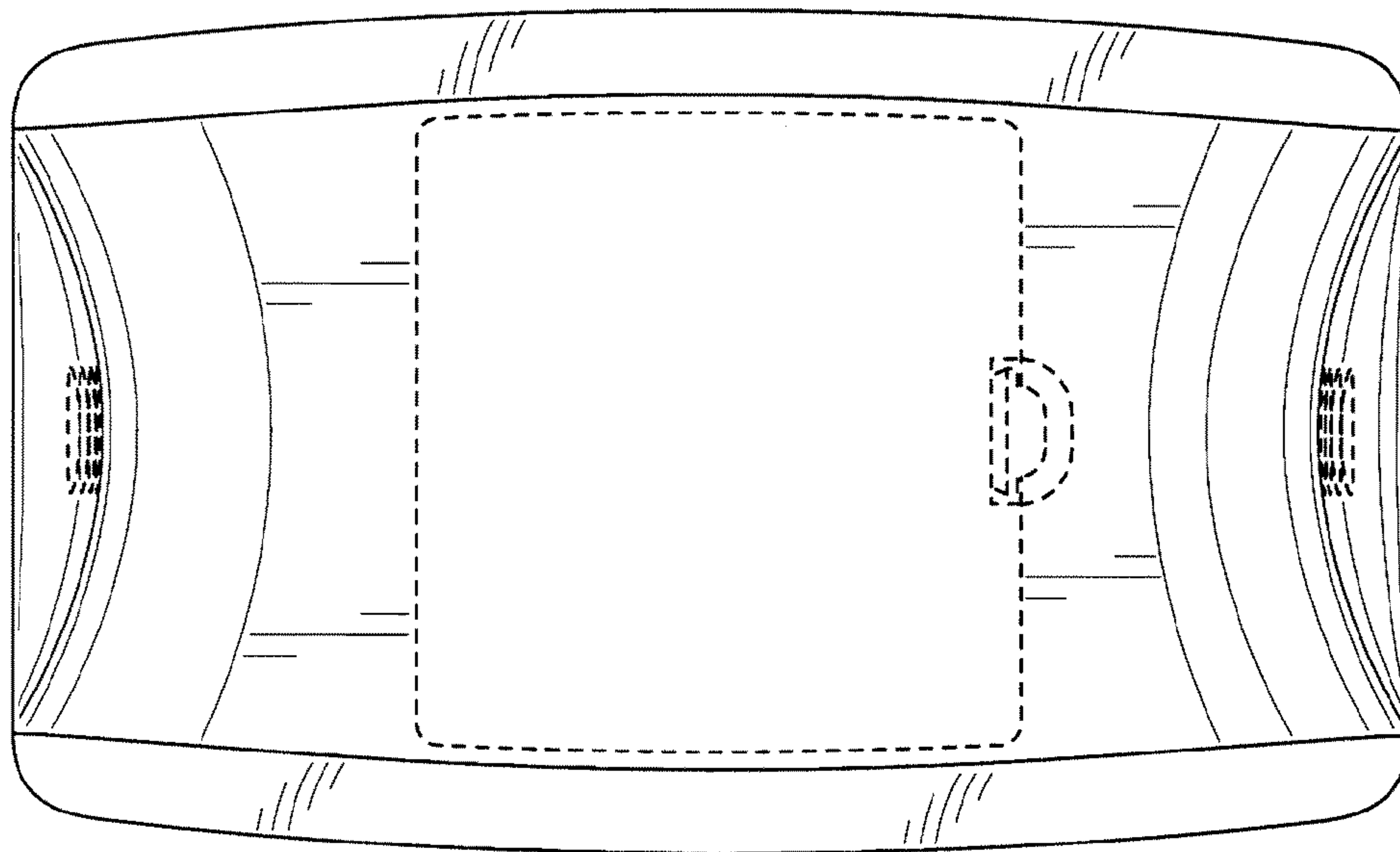
