We claim the ornamental design for a truck cab, as shown and described.

FIG. 4 is a right side view of the truck cab shown in FIGS. 1 and 2;

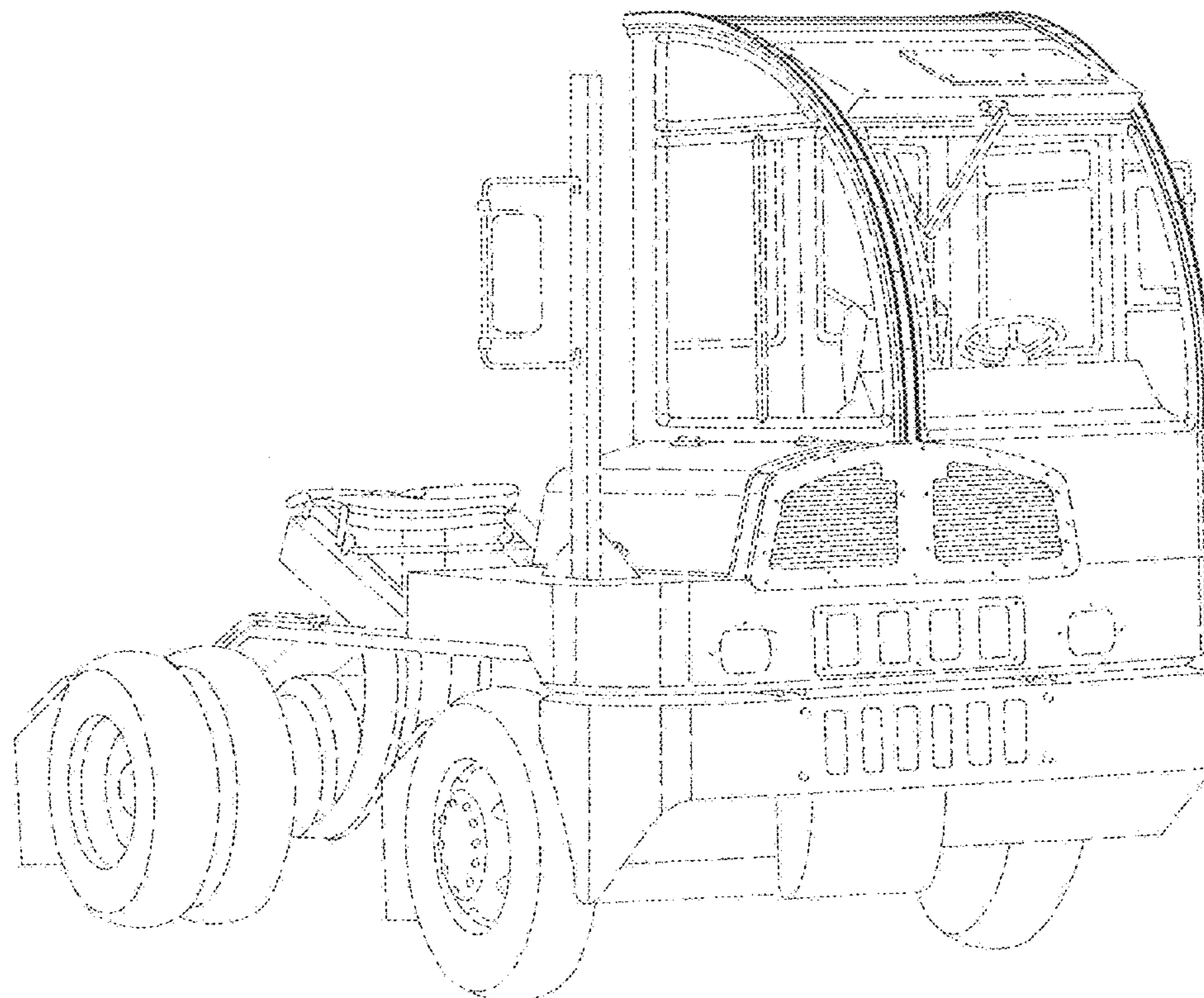
FIG. 5 is a left side view of the truck cab shown in FIGS. 1 and 2;

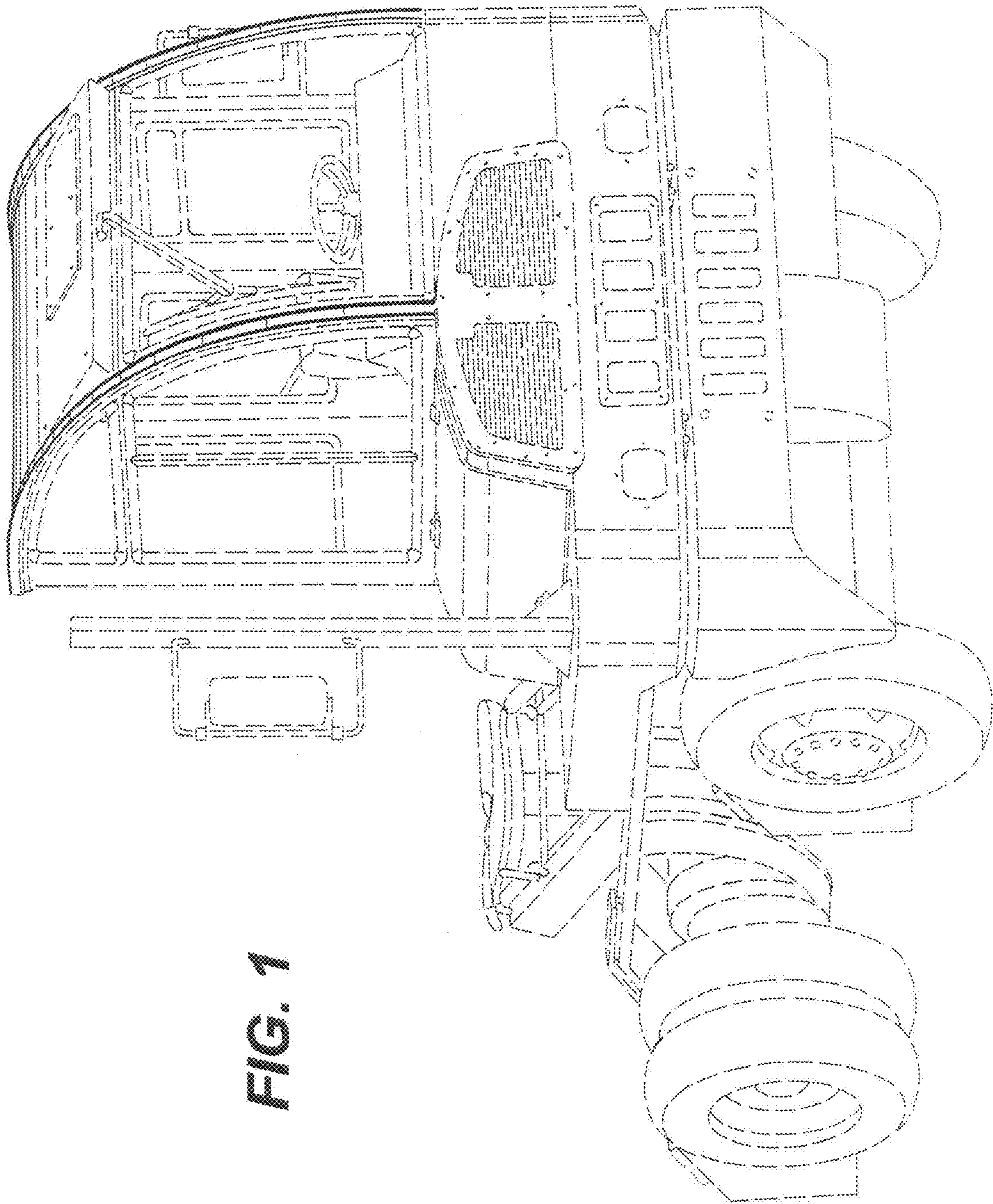
FIG. 6 is a rear view of the truck cab shown in FIGS. 1 and 2; and,

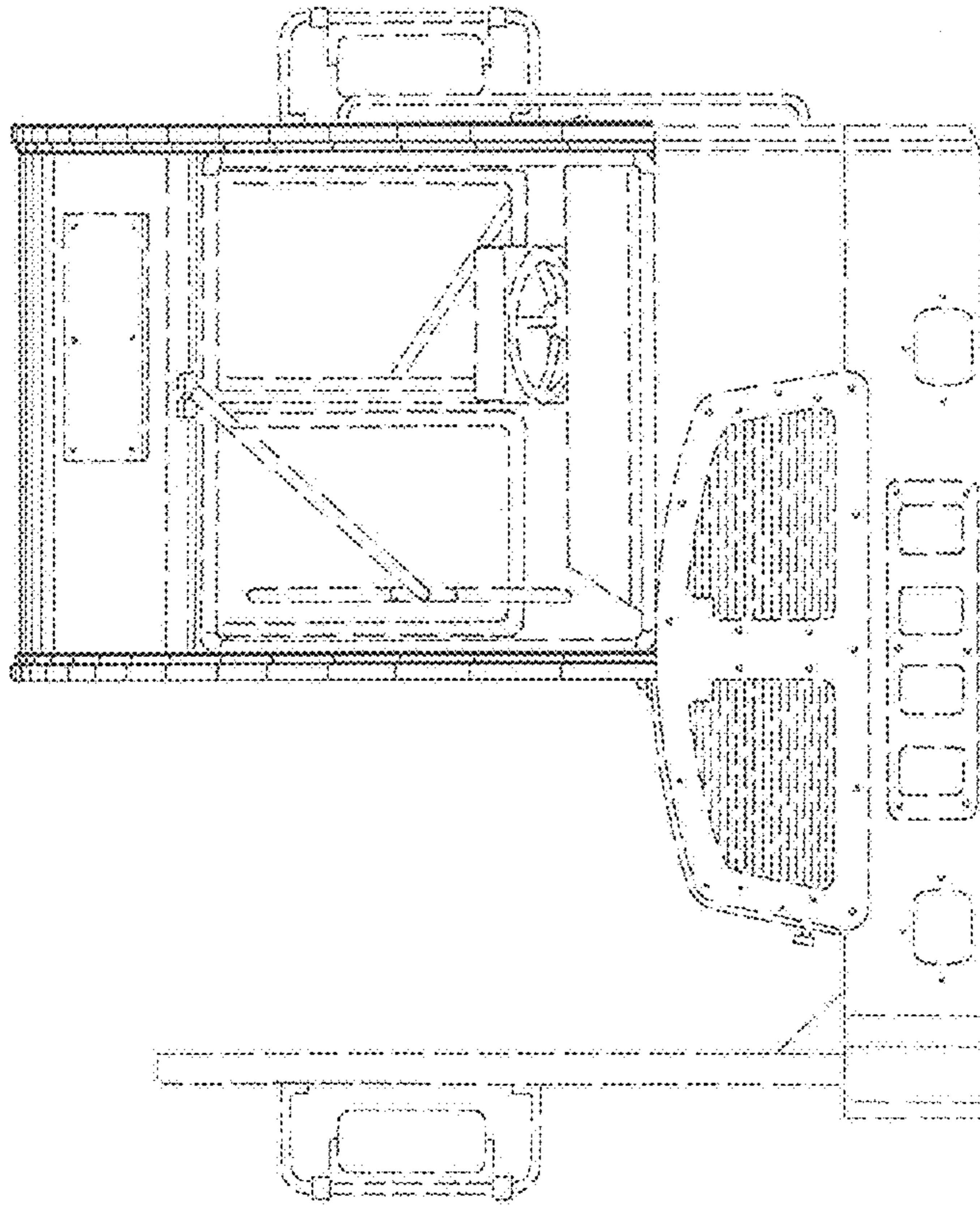
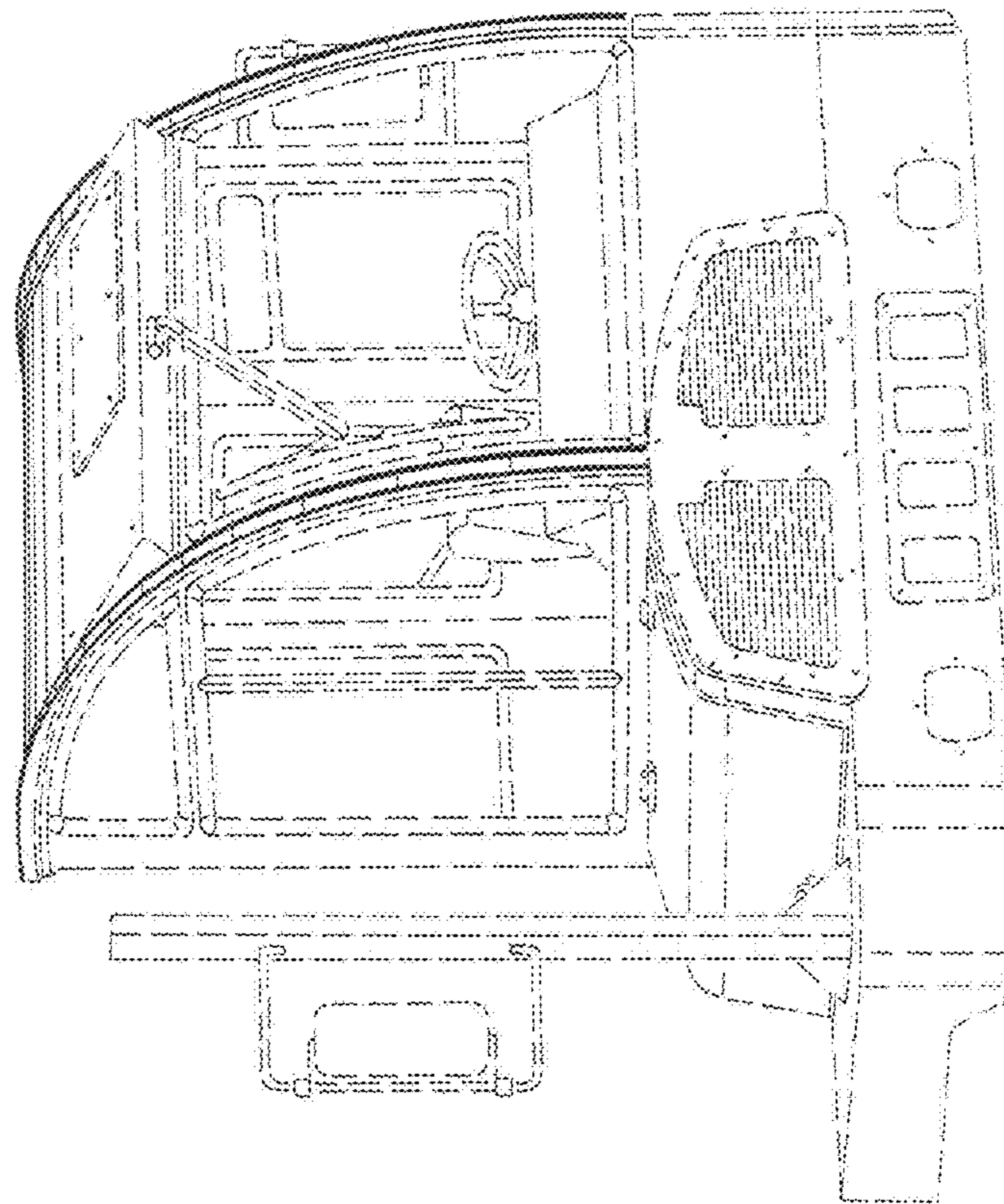
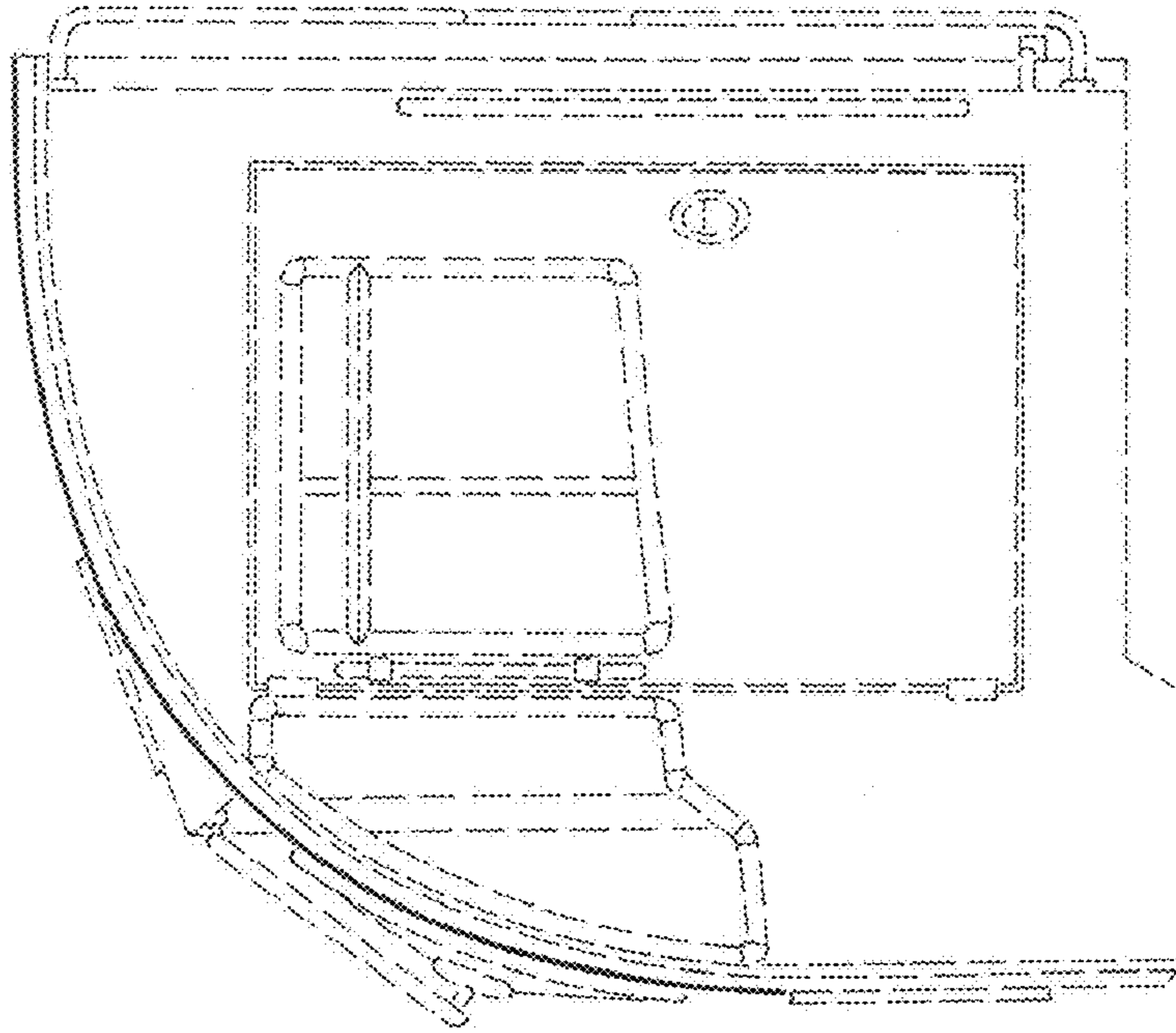


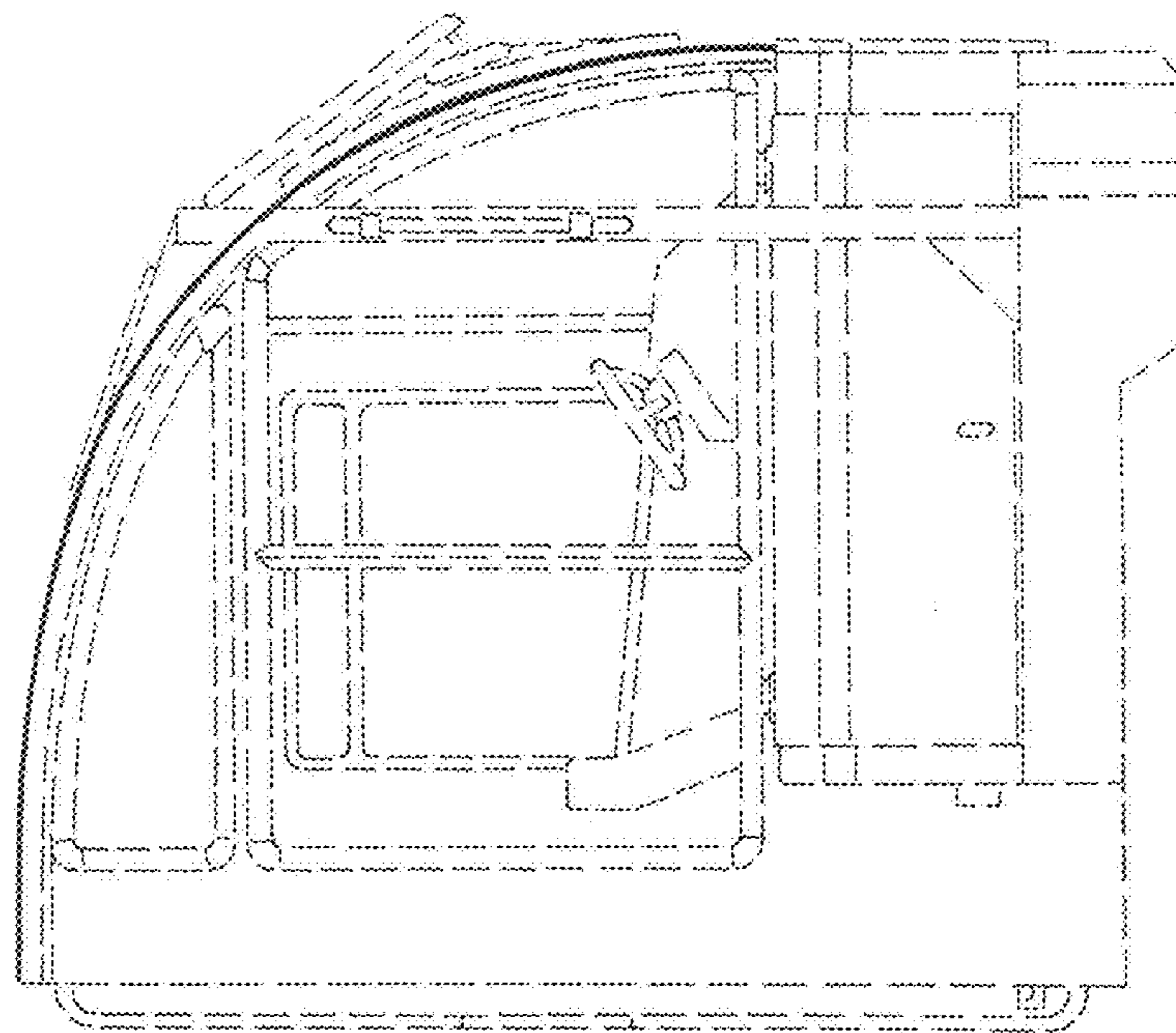

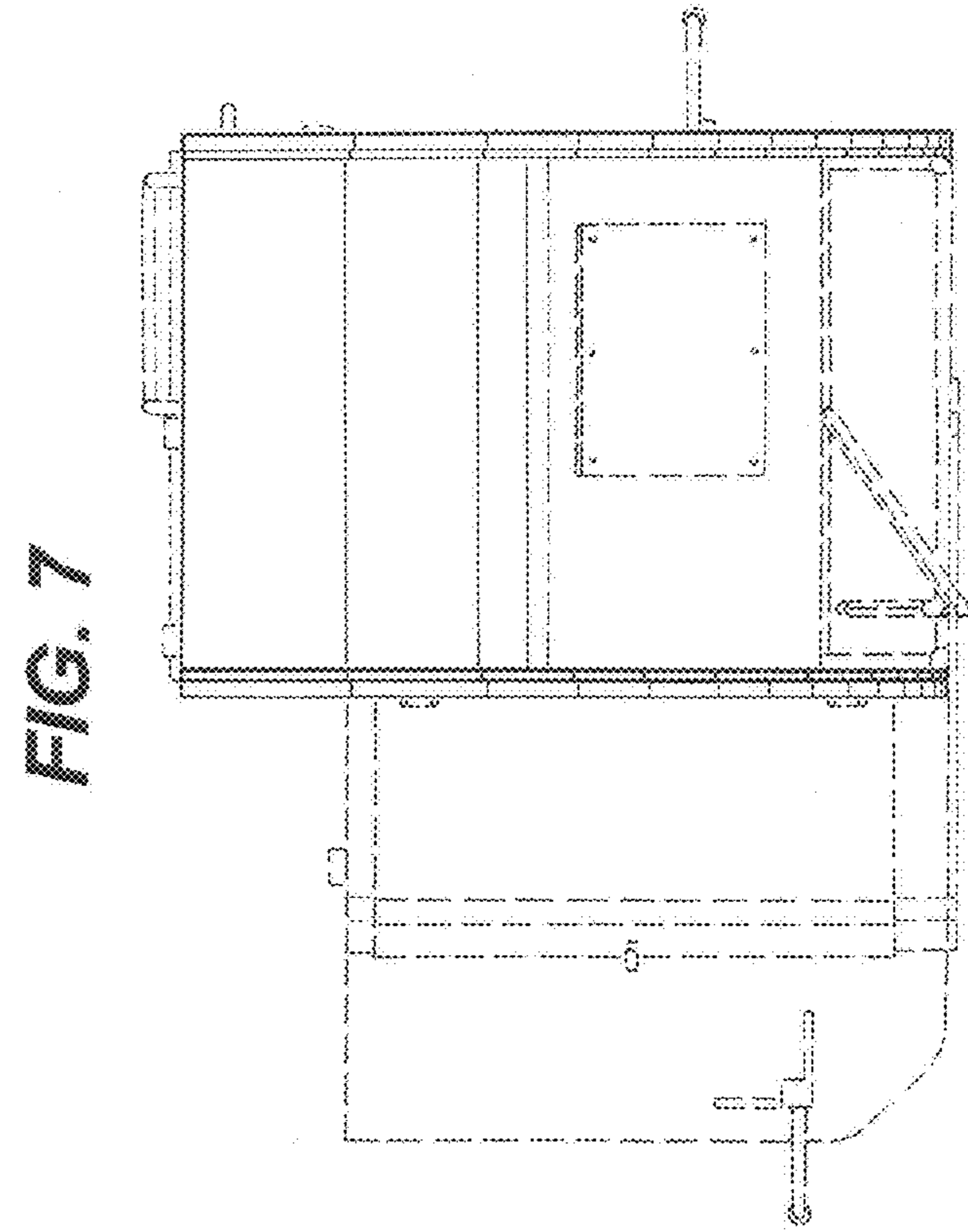

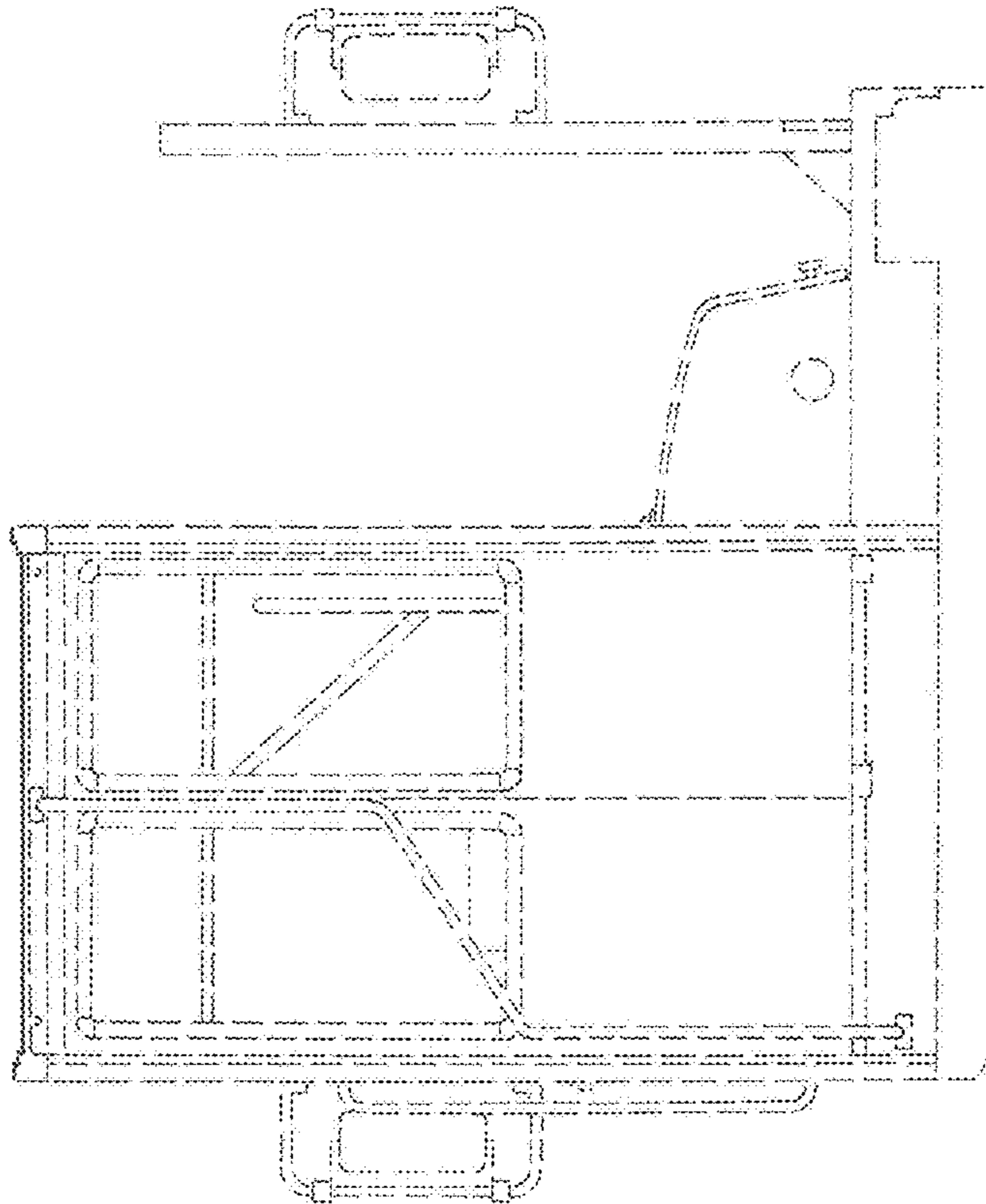
