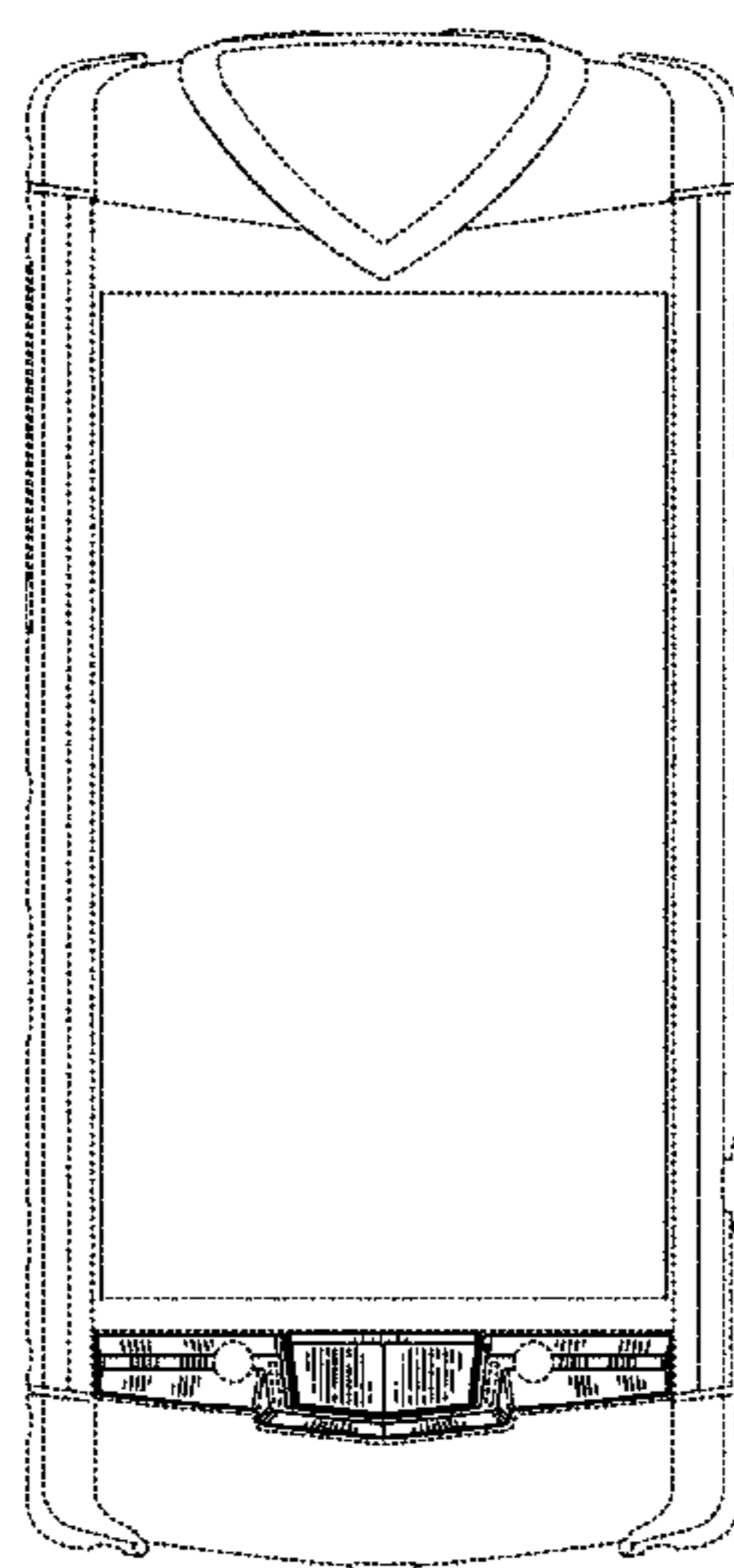
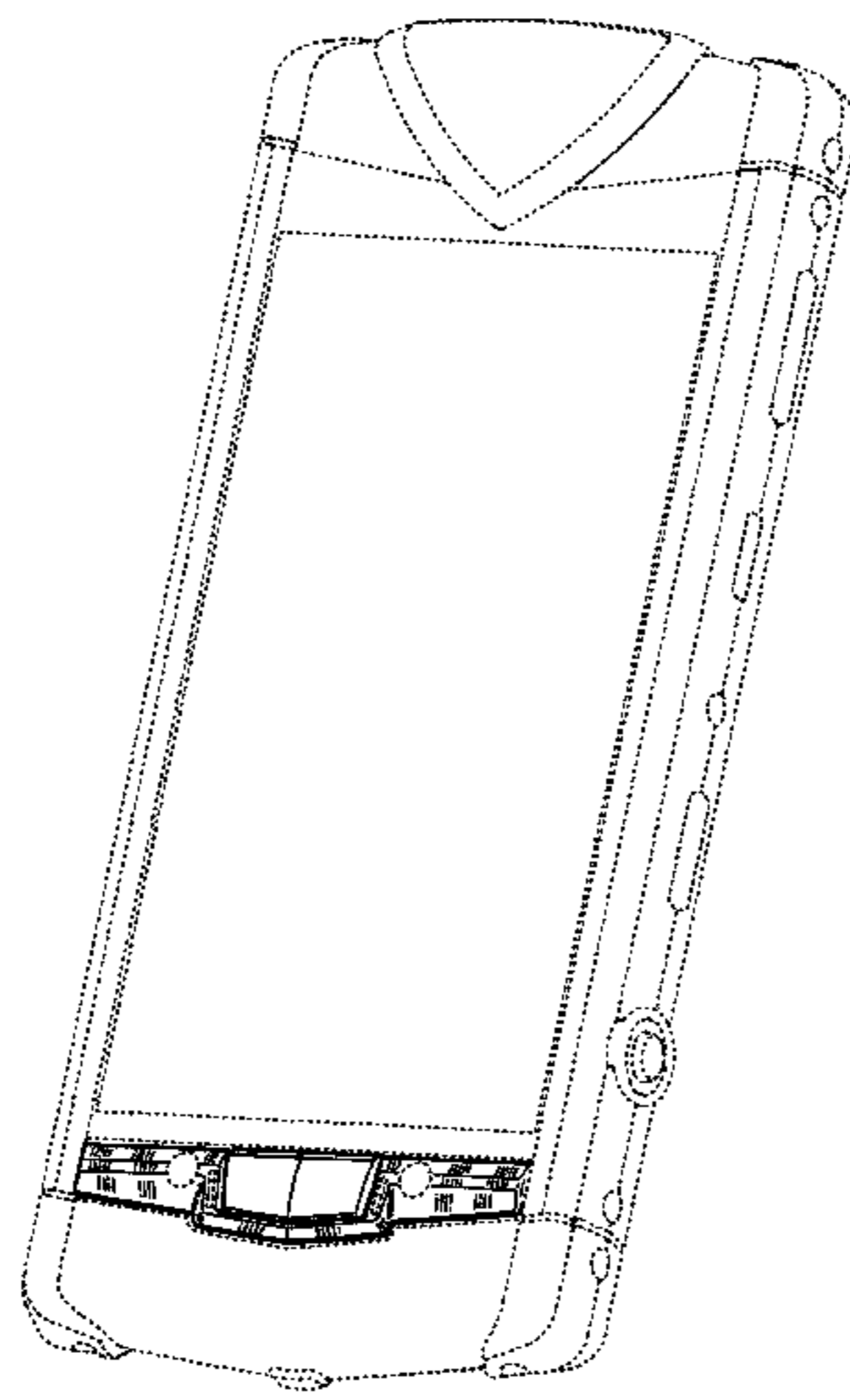
The ornamental design for a set of handset keys, as shown and described.

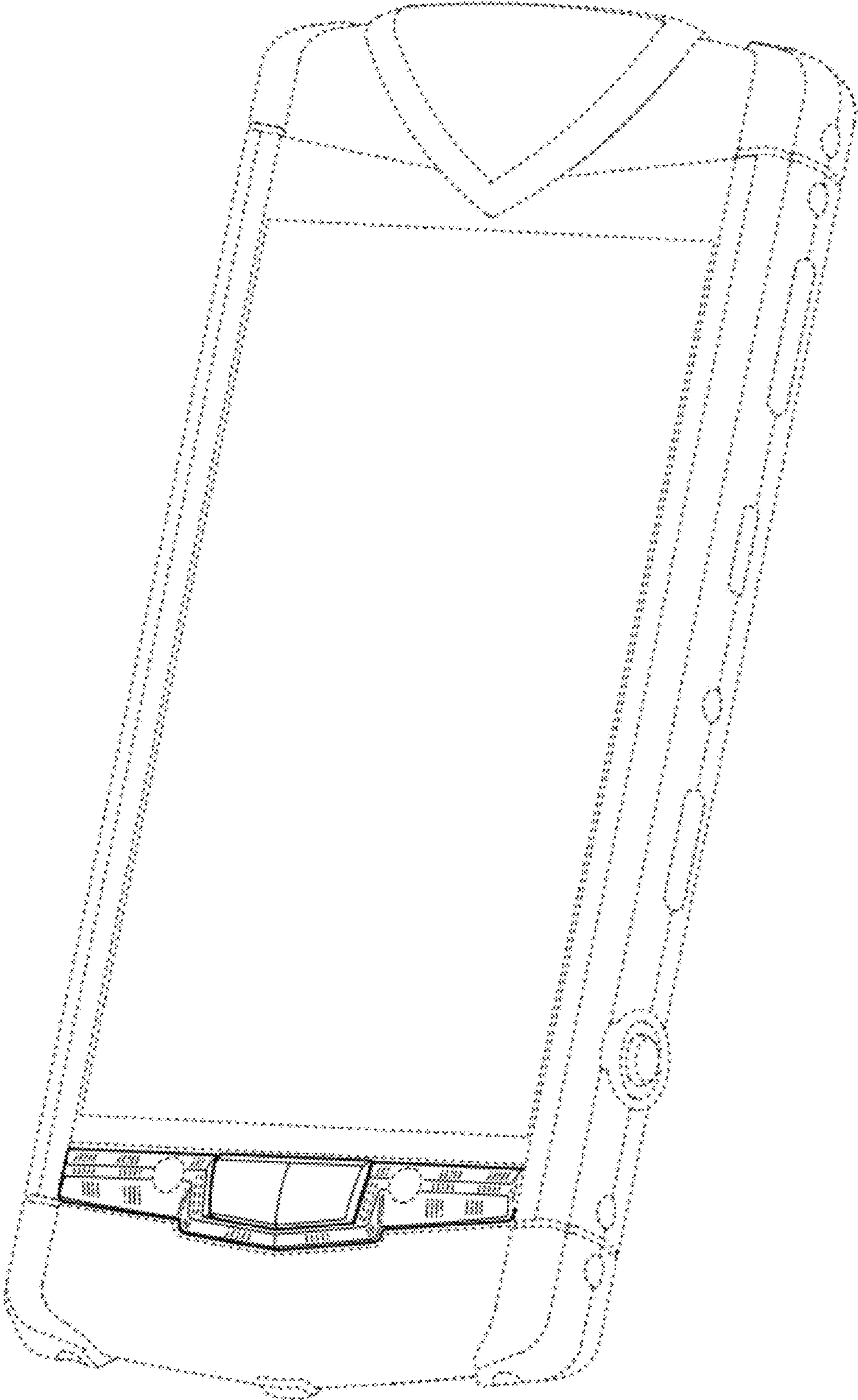

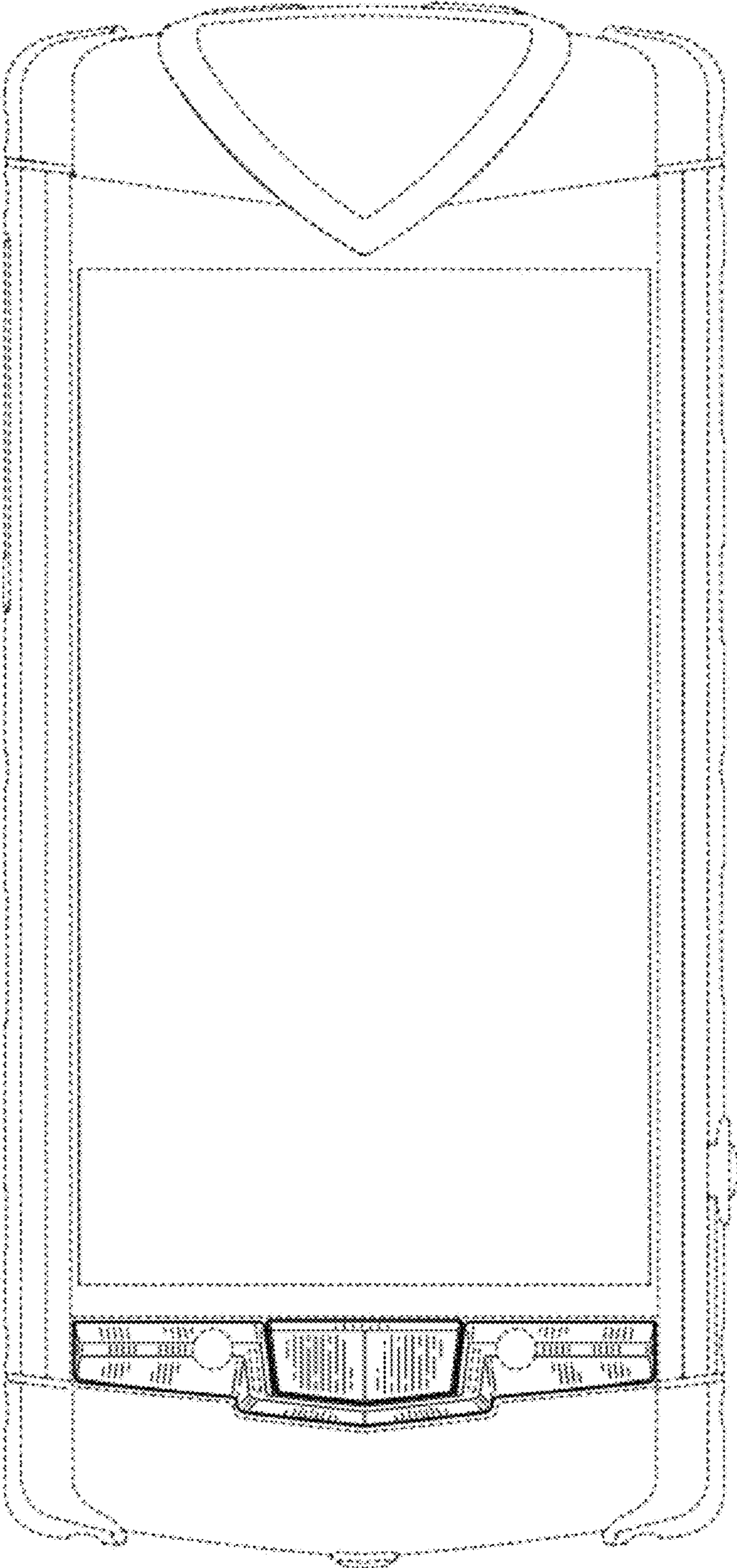

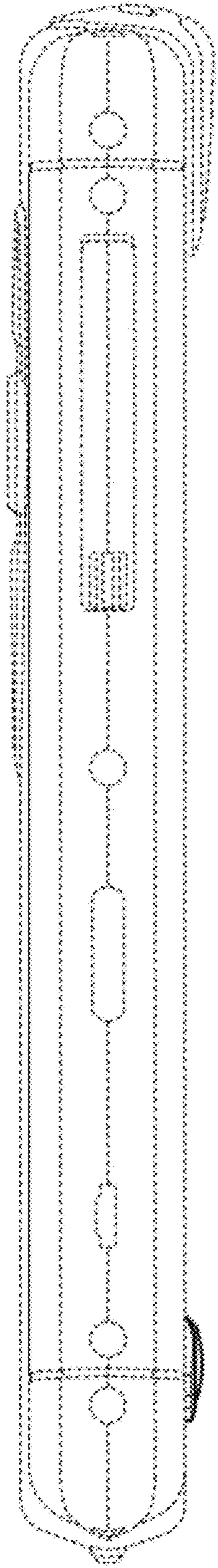

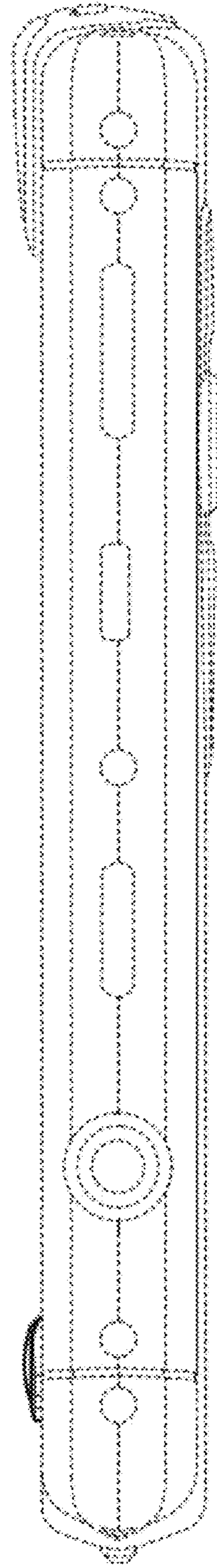

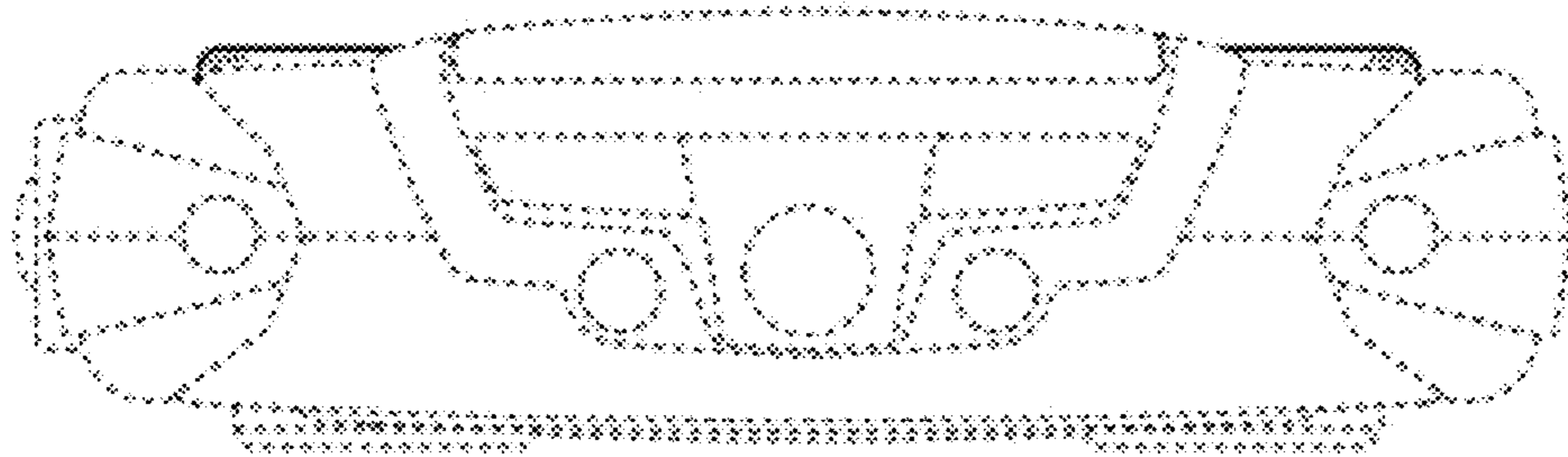

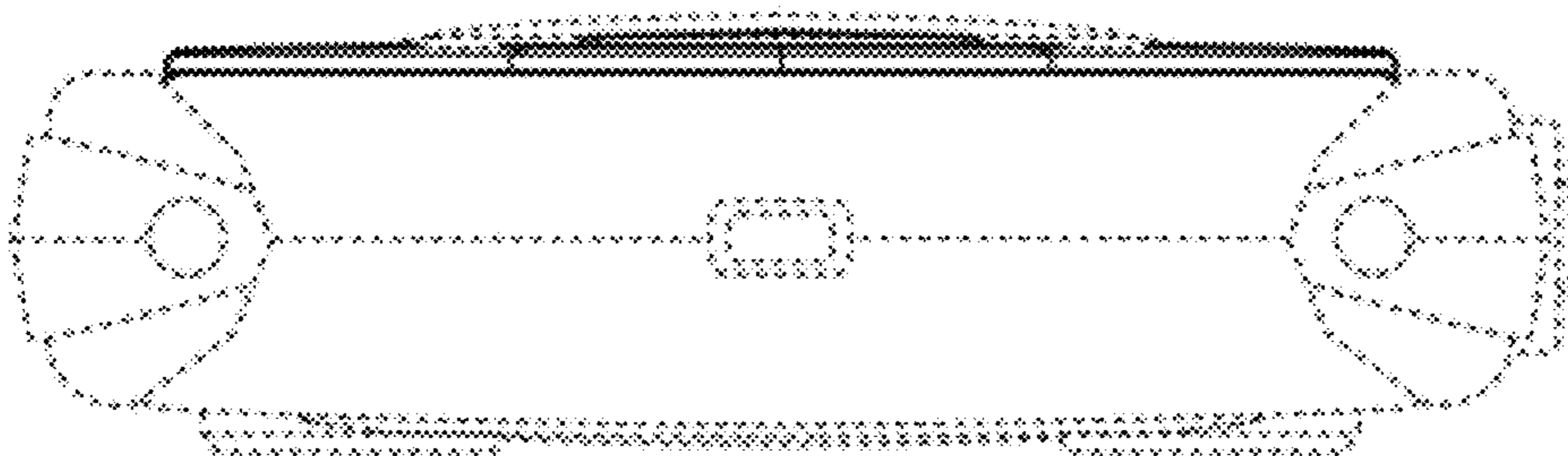

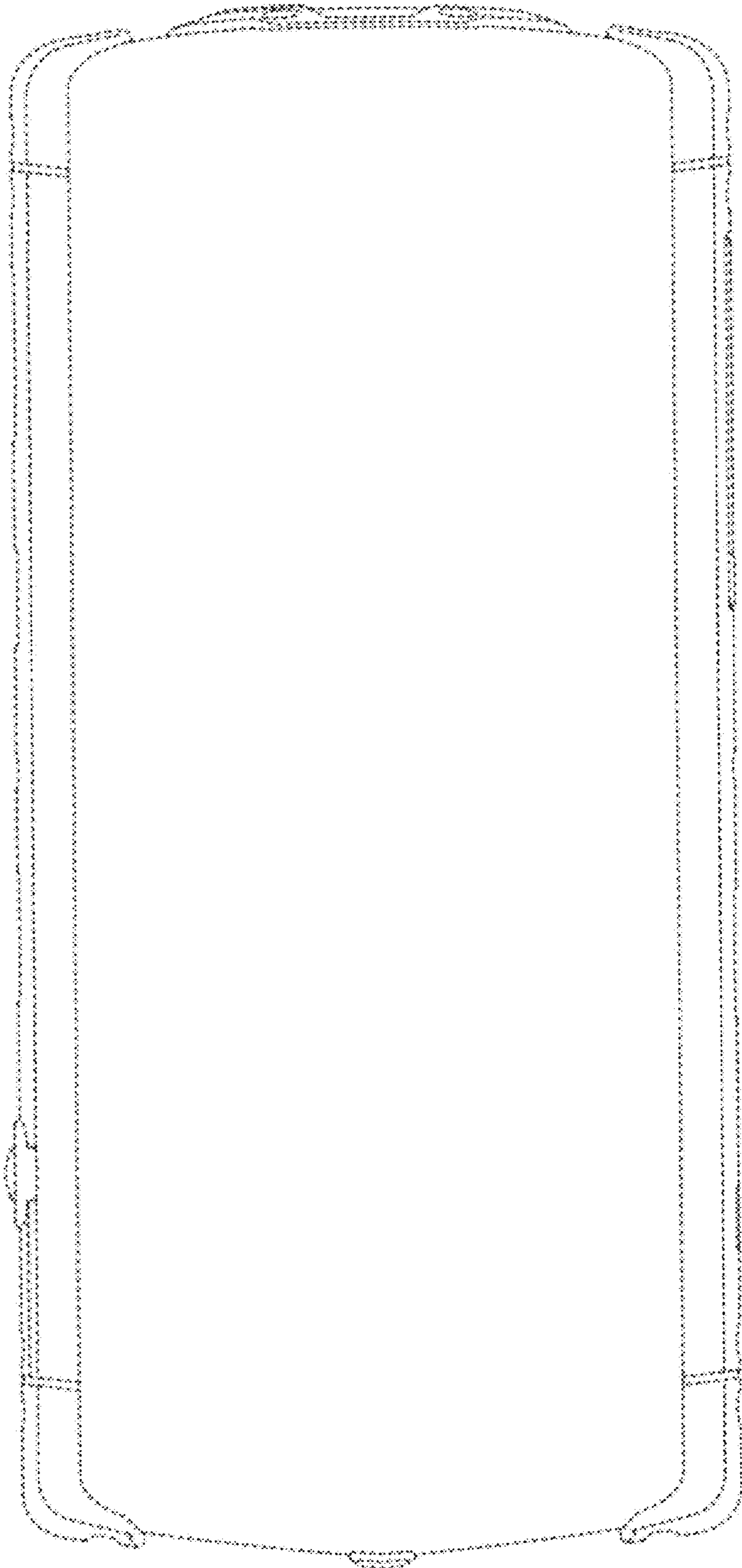
