(57) **CLAIM**

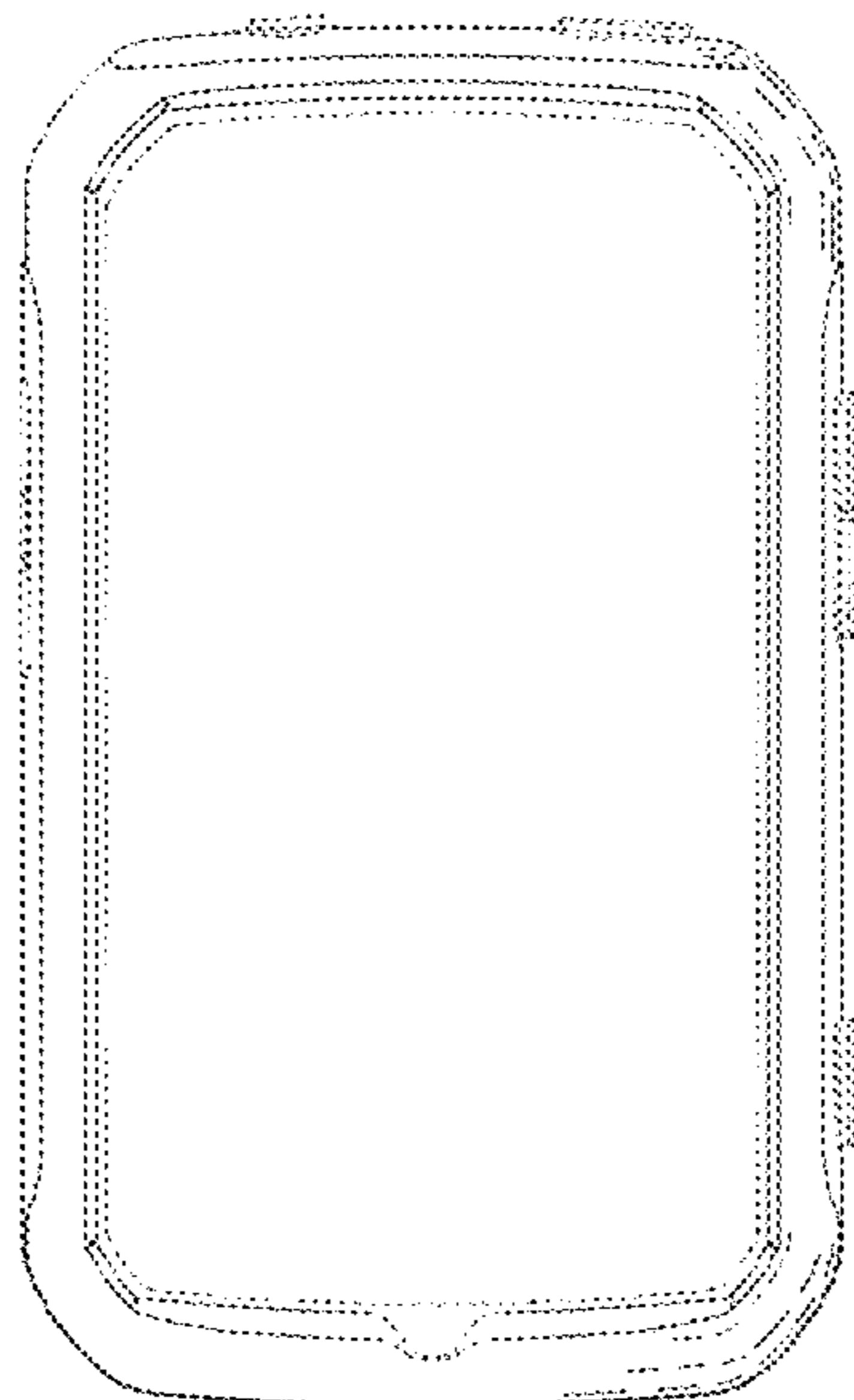
The ornamental design for a case for electronic device, as shown and described.

DESCRIPTION

FIG. 1 is a front isometric view of a case for electronic device showing our new design;

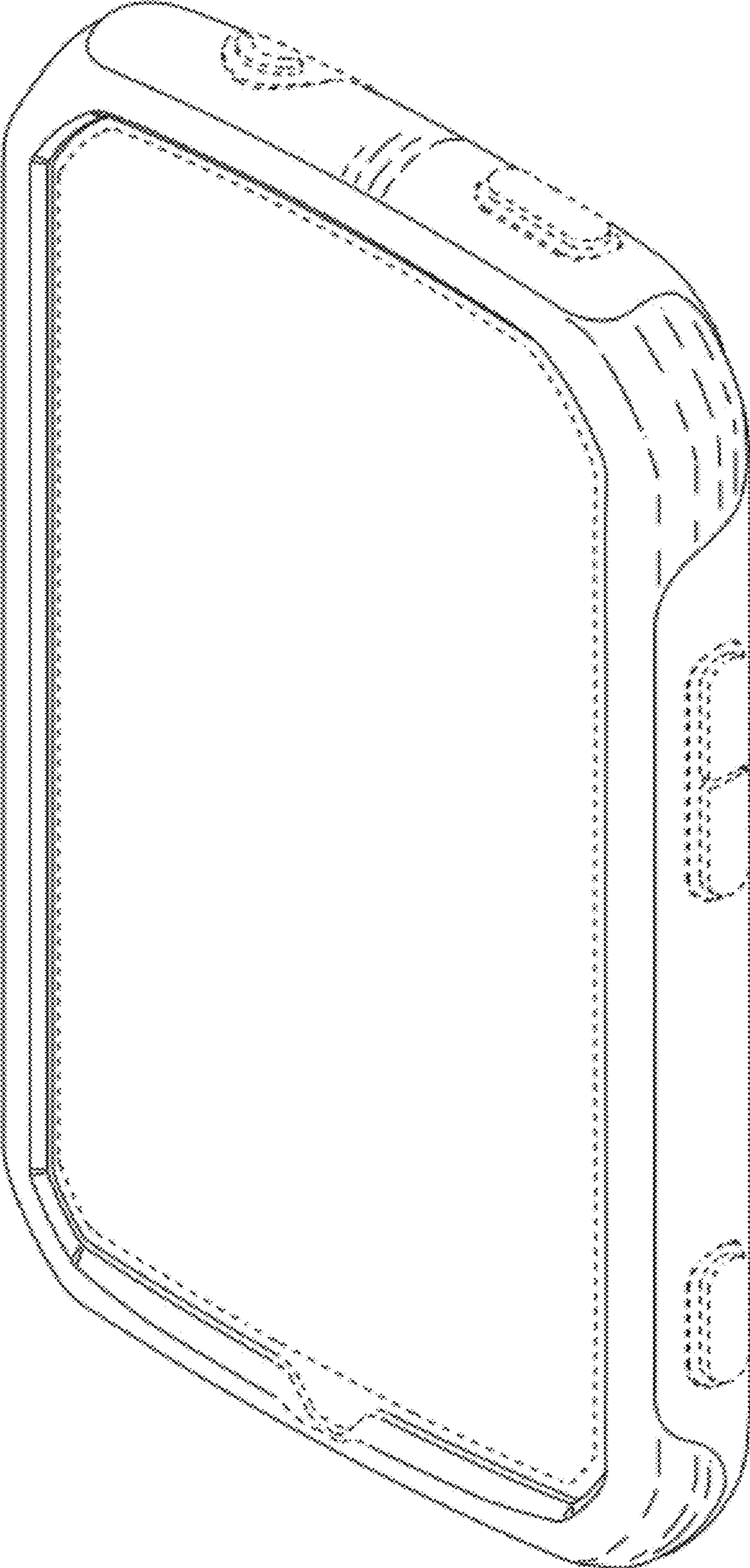

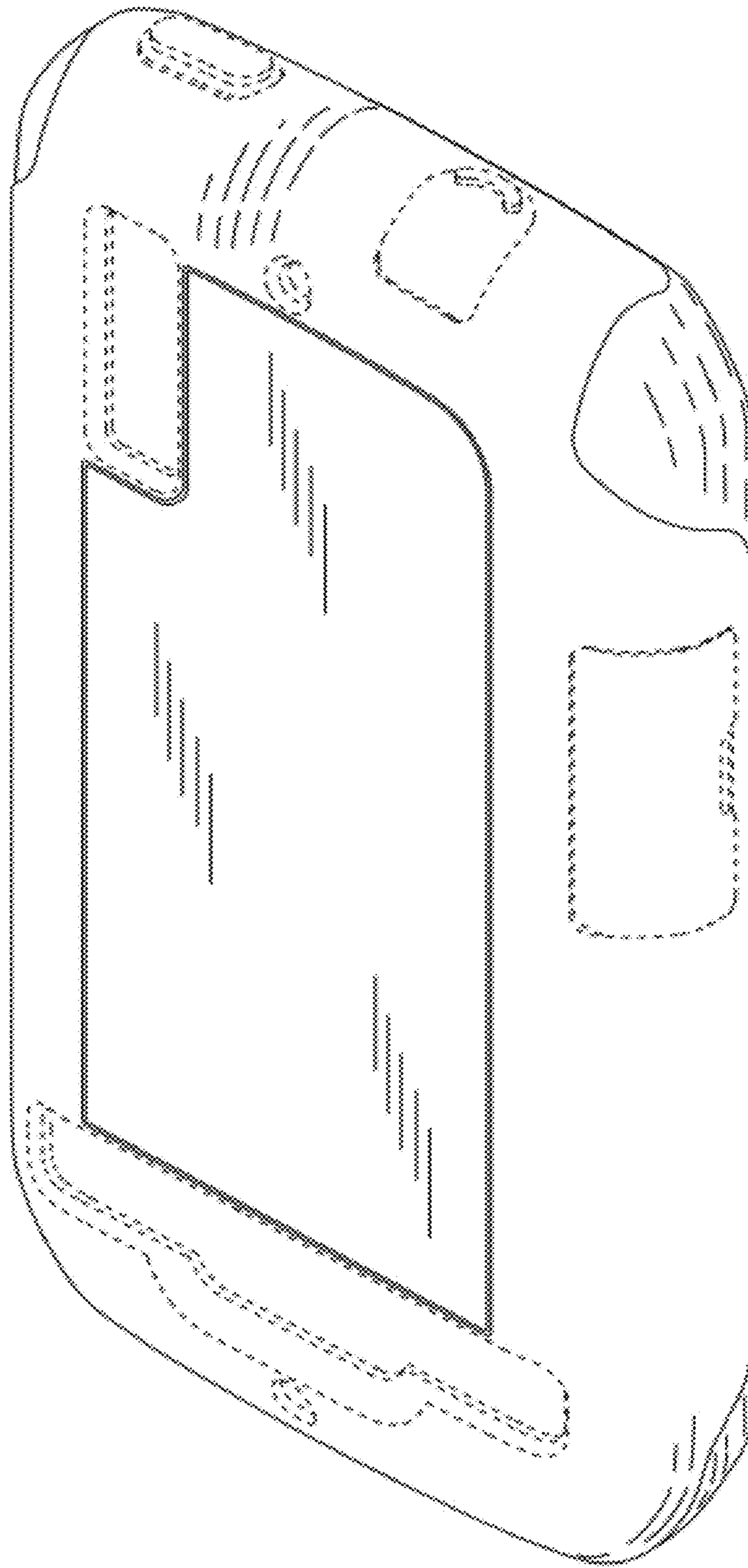

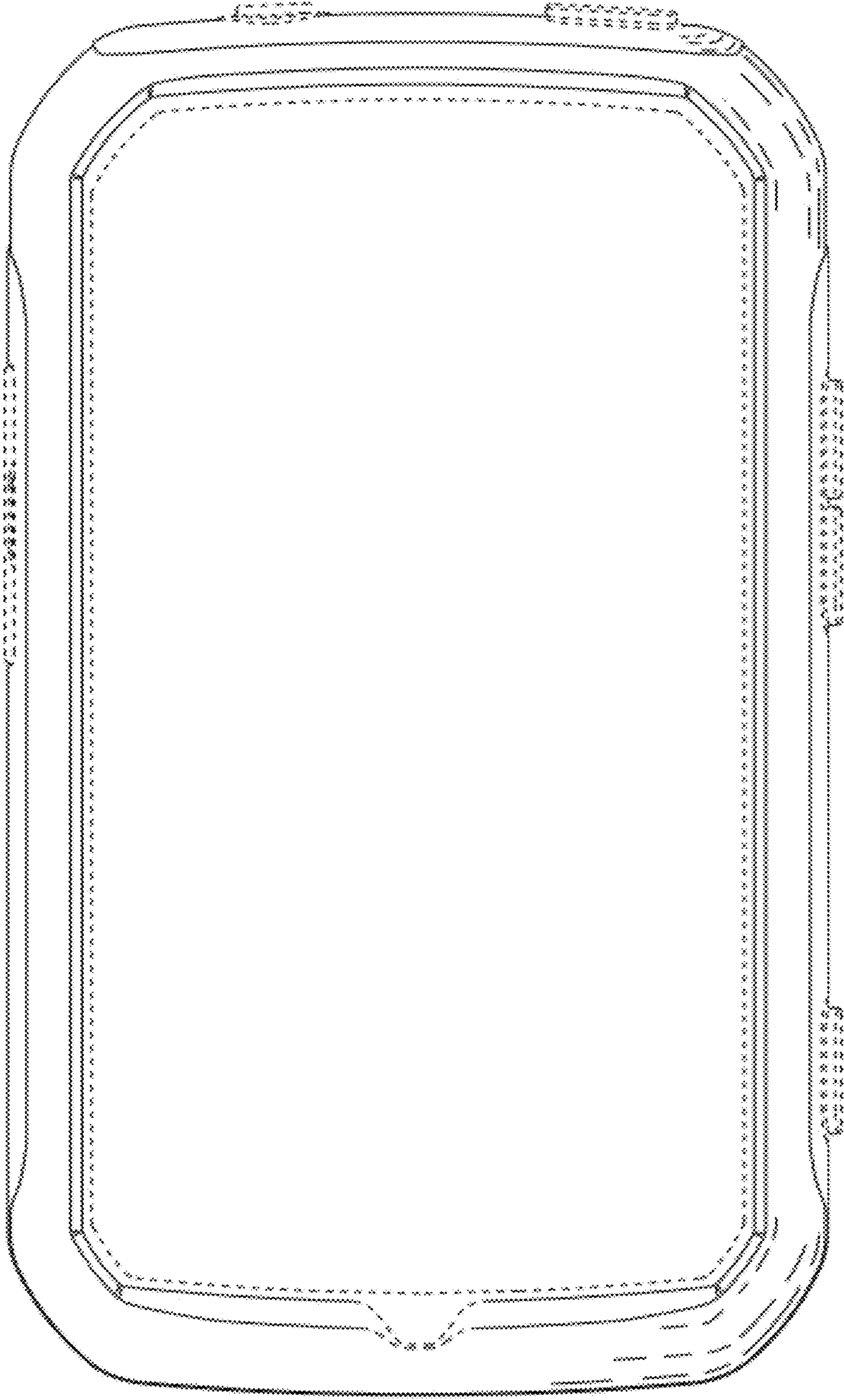

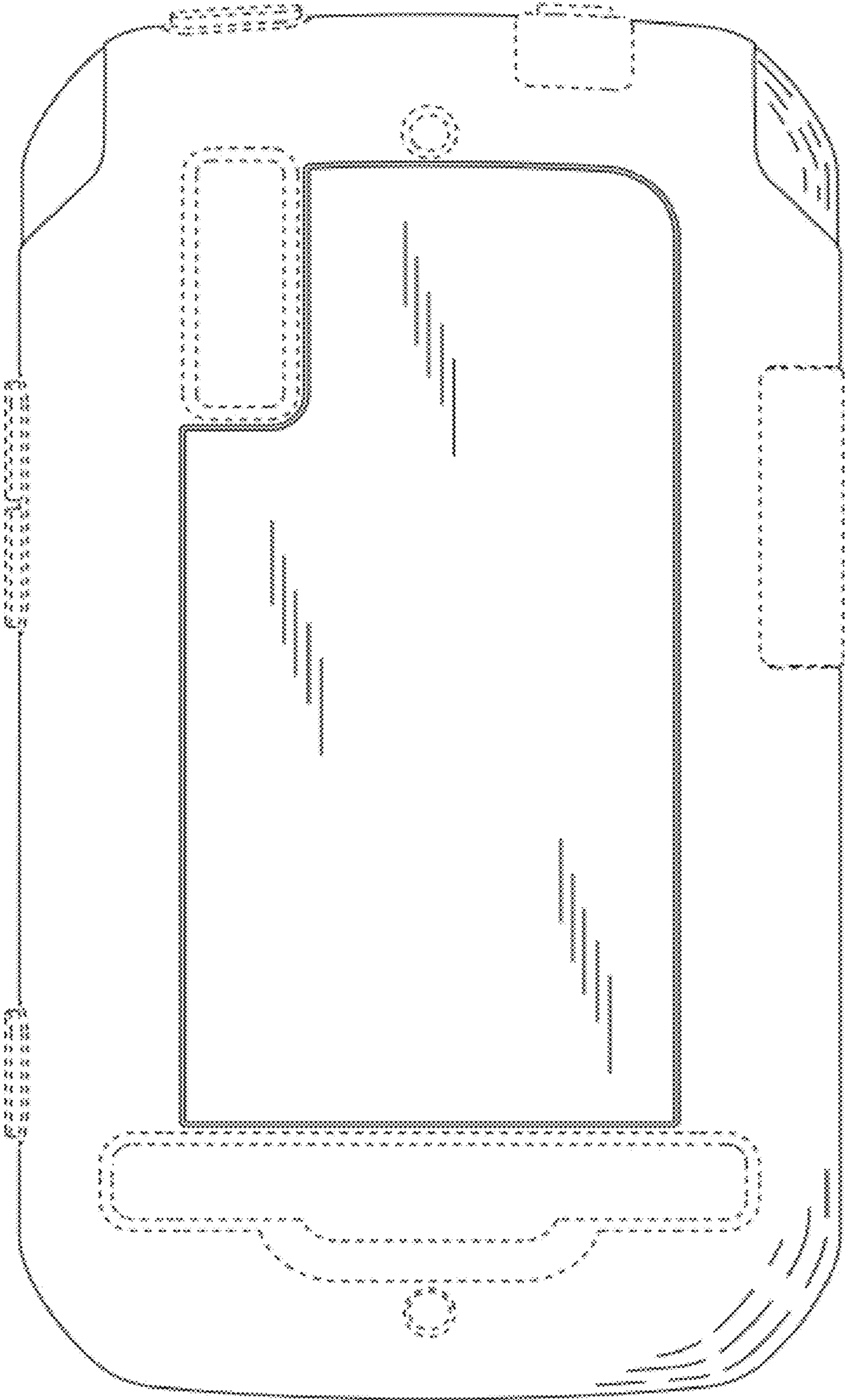

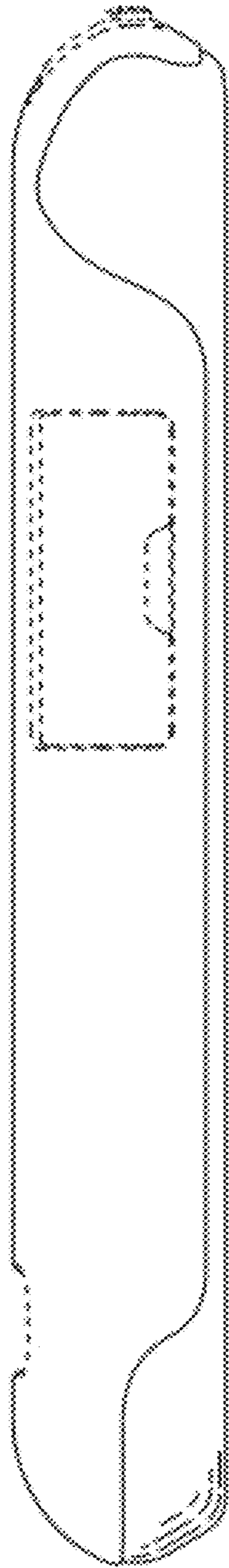

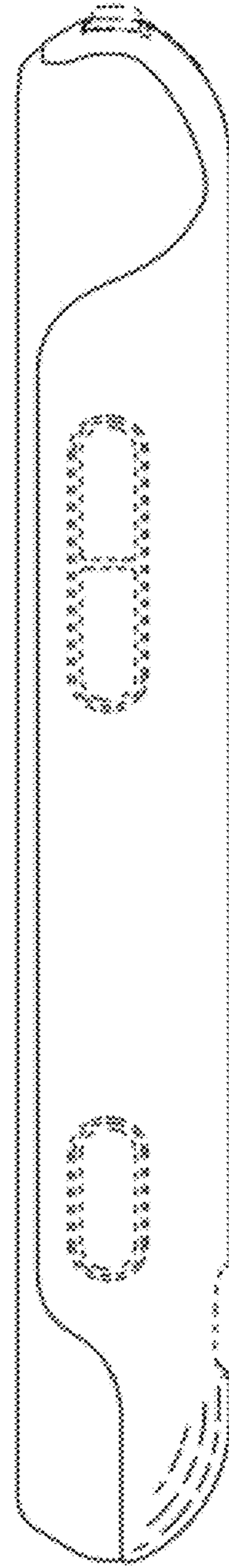

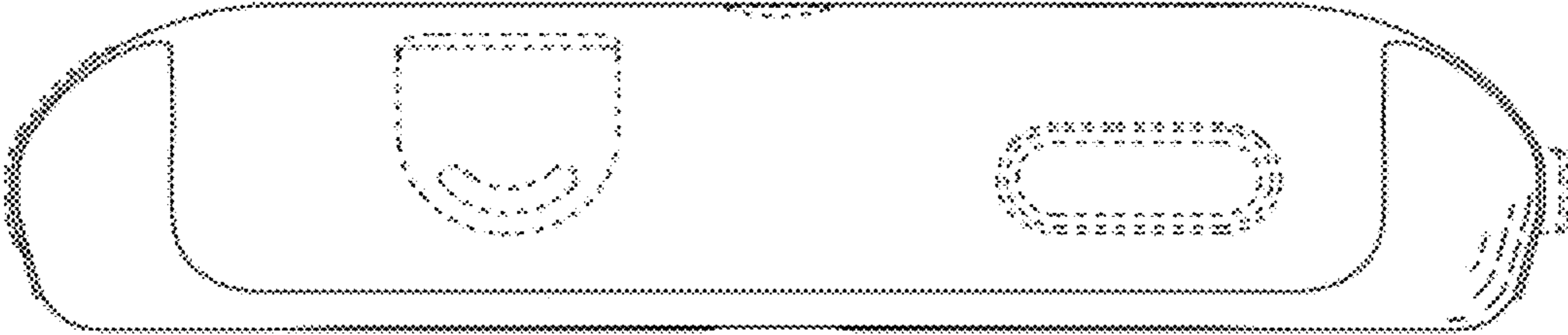
