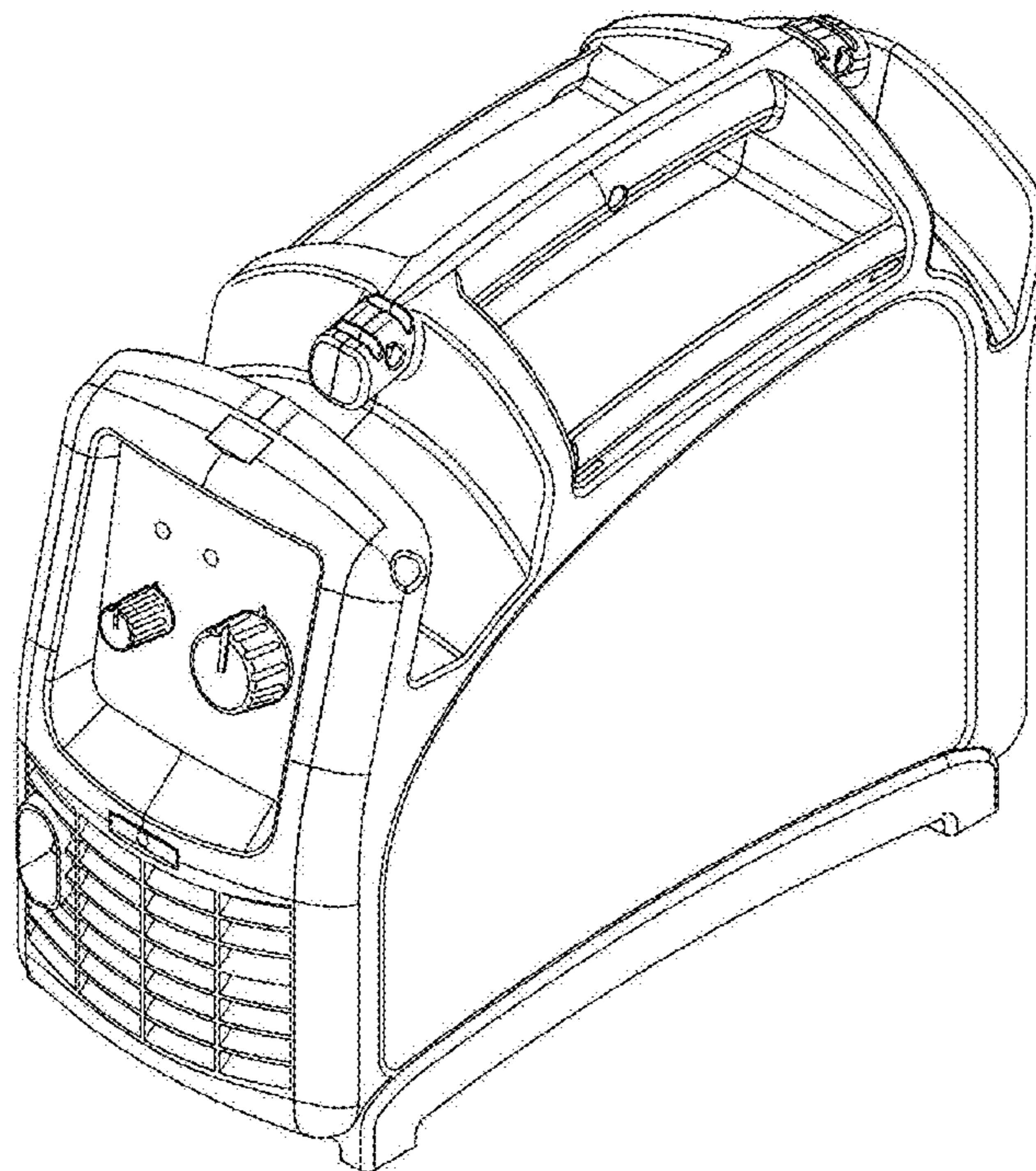
(57) **CLAIM**

The ornamental design for a power source for welding, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a power source for welding, in accordance with the present invention;
FIG. 2 is a front elevation view of the power source for welding shown in FIG. 1;
FIG. 3 is a rear elevation view of the power source for welding shown in FIG. 1;
FIG. 4 is a right side elevation view of the power source for welding shown in FIG. 1;

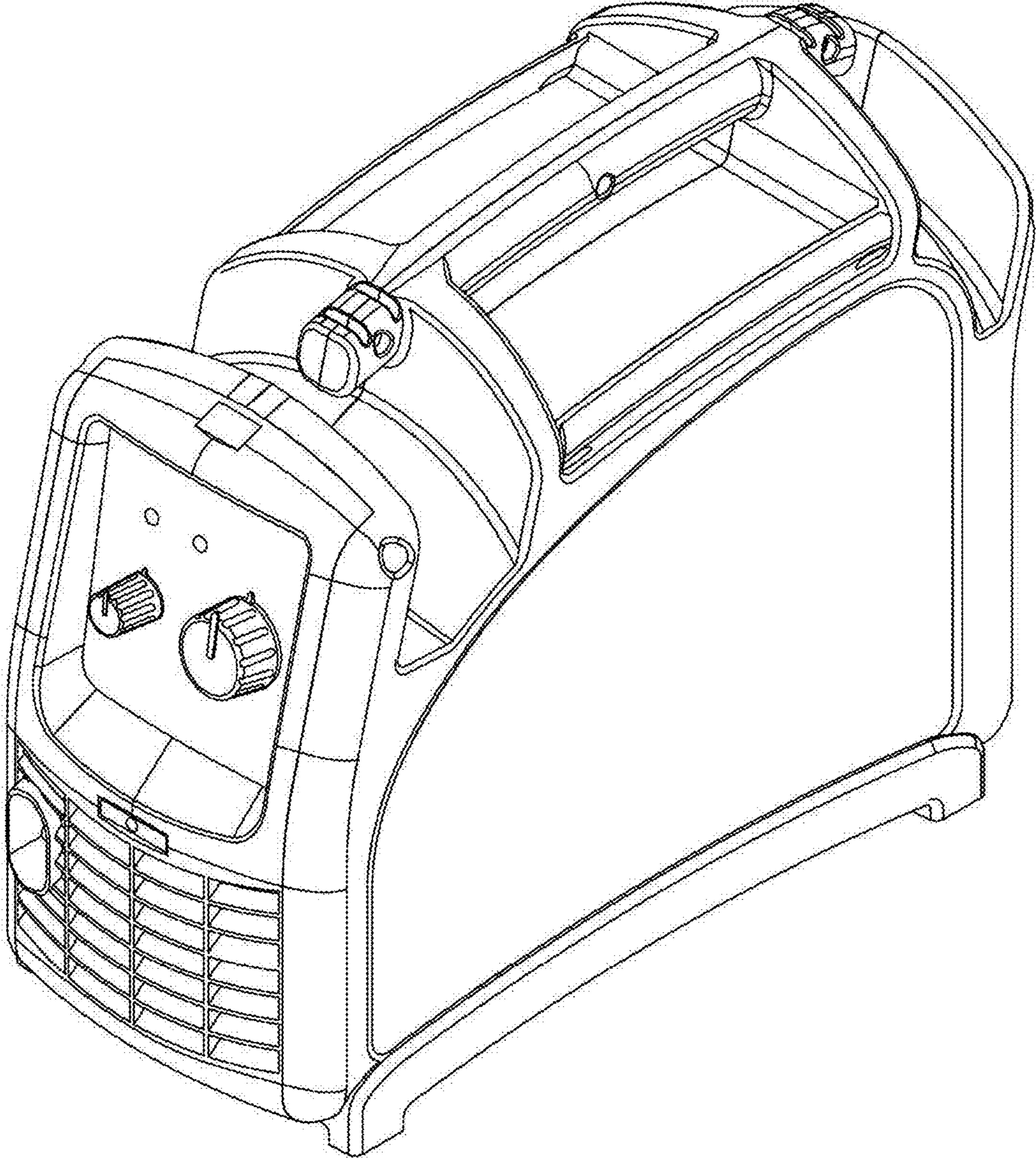

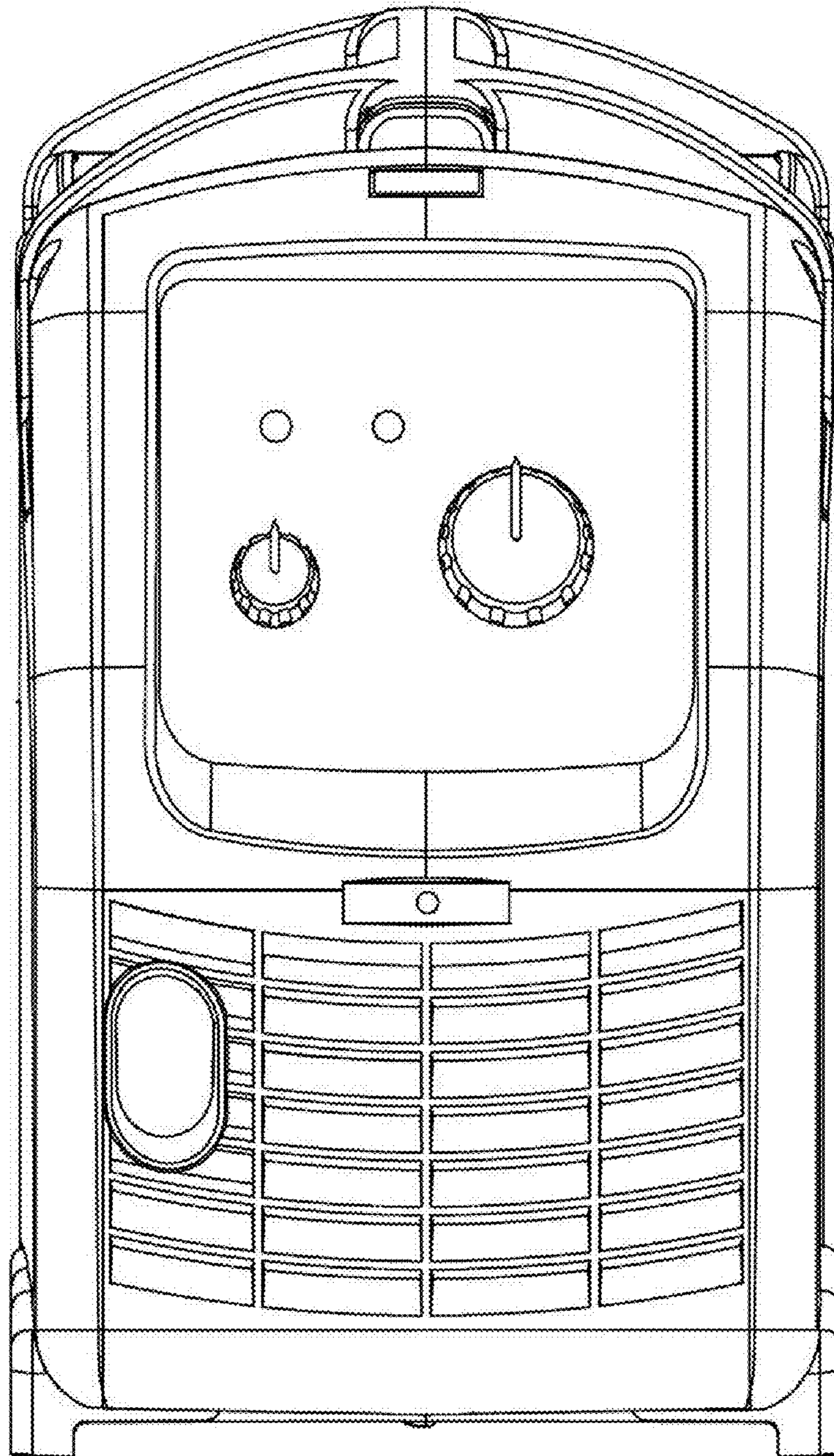

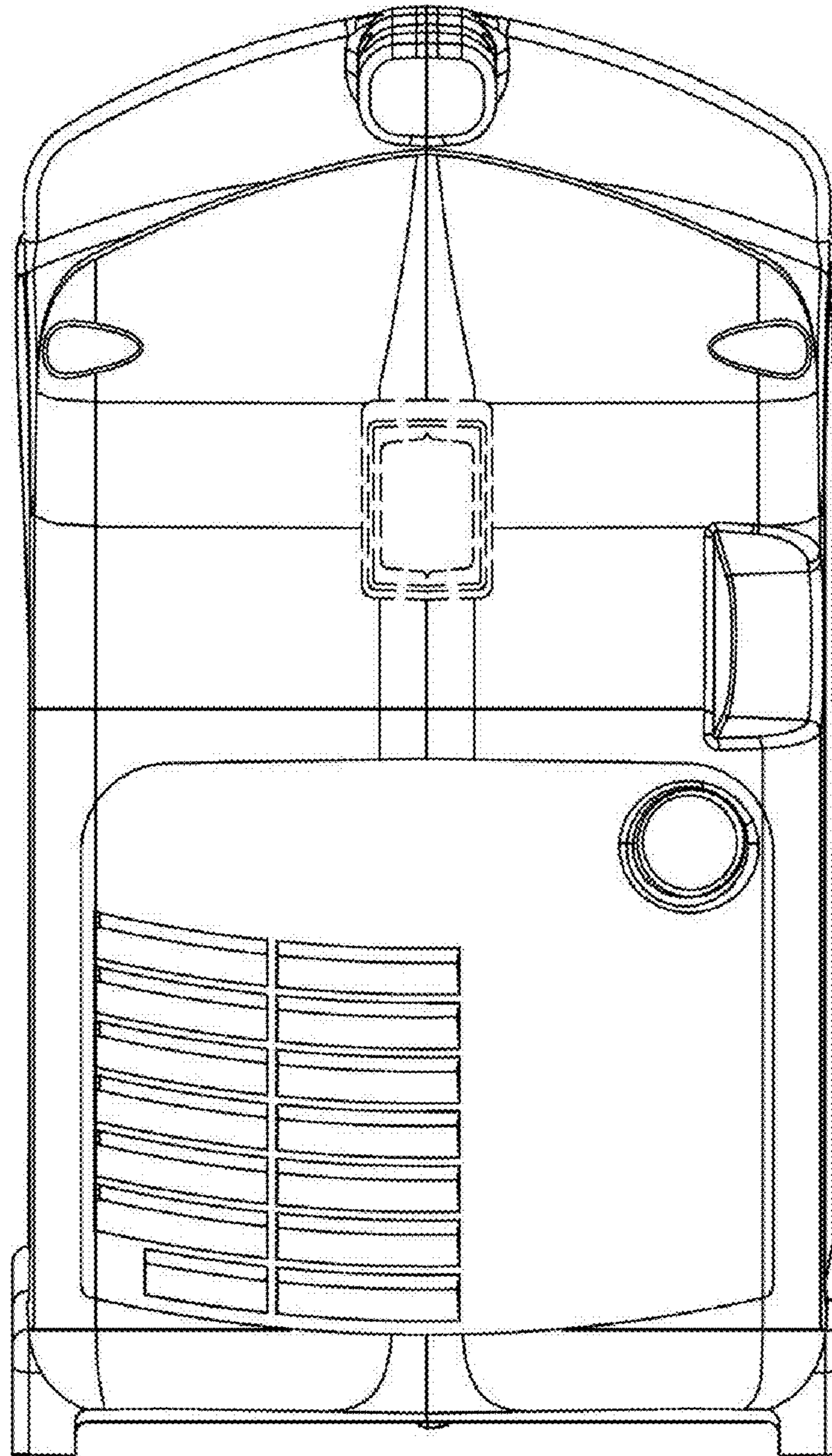

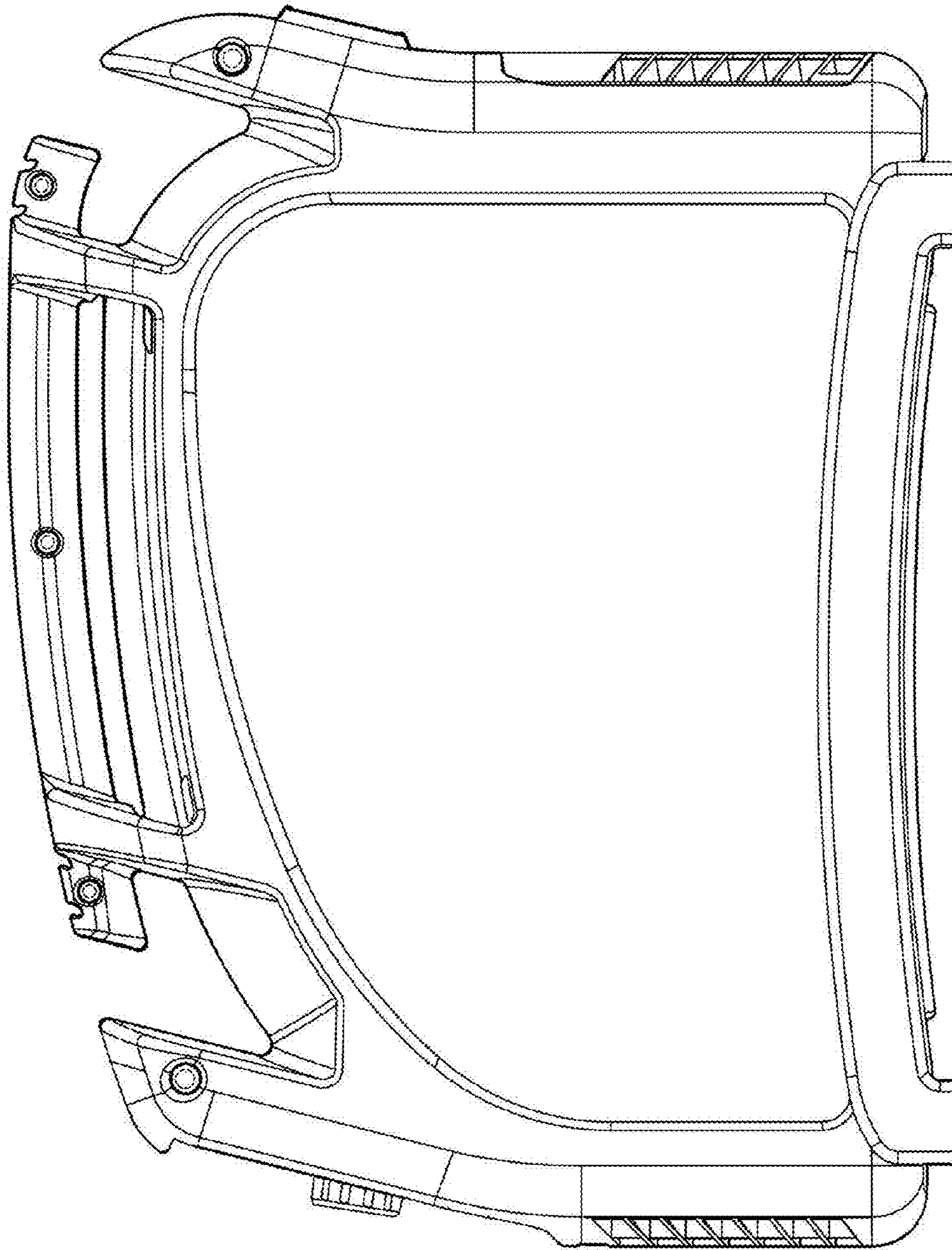

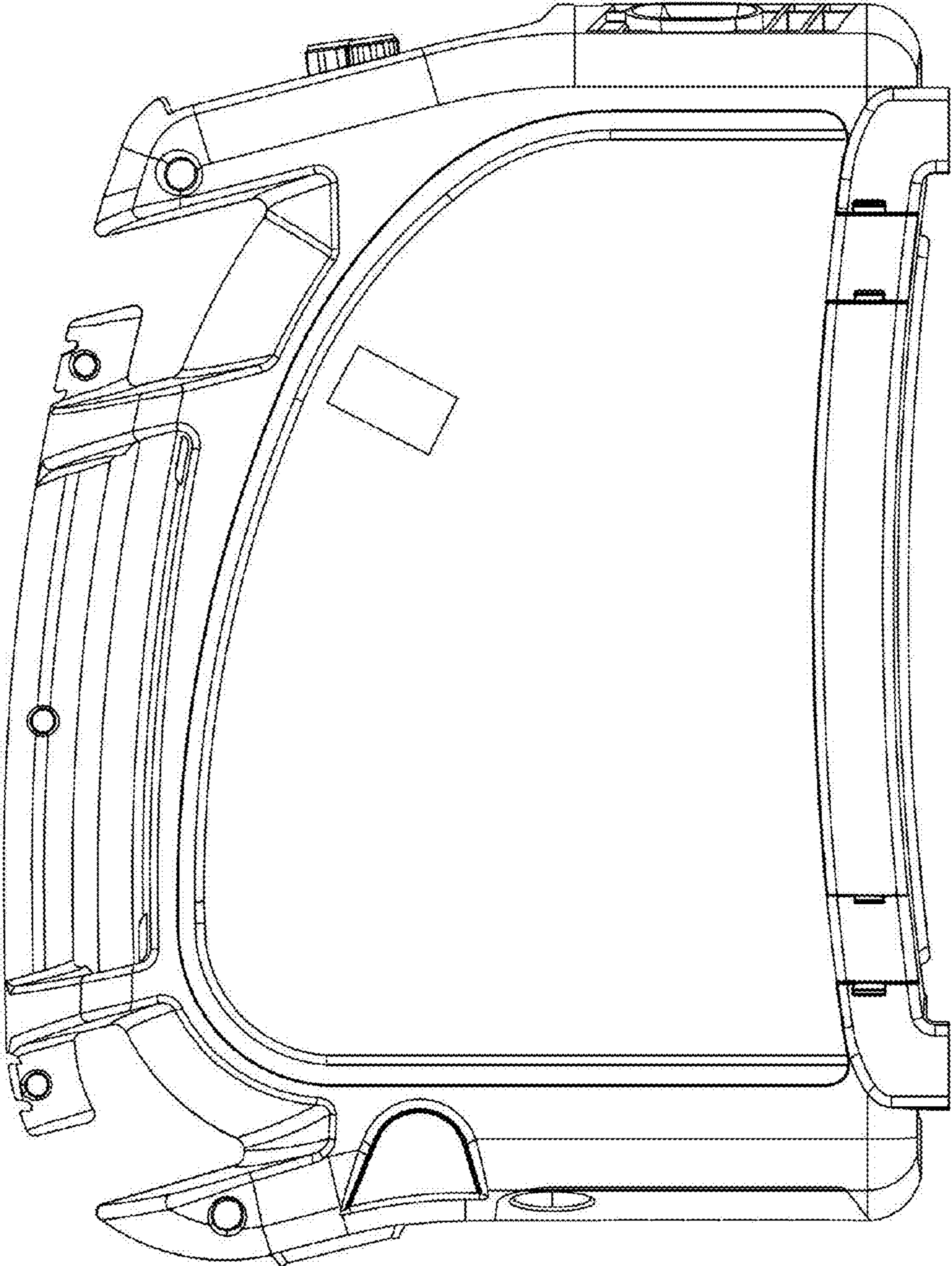

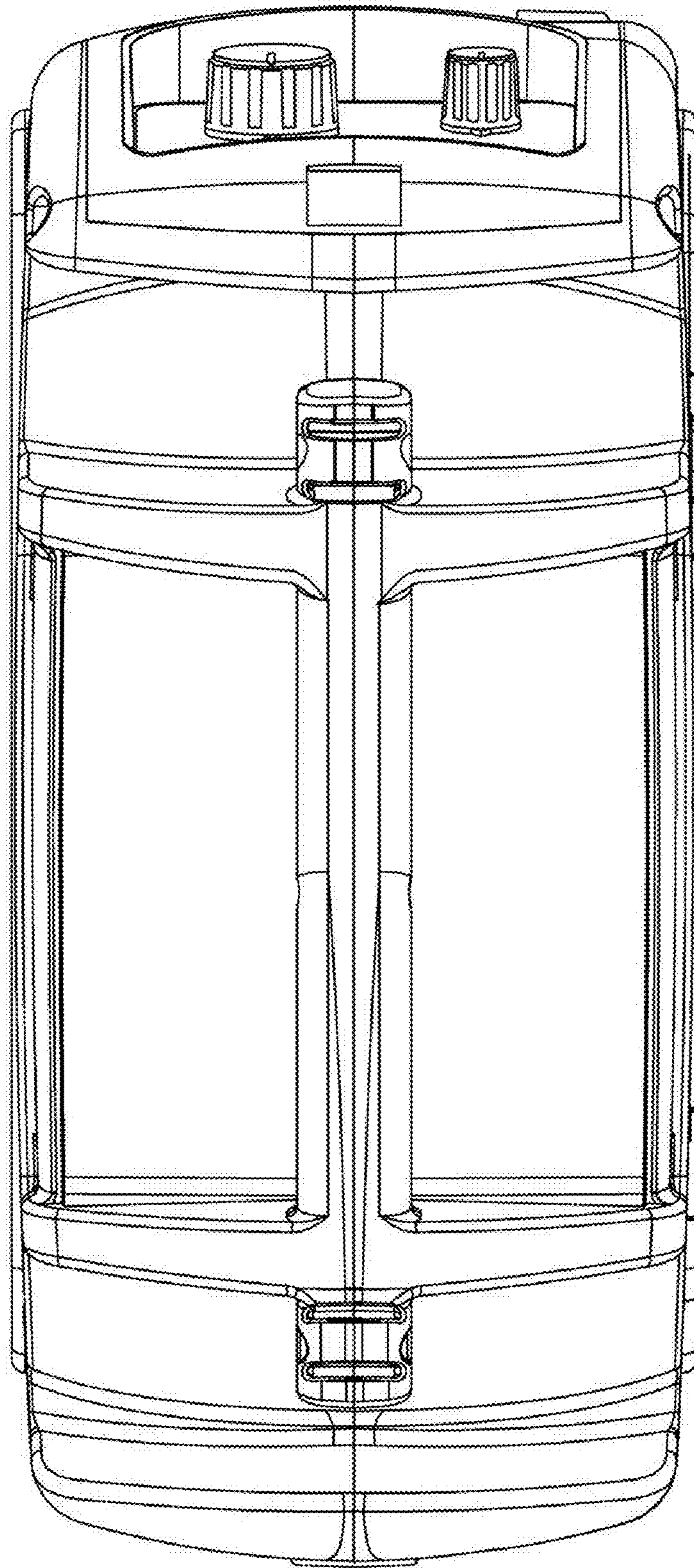

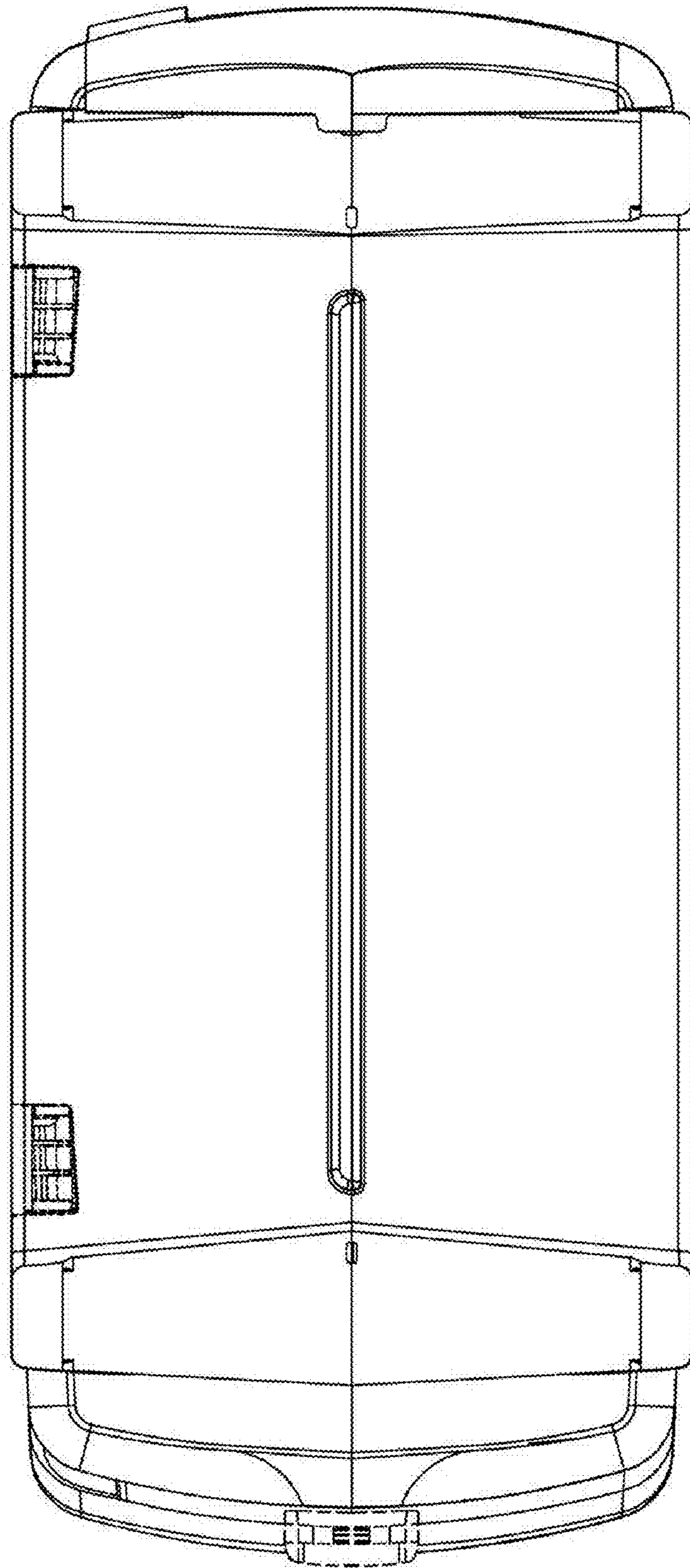
