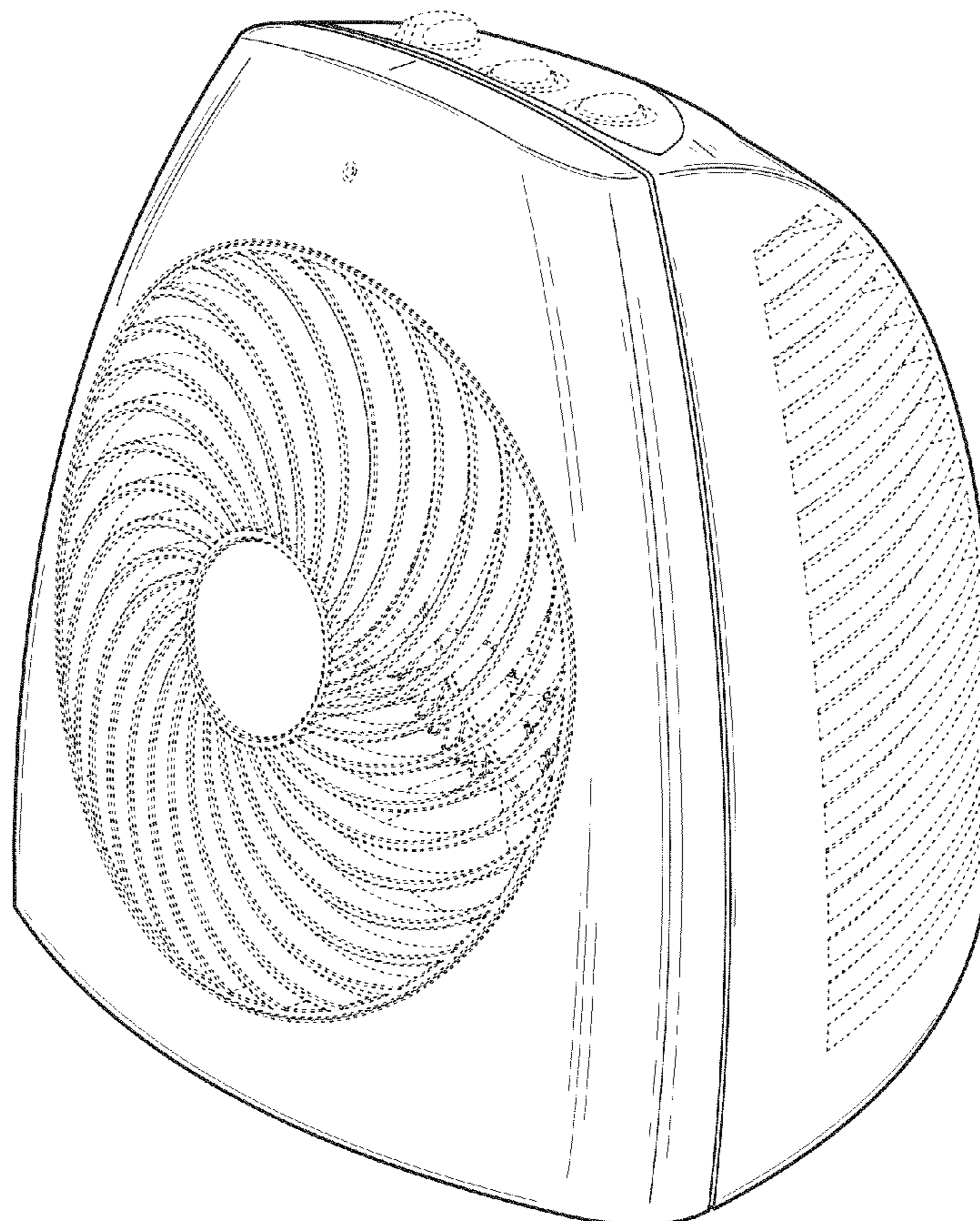
(57) **CLAIM**

The ornamental design for a heater, as shown and described.

**DESCRIPTION**

FIG. 1 is a front left elevation view of the heater;  
FIG. 2 is a left elevation view of the heater of FIG. 1;  
FIG. 3 is a right elevation view of the heater of FIG. 1;  
FIG. 4 is a top plan view of the heater of FIG. 1;  
FIG. 5 is a bottom plan view of the heater of FIG. 1;  
FIG. 6 is a front plan view of the heater of FIG. 1; and,  
FIG. 7 is a rear plan view of the heater of FIG. 1.

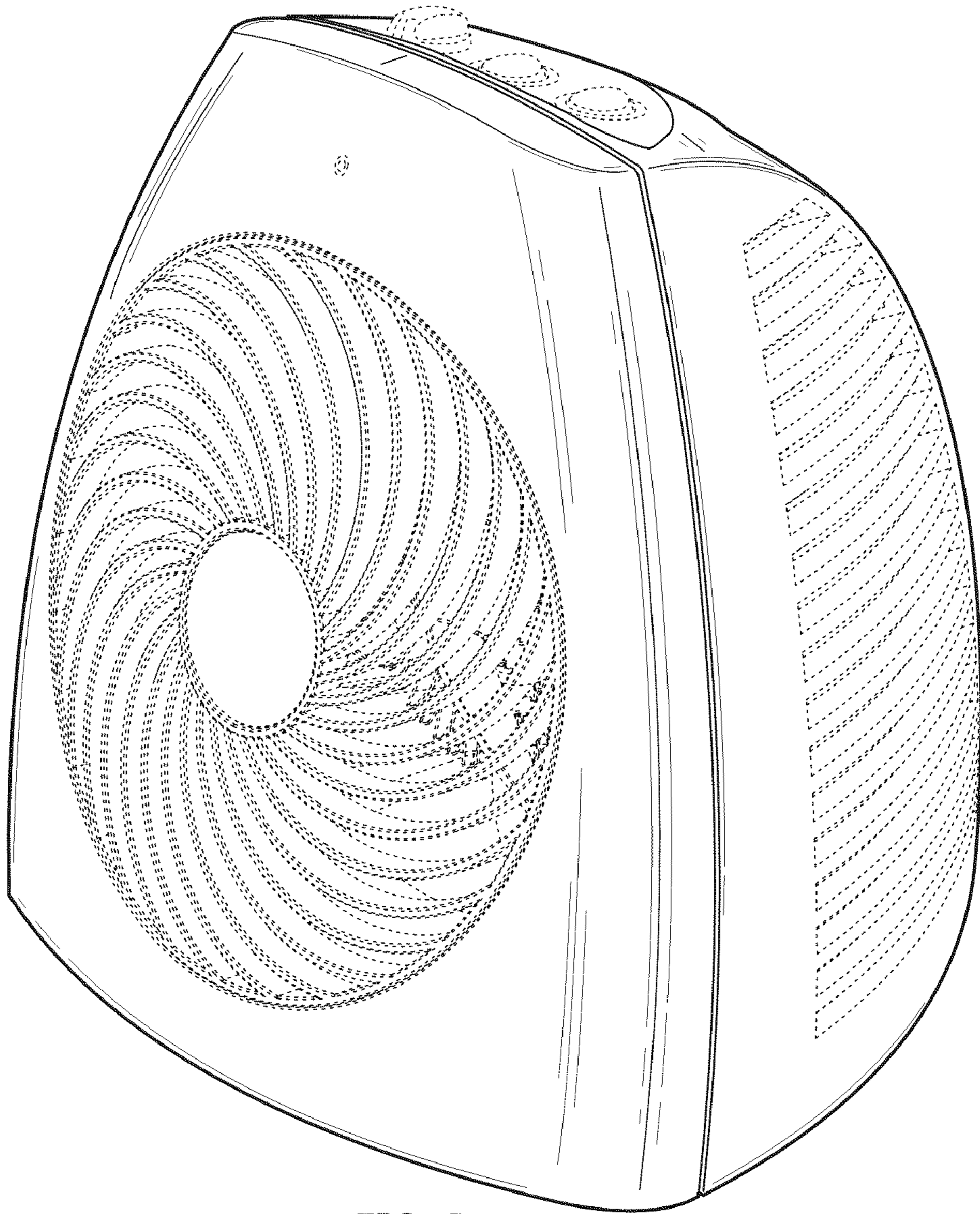

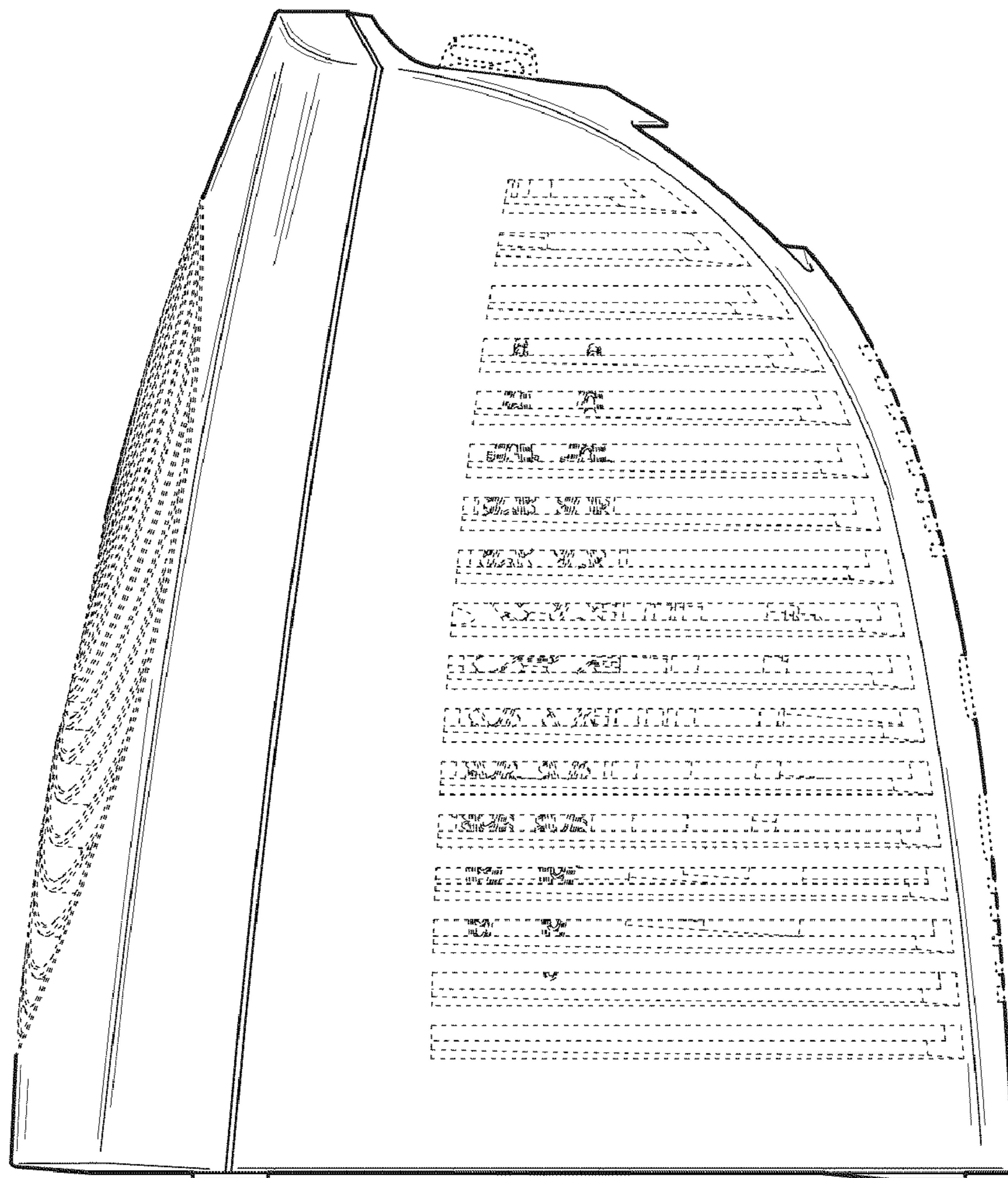

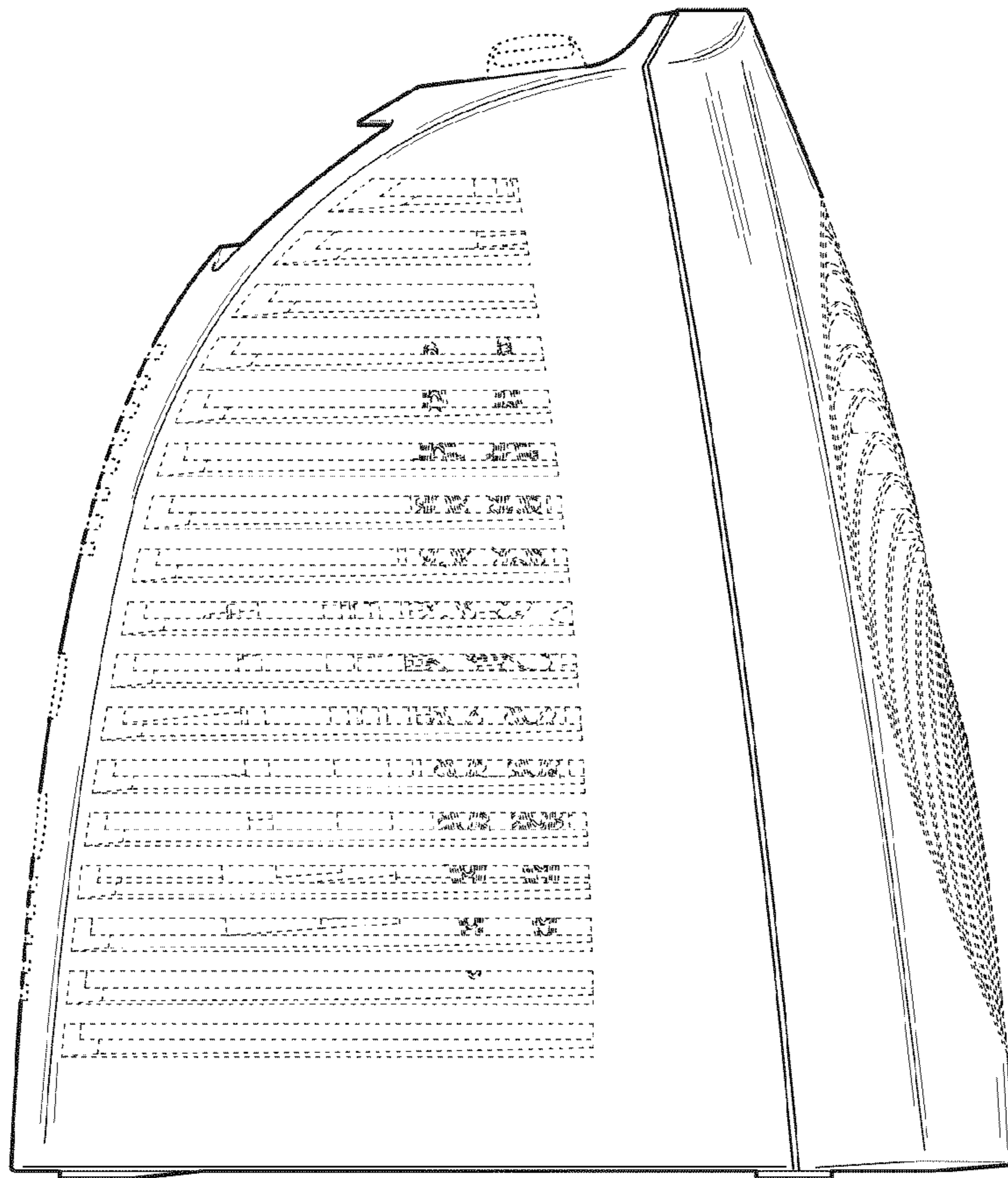

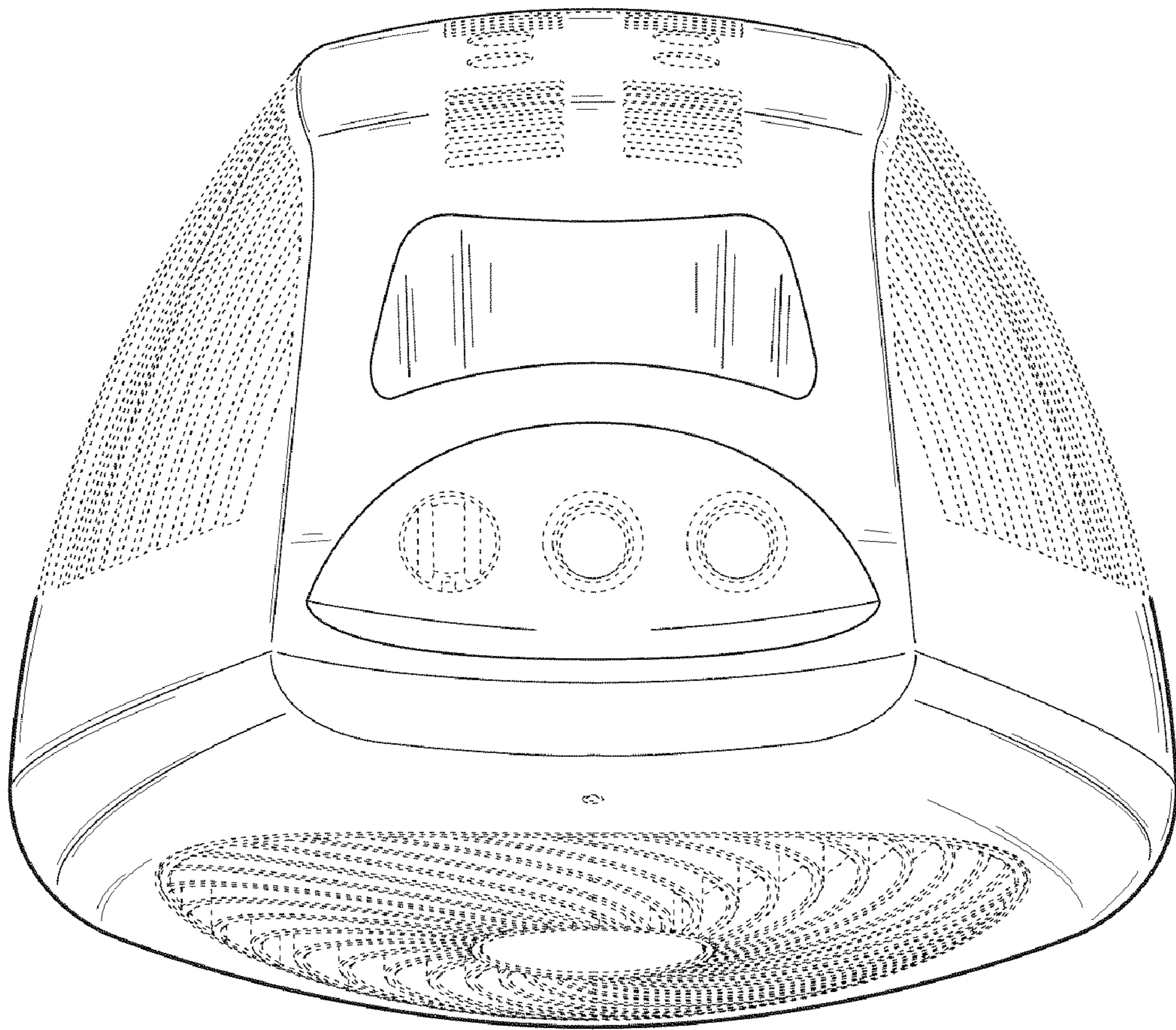

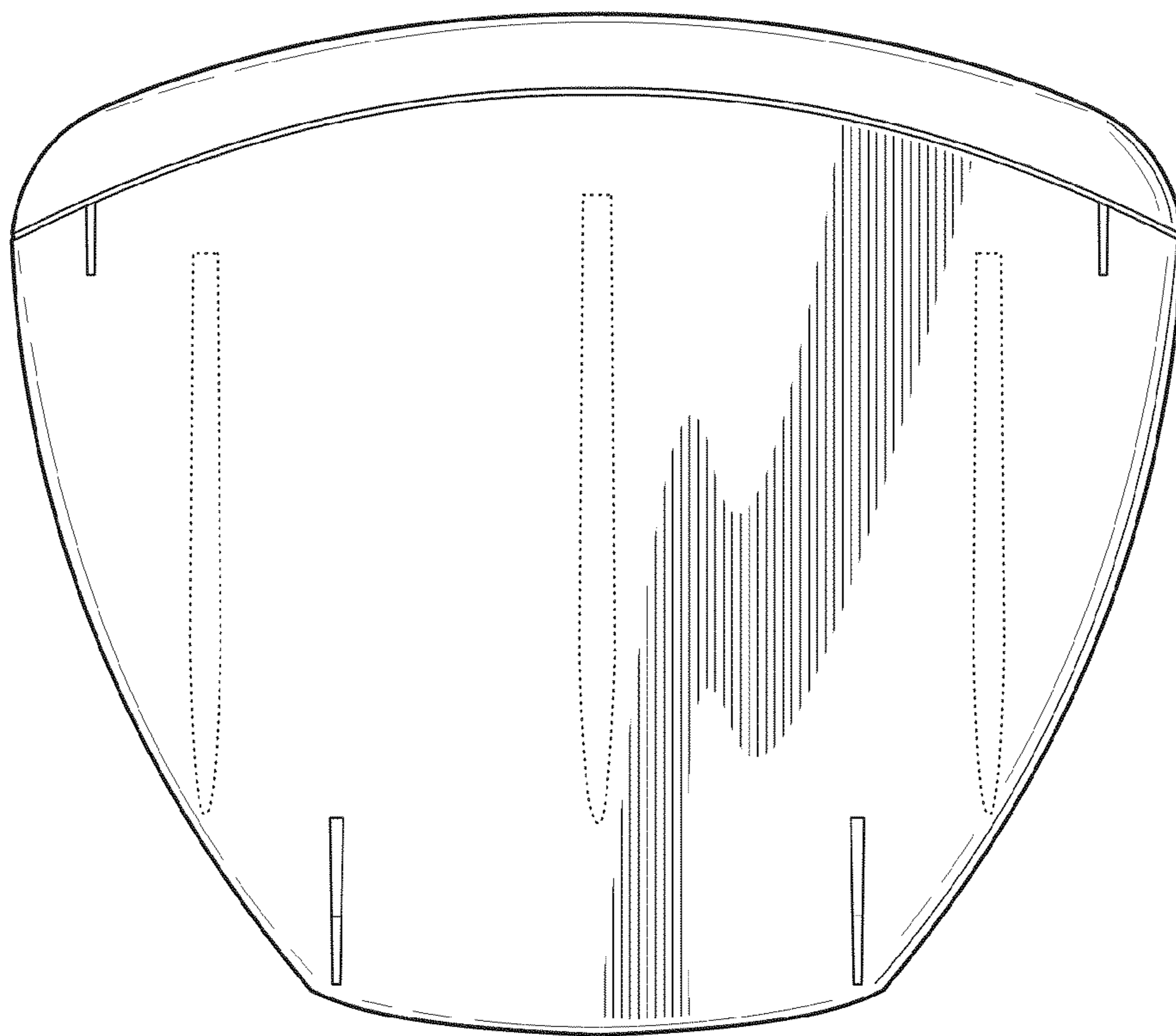

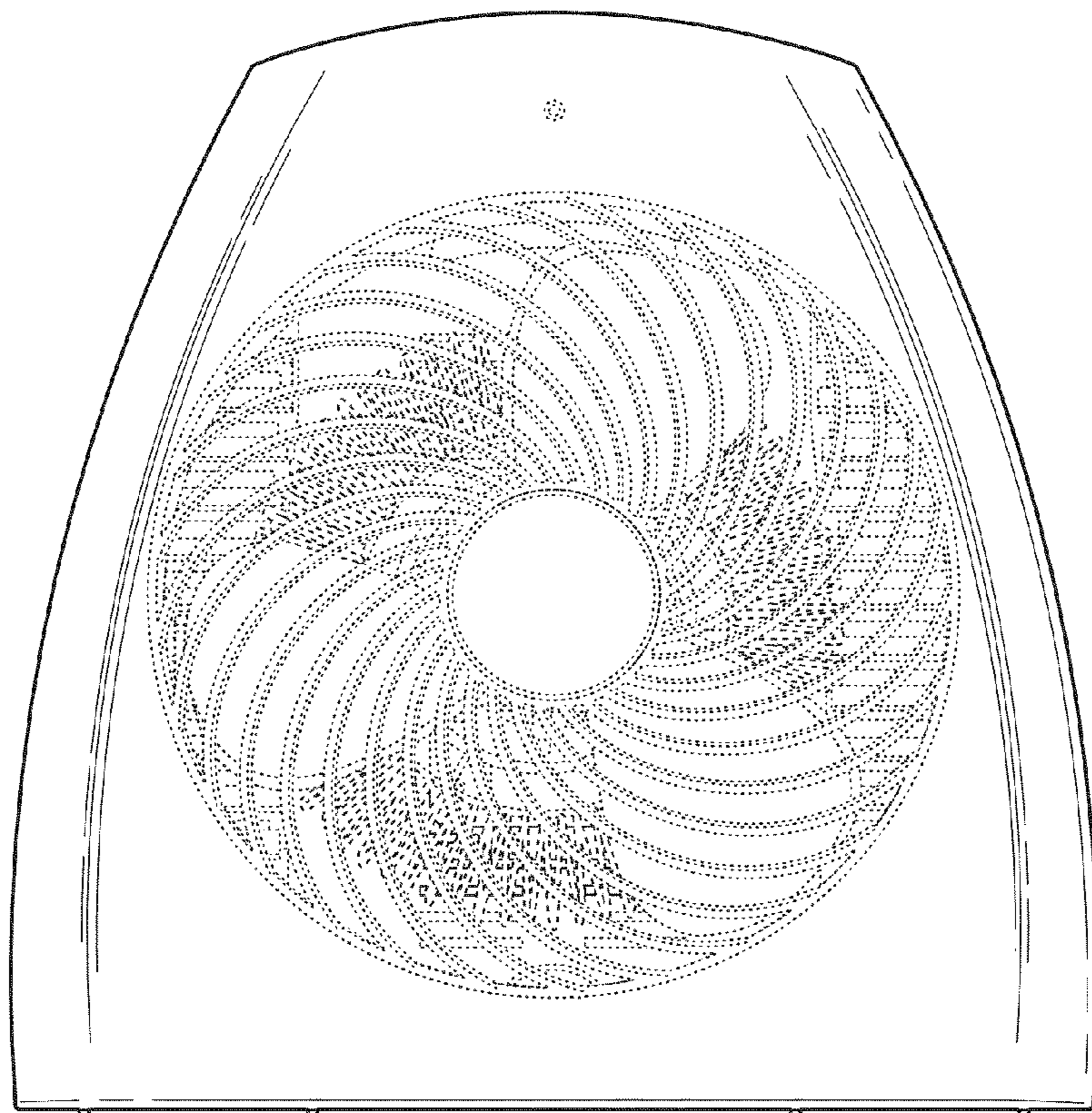

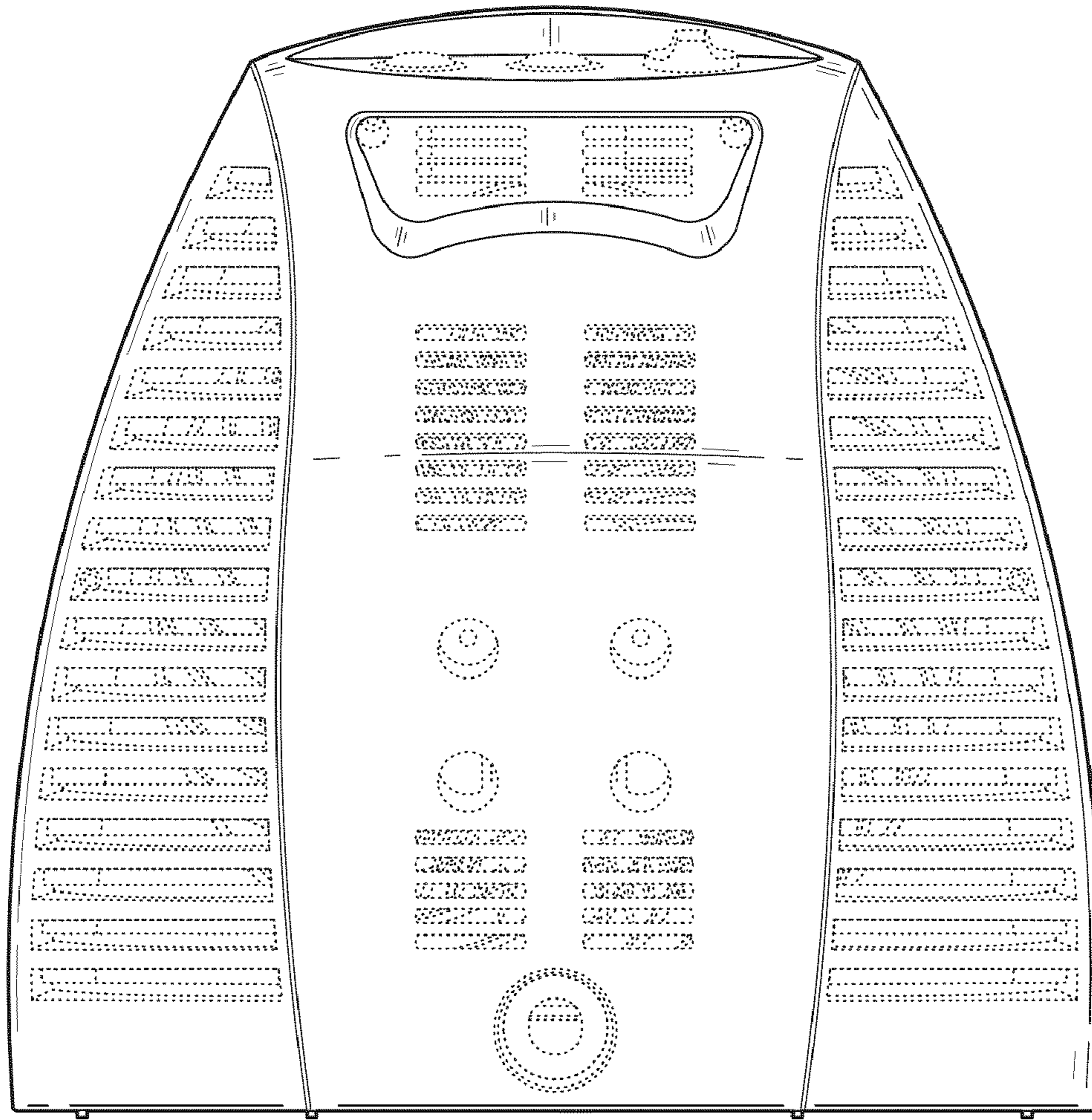
