(57) **CLAIM**

The ornamental design for a leash, as shown and described.

DESCRIPTION

FIG. 1 is an isometric perspective view of the top and third side of a leash.

FIG. 2 is a plan view of the leash shown in FIG. 1.

FIG. 3 is a first side view of the leash shown in FIG. 1.

FIG. 4 is a bottom view of the leash shown in FIG. 1.

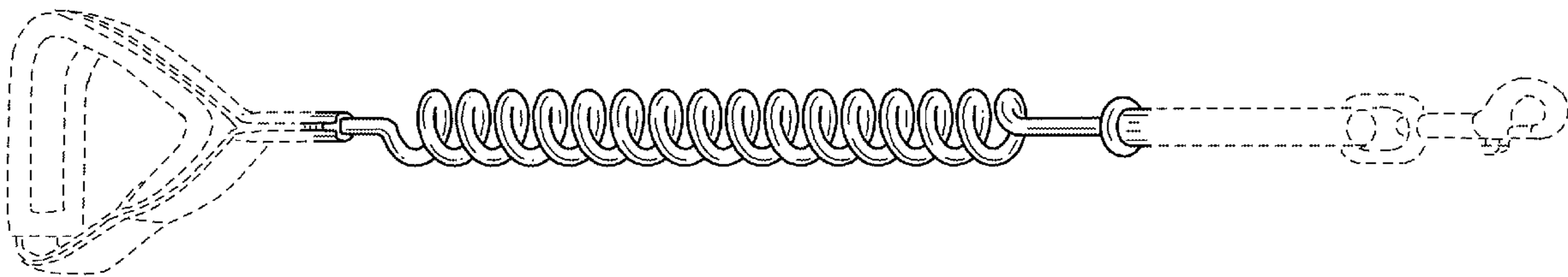
FIG. 5 is a second side view of the leash shown in FIG. 1.

FIG. 6 is a first end view of the leash shown in FIG. 1 as taken from the 7-7 line indicated in the FIG. 2 drawing view.

FIG. 7 is a second end view of the leash shown in FIG. 1 as taken from the 6-6 line indicated in the FIG. 2 drawing view; and,

FIG. 8 is an isometric perspective view of the top and third side of the leash shown in FIG. 1, in an extended condition. The broken lines are not part of the claimed design.

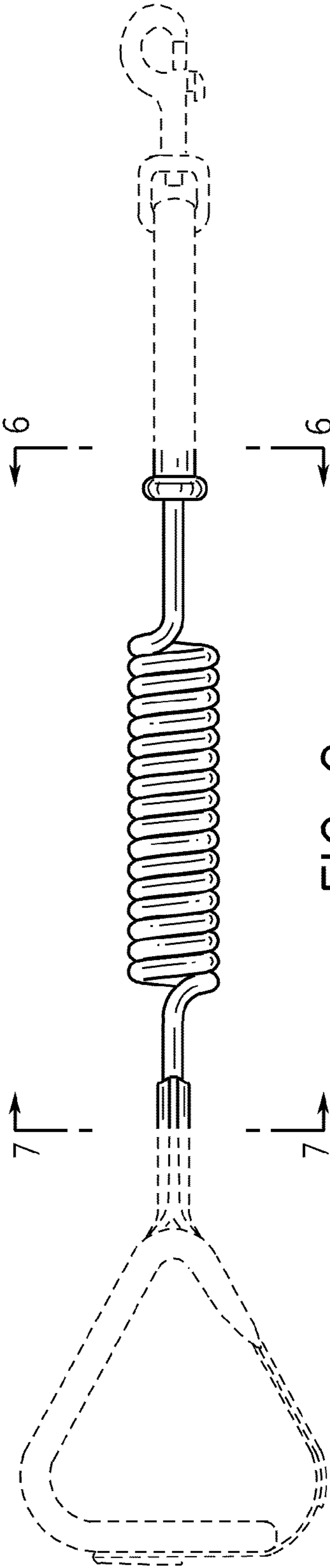
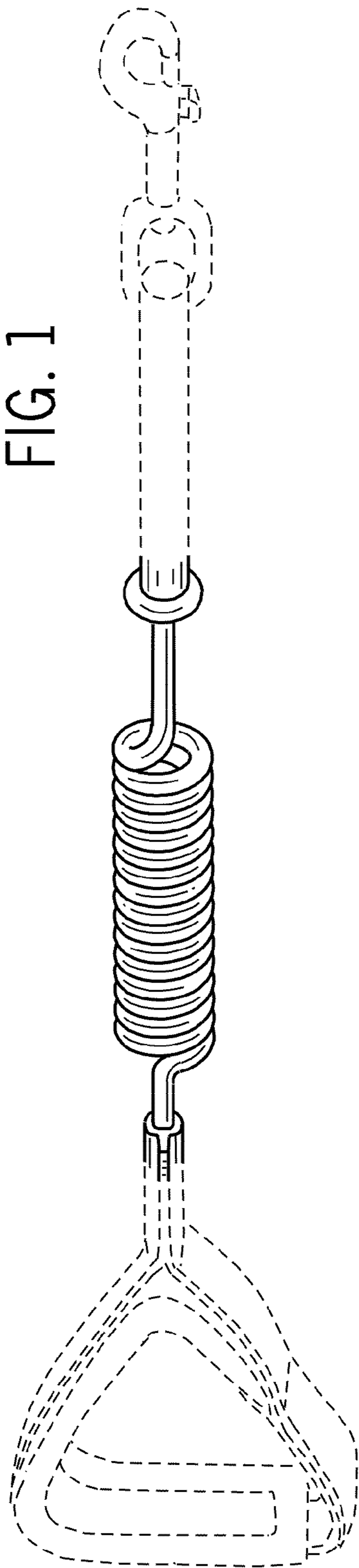

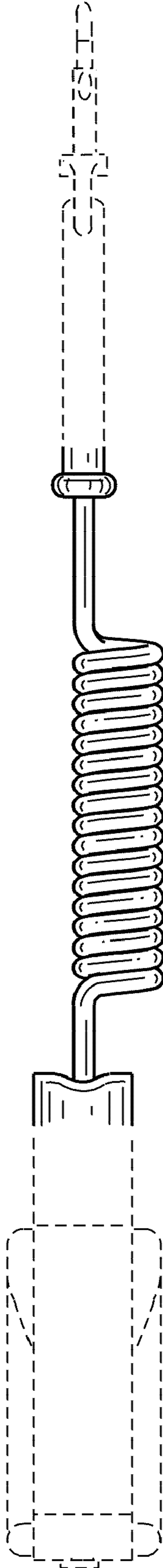

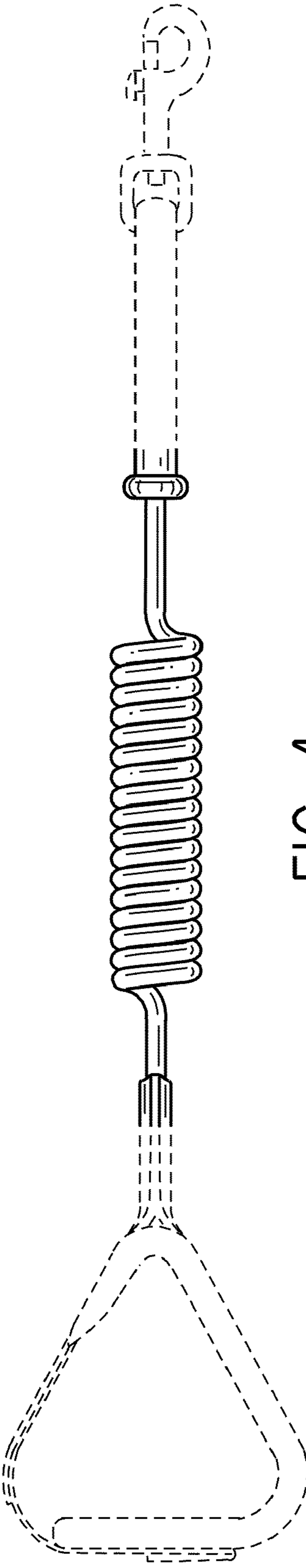

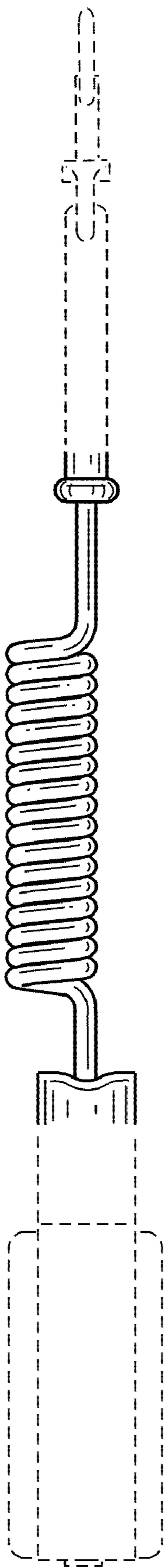

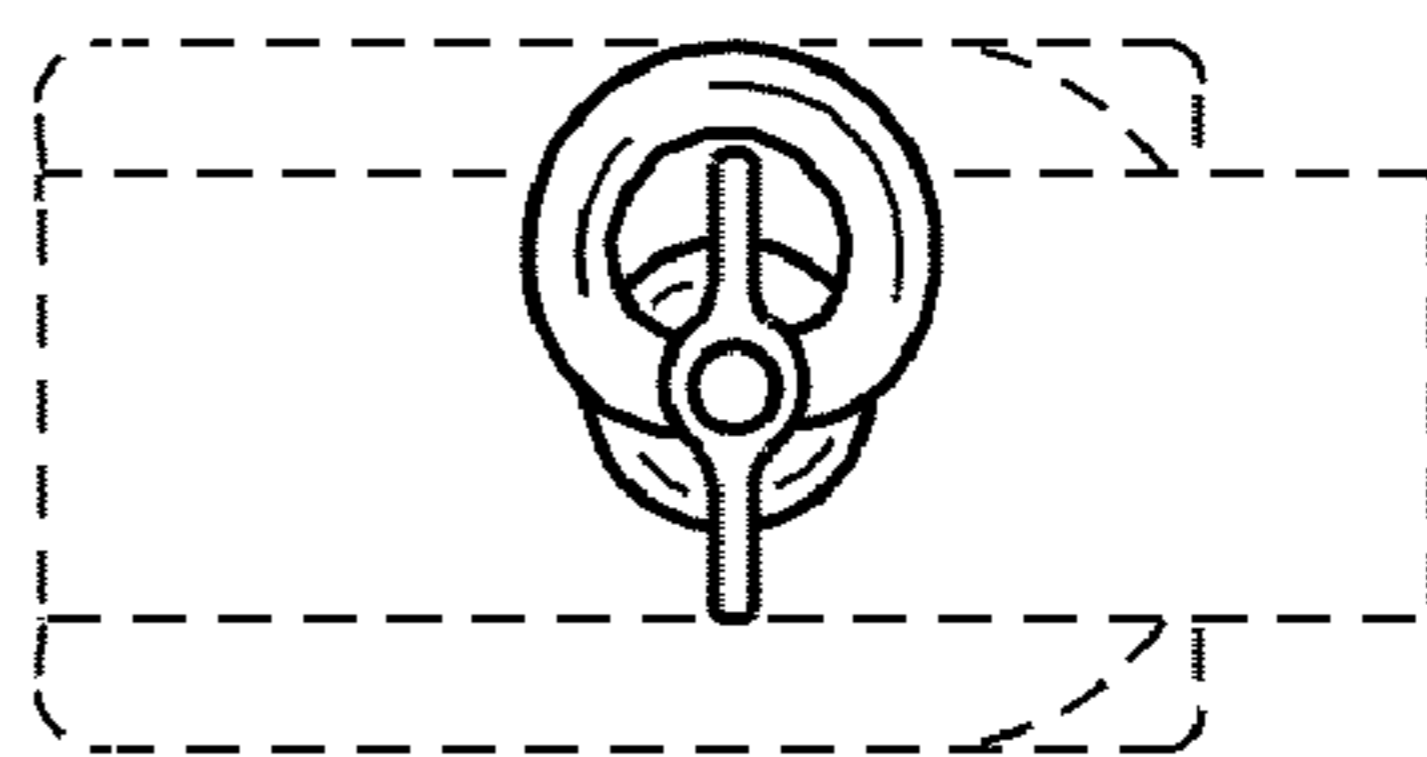

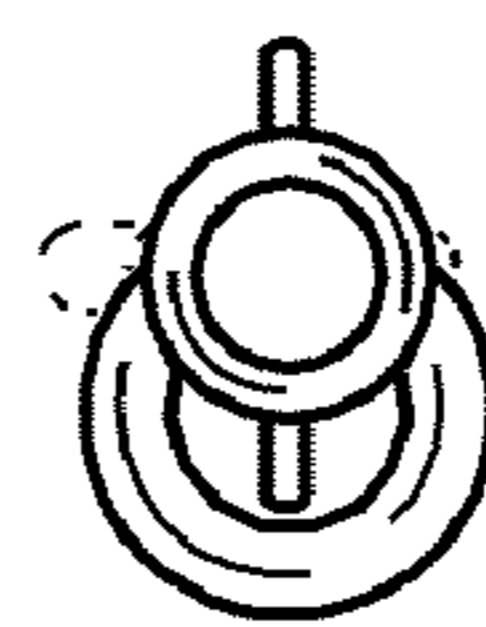

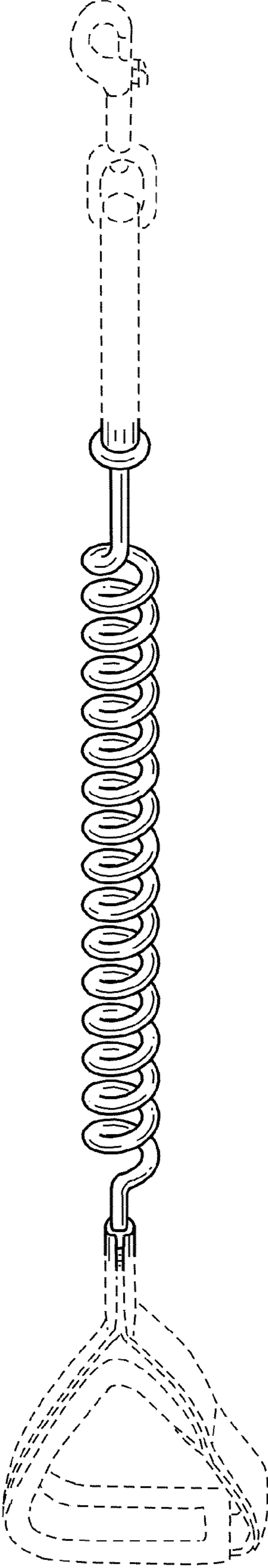
