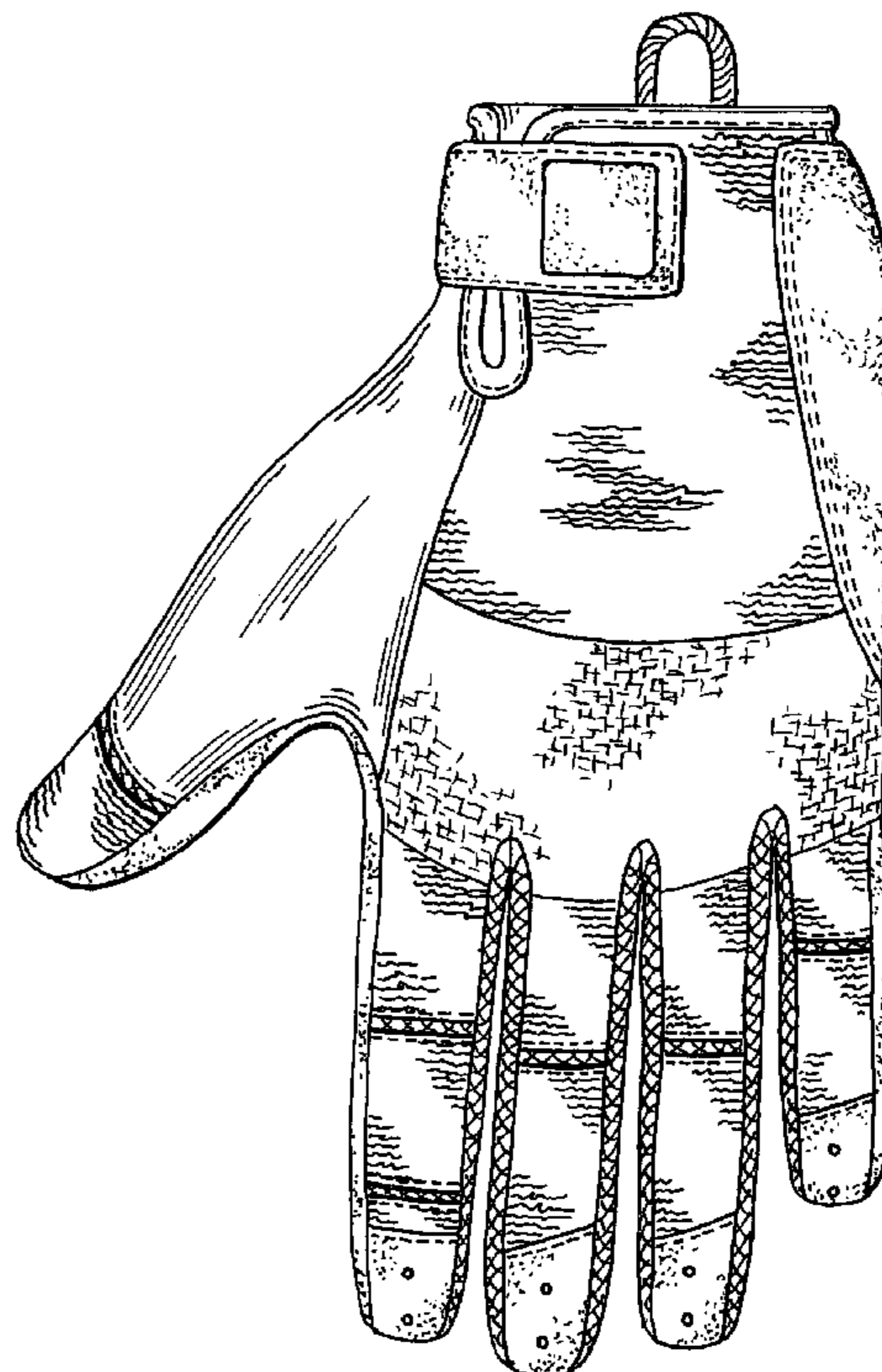
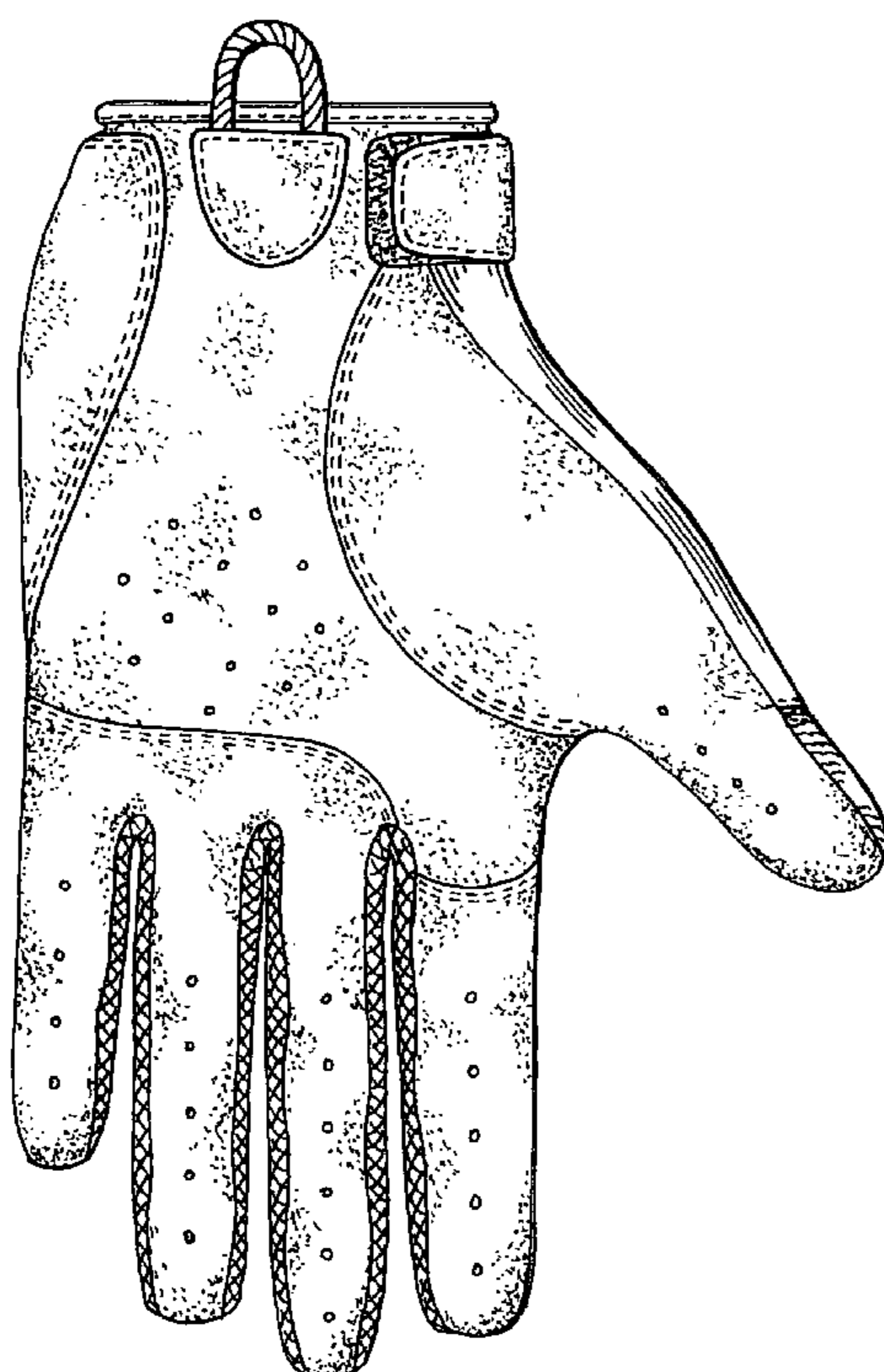
(57) **CLAIM**

We claim the ornamental design for a glove, as shown and described.

DESCRIPTION

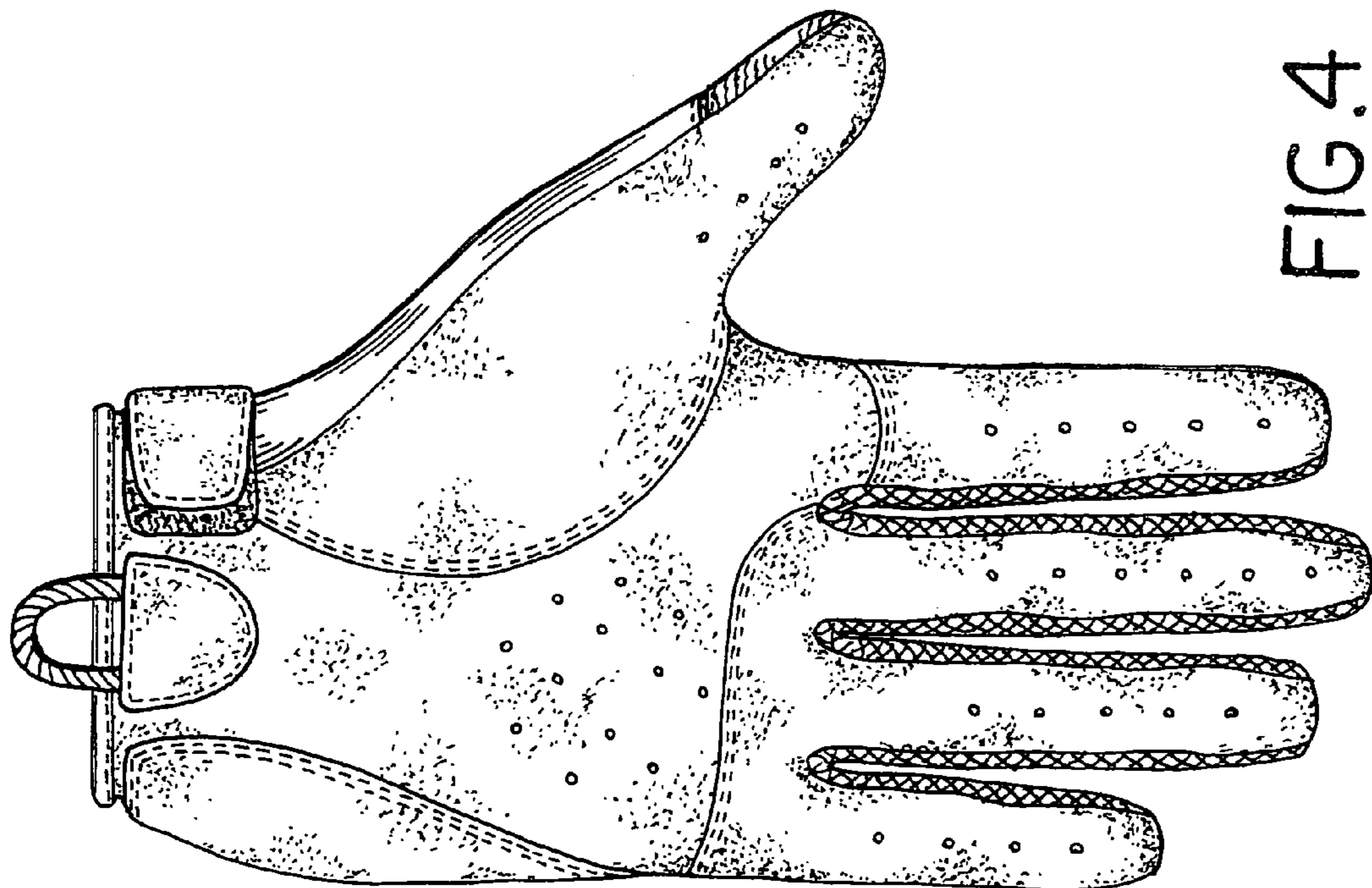
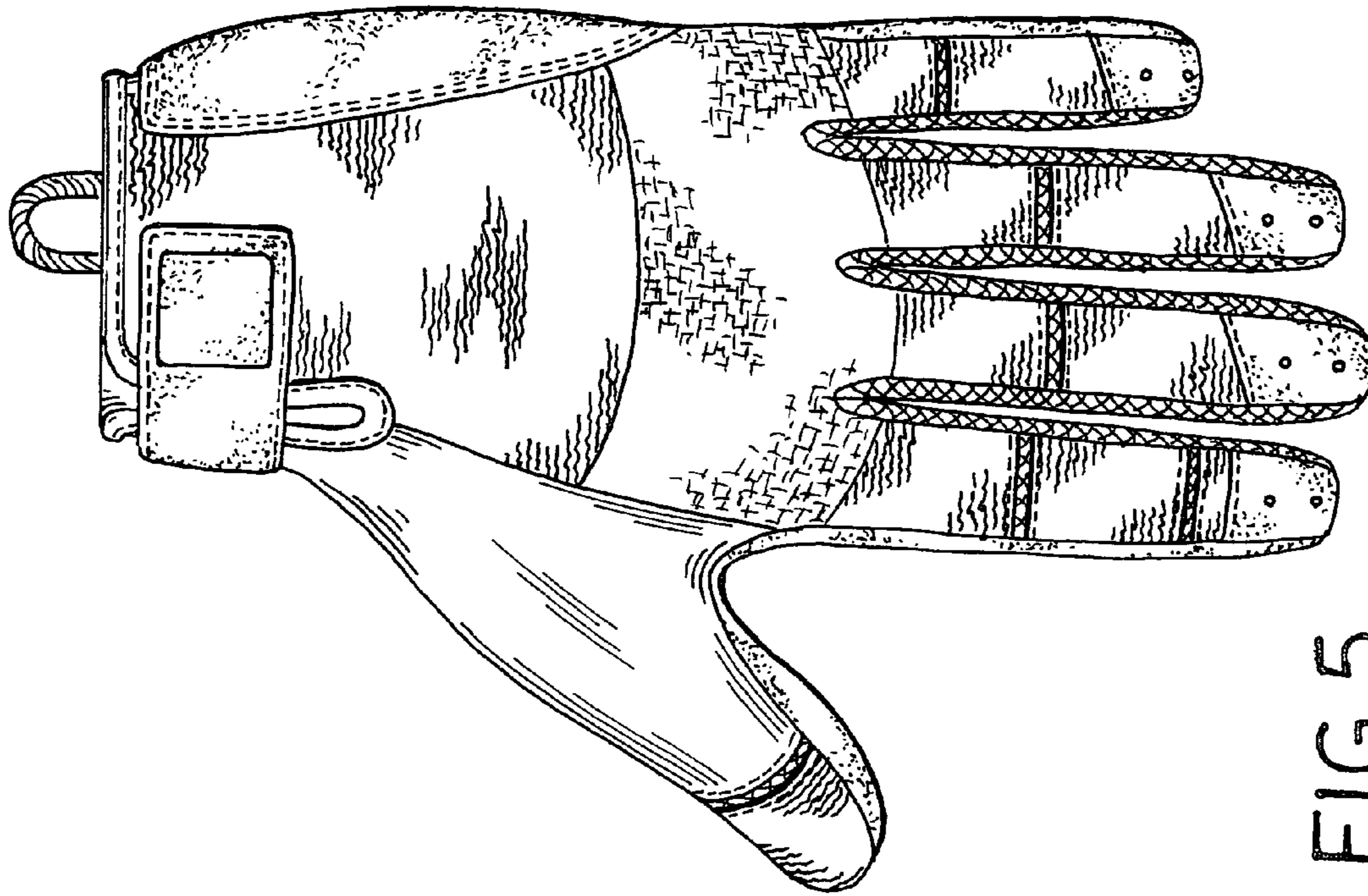


FIG. 4 FIG. 5

FIG. 1 is a perspective view of a glove showing our design; FIG. 2 is a medial side view of the glove shown in FIG. 1; FIG. 3 is a lateral side view of the glove shown in FIG. 1; FIG. 4 is a top palmar view of the glove shown in FIG. 1; FIG. 5 is a bottom dorsal view of the glove shown in FIG. 1; FIG. 6 is an end view of the glove shown in FIG. 1. The broken-line shown on the inside of the wrist defines the bounds of the claim, and forms no part thereof; and, FIG. 7 is a front view of the glove shown in FIG. 1. Shading in FIGS. 1-7 represent materials from which the glove is constructed and form part of the claimed design. Regularly spaced broken lines in FIGS. 1-7 represent stitching and also form a part of the claimed design.

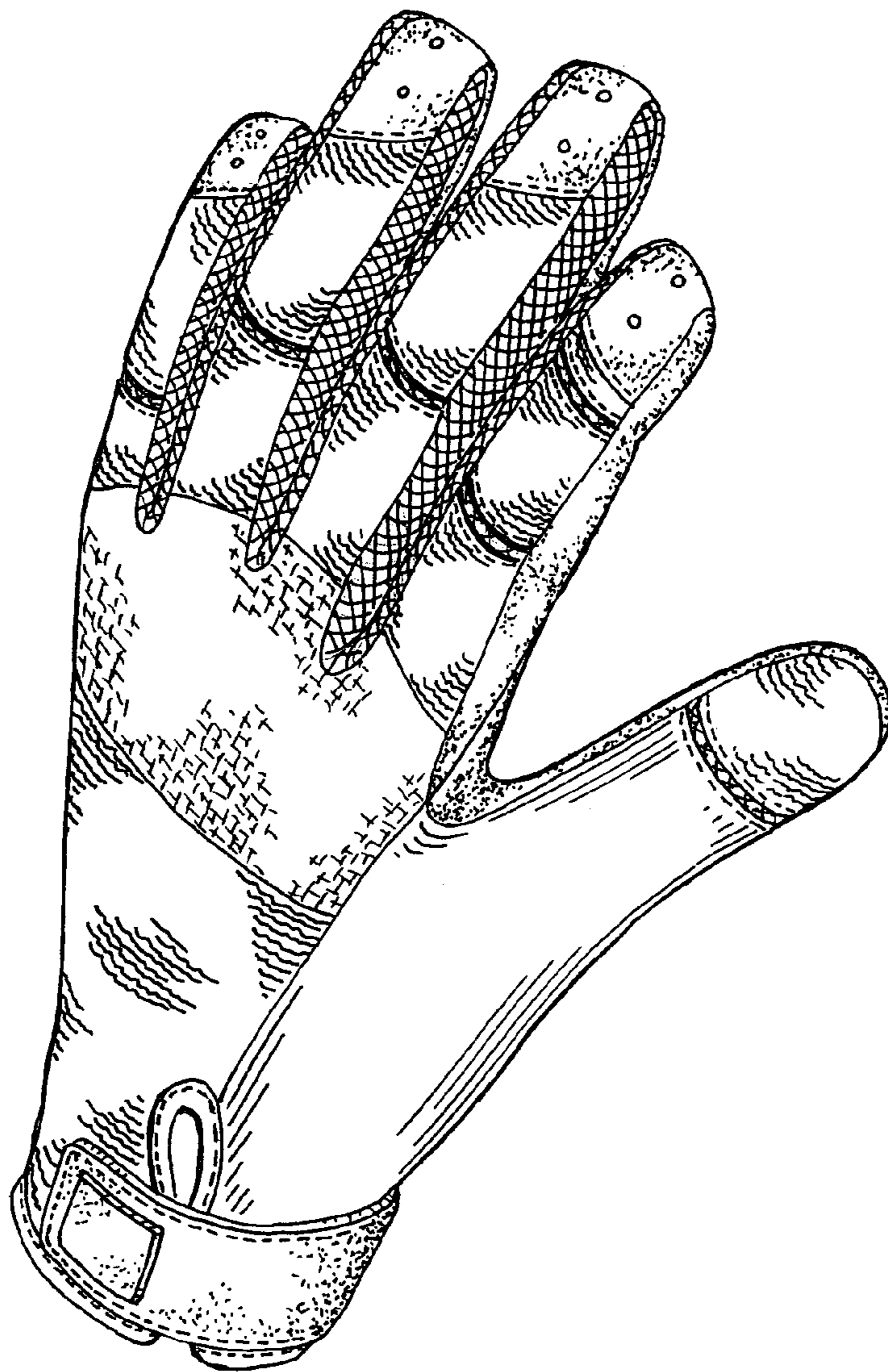

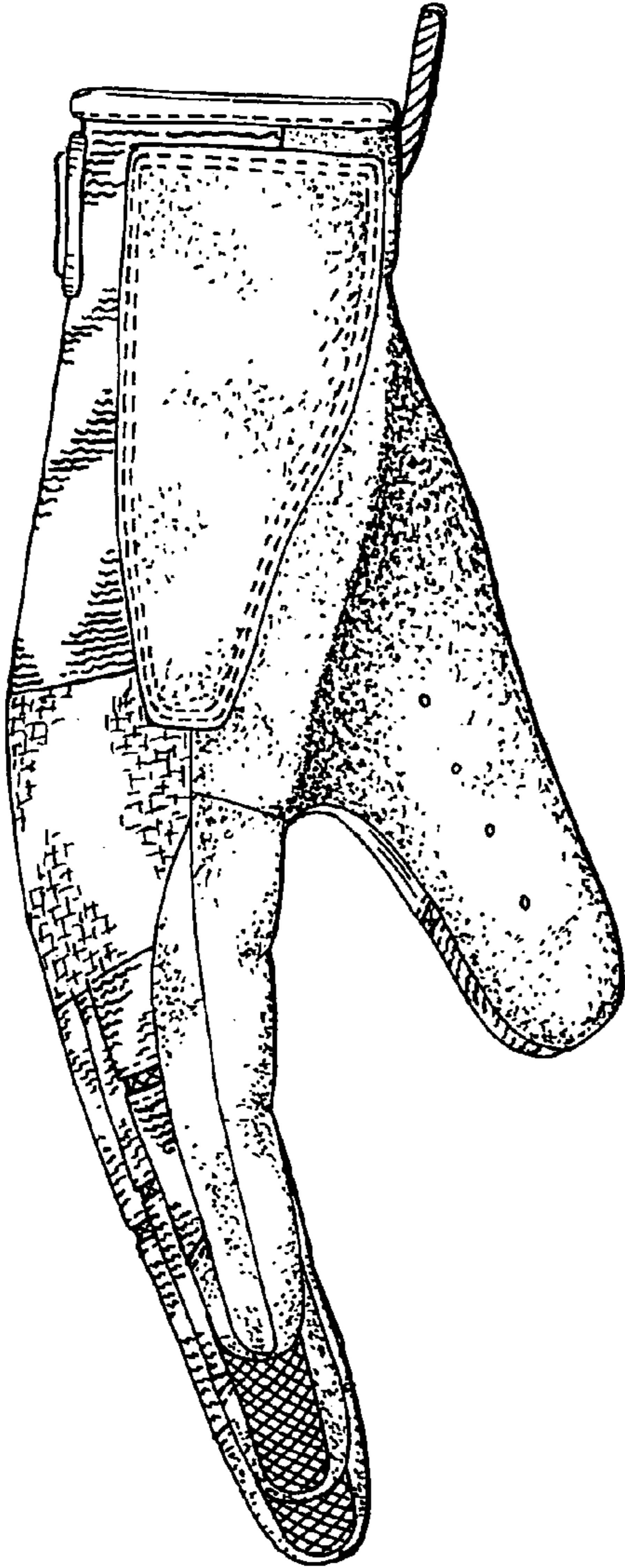

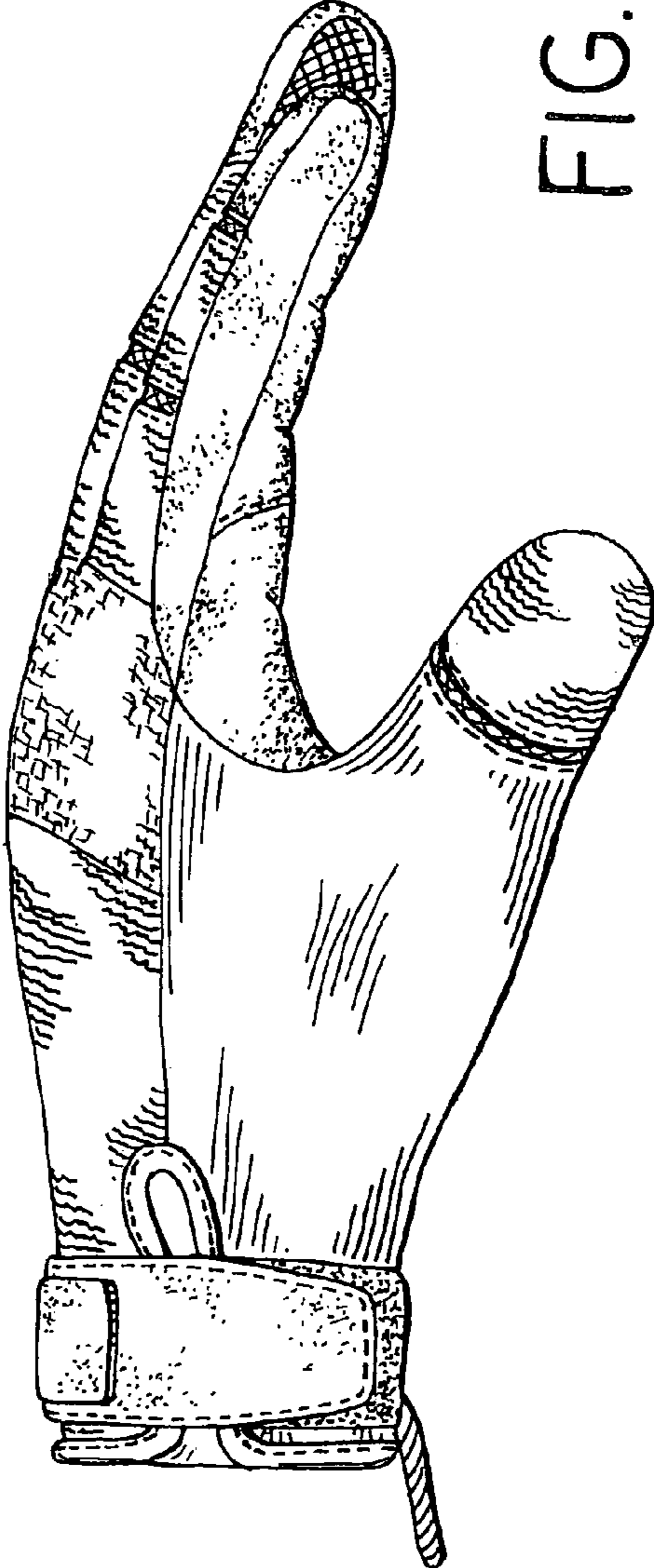

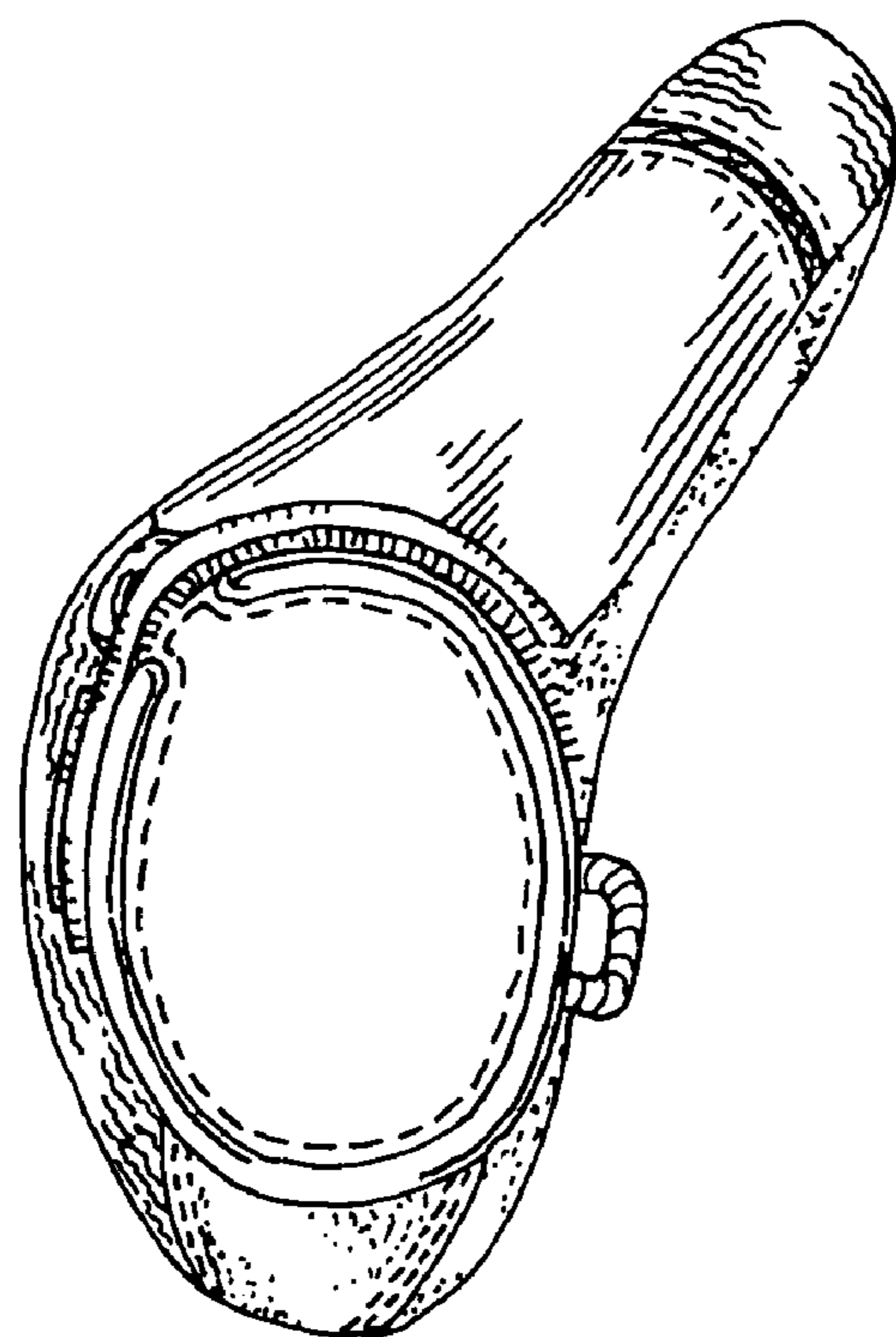

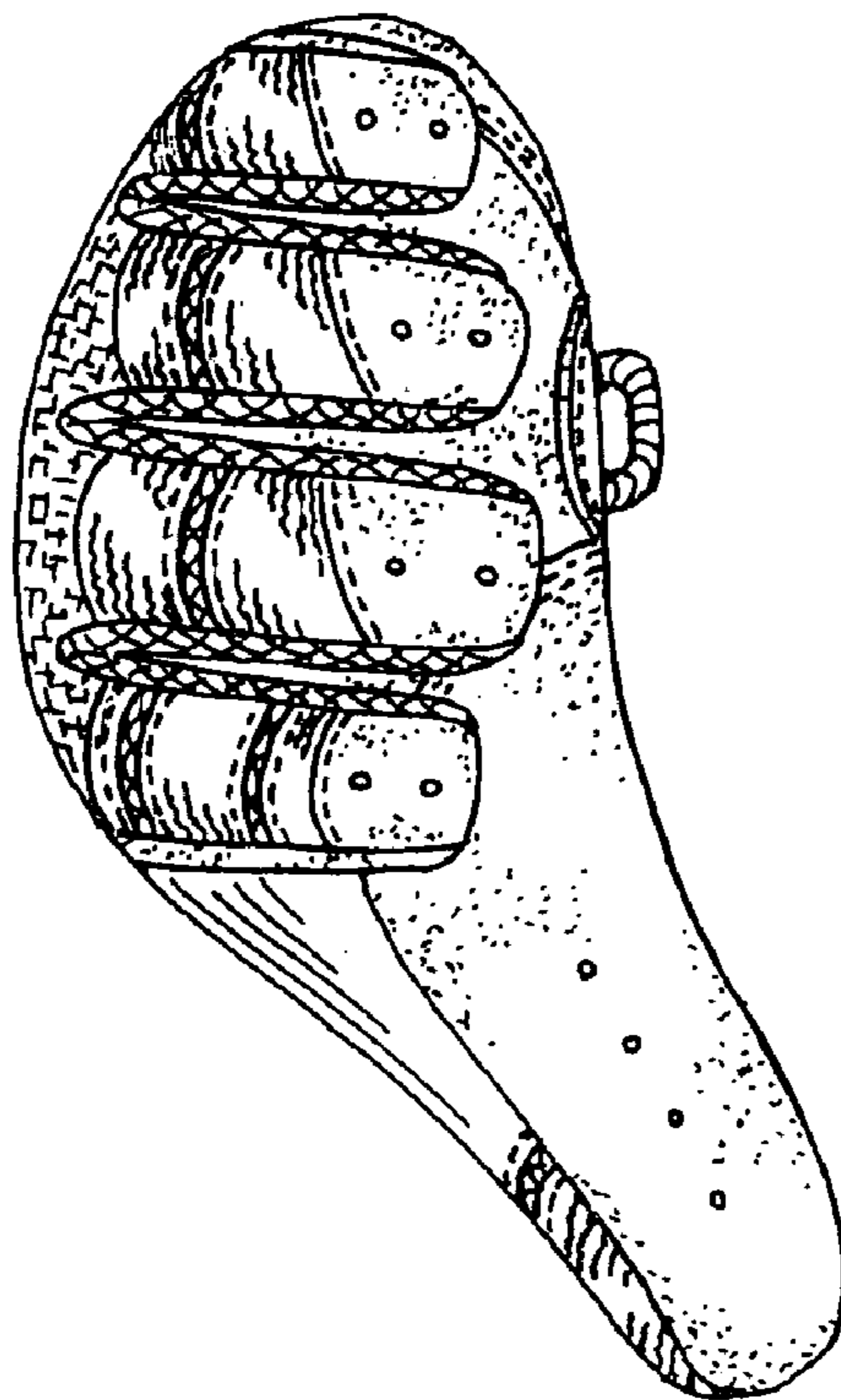
