(57) **CLAIM**

The ornamental design for a sports jersey, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a sports jersey showing my new design;

FIG. 2 is front view of the sports jersey shown in FIG. 1;

FIG. 3 is a rear view of the sports jersey shown in FIG. 1;

FIG. 4 is a first side view of the sports jersey shown in FIG. 1;

FIG. 5 is a second side view of the sports jersey shown in FIG. 1;

FIG. 6 is a top view of the sports jersey shown in FIG. 1; and

FIG. 7 is an enlarged view of a portion of the sports jersey circumscribed by an uneven broken line in FIG. 3 and identified by the reference number 7; FIG. 7 illustrates the appearance of the fabric of the sports jersey.

FIG. 8 is a perspective view of a second embodiment of a sports jersey showing my new design;

FIG. 9 is a front view of the sports jersey shown in FIG. 8;

FIG. 10 is a rear view of the sports jersey shown in FIG. 8;

FIG. 11 is a first side view of the sports jersey shown in FIG. 8;

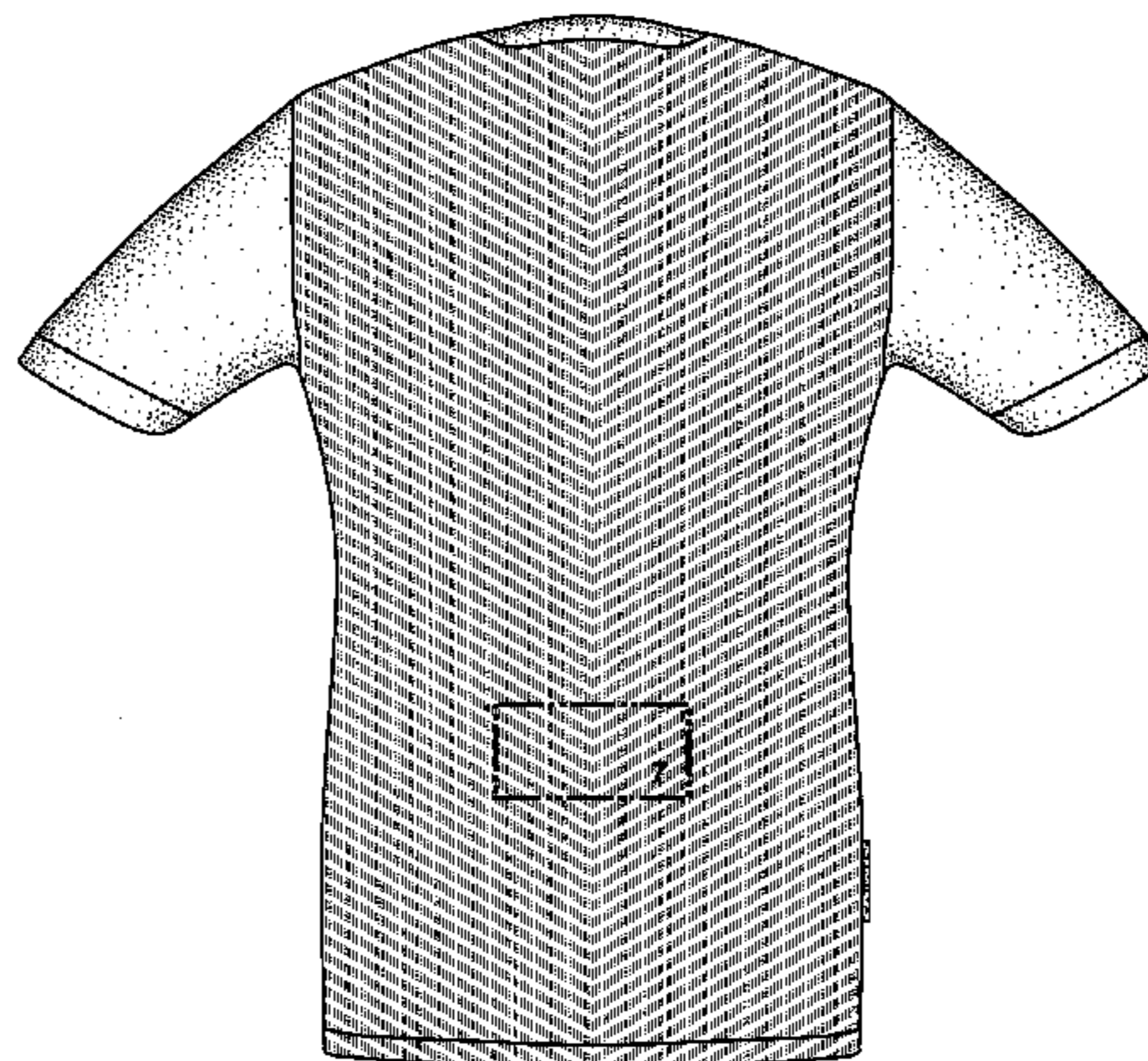
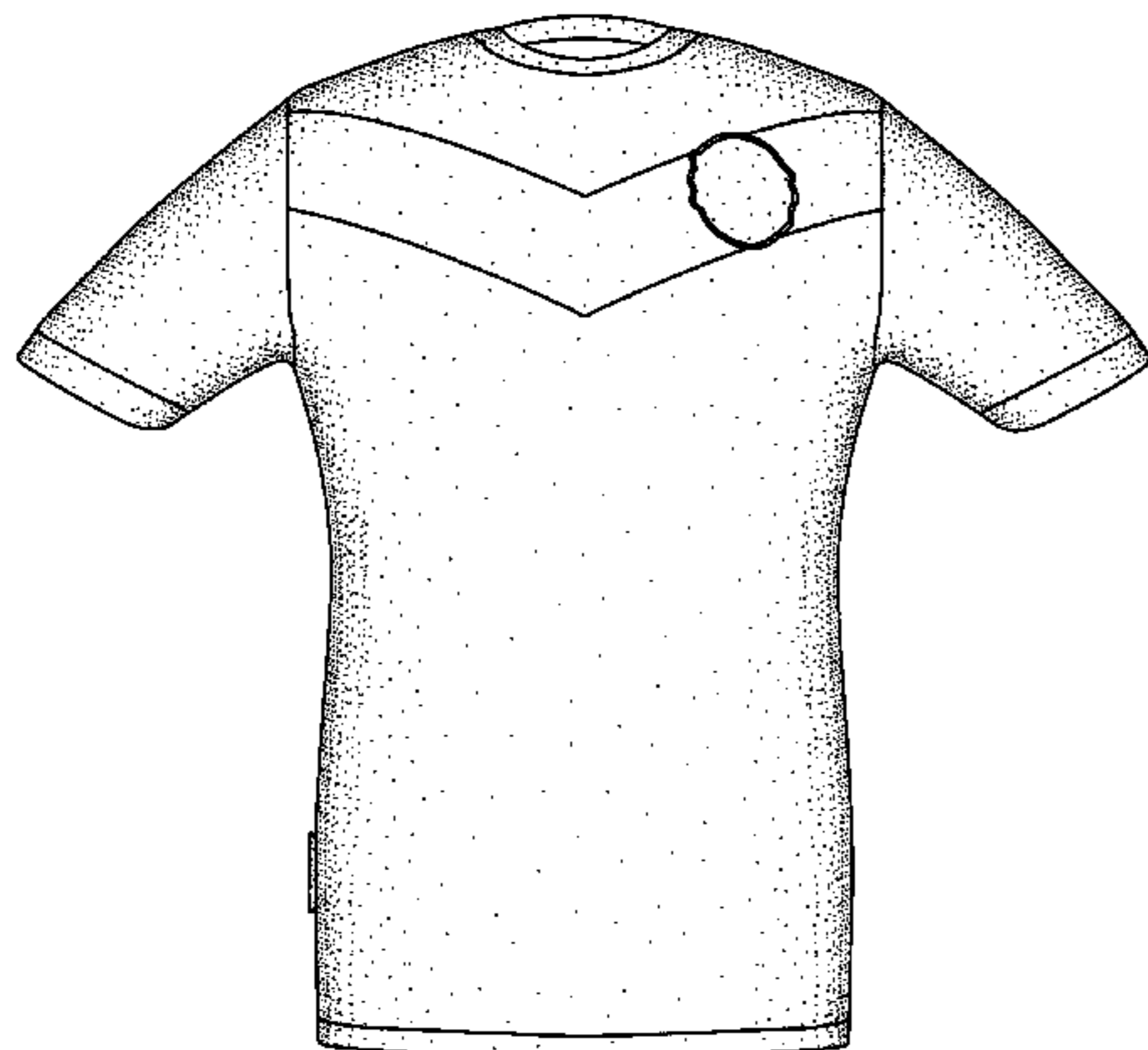
FIG. 12 is a second side view of the sports jersey shown in FIG. 8;

FIG. 13 is a top view of the sports jersey shown in FIG. 8; and,

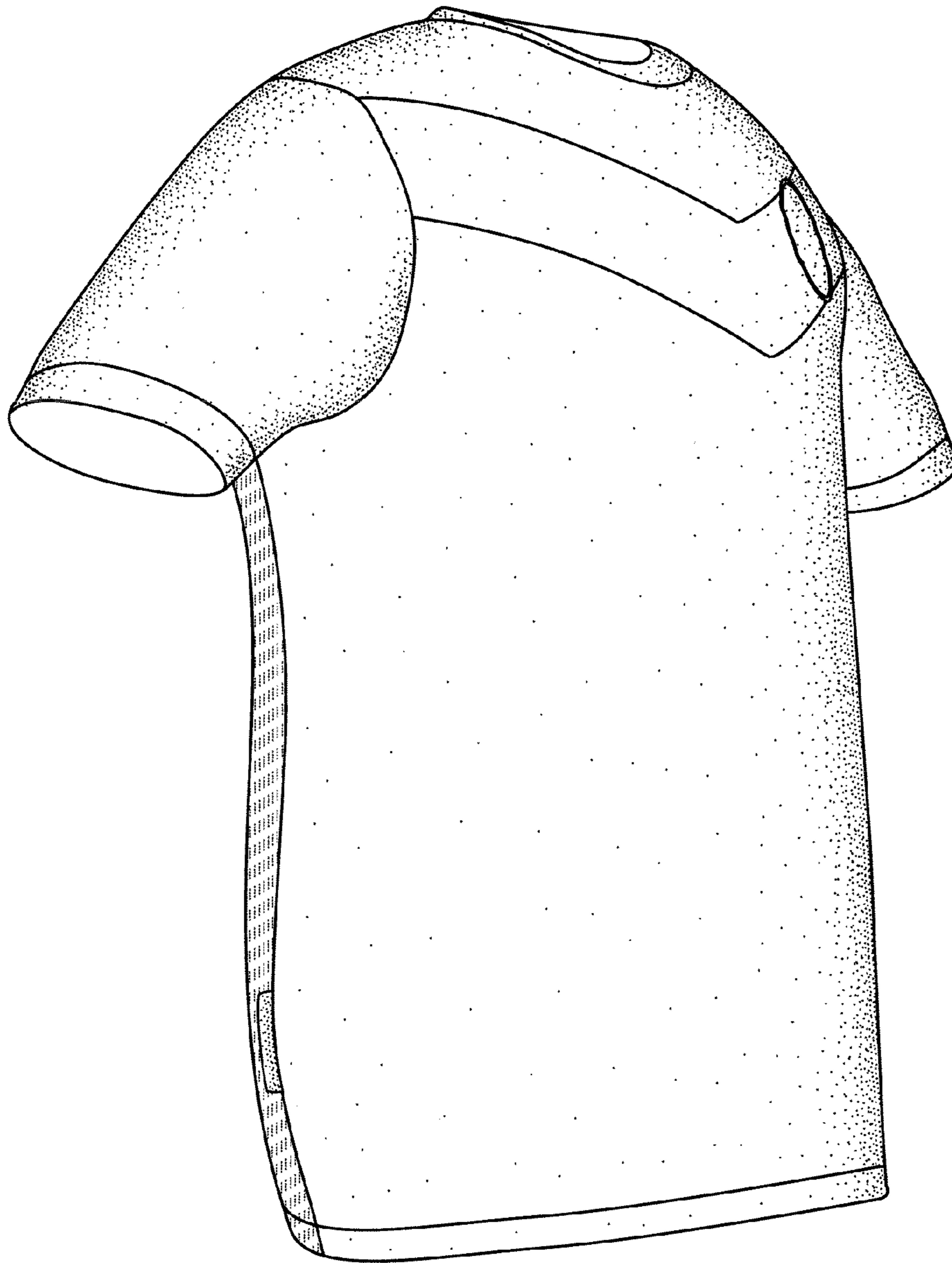

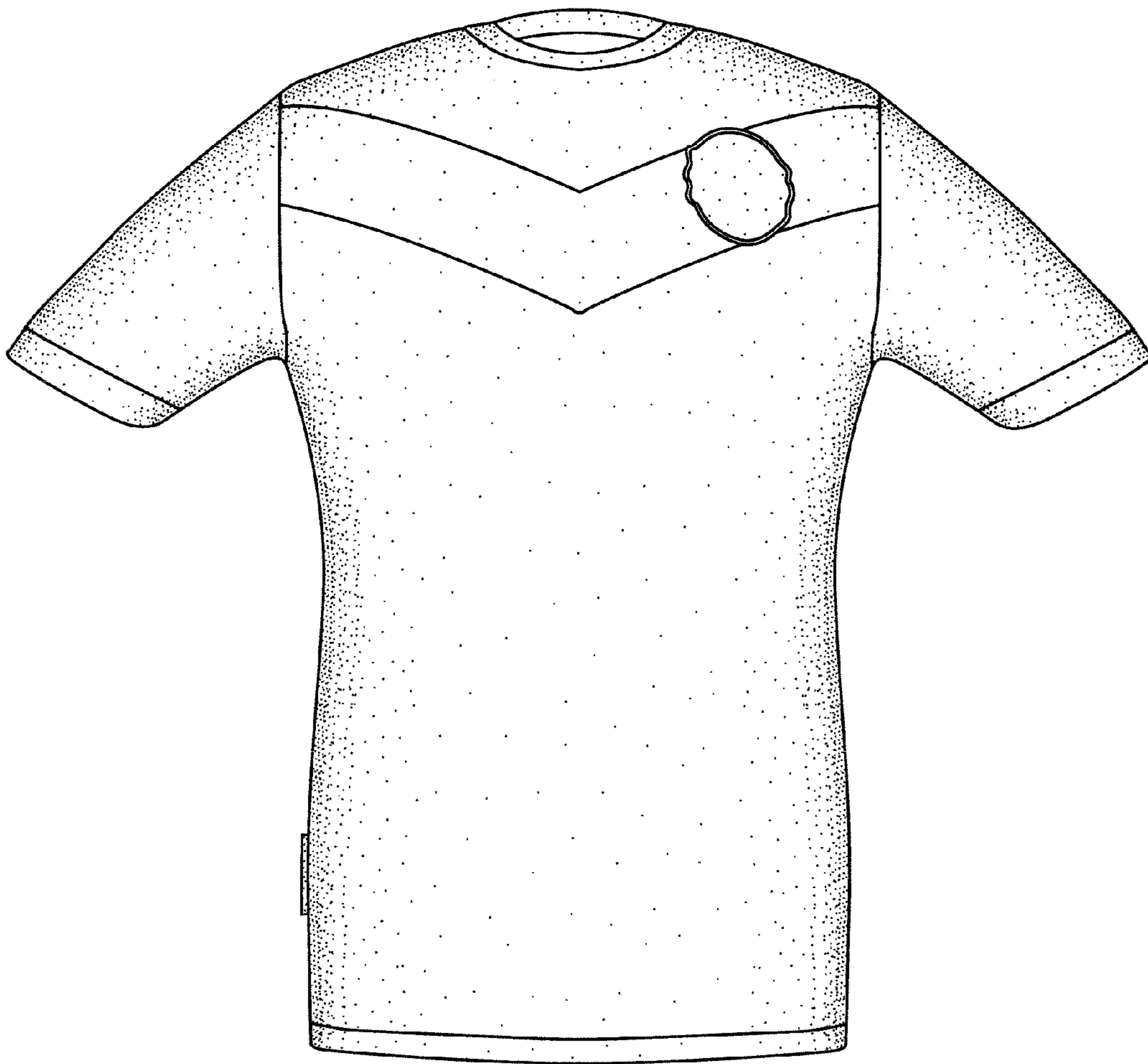

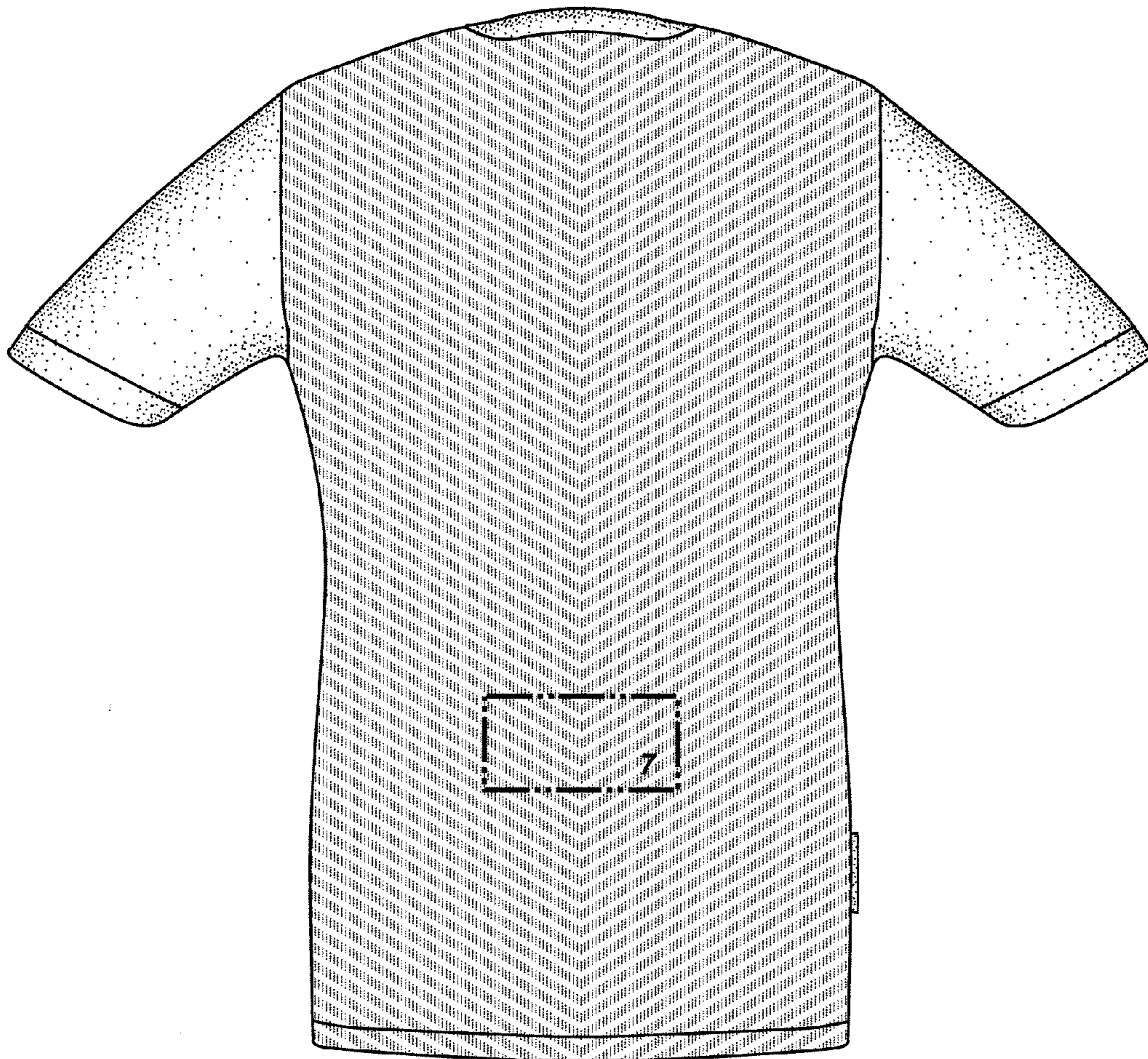

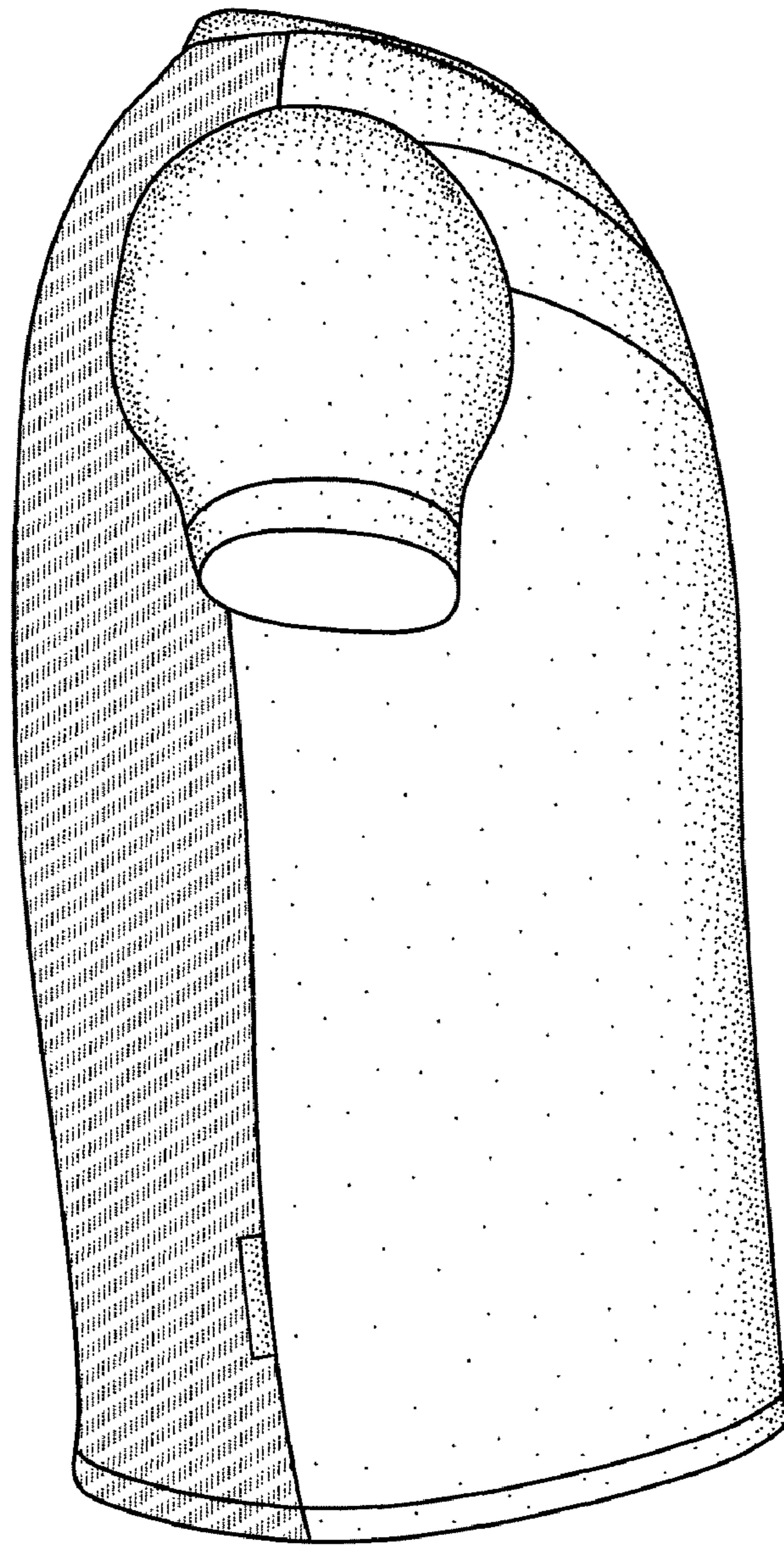

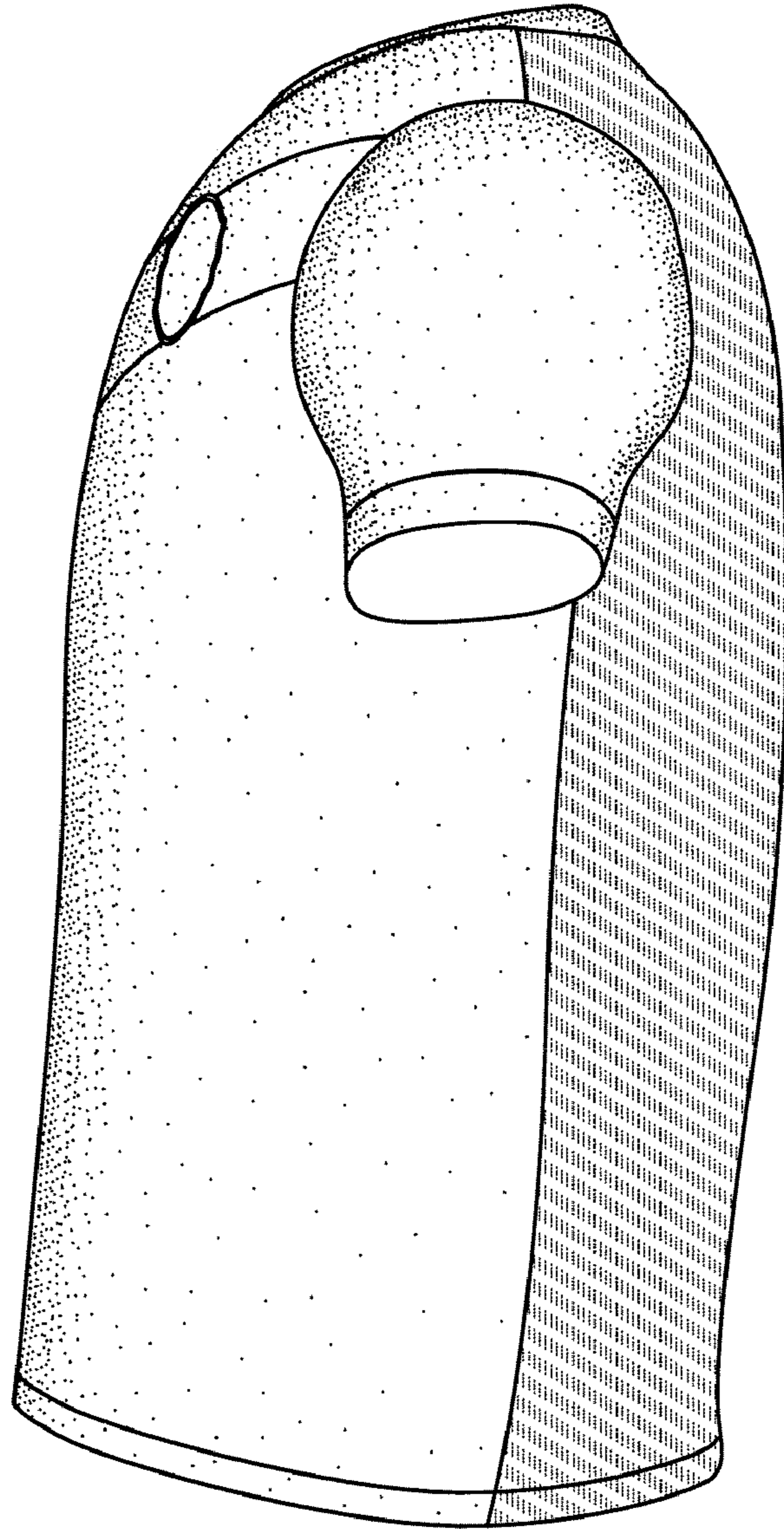

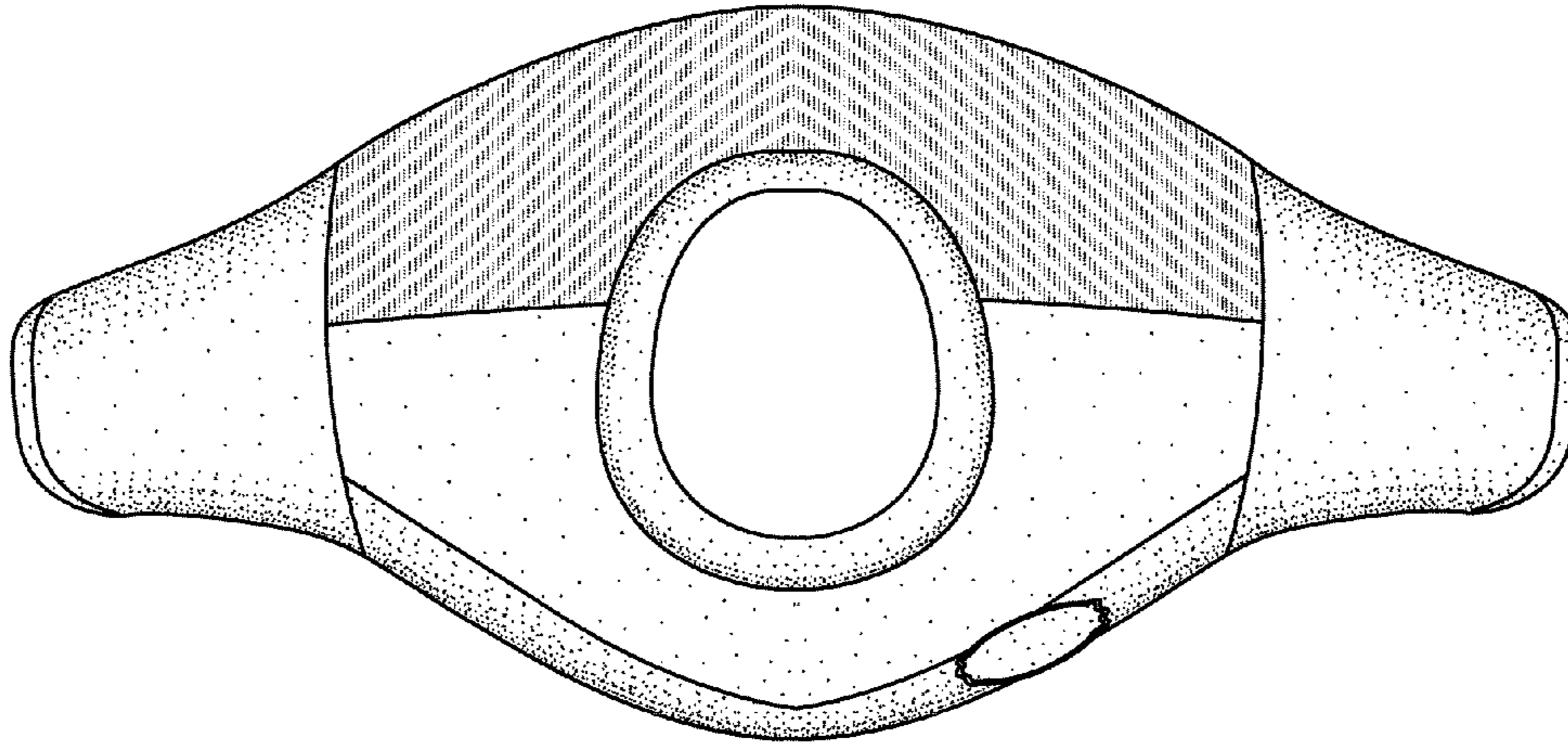

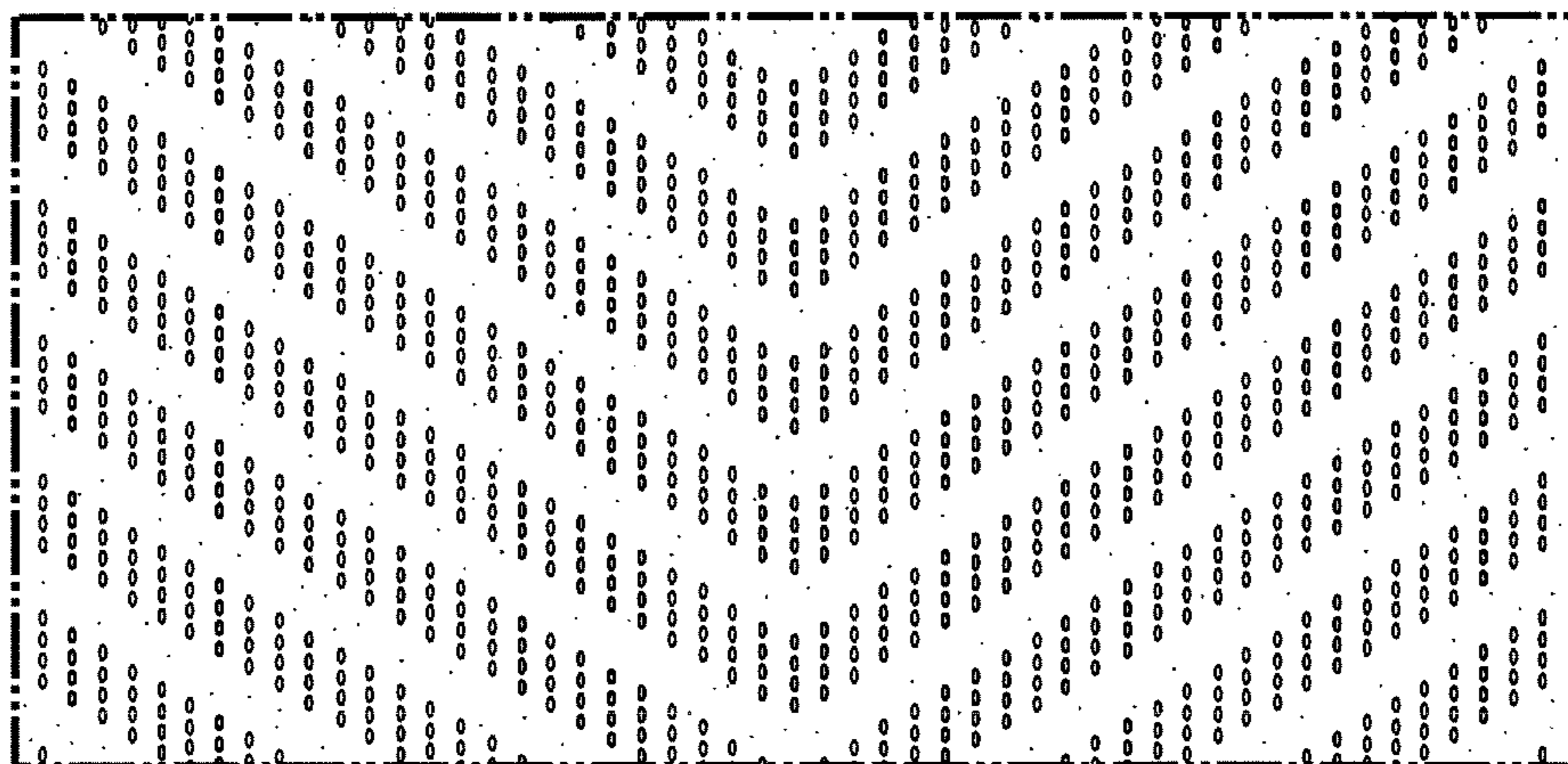

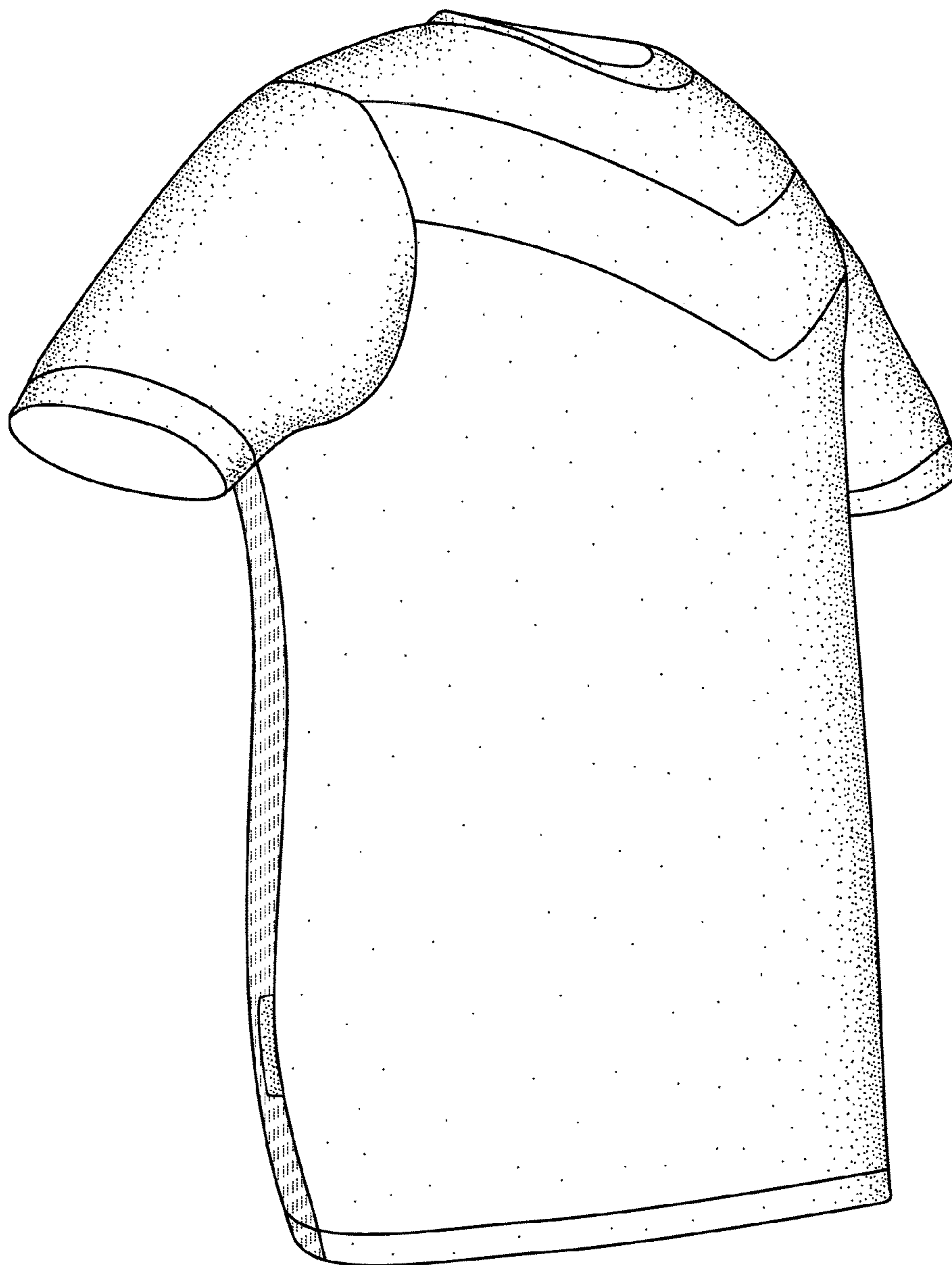

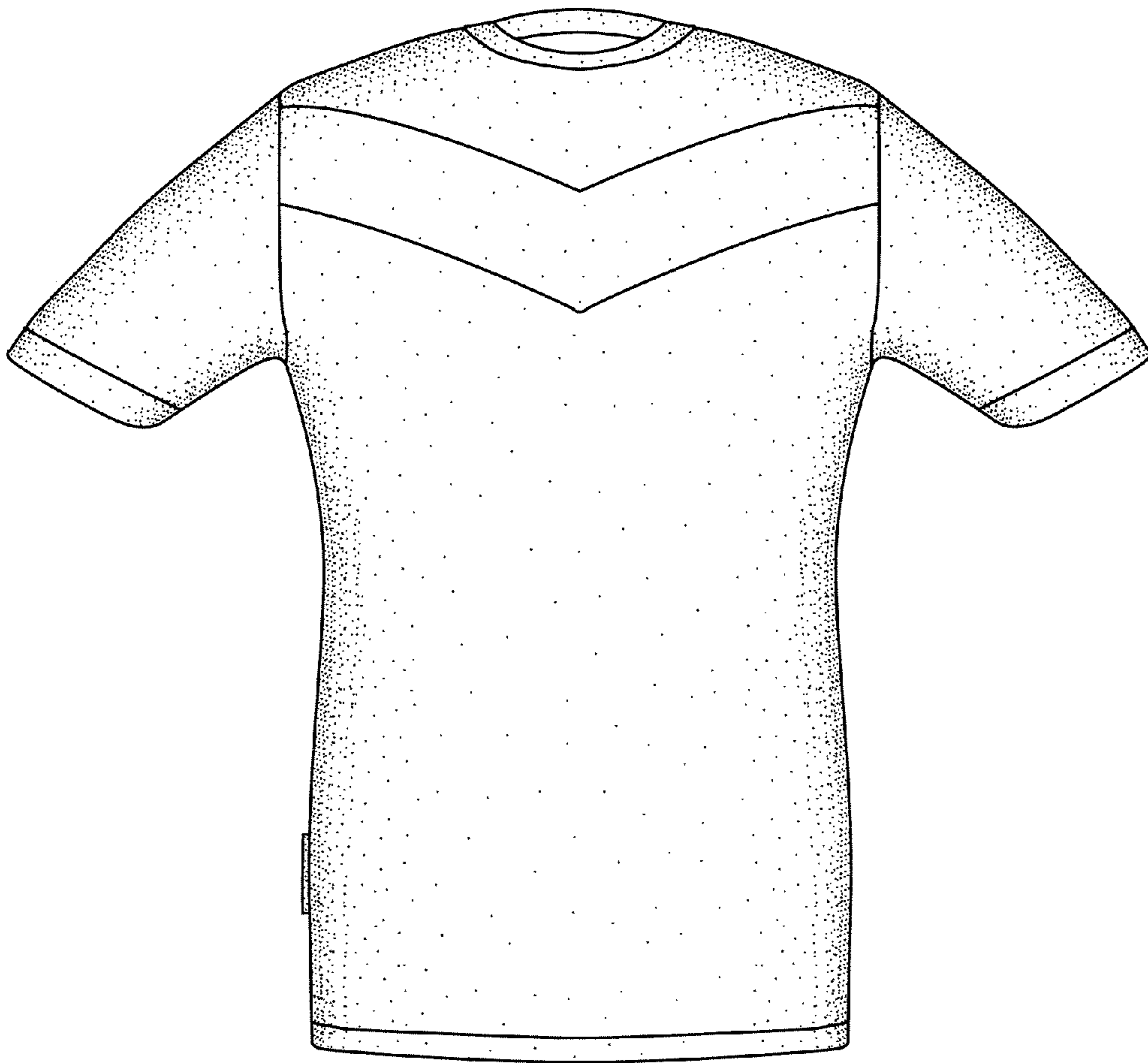

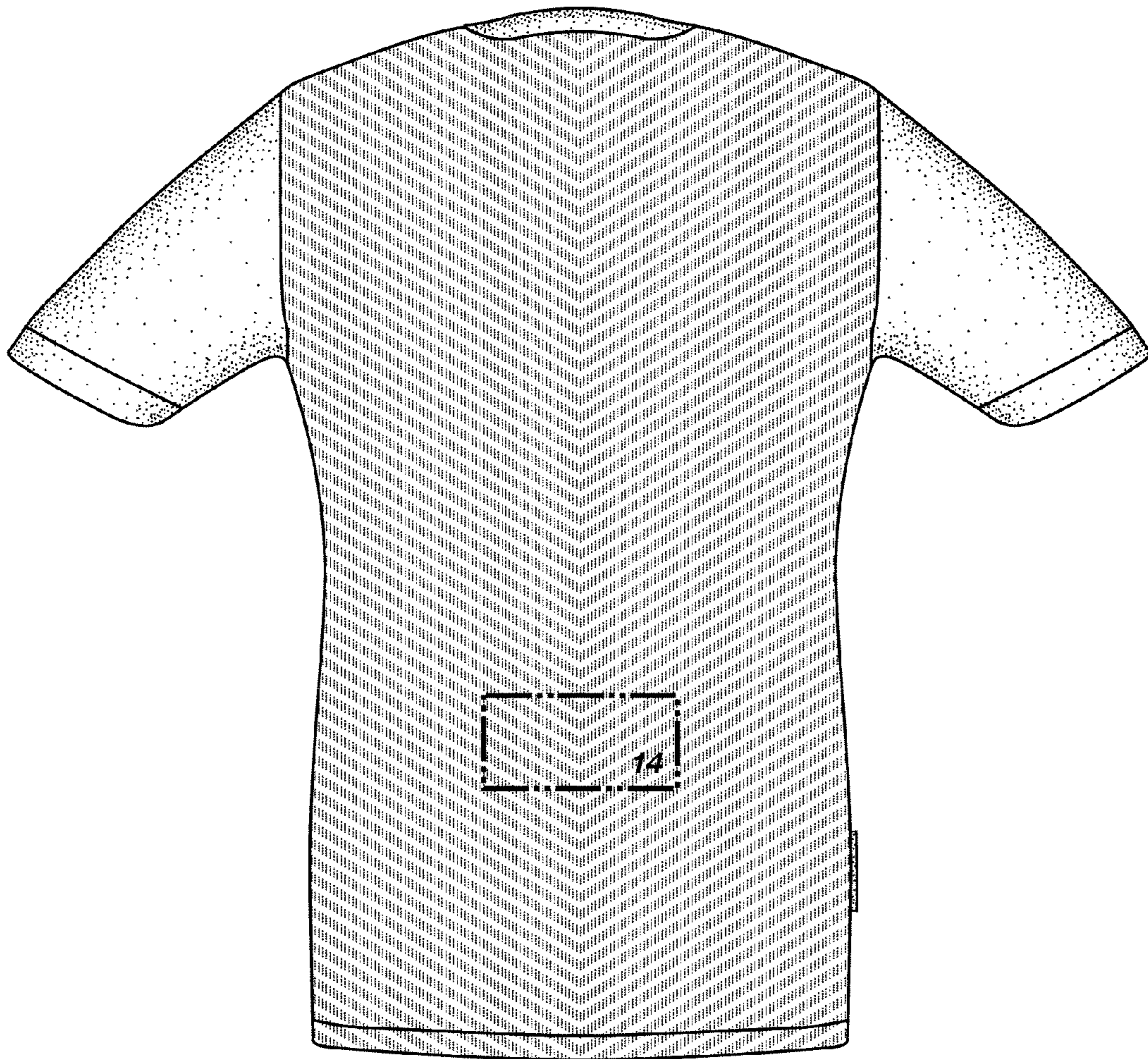

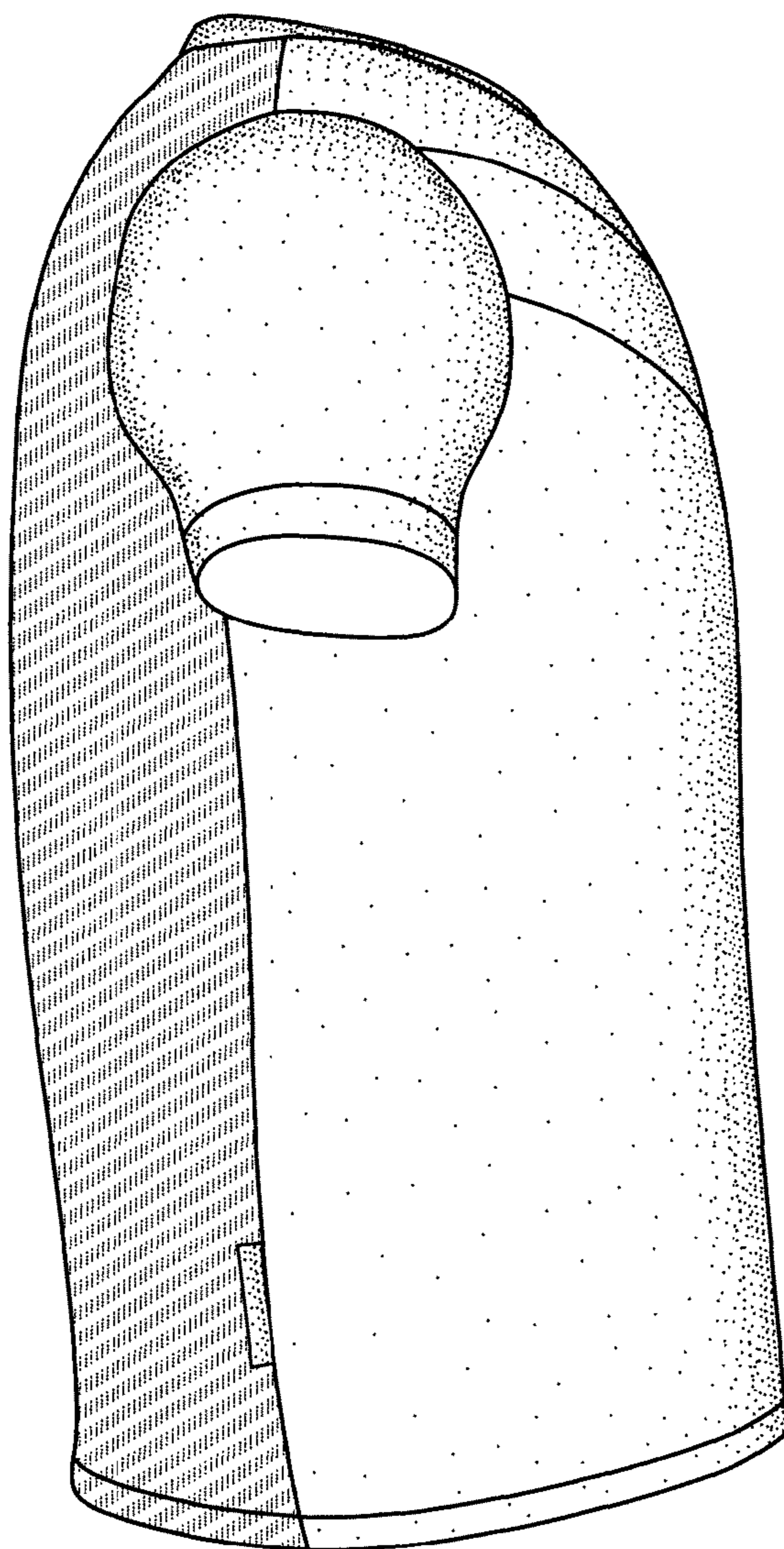

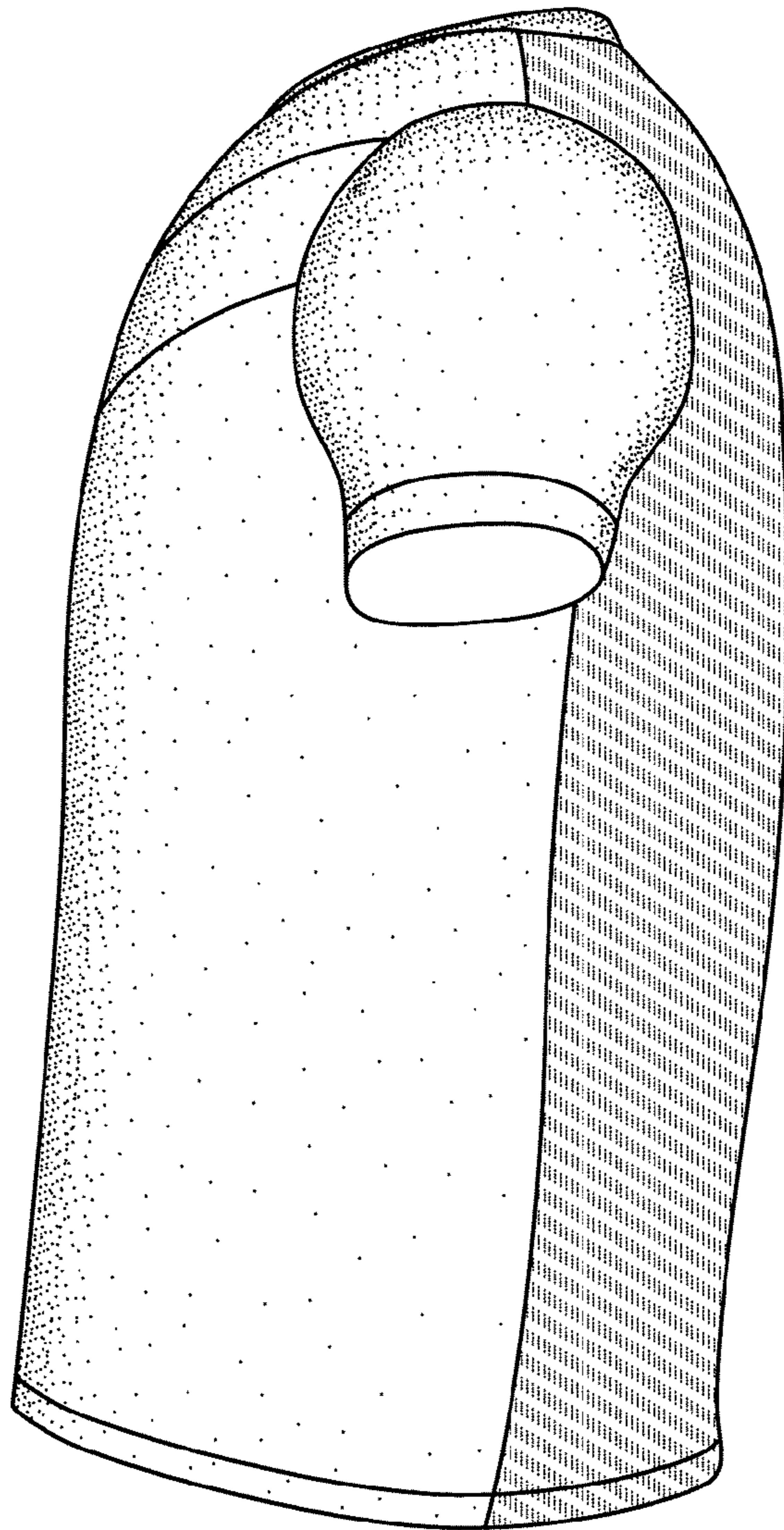

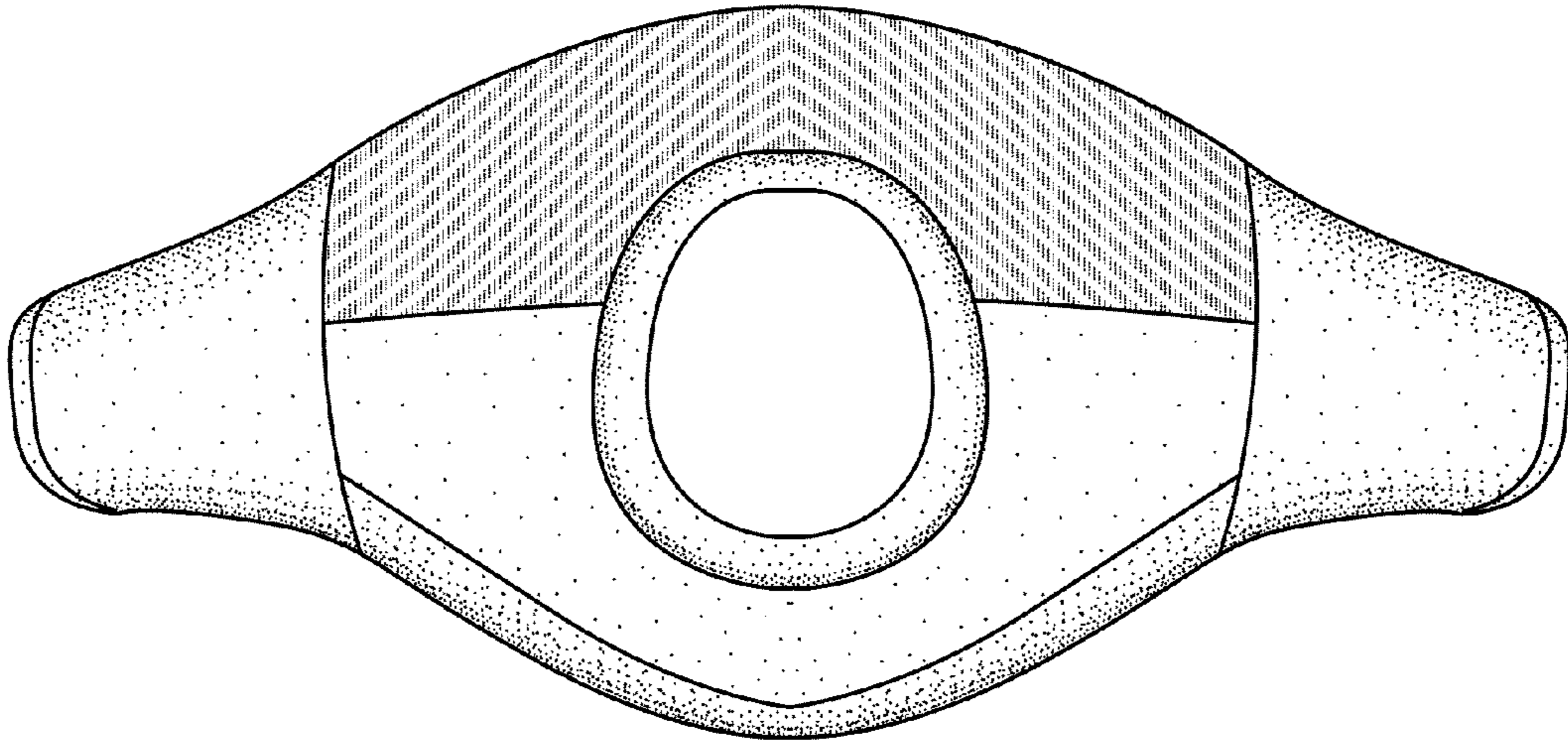

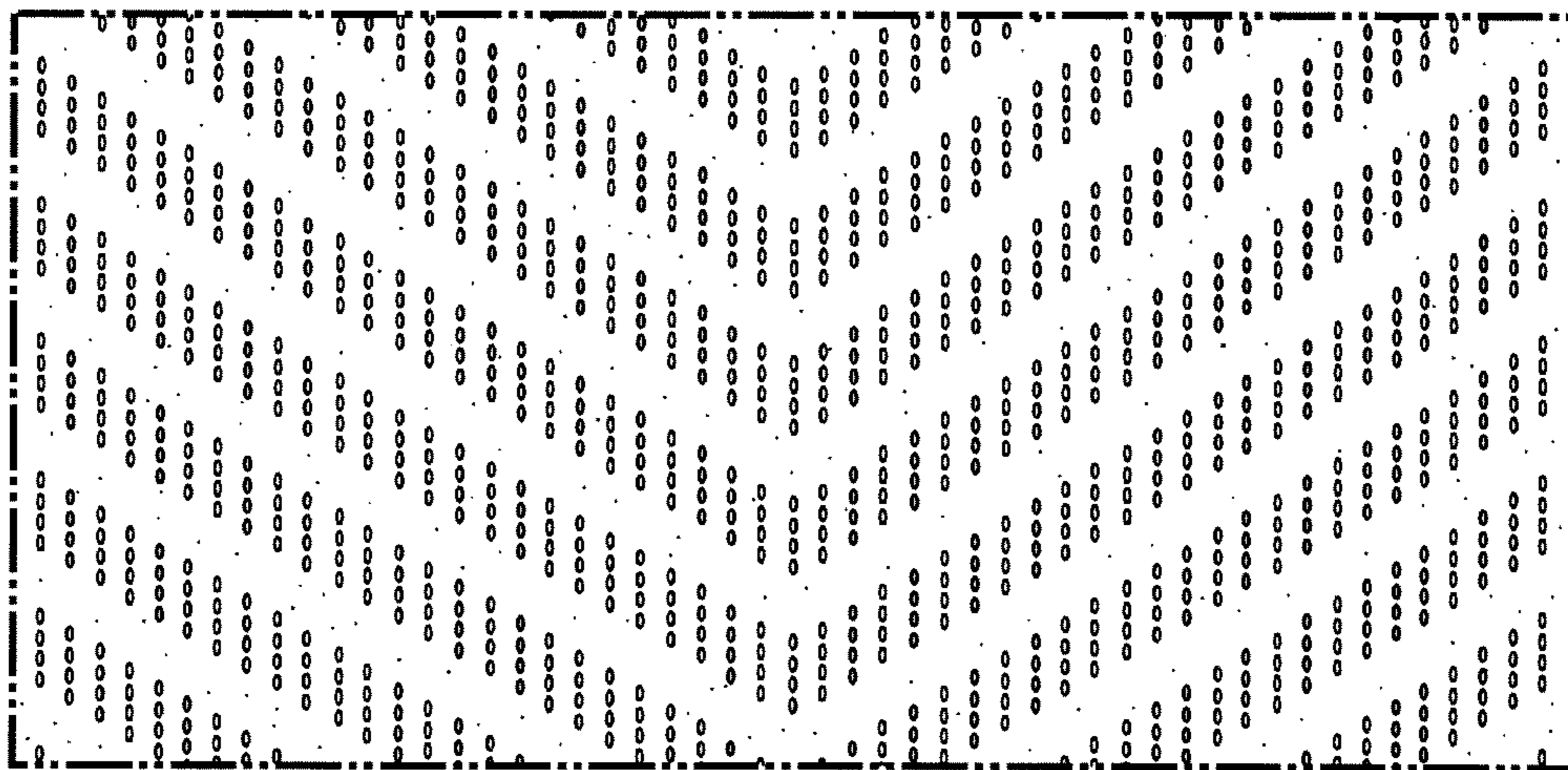
