(57) **CLAIM**

The ornamental design for an integrated tactical jacket, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of integrated tactical jacket showing the design;

FIG. 2 is a front view of the integrated tactical jacket of FIG. 1;

FIG. 3 is a rear view of the integrated tactical jacket of FIG. 1;

FIG. 4 is a right side view of the integrated tactical jacket of FIG. 1;

FIG. 5 is a left side view of the integrated tactical jacket of FIG. 1;

FIG. 6 is a top view of the integrated tactical jacket of FIG. 1;

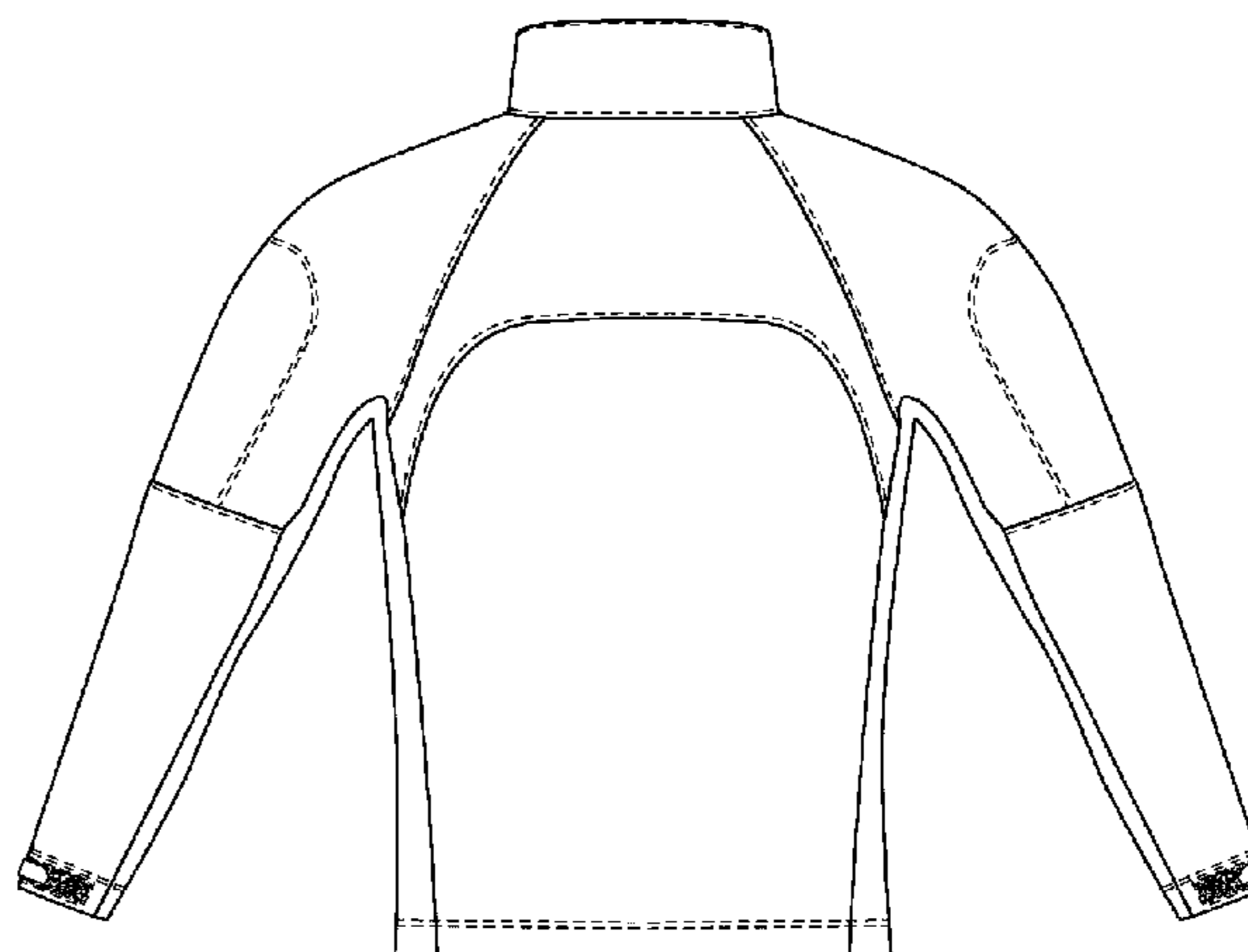
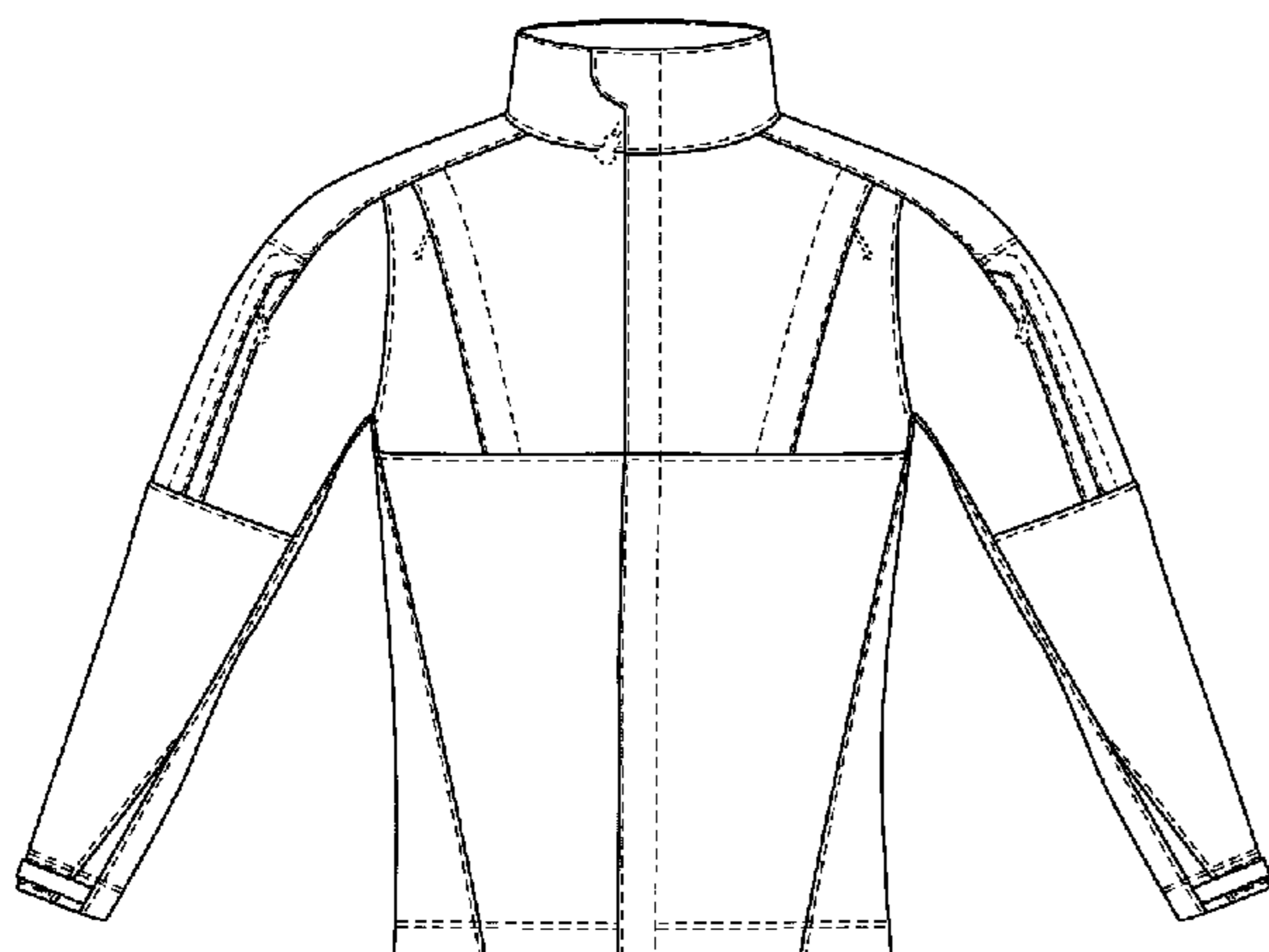
FIG. 7 is a bottom view of the integrated tactical jacket of FIG. 1; and,

FIG. 8 is a front perspective view of the integrated tactical jacket of FIG. 1, as worn.

The broken lines, shown on the surface of the jacket in FIGS. 1-8, represent stitching. The broken lines in FIG. 8, showing portions of the human form, illustrate the design in use and form no part of the claim.

In FIGS. 1, 2, 4-6 and 8, the broken lines showing slide fastener pull tabs represent the portions of the jacket, which form no part of the claimed design.

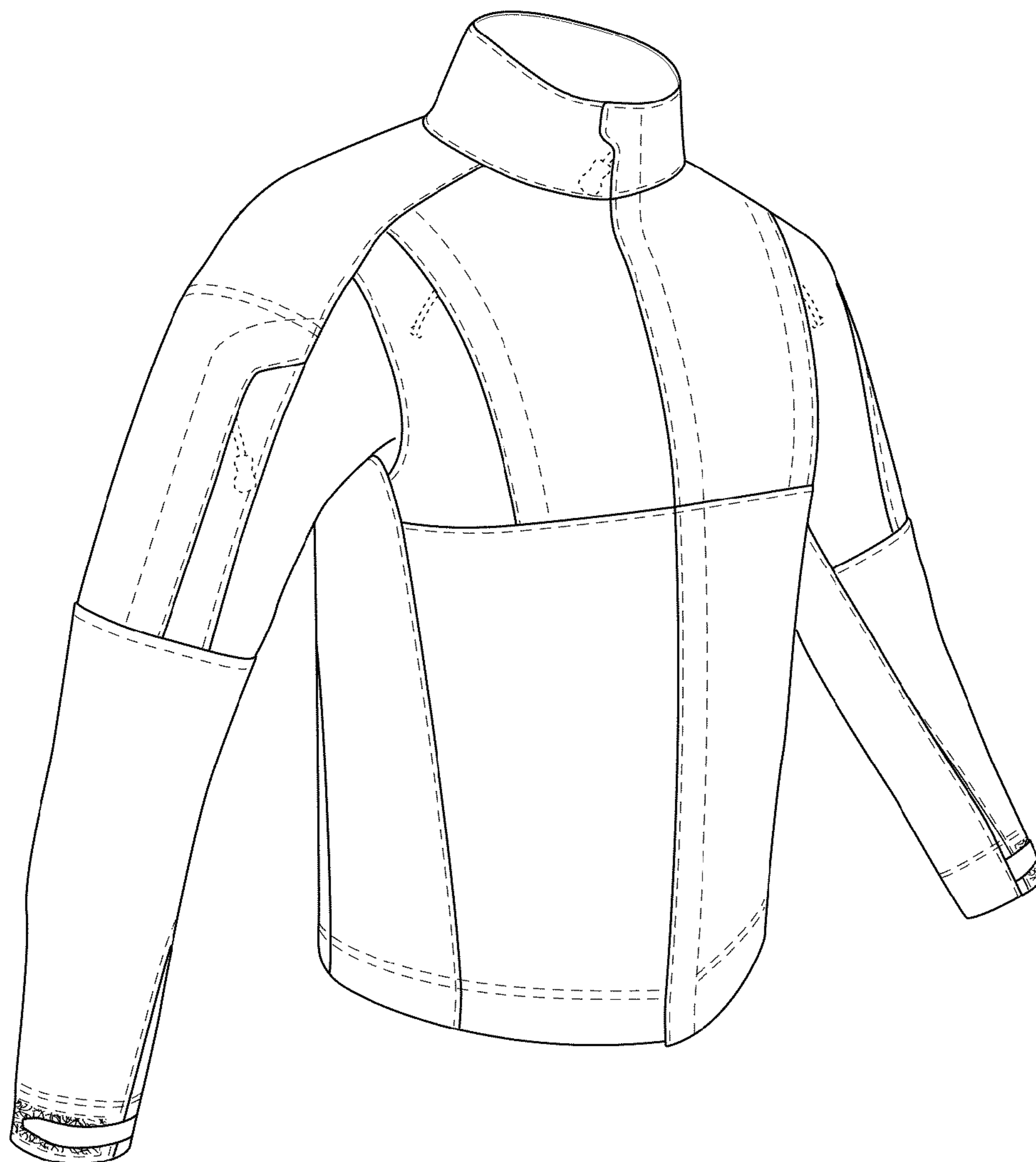

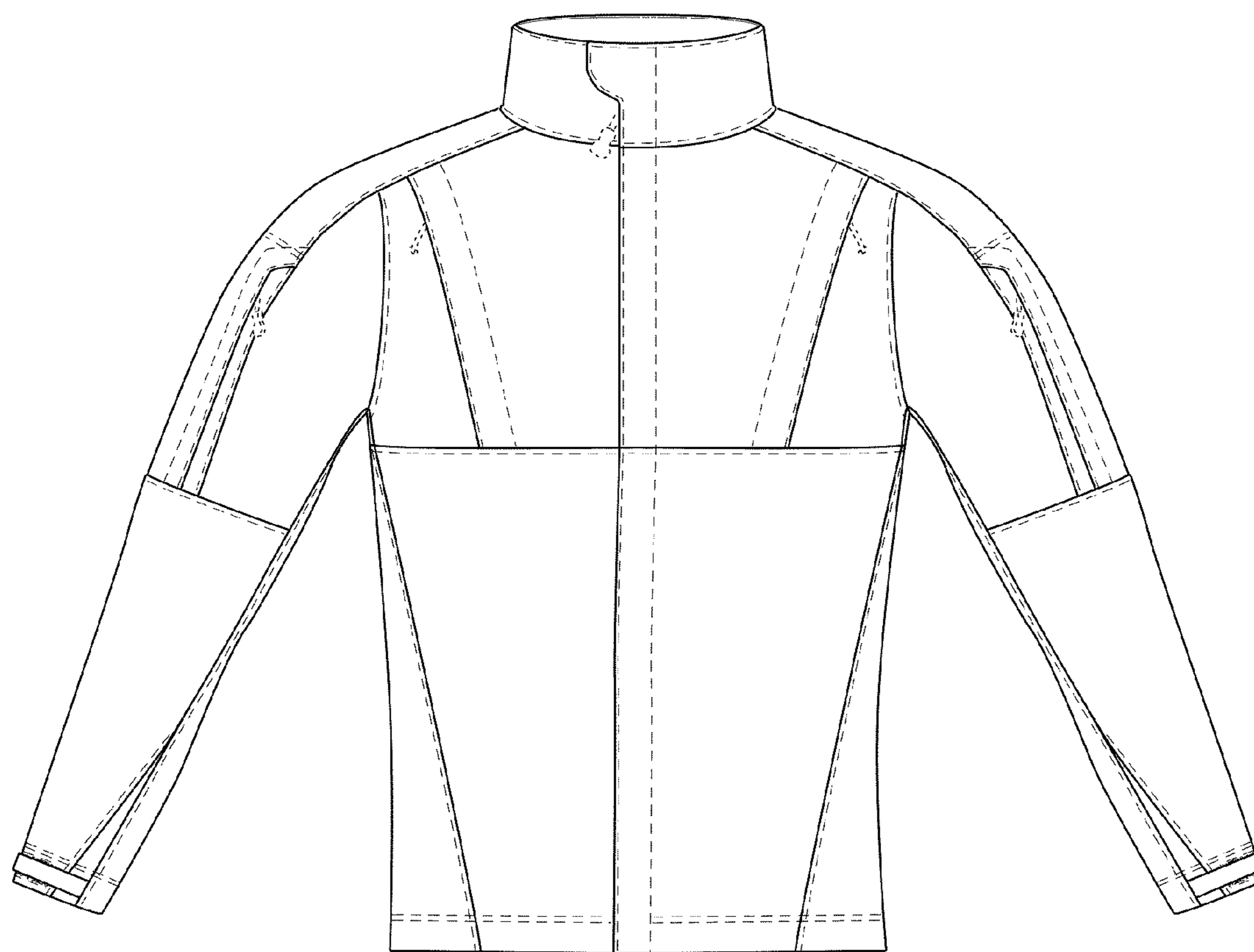

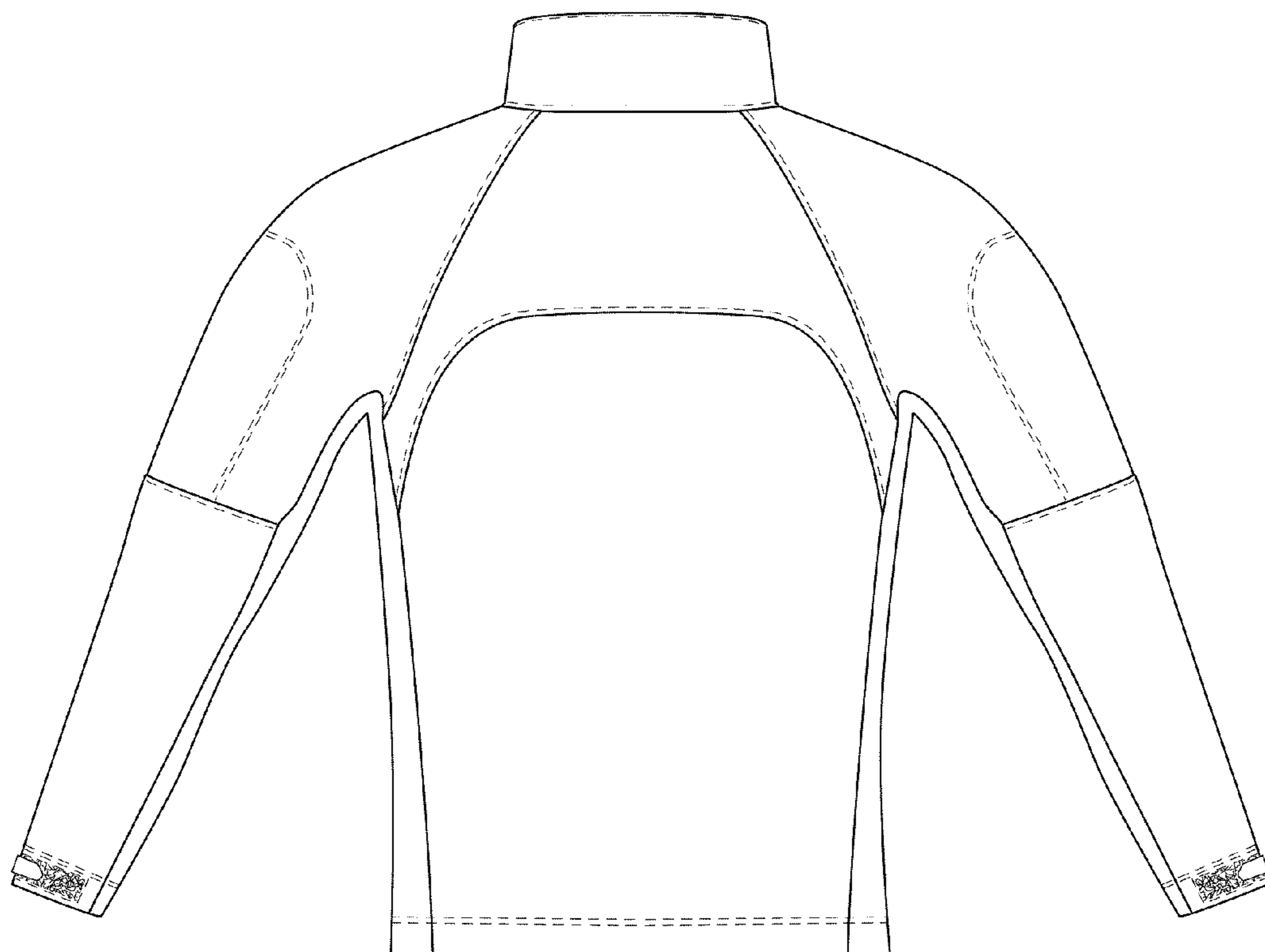

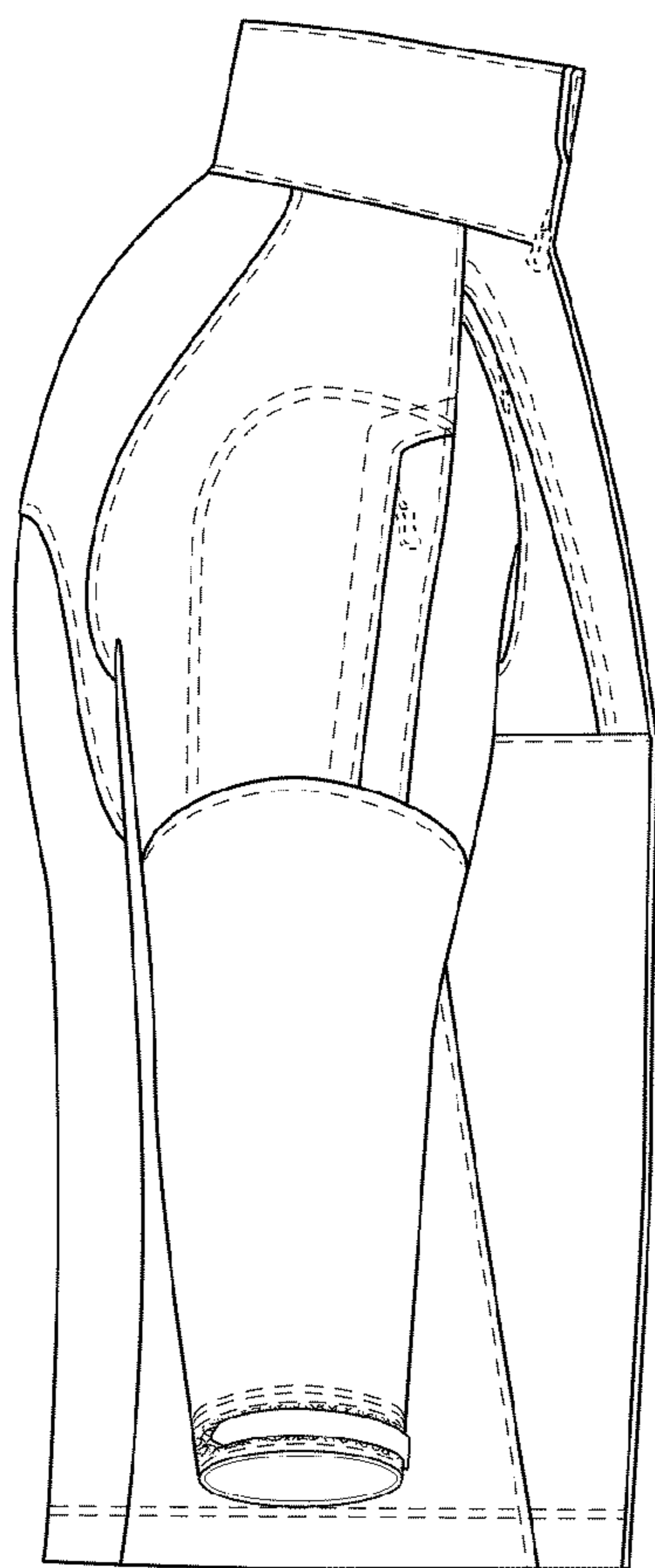

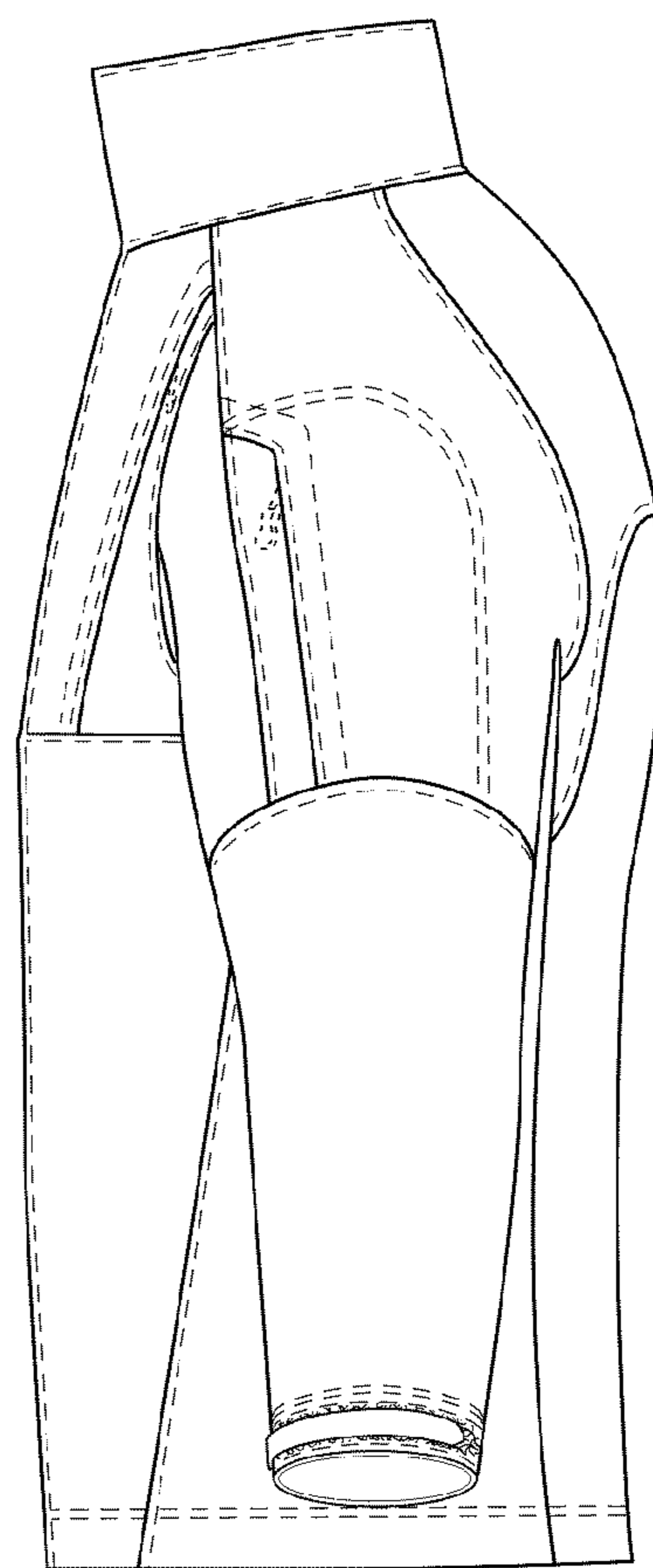

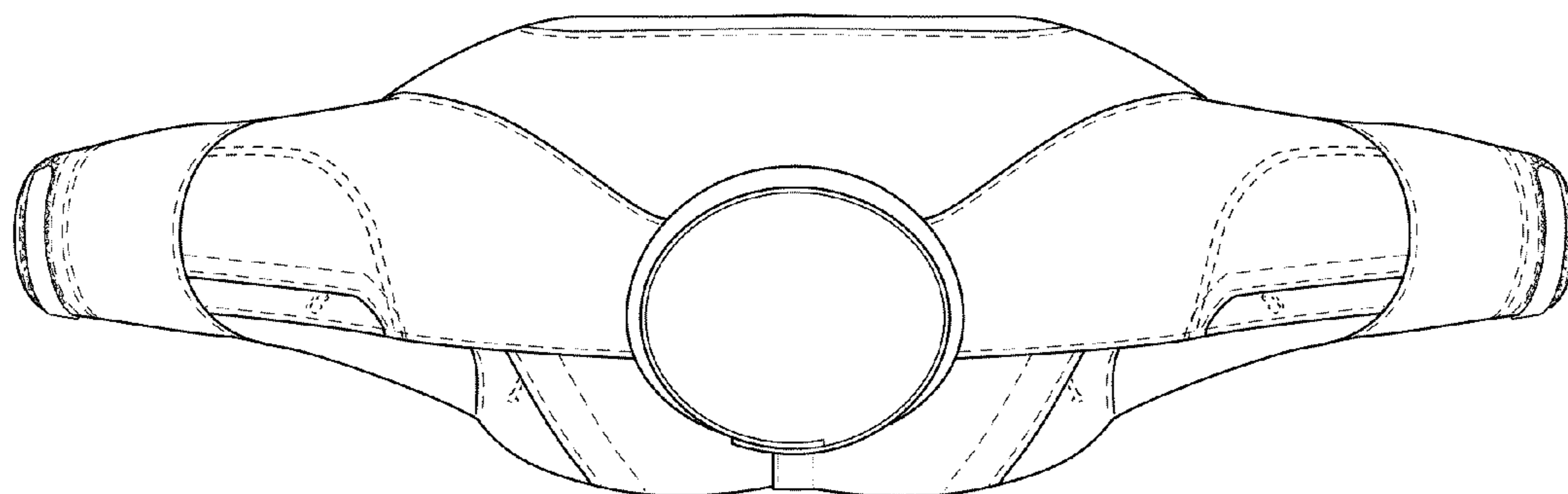

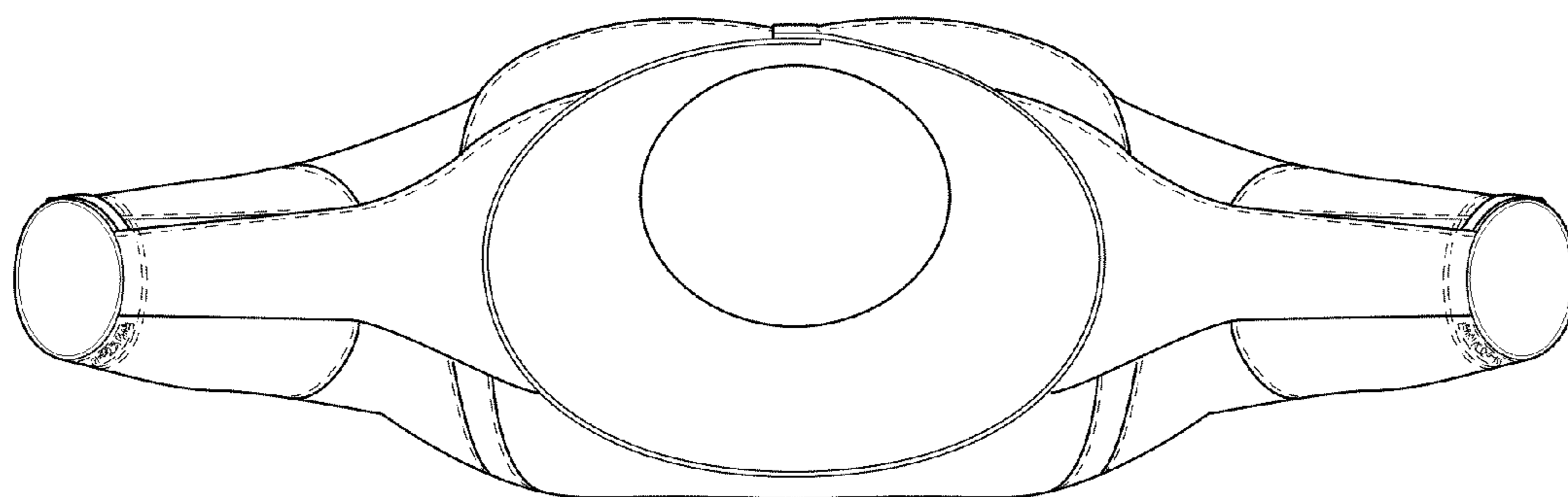

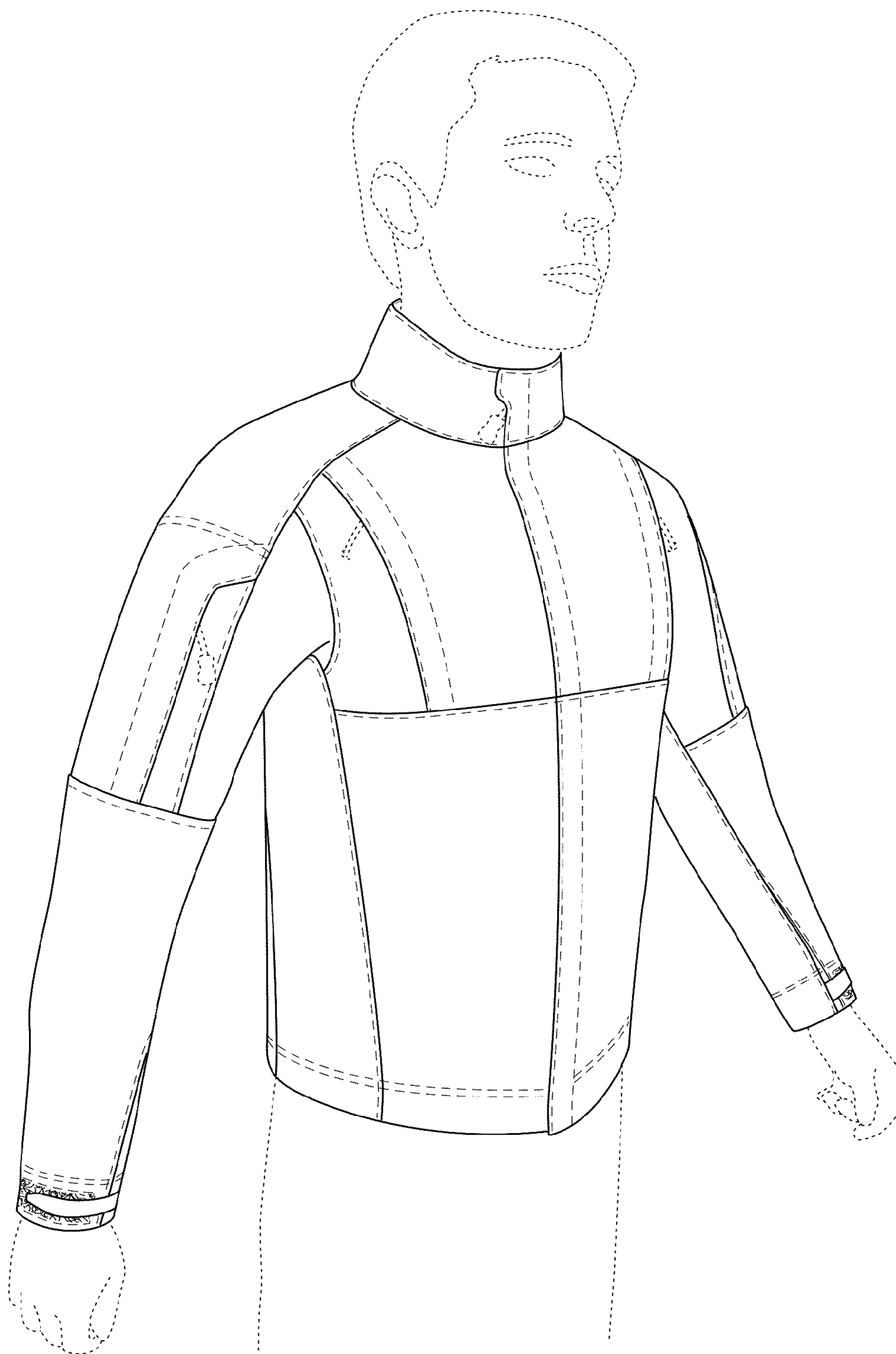
