(57) **CLAIM**

The ornamental design for a cleat/spike cradle shoe, as shown and described.

**DESCRIPTION**

This is a design of application Ser. No. 10/900,217, filed Jul. 27, 2004 and 11/526,372, filed Sep. 25, 2006.

FIG. 1 is a side perspective view of the cleat/spike cradle shoe showing my new design.

FIG. 2 is an exploded view of the cleat/spike cradle shoe showing my new design.

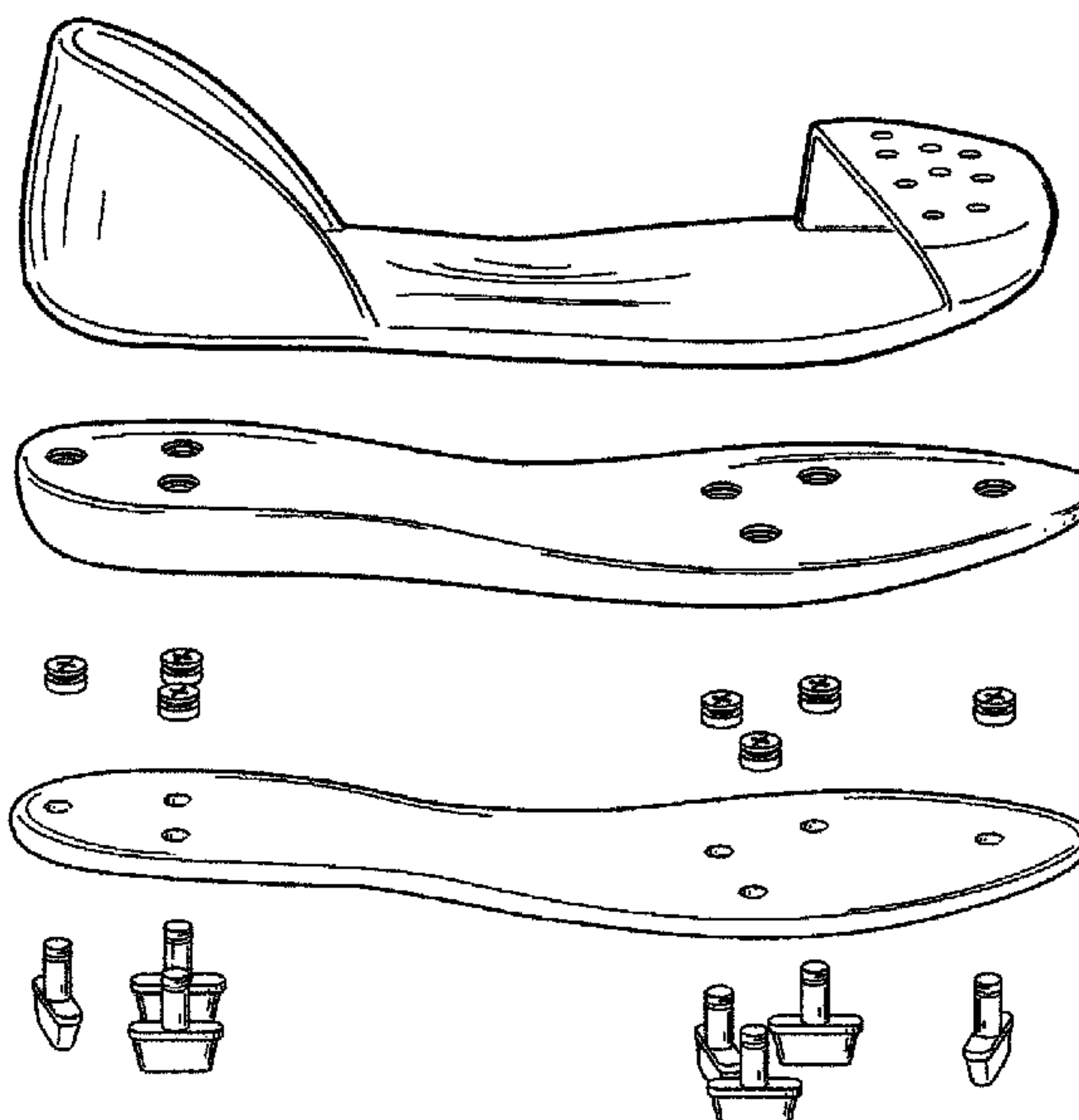
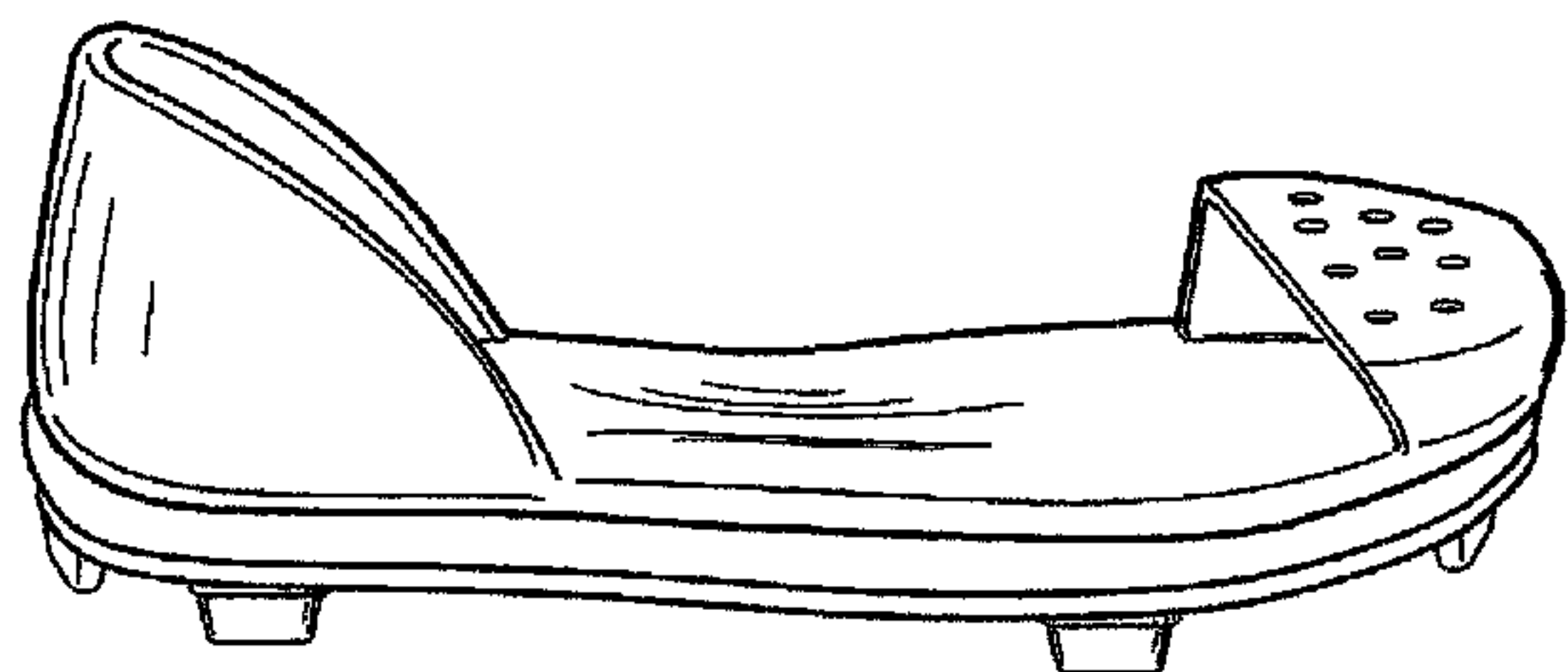
FIG. 3 is a rear elevational view of the cleat/spike cradle shoe showing my new design.

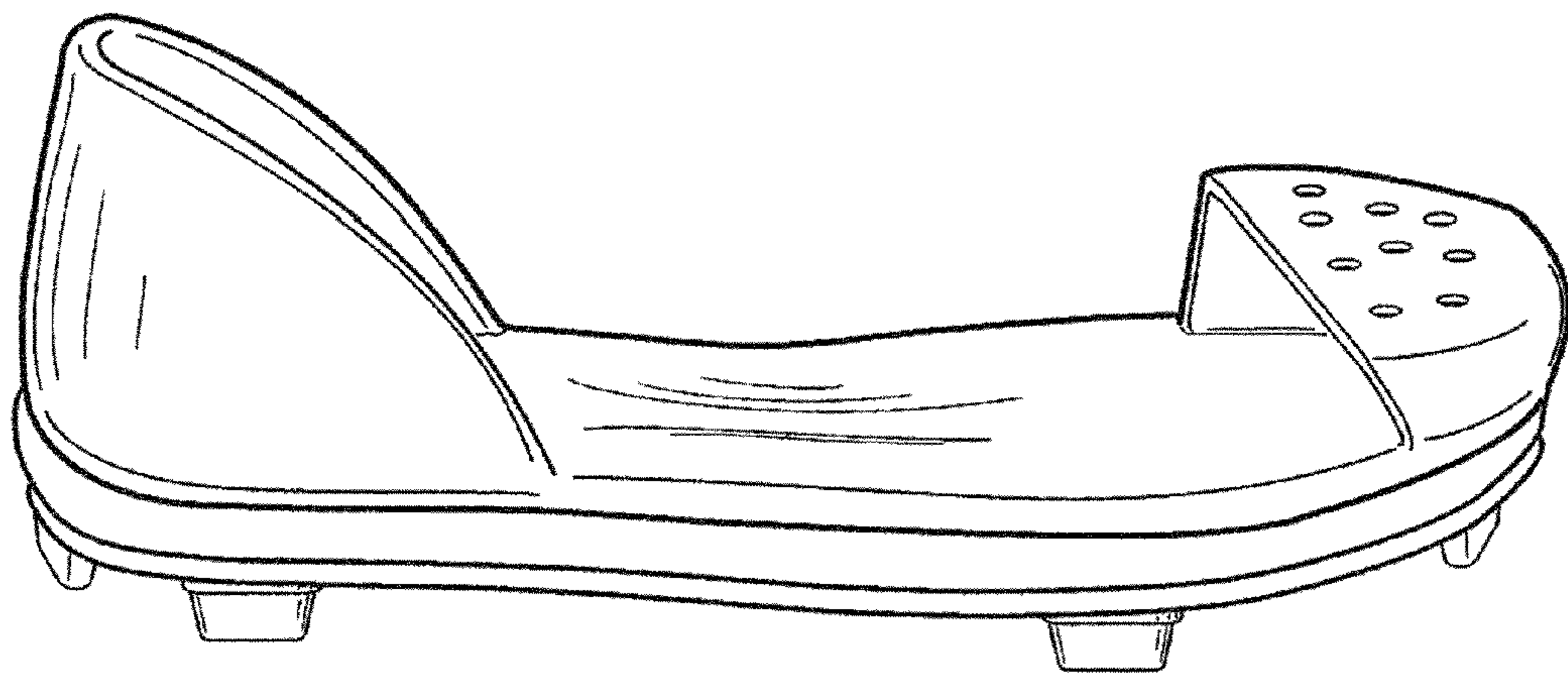

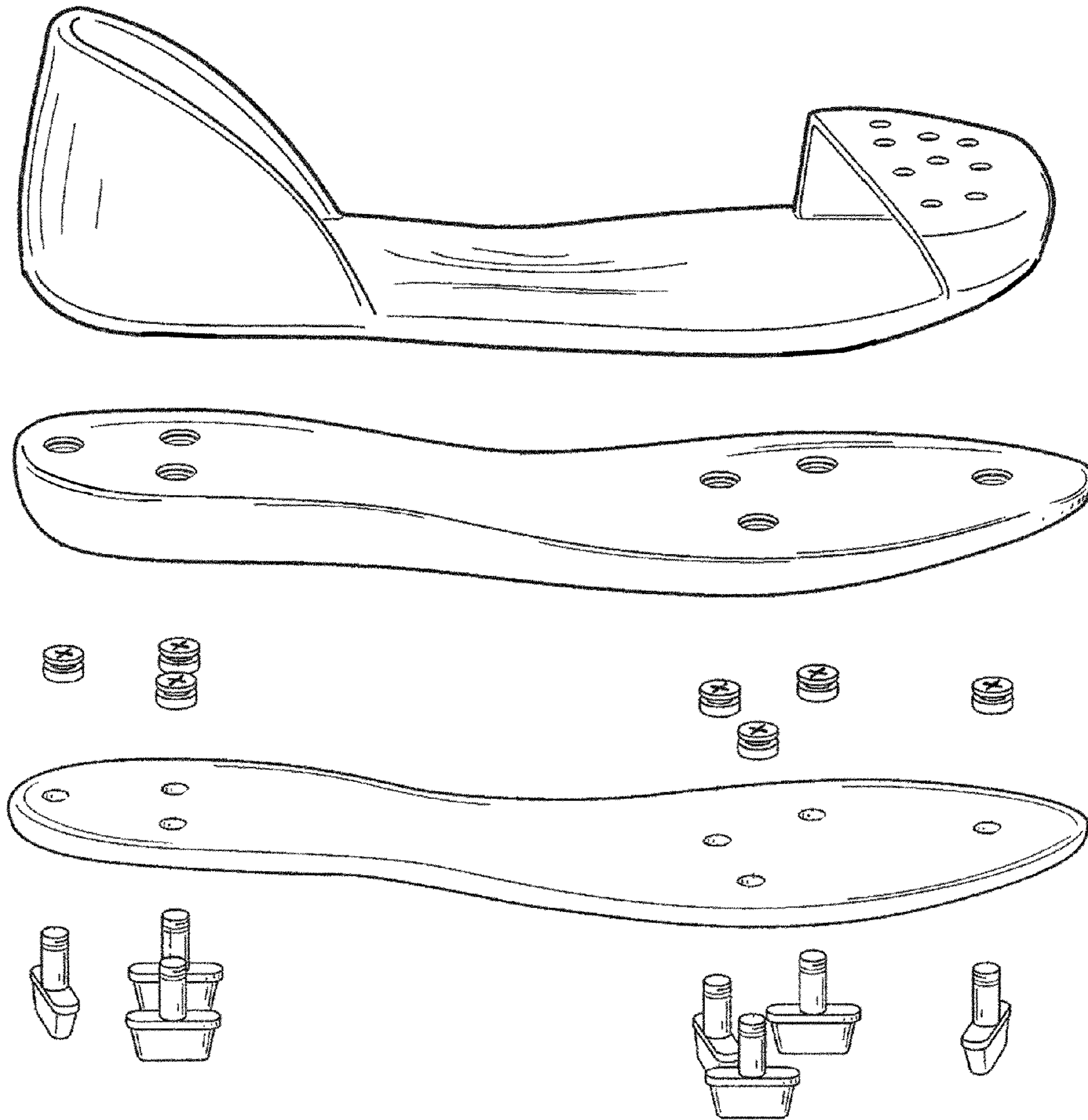

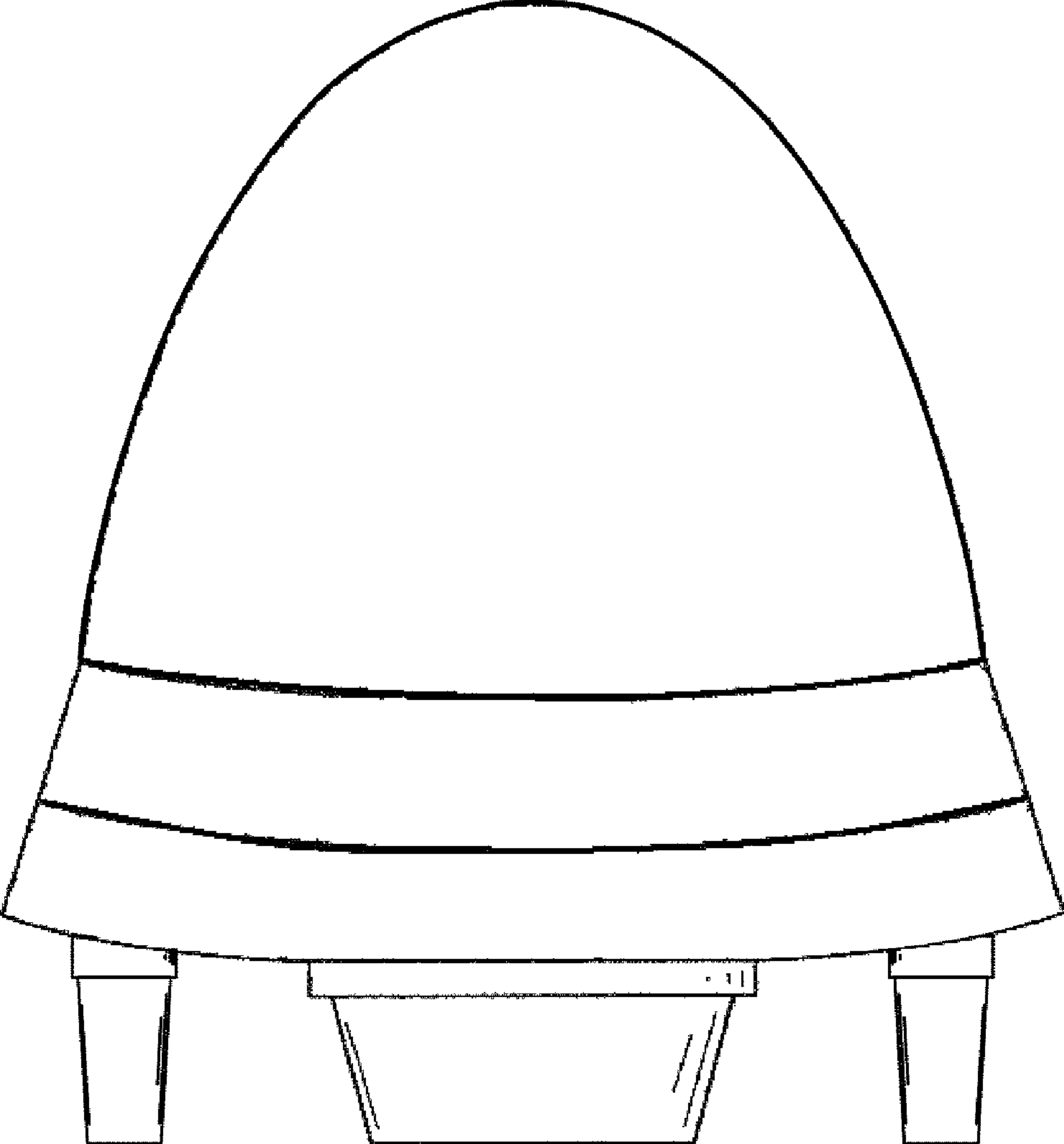

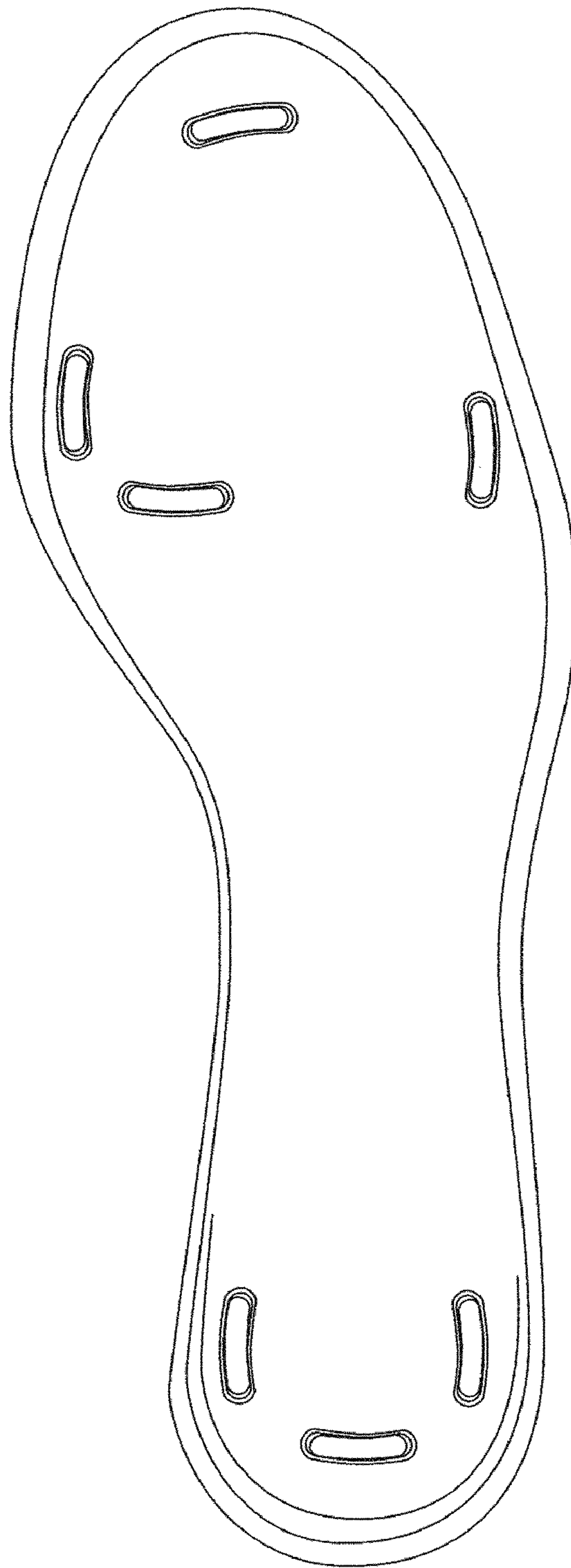

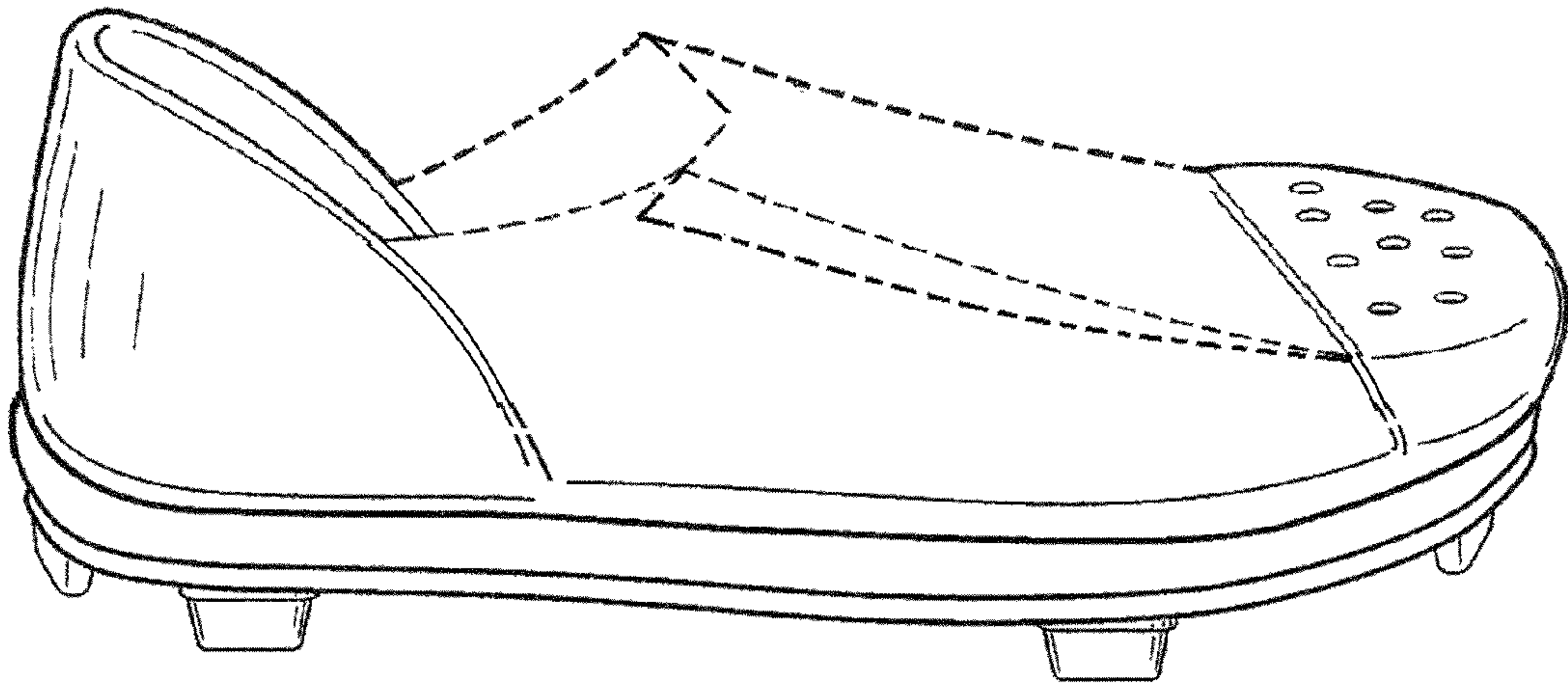
