(57) **CLAIM**

The ornamental design for a multipurpose golf club container, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevation view of a multipurpose golf club container, showing the new design in the closed configuration;

FIG. 2 is a rear view of a multipurpose golf club container in the closed configuration;

FIG. 3 is a rear elevation view of a multipurpose golf club container in the open configuration;

FIG. 4 is a front elevation view of a multipurpose golf club container in the open configuration;

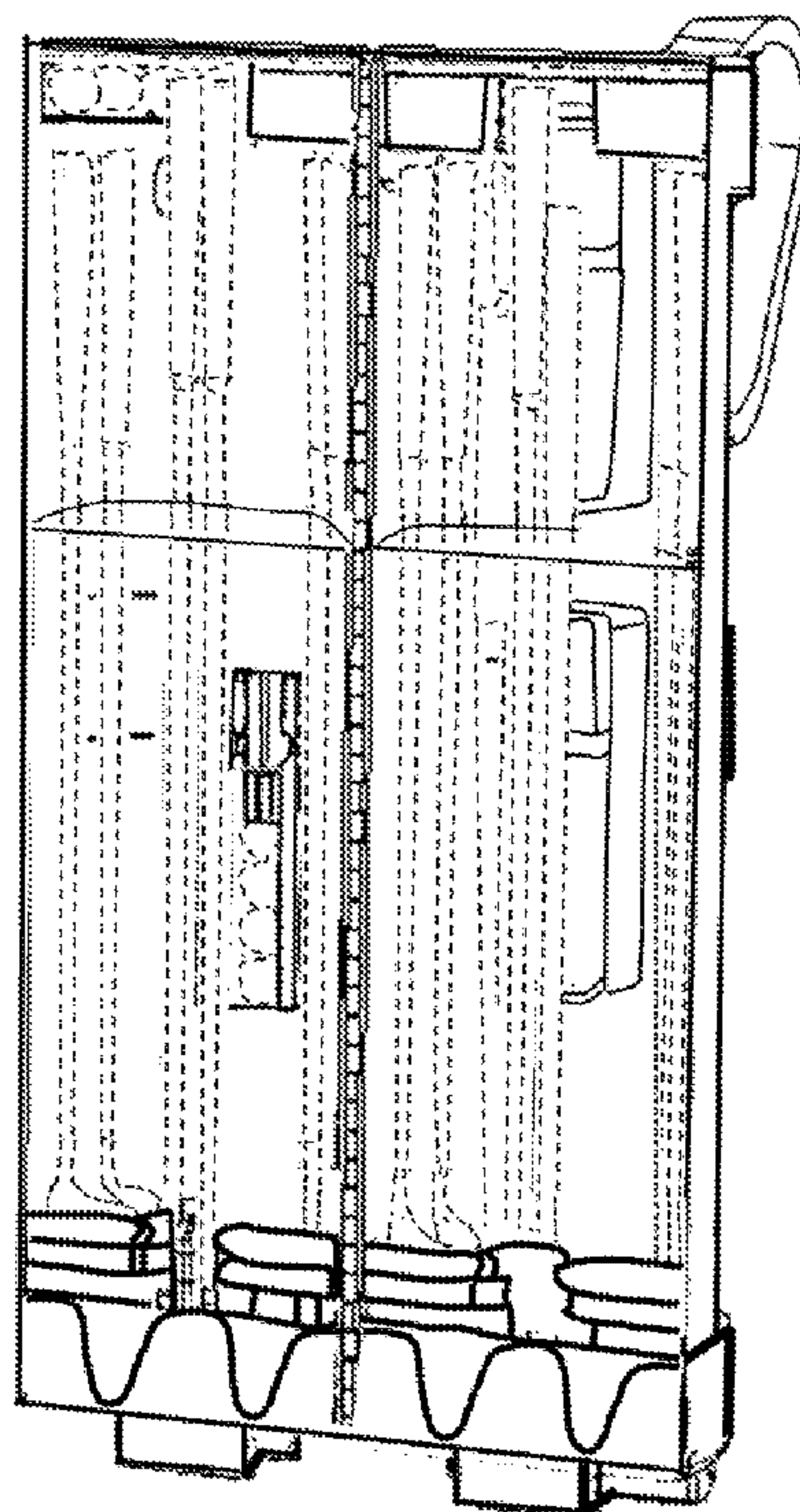
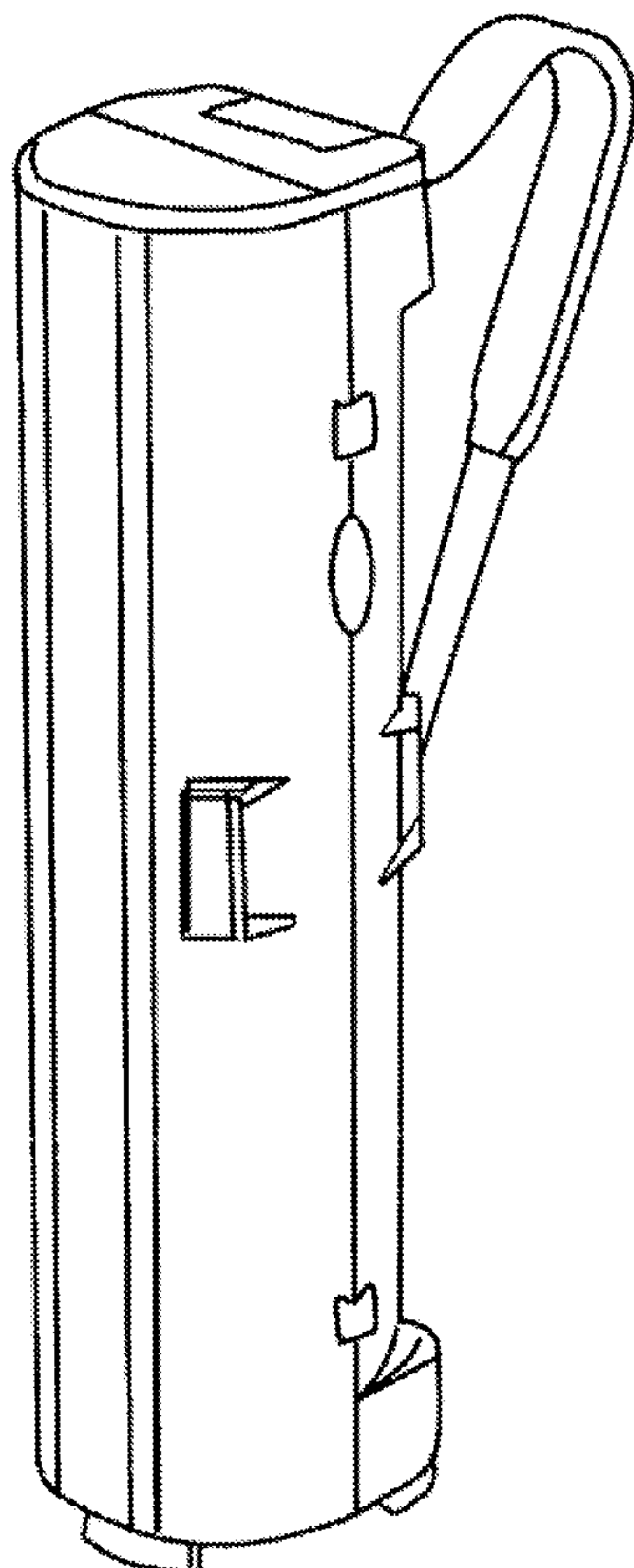
FIG. 5 is a front view of a multipurpose golf club container in the open configuration; and,

FIG. 6 is a front view of a multipurpose golf club container in the open configuration.

The multipurpose golf club container comprises two compartments for containing golf clubs and as shown has an open configuration and a closed configuration, and wheels.

The broken lines showing golf clubs and golf balls are for the purposes of illustrating environment and form no part of the claimed design.

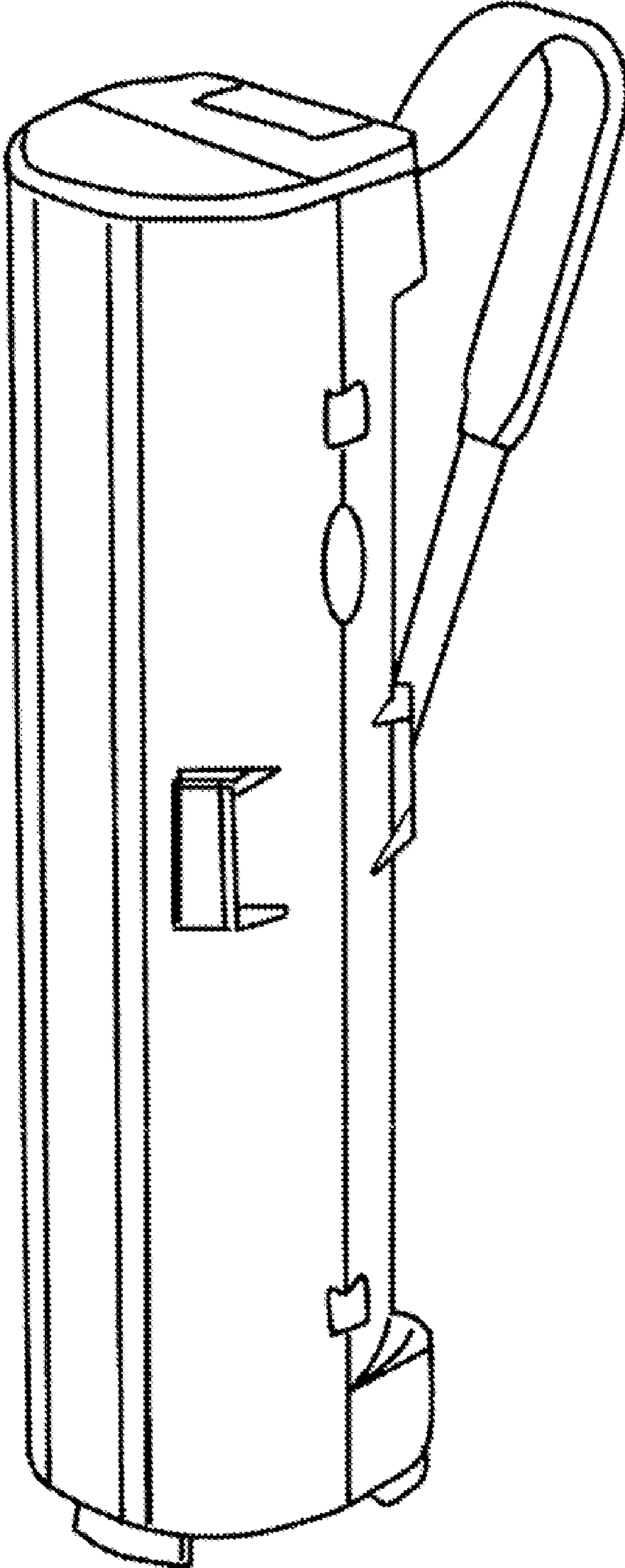

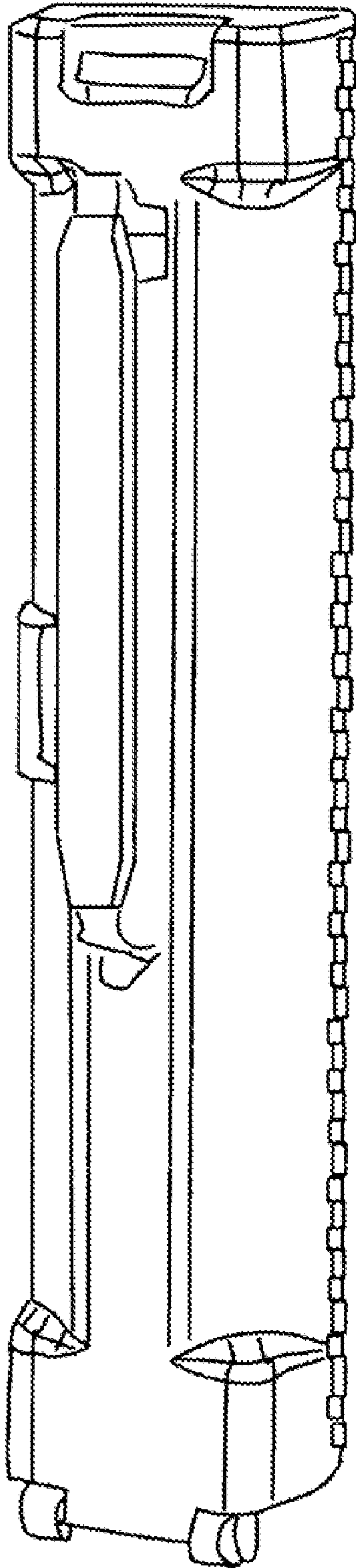

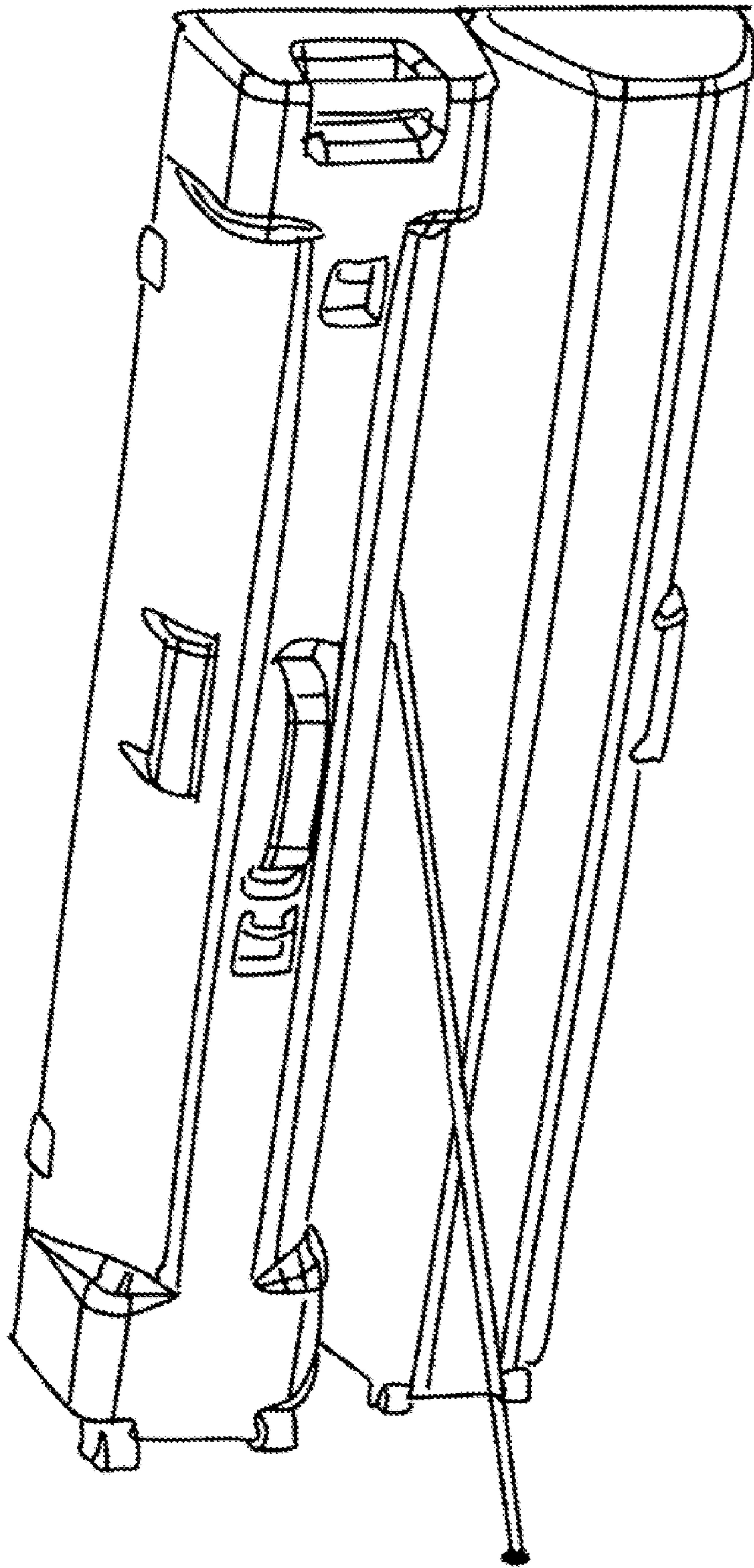

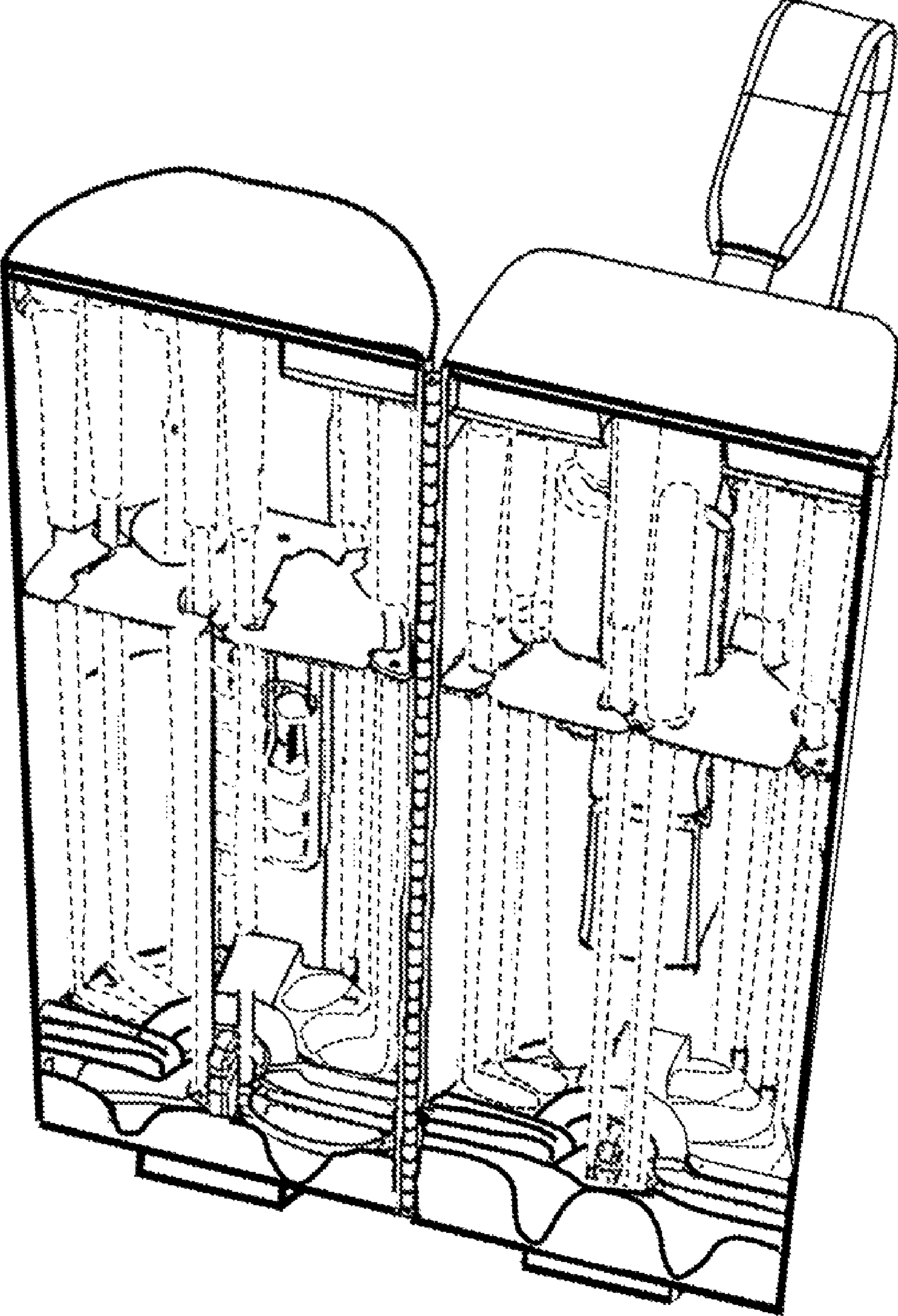

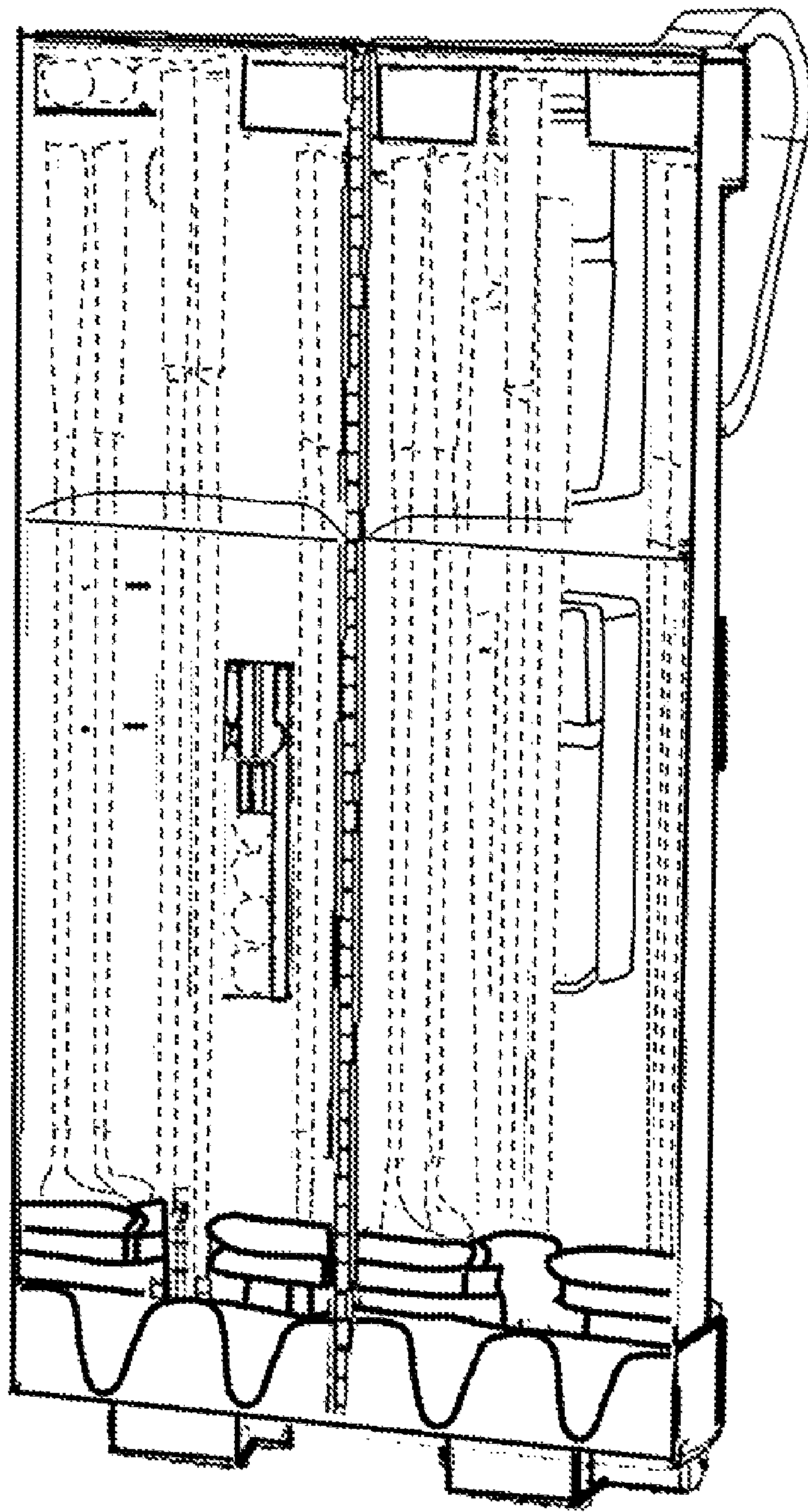

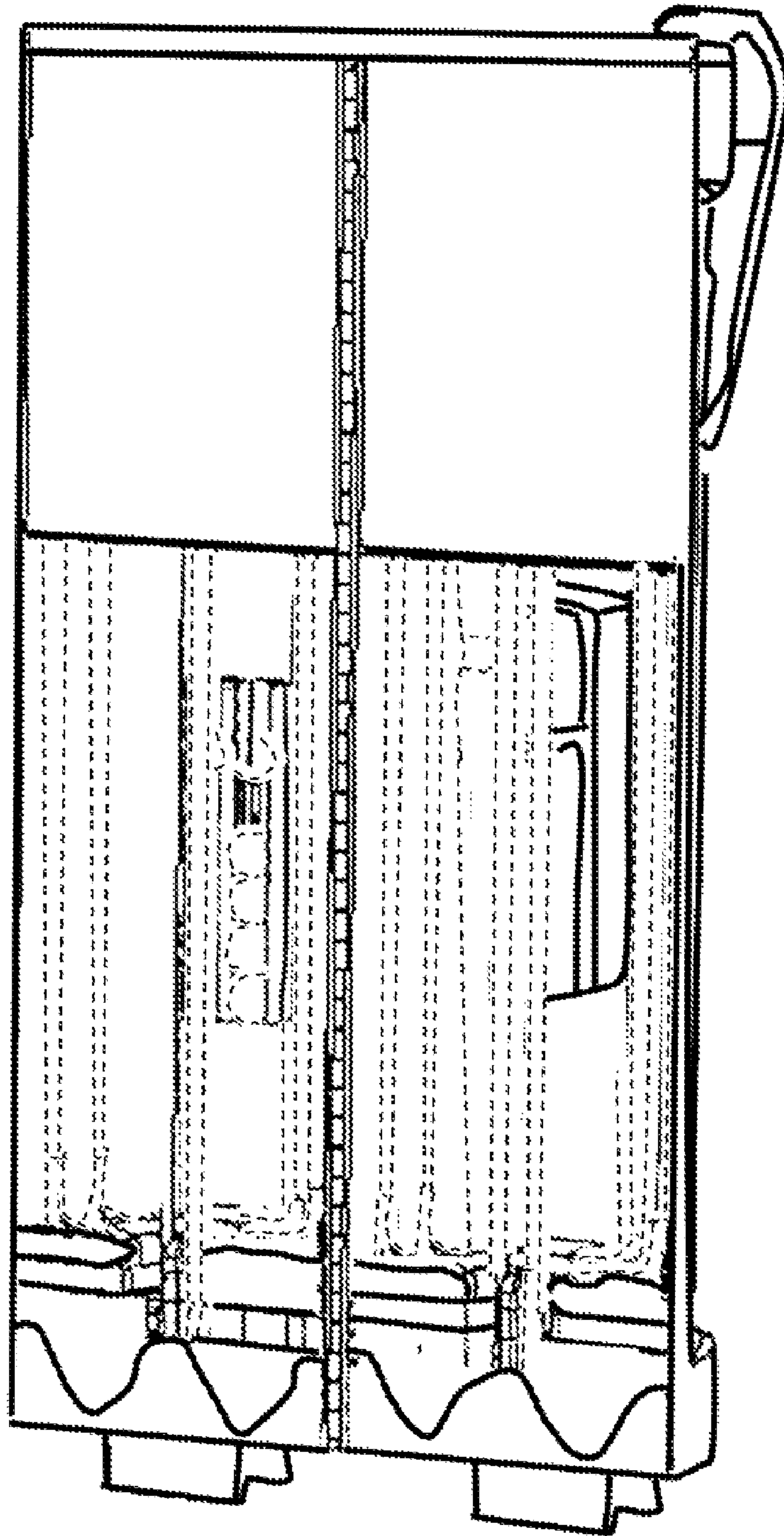
