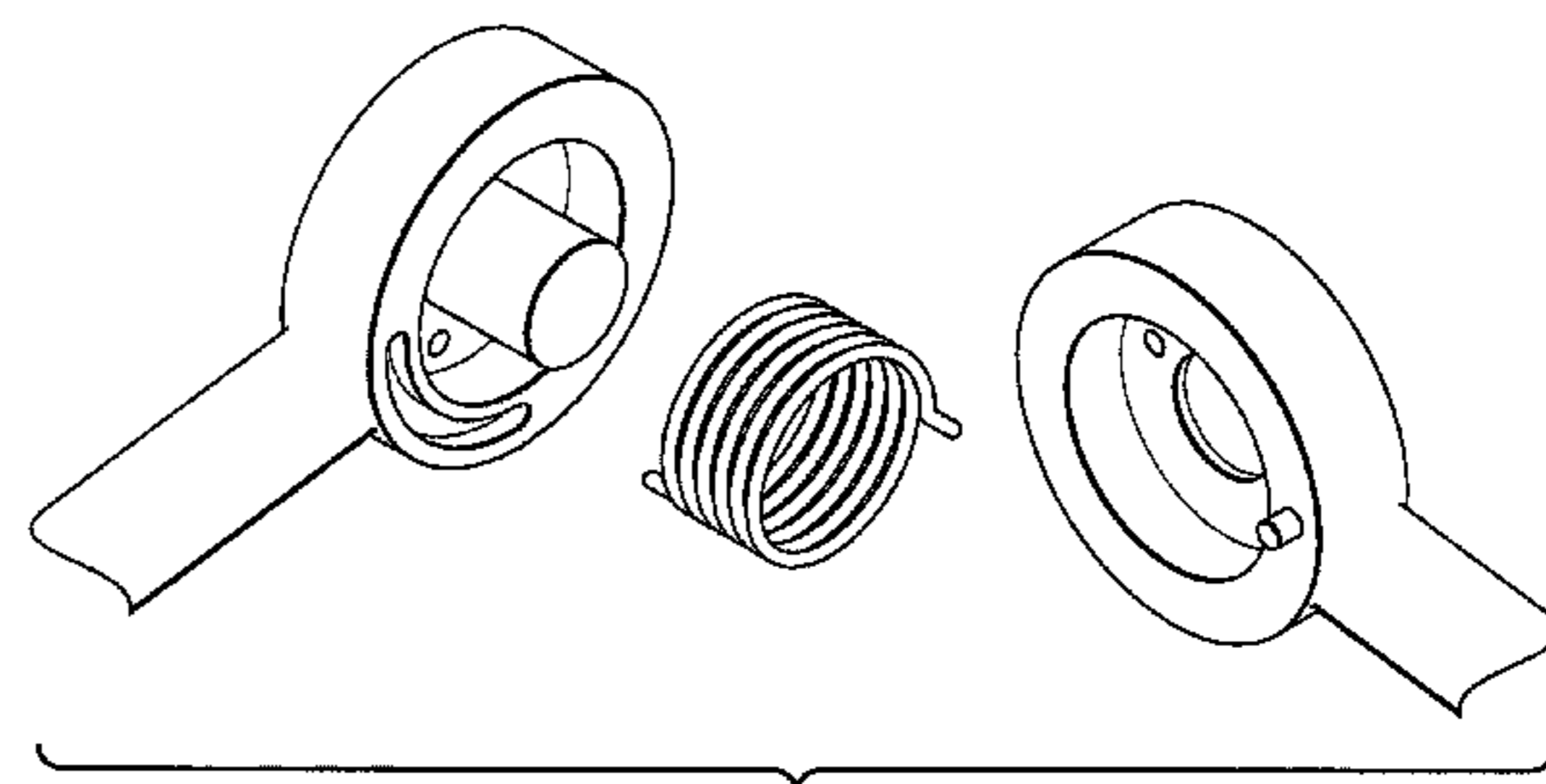
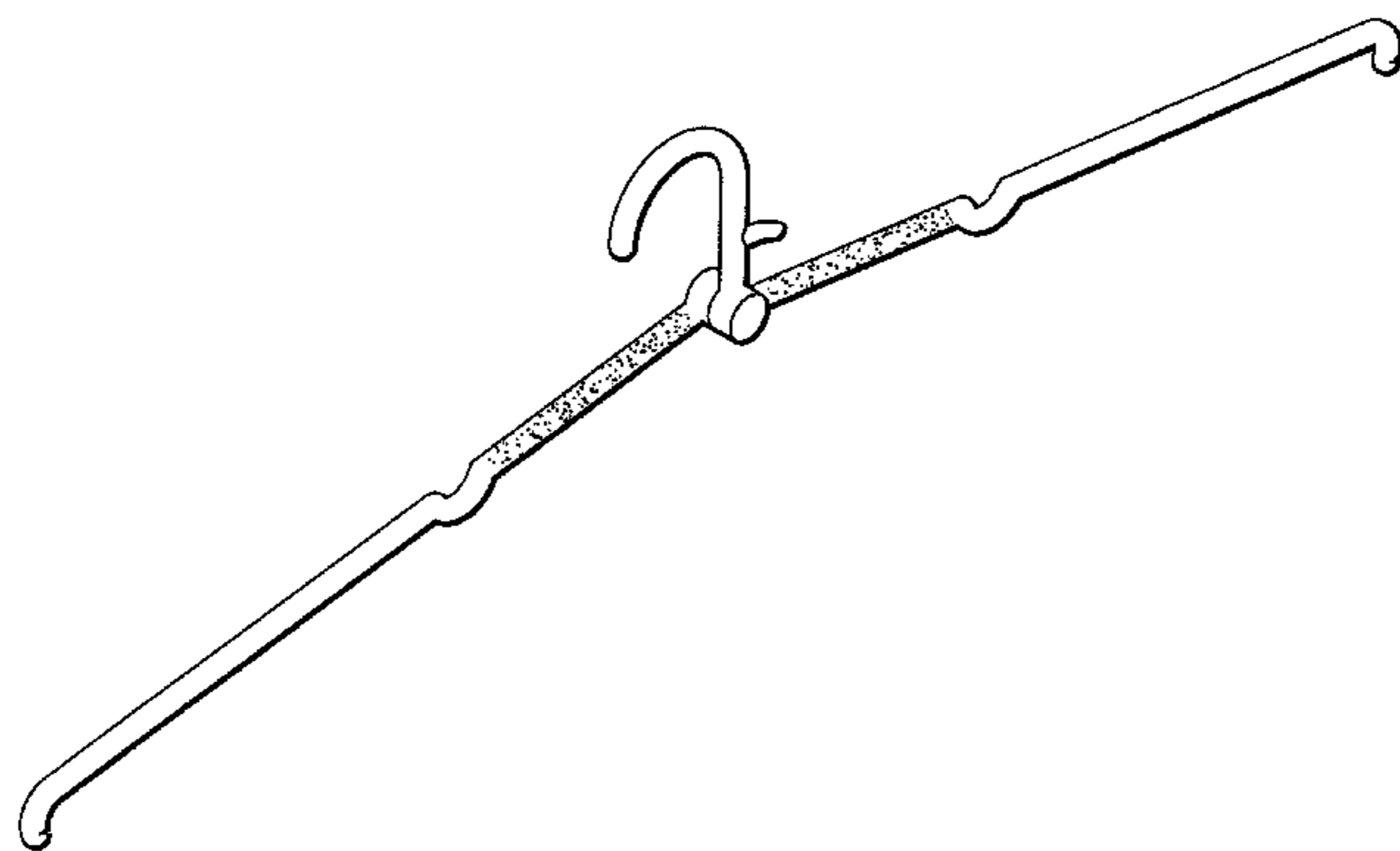
(57) **CLAIM**

The ornamental design for hanger apparatus, as show and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a hanger apparatus showing our new design, shown in an unfolded condition;  
 FIG. 2 is an enlarged exploded perspective view of the hinge portion of a hanger apparatus;  
 FIG. 3 is a front elevational view thereof, the rear elevational view being a mirror image thereof;  
 FIG. 4 is a front elevational view thereof, with a hanger apparatus shown in a folded condition; and,  
 FIG. 5 is partial enlarged view of a hanger apparatus ends shown in FIG. 4.

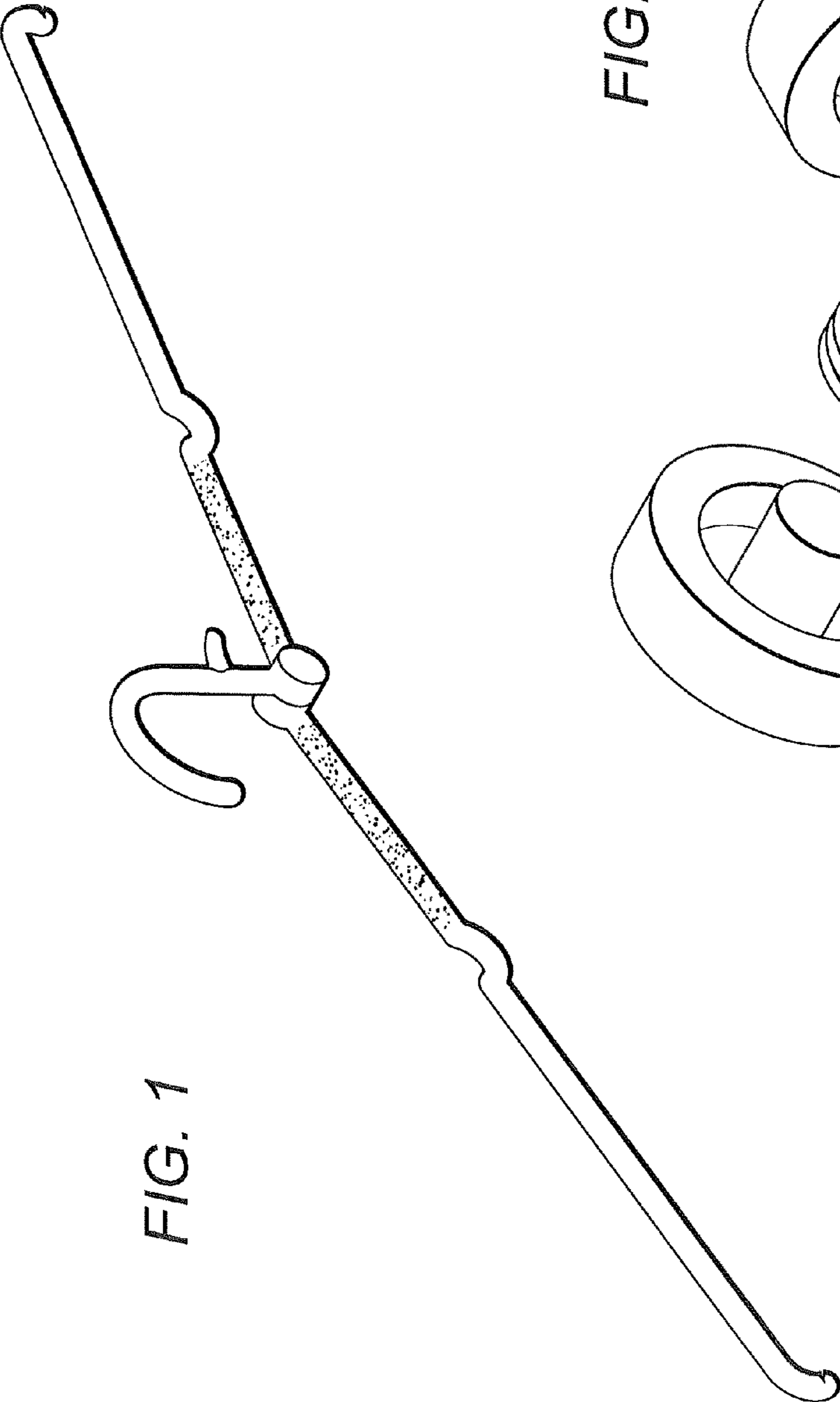

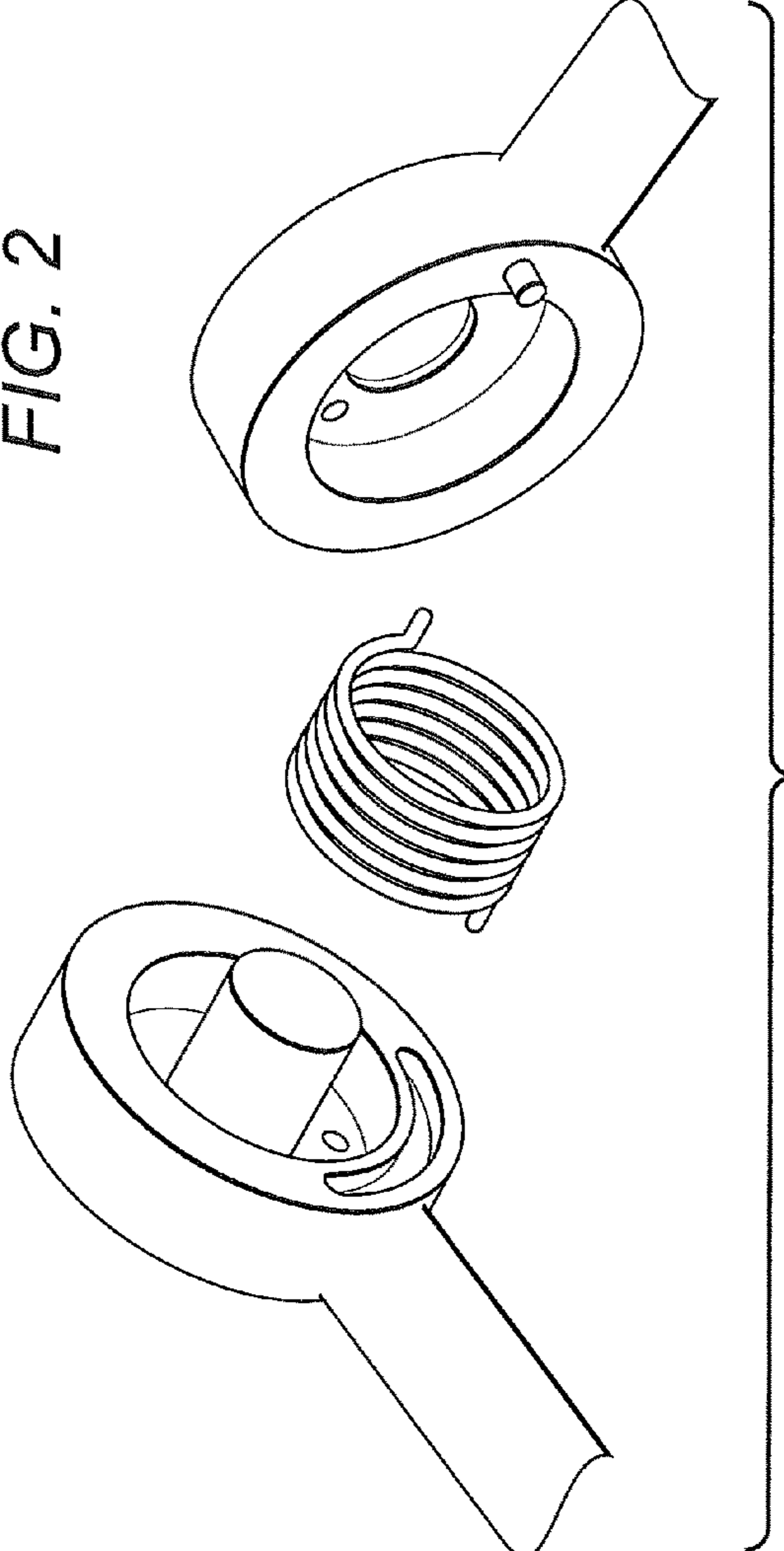

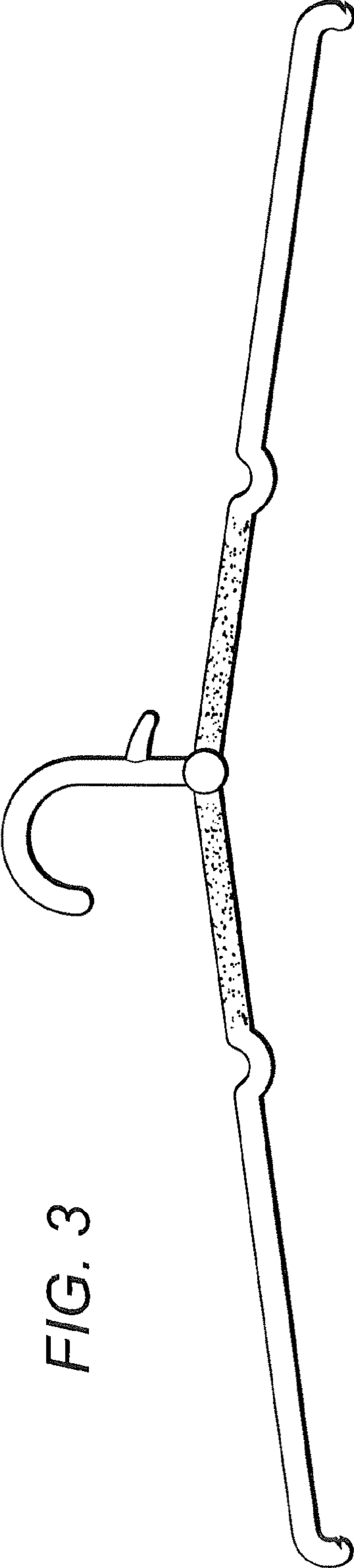

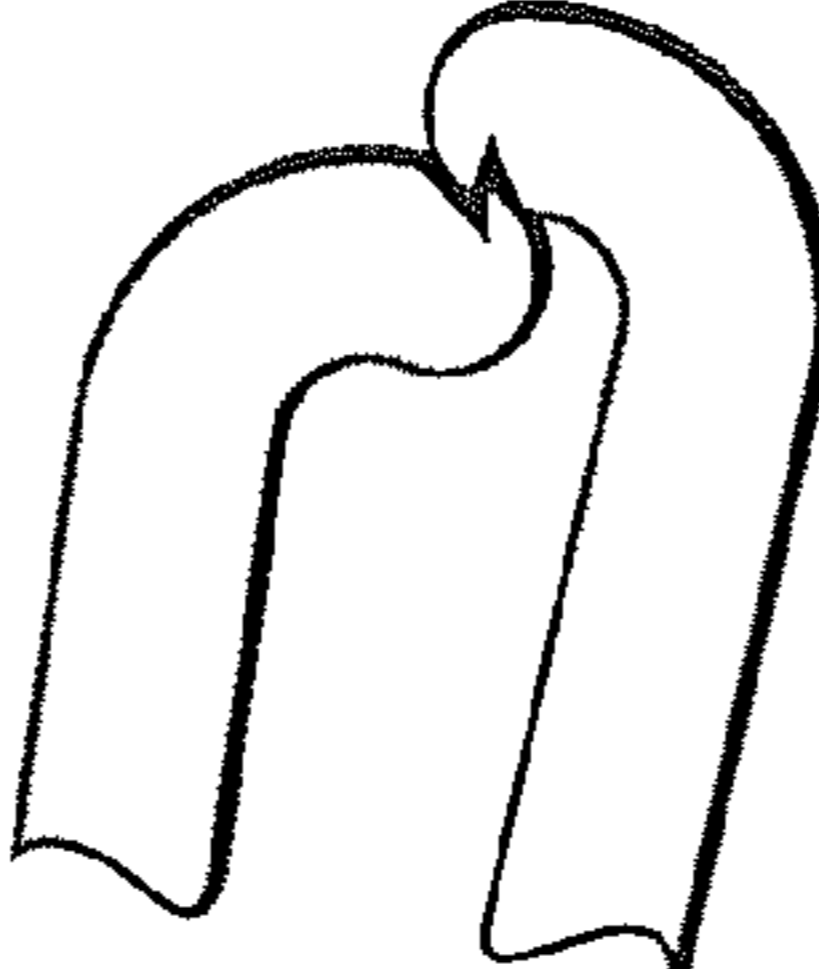

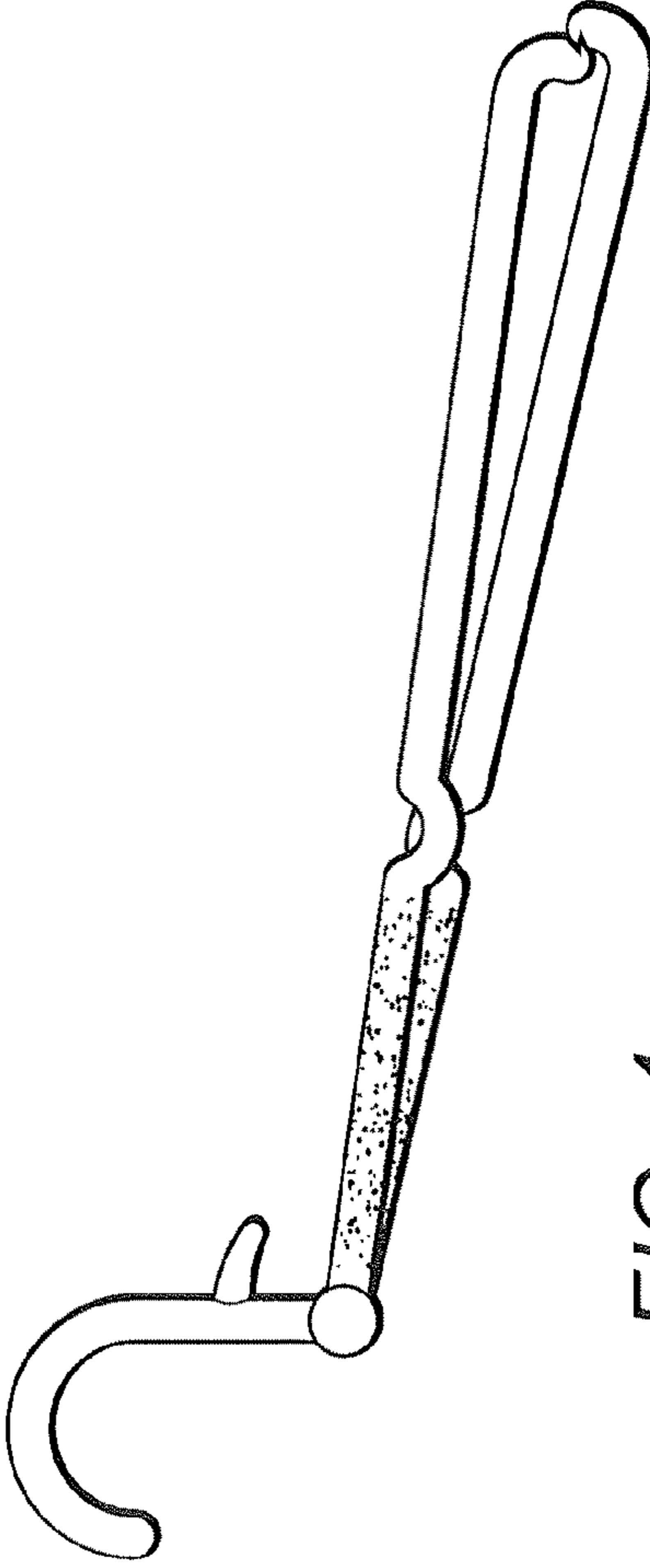
