The broken line showing of the hanger and lettering is for the purpose of illustrating environmental structure and forms no part of the claimed design.

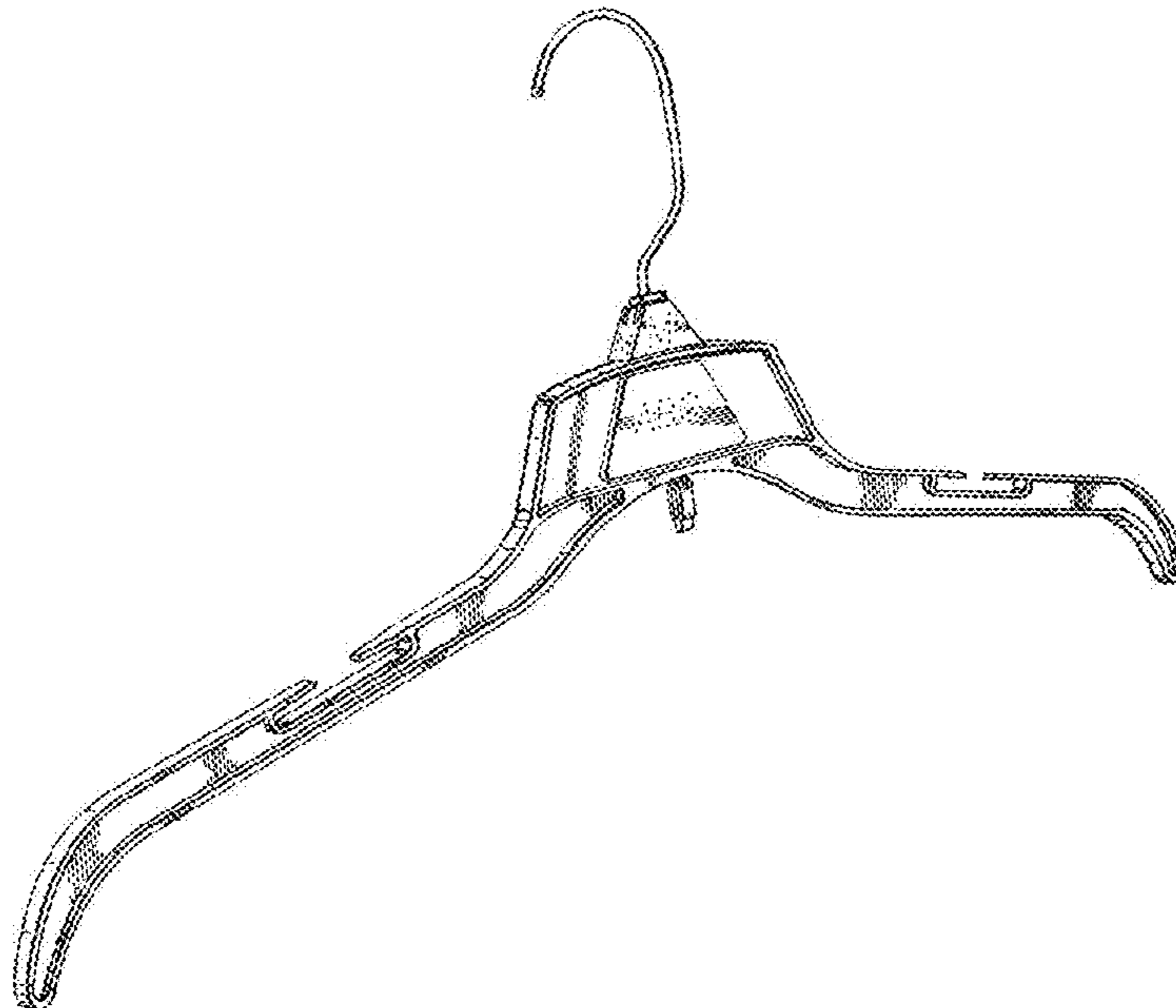

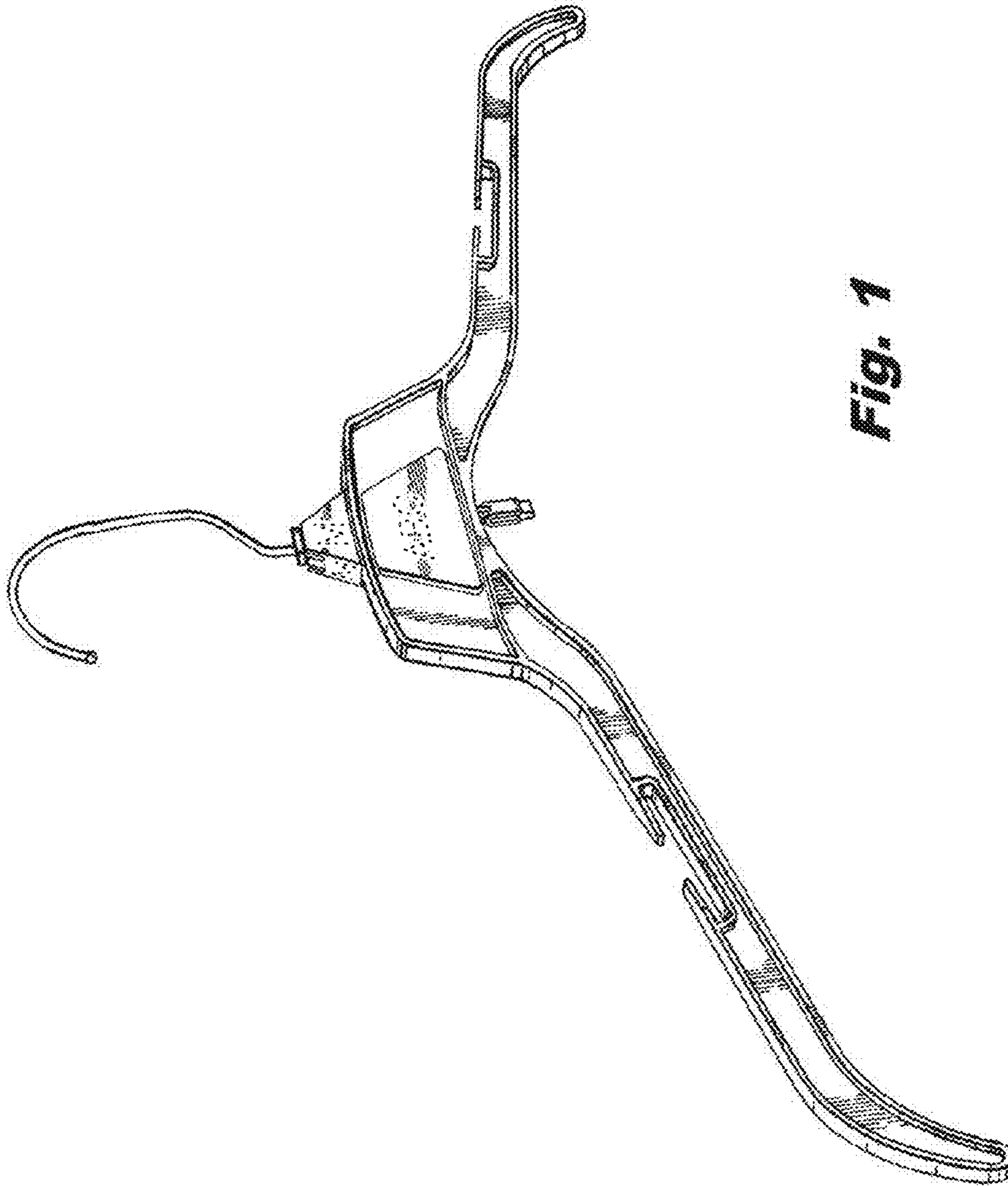

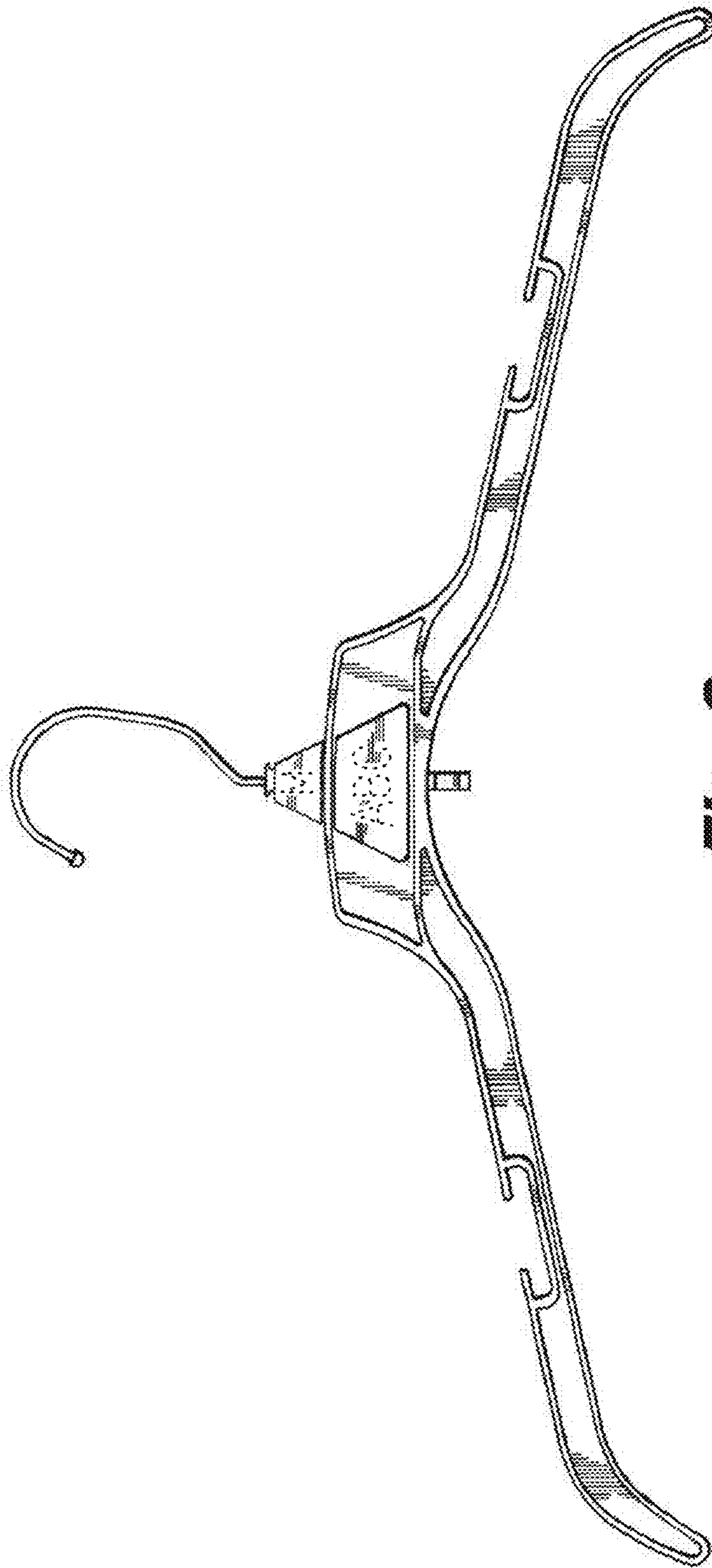

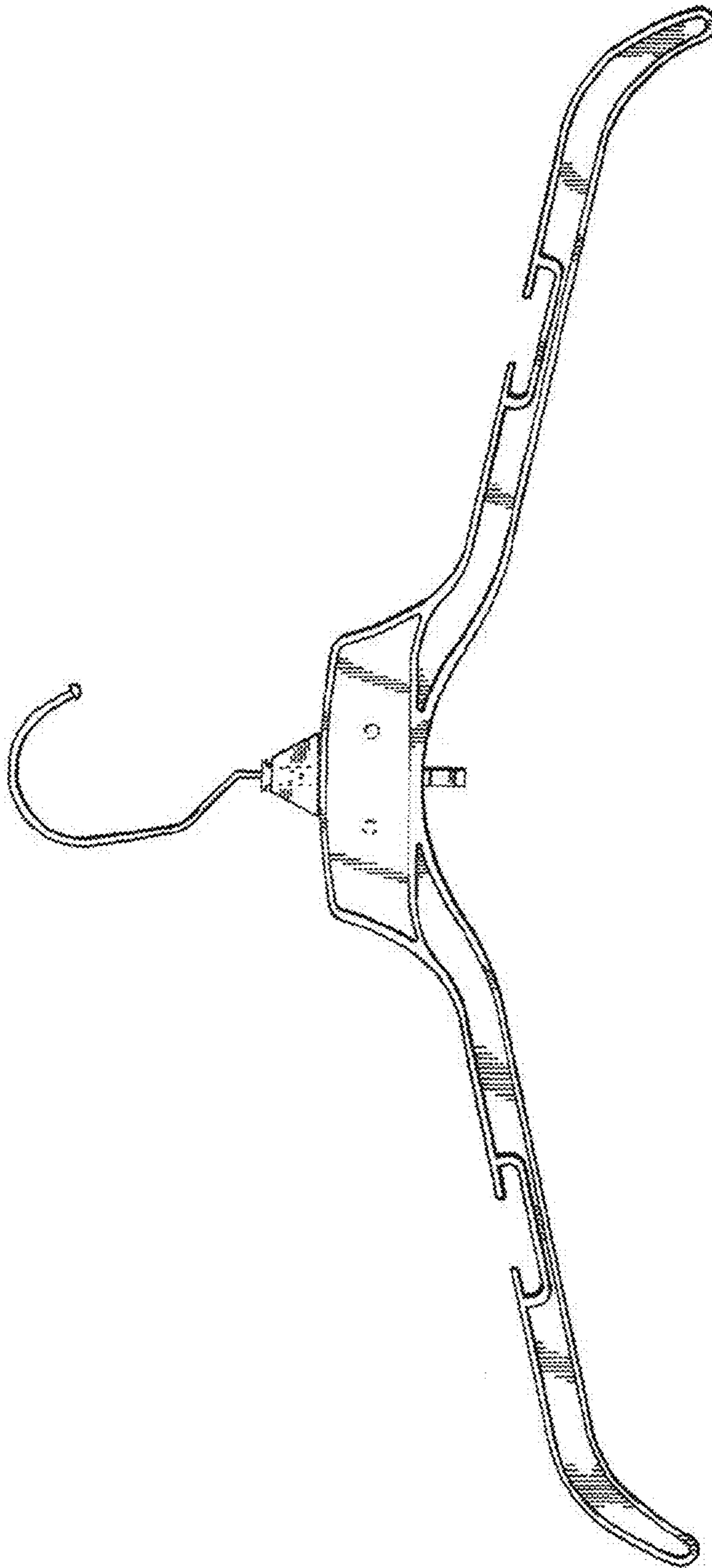

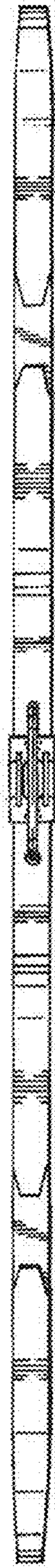

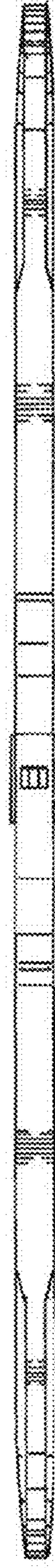

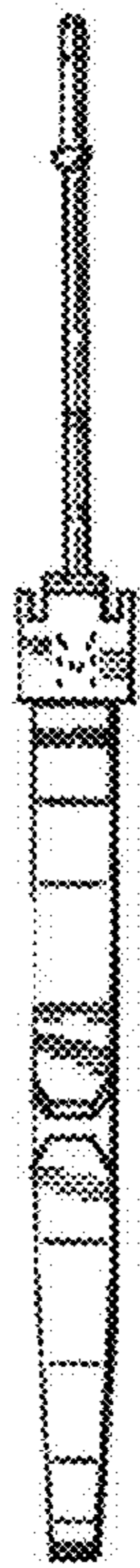

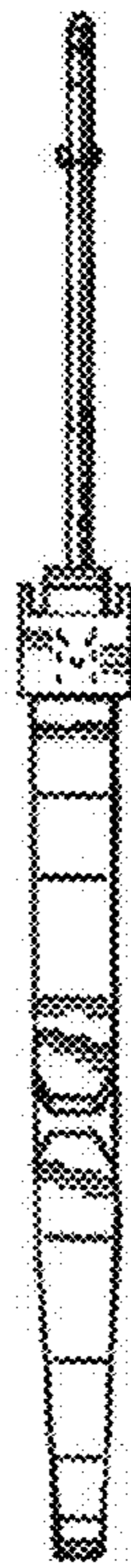

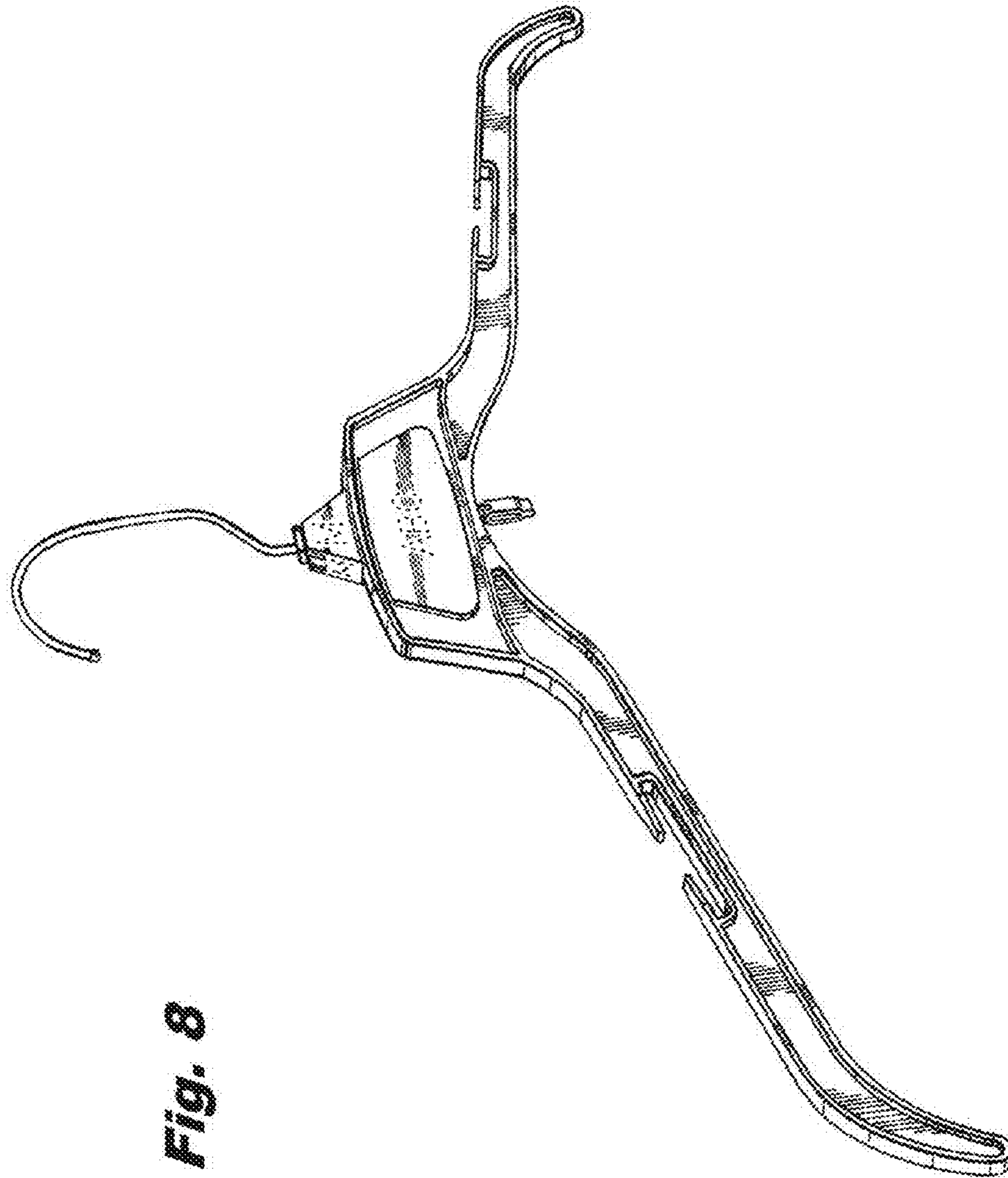

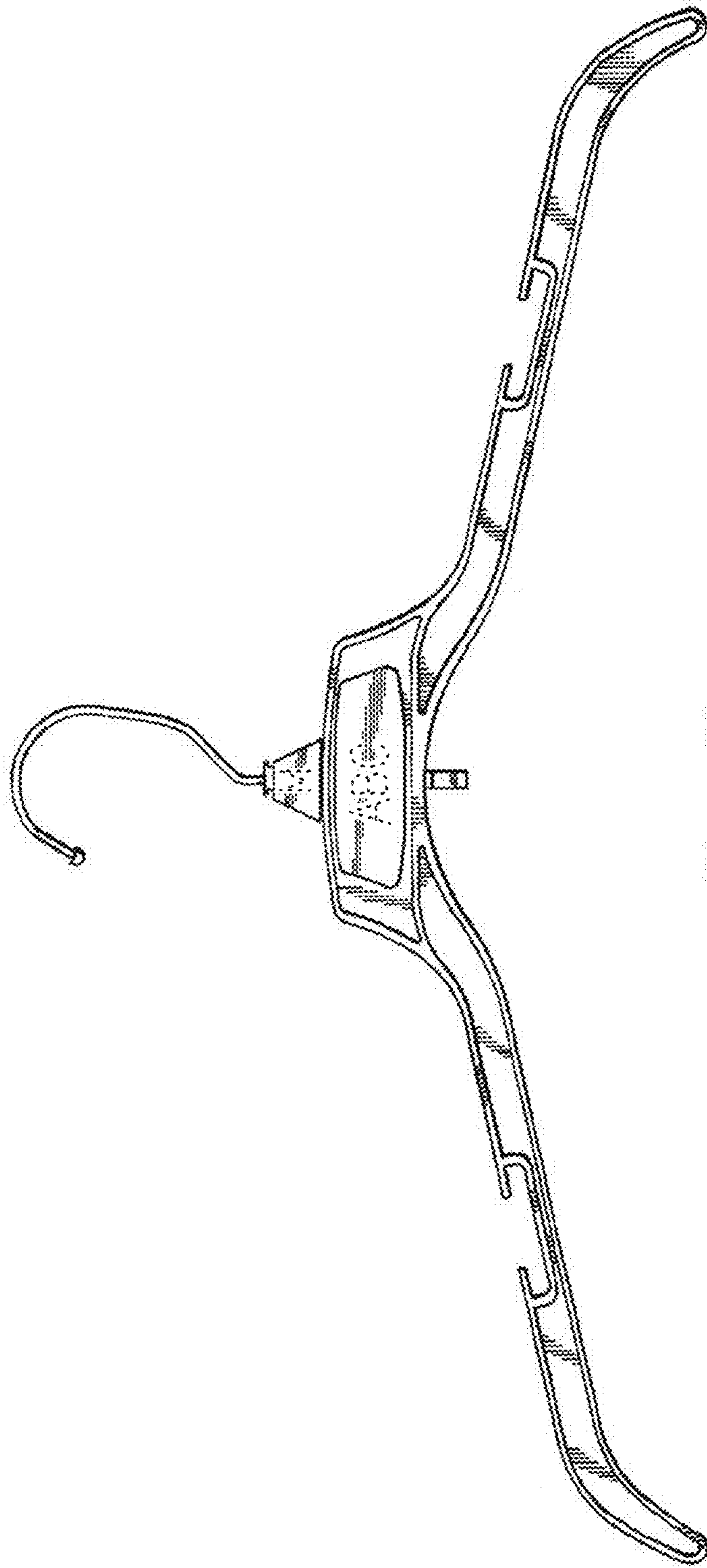

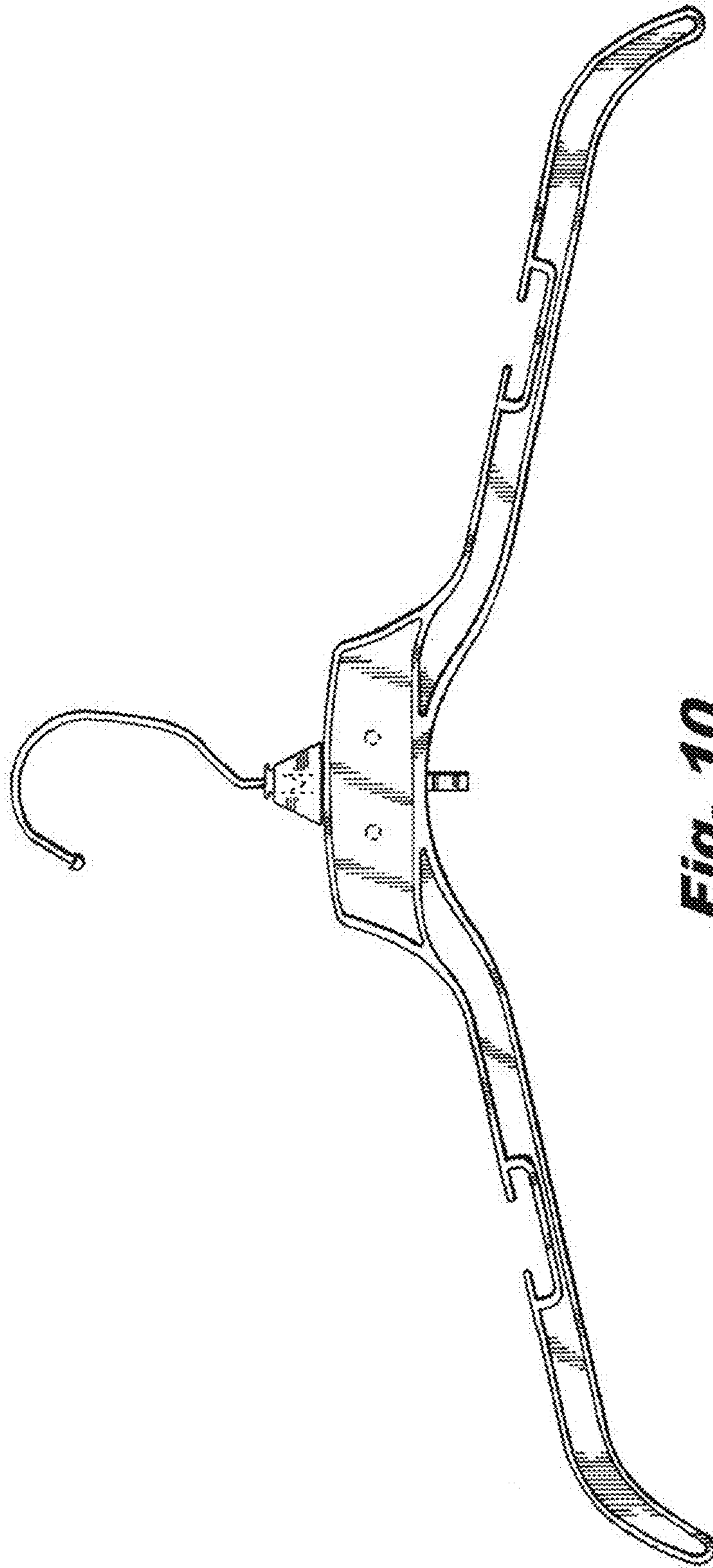
