FIG. 7 is a top view thereof.

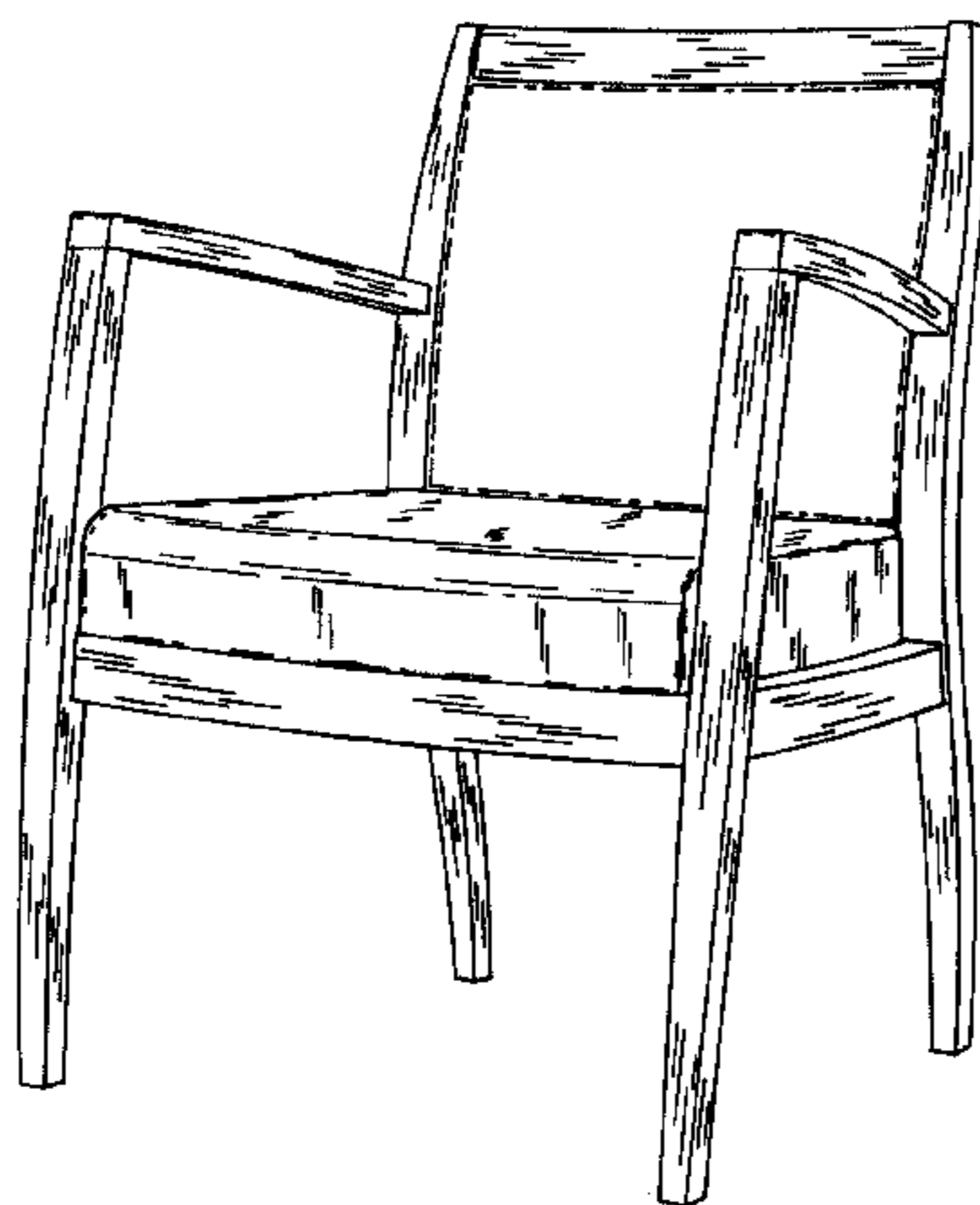
FIG. 8 is a front perspective view of a side chair according to a second embodiment of my design;

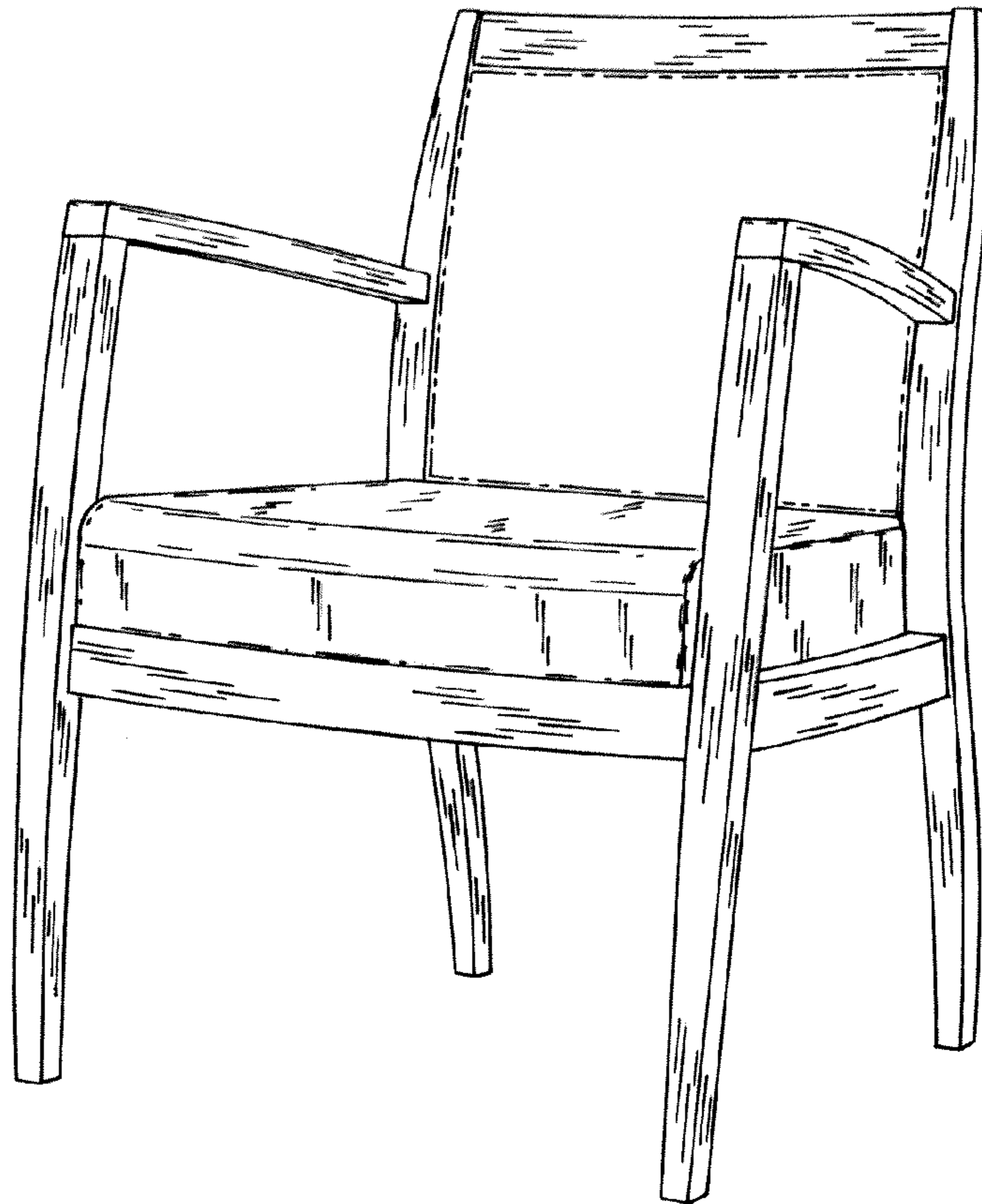
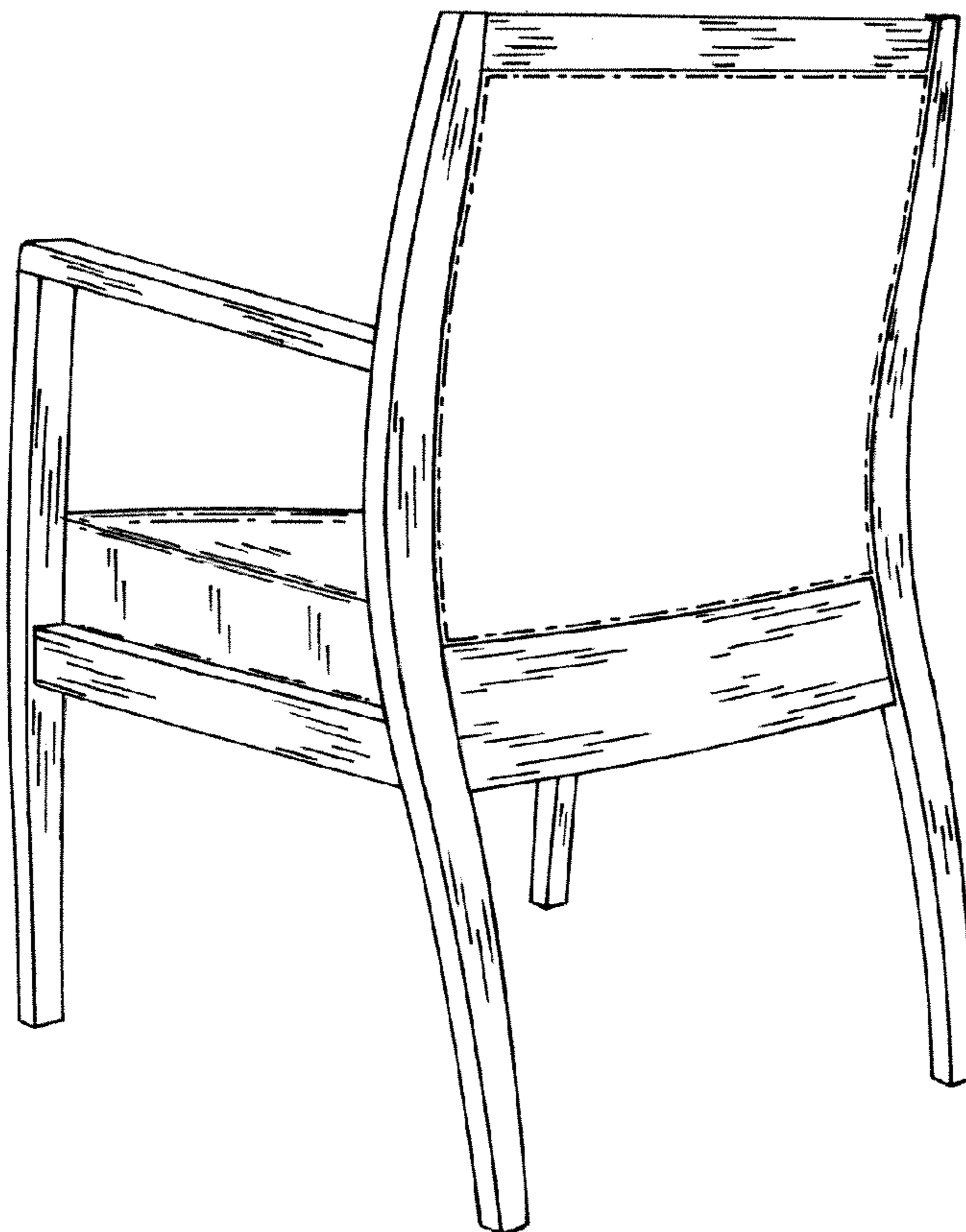

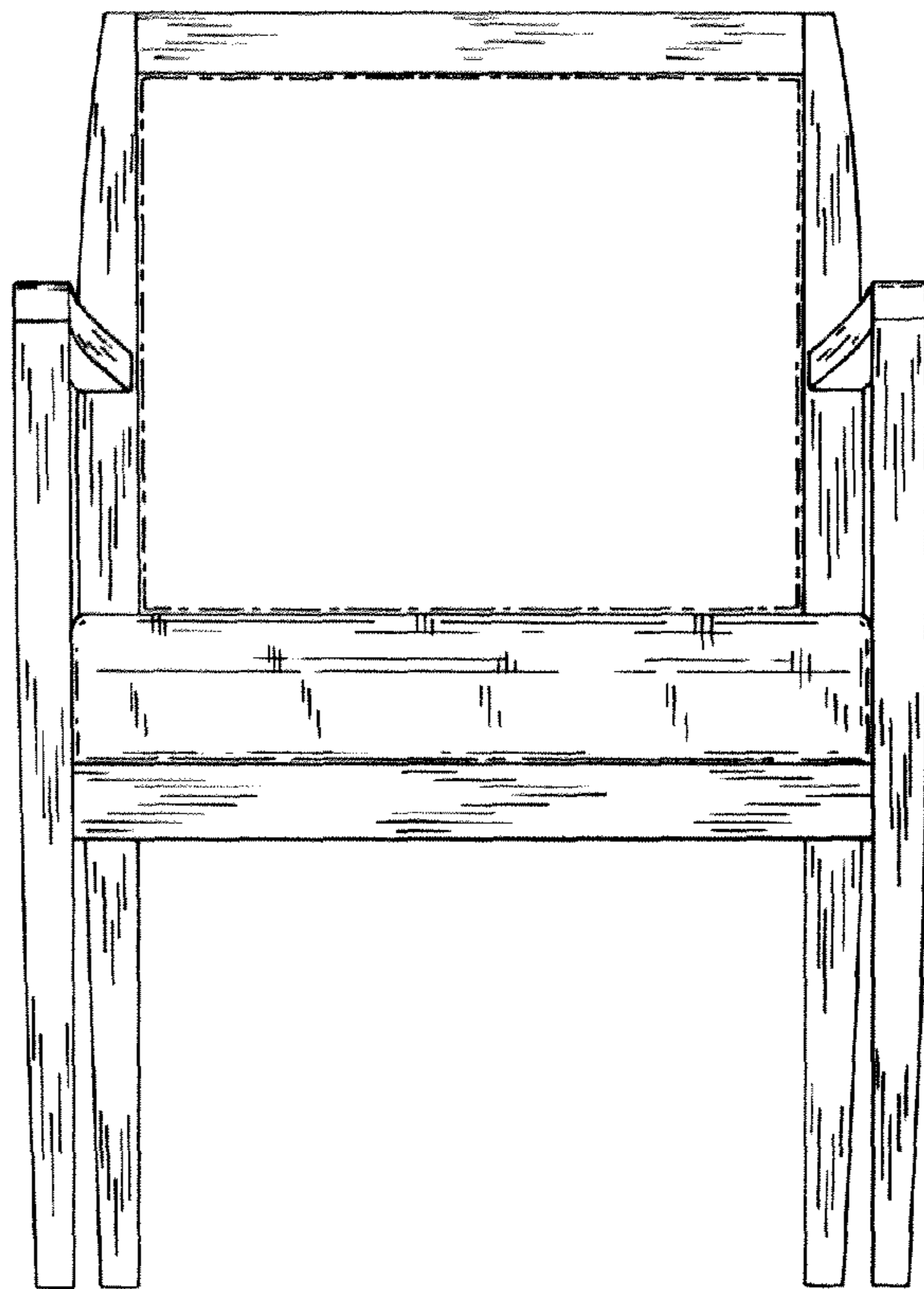

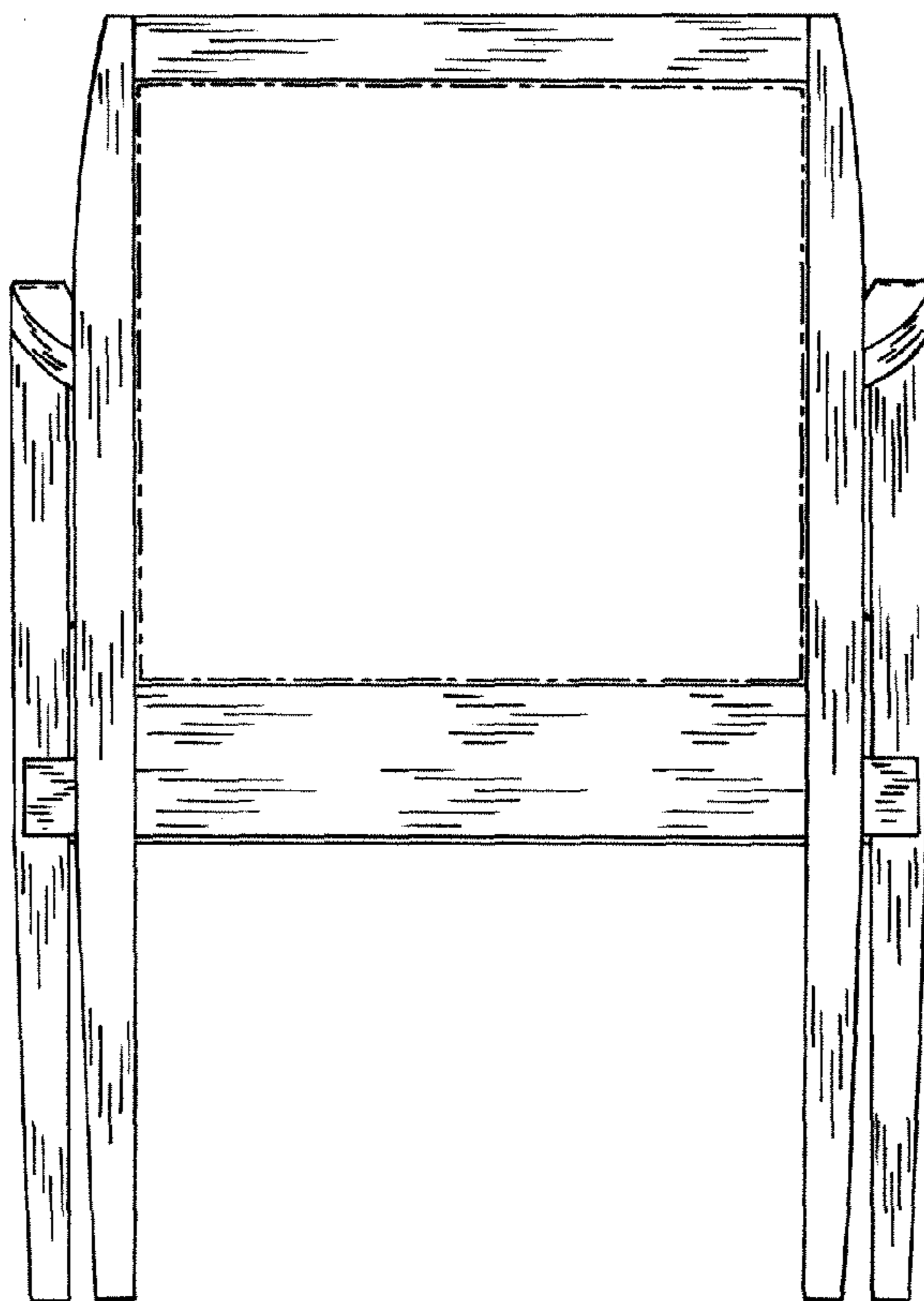

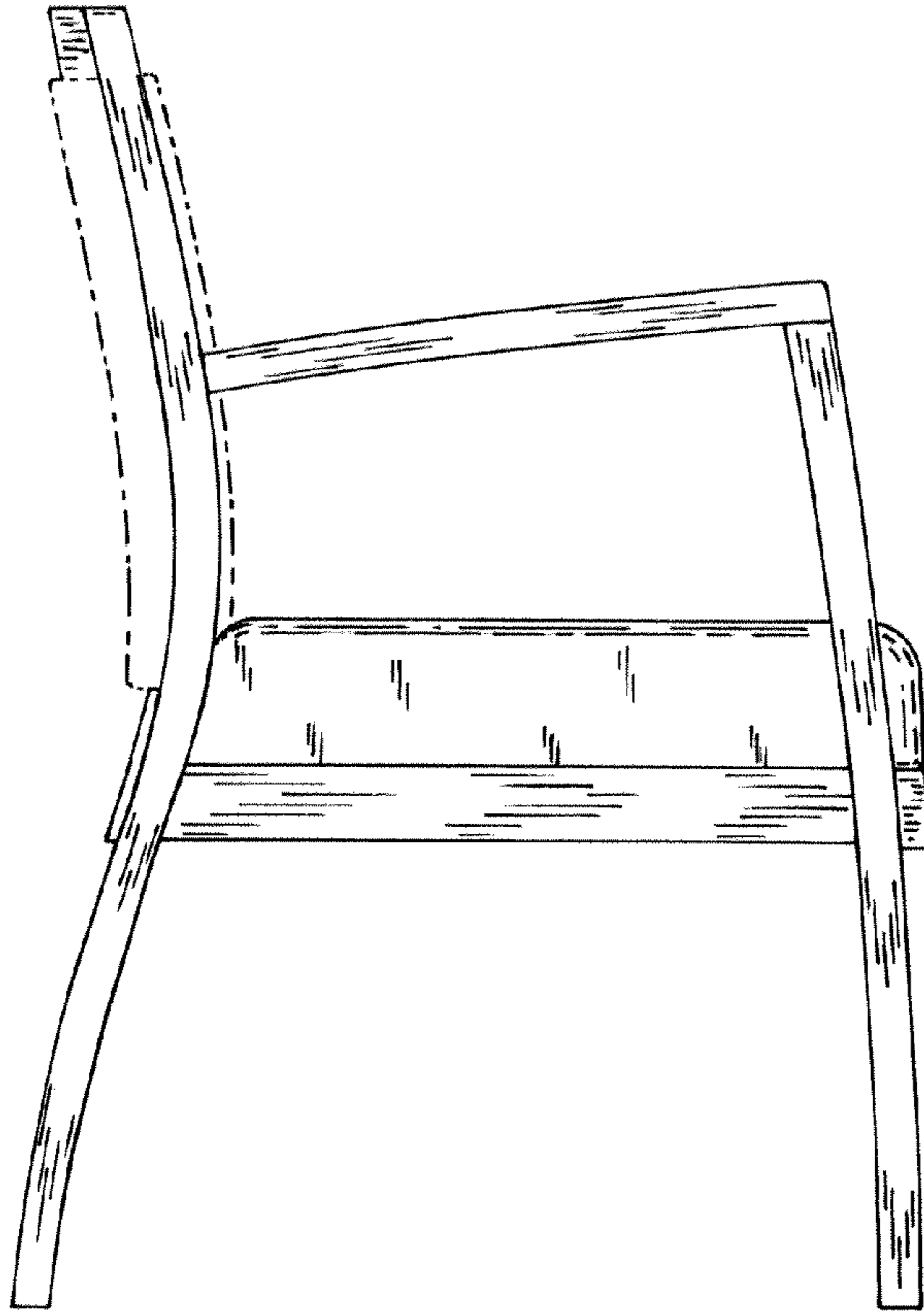

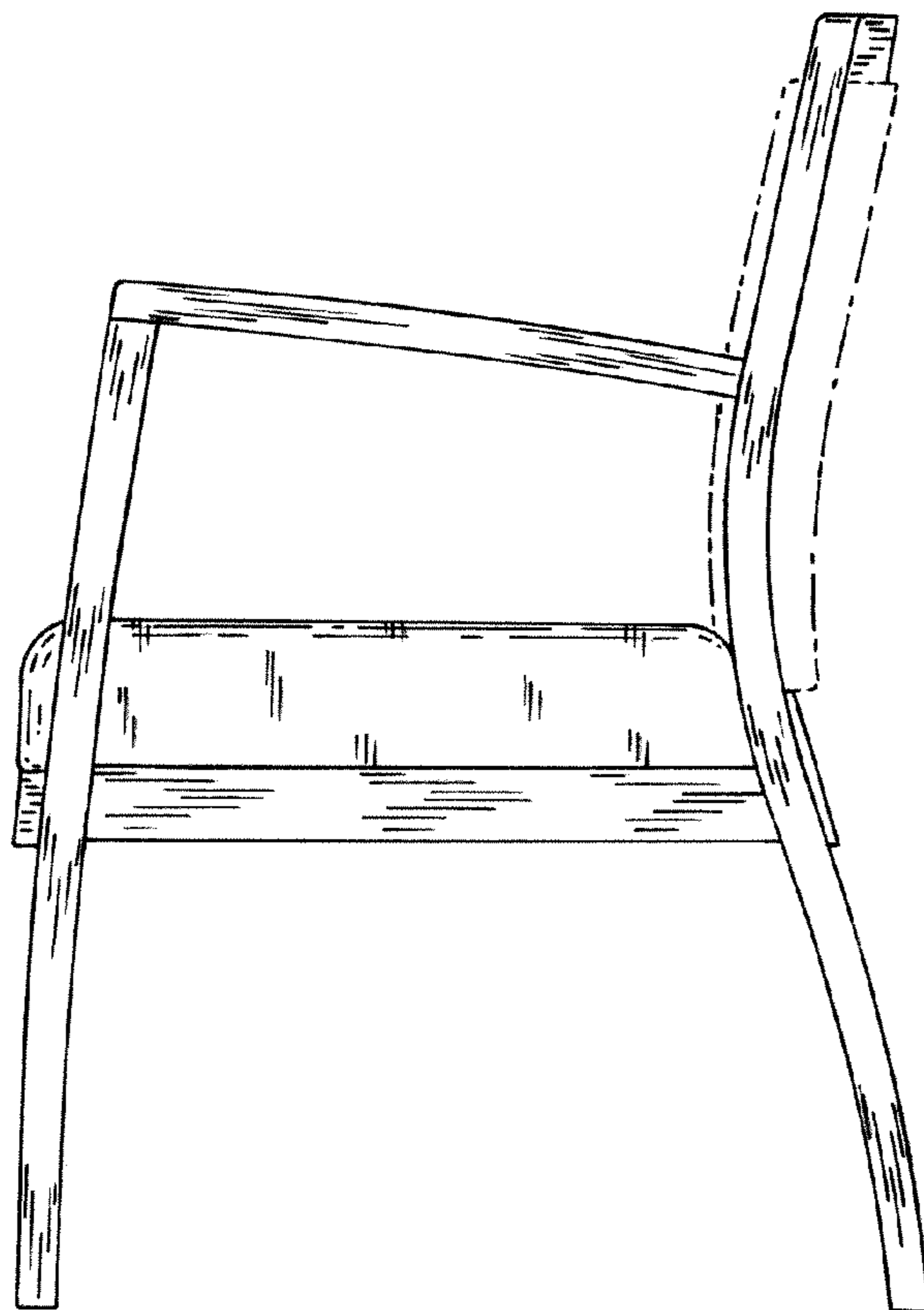

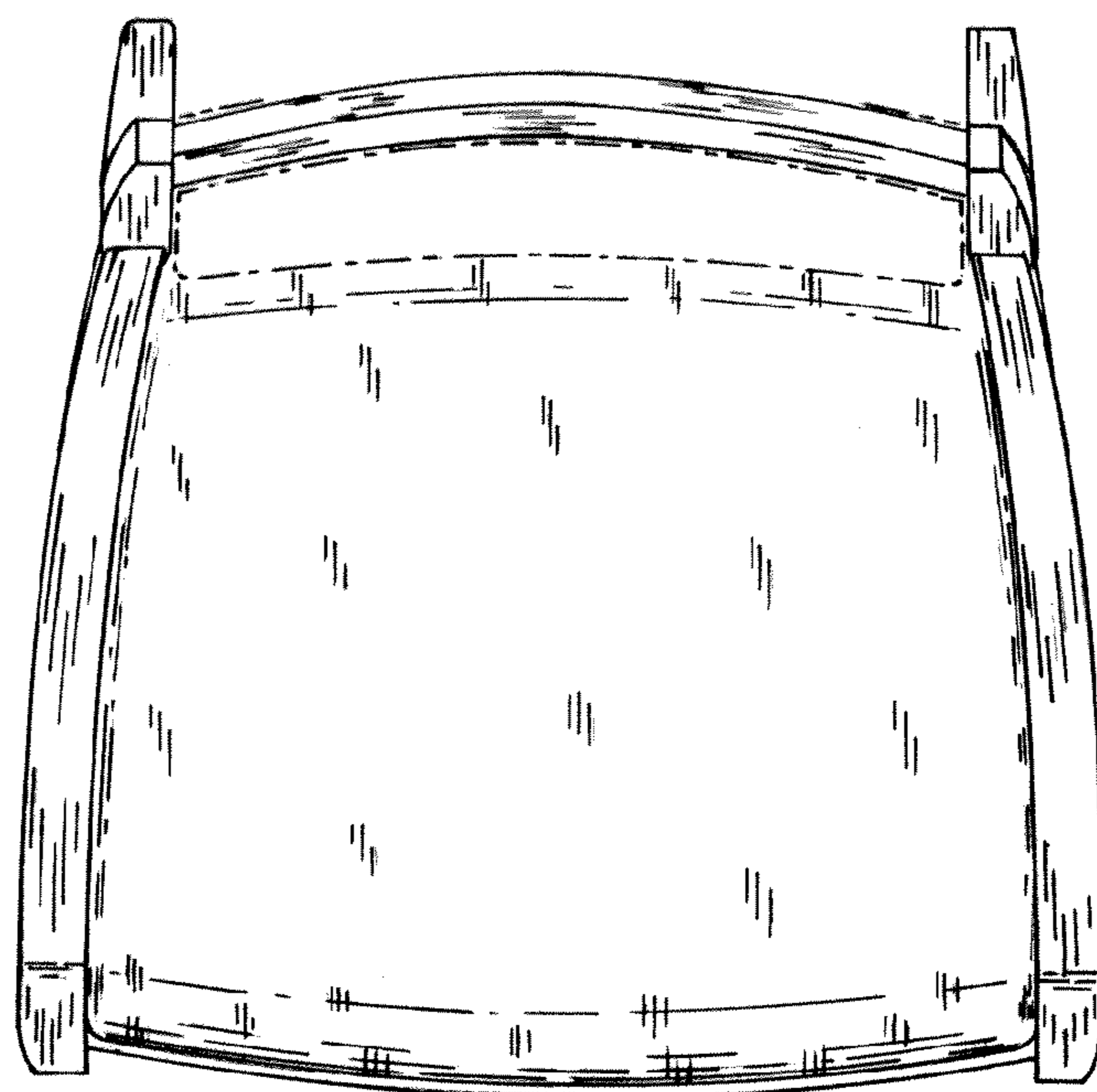

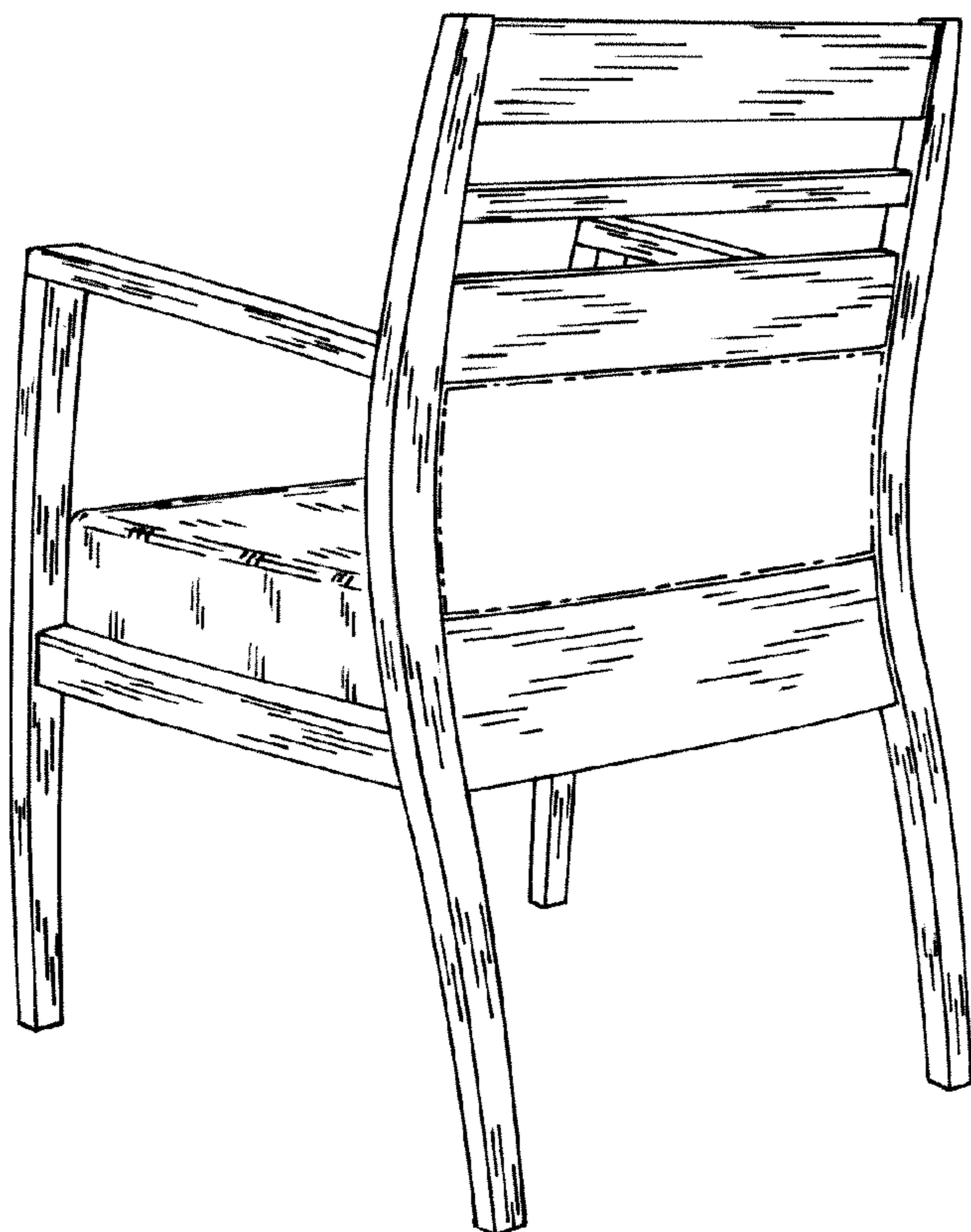
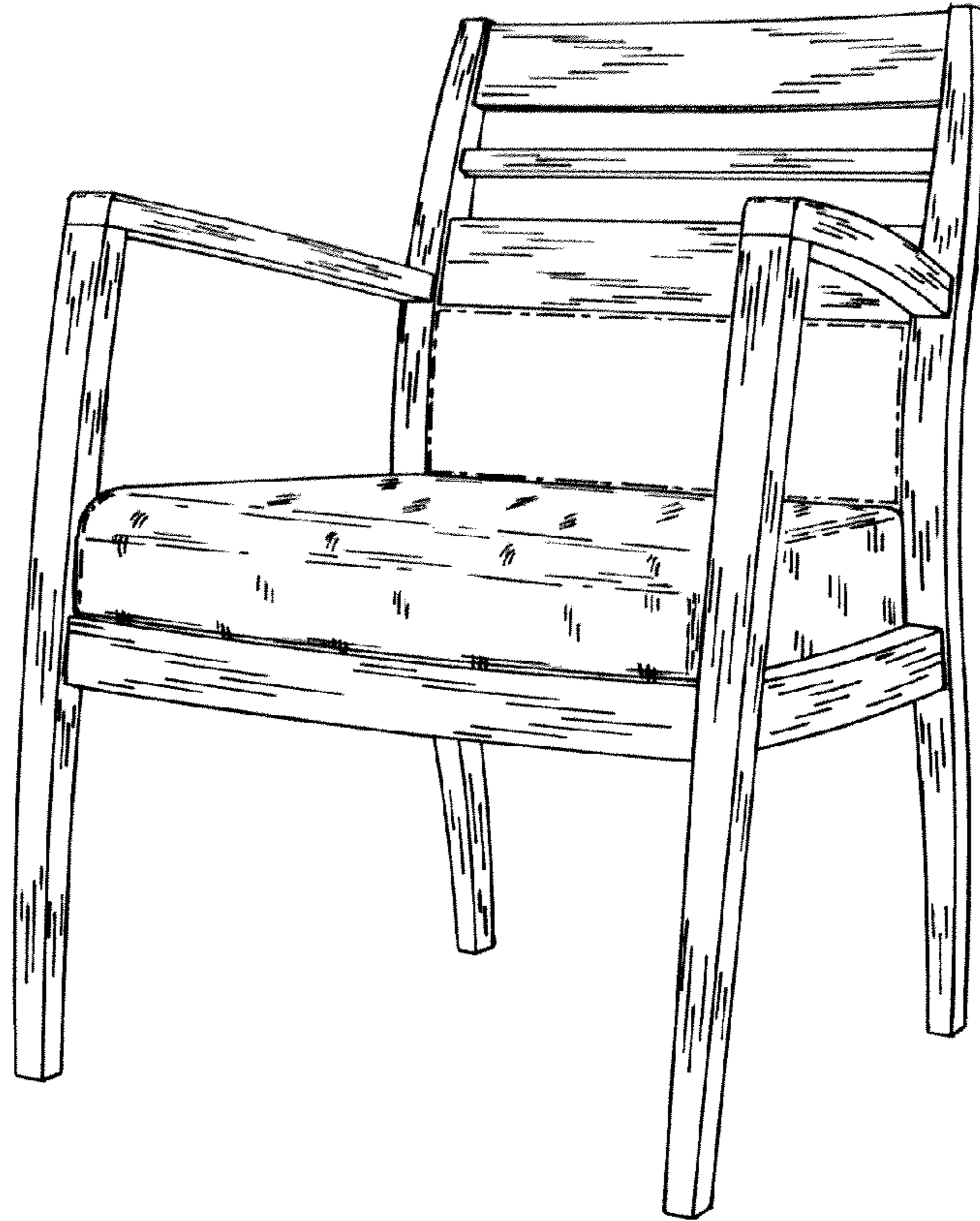

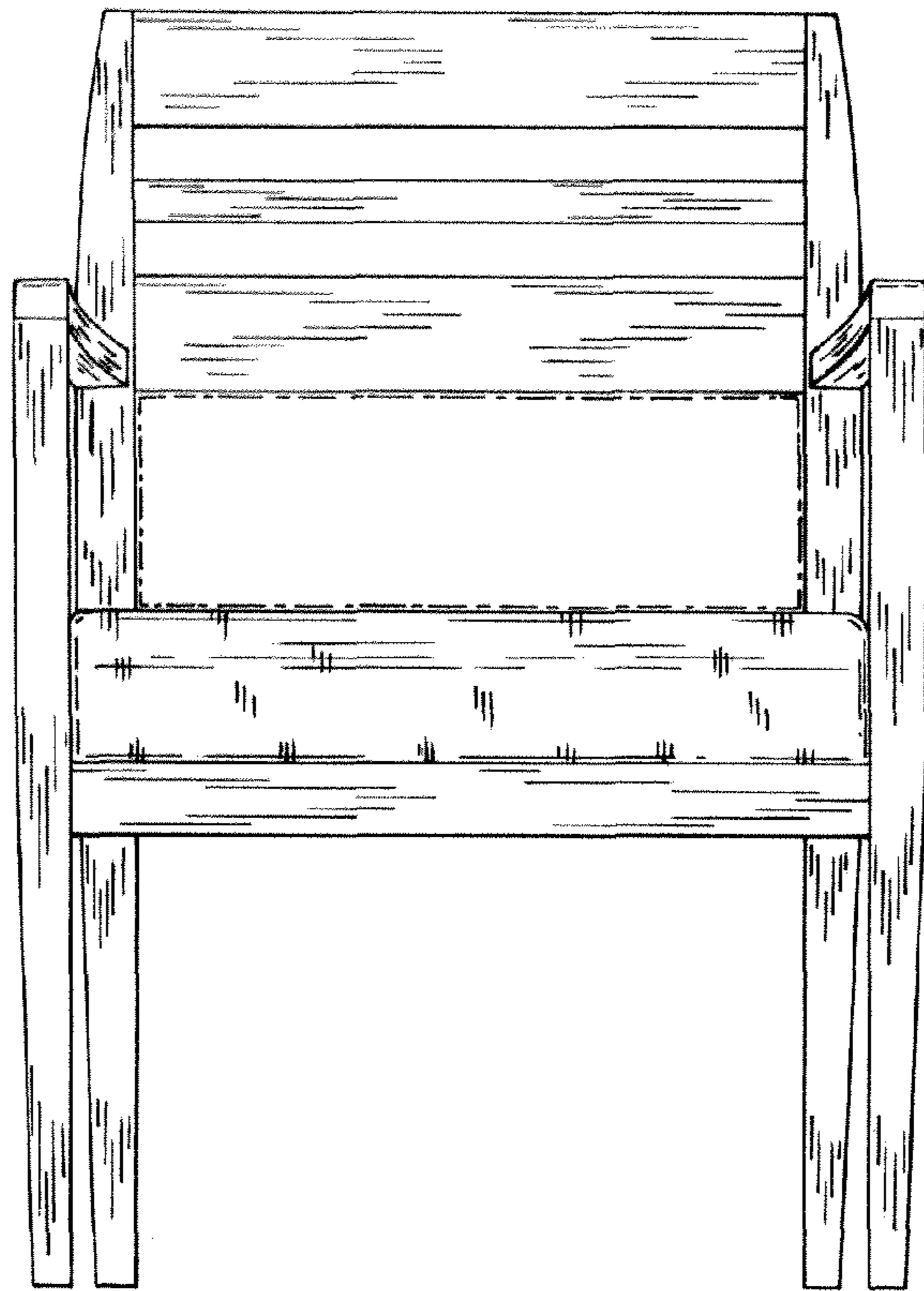

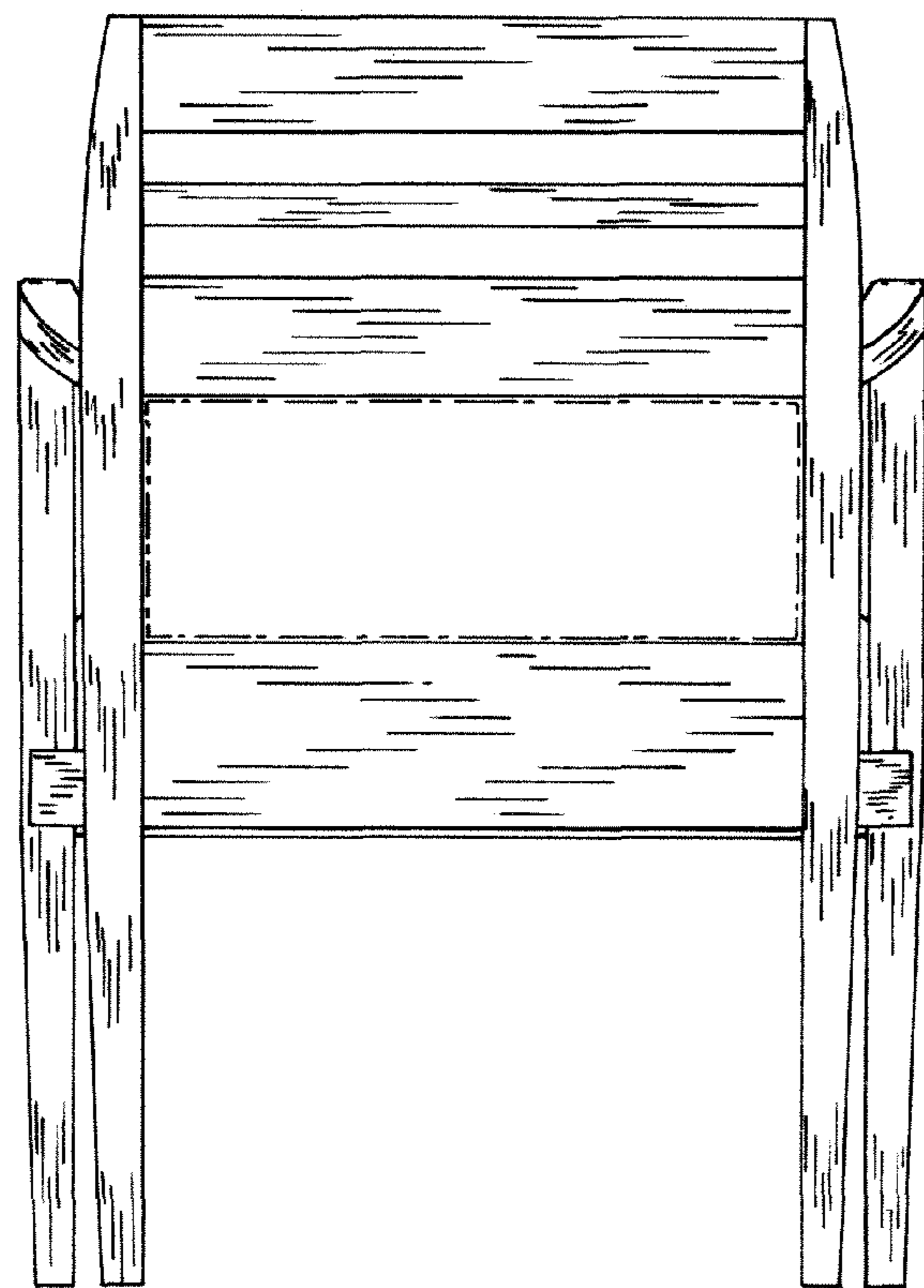

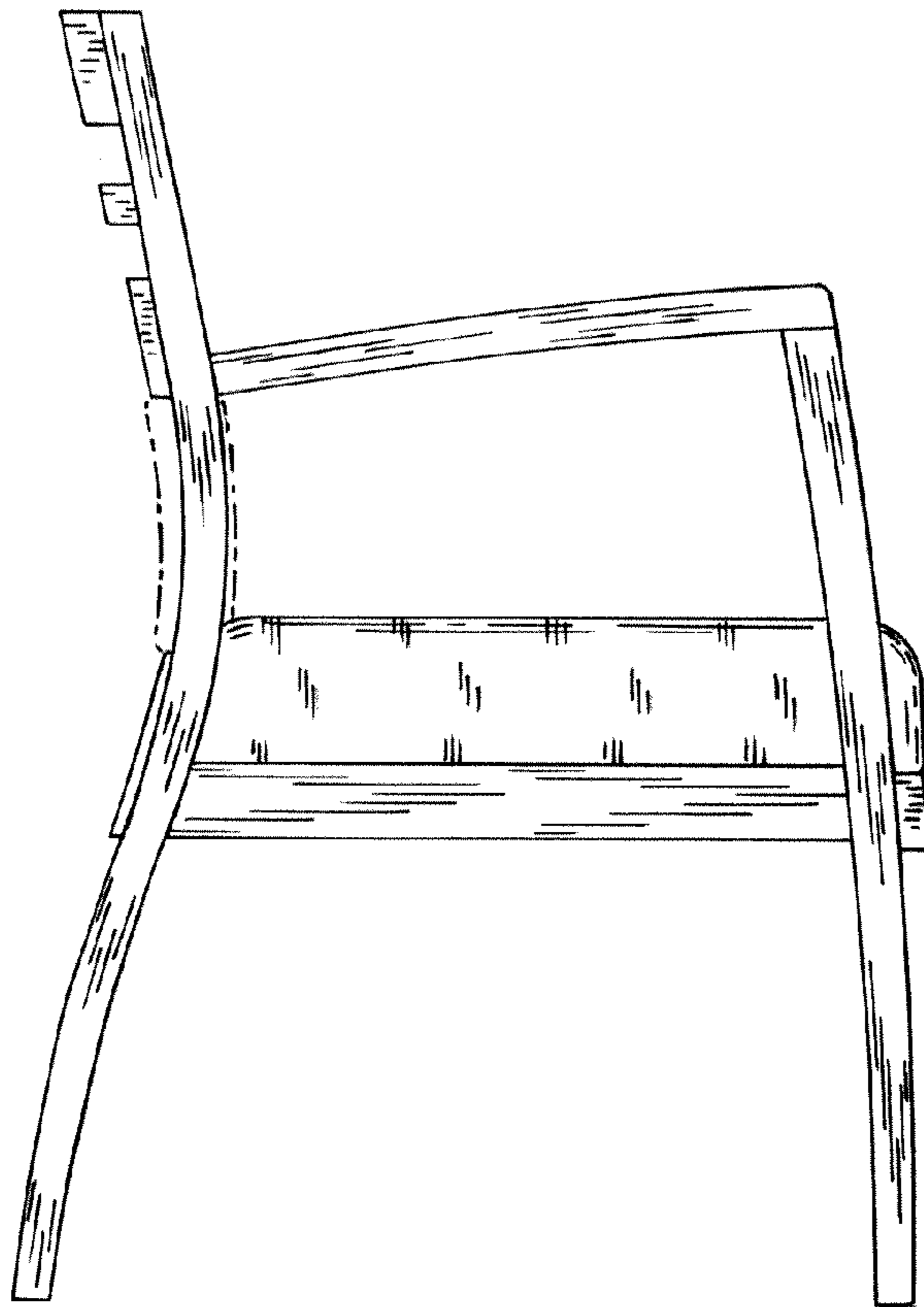

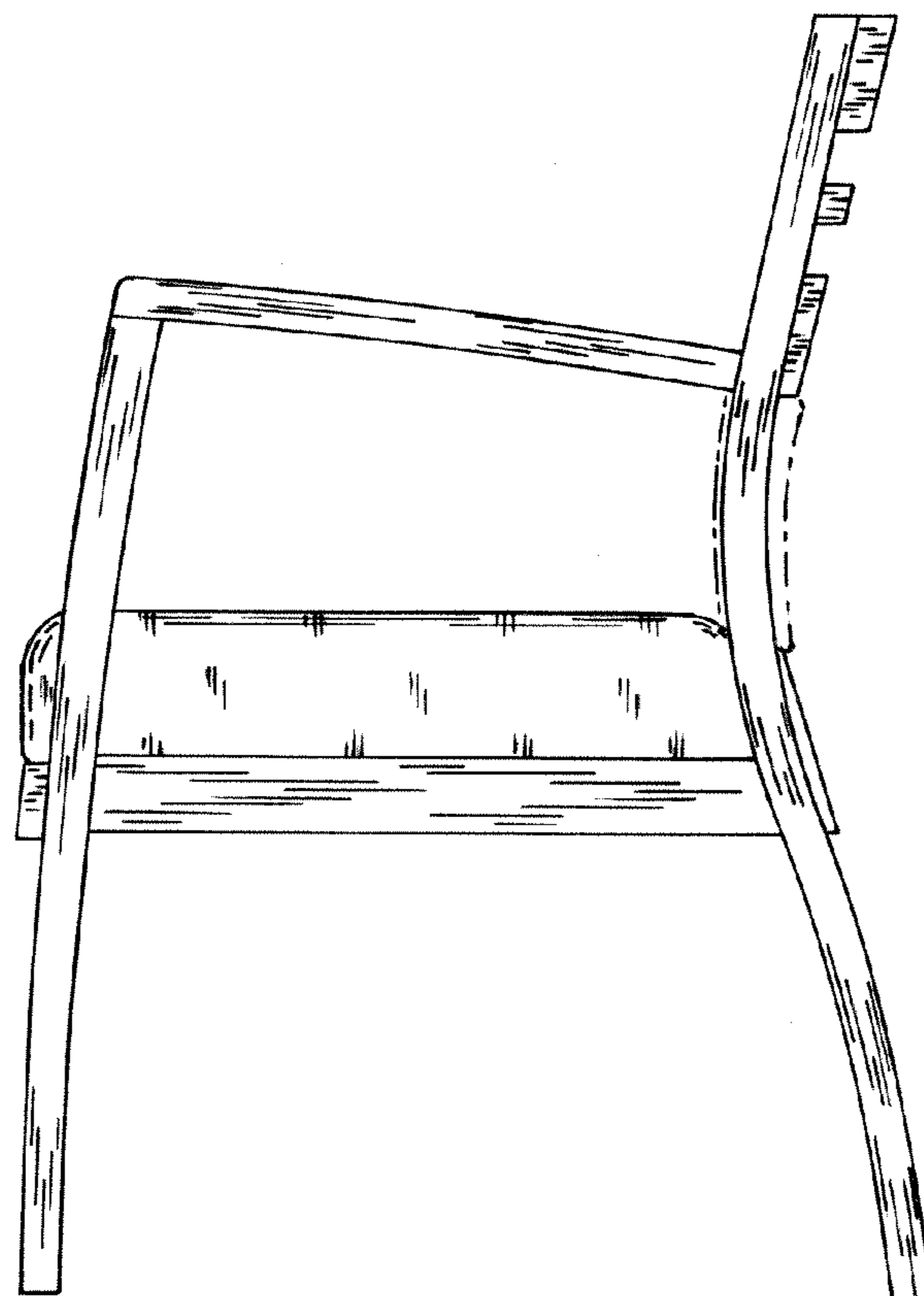

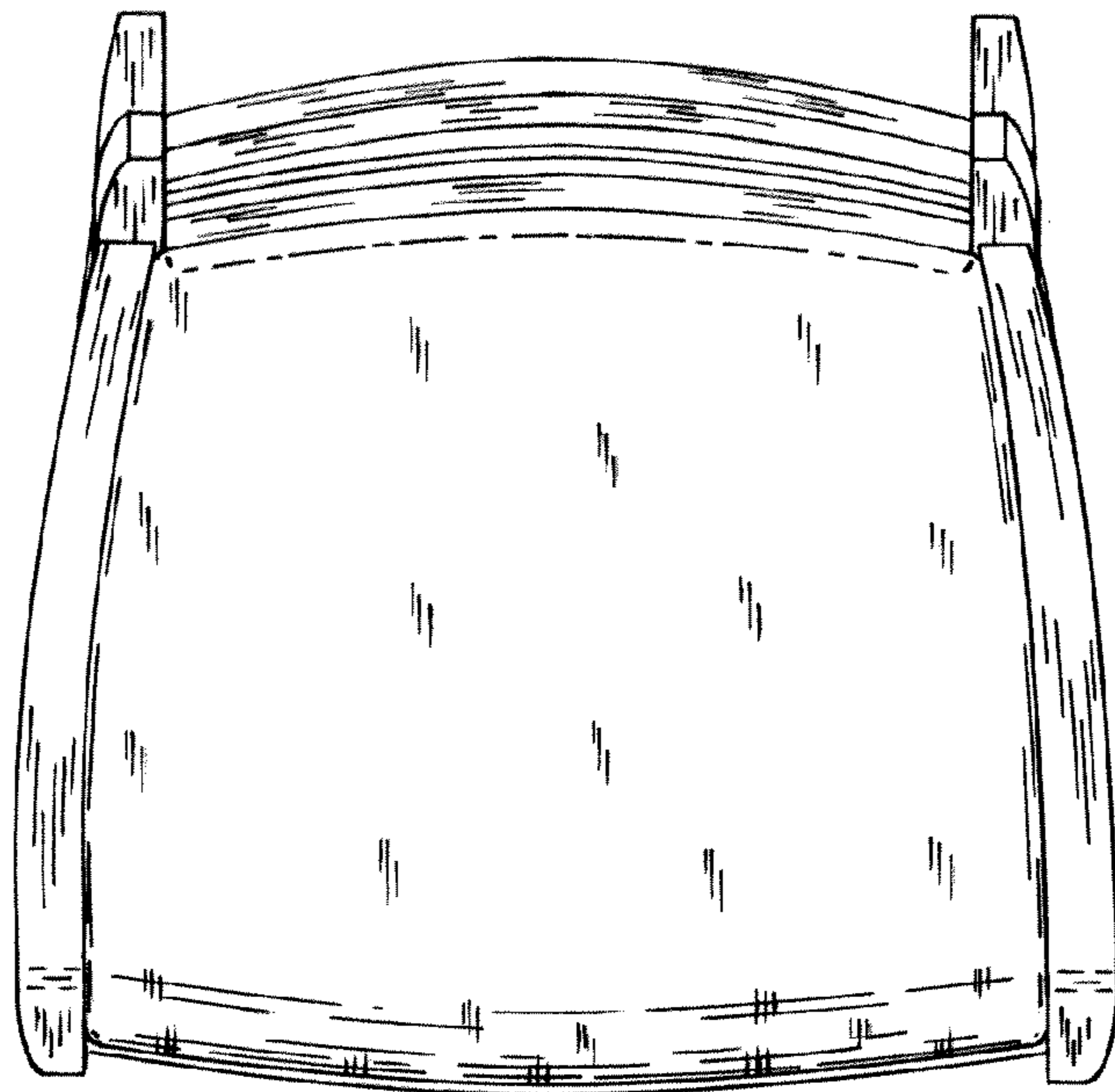
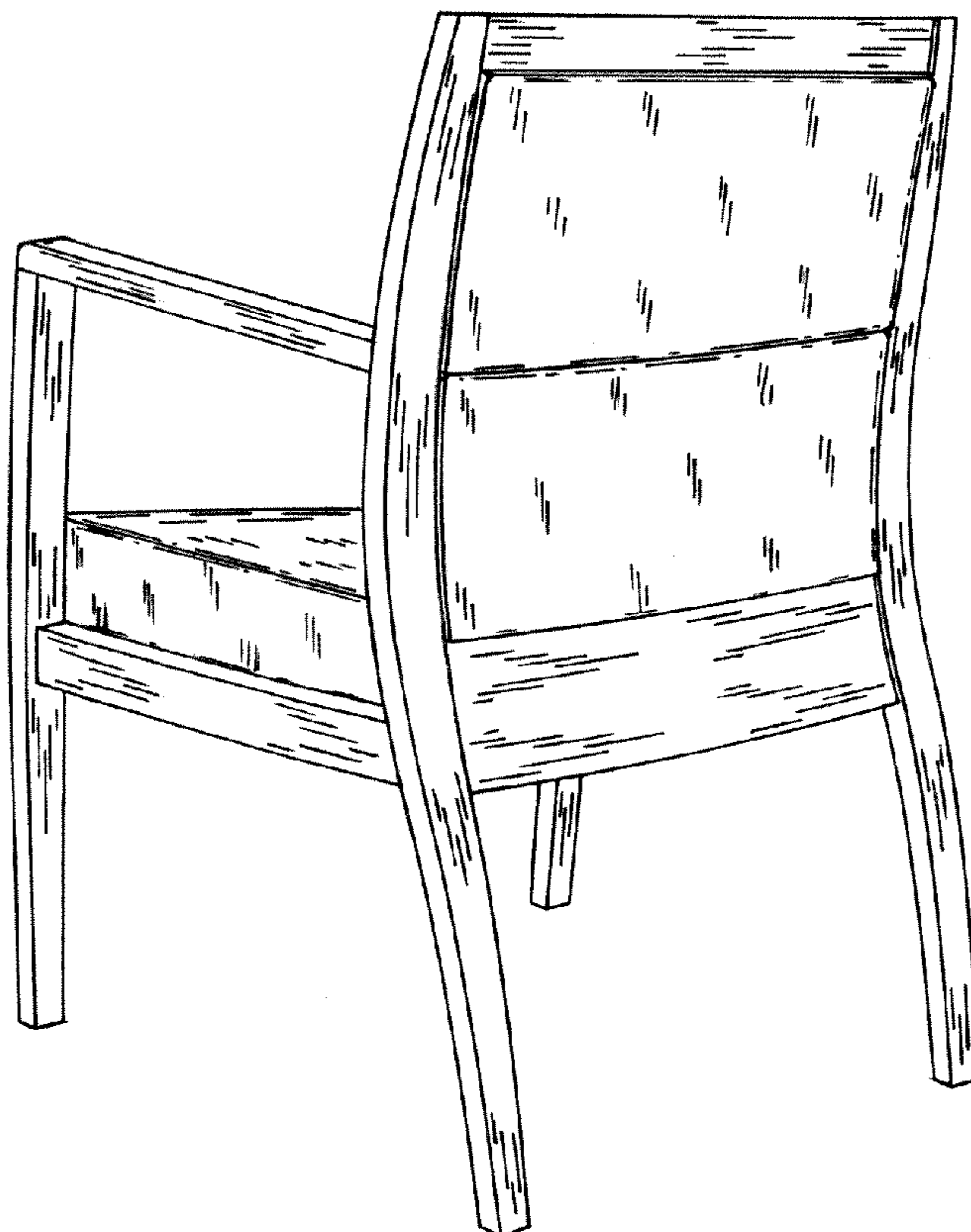

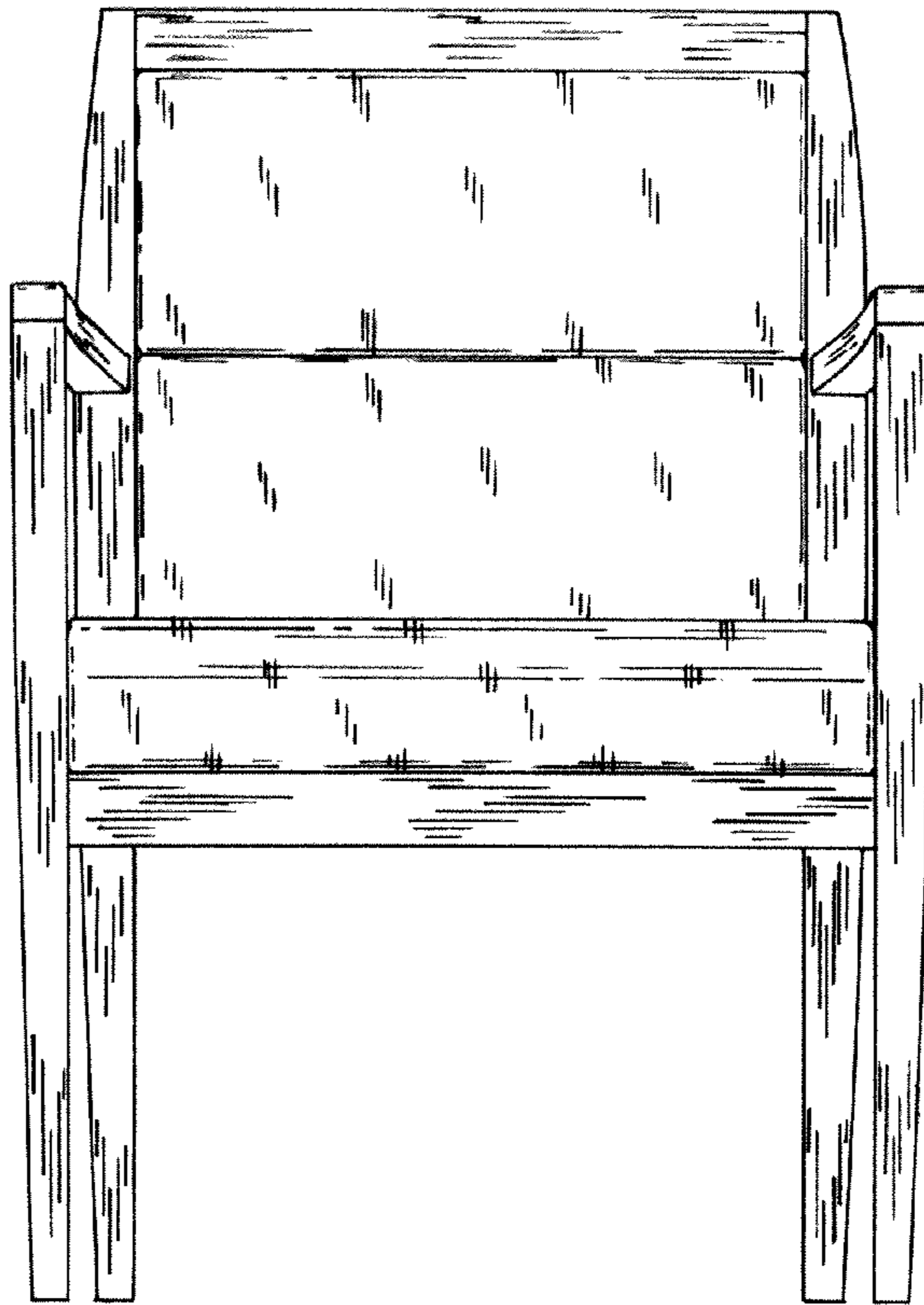

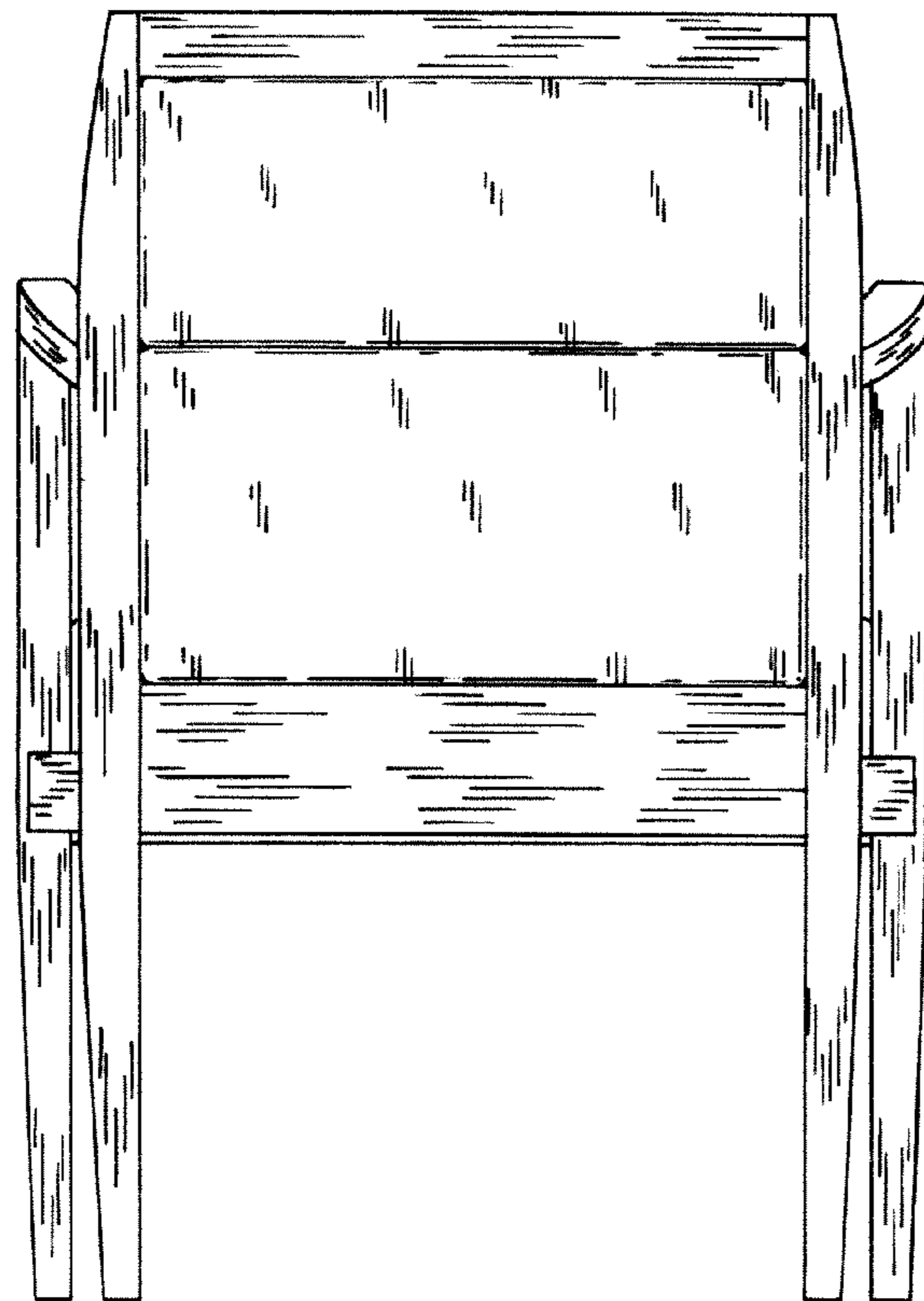

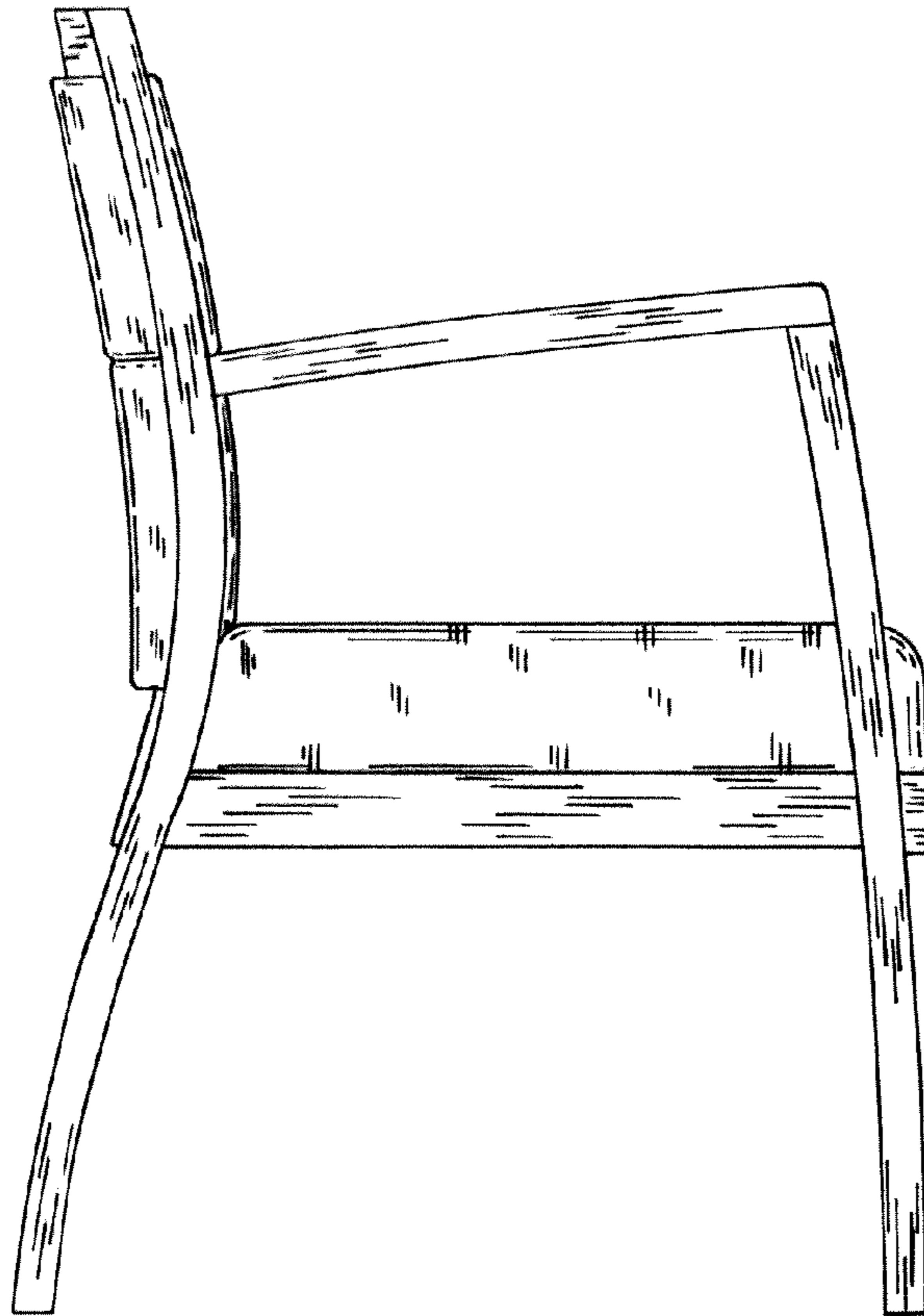

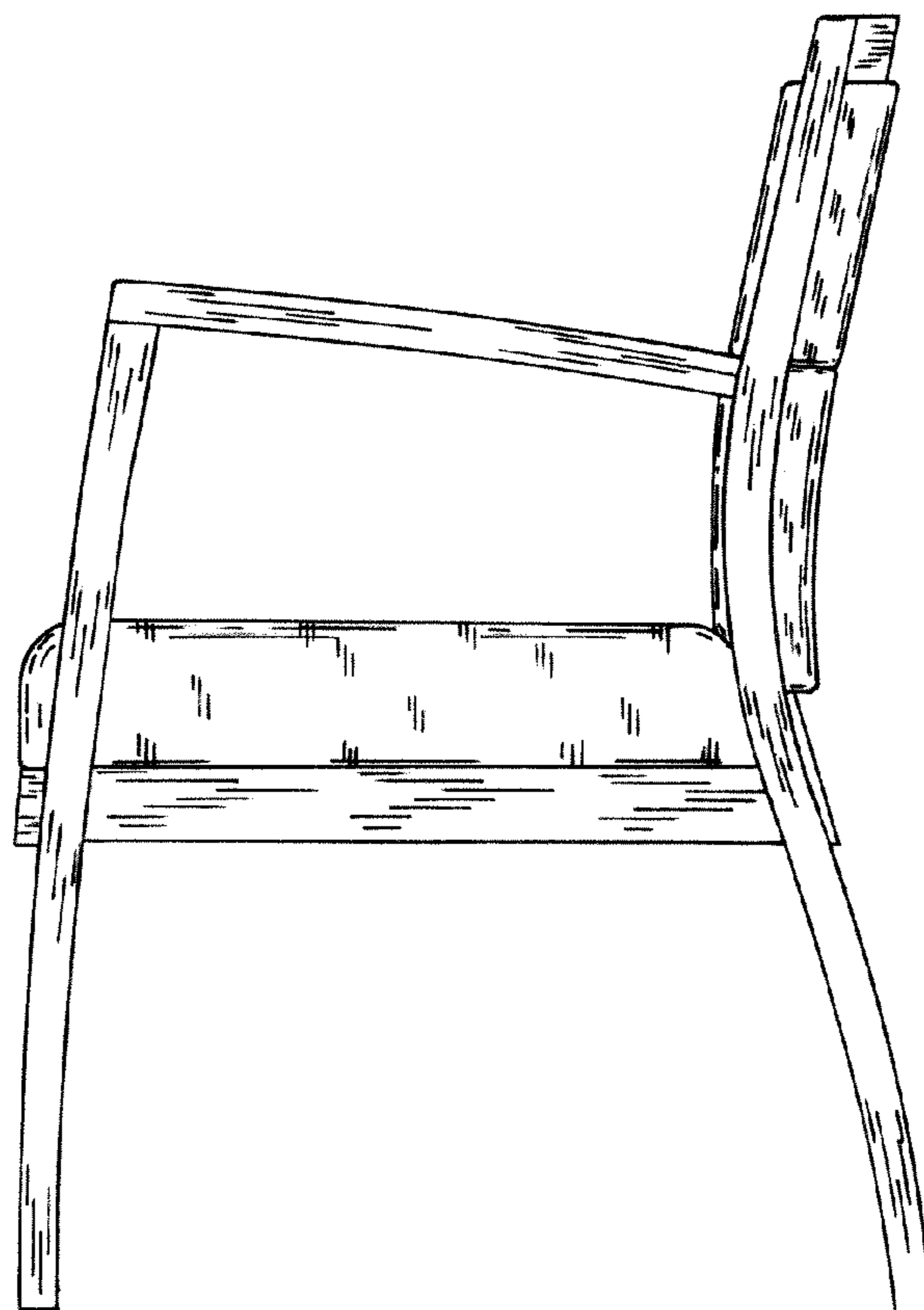

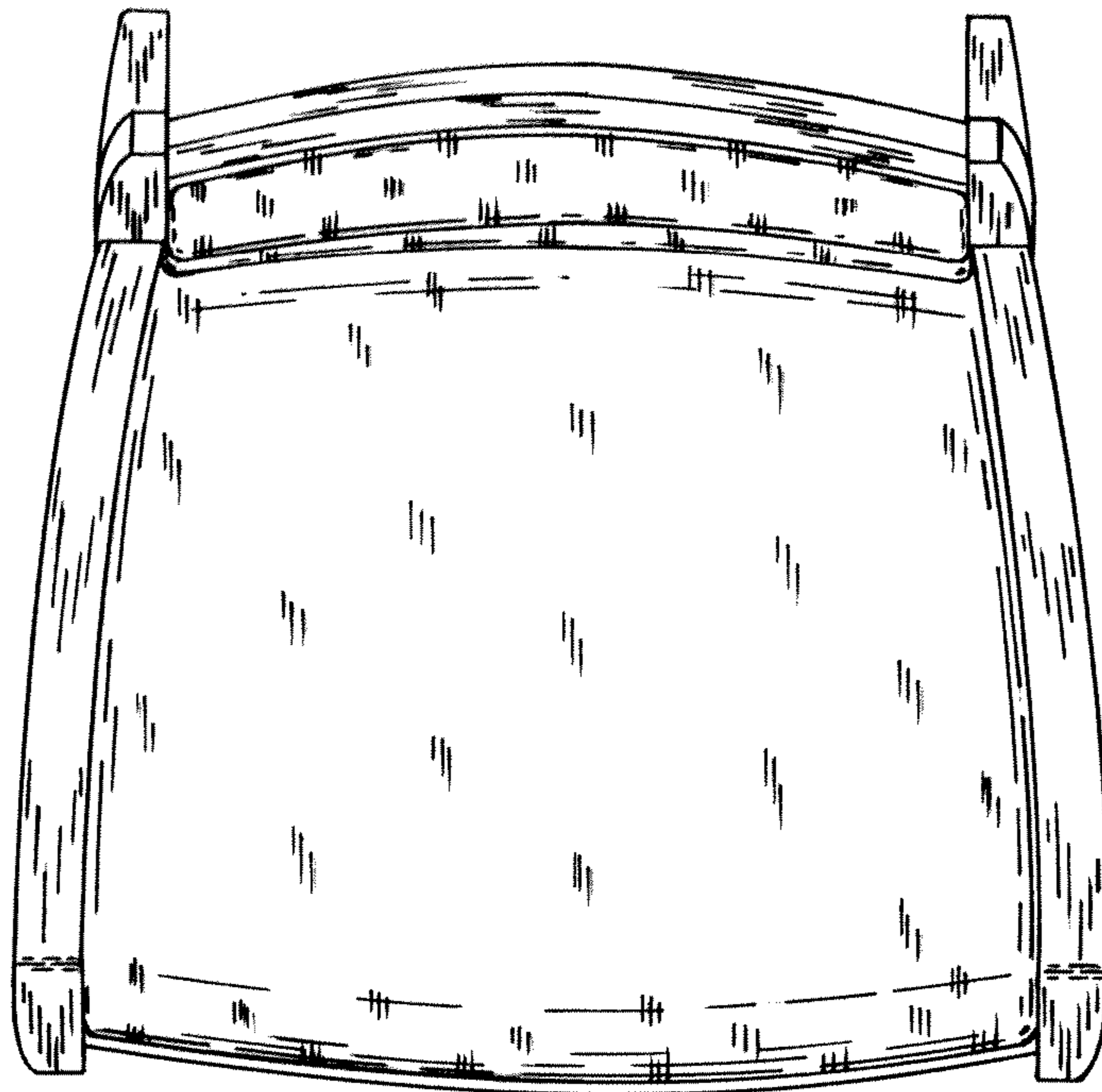
