**DESCRIPTION**

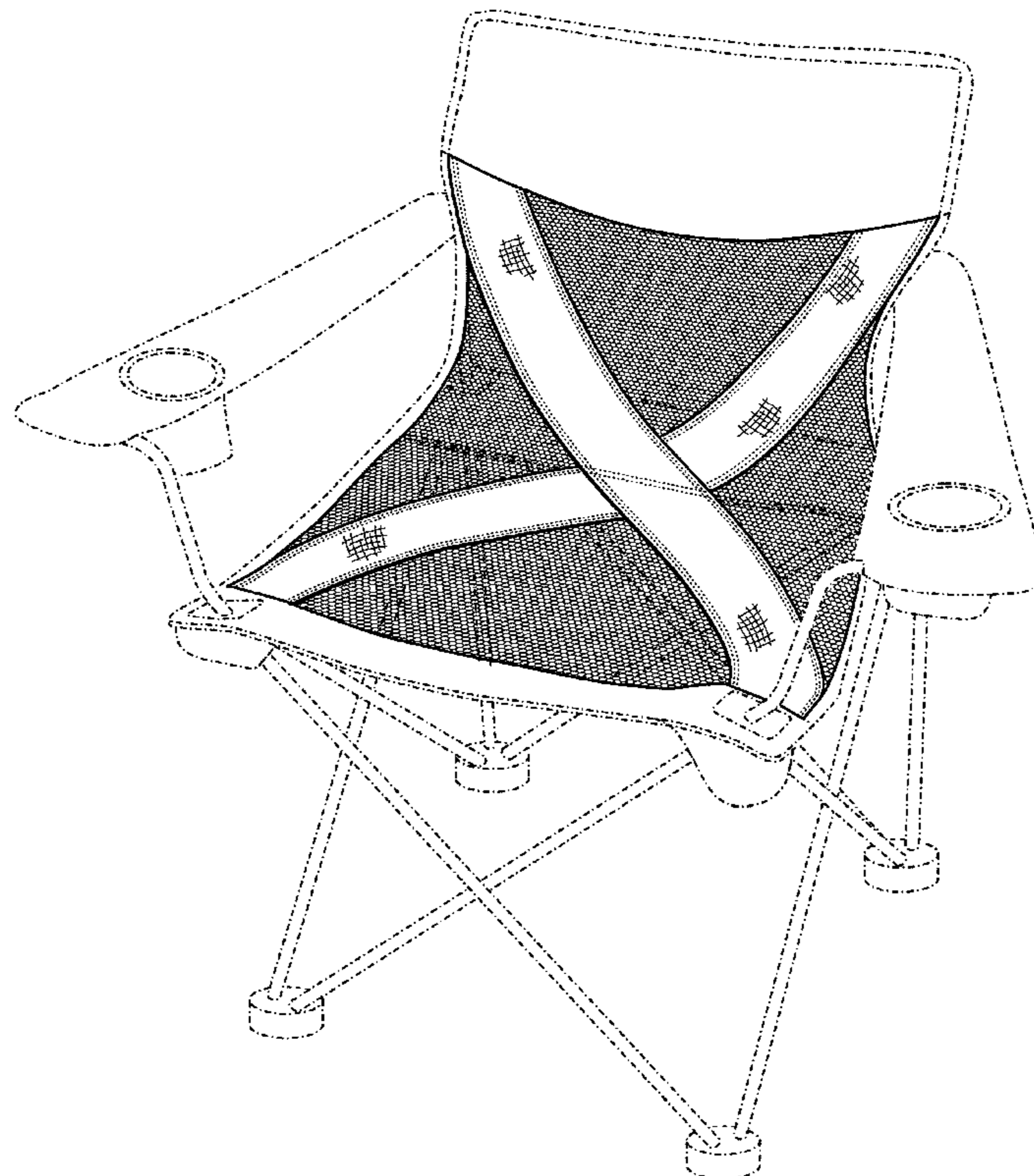

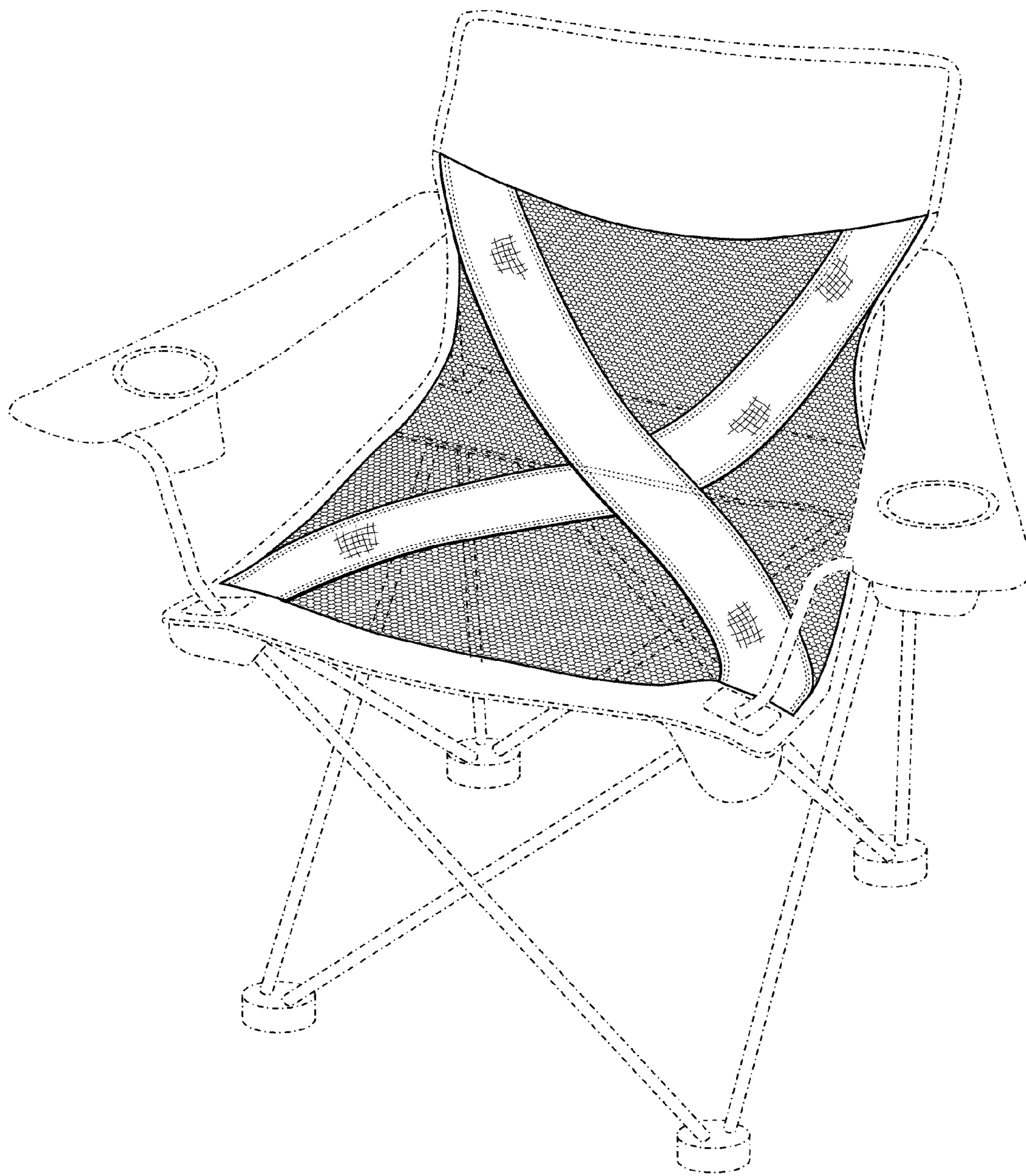

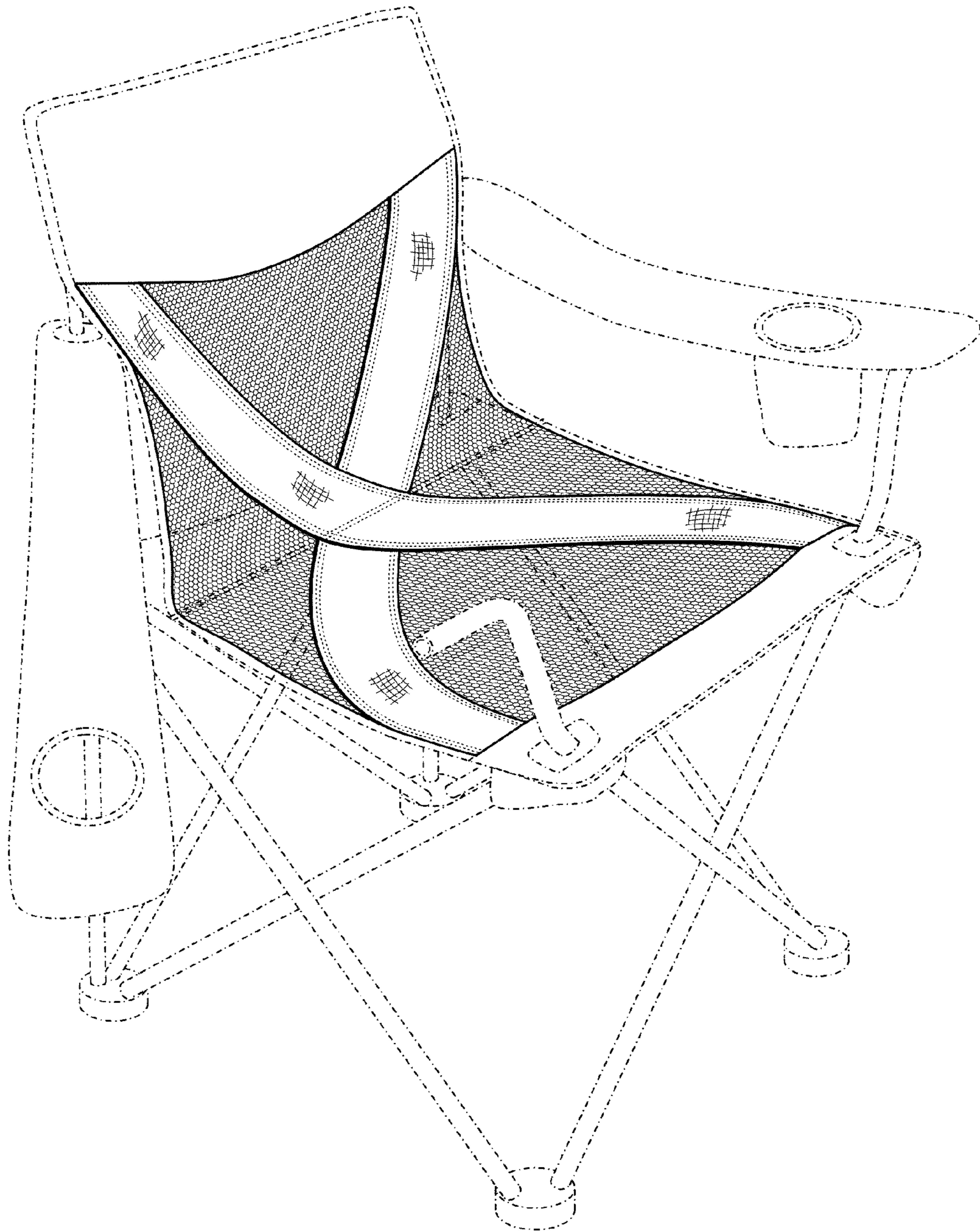

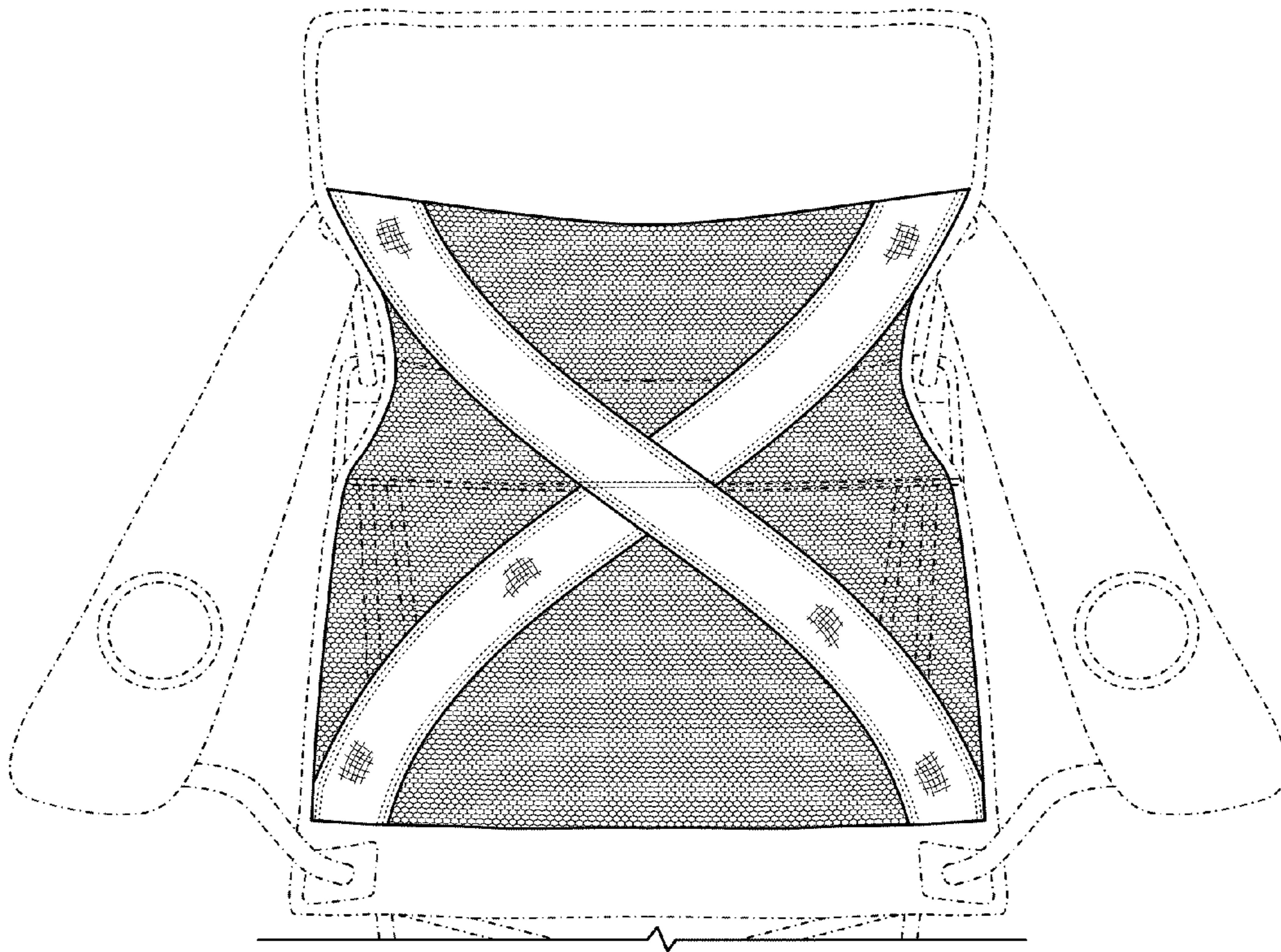
