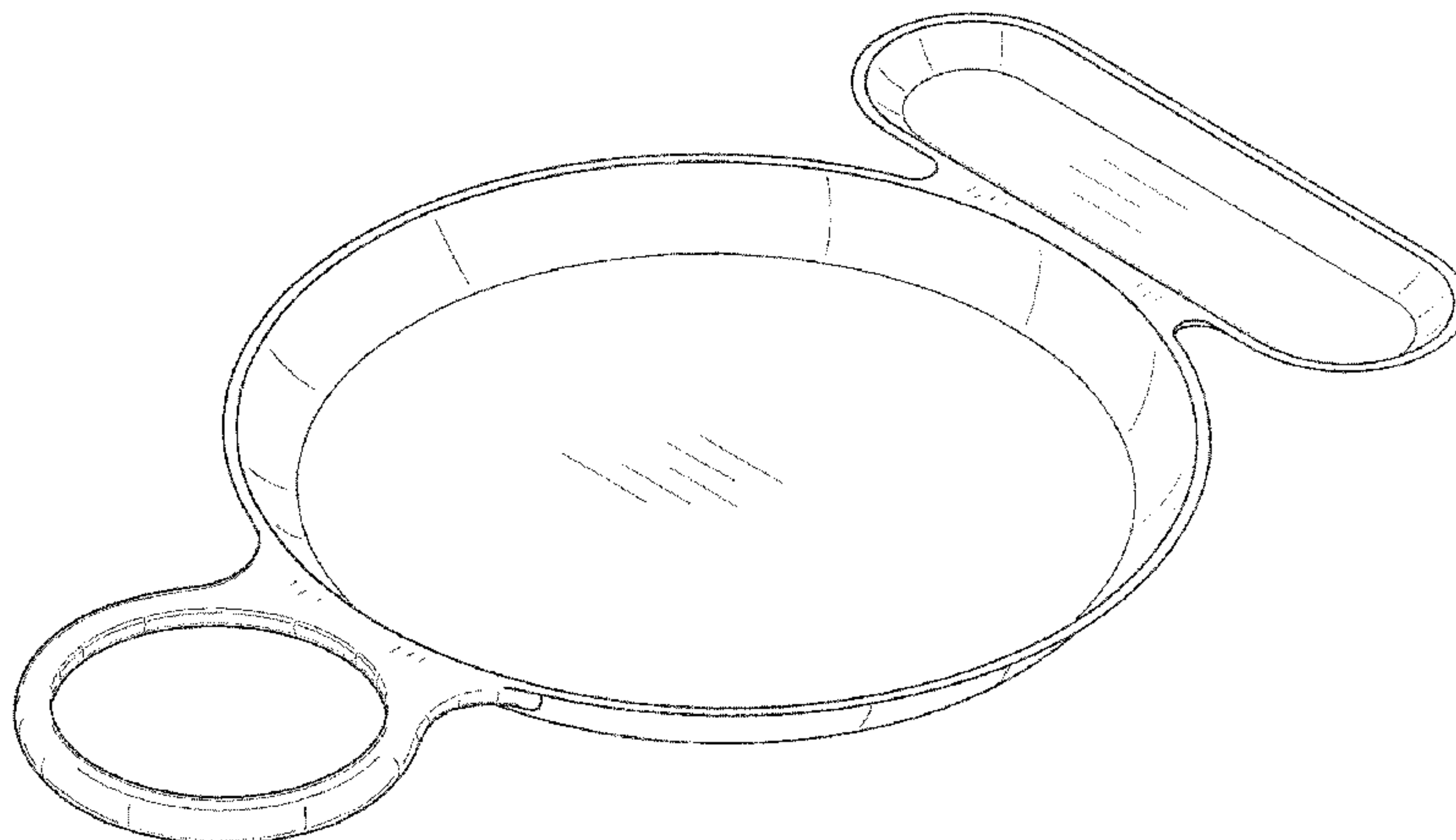
(57) **CLAIM**

The ornamental design for a cocktail plate device, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a cocktail plate device showing my new design;  
FIG. 2 is a top view thereof;  
FIG. 3 is a bottom view thereof;  
FIG. 4 is a side view (opposite side view is mirror image) thereof;  
FIG. 5 is a front view thereof;  
FIG. 6 is a back view thereof; and,

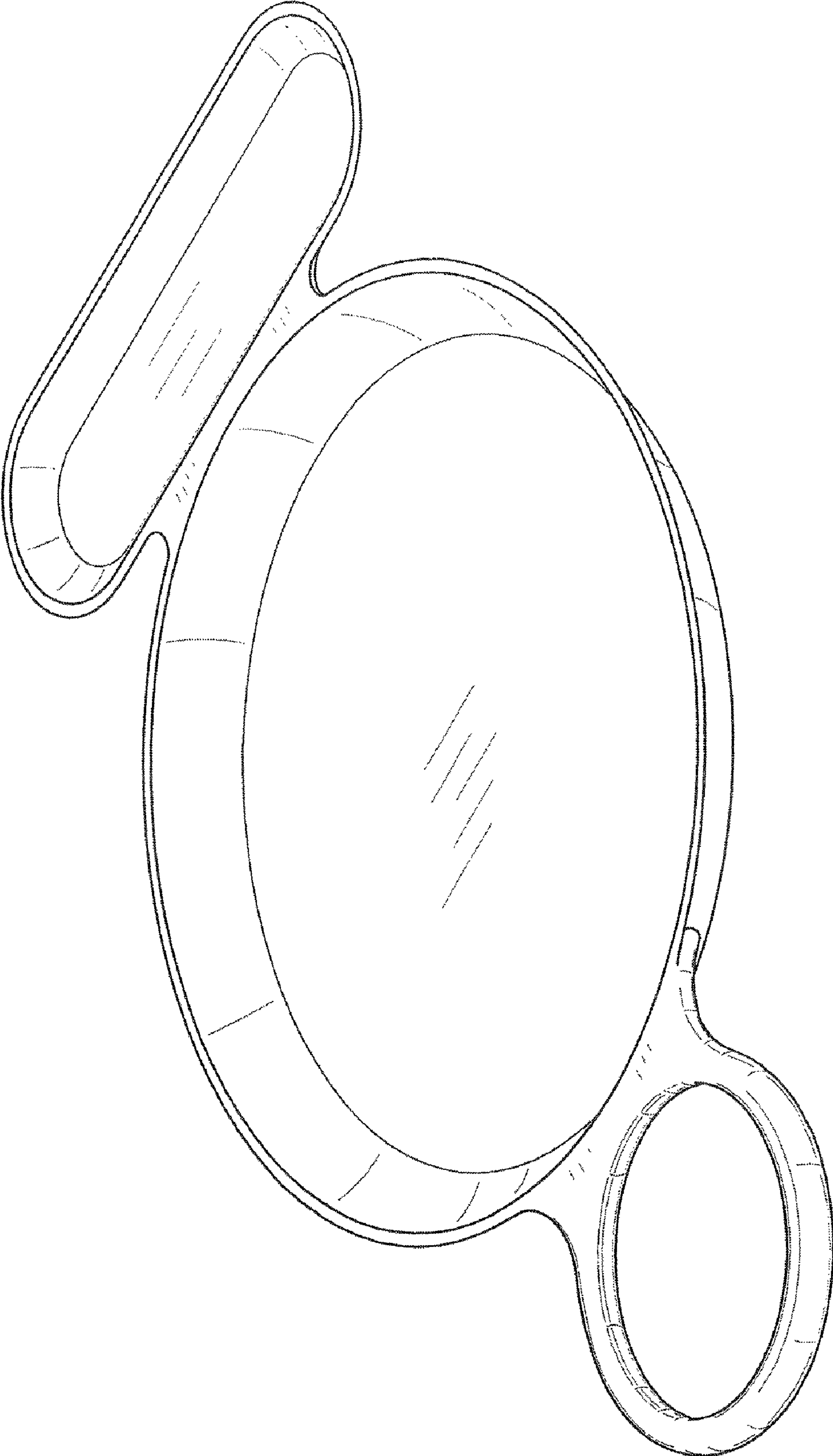

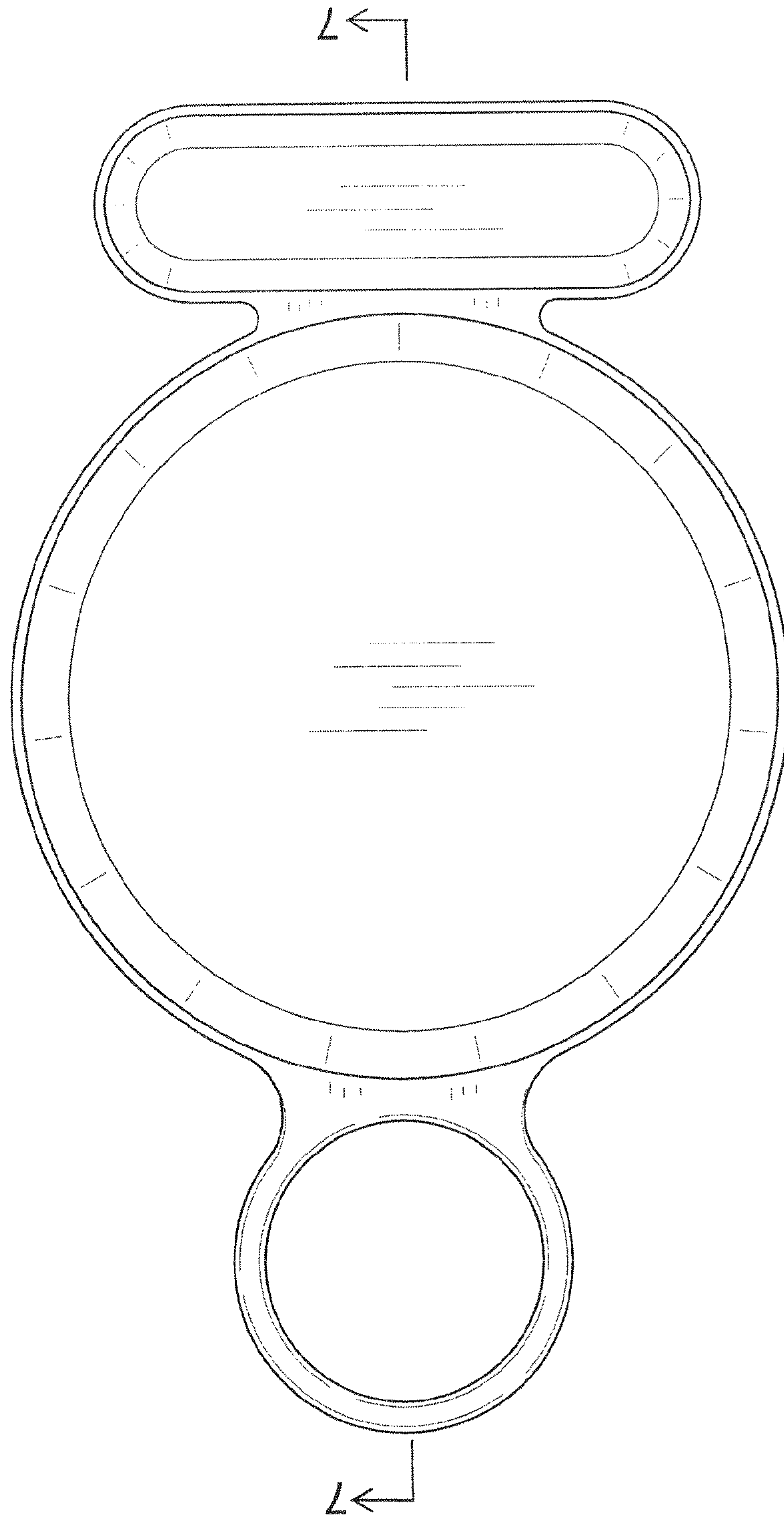

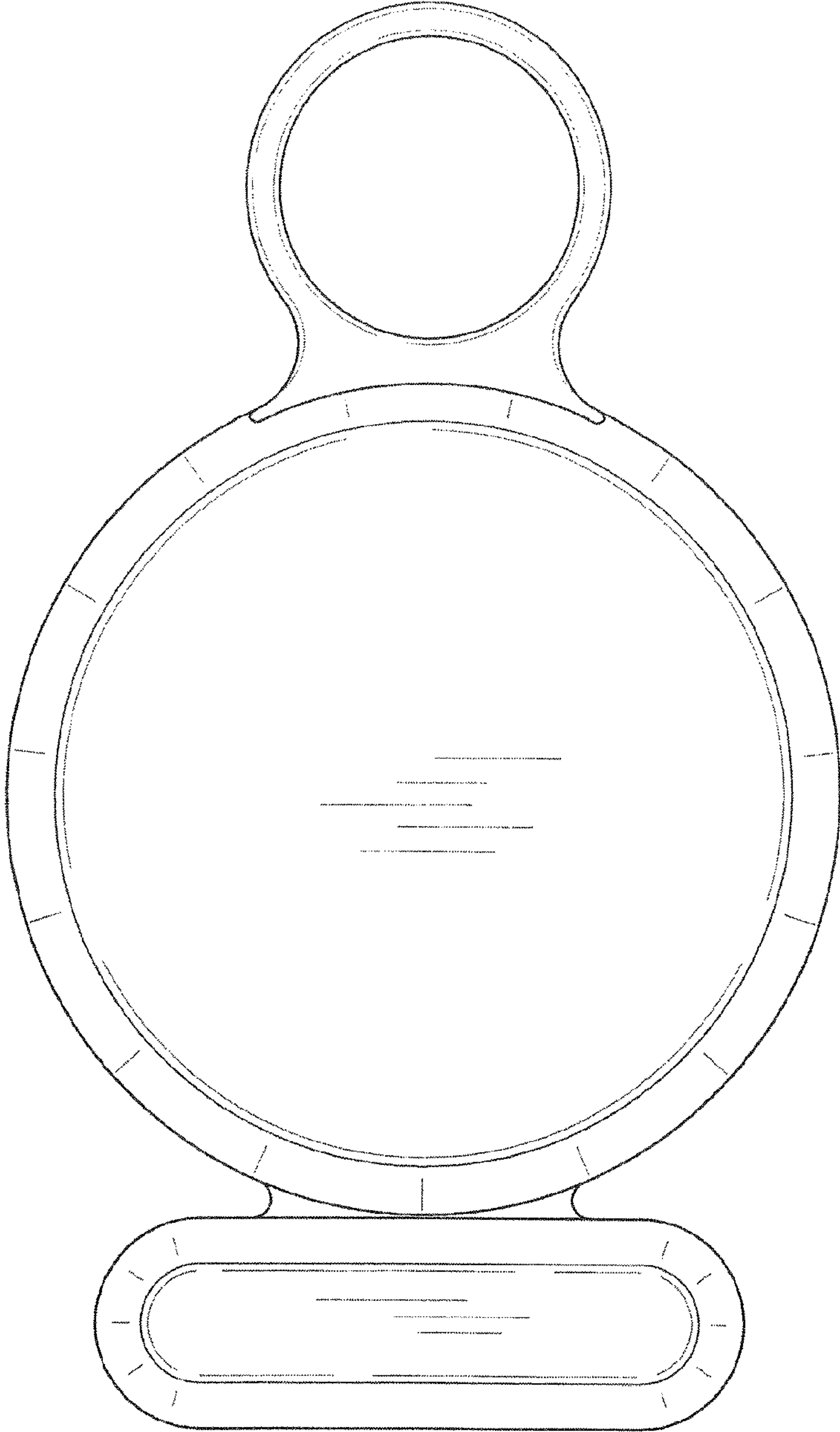

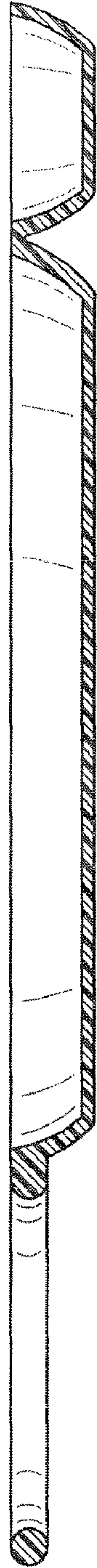
